**1. Minutes of the last meeting of the Executive Committee - Confirmation of.**

Minutes of the last meeting of the Executive Committee held on 24th March,2000 were confirmed.

**2. Minutes of the last meeting of the Executive Committee - Action taken thereon.**

The Executive Committee noted the action taken by the office on the various items included in the minutes of its last meeting held on 24/3/2000.

**3. Medical College, Bhavnagar - Recognition of the college for the award of MBBS degree granted by Bhavnagar University.**

Read : The Council Inspectors report (12th & 13th April, 2000) on the physical and other infrastructure facilities available at Medical College, Bhavnagar and standard of examination held under Bhavnagar University for purpose of recognition of the college for the award of MBBS degree granted by Bhavnagar University.

The Executive Committee considered the Council Inspectors report (12th & 13th April,2000) on the physical and other infrastructure facilities available at Medical College, Bhavnagar for undergraduate teaching and training and standard of examination under Bhavnagar University along with letter dated 26.5.2000 received from the Commissioner, Health Medical Services and Medical Education (Health Section), Govt. of Gujarat wherein it has been informed that the necessary action is being taken to complete the civil work and further that the new college building is ready and that necessary alterations are also being made in the hostel. It also noted that the Commissioner has informed that several measures are being taken to improve and strengthen various departments including Gynaecology department and Operation theatre.

In view of this letter, the Committee decided to verify the same by way of an inspection and authorised the President to take further decision regarding recognition of the college for the award of MBBS degree granted by Bhavnagar University on receipt of the verification report.

**4. Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun - Renewal of Central Govt. permission for 6th batch of students.**

Read : The Council Inspectors report (24th & 25th April, 2000) for renewal of permission for admission of the 6th batch of students at Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun.

The Executive Committee considered the Council Inspectors report (24th & 25th April, 2000) and decided to recommend to the Central Govt. to renew the permission for admission of the 6th batch of students for the academic session 2000-2001 at Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun with an annual intake of 100 students.

**5. Kamineni Instt. of Medical Sciences, Sreeturm, Narketpalli, Nalgonda - Renewal of permission for admission of the 2nd batch of students.**

Read : The Council Inspectors report (14th, 15th & 16th April, 2000) for renewal of permission for admission of 2nd batch of students at Kamineni Instt. of Medical Sciences, Sreeturm, Narketpalli.

The Executive Committee considered the Council Inspectors report (14th, 15th & 16th April, 2000) and decided to recommend to the Central Govt. to renew the permission for admission of 2nd batch of students for the academic session 2000-2001 at Kamineni Instt. of Medical Sciences, Sreeturm, Narketpalli with an annual intake of 100 students.

**6. KAP Vishwanathan Govt. Medical College at Trichy - Renewal of permission for admission of the 3rd batch of students for the academic year 2000-2001.**

Read : The Council Inspectors report (25th & 26th April, 2000) for renewal of permission for admission of the 3rd batch of students at KAP Vishwanathan Govt. Medical College at Trichy.

The Executive Committee considered the Council Inspectors report (25th & 26th April, 2000) and decided to recommend to the Central Govt. to renew the permission for admission of 3rd batch of students for the academic session 2000-2001 at KAP Vishwanathan Govt. Medical College at Trichy with an annual intake of 100 students.

**7. Sri Guru Ramdas Instt. of Medical Sciences, Sri Amritsar - Renewal of permission for admission of the 4th batch of students.**

Read : The Council Inspectors report (8th & 9th May, 2000) for renewal of permission for admission of the 4th batch of students at Sri Guru Ram Das Instt. of Medical Sciences, Sri Amritsar.

The Executive Committee considered the Council Inspectors report (8th & 9th May, 2000) and decided to recommend to the Central Govt. to renew the permission for admission of 4th batch of students for the academic session 2000-2001 at Sri Guru Ram Das Instt. of Medical Sciences, Sri Amritsar with an annual

intake of 50 students.

**8. Increase of MBBS seats from 100 to 150 at Smt. NHL Municipal Medical College, Ahmedabad u/s 10A of the IMC Act, 1956.**

Read : The Council Inspectors report (24th & 25th April, 2000) for increase of MBBS seats from 100 to 150 at Smt. NHL Municipal Medical College, Ahmedabad u/s 10A of the IMC Act, 1956.

The Executive Committee considered the Council Inspectors report (24th & 25th April, 2000) along with the inspection report (17th May, 2000) carried out for verification of the information furnished by the college authorities regarding the appointment of staff after the inspection carried out on 24th & 25th April, 2000). The Committee decided to recommend to the Central Govt. to issue letter of permission for increase of MBBS seats from 100 to 150 for a period of one year for the academic session 2000-2001 at Smt. NHL Municipal Medical College, Ahmedabad.

The Committee further decided to recommend that recognition of MBBS degree granted by Gujarat University in respect of students being trained at Smt. NHL Municipal Medical College, Ahmedabad be continued with an annual intake of 100 students and observations made by the Council Inspectors in the inspection report be implemented within 3 months.

**9. Increase of MBBS seats from 50 to 100 at Guru Gobind Singh Medical College, Faridkot u/s 10A of the IMC Act, 1956.**

Read : The compliance verification report (6th April, 2000) alongwith previous inspection reports (May, 99 and Sept., 99) for increase of MBBS seats from 50 to 100 at Guru Gobind Singh Medical College, Faridkot u/s 10A of the IMC Act, 1956.

The Executive Committee considered the compliance verification report (6th April, 2000) carried out on receipt of the compliance through the Central Govt. on rectification of the deficiencies pointed out in the previous inspection report along with inspection reports (May, 99 and Sept., 99) for increase of MBBS seats from 50 to 100 at Guru Gobind Singh Medical College, Faridkot and noted the following:-

1. Shortage of staff:

Associate Professor/Reader - 4: Physiology -1,  
Anaes.-1, Radiology -1, Dentistry -1.  
Dentistry -1.

Demonstrator/Registrar - 3: Pathology -2, Microbiology-1.

In Clinical departments, there is no cadre of Associate Professor so far in the State.

Following Professors do not have adequate experience as Associate Professor/Reader though they have 15-20 years experience as Assistant Professor:-

1. T.B. & Chest - 1
2. Surgery - 1
3. Anaesthesiology- 1
4. Obst. & Gynae. - 2

Two Medical Officers in Pathology and one in Microbiology have not been considered as Demonstrator as they did not give their consent to be designated and joined as

Demonstrators.

2. The bed occupancy has not improved at all. After going through the figures given in the compliance verification report (April,2000) i.e. 1997(59.80%),1998(57.80%),1999 (50.40%) and upto 31st March,2000 (46%), it is clear that bed occupancy instead of showing improvement is decreasing. Similarly the OPD attendance instead of showing improvement is also decreasing.
3. The new interns hostel has still not been completed.
4. The new OPD has not yet been completed.
5. Deficiency of equipments for the ICCU, TMT, Echo, Mammography and CT Scan still continue.
6. Computerization of library in terms of medlar and internet and Medical Record Section has still not been done.
7. Other observations made in the compliance verification report.

In view of the above recorded deficiencies, the Committee decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats from 50 to 100 at Guru Gobind Singh Medical College, Faridkot u/s 10A of the I.M.C. Act,1956. The Committee further decided to request the Central Govt. that the scheme submitted by the institution for increase of seats be disapproved.

**10. Increase of MBBS seats from 100 to 150 at M.R. Medical College, Gulbarga u/s 10A of the IMC ACT, 1956.**

Read : The compliance verification report (22nd March, 2000) alongwith the previous inspection reports (Dec., 98 and August, 99) for increase of MBBS seats from 100 to 150 at M.R. Medical College, Gulbarga.

The Executive Committee considered the compliance verification report (22nd March,2000) carried out on receipt of the compliance through the Central Govt. on rectification of the deficiencies pointed out in the previous inspection reports (Dec.,98 and August,99) for increase of MBBS seats from 100 to 150 at M.R. Medical College, Gulbarga and noted the following:-

1. The institution does not have the required number of beds in their own hospital for 150 admissions and further that the clinical material is also grossly inadequate in the hospital owned by the authorities.
2. Shortage of staff:  
  
Professor - 2: Forensic Medicine -1, Biochemistry -1.  
  
Reader - 3: Biochemistry -1, Radio-Diagnosis - 2.  
  
Lecturer - 3: PSM -1, Epidemiologist/Lecturer -1, Biophysics-1.  
  
Tutors - 2: PSM -1, Radiodiagnosis -1.  
  
Junior Residents - 6: General Medicine-3, Dermatology -3.

In view of above, the Committee decided to recommend to the Central Govt. not to issue Letter of Intent for increase of MBBS

seats from 100 to 150 at M.R. Medical College, Gulbarga u/s 10A of the I.M.C. Act, 1956. The Committee further decided to request the Central Govt. that the scheme submitted by the institution for increase of seats be disapproved.

**11. MBBS (NTR University of Health Sciences) - Continuance of recognition in respect of students being trained at Andhra Medical College, Visakapatnam.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by NTR University of Health Sciences in respect of students being trained at Andhra Medical College, Visakapatnam.

The Executive Committee noted that the Committee at its meeting held on 16.6.99 had granted 3 months time to the authorities of Andhra Medical College, Visakapatnam to comply with the deficiencies pointed out in the inspection report (23rd, 24th & 25th Feb., 99) carried out for continuance of recognition of MBBS degree granted by NTR University of Health Sciences to which no reply has been received inspite of reminder sent on 28.12.99. The Committee further considered the latest list of the staff along with the list of Postgraduate students admitted during the year 1999-2000 received from the college authorities and noted the following:-

1. Shortage of staff for 150 admissions:-

Professor - 1 (T.B. & Chest)

Associate Professor - 10 : Anatomy-1, Physiology -2,  
Pharmacology -2, PSM -1, General Surgery -1,  
Radiodiagnosis- 2, Dentistry -1.

Assistant Professor - 12: Anatomy -4, Physiology -3,  
Pharmacology -2, Forensic Med.-1,  
Statistician Lecturer -1,  
Biophysics -1.

Tutors - 4: Pathology -1, PSM -2, Anaesthesia -1.

From the list of the postgraduate students admitted during the year 1999-2000, the Committee observed that the deficiency of staff will further increase considerably if postgraduate requirements are also considered specially in basic and para clinical departments.

In view of above, the Committee decided to issue a show cause notice to the concerned authorities as to why steps should not be initiated to recommend to the General Body of the Council for derecognition of the institution for the award of MBBS degree granted by NTR University of Health Sciences for not complying with the deficiencies pointed out in the inspection report. The Committee further decided to give one month's time to the institution to respond to the show cause notice.

The Committee also decided to write a D.O. letter to the Vice-Chancellor, NTR University of Health Sciences and Secretary, Govt. of Andhra Pradesh requesting to restrict the number of admissions in postgraduate diploma courses as per MCI norms i.e. 12 students per year.

Copy of letter sent to the authorities be marked to the Chief Secretary, Secretary (Health), Director of Medical Education, Registrar of the University, Member of the Council representing the State Govt. and the Central Govt.

**12. MBBS (NTR University of Health Sciences) - Continuance of recognition in respect of students being trained at Guntur Medical College, Guntur.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by NTR University of Health Sciences in respect of students being trained at Guntur Medical College, Guntur.

The Executive Committee noted that the Committee at its meeting held on 16.6.99 had granted 3 months time to the authorities of Guntur Medical College, Guntur to comply with the deficiencies pointed out in the inspection report (26th & 27th April, 99) carried out for continuance of recognition of MBBS degree granted by NTR University of Health Sciences. The Committee further considered the compliance received from the college authorities vide their letter dated 23.9.99 and the communication sent by the Council office on 4.11.99 asking to send a detailed and proper compliance report to process the matter further to which no reply has been received inspite of reminder sent on 28.12.99.

In view of the above, the Committee decided to send final reminder to the concerned authorities to send a detailed and proper compliance report touching on all the deficiencies pointed out in the inspection report for further consideration of the matter.

The Committee also decided to write a D.O. letter to the Secretary to the Govt. of Andhra Pradesh requesting to take necessary steps and expedite sending the compliance report on rectification of the deficiencies pointed out in the inspection report of Guntur Medical College, Guntur.

**13. MBBS (Bhagalpur University) - Continuance of recognition in respect of students being trained at J.N.Medical College, Bhagalpur.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Bhagalpur University in respect of students being trained at J.N. Medical College, Bhagalpur.

The Executive Committee noted that the Committee at its meeting held on 17.9.97 on considering the periodical inspection report and the compliance received from the Principal, J.N. Medical College, Bhagalpur had granted six months time to the institution to rectify the deficiencies pointed out in the inspection report and to send a compliance report. As no reply was received, the matter was again considered by the Committee at its meeting held on 2.7.98 wherein it was decided to send a final reminder to the authorities concerned giving 3 months time to send a compliance. Final reminder was sent on 28.7.98.

The Committee further noted that the compliance report was received from the college authorities vide letter dated 15.10.98 which was not satisfactory and a letter was sent by the Council office on 16.11.98 advising to send a detailed compliance report. The Committee also noted that as per request of the Commissioner & Secretary, Govt. of Bihar vide letter dated 27.2.99, time for submission of the compliance report was extended upto July, 99. Time granted for submission of the compliance report is already over and no compliance report after rectificating the deficiencies has been received.

The Committee decided to give final 2 months time to the authorities to send the compliance. It also decided that a D.O. letter to the Commissioner & Secretary, Govt. of Bihar be sent requesting to take necessary steps in expediting sending the compliance report on rectification of the deficiencies pointed out in the inspection report of J.N. Medical College, Bhagalpur. Copy of this letter be marked to the Member of the Council representing the State Govt.

**14. MBBS (Baba Sahab Bhim Rao Ambedkar Bihar University) - Continuance of recognition in respect of students being trained at Sri Krishna Medical College, Muzaffarpur.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Baba Saheb Bhim Rao Ambedkar Bihar University in respect of students being trained at Sri Krishna Medical College, Muzaffarpur.

The Executive Committee noted that periodical inspection for continuance of recognition of MBBS degree granted by Baba Saheb Bhim Rao Ambedkar Bihar University in respect of students being trained at Sri Krishna Medical College, Muzaffarpur was carried out in Nov., 98 and sent for obtaining the observations of the University/college authorities on the remarks made in the inspection report vide MCI letter dated 12.1.99. The Committee further noted the compliance report has been received from the college authorities vide letter dated 28.7.99 wherein mere proposals have been sent to the State Govt. for recitification of the deficiencies.

In view of above, the Committee decided to send a reminder to the concerned authorities giving 3 months time to rectify the deficiencies and to send a detailed compliance to that effect for further consideration in the matter. Copy of this letter be marked to the Member of the Council representing State Govt.

**15. MBBS (Ranchi University) - Continuance of recognition in respect of students being trained at MGM Medical College, Jamshedpur.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Ranchi University in respect of students being trained at MGM Medical College, Jamshedpur.

The Executive Committee noted that the periodical inspection report (March, 97) of M.G.M. Medical College, Jamshedpur along with the compliance received from the college authorities was considered by the Committee at its meeting held on 10.12.97. As the compliance sent were mere proposals, 3 months time was granted by the Committee to send a detailed compliance report. It was also decided that in case satisfactory compliance is not received within the stipulated period the Council will be constrained to reduce the number of seats in consonance with the facilities available or take necessary action as deemed fit under the provisions of I.M.C. Act, 1956. This decision was communicated to the concerned authorities on 5.1.1998.

The Committee further noted that the compliance thus received was again considered by the Committee at its meeting held on 2.7.98. Since all the deficiencies pointed out including staff were still persisting, the Committee decided to issue a show cause notice to the concerned authorities as to why steps should not be initiated to recommend to the Central Govt. to de-recognise the institution for the award of MBBS degree for not complying with the deficiencies pointed out in the inspection report. On receipt of the compliance report in response to the

show cause notice 3 months time was again granted by the Committee at its meeting held on 3.1.1999. As per request of the Commissioner & Secretary, Govt. of Bihar vide letter dated 27.2.99, the time for submission of the compliance report was extended upto July,1999.

The Committee considered the letter 22.5.2000 now received from the Commissioner & Secretary, Health, ME & FW Department, Govt. of Bihar informing that the State Govt. has sanctioned Rs. 3,21,21,000/- as annual budget for the college including salary and allowances whereas for the hospital the annual budget is Rs.2,97,77,000/-. He has admitted that the condition of the M.G.M. Medical College & Hospital is not upto mark, but till the time the facilities of Tata Main Hospital is available to the students for clinical teaching. This facility as per agreement will be provided by T.M.H. for one more year. He has also informed regarding the appointment of certain teachers against the deficiencies of staff shown in the inspection report. As all the deficiencies noted in the inspection report have not yet been complied with including the staff, the Commissioner & Secretary has requested to give some more time for removing the deficiencies.

In view of above the Committee decided to give another 3 months time to the concerned authorities to rectify the deficiencies and send a detailed compliance report for further consideration in the matter. Copy of the decision communicated to the State authorities be marked to the Member of the Council representing the State Govt.

**16. MBBS (Ranchi University) - Continuance of recognition in respect of students being trained at Rajendra Medical College, Ranchi.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Ranchi University in respect of students being trained at Rajendra Medical College, Ranchi.

The Executive Committee noted that the periodical inspection report (Jan.,97) of Rajendra Medical College, Ranchi in the absence of observations of the University/college authorities was considered by the Committee at its meeting held on 17.9.97 wherein it was decided to send a final reminder to the concerned authorities for sending a compliance. The Committee further noted that in response to the above compliance reports were received from the college authorities vide letters dated 6.12.97 and 20.8.98. Since the compliance as received were not satisfactory, the college authorities were requested by the office to send a detailed compliance report. Further as per the request of the college authorities, time for submission of the compliance report was granted till 31.3.1999 by the Executive Committee at its meeting held on 3.1.1999. As per request of the Commissioner & Secretary, Govt. of Bihar vide letter dated 27.2.99 time for submission of the compliance report was again extended upto July,99. After that letter dated 9.10.99 was received from the Principal of the college who informed that "it has not been possible for the Govt. to make appointments against some of the posts of Professors although the Govt. of Bihar has tried its level best to make such appointments through Bihar Public Service Commission.

On considering the above letter of the Principal, the Committee at its meeting held on 4.11.99 granted one month's time to the institution for sending a compliance report and the list of the staff working at the college for further consideration of the matter.



The Executive Committee considered the letter dated 26.2.2000 received from the Principal of the college who has informed that in respect of general maintenance of the entire Rajendra Medical College & Hospital campus the situation has improved markedly as regards to the building, the power supply and electrical installations, machine and equipment, the water supply, road etc. and now the situation is upto the mark. Regarding the staff position, the Principal has informed that the Govt. of Bihar has left no stone unturned to fill up the post of teachers which have remained vacant in the recent past. The Committee also considered the letter dated 11.3.2000 received from the Joint Secretary to the Govt. of Bihar, Department of Health, Medical Education and Family Welfare informing that the department is proposing to fill vacant posts of medical college under question. It is presumed that the required process will take at least six months for finalisation of the same.

In view of above the Committee decided to give 3 months time to the concerned authorities to rectify the deficiencies and send a detailed compliance report for further consideration in the matter. Copy of the decision communicated to the State authorities be marked to the Member of the Council representing the State Govt.

**17. MBBS (Patna University) - Continuance of recognition in respect of students being trained at Patna Medical College, Patna.**

Read : The periodical inspection report (23rd & 24th June, 99) for continuance of recognition of MBBS degree granted by Patna University in respect of students being trained at Patna Medical College, Patna.

The Executive Committee noted that the periodical inspection report for continuance of recognition of MBBS degree granted by Patna University in respect of students being trained at Patna Medical College, Patna was carried out on 23rd & 24th June, 99 and sent for obtaining the observations of the University/college authorities on the remarks made by the Inspectors in their report vide MCI letter dated 24.8.99 to which no response has been received till date.

The Committee decided to write a D.O. letter to the Commissioner & Secretary, Govt. of Bihar and Member of the Council representing the State Govt. requesting to look into the matter personally and expedite for getting the response from the concerned authorities to take further necessary action in the matter.

**18. MBBS ( Magadh University Bodh Gaya) - Continuance of recognition in respect of students being trained at Nalanda Medical College, Patna.**

Read : The periodical inspection report (21st & 22nd June, 99) for continuance of recognition of MBBS degree granted by Magadh University Bodh Gaya in respect of students being trained at Nalanda Medical College, Patna.

The Executive Committee noted that the periodical inspection report for continuance of recognition of MBBS degree granted by Magadh University Bodh Gaya in respect of students being trained at Nalanda Medical College, Patna was carried out on 21st & 22nd June, 99 and sent for obtaining the observations of the University/college authorities on the remarks made by the Inspectors in their report vide MCI letter dated 24.8.99 to which

no response has been received till date.

The Committee decided to write a D.O. letter to the Commissioner & Secretary, Govt. of Bihar and Member of the Council representing the State Govt. requesting to look into the matter personally and expedite for getting the response from the concerned authorities to take further necessary action in the matter.

**19. MBBS (L.N.Mithila University) - Continuance of recognition in respect of students being trained at Darbhanga Medical College, Laheriasarai.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by L.N. Mithila University in respect of students being trained at Darbhanga Medical College, Laheriasarai.

The Executive Committee noted that the Committee at its meeting held on 25.8.98 considered the periodical inspection report (April,98) of Darbhanga Medical College, Laheriasarai and noting the deficiencies in the infrastructural facilities had granted 3 months time to the institution to rectify the deficiencies and send a compliance to that effect for further consideration in the matter. The Committee further noted that as per request of the Commissioner & Secretary, Govt. of Bihar, dated 27.2.99, time for submission of the compliance report was extended upto July,99. No compliance rectifying the deficiencies as noted in the inspection report has been received till date from the concerned authorities inspite of extension of time upto July,99.

The Committee decided to give final 3 months time to the concerned authorities for sending the compliance. Copy of this letter be marked to the Member of the Council representing State Govt.

**20. MBBS (Rani Durgawati Vishwavidyala) - Continuance of recognition in respect of students being trained at NSCB Medical College, Jabalpur.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Rani Durgawati Vishwavidyala in respect of students being trained at NSCB Medical College, Jabalpur.

The Executive Committee noted that the Committee at its meeting held on 24.3.2000 considered the periodical inspection report (April,98) of NSCB Medical College, Jabalpur along with list of staff and list of postgraduate students received from the college authorities and observed the deficiency of staff and also noted that no compliance regarding the other deficiencies pointed out in the inspection report has been sent. From the list of the students admitted to postgraduate degree/diploma courses, the Committee observed that the college is running 14 postgraduate courses in almost all the specialities. It also observed that the shortage of staff will further increase considerably if the requirement of postgraduate training programme in various departments are also taken into consideration.

In view of above, it decided to issue a show cause notice to the concerned authorities as to why steps should not be initiated to recommend to the General Body of the Council for derecognition of the institution for the award of MBBS degree granted by Rani Durgawati Vishwavidyalaya. Two months time was granted to the institution to respond to the show cause notice. The Committee also decided to direct the college authorities to stop admissions in the postgraduate courses which are being run by the

institution with immediate effect.

The Executive Committee noted the letter dated 2.5.2000 now received from the Director Medical Education, Govt. of Madhya Pradesh in response to the show cause notice, wherein he has informed that the Directorate is actively acting upon sincerely regarding rectification of the deficiencies pointed out in the inspection report. Regarding ban of the admissions to postgraduate courses, the Director has informed that he has taken the liberty in revising the decision of the Executive Committee in the current academic session as this year's PG entrance test result has been declared and they are in the process of holding the counselling. The decision of banning the students for admission to postgraduate course at Medical College, Jabalpur could adversely affect the future of students.

The remarks of the DME that "he has taken the liberty of revising the decision of the Executive Committee about ban of postgraduate admissions at Medical College, Jabalpur....." was viewed very seriously as no authorisation was given to the DME to review the decision taken by the Executive Committee of the Council.

The Committee also considered the fax letter dated 12.5.2000 received from the Principal Secretary, Govt. of Madhya Pradesh informing therein the corrective measures taken by the Govt. of Madhya Pradesh for appointment of staff in the medical colleges of M.P. as under:-

1. Govt. has created 3 posts of Professors, 16 posts of Associate Professors and 11 posts of Assistant Professors at Jabalpur.
2. 54 posts of Assistant Professors in different Medical Colleges of M.P. have already been filled by interview and appointment. Another 45 candidates have been selected and are being appointed from the next session.
3. Govt. is also considering for the contract appointment of teachers in Medical Colleges to be appointed before August,2000.
4. He has stated that conditions will improve in all the colleges of M.P. Contract services, appointments shall open a new channel of entry for medical teachers which will certainly enhance the number of teachers in the State as early as the start of next session in July/August,2000.
5. that the college at Bhopal, Indore, Jabalpur & Gwalior had original permission and capacity for 150 admissions each per year, but only 140 admissions were being made except for Rewa which was admitting 90 students against a capacity of 100 students and further that the Govt. decided to fill these remaining seats with NRI students.

The Executive Committee taking note of the letter of DME and further that inspite of show cause, the State authorities have still not rectified the gross deficiencies pointed out in the inspection report inspite of giving adequate time and also noting that the State has decided to fill 10 seats with NRI students raising the admission capacity from 140 to 150 without obtaining the permission of the Central Govt. for the said increase (Council Inspectors report April,98 clearly indicates the admission capacity of the college as 140 from 1977 onwards) decided to recommend to the General Body of the Council to withdraw the recognition of MBBS degree granted by Rani Durgawati

Vishwavidyalaya in respect of students being trained at NSCB Medical College, Jabalpur u/s 19 of the I.M.C. Act, 1956.

**21. MBBS (A.P. Singh University, Rewa) - Continuance of recognition in respect of students being trained at S.S. Medical College, Rewa.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by A.P. Singh University, Rewa in respect of students being trained at S.S. Medical College, Rewa.

The Executive Committee considered the periodical inspection report 2nd & 3rd Nov., 98 of S.S. Medical College, Rewa along with the compliance report received from the Registrar, A.P. Singh University, Rewa vide letter dated 25.3.2000 and noted that except for some rectification in Central library rest of the deficiencies pointed out in the inspection report continue as such.

The Committee decided to give 3 months time to the concerned authorities to send a proper compliance touching on all the deficiencies pointed out in the inspection report for further consideration in the matter. Copy of the letter be marked to the Member of the Council representing State Govt.

**22. MBBS (Gorakhpur University) - Continuance of recognition in respect of students being trained at BRD Medical College, Gorakhpur.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at BRD Medical College, Gorakhpur.

The Executive Committee noted that the General Body of the Council at its meeting held on 17.3.98 had decided to represent to the Central Govt. to withdraw the recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur u/s 19 of the I.M.C. Act, 1956. It further noted that as per request of the Central Govt. fresh inspection of the college was carried out on 14th & 15th Oct., 99 and the inspection report was considered by it at its meeting held on 4.11.1999. On considering the inspection report, the Committee noted that college is admitting 105 students each year against the approved intake of 50 students. It also noted that the college is having the shortage of staff even for 50 admissions and the college is also running various postgraduate courses in almost all the specialities. In view of above, the Committee had reiterated its earlier decision which was duly approved by the General Body of the Council at its meeting held on 17.3.98 to represent to the Central Govt. to withdraw the recognition of MBBS degree granted by Gorakhpur University in respect of this college and further decided to direct the college authorities to stop admissions in the postgraduate courses which are being run by the institution. In response to the decision of the Committee, a D.O. letter was sent by Shri C.L. Bhatia, the then Deputy Secretary to the Govt. of India, to Shri R.K. Mittal, Secretary, Medical Education Department, Govt. of Uttar Pradesh to take appropriate steps to rectify the deficiencies pointed out in the inspection report of Oct., 99 within 3 months in respect of BRD Medical College, Gorakhpur and send a compliance report to the MCI under intimation to the Ministry.

The Executive Committee considered the letter dated 5.4.2000 received from the Central Govt. referring to the above letter stating therein that the Govt. of U.P. has informed that "they

have decided that medical colleges in U.P. shall admit the number of students as has been determined by the MCI for MBBS course. The Health Secretary, Govt. of U.P. has addressed a letter to Director General of Health Services U.P. and Principals of all medical colleges in this regard. The Govt. of U.P. has further informed that the process of giving autonomy to the medical colleges in U.P. is almost complete and facilities will be developed by the colleges to ensure that they fulfil the minimum requirements of medical colleges prescribed by the Council".

In view of the various steps taken by the State Govt., the Committee decided to give six months time to the concerned authorities to rectify the deficiencies for 50 admissions and send a compliance report to that effect for further consideration in the matter. Decision with regard to stopping postgraduate admissions at the institution however shall continue.

**23. MBBS (Manipal Academy of Higher Education - Deemed University) - Continuance of recognition in respect of students being trained at Kasturba Medical College, Mangalore.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Manipal Academy of Higher Education in respect of students being trained at Kasturba Medical College, Mangalore.

The Executive Committee considered the periodical inspection report (May, 98) of Kasturba Medical College, Mangalore along with the compliance report received from the Registrar, Manipal Academy of Higher Education, Manipal vide letter dated 17.4.2000 and decided to verify the compliance by way of an inspection for further consideration of the matter.

**24. MBBS (Manipal Academy of Higher Education - Deemed University) - Continuance of recognition in respect of students being trained at Kasturba Medical College, Manipal.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Manipal Academy of Higher Education in respect of students being trained at Kasturba Medical College, Manipal.

The Executive Committee considered the periodical inspection report (May, 98) of Kasturba Medical College, Manipal along with the compliance report received from the Registrar, Manipal Academy of Higher Education, Manipal vide letter dated 17.4.2000 and decided to verify the compliance by way of an inspection for further consideration of the matter.

**25. MBBS (The Tamilnadu Dr. MGR Medical University, Chennai) - Continuance of recognition in respect of students being at PSG Instt. of Medical Sciences, Coimbatore.**

Read : The periodical inspection report (21st & 22nd July, 99) along with the compliance report received from the college authorities for continuance of recognition of MBBS degree granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at PSG Instt. of Medical Sciences, Coimbatore.

The Executive Committee considered the periodical inspection report (21st & 22nd July, 99) of P.S.G. Institute of Medical Sciences, Coimbatore along with the compliance report received from the college authorities vide letter dated 16.3.2000 and

decided to verify the compliance by way of an inspection for further consideration of the matter.

**26. MBBS (Dibrugarh University) - Continuance of recognition in respect of students being trained at Assam Medical College, Dibrugarh.**

Read : The matter with regard to continuance of recognition of MBBS degree granted by Dibrugarh University in respect of students being trained at Assam Medical College, Dibrugarh.

The Executive Committee noted that the Committee at its meeting held on 17.9.97 considered the periodical inspection report (April, 97) of Assam Medical College, Dibrugarh in the absence of the observations of the University/college authorities wherein the Committee decided to send a final reminder to the concerned authorities for sending their observations. Final reminder was sent on 15.10.97 which also stands unreplied. The matter was again considered by the Committee at its meeting held on 2.7.98 and it was decided that a show cause notice be issued to the concerned authorities as to why steps should not be initiated to recommend to the Central Govt. to derecognise the institution for the award of MBBS degree for admitting more students beyond the sanction strength of the Council as seen from the inspection report and also many other deficiencies in over all infrastructural facilities on which the observations/compliance have not been received inspite of sending final reminder. One month time was granted to the institution by the Committee to send a reply. In response to the show cause notice compliance report regarding rectification of deficiencies was received from the Registrar, Dibrugarh University vide letter dated 20.8.98 and a letter dated 26.9.98 from the Secretary to the Govt. of Assam, Health & F.W. Department giving assurance to rectify the deficiencies. The compliance thus received was considered by the Executive Committee at its meeting held on 14.10.98. Since certain deficiencies noted in the inspection report are still to be complied with, the Committee granted 3 months time to the institution to send a proper compliance.

The Committee further noted that the last compliance report received from the Principal, Assam Medical College, Dibrugarh vide letter dated 2.1.1999 was also not satisfactory. It further noted the letter sent by the MCI on 5.2.99 to the college authorities to send a proper compliance touching on all the deficiencies pointed out in the inspection report for further consideration of the matter to which no reply has been received.

The Committee decided to give final 3 months time to the authorities to send a compliance. It also decided that a D.O. letter be sent to the Secretary (Health), Govt. of Assam, Health & F.W. Department requesting to take necessary steps in expediting sending the compliance report on rectification of the deficiencies pointed out in the inspection report of Assam Medical College, Dibrugarh. Copy of this letter be marked to the Member of the Council representing the State Govt.

**27. Change of name of Bombay University to Mumbai University in the schedule to the IMC Act, 1956.**

Read : The letter dt. 7th April, 2000 alongwith copy of notification received from University of Mumbai and Maharashtra State Govt. Gazette for change of name of Bombay University to Mumbai University in the schedule to the IMC Act, 1956.

The Executive Committee noted that according to the

notification issued by the University of Mumbai the name of Bombay University has been changed to University of Mumbai w.e.f. its publication in the Maharashtra State Govt. Gazette on 4th Sept., 96.

The Committee decided to recommend that MBBS/postgraduate (degree/diploma) qualifications granted by Mumbai University be recognised and included in the 1st Schedule to the I.M.C. Act, 1956 being change of name of Bombay University to Mumbai University.

**28. Establishment of new medical college at Shillong by North Eastern India Trust for Education and Development, Shillong - regarding.**

Read : The Central Govt's letter dt.10th March, 2000 seeking comments of the MCI with regard to establishment of new medical college at Shillong by North Eastern India Trust for Education and Development, Shillong who does not have its own hospital as required u/s 10A of the IMC Act, 1956 for establishment of the new medical college.

The Executive Committee considered the letter No.12012/80/99-ME(P), dated 10th March, 2000 received from the Central Govt., Ministry of Health & F.W. requesting to send the comments of the MCI whether any relaxation in the condition of owning and managing of 300 bedded hospital as required under the Regulations of the Council for establishment of the medical college can be given to the North Eastern India Trust for Education and Development, Shillong who has applied for seeking permission of the Central Govt. for establishment of new medical college at Shillong. The Executive Committee decided to convey to the Central Govt. that existing Regulations of the Council "the applicant should own and manage a hospital of not less than 300 beds with necessary infrastructure facilities capable of being developed into a teaching institution in the campus of the proposed medical college" should be followed. No relaxation in any case can be granted.

**29. Establishment of new medical college at Medak Distt. A.P. by Apollo Hospital Educational & Research Foundation, Hyderabad - Refund of application fee.**

Read : The letter received from the Administrator Apollo Hospital Educational & Research Foundation, Hyderabad requesting to refund the application fee submitted with the application for establishing medical college at Medak Distt. A.P.

The Executive Committee noted that the application fee which the applicant submits with the application is non-refundable and is for registration, technical scrutiny, contingent expenditure and for three inspections. It also noted that on receipt of the request of the Apollo Hospital Educational & Research Foundation, Hyderabad 50% of the application fee i.e.Rs.1.75 lakhs has already been refunded and decided not to agree to refund the full amount i.e. Rs.3.50 lakhs as requested.

**30. Establishment of new medical college at Sr. Jagadguru Murugharajendra Vidyapeetha (R) , Chitradurgaa u/s 10A of the IMC Act, 1956.**

Read : The Council Inspectors report (5th & 6th May, 2000) for establishment of new medical college at Sr. Jagadguru Murugharajendra Vidyapeetha (R), Chitradurga u/s 10A of the IMC Act, 1956.

The Executive Committee considered the Council Inspectors report (5th & 6th May, 2000) for establishment of new medical college at Sr. Jagadguru Murugharajendra Vidyapeetha (R), Chitradurga u/s 10A of the IMC Act, 1956 and noted the following:-

1. Certificate of Affiliation of University was issued by the Rajiv Gandhi University of Health Sciences, Bangalore for the academic year 1999-2000. Affiliation for the year 2000-2001 is not issued by the University.
2. Lecture theatres are not available.
3. Animal house is not as per Council's guidelines.
4. Central library does not have adequate number of books, journals, Xerox and microfilm reader.
5. There is no clear distribution of beds for any speciality as per Council recommendations. There is shortage of 157 teaching beds. Present distribution of available 87 beds in general male ward is unsatisfactory.
6. In all wards duty doctors room, pantry, examination/procedure room, teaching area, side laboratory etc. have not been provided.
7. In OPD space provided to different specialities is not sufficient. All the chambers of consultants have not been provided with basic facilities like examination tray, x-ray view box, injection room, plaster room, audiometry room, dark room, procedure room, teaching area etc.
8. Casualty department, operation theatres and labour rooms are commissioned but non-functional.
9. Central laundry, kitchen, canteen, incinerator, quarters are not available.
10. In the department of Anatomy there is no mortuary cooler, no provision for student lockers and no books in the departmental library.
11. In the department of Physiology no books are available in the departmental library.
12. In the department of Biochemistry, head of the department is non-medical and there is no book available in the departmental library.
13. Para clinical and clinical departments are not established.
14. Shortage of teaching staff is as under:-

15. Other observations made in the inspection report.

In view of the above, the Committee decided to recommend to the Central Govt. not to issue Letter of Intent for establishment of new medical college at Chitradurga by Sri Jagadguru Murugharajendra Vidyapeetha(R), u/s 10A of the I.M.C. Act, 1956.

**31. Establishment of new medical college (C.U. Shah Medical College) at Surendernagar by Saurashtra Medical Centre u/s 10A of the IMC Act, 1956.**

Read : The Council Inspectors report (15th & 16th May, 2000) for establishment of new medical college (C.U. Shah Medical College) at Surendernagar by Saurashtra Medical Centre u/s 10A of the IMC Act, 1956.

The Executive Committee considered the Council Inspectors report (15th & 16th May, 2000) for establishment of new medical college (C.U. Shah Medical College) at Surendernagar by Saurashtra Medical Centre u/s 10A of the IMC Act, 1956 and noted the following:-

1. Animal house with provision for experimental work is not yet ready.
2. The library complex as per plan submitted is not yet ready.
3. The facilities available in two reading rooms which can accommodate 60 and 20 persons respectively is not adequate to meet the requirement at inception.
4. The institution is short of accommodation for residents required at inception.
5. Residential accommodation for teaching staff as required at inception is not ready.
6. Chambers of OPD are not adequately equipped with wash basins, trolley, running water etc.
7. Beds in some of the wards are arranged more closely and temporary nursing stations have been provided and records of the wards and operation theatres are not maintained properly as required in a teaching hospital.
8. Casualty services have not been provided with proper resuscitation services. It does not have a defibrillator at present.
9. Clinical laboratories need improvement in space and equipments. There is no Microbiology or Histopathology services available at present.
10. The operation theatre is not equipped with on-line oxygen and proper emergency facilities.
11. Other observations made in the inspection report.

In view of above, the Committee decided to recommend to the Central Govt. not to issue Letter of Intent for establishment of new medical college (C.U. Shah Medical College) at Surendernagar

(Gujarat) by Saurashtra Medical Centre, u/s 10A of the I.M.C. Act, 1956.

**32. Establishment of new medical college at Gangtok by Sikkim Manipal University of Health, Medical Technolgical Sciences u/s 10A of the IMC Act, 1956 .**

Read : The compliance verification report (22nd, 23rd & 24th May, 2000) along with the inspection report (Oct., 99) for establishment of new medical college at Gangtok by Sikkim Manipal University of Health, Medical Technological Sciences u/s 10A of the IMC Act, 1956.

The Executive Committee considered the compliance verification report (22nd, 23rd & 24th May, 2000) along with the inspection report dated October, 1999 for establishment of a new medical college at Gangtok by Sikkim Manipal University of Health, Medical & Technological Sciences and noted the following:-

1. That two plots of land are available measuring 21.48 acres (5th mile) and 3.63 acres (6th mile) which makes a total of 25.11 acres. These two plots are located at a distance of 1.5 kms by road. However, if a short cut (hilly route) is taken then it is a 5 minutes walk but the area through which it passes does not belong to the institution.
2. According to the Memorandum of Understanding dated 30th Sept., 1998 reached between Manipal Pai Foundation, Manipal and Sikkim Manipal University of Health, Medical & Technological Sciences, Gangtok, Manipal Pai Foundation has acquired DIET complex at a cost of around Rs. 73 lakhs from the Govt. of Sikkim. This DIET complex is located in the 21.48 acres plot. The Engineering college complex is running temporarily on the DIET complex at present. Acquiring DIET complex by Manipal Pai Foundation has reduced the size of the plot of 21.48 acres available with the Sikkim Manipal University of Health, Medical & Technological Sciences, Gangtok. Thus, at present the Sikkim Manipal University of Health, Medical & Technological Sciences, Gangtok does not have a total of 25 acres of land.
3. The name of the institution is still maintained as Manipal Instt. of Medical Sciences.
4. Shortage of Staff:

May (upto 18.5.2000) - 163. For 150 admissions, nearly 600 patients per day are required at the time of inception. Hence, the OPD attendance is grossly inadequate.

Bed occupancy per day

April,2000 - 50%  
May (upto 18.5.2000) - 53%

However, on the day of inspection i.e. 23rd May,2000 the bed occupancy was 75% which is beyond comprehension as in view of the less OPD attendance, 75% bed occupancy normally is not possible. Other clinical material consisting major & minor surgical operations, casualty admissions and Radio-Diagnostic facilities are also not adequate.

6. So far no residential quarters have been constructed in the campus against the 10% Council requirement at inception.
7. The audio-metry room needs to be sound proof with silent air-conditioning and equipment.

In view of the above, the Executive Committee decided to recommend to the Central Govt. not to issue Letter of Intent for starting of a proposed medical college at Gangtok by Sikim Manipal University of Health, Medical & Technological Sciences, Gangtok.

**33. New medical college at Mehboobnagar by SVS Educational Society, Hyderabad - Renewal of permission for admission of the 2nd batch of students.**

Read : The Council Inspectors report (9th & 10th May,2000) for renewal of permission for admission of the 2nd batch of students i.e. 2000-2001 at Mahboobnagar by SVS Educational Society, Hyderabad.

The Executive Committee considered the Council Inspectors report (9th & 10th May,2000) for renewal of permission for admission of the 2nd batch of students for the academic session 2000-2001 at Mehboobnagar by SVS Educational Society, Hyderabad and noted the following:-

1. Shortage of teaching staff:

2. Clinical material is inadequate. Bed occupancy is 40 to 50%.
3. There is only 1 lecture theatre. One more lecture theatre with audio visual aids is required.
4. Animal house is small. Ventilation, water supply and

drainage facilities are not satisfactory.

5. Medical Education Unit is not available.
6. Common rooms for boys and girls are not provided.
7. OPD space is inadequate. OPD needs reorganisation by providing more space and infrastructural facilities as per Council requirement.
8. Wards are not provided with doctors duty room, student duty room, pentry, examination & treatment room, teaching areas etc.
9. Only 1 operation theatre is functional. Casualty O.T. is not provided with necessary equipment.
10. Kitchen and incinerator have not been provided.
11. Para clinical departments i.e Pathology, Microbiology, Pharmacology, Forensic Medicine & PSM are not established. Limited space is provided for staff members to seat.
12. Clinical departments are not fully established.
13. Other observations made in the inspection report.

In view of above, the Committee decided to recommend to the Central Govt. not to renew the permission for admission of 2nd batch of students for the academic session 2000-2001 at SVS Medical College, Mehboobnagar, Hyderabad u/s 10A of the I.M.C. Act,1956.

34. **Acharya Sri Chander College of Medical Sciences, Jammu - Renewal of permission for admission of the 5th batch of students.**

Read : The Council Inspectors report (23rd & 24th May,2000) for renewal of permission for admission of the 5th batch of students at Acharya Sri Chander College of Medical Sciences, Jammu.

The Executive Committee on considering the Council Inspectors report (23rd & 24th May,2000) decided to recommend to the Central Govt. to renew the permission for admission of the 5th batch of students for the academic session 2000-2001 at Acharya Sri Chander College of Medical Sciences, Jammu with an annual intake of 100 students.

35. **Increase of MBBS seats from 125 to 150 at Rajah Muthiah Medical College, Annamalainagar - Renewal of permission for the 3rd batch i.e. for the session 2000-2001.**

Read : The compliance verification report (10th & 11th May, 2000) alongwith the inspection report( 3rd & 4th March, 2000) for renewal of permission for admission of the 3rd batch of students against the increased intake i.e. 125 to 150 at Rajah Muthiah Medical College, Annamalainagar.

The Executive Committee considered the compliance verification report (10th & 11th May,2000) carried out on receipt of the compliance on the deficiencies pointed out in the inspection report (3rd & 4th March,2000) received through the Central Govt. for renewal of permission for admission of the 3rd batch of students against the increased intake i.e. 125 to 150 at Rajah Muthiah Medical College, Annamalainagar.

The Committee further noted that the Dean, Faculty of Medicine, Annamalai University vide letter dated 25.5.2000 has furnished the information regarding the appointment of 11 Tutors in various departments after the compliance verification inspection which was carried out on 10th & 11th May, 2000 and decided to verify the same by way of an inspection.

The Committee further decided to authorise the President to decide in the matter on receipt of the compliance verification report.

**36. Starting of new medical college at Moradabad by Moradabad Charitable Trust & Research Centre, Moradabad u/s 10A of the IMC Act, 1956.**

Read : The letter dt.4th May, 2000 from the Secretary, Govt. of Uttar Pradesh as forwarded by the Central Govt. vide letter dt.9th May, 2000 requesting to consider the matter in light of the letter received from the Secretary to the Govt. of Uttar Pradesh regarding issue of Essentiality Certificate for starting of medical college at Moradabad.

The Executive Committee noted that the Committee at its meeting held on 4.11.1999 on careful consideration of the Scheme, compliance and compliance verification report (Oct., 99) decided to recommend to the Central Govt. not to issue Letter of Intent for establishment of new medical college at Moradabad by Moradabad Charitable Trust and Research Centre, Moradabad u/s 10A of the I.M.C. Act, 1956 in view of the deficiencies of staff and other infrastructural facilities for establishment of a medical college. The Committee further noted that the Central Govt. vide letter dated 17.1.2000 had forwarded the compliance report submitted by the college authorities which was scrutinised by the Council office. Since the compliance submitted was not satisfactory and the Essentiality Certificate issued by the State Govt. for establishment of the proposed medical college at Moradabad is expiring on 12.3.2000, the Council office vide letter dated 15.2.2000 returned the Scheme to the Central Govt. for disapproval.

The Executive Committee further considered the letter dated 4.5.2000 from the Secretary, Govt. of Uttar Pradesh as forwarded by the Central Govt. vide letter dated 9.5.2000 requesting to consider the matter in light of the letter received from the Secretary of Govt. of Uttar Pradesh.

The Committee further noted that the Secretary, Govt. of Uttar Pradesh in his letter has informed that the matter regarding revalidation of Essentiality Certificate is under active consideration of the State Govt. and a decision in this regard will be taken soon. He also informed that till decision is taken in the matter, the Essentiality Certificate/No Objection Certificate should not be treated as time barred.

In the absence of clear cut letter from the State Govt. extending the date of Essentiality Certification/No objection certificate, the Committee decided to reiterate its earlier decision taken, requesting the Central Govt. to disapprove the Scheme for starting of Medical College at Moradabad by Moradabad Charitable Trust.

The Committee further decided that the college authorities may apply afresh after the Essentiality Certificate is renewed by the State Govt.

**37. Academy of Medical Sciences, Kannur - Recognition of the college for the award of MBBS degree granted by Calicut University.**

Read : The Council Inspectors report (22nd,23rd & 24th May, 2000) for recognition of the college i.e. Academy of Medical sciences, Kannur for the award of MBBS degree granted by Calicut University.

The Executive Committee considered the Council Inspectors report (22nd, 23rd & 24th May,2000) carried out to assess the undergraduate teaching facilities available at Academy of Medical Sciences, Kannur along with the standard of examination held under Calicut University and noted the following:-

1. The hospital building has to be commissioned by shifting wards, operation theatre complex and ICUs etc. at the earliest.
2. The auditorium has not been furnished properly.
3. The medical education unit requires enhancement of equipment and other facilities.
4. The interns hostel in the rural health centre has not been completed and commissioned as yet.
5. The boys hostel block is also not completed.
6. Residential accommodation for the staff is yet to be constructed and enhanced.
7. The casualty needs more equipment for resuscitation and monitoring.
8. The ICUs also need to be enhanced in equipment.
9. The CSSD and laundry is required to be established in the new hospital building.
10. Other observations made in the inspection report.

Taking into consideration the above noted observations, the Committee decided to recommend to the Central Govt. not to renew the permission for admission of 6th batch of students for the academic session 2000-2001 at Academy of Medical Sciences, Kannur.

The Committee further decided that the matter regarding recognition of the college for the award of MBBS degree granted by Calicut University may be considered after complying with all the requirements as per the project report.

**38. Mata Gujri Memorial Medical College, Kishanganj - Recognition of the college for the award of MBBS degree granted by B.N. Mandal University, Madhepura, Bihar.**

Read : The Council Inspectors report (16-19th May,2000) for recognition of Mata Gujri Memorial Medical college Kishanganj for the award of MBBS degree granted by B.N.Mandal University, Madhepura, Bihar.

The Executive Committee considered the Council Inspectors report (16-19th May,2000) carried out to assess the undergraduate teaching facilities available at Mata Gujri Memorial Medical College, Kishanganj along with the standard of examination held under B.N. Mandal University, Madhepura, Bihar upon receipt of

request u/s 11(2) of the I.M.C. Act,1956 forwarded through the Central Govt. vide its letter 18.4.2000 and further that a legal opinion for carrying out the inspection was sought from the Council Advocate on 18.11.1999 and noted the following:-

1. The shortage of staff is as under:-

Professors - 5 : (Orthopaedic-1, Obst. & Gynae.-1, Anaes.-1, Paed.-1, Dentistry -1).

Readers -6 : (Physiology-1, Pharmacology-1, Microbiology-1, Psychiatry -1, Skin-1, Radio-Diagnosis - 1).

Lecturers - 7 :(Anatomy -2, Physiology-1, Pharmacology-1, PSM-1, Skin -1, Anaesthesia -1).

Tutor/Registrars -2 : (Anatomy-1, Biochemistry-1).

Lecturer/Epidmiologist - 1 (PSM).

Lecturer/Statistician - 1 (PSM).

Pharm.Chemist - 1(Pharm.)

Total staff requirement - 109

Percentage deficiency - 21%

2. There is shortage of x-ray machine as per the MCI requirement.
3. There is deficiency of pre-anaesthetic medication room, post-operative recovery room in the operation theatre. There is also shortage of equipment in the ICU/ICCU.
4. The space in the OPD is less. There is over-crowding of patients. The space is also short for teaching activities.
5. The Medical Education unit is not functional.
6. The casualty services are required to be upgraded.
7. The Medical Record department is not upgraded and made functional.
8. The Central Sterilisation department is not properly developed.
9. Other observations made in the inspection report.

In view of above, the Committee decided not to recommend recognition of Mata Gujri Memorial Medical College, Kishanganj, Bihar for the award of MBBS degree granted by B.N. Mandal University.

**39. To consider the Council Inspectors report carried out to assess the facilities available at Govt. Medical College, Mysore for teaching and training of Undergraduate (MBBS) students.**

Read : The Council Inspectors report (11th & 12th May, 2000) carried out to assess the facilities available at Govt. Medical College, Mysore for teaching and training of Undergraduate (MBBS) students.

The Executive Committee considered the Council Inspectors report (11th & 12th May, 2000) of Govt. Medical College, Mysore carried out to assess the undergraduate teaching and training facilities available at the college and noted over all deficiencies including gross deficiencies in the staff.

The Committee decided to obtain the information pertaining to the admissions being made to all the postgraduate degree/diploma courses which are being run by the college for further consideration in the matter as on receipt of this information the total deficiencies of staff for the sanctioned number of admissions can be calculated.

**40. MBBS (Rajasthan University) - Continuance of recognition in respect of students being trained at S.P. Medical College, Bikaner.**

Read : The periodical inspection report (July, 98) alongwith the compliance report received from the college authorities for continuance of recognition of MBBS degree granted by Rajasthan University in respect of students being trained at S.P. Medical College, Bikaner.

The Executive Committee considered the periodical inspection report (July, 98) along with the compliance report on the deficiencies pointed out in the inspection report submitted by the Principal, S.P. Medical College, Bikaner vide letter dated 10.5.2000 and decided to recommend that recognition of MBBS degree granted by Rajasthan University in respect of students being trained at S.P. Medical College, Bikaner be continued with an annual intake of 100 students.

**41. (Saurashtra University ) - Continuance of recognition in respect of students being trained at M.P. Shah Medical College, Jamnagar.**

Read : The periodical inspection report (Jan., 94) alongwith the compliance report and letter from the Commissioner, Health Medical Services and Medical Education, Govt. of Gujrat requesting to grant 3 months time for filling up various posts at M.P. Shah Medical College, Jamnagar and submission of the compliance.

The Executive Committee considered the periodical inspection report (Jan., 94) alongwith the compliance report and letter from the Commissioner, Health Medical Services & Medical Education, Govt. of Gujrat requesting to grant 3 months time for filling up various posts at M.P. Shah Medical College, Jamnagar and for submission of the compliance and decided to grant 3 months time as requested.

**42. MBBS (Pune University ) - Continuance of recognition in respect of students being trained at Armed Forces Medical College, Pune.**

Read : The compliance verification report (5th & 6th May, 2000) along with the inspection report 18th & 19th Nov., 98 for continuance of recognition of MBBS degree granted by Pune University.

The Executive Committee considered the compliance verification report (5th & 6th May, 2000) along with the inspection report 18th & 19th Nov., 98 and decided to recommend that recognition of MBBS degree granted by Pune University in respect of students being trained at Armed Forces Medical



College, Pune be continued with an annual intake of 140 students.

43. **To consider the letter received from the Chief Minister, Govt. of Madhya Pradesh with regard to lowering of percentage of marks for admission to postgraduate medical courses.**

Read : The letter received from the Chief Minister, Govt. of Madhya Pradesh with regard to lowering of percentage of marks for admission to postgraduate medical courses.

The Executive Committee perused the letter received from the Hon'ble Chief Minister of State of Madhya Pradesh Shri Digvijay Singh requesting the Council that the percentage of marks as qualifying marks which is fixed as 35% for general category and 25% for reserved category instead of 50% and 40% may be reviewed and re-fixed by the MCI in the interest of backward classes of the State.

The above mentioned request on behalf of the State of Madhya Pradesh was examined and considered by the Executive Committee in light of the judgement of the Hon'ble Supreme Court in the case of Dr. Preeti Srivastava Vs. State of Madhya Pradesh. The decision of the Council as per the direction of the Hon'ble Supreme Court in the case of Dr. Preeti Srivastava is still in process and is yet to be finalised. It had been clearly stipulated by the Hon'ble Supreme Court in the judgement in the case of Dr. Preeti Srivastava but till such time the Council decides the issue finally as directed by the Hon'ble Supreme Court, the percentage of 50% for general category candidates and 40% for Scheduled Caste category candidates as is being followed for admission in undergraduate (MBBS) course, shall be followed for admissions to Postgraduate courses.

In view of this clear observation / direction of the Hon'ble Supreme Court, the Executive Committee of the Council does not find itself in a position to accept the request on behalf of the State of Madhya Pradesh. This may be informed to the State Govt. accordingly.

44. **Additional name of Hospitals recognised by the Council for purposes of compulsory rotating Internship Training - Information thereon.**

The Executive Committee noted the additional name of Hospitals recognised by the Council for purpose of compulsory rotating internship training as under:-

45. **Fr. Muller's Medical College at Mangalore by Fr. Muller's Charitable Institute, Mangalore - Renewal of permission for admission of the 2nd batch of students.**

Read : The compliance verification report (20th May, 2000) along with the inspection report (March, 2000) for renewal of permission for admission of the 2nd batch of students i.e. for the academic session 2000-2001 at Fr. Muller's Medical College at

Mangalore.

The Executive Committee considered the compliance verification report (20th May, 2000) carried out on receipt of the compliance on the deficiencies pointed out in the inspection report (3rd & 4th March, 2000) through the Central Govt. and decided to recommend to the Central Govt. to renew the permission for admission of the 2nd batch of students for the academic session 2000-2001 at Fr. Muller's Medical College, Mangalore with an annual intake of 100 students.

**46. Increase of MBBS seats from 210 to 250 at B.J. Medical College, Ahmedabad - Renewal of permission for the academic session 2000-2001.**

Read : The Council Inspectors report (18th, 19th & 20th May, 2000) carried out for renewal of permission for admission of the students against the increased intake i.e. from 210 to 250 at B.J. Medical College, Ahmedabad for the academic session 2000-2001.

In light of the fax message dated 25.5.2000 received from the Commissioner, Health, Medical Services & Medical Education (Health Section), Govt. of Gujarat regarding additional information, the Executive Committee decided to verify the same by way of an inspection and authorised the President to decide in the matter on receipt of the compliance verification report.

**47. Increase of MBBS seats from 140 to 180 at Medical College, Vadodra - Renewal of permission for the academic session 2000-2001.**

Read : The Council Inspectors report (18th, 19th & 20th May, 2000) carried out for renewal of permission for admission of the students against the increased intake i.e. from 140 to 180 at Medical College, Vadodra for the academic session 2000-2001.

In light of the fax message dated 25.5.2000 received from the Commissioner, Health, Medical Services & Medical Education (Health Section), Govt. of Gujarat regarding additional information, the Executive Committee decided to verify the same by way of an inspection and authorised the President to decide in the matter on receipt of the compliance verification report.

**48. MBBS (Shivaji University) - Continuance of recognition in respect of students being trained at D.Y. Patil Medical College, Kolhapur.**

Read : The periodical inspection report (27th & 28th Oct., 99) alongwith the compliance report received from the Dean, D.Y. Medical College, Kolhapur for continuance of recognition of MBBS degree granted by Shivaji University.

The Executive Committee considered the periodical inspection report (27th & 28th Oct., 99) along with the compliance report received from the Dean, D.Y. Patil Medical College, Kolhapur vide letter dated 28.4.2000 and decided to verify the compliance report by way of an inspection immediately.

**49. To note the letter of permission/Disapproval of the scheme issued by the Central Govt. for establishment of new medical colleges/increase of seats u/s 10A of the IMC Act, 1956.**

The Executive Committee noted the Letter of

Permission/Disapproval of the Scheme issued by the Central Govt. for establishment of new medical colleges/increase of seats u/s 10A of the I.M.C. Act, 1956 as follows:-

1. Establishment of new medical college at Toothukudi (Tuticorin) Tamil Nadu. Letter of Permission issued by the Central Govt. in April 2000 for establishment of the college with annual intake of 100 students for the academic year 2000-2001 (for a period of one year).
2. Establishment of new medical college at Nellore by Narayana Educational Society. Letter of Permission issued by the Central Govt. on 17th April 2000 for establishment of the college with annual intake of 100 students with prospective effect (for a period of one year).
3. Establishment of new medical college at Asthal Bohar, Rohtak by Shri Baba Mast Nath Ayurved and Sanskrit Shikshan, Asthal Bohar, Rohtak. Central Govt. disapproved the scheme for establishment of medical college at Asthal Bohar vide letter dt. 10th May, 2000.
4. Increase of MBBS seats from 65 to 100 at Indira Gandhi Medical College, Shimla. Central Govt. disapproved the scheme for increase of MBBS seats from 65 to 100 at Indira Gandhi Medical College, Shimla vide letter dated 11th April, 2000.
5. Increase of MBBS seats from 50 to 100 at NKP Salve Instt. of Medical Sciences and Research Centre, Nagpur. Central Govt. disapproved the scheme for increase of MBBS seats from 50 to 100 at NKP Salve Instt. of Medical Sciences and Research Centre, Nagpur vide letter dt. 24th April, 2000.
6. Increase of MBBS seats from 70 to 100 at Goa Medical College, Goa. Central Govt. disapproved the scheme for increase of MBBS seats from 70 to 100 at Goa Medical College, Goa vide letter dt. 11th April, 2000.
50. **NTR University of Health Sciences, Vijaywada - Admission into Ist MBBS course for the academic year 1999-2000 at Narayana Medical College, Nellore.**

Read : The matter with regard to admission to Ist MBBS course at Narayana Medical College, Nellore for the academic year 1999-2000 in view of the letter of Permission for admission of the students issued by the Central Govt on 17/4/2000.

The Executive Committee noted that the Council had received a letter dated 22.3.2000 from the Registrar, NTR University of Health Sciences, Vijaywada in response to the query with regard to cut-off date for the last admission made each year. The Registrar had informed that as per regulations the admission to the MBBS course shall close at the end of 30 days from the date of commencement of classes and the classes commenced on 30.12.99 (meaning thereby that admissions are closed on 30.11.99).

While communicating the decision of the Executive Committee to recommend to the Central Govt. to issue Letter of Permission for starting of Narayana Medical College, Nellore by Narayana Educational Society u/s 10A of the I.M.C. Act, 1956 with annual intake of 100 students for the academic session 2000-2001. Copy of the above letter of the NTR University of Health Sciences was sent to the Central Govt. for their information.

The Central Govt. vide letter dated 17th April, 2000 had issued Letter of Permission for establishment of Narayana Medical College, Nellore by Narayana Educational Society, Nellore with annual intake of 100 students with prospective effect for a period of one year.

In the meantime, news-item "Admission to MBBS & BDS courses in private colleges for the year 1999-2000" issued by NTR University of Health Sciences appeared in Telugu Dailies, wherein it was mentioned that "applications are invited from Indian nationals who have qualified at EAMCET 99 of Andhra Pradesh held on 17.5.99 for admission into 1st year MBBS and BDS courses for the academic year 1999-2000 into Narayana Medical College, Nellore and CKS Teja Institute of Dental Sciences & Research, Tirupati, Private Colleges local to SVU region.

In view of the letter received from the NTR University of Health Sciences regarding cut off date for admission to MBBS course, the Registrar, NTR University of Health Sciences vide MCI letter dated 9.5.2000 was requested to send clarifications/comments in the matter.

The Registrar, NTR University of Health Sciences vide fax dated 16.5.2000 has informed that the Govt. of India vide letter dated 17th April, 2000 has granted permission for establishment of a medical college at Nellore. The letter of permission states that the permission is with prospective effect for a period of one year and it will be renewed on yearly basis on verification of achievements of annual targets set out in the project report. As per the above Central Govt.'s letter the permission is valid for one year and only one batch of students is to be admitted initially for a period of one year. The management of Narayana Educational Society, Nellore has requested to admit the students for 1999-2000.

The University has issued notification for admission of students for the year 1999-2000 only and the management was informed that the admission for the next batch of students will be considered only after receiving another letter of permission from the Govt. of India for the next academic year.

The Executive Committee noting the above facts decided to inform the Central Govt. that MCI will not be carrying out inspection for renewal of the permission at this college for the academic session 2000-2001 to avoid duplication of batches in one academic year and further that the Central Govt. should have mentioned the academic session while granting the permission for making admissions against this medical college rather than only writing "with prospective effect for a period of one year" to avoid any confusion in future.

**51. Introduction of condensed MB (Diploma) course of 3 1/2 at Calcutta National Medical College & Hospital, Calcutta.**

Read : The letter dated 16th May, 2000 received from the Secretary, Health & F.W. Deptt, Govt. of West Bengal in response to the decision of the Executive Committee taken at its meeting

held on 24/3/2000.

The Executive Committee decided to defer the consideration of the matter to its next meeting.

52. **Special leave to Appeal(Civil), No.18/2000 filed by Medical Council of India v/s Subharati K.K.B. Charitable Trust before the Hon'ble Supreme Court - Compliance of the Orders thereto.**

Read : The Council Inspectors report (9th & 10th May, 2000) carried out in compliance of the Hon'ble Supreme Court order in special leave to Appeal(Civil), No.18/2000 filed by Medical Council of India v/s Subharati K.K.B. Charitable Trust.

The decision taken by the Executive Committee under this Item be submitted to the Hon'ble Supreme Court.

53. **Extension of services to Shri Kishori Lal, Asst. Secretary in the Council office.**

Read : The matter with regard to extension of services to Shri Kishori Lal, Asst. Secretary in the Council office for a further period of one year.

The Executive Committee approved the extension of service for a further period of one year w.e.f.01.06.2000 to Shri Kishori Lal, Assistant Secretary in the Council office.

54. **Issue of Untrue, misleading & Improrpoer Medical Certificate to Dr. Sandeep Sethi, Regn.No.MCI-4273, April, 1983 - Awarding punishment thereof.**

Read : The matter with regard to awarding punishment to Dr. Sandeep Sethi for issuing untrue, misleading & improper medical certificate to an employee of the Council working as peon.

The Executive Committee deliberated in the matter and noted that Dr. Sandeep Sethi registered with the Council under Regn. No. MCI-4273, April,1983 has violated the provisions of the Code of Medical Ethics regarding issuing a medical certificate. The Committee decided that since this is the first matter which has come to the notice of the Council, the concerned doctor may be warned strictly and be advised to follow the Code of Medical Ethics strictly in such matters in future.
