5. **Approval of the minutes of the meeting of Administration & Grievance Committee held on 11.12.2015.**

The Executive Committee of the Council perused the minutes of the meeting of Administration & Grievance Committee held on 11.12.2015 and approved item nos. 1 & 3 and with regard to rest of the items, the Committee observed as under pointwise:-

Item No.2

Ragging at Darbhanga Medical College: It appears that sub-committee has not recommended any action against the college or against the student Shri Chandan Pathak who appeared before the sub-committee. It is noted with concern that Dean has not taken any action to ensure presence of 2nd student Shri Chandan Kumar. He may be called forthwith. If he does not appear before sub-committee, action be taken against him *ex-parte*.

However, E.C. decided that action as has been taken against an institute similarly placed may be reiterated and therefore a fine of Rs. 1 Lakh may be imposed on the institute. It was also decided that minimum punishment to be awarded in all such cases is suspension for 6 months and accordingly Dean be directed to put Shri Chandan

Pathak under suspension for 6 months w.e.f. and submit compliance within 2 weeks. E.C. also decided to advise the sub-committee to recommend the action on this line in all similar cases in future. Further if 2nd student Shri Chandan Kumar does not appear before sub-committee, action be taken against him *ex-parte*. Referred back with above observations.

Ragging at Jorhat Medical College: No details of enquiry report & letters of Principal have been recorded in Minutes. In absence of these particulars, no decision can be taken. Sub-committee is requested to incorporate these details in Minutes & resubmit the item.

1. Deficiency of faculty is 36.73 % as detailed in the report.
2. Shortage of Residents is 88.13 % as detailed in the report.
3. Majority of Residents are not staying in campus.
4. OPD: Staff for Registration counters is inadequate. Waiting area is inadequate. Enquiry desk is not available. Teaching area is not available. Injection room is common for males & females. ECG room is not available. Dressing room is common for males & females. Minor OT is not available. Plaster room & Plaster Cutting room are common. In Ophthalmology OPD, Dark Room & Dressing room are not available. Special clinics are not available in Paediatrics & O.G. OPD.
5. Bed occupancy is 49 % on day of assessment.

7. Wards: Examination cum Treatment room, Pantry are not available in any ward. Demonstration room, Duty room are not available in most of the wards.
8. There was only 01 Major operation for the whole hospital on day of assessment.
9. Casualty: Only 14 beds are available against requirement of 25. Separate Casualty for O.G. is not available. C.M.O.s are less than required. Disaster Trolley, Resuscitation equipment, Crash Cart, Defibrillator, Ventilator are not available.
10. Central Clinical Laboratory: Separate sections for Pathology, Microbiology, Biochemistry are not available.
11. O.T.s: Infusion Pumps are not available. All O.T.s do not have basic concept of sterile environment and persons circulating within O.T.s are not changing to O.T. dress. O.T.s are used as storage room also. Preoperative & Postoperative wards are not available.
12. ICUs: ICCU & ICUs are not air-conditioned. Central O₂ and Central Suction are not functional. Major equipment is not available. There was NIL patient in ICCU & SICU and only 1 patient in MICU on day of assessment.
13. CT Scan is 6 slice against 16 slice required.
14. Blood Bank: Blood component separation facility is not available.
15. CSSD: It is not available.
16. Speech Therapy is not available.
17. Available areas of Dean's office, college office are smaller than required.
18. Pharmaco Vigilance Committee: No meeting has been held during the past year.
19. Examination Hall: Available hall has capacity of 100 against 250 required.
20. Lecture Theaters: Audio Visual aids & E class facility are not available in any lecture theater. Hospital Lecture Theater is not available.
21. Central library: Available area is 776 sq.m. against requirement of 1,600 sq.m. Capacity of Students' reading room (Outside) & Students' reading room (inside) is 30 & 70 respectively against requirement of 100 each. Capacity of Staff reading room is only 10. Residents' reading room is not

available. Internet nodes are not functional. Recent editions of books and journals are not available.

22. Students' Hostels: I M.B;B.S. girls are kept in common hall. They are unhygienic. They are inadequately furnished. Toilet facilities are inadequate. There is no Study room, inadequate recreation facility, no gymnasium.
23. Residents' Hostel: it is not available.
24. Intercom is not available.
25. Central Research Laboratory is not available.
26. Common Rooms for Boys & Girls are not available.
27. Paramedical & non-teaching staff: Only 97 paramedical & non-teaching staff are available against 160 required.
28. Anatomy department: Only 1 Demonstration room is available against requirement of 2. Audiovisual aids are not available. There is only 1 cadaver. Only 75 specimens are available. Articulated & Disarticulated Bone sets are not available. Lockers are not available.
29. Physiology & Biochemistry department: Capacity of Demonstration room is smaller than required. Audiovisual aids are not available.
30. NIL Demonstration rooms are available in paraclinical departments of Pathology, Microbiology, Pharmacology & Forensic Medicine. Museum facilities are inadequate.
31. Community Medicine department: Demonstration room is smaller than required and is combined with museum. Audiovisual aids are not available.
32. RHTC: Residential accommodation is not available. Specialists' visits are not organized.
33. UHC: Specialists' visits are not organized.
34. Website: Toll free number to report ragging is not provided.
35. Other deficiencies as pointed out in the assessment report.

Orthopaedics ward has no examination room, no pantry. In many wards, patients are lying on cots in lobby. Ophthalmology, ENT wards are under renovation and non-functional.

In view of the above, as the applicant college does not meet the Qualifying Criteria 6(b)(i) , 6(b)(ii) & 6(b)(iii) of Opening of New or Higher Courses of Study or Training (including Postgraduate Course of Study or Training) and increase of Admission Capacity in any course of Study or Training (including Postgraduate Course of Study or Training) (Amendment) Regulations,2009 (Part-III) as number of teaching beds, OPD attendance and Bed occupancy are less than the required for eligibility, the Executive Committee of the Council decided to return the application for increase in MBBS seats from 150 to 250 at D.Y. Patil Medical College, Navi Mumbai under Dr. D Y Patil University (Deemed), Navi Mumbai u/s 10A of the IMC Act 1956 for academic year 2016-17 recommending disapproval of the scheme to the Central Govt. as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the Regulations framed therein to keep the application pending in the Council office for the next academic year.

7. Wards: Distance between 2 beds is < 1.5 m. There is a common Nursing station for all the wards. Ancillary ward facilities are inadequate.

10. Histopathology & Cytopathology are not done in the institute.

6. ICUs: There was NIL patient in ICCU & SICU and only 1 patient in MICU and only 2 patients in NICU/PICU on day of assessment.
7. ETO Sterilizer is not functional.
8. Nursing staff: 162 Nurses are available against 175 required.
9. Lecture Theater: Out of 2 Lecture Theaters required, 1 is still under construction.
10. Central Library: Building is under construction. Internet Nodes are not available. Only 1,561 books are available against requirement of 3,000.
11. Common Rooms for Boys & Girls are under construction.
12. Students' Hostels are under construction.

39. **Renewal of permission for MBBS course for 5th batch (100 seats) of Lord Buddha Koshi Medical College & Hospital, Saharsa, Bihar under B.N Mandal University, Madepura u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.**

Read: the matter with regard to renewal of permission for MBBS course for 5th batch (100 seats) of Lord Buddha Koshi Medical College & Hospital, Saharsa, Bihar under B.N Mandal University, Madepura u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors letter dated 24/11/2015 and noted the following:-

1. We three assessors (Dr. P. Venkata Krishna, Dr. SK Dhattarwal and Dr. Arnab Sengupta), reached Lord Buddha Koshi Medical College and Hospital, Saharsha, Bihar on 23rd November, 2015 at 9 AM.
2. As per clause vi) of assessment appointment letter, we asked the Dean, Dr. J. Prakash and RN Sinha, Medical Superintendent for communicating to the faculty and residents to put their signature on the department wise attendance sheet. This was repeatedly announced that, this must be completed by 11 A.M. In spite of that, only 34 faculty members and residents signed the attendance sheet.
3. Immediately on reaching there, we asked for videographic and photographic facilities and only one videographer and photographer came at about 12 noon, while we asked for three. In the meantime we used our own phone cameras to take pictures of the college. However, many times they objected to this and tried to prevent us taking photographs. We are sending those photographs along with this.
4. In those photographs it is clearly evident that, the faculty shown on the display boards was not available and existent and most of the OPDs were empty.
5. The videographer and the photographer were instructed to hand over the DVD to the assessors by 4PM, because we completed the required activities upto 2 PM; but the Chairman prevented the videographer and the photographer busy in shooting video and photographs of the delayed faculty and residents which was witnessed by the police officials present during the process.
6. The chairman prevented the assessors from verifying the faculty and residents from 2.30 PM to 4 PM on 23rd November, 2015. So we completed the verification of declaration forms with police escort up to 7.30 PM.
7. Fake patients were being shifted from one ward to another even in front of us.
8. When assessment team went to ENT indoor ward, it was found to be room only with declaration forms being prepared by two persons.
9. Some of the faculty members do not know each other in the same departments and HOD did not know departmental labs and demonstration rooms including library.
10. In Emergency room, ICCU and OT expired and fungus affected life saving drugs were found.
11. In casualty no injury register was available and in the police information booklet there was gap of six months, five months and nine months in subsequent entries in different years.
12. Some of the declaration forms presented to the assessors were not signed by the HOD, Dean and not even by the concerned faculty/residents.
13. There is evidence of fake signatures of different HODs.
14. Wherever the assessors were going the Chairman, Dr. P.K Singh and his personal men interfered into every matter. But the Dean or MS were not seen to accompany the assessors.
15. At about 4 PM the chairman of the said medical college Dr. P.K Singh along with a few others started making derogatory comments to us. He resorted to threaten us to follow their suit. After this, all the three assessors were surrounded by the alleged faculty members and some employees of the college, who were instigated by the chairman and personal staff to get declaration forms being signed forcibly by the assessors and they threatened us to keep us hostage unless we acceded to their threat. We were forced to collect the declaration forms of those faculty members and residents, who did not sign attendance sheet up to 11AM. The overall situation was extremely hostile and there was tremendous threat perception to all the assessors. This was brought to the notice of MCI at 8527585678 and 9810208745. Subsequently police personnel along with SHO of local PS came to college council room and rescued us at 7.30 PM.
16. At about 11 PM on 23rd November, 2015 one person came to our hotel at Saharsha and handed over two copies of DVD and asked for the receipt that we have received the videography and photography cds. We told that we have to verify the cds and then only we can give the receipt or otherwise give

copies of the cds to the Dean and collect the receipt from him. Then he left away. On detail examination, they were found to be totally edited and evidence of deficiencies were found deleted at most of the places. The video has been prepared at the instance of chairman personnel and not on the direction of the assessors. So we felt that further process of the assessment is not justified and we felt threat to our lives and returned back and informed the same to the MCI on phone.

17. *As a result, we could not complete the assessment process.*

18. *We left Saharsa at 8 AM on 24th November, 2015."*

3. Bed occupancy was 20.2 % on day of assessment.
4. OPD: No staff was available at Enquiry desk at time of taking round in OPD. Injection rooms for Male/Female are not available. Minor O.T. is not available. Plaster room & Plaster cutting room are common. Specialty clinics are not available in Paediatrics OPD.
5. Teaching beds: 499 beds are available against 506 required.
6. Wards: 5 beds in Paediatrics were without mattresses. Demonstration room is not available in several wards.
7. OPD attendance was 850 against 900 required.
8. There were only 06 Major Surgical operations & NIL Minor operations for the whole hospital on day of assessment.
9. There were only 2 Normal Deliveries & NIL Caesarean Section on day of assessment.
10. O.T.s: All O.T.s have more than 1 table which is not as per norms.
11. ICUs: There were NIL patient in SICU & only 2 patients in ICCU and NICU/PICU on day of assessment.
12. Examination Hall: There are 5 mall halls with total capacity of 210 against requirement of 250. Additional 80 capacity is provided in corridor which is not permissible.
13. Lecture Theaters: E class facility is not available in any lecture theater in college or hospital.

14. Central Library: Available area is 1,500 sq.m. against requirement of 1,600 sq.m. Outside Reading Room has capacity of 40 against requirement of 100 and is located in corridor of top floor of academic building where only tables are available without any seating arrangement
15. Residents' Hostel: Residents & Nursing staff along with faculty & non-teaching staff stay together in 2 blocks with 78 rooms against requirement of 67 Residents & 50 Nurses. Hence accommodation available for Residents is grossly inadequate.
16. Nurses' Hostel: Nursing staff along with Residents, faculty & non-teaching staff stay together in 2 blocks with 78 rooms against requirement of 50 Nurses & 67 Residents. Hence accommodation available for Nurses is grossly inadequate.
17. Residential Quarters for Non-teaching staff are not available.
18. Central Research laboratory is not available.
19. Anatomy department: Audiovisual aids are not available in both Demonstration rooms. Cold storage for dead bodies is shared with Forensic Medicine department. There was no dead body & it was locked at time of assessment. Dissection Hall is on 5th floor without any lift for carrying cadavers.
20. RHTC: In Girls' block, there was no bed at time of assessment. Proper dining facility is not available.
21. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for increase of seats in MBBS course from 100 to 150 u/s 10A of the IMC Act 1956 in respect of Maharashtra Institute of Medical Sciences and Research, Latur for the academic year 2016-17.

6. Histopathology workload is only 04 & Cytopathology workload is only 03 on day of assessment.
7. Microbiology & Serology workload is inadequate.
8. There were only 2 patients each in ICCU, MICU on day of assessment which is inadequate.
9. Nursing staff: Only 304 Nurses are available against requirement of 372.
10. Anatomy department: There are only 105 specimens.

3. There is no Medical Superintendent in the affiliated hospital.
4. Office of Medical Superintendent is much smaller than required.
5. OPD: Separate Registration Counters for OPD/IPD are not available.
6. OPD was non-operational on 1st day of assessment. Only after arrival of assessors, O.G. & Orthopaedics OPD were operational & a few patients were seated.
7. Wards: All wards were not functional. Wards are not as per MSR Regulations. Only in 3 wards, Nursing staff was present without any sign of functionality. No other staff was present. There were no medicines in the wards.
8. OPD attendance was 149 on day of assessment. Even this figure, given by institute is inflated. When assessors entered OPD, hardly 10-15 persons were standing in queue for registration. Even at 11:30, only 2-3 persons were there at Registration counter who were looking healthy. In OPD, hardly any patients were seen in waiting areas of OPD or in IPD.
9. Bed occupancy was Zero % on day of assessment.
10. Casualty attendance was NIL. No records were available of past 24 hours.
11. There were NIL Major & Minor operations on day of assessment.
12. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment.
13. In Gynaec O.T., a list of previous day (i.e. 08/12/2015) showing 2 names – Veena & Pooja – was provided. These names were found in O.T. registers also. However on verification, no such patients were found in wards. Hospital is non-functional since last several months & fake records are being created in registers.
14. USG workload was NIL. USG machines were covered & sealed by District Competent Authority.
15. Laboratory investigations workload was NIL.
16. Casualty: No doctors are posted. Disaster trolley, Crash Cart, Ventilator are not available.
17. All ancillary facilities like Central Clinical laboratories, Casualty, O.T.s, ICUs, Blood Bank, CSSD, Laundry, etc. are non-functional since last several months. However fake records are being generated.
18. There is only 1 mobile X-ray machine against requirement of 2.
19. No blood has been issued after 28/09/2015.
20. No record is available in Pharmacy of drugs issued. Stock Management Software is not working.

21. Only 10 Nurses are available against requirement of 175. No Nursing staff was available except Nursing Superintendent & 2 Staff Nurses.
22. Only 12 Paramedical & Non-teaching staff are available against requirement of 100.
23. Lecture Theaters: They are not of true gallery type. They are in 4 steps only; each step being of 6 ".
24. Residential quarters for Non-teaching staff are of dormitory type with 4 persons in a room which cannot be a substitute for quarters.
25. Anatomy department: NIL cadavers are available. There is no catalogue of Histology slides.
26. Other deficiencies as pointed out in the assessment report.

7. Bed occupancy is 32.7 % on day of assessment.
8. There were only 3 Major & NIL Minor operations on day of assessment.

9. There were NIL Normal Deliveries & NIL Caesarean Sections on day of assessment.
10. Histopathology & Cytopathology workload was NIL on day of assessment.
11. Laboratory investigation workload was inadequate on day of assessment.
12. Casualty: No Medical Officer was available in Casualty. Central Suction facility is not available. Crash Cart, Defibrillator, Ventilator are not available. Register is not available.
13. ICUs: There was NIL patient in ICCU, SICU & PICU/NICU & only 1 in MICU on day of assessment.
14. ETO Sterilizer is not available.
15. Students' Hostels: They are partially furnished.
16. Residents' Hostel: It is partially furnished.
17. Nurses' Hostel: Hostel: It is partially furnished.
18. Residential Quarters: Only 08 quarters are available for non-teaching staff against 20 required.
19. Anatomy department: Available Lockers are only 54. Only 35 specimens are available. NIL cadaver is available.
20. Audiovisual aids are not available in Demonstration rooms of Physiology & Biochemistry departments.
21. Other deficiencies as pointed out in the assessment report.

1. Deficiency of faculty is 15.38 % as detailed in the report.
2. Shortage of Residents is 22.53 % as detailed in the report.
3. Bed occupancy is 65.85 % on day of assessment against 75 % required.
4. There were only 07 Major & 1 Minor operations for the whole hospital on day of assessment.
5. There was NIL Normal Delivery & only 1 Caesarean Section on day of assessment.
6. Workload of Special investigations like Ba, IVP was NIL on day of assessment.
7. Workload of Histopathology was only 04 & of Cytopathology was only 01 on day of assessment.
8. Wards are not as per MSR Regulations. Ancillary facilities like Demonstration room, Duty room, Pantry, Examination/Treatment room & Store room are either not available or not functional.
9. One ward of 25 beds in O.G. was not functional.

10. Other deficiencies as pointed out in the assessment report.

The Executive Committee of the Council considered the Council Assessors report (26th & 27th November, 2015) and noted the following:-

1. Clinical Material

- Clinical material was grossly inadequate.
- Only one major and one minor surgery performed on the day of assessment
- Normal Delivery – Nil on the day of assessment
- Caesarean section – Nil on the day of assessment
- No Blood units dispensed on the day of assessment
- Maximum OPD was 300 to 400 on the day of assessment.
- Only One Male and One female registration counter.
- In OPD, 70 to 80 People were seated whole the day only for the purpose of head counting. Many Patients in OPD were having the Vague/Insignificant complains for which person normally do not come to Hospital.
- Bed Occupancy on the day of assessment was 66.33% but many Patients were not genuine/fake/dummy.
- Some Indoor patients not having any Medicines, No relative, No any Utensils/Personal belongings and apparently looks to have been made to seat for head count purpose only.
- Some case sheet have no/inadequate notes and some case sheets were prepared before some days and were not matched with details of patients.
- No CMO was present. Only one junior resident from General Medicine was available. At the time of round 7 patients were available but 5 out of these 7 patients were admitted without proper indication in casualty

Fake Patients:

1. There were two Pediatrics ward in Hospital. In first Pediatric ward, No Patients was there, but after half an hour, when we have taken round of Second pediatric ward, there were Eleven Patients/Children, out of these eleven patients, most of patients were fake. These Children were playing in the ward. Not a single relative of any Child was present there. In Patients named Ashok(I.P No. 1511250015), In OPD card, Name, Age, Sex, Date, OPD no. etc information was blank.

2. In Pediatric ward, Patient named Master Ravindra (UHID :1511260007), Registration No. are different in Indoor case sheet and OPD case Sheet. Patient is not genuine.

On Second day of round, out of these 11 pediatric patients in one ward/one unit,6 patients were present in another ward/another unit.

3. In FEMALE SURGERY Ward, Patients named Mrs. Anjinmma (OPD No. 1511260019) Date of OPD card : 26/11/15 and Date of Admission :26/11/15. Patient operated for Right Sided Carcinoma breast. But in Case Paper, Chief Complains is Pain in Abdomen. There is No Operative Note/Name of Surgeon/Anesthetist in case sheet. As per written statement of Staff nurse and 2nd MBBS students that this patients have operated in another Hospital and Admitted here today and it suggests that patient admitted here only for head counting.
4. In Orthopedic (female) ward, One Patient named Mrs.Rajamma (IP No. 151125001) was admitted for chronic Pain in Neck since 1 year without any X- Ray of Neck.
5. In Orthopedic ward, Patient named Shaik Shavali (IP No. 1511240012) admitted today (i.e.26/11/15) as per the information given by Patient, but record shows date of admission 24/11/15..
6. Most of Patients in orthopedic ward were with very minor complains of Knee pain, Limb pain, Back pain without any surgical interventions. Most of patients were not genuine.
7. In Surgery (female) ward, patient named Hasina (IP no.1511230012) admitted before 3 days with Chief complain of Burning in Micturition. But there was no routine Urine/Blood investigations have been done..
8. In ENT Male ward, with 3 male patients, one female patient was also present. Medical Superintendent has misguided us and has given wrong information also in this ward. He insisted for to count 4 indoor patients. But actually with 3 male patients, one female relative was sleeping on the bed.
9. In General Surgery ward, there were two patients admitted named Rammanna and Nasbisab without any case sheet.
10. In Ophthalmology ward, Patient named Salamma, Aged 68 years (IP No. 1511250051) admitted on 25/11/15. But Out patients card of Mrs. Salamma (UHID 15070600300) was found blank and date mentioned in OPD card was 6/7/2015.
11. In Dermatology ward, Patient named Thima Raju (IP No. 15112600340) admitted on 26/11/2015, but in Indoor case sheet, In History name,age,sex,ward and date was not mentioned. Even in History sheet, detailed diagnosis of patients mentioned was found at the time of early morning round on 26/11/2015 which was not possible on the day of admission.
12. In ENT ward, Patient named Mr.Mahammad (IP No. 1511160014) was admitted on 16/11/2015. As per the indoor case sheet, he was discharged on 18/11/15. In Indoor case sheet, no any notes of doctors after 18/11/15 till date/our round was written in case sheet.
13. In Surgery ward, Patient named M.Bandanawaz (IP No.1511260034), In Indoor case sheet, name, age, sex, ward and date was not mentioned in history. A physical examination and Investigation page was found blank. OPD card also blank. Whole case paper blank.

Faculty and Residents: Deficiency of teaching faculty on the day of assessment was 03% and Deficiency of residents on the day of assessment was Nil. But many teaching faculty and residents doctors have been presented only for the Inspection purpose. Many residents are not staying in Hostel/Campus. Many faculty and residents were not aware of Patients care/details of Patients. On random verification/assessment

round, following fake Residents/Faculty have been Identified by us.

Fake Faculty/Residents:

- (a) Dr. Mansur Basha, Doctor (Senior Resident of General Surgery) of Unit I do not know about Patients in male ward and have no treatment advice/signature on case sheets. .
- (b) Dr.Chandra Mouli (SR in Medicine) is not staying in Hostel/Campus.
- (c) Dr.Pushpa lata (SR in Ophthalmology) is not staying in Hostel/Campus.
- (d) Dr.Swetha A. (SR in Obst & GyneC) is not staying in Hostel/Campus.
- (e) Dr. Jawad Hussain (SR in general Surgery) is not staying in Hostel/Campus.
- (f) Dr. Rama Siva Naik (JR in General Surgery) not signed in any Case paper/record sheet of Indoor patients.
- (g) Dr.H.Jagadish Prasad has not signed in any case sheet. According his statement, relative of all pediatric patients were not present in the ward and No medicines available with Pediatric patients. He also stated that yesterday there were 11 patients in Pediatric Unit –I (ward) but today only 5 patients are available.
- (h) Dr.N.Ravishankar Reddy, Assistant Professor in TB & Chest department do not know the details of admitted patients and also do not have any signature or treatment advice written in case sheet.
- (i) Dr.P.Sree Rama Prasanna (SR in Obst and GyneC) is not staying in Hostel/Campus.
- (j) Dr.B.Prasad (SR in General Medicine) is not staying in Hostel/Campus.

On second day, when we have taken round of OPD/ Hospital, most of residence doctors and many faculty members were not available. As per the Written statement of Professor of orthopedic DR.H.Uumanathan, No patient in ortho OPD today and No SR and JR present in OPD. Dr. B.G.Rahul (SR in Unit II – GS) is alone in OPD and No JR, Assistant Professor and Associate professor is present in OPD. Dr.S.Jhansi Lal from Unit I (GS) is examining patients in OPD but scheduled OPD is of Unit II. No SR in OPD (General Medicine) but Professor Dr.Ramchandara reddy said SR present in OPD and One JR present in OPD but OPD today is of Unit II.

Infrastructure:

- Against requirement of 36 Nonteaching staff quarters, 20 quarters are ready.
- It is not possible to visualize all Patients from nursing station in some ward.
- No Demonstration room, No Doctors duty room, No Pantry, No store room in all wards, These rooms are shared by two or three wards.
- In TB,Psychiatry and Skin wards 3 to 4 beds in small rooms are available.No Nursing station and other facility available.

Fake Statement:

- As per Male resident quarters list (Signed by Dean), In Room No. 1 name of Dr.B.Prasad, Sr. resident, General Medicine, was mentioned, but at the time of round, it was found that Dr.Vijay Chandra, Jr. of General Surgery was staying in Room no.1 of Male resident quarters.
 - As per teaching staff quarters list(Signed by Dean),In quarters No. 6 name of Dr.Gowri Devi, Assistant Professor (Community Medicine)was mentioned, but at the time of round, it is found that 70 years aged Retired teacher named Mr.Peter was staying in quarters No.6.
2. Wards are not as per MSR Regulations. In some wards, no Nursing station was available. Only vacant table & chairs were provided without any Nursing staff.
 3. Workload of Special investigations like Ba, IVP was NIL on day of assessment. That of CT Scan was only 02.
 4. Histopathology workload was NIL & Cytopathology workload was only 02 on day of assessment.
 5. ICUs: There was NIL patient in PICU/NICU, only 1 in MICU & only 2 in ICCU on day of assessment.
 6. Nursing staff: Only 131 Nurses are available against requirement of 175.
 7. Students' Hostels: They are partially furnished. Recreation room facilities are inadequate. No warden/caretaker/supervisor was available. Mess is not available. No Separate Mess in Boys, Girls, Nursing, Male resident and female resident hostel. Only one Mess was available in Campus.
 8. Residents' Hostel: It is partially furnished. Recreation room facilities are inadequate. No warden/caretaker/supervisor was available. Mess is not available. Overall impression was that very few Residents are staying there.
 9. Residential Quarters: In Qtr. # 6, as per Dean's statement one Dr. Gowri Devi was supposed to be staying but on verification one retired person Dr. Peter was found staying there. With regard to quarters for non-teaching staff, only 20 quarters are available against requirement of 36. In remaining 16 quarters civil work was going on.
 10. Paramedical & Non-teaching staff: Only 52 Paramedical & Non-teaching staff are available against requirement of 100.
 11. Anatomy department: Only 120 specimens are available.
 12. Other deficiencies as pointed out in the assessment report.

The Executive Committee of the Council considered the matter in detail and perused the communications received from Director, Medical & Health Services, Silvassa as well as the legal opinion which states as under:-

*“.....clarification furnished by the applicant shows that **“infrastructure is under construction”**. However, as far as land requirement is concerned the applicant Administration of UT of Dadra & Nagar Haveli fulfils it. Hence, the matter may be further processed.”*

In view of above, the Executive Committee of the Council and decided to process the application for establishment of new medical college at Silvassa, Union Territory of Dadra & Nagar Haveli (Shri Vinoba Bhave Institute of Medical Sciences, Silvassa, U.T) by UT of Daman & Diu of Dadra & Nagar Haveli u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

67. Transfer of students of Sardar Rajas Medical College, Kalahandi, Orissa admitted in the academic year 2013-2014 and 2014-2015 in other recognized medical college of the State of Odisha- Regarding.

Read: the matter with regard to transfer of students of Sardar Rajas Medical College, Kalahandi, Orissa admitted in the academic year 2013-2014 and 2014-2015 in other recognized medical college of the State of Odisha.

The Executive Committee of the Council considered the matter with regard to transfer of students of Sardar Rajas Medical College, Kalahandi, Orissa admitted in the academic year 2013-2014 and 2014-2015 in other recognized medical college of the State of Odisha and noted that the State Govt. only wants to transfer these students without closing down the college or invoking bank guarantee.

In view of above, the Executive Committee of the Council reiterate its earlier decision which had been communicated to the Central Government as well as the State Government at the meeting held in the Ministry of Health & F.W., on 12.10.2015 which was as under:-

“The stand of MCI was conveyed as under:-

a) Transfer of students can be allowed only if the State Government gives undertaking/declaration that the college would be closed down.

- b) *Students admitted under Government quota should be transferred to Government Colleges of the State only.*
- c) *Students admitted under management quota should be transferred to private colleges of the State.”*

The Executive Committee of the Council further noted that in Form 2 of Establishment of Medical College Regulations, 1999 i.e. Essentiality Certificate, issued by the State Govt. of Odisha dated 27.08.2011 one requirement is a certificate/undertaking by the State Government which reads as under:

“It is further certified that in case the applicant fails to create infrastructure for the medical college as per MCI norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government.”

The Executive Committee of the Council further decided that the bank guarantee be encashed and the amount handed over to the State Government for utilization for adjustment of the students of the academic year 2013-14 and 2014-15.

68. Establishment of new medical college at Mahabubnagar, Telangana by Government of Telangana with an annual intake of 150 MBBS students under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Mahabubnagar, Telangana by Government of Telangana with an annual intake of 150 MBBS students under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (08th and 09th December, 2015) and noted the following:

1. Deficiency of faculty is 41.5 % as detailed in report.
2. Shortage of Residents is 47.8 % as detailed in report.
3. OPD: Separate Registration counters are not available for Males/Females. Teaching areas are not available. Specialty clinic facilities are inadequate in Paediatrics & OG OPD.
4. Wards: Demonstration rooms, Examination cum Treatment room & Pantry are not available in any ward.
5. OPD attendance was 400 on day of assessment against requirement of 600.
6. There was NIL Major Surgical operation on day of assessment.
7. Histopathology & Cytopathology workload is NIL on day of assessment.
8. MRD: It is manual. ICD X classification of diseases is not followed for indexing.
9. Casualty: Separate Casualty for O.G. is not available. Defibrillator, Ventilator are not available.
10. Central Clinical laboratory is not available.
11. O.T.s: Central O₂& Central Suction are not available. Multipara Monitors, Infusion Pumps, Defibrillators are not available.
12. ICUs: SICU is not available. Major equipment is not available in ICCU or any ICU.
13. Radiodiagnosis department: AERB approval is not available for any X-ray machine. Only 1 USG is available against 2 required. 1 static X-ray machine is not functional. PNDDT approval is not available for USG machine.
14. CSSD is not available.
15. College Council is not yet constituted.

16. Lecture Theaters: Space is inadequate for required capacity of 180. They are not of gallery type and not properly equipped. Audiovisual aids are not available.
17. Central Library: Space is inadequate. It is not properly furnished. It is not air-conditioned. Books & Journals are not available. Internet Nodes are not available.
18. Common Rooms for Boys & Girls are not available.
19. Central Photography Section is not available.
20. Students', Residents' & Nurses Hostels are not available.
21. Residential Quarters: Only 4 quarters are available for faculty against 13 required & NIL quarters are available for non-teaching staff.
22. Nursing staff: 157 Nurses are available against 175 required.
23. Paramedical & Non-teaching staff: Only 34 Paramedical & Non-teaching staff are available against 100 required.
24. Anatomy department: Audiovisual aids are not available. Dissection tables are not available. Cadavers, Storage tank, Band saw, Lockers are not available. Museum is not functional.
25. Physiology department: Equipment, water supply, instruments furniture are not available in laboratories. Audio Visual aids are not available in Physiology & Biochemistry departments.
26. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for establishment of New Medical College at Mahabubnagar, Telangana by Government of Telangana under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

69. Establishment of new medical college at Mirzapur, Poll, Saharanpur by Abdul Waheed Educational and Charitable Trust, Mirzapur, Saharanpur with an annual intake of 150 MBBS students under Glocal University, Saharanpur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Mirzapur, Poll, Saharanpur by Abdul Waheed Educational and Charitable Trust, Mirzapur, Saharanpur with an annual intake of 150 MBBS students under Glocal University, Saharanpur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (11th & 12th December, 2015) and noted the following:

1. Deficiency of teaching faculty is 36.92 % as detailed in the report.
2. Shortage of Residents is 36.95 % as detailed in report.
3. Teaching beds are inadequate as under:

4. Wards: Female patients' ward of General Medicine, General Surgery & O.G. are combined in 1 ward. Nursing station, Examination cum treatment room, Demonstration room, pantry are not available. Male & Female patients are kept in the same ward in Ophthalmology, ENT and Skin & VD.
5. OPD attendance is 325 against 600 required. It was only 55 at 11 a.m.
6. Bed occupancy was 27.66 % at 10:30 a.m. All patients in all wards were admitted on day of assessment without definite symptoms. Indoor tickets are blank. In Ophthalmology, 3 patients were admitted with general complaints without any Ophthalmic problem. In Skin & VD ward, all patients were admitted without any Skin problem.
7. OPD: Separate Registration counters for OPD/IPD are not available. Waiting area is inadequate. Teaching areas are not available. Enquiry desk is not available. Examination rooms are inadequate. Injection room is common for males/females & is non-functional. ECG room is not available. Dressing room is not available. Minor O.T. is not available. Plaster room & Plaster cutting room are not available. In Ophthalmology OPD, Dark room, Refraction room & Dressing room are not available. Specialty clinics are not available in Paediatrics & OG OPD. ENT OPD is not in functional state.
8. Audiometry & Speech therapy are not available.
9. In Radiodiagnosis department, there were fake entries of patients. Total 91 X-rays are shown but there is no X-ray plate, dark room & no reports.
10. In Laboratory, there is no functional equipment. There is only sample collection center with fake entries. Registers for testing & reports are not available.
11. MRD: ICD X classification of diseases is not followed for indexing.
12. Casualty: Separate Casualty for O.G. is not available. Central O₂ & Central Suction are not available. Resuscitation equipment is inadequate.
13. Central Clinical laboratory runs only as Pathology laboratory. There is no functional equipment.
14. O.T.s: Only 2 Major O.T.s are available against 4 required. Out of these, 2nd O.T. is non-functional. Minor O.T.s are not available. They are not air-conditioned. Central O₂ & Central Suction are not available. Resuscitation equipment is inadequate. Preoperative beds are not available.
15. ICUs: MICU & SICU are not available. There was NIL patient in NICU/PICU. Beds in NICU were adult beds. In ICCU, all 5 patients were general patients without any IV channel for any patient.
16. Radiodiagnosis department: Only static X-ray machine is available against 2 required. Only 1 mobile X-ray patient is available against 2 required. AERB approval is not available. Only 1 USG is available against 2 required; even this is not functional. Valid PNDDT approval is not available.
17. Blood Bank is not available.
18. CSSD is not available.
19. College Council is not constituted.
20. Lecture Theaters: Capacity of 1 lecture theater is 160 & of another is 90 which is less than 180 required. They are not of gallery type. E class facility is not available.
21. Central Library: Students' Reading room (Outside) is not available. Staff reading room is not available. Only 2,255 books are available against 3,000 required.
22. Common Rooms for Boys & Girls are not available.
23. Students' Hostels: There are no separate hostels for medical students. Engineering students stay in 1 wing of Boys' hostel.
24. Residents' Hostel: It is in 1 wing of Engineering hostel.
25. Nurses' Hostel: It is under construction.
26. Intercom is not available.
27. Anatomy department: Laboratory seats are inadequate. NIL specimens are available. MRI/CT films are not available. Cold storage for dead bodies is not available. Embalming room is not available. No wash basins are available in Dissection Hall, Histology laboratory.

28. Physiology department: Clinical Physiology & Haematology laboratories are under construction. Mammalian laboratory is not available.
29. Biochemistry department: Practical Laboratory is under construction.
30. Other deficiencies as pointed out in the assessment report.

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3 (2) (5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds, the Executive Committee of the Council decided to return the application for establishment of a new medical college at Mirzapur, Poll, Saharanpur by Abdul Waheed Educational and Charitable Trust, Mirzapur, Saharanpur with an annual intake of 150 MBBS students under Glocal University, Saharanpur to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

The Executive Committee of the Council further decided to write a letter to the Secretary (ME) of State Govt. of U.P. requesting to intimate as to how they have issued the Essentiality Certificate certifying that the applicant owned and managed a functional hospital of 300 beds having adequate clinical material when on inspection it has been found that the teaching beds are only 106 against the requirement of 300 beds.

70. Rohilkhand Medical College & Hospital, Bareilly – Renewal of Permission for admission of 5th Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2016-17.

Read: the matter with regard to Rohilkhand Medical College & Hospital, Bareilly – Renewal of Permission for admission of 5th Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2016-17.

The Executive Committee of the Council considered the Council Assessors report (28th and 29th October, 2015) alongwith complaints dated 11.04.2015 & 05.11.2015 from Dr. Varsha Chaudhary, Associate Professor, Department of Community Medicine, Rohilkhand Medical College, Bareilly and Sh. Durgesh Sengar, Chairman, Rashtriya Bhrashtachar Unmulan Samiti, Delhi and noted the following:-

1. Deficiency of faculty is 8.78 % as detailed in report.
2. Shortage of Residents is 7.14 % as detailed in report.
3. Data of OPD attendance provided by institute at 1,610 are inflated. Actual OPD is around 1,000 which is inadequate against requirement of 1,200.
4. Bed occupancy as observed by assessors is 38.75 % (i.e. 279/720) on 1st day of assessment. Data of 80 % provided by institute are inflated.
5. Total number of actual Major operations on day of assessment are only 04. Data of 25 Major operations provided by institute are inflated.
6. Total number of actual Minor operations on day of assessment are only 10. Data of 70 Minor operations provided by institute are inflated.
7. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment. There was no woman in Labour room.
8. Data of Radiological & Laboratory investigations as provided by institute are inflated.
9. Emergency O.T. is non-functional for last 1 year.
10. Facilities in Central Research laboratory are inadequate.
11. Wards: There is no Demonstration room in male medical ward. In Tb & Chest ward, distance between 2 beds is < 1.5 m.

12. RHTC: Family folders are not maintained. Temperature chart is not maintained in cold chain equipment. 2 MSW & 1 PHN do not have required qualification.
13. UHC: Family folders are not maintained. 2 MSW & 1 PHN do not have required qualification.
14. Most of the beds in the wards appear vacant and the bed occupancy is grossly inadequate.
15. The nursing stations in most of the wards are not in proper place. Staff nurses are not visible in most of the wards.
16. The faculty chambers are inadequate for the number of faculty in most departments.
17. Most of the patients in medical wards are projected as being of dengue fever with temperature charts revealing normal body temperature.
18. Most of the patients in medical wards are admitted on account of trivial complaints which did not warrant admission and are not useful for teaching purposes.
19. In surgical wards, most of the patients are of vague, mild and occasional pain abdomen which has not been investigated with any test at all and the patients does not appear to be in need of admission.
20. Many individuals occupying the beds in surgical wards were presented as patients but no medical record was available for them and on enquiring from the individuals, they confirmed that they are not patients but only attendants.
21. Almost all the medical files of admitted patients have similar wordings in the Nursing notes for three times a day.
22. Some medical files were shown as patient files but the patients were not traceable in the ward and were then depicted as having left against medical advise (LAMA) prior to the inspection. It appears that record of already discharged patients was presented as that of currently admitted patients. However, this was not supported by the physical presence of these patients.
23. Most of the patients in the OT lists of different surgical departments for the day of inspection were not present in the Operation theatre or in the wards.
24. None of the patients of the previous days surgery OT list were present in the ward/surgical ICU.
25. The PAC room appears uninhabited and has no doctor, register or any equipment.
26. In Ophthalmology ward, none of the patients of OT list of previous two days (26th and 27th October, 2015) are available in the ward nor were any of them discharged as per the discharge register.
27. In TB and Chest, there are 3 postgraduate seats. However, there are no Professors or Associate Professors which grossly affects undergraduate and postgraduate teaching.
28. In the Deptt. of Radiodiagnosis, the yearly PG intake is 2 and there is no Professor. This adversely affects PG teaching & UG teaching.
29. In Dermatology, the PG intake is three while there are only two Professors. This adversely affects PG teaching & UG teaching.
30. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 5th batch of MBBS students against the increased intake i.e. from 100 to 150 u/s 10A of the IMC Act, 1956 in respect of Rohilkhand Medical College & Hospital, Bareilly under M J P Rohilkhand University, Bareilly for the academic year 2016-17.

71. **Consideration of Compliance Verification Assessment with regard to continuance of recognition of MBBS degree granted by Rajiv Gandhi**

University of Health Sciences, Bangalore in respect of students being trained at Basaveshwara Medical College, Chitradurga.

Read: the matter with regard to consideration of compliance verification assessment report with regard to continuance of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Basaveshwara Medical College, Chitradurga.

The Executive Committee of the Council considered the compliance verification assessment report (2nd December, 2015) and previous assessment report (24th September, 2014) and noted the following:-

1. Shortage of Residents is 34.73 % as detailed in report.
2. Majority of Senior & Junior Residents are not residing in campus.
3. Bed occupancy in department of General Medicine is 40 % (i.e. 51 out of 120).
4. Total number of Major operations completed upto 12 p.m. on day of assessment is only 05.
5. Laboratory investigations: In Biochemistry sections, there were only 35 samples till 12:30 p.m. There were only 7 & 5 requisition forms respectively in Microbiology & Serology upto 12:30 p.m.
6. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision with regard to application of clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment), 2010 (Part II), dated 16th April, 2010 and to return the postgraduate applications of Basaveshwara Medical College, Chitradurga recommending disapproval of the scheme.

72. Continuance of recognition of MBBS degree granted by Kerala University of Health & Allied Sciences, Thrissur (Previously University of Calicut) in respect of students being trained at Jubilee Mission Medical College & Research Institute, Thrissur.

Read: the matter with regard to continuance of recognition of MBBS degree granted by Kerala University of Health & Allied Sciences, Thrissur (Previously University of Calicut) in respect of students being trained at Jubilee Mission Medical College & Research Institute, Thrissur.

The Executive Committee of the Council considered the compliance verification assessment report (16th December, 2015) and previous assessment reports (6th July, 2015 & 3rd & 4th September, 2014) and noted the following:-

1. Shortage of Residents is 42 % as detailed in report.
2. Deficiency of faculty is 21.88 % as detailed in report.
3. Bed occupancy on day of assessment is 65.66 % on day of assessment.
4. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision with regard to application of clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment), 2010 (Part II), dated 16th April, 2010 and to return the postgraduate applications of Jubilee Mission Medical College & Research Institute, Thrissur recommending disapproval of the scheme.

73. Approval of the minutes of the Finance Committee meeting held on 24th November, 2015.

Read: the minutes of the Finance Committee meeting held on 24th November, 2015.

The Executive Committee of the Council perused the minutes of the Finance Committee meeting held on 24th November, 2015 and observed as under:

Item No.1. **Revised Budget Estimates 2015-16 and Budget Estimate for the year 2016-17 of MCI.**

The Committee directed the office to enclose the necessary details.

Item No.2 **Audited Annual Accounts of the Medical Council of India alongwith Audit Report for the year 2014-15.**

The Committee observed that in future for getting higher interest rates for the Institution on deposits, tender may be called from Nationalized Banks. All attempts may be made (yearly deposits and multiple deposits) to achieve the highest interest rates.

74. **Establishment of new medical college (Sri Siddhartha Institute of Medical Sciences & Research Centre) at Nelamangala Taluk, Bangalore, Karnataka by Sri Siddhartha Academy of Higher Education, Tumkur, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the matter with regard to establishment of new medical college (Sri Siddhartha Institute of Medical Sciences & Research Centre) at Nelamangala Taluk, Bangalore, Karnataka by Sri Siddhartha Academy of Higher Education, Tumkur, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council noted that the office vide its various communications had requested the clarifications from the college authorities but no reply received. The Committee further noted the response dated 26.11.2015 received from the University Grants Commission, New Delhi as well as the legal opinion on the matter which reads as under:-

"The aforesaid file has been referred for my opinion in the context of letter dated 26.11.2015 received from UGC regarding the status of Sri Siddhartha Academy of Higher Education. It is stated therein that the said institution is in Category 'C' and in respect of Category 'B' and 'C', the proposals for expansion of the academic activities of category 'B' and 'C' deemed to be Universities are not processed by the UGC. The UGC has also stated that at present, the UGC is processing the proposals for establishment of off-campus center(s)/New Department(s)/ New Institution(s) in respect of the deemed to be universities which are in Category 'A' only.

It may be noted that in respect of "deemed to be University" an ambit order has to be used by the Government of India after consultation with the UGC for institutions under the deemed to University. The UGC has categorically stated that the Sri Siddhartha Academy of Higher Education is a Category C Institution. Further, the UGC has stated that it is not processing any proposal for expansion of category 'B' and 'C' institution. Thus, it is evident that matter relating to issuance of an ambit order in respect of the proposed New Medical College by the applicant deemed to be University would not be considered by the UGC.

Therefore, in view of this position, it would be appropriate to place the matter before the Executive Committee of the Council for recommending disapproval to the Central Govt. as the communicated dated 26.11.15 from the University Grants Commission clearly brings out that proposal for expansion of 'C' Category institution in which Sri Siddhartha Academy of Higher Education is so placed by UGC, is not being processed by the UGC."

In view of above, the Executive Committee of the Council accepted the above legal opinion and decided to recommend to the Central Government to disapprove the scheme and return the application for establishment of New Medical College (Sri Siddhartha Institute of Medical Sciences & Research

Centre) at Nelamangala Taluk, Bangalore, Karnataka by Sri Siddhartha Academy of Higher Education, Tumkur, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

75. Establishment of New Medical College at Paripally Kollam Dist., Kerala (ESIC Medical College, Paripally, Kollam) by Govt. of Kerala u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the matter with regard to establishment of New Medical College at Paripally Kollam Dist., Kerala (ESIC Medical College, Paripally, Kollam) by Govt. of Kerala u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council considered the letter dated 09/12/2015 received from the Central Govt., Ministry of Health & Family Welfare, New Delhi forwarding the representation/compliance dated 28/11/2015 submitted by the Special Officer, Government Medical College, Kerala for review.

The Executive Committee of the Council observed that fresh Essentiality Certificate in the name of present applicant, viz. Govt. of Kerala has been issued only on 07/11/2015 and Consent of Affiliation on 12/11/2015 – i.e. after the last date of submission of application which is 31/08/2015, which is not acceptable.

The Committee further noted the following relevant portion of the *Hon'ble Supreme Court judgment dated 20/08/2015 in W.P.(C) No. 705/2015-Royal Medical Trust(Regd.) and Another Vs. Union of India and Anrs.:-*

“.....(A) Initial assessment of the application at the first level should comprise of checking necessary requirements such as essentiality certificate, consent of affiliation and physical features like land and hospital requirement. If an applicant fails to fulfill these requirements, the application on the face of it, would be incomplete and be rejected. Those who fulfill the basic requirements would be considered at the next stage....”

The Committee further noted the following relevant portion of the *Hon'ble Supreme Court judgment dated 20/08/2015 in SLP.(C) No. 15043/2015-Padmashree Dr. D.Y. Patil Medical College Vs. Medical Council of India & Anr.:-*

16. *In W.P. (C) No.705/2014 – Royal Medical Trust (Regd.) and Anr. V. Union of India & Anr. decided on 20.8.2015, this Court has observed that the Schedule must take care of following aspects:*

“(A) Initial assesment of the application at the first level should comprise of checking necessary requirements such as essentiality certificate, consent for affiliation and physical features like land and hospital requirement. If an applicant fails to fulfill these requirements, the application on the face of it, would be incomplete and be rejected. Those who fulfill the basic requirements would be considered at the next stage.

(B) Inspection should then be conducted by the Inspectors of the MCI. By very nature such inspection must have an element of surprise. Therefore, sufficient time of about three to four months ought to be given to the MCI to cause inspection at any time and such inspection should normally be undertaken latest by January. Surprise inspection would ensure that the required facilities and infrastructure are always in place and not borrowed or put in temporarily.

(C) Intimation of the result or outcome of the inspection would then be communicated. If the infrastructure and facilities are in order, the concerned Medical College should be given requisite permission/renewal. However if there

are any deficiencies or shortcomings, the MCI must, after pointing out the deficiencies, grant to the college concerned sufficient time to report compliance.

(D) *If compliance is reported and the applicant states that the deficiencies stand removed, the MCI must cause compliance verification. It is possible that such compliance could be accepted even without actual physical verification but that assessment be left entirely to the discretion of the MCI and the Central Government. In cases where actual physical verification is required, the MCI and the Central Government must cause such verification before the deadline.*

(E) *The result of such verification if positive in favour of the Medical College concerned, the applicant ought to be given requisite permission/renewal. But if the deficiencies still persist or had not been removed, the applicant will stand disentitled so far as that academic year is concerned."*

It is apparent from the aforesaid decision and the regulations that the application at the first instance is required to be complete and incomplete applications are liable to be rejected. Thereafter, there has to be an inspection and other stages of decision-making process."

In view of above, the Executive Committee of the Council decided to reiterate its earlier decision taken at its meeting held on 28.10.2015 to return the application for establishment of new medical college at Paripally Kollam Dist., Kerala (ESIC Medical College, Paripally, Kollam) by Govt. of Kerala to the Central Govt. recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

76. Establishment of new medical college at Falkawn, Mizoram (Mizoram Institute of Medical Education and Research) by Government of Mizoram u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the matter with regard to establishment of new medical college at Falkawn, Mizoram (Mizoram Institute of Medical Education and Research) by Government of Mizoram u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council considered the letter dated 09/12/2015 received from the Central Govt., Ministry of Health & Family Welfare, New Delhi forwarding the representation/compliance dated nil submitted by Health & Family Welfare Department, Government of Mizoram for review.

The Executive Committee of the Council observed that even the compliance given by the applicant to the hearing committee shows that the applicant presently has only 172 beds. The submission made by the applicant reads as under:

"The number of beds in the proposed medical college hospital (namely State Referral Hospital, Falkwan) is currently 172 and will be 250 before the end of the year. Work is progressing in full swing to ensure the completion of the hospital with fully functional 250 beds. It may be noted that the Government of Mizoram is taking up necessary actions to set up 250 beds, which is the special relaxation given to North Eastern States and hilly states (as against the 300 beds mandated earlier)

The Executive Committee of the Council further observed that now fresh Essentiality Certificate has been issued by Govt. of Mizoram only on 30/11/2015 which states that "the applicant owns and manages a 250 bedded hospital which was established in 2005." – i.e. after the last date of submission of application which is 31/08/2015., which is not acceptable.

The Committee further noted the following relevant portion of the Hon'ble Supreme Court judgment dated 20/08/2015 in W.P.(C) No. 705/2015-Royal Medical Trust(Regd.) and Another Vs. Union of India and Anrs.:-

".....(A) Initial assessment of the application at the first level should comprise of checking necessary requirements such as essentiality certificate, consent of affiliation and physical features like land and hospital requirement. If an applicant fails to fulfill these requirements, the application on the face of it, would be incomplete and be rejected. Those who fulfill the basic requirements would be considered at the next stage...."

The Committee further noted the following relevant portion of the Hon'ble Supreme Court judgment dated 20/08/2015 in SLP.(C) No. 15043/2015-Padmashree Dr. D.Y. Patil Medical College Vs. Medical Council of India & Anr.:-

16. In W.P. (C) No.705/2014 – Royal Medical Trust (Regd.) and Anr. V. Union of India & Anr. decided on 20.8.2015, this Court has observed that the Schedule must take care of following aspects:

"(A) Initial assesment of the application at the first level should comprise of checking necessary requirements such as essentiality certificate, consent for affiliation and physical features like land and hospital requirement. If an applicant fails to fulfill these requirements, the application on the face of it, would be incomplete and be rejected. Those who fulfill the basic requirements would be considered at the next stage.

(B) Inspection should then be conducted by the Inspectors of the MCI. By very nature such inspection must have an element of surprise. Therefore, sufficient time of about three to four months ought to be given to the MCI to cause inspection at any time and such inspection should normally be undertaken latest by January. Surprise inspection would ensure that the required facilities and infrastructure are always in place and not borrowed or put in temporarily.

(C) Intimation of the result or outcome of the inspection would then be communicated. If the infrastructure and facilities are in order, the concerned Medical College should be given requisite permission/renewal. However if there are any deficiencies or shortcomings, the MCI must, after pointing out the deficiencies, grant to the college concerned sufficient time to report compliance.

(D) If compliance is reported and the applicant states that the deficiencies stand removed, the MCI must cause compliance verification. It is possible that such compliance could be accepted even without actual physical verification but that assessment be left entirely to the discretion of the MCI and the Central Government. In cases where actual physical verification is required, the MCI and the Central Government must cause such verification before the deadline.

(E) The result of such verification if positive in favour of the Medical College concerned, the applicant ought to be given requisite permission/renewal. But if the deficiencies still persist or had not been removed, the applicant will stand disentitled so fare as that academic year is concerned."

It is apparent from the aforesaid decision and the regulations that the application at the first instance is required to be complete and incomplete applications are liable to be rejected. Thereafter, there has to be an inspection and other stages of decision-making process."

In view of above, the Executive Committee of the Council decided to reiterate earlier decision conveyed to the Central Government vide letter dated 19.10.2015 to return the application for establishment of new medical college at Falkawn, Mizoram (Mizoram Institute of Medical Education and Research (MIMER) by Government of Mizoram to the Central Govt. recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year

2016-17, as the applicant fails to meet the necessary requirement of owning and managing a 300 bedded hospital.

77. Establishment of new medical college at Hamirpur, Himachal Pradesh (Govt. Medical College, Hamirpur) by Govt. of Himachal Pradesh u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the matter with regard to establishment of new medical college at Hamirpur, Himachal Pradesh (Govt. Medical College, Hamirpur) by Govt. of Himachal Pradesh u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council considered the matter at length and noted the fax letter dated 08/12/2015 of the Director, Medical Education & Research, Himachal Pradesh stating as under:-

"With due regard and humble submission, I have the honour to invite a reference to your office letter No.MCI34(41)(E-22)/2015-Med./141846-47-51 dated 15/10/2015 & 24/11/2015 on the subject cited above.

In this context, it is submitted that the land identified for new Medical College at Hamirpur is forest land and the case for FCA clearance has already been submitted to the Forest Department by the CMO concerned and the process to transfer the same in the name of Health & Family Welfare Department is underway and it will take some time.

In view of above, it is requested that time of three months may kindly be granted for submission of the requisite documents as sought by your good office vide letter under reference please."

The Committee further observed that the time schedule prescribed under Establishment of Medical College Regulations with regard to last date prescribed under Establishment of Medical College Regulations, 1999 as amended from time to time reads as under:

It was further observed that these Regulations being Statutory Regulations are mandatory and binding in character and are required to be strictly adhered to by all the authorities. The operative part of the order of Hon'ble Supreme Court in Mridul Dhar's case is as under:

"1-13.

14. Time schedule for establishment of new college or to increase intake in existing college, shall be adhered to strictly by all concerned.

15. Time schedule provided in Regulations shall be strictly adhered to by all concerned failing which defaulting party would be liable to be personally proceeded with."

In view of above, the Executive Committee of the Council decided to return the application for establishment of a new medical college at Hamirpur, Himachal Pradesh (Govt. Medical College, Hamirpur) by Govt. of Himachal Pradesh to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-2017 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

78. Establishment of new medical college at Tiruvallur District., Chennai Tamilnadu (D.D. Medical College & DD Hospital) by D.D. Medical Education Trust, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the matter with regard to establishment of new medical college at Tiruvallur District., Chennai Tamilnadu (D.D. Medical College & DD Hospital) by D.D. Medical Education Trust, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council noted that the Council Office vide its various communications to the Registrar, the Tamilnadu Dr. MGR Medical University/Secretary, Govt. of Tamilnadu, Chennai requested for clarifications/documents. The Committee noted the following response dated 17.11.2015 received from the Registrar, The Tamilnadu Dr. M.G.R. Medical University, Chennai-

"....that the Consent of affiliation issued by this University in the year 2008 to the Chairman DD Medical and Educational Trust, Chennai will not be valid for the establishment of a new medical college at Tiruvallur District from the academic year 2015-2016."

The Executive Committee of the Council further noted the following letter dated 09/12/2015 of Dr. J. Radhakrishnan, I.A.S., Secretary to Government, Health & Family Welfare Department, Secretariat, Chennai:-

"...the Essentiality Certificate No.20991/MCA.2/2006-09, dated 29/08/2008 issued by the Government of Tamilnadu in favour of the Chairman, Deen Dayal Medical and Educational Trust for starting the DD Medical College at Kunnavalam, Tiruvallur District already exhausted and became invalid. Since the State Government have already adjusted the MBBS students legally admitted by DD Medical College in the year 2010 in various

Government Medical Colleges of the State with the prior approval of Medical Council of India and Central Government.”

In view of above, the Executive Committee of the Council decided to recommend to the Central Government to return the application for establishment of new medical college at Tiruvallur District., Chennai Tamilnadu (D.D. Medical College & DD Hospital) by D.D. Medical Education Trust, Chennai recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

79. Establishment of new medical college at Gajaroula, Dist. Amroha, Uttar Pradesh by Shri Venkateshwara University, Meerut (Trust name - Shri Bankey Bihari Educational & Welfare Trust) with an annual intake of 150 MBBS students under Shri Venkateshwara University, Gajroula, Amroha u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Gajaroula, Dist. Amroha, Uttar Pradesh by Shri Venkateshwara University, Meerut (Trust name - Shri Bankey Bihari Educational & Welfare Trust) with an annual intake of 150 MBBS students under Shri Venkateshwara University, Gajroula, Amroha u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (18th & 19th December, 2015) and noted the following:

1. Hospital was locked.
2. Deficiency of faculty is 98.46 % as detailed in report.
3. Shortage of Residents is 100 % as detailed in report.
4. Bed Occupancy was ZERO % on day of assessment.
5. OPD attendance was ZERO on day of assessment.
6. Teaching Beds: As wards were locked, they could not be verified.
7. Ancillary facilities could not be verified as the wards were locked. There were NIL Minor & Major operations on day of assessment.
8. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment.
9. Radiological & Laboratory investigations workload was NIL on day of assessment.
10. Casualty: No doctors or Nurses are posted. Separate Casualty for O.G. is not available. Ventilator is not available.
11. O.T.: Only 3 O.T.s are available against requirement of 4. One O.T. contains 2 tables which is not as per norms.
12. There was NIL patient in ICCU or any ICU.
13. Labour room was locked.
14. Radiodiagnosis department: Mobile & Static X-ray machines were not functional. Only 1 USG is available against requirement of 2.
15. Blood Bank is not functional.
16. Central Photography Section: Staff & Equipment are not available.
17. No staff and patients were available at Registration counter or in OPD. Only empty rooms were seen.
18. MRD: It was available but locked.
19. No staff is available in Pharmacy.
20. NIL Nurses are available against 175 required.
21. Only 15 Paramedical & Nursing staff are available against 100 required.
22. Anatomy department: NIL cadavers are available. Cold storage for dead bodies is not available. Embalming room is not available. Only 84 Lockers are available.
23. Other deficiencies as pointed out in the assessment report.

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3(2)(5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds, the Executive Committee of the Council decided to return the application for establishment of a new medical college at Gajaroula, Dist. Amroha, Uttar Pradesh by Shri Venkateshwara University, Meerut (Trust name - Shri Bankey Bihari Educational & Welfare Trust) under Shri Venkateshwara University, Gajroula, Amroha to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

80. Establishment of new medical college at Mathura, Uttar Pradesh by Shri Mohan Singh Shiksha Sansthan, Mathura, Uttar Pradesh with an annual intake of 150 MBBS students under Dr. B.R. Ambedkar University, Agra u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Mathura, Uttar Pradesh by Shri Mohan Singh Shiksha Sansthan, Mathura, Uttar Pradesh with an annual intake of 150 MBBS students under Dr. B.R. Ambedkar University, Agra u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (18th & 19th December, 2015) and noted the following:

1. Deficiency of faculty is 84.61 % as detailed in report.
2. Shortage of Residents is 89.13 % as detailed in report.
3. Bed occupancy was 6.33 % on day of assessment.
4. Most of the OPDs did not have any consultants. There were very few patients attending OPDs.
5. OPD: Separate Registration counters for male/female are not available. Separate Registration counters for OPD/IPD are not available. Waiting area is inadequate. Injection room, Dressing room, Plaster room & Plaster Cutting room are not functional. In Ophthalmology OPD, Dark Room & Dressing room are not available. Specialty clinic facilities are not available in Paediatrics & OG OPD.
6. Wards: There are no Nursing stations. Only table & Chair are provided. Only space is provided for ancillary facilities. Demonstration rooms are not furnished & do not have patient examination table or chairs.
7. OPD figures provided by institute are highly exaggerated. Very few patients were seen in OPD.
8. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment.
9. Radiological & Laboratory investigations workload is inadequate.
10. MRD is not available. ICD X classification of diseases is not followed for indexing.
11. Casualty: Separate Casualty for O.G. is not available. No doctor was available. There is no ventilator.
12. ICUs: There was NIL patient in ICCU & MICU, SICU & PICU. There was only 1 patient in NICU.
13. Labour room: Septic room & Eclampsia room are not functional.
14. Only 1 mobile X-ray machine is available against requirement of 2. Only 1 USG machine is available against requirement of 2.
15. Blood Bank is not available.
16. CSSD is not functional.
17. Audiometry & Speech therapy are not available.
18. Intercom is not available.

19. Kitchen & Canteen are not available.
20. Nursing staff: Only 154 Nurses are available against 175 required.
21. Paramedical & Non-teaching staff: Only 33 Paramedical & Non-teaching staff are available against requirement of 100.
22. Dean's office & Administrative offices are not furnished.
23. College Council is not constituted.
24. Lecture Theaters: E class facility is not available.
25. Central Library: It is not air-conditioned. NIL Indian & NIL foreign journals are available. Internet Nodes are not available.
26. Common Rooms for Boys & Girls are under construction.
27. Central Photography section is not available.
28. Students' Hostels: They are not furnished. Toilet facilities are not available. Visitors' rom, A.C. study room with computer & Internet & Recreation room are not available.
29. Residents' Hostel: It is not furnished. Toilet facilities are not available. Visitors' rom, A.C. study room with computer & Internet & Recreation room are not available.
30. Nurses' Hostel: It is not furnished. Toilet facilities are not available.
31. Anatomy department: Museum is non-functional. NIL specimens, X-ray, MRI & CT films are available. Office is not furnished.
32. Physiology department: Seating arrangement is not available in Demonstration rooms. Audiovisual aids are not available. Tables are not organized in Clinical physiology laboratory. Office is not furnished.
33. Biochemistry department: Seating arrangement is not available in Demonstration rooms. Audiovisual aids are not available. Office is not furnished.
34. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for establishment of New Medical College at Mathura, Uttar Pradesh by Shri Mohan Singh Shiksha Sansthan, Mathura, Uttar Pradesh under Dr. B.R. Ambedkar University, Agra u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

81. Increase of seats in MBBS course from 150-250 for the academic session 2016-17 at VSS Medical College, Burla.

Read: the matter with regard to increase of seats in MBBS course from 150-250 for the academic session 2016-17 at VSS Medical College, Burla.

The Executive Committee of the Council considered the Council Assessors report (08th & 09th December, 2015) and noted the following:

1. There was strike of students from 21/11/2015 onwards. At 09:45 a.m. they got opportunity to lock college building & library premises.
2. Deficiency of faculty is 96.35 % as detailed in report.
3. Shortage of Residents is 76.56 % as detailed in report.
4. Declaration Forms were not made available to assessors.
5. College premises were locked; hence no verification could be made in respect of Dean's office, Administrative office, MEU, CME Programmes, College Council, Examination Halls, Lecture Theaters, Pharmaco Vigilance Committee, Central Library, Common Rooms for Boys & Girls, Central Photography Section, Central research Laboratory, Teaching Programme, preclinical and Paraclinical departments.
6. Details of Residents' & Nurses' Hostels and Residential Quarters were not provided.
7. OPD: Waiting area is inadequate. ECG room is not available. Injection room is common for males/females. Dressing room is common for males/females. Specialty clinic facilities are inadequate in Paediatrics & OG OPD.

8. Teaching beds are inadequate as under:

9. Wards: Examination cum Treatment room & Demonstration rooms are not available in some wards.
10. OPD attendance on day of assessment was 784 only against 3,000 required.
11. Data of Radiological & Laboratory investigations were not provided in spite of repeated requests.
12. MRD: It is manual. ICD X classification of diseases is not followed for indexing of diseases. Medical Records Officer & statistician are not available.
13. Casualty: Only 20 beds are available against 30 required. Separate Casualty for O.G. is not available. Central O₂ & Central Suction are not available. Defibrillator is not available.
14. Central Clinical Laboratory, Pharmacy, CSSD, laundry, Kitchen could not be verified.
15. O.T.: Only 9 Major O.T.s are available against 11 required. Each O.T. has 2 tables which is not as per norms. Minor O.T.s were unsterile & dusty. Defibrillators & Infusion Pumps are not available. Central O₂ and Central N₂O are not available except in General Surgery O.T.s. Septic O.T. is not available. Preoperative & Postoperative beds are not available.
16. Radiodiagnosis department: Only 1 mobile X-ray machine is available against requirement of 6. Only 2 static X-ray machines are available against requirement of 6. Only 2 USG machines are available against requirement of 3. MRI is not available.
17. Blood Bank: Register is not maintained properly.
18. Intercom is not available.
19. Nursing and paramedical & Nonteaching staff could not be verified.
20. Students' Hostels: Available accommodation is only 642 against requirement of 938. Hygiene is very poor. Kitchen & wash rooms were horrible.
21. Interns' Hostel: Available accommodation is 182 against requirement of 250.
22. There is no accommodation for Senior Residents.
23. RHTC: No documents are available to show under it is under whose control. Residential accommodation has not been occupied for several years. There are no activities under National Health Programmes.
24. UHC: No documents are available to show under it is under whose control. There are no activities under National Health Programmes.
25. Website: Citizens' charter is not available.
26. Other deficiencies as pointed out in the assessment report.

In view of the above, as the applicant college does not meet the Qualifying Criterion 6(b)(i) & 6(b)(ii) of Opening of New or Higher Courses of Study or Training (including Postgraduate Course of Study or Training) and increase of Admission Capacity in any course of Study or Training (including Postgraduate Course of Study or Training) (Amendment) Regulations, 2009 (Part-III) as number of teaching beds are less than the required, the Executive Committee of the Council decided to return the application for increase in MBBS seats from 150 to 250 at VSS Medical College, Burla under Sambalpur University u/s 10A of the IMC Act 1956 for academic year 2016-17 recommending disapproval of the scheme to the Central Govt. as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the Regulations framed therein to keep the application pending in the Council office for the next academic year.

82. Increase of seats in MBBS course from 100 to 150 at Vinayaka Mission's Kirupananda Variyar Medical College & Hospital, Salem u/s 10A of the IMC Act, 1956 for the academic year 2016-17 – Withdrawal of application.

Read: the matter with regard to increase of seats in MBBS course from 100 to 150 at Vinayaka Mission's Kirupananda Variyar Medical College & Hospital, Salem u/s 10A of the IMC Act, 1956 for the academic year 2016-17 – Withdrawal of application.

The Executive Committee of the Council considered the matter with regard to increase of seats in MBBS course from 100 to 150 at Vinayaka Mission's Kirupananda Variyar Medical College & Hospital, Salem and perused the following letter dated 07.12.2015 from the Registrar, Vinayaka Missions University, Salem addressed to Secretary, Ministry of Health & Family Welfare, Govt. of India, New Delhi and copy to the Council:-

"...we would like to inform the Secretary, Ministry of Health & Family Welfare, Government of India/Medical Council of India, we hereby withdraw our application for increase in the intake from 100 to 150 seats for offering MBBS degree course in our Vinayaka Mission's Kirupananda Variyar Medical College & Hospital, Salem under the ambit of Vinayaka Missions University, Salem, Tamil Nadu for the academic year 2016-17 due to administrative reasons.

Hence, we request the Secretary, Ministry of Health & Family Welfare, Government of India/Medical Council of India that our application alongwith a Demand Draft for Rs. 4,00,000/- may kindly be returned to this office, at the earliest convenience in this regard."

In view of above, the Executive Committee of the Council decided to return the application for increase of seats in MBBS course from 100 to 150 Vinayaka Mission's Kirupananda Variyar Medical College & Hospital, Salem to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-2017 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

The Executive Committee of the Council further decided that with regard to return of Demand Draft, as the application was already processed before it was withdrawn, it was not possible to return the application money.

83. Compliance Verification Assessment of the physical and the other teaching facilities available for 100 MBBS seats at Dr. Somervell Memorial CSI Medical College & Hospital, Thiruvananthapuram under Kerala University of Health Sciences, Thrissur.

The Executive Committee of the Council considered the compliance verification assessment report (16.12.2015) along with previous assessment reports (01.07.2015, 8th May, 2015 and 10th & 11th March, 2015) and noted the following:-

1. Deficiency of faculty is 30.93 % as detailed in report.
2. Shortage of Residents is 46.83 % as detailed in the report.
3. Bed occupancy is 38.30 % on day of assessment.
4. Number of patients in OPD is 400 – 500 on day of assessment against requirement of 800.
5. Workload of Special investigations like Ba, IVP was NIL on day of assessment.
6. In Skin & VD ward, one male patient was without any case paper.
7. In USG register of Radiodiagnosis department, no entry of indoor patient was recorded.
8. In Histopathology register, there was no column/entry of patients, department, ward.
9. On enquiry, Registration counter clerks were not able to give clinical data.
10. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision with regard to application of clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment),2010(Part II), dated 16th April, 2010 and to return the postgraduate applications of Dr. Somervell Memorial CSI Medical College & Hospital, Thiruvananthapuram recommending disapproval of the scheme.

The Executive Committee of the Council further decided that since the gross deficiencies of teaching faculty, residents, & infrastructure are still persisting inspite of repeated opportunities being given to the institute to rectify the same over a period of time, why the recognition for the award of MBBS degree granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Dr. Somervell Memorial CSI Medical College & Hospital, Thiruvananthapuram be not withdrawn u/s 19 of the IMC Act, 1956. It was further decided that the institute be directed not to make further admissions from the academic year 2016-17 onwards.

The Committee further decided to place the matter before the General Body of the Council.

84. Establishment of New Medical College at Bajehra, Unnao, Uttar Pradesh by F.I Memorial & Welfare Society, Lucknow with an annual intake of 150 MBBS students under Chhatrapati Shahu Ji Maharaj University, Kanpur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of New Medical College at Bajehra, Unnao, Uttar Pradesh by F.I Memorial & Welfare Society, Lucknow with an annual intake of 150 MBBS students under Chhatrapati Shahu Ji Maharaj University, Kanpur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council perused the Council Assessors report (11th & 12th December, 2015) alongwith a letter dated 12/12/2015 stating as under:-

- a. *Hospital was not functional*
- b. *There were no patients either in OPD or in wards*
- c. *There was no staff including Principal & Medical Superintendent*
- d. *There is building of hospital, college, hostels for boys & girls. Quarters for Teaching staff, non teaching staff and nurses were present, however they were unoccupied.*
- e. *Operation theaters were not functional.*
- f. *There were no teaching faculty except one Tutor in Biochemistry & one Senior Residents in OBGY, However on verification, Biochemistry tutor is not accepted & OBGY senior resident did not turn up for verification, hence she was not accepted.*
- g. *Principal of the institute arrived after 1 PM, hence he was not accepted.*
- h. *RHTC is not functional.*
- i. *UHTC is not there.*
- j. *In Anatomy, Physiology & Biochemistry Dept's there were demonstration rooms, labs & library were available but with inadequate infrastructure.*
- k. *Two lecture theatres were available but without electricity.*
- l. *When the assessment team entered the hospital two persons were available near the reception counter & one lady came who said she is in charged of class IV and sweepers. No computer operator was made available and also no person for videography/photography was made available by the hospital manager who came at 11.30 am."*

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3(2)(5) of Establishment of Medical College Regulations, 1999 as amended pertaining to the requirement of a functional hospital of not less than 300 beds, the Executive Committee of the Council decided to return the application for establishment of a new medical college at Bajehra, Unnao, Uttar Pradesh by F.I Memorial & Welfare Society, Lucknow under Chhatrapati Shahu Ji Maharaj University, Kanpur to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

85. Establishment of New Medical College at Palghar, Maharashtra by Vedantaa Institute of Academic Excellence Pvt. Ltd., Mumbai with an annual intake of 150 MBBS students under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of New Medical College at Palghar, Maharashtra by Vedantaa Institute of Academic Excellence Pvt. Ltd., Mumbai with an annual intake of 150 MBBS students under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (14th & 15th December, 2015) and noted the following:-

1. Deficiency of faculty is 100 % as detailed in report.
2. Shortage of Residents is 100 % as detailed in report.
3. Teaching Hospital is not available. NIL teaching beds are available.
4. OPD attendance was only 70 till 12:30 p.m.
5. Dean was not available till 11: 30 a.m. on day of assessment.
6. Medical Superintendent's office is not available.

7. OPD: Separate Registration counters for males & females are not available. Separate Registration counters for OPD/IPD are not available. Registration counters are not computerized. Staff for Registration counters is inadequate. Examination rooms for different departments are not separately available. Teaching areas are not available. Waiting area is open space. Enquiry desk is not available. Injection room & Dressing room are not available. Minor O.T. is not available. ECG room is not available. Plaster room & Plaster Cutting room are not available. In Ophthalmology OPD, Dark Room, Refraction room & Dressing room are not available. Facilities for Specialty clinics are not available in Paediatrics & O.G. OPD.
8. Audiometry & Speech Therapy are not available.
9. No specialist was available on day of assessment. Only General Duty Medical officers were available.
10. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment.
11. Radiological investigation workload was NIL on day of assessment.
12. Except Biochemistry, workload of all other laboratory investigations was NIL on day of assessment.
13. MRD is not available.
14. Casualty: Casualty & Indoor wards are combined. Separate Casualty is not available. Only 1 GDMO looks after Casualty, OPD & IPD. Central O₂ & Central Suction are not available. Equipment is not available.
15. Central clinical laboratory, O.T.s, ICCU & ICUs, Labour Room, CSSD, Intercom are not available.
16. Mobile & Static X-rays & USG are not available.
17. Blood Bank is not available.
18. Intercom is not available.
19. Pharmacy is running without qualified Pharmacist.
20. Only 8 Nursing & 5 Paramedical staff available at time of assessment which is grossly inadequate.
21. Dean's office & Administrative Office were not available.
22. College Council is not constituted.
23. Pharmacovigilance Committee is not available.
24. Lecture Theaters are not available.
25. Central Library is not available.
26. Common Rooms for Boys & Girls are not available.
27. Central photography Section is not available.
28. Students', Residents' & Nurses' Hostels are not available.
29. Residential Quarters are not available.
30. Gender Harassment Committee is not constituted.
31. Website is not available.
32. Preclinical departments of Anatomy, Physiology & Biochemistry are not available.
33. Other deficiencies as pointed out in the assessment report.

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3(2)(5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds, the Executive Committee of the Council decided to return the application for establishment of a new medical college at Palghar, Maharashtra by Vedantaa Institute of Academic Excellence Pvt. Ltd., Mumbai under Maharashtra University of Health Sciences, Nashik to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

The Executive Committee of the Council further decided to write a letter to the Secretary(ME) of State Govt. of Maharashtra requesting to intimate as to

how they have issued the Essentiality Certificate certifying that the applicant owned and managed a functional hospital of 300 beds having adequate clinical material when on inspection it has been found that the hospital was not functional.

86. Establishment of new medical college at Vadodara, Gujarat by Parul University, Gujarat with an annual intake of 150 MBBS students under Parul University, Vadodara u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Vadodara, Gujarat by Parul University, Gujarat with an annual intake of 150 MBBS students under Parul University, Vadodara u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (1st & 2nd December, 2015) and noted the following:

1. College Council is not constituted.
2. MRD is partly computerized.
3. Only 3(three) patients were available in the morning on next day (02/12/2015) at 9.20 am.
4. Randomly selected 04 Residents for verification of residential proof. Neither had room keys nor were living in campus.
5. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for establishment of new medical college at Vadodara, Gujarat by Parul University, Gujarat with an annual intake of 150 MBBS students under Parul University, Vadodara u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

87. Establishment of new medical college at Kuttapuzha, Thiruvalla, Kerala by Believers Church India, Thiruvalla, Kerala with an annual intake of 100 MBBS students under the Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Kuttapuzha, Thiruvalla, Kerala by Believers Church India, Thiruvalla, Kerala with an annual intake of 100 MBBS students under the Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (16th & 17th December, 2015) and noted the following:-

1. Deficiency of faculty is 17.24 % as detailed in report.
2. Shortage of Residents is 24.44 % as detailed in report.
3. Total 202 patients were in wards out of whom 45 were not genuine and did not merit admission; resultantly net Bed Occupancy was 157 out of 300 – i.e. 52.33 % which is inadequate.
4. There was NIL Normal Delivery & 1 Caesarean Section on day of assessment.
5. Wards: In all the wards patients were placed head on with partial partition resulting in space between 2 beds being < 1.5 m. Demonstration rooms were having capacity < 25 and they did not have examination table.
6. MRD is both manual & computerized.
7. Lecture Theaters: Facility for E class is not available.

8. Central Library: Capacity of Staff Reading room is 16 against requirement of 20.
9. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for establishment of New Medical College at Kuttapuzha, Thiruvalla, Kerala by Believers Church India, Thiruvalla, Kearla under the Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

88. Establishment of new medical college at Saharsa, Bihar (Shree Narayan Medical College, Saharsa, Bihar) by Shree Narayan Foundation, Saharsa, Bihar u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the matter with regard to establishment of new medical college at Saharsa, Bihar (Shree Narayan Medical College, Saharsa, Bihar) by Shree Narayan Foundation, Saharsa, Bihar u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council noted that the office vide its various communications had requested the clarifications from the college authorities. The Committee further noted the response dated 05.12.2015 received from the Managing Trustee/Secretary, Shree Narayan Foundation, Bihar as well as the legal opinion on the matter which reads as under:-

“ ...

8. *It is stated that Shree Narayan Medical Institute and Hospital; Shree Narayan Foundation and Smt. Kameshwari Kumari are distinct legal entities in the eyes of law. This implies that any legal document pertaining to one entity cannot be interchangeably used in relation to another and hence a registered deed in the name of Smt. Kameshwari Kumari or Shree Narayan Medical Institute and Hospital cannot be considered to be a registered deed in the name of Shree Narayan Foundation.*
9. *On the basis of the above, it is stated that one of the qualifying criteria of the Establishment of Medical College Regulations, 1999 is that the applicant should own and possess 20 acres of single and contiguous piece of land. It is evident that the land under reference in this case is owned by three distinct legal entities, namely, Sri Narayan Foundation, Shree Narayan Medical Institute and Hospital and Smt. Kameshwari Kumari.*
10. *In view of the above, the applicant Sri Narayan Foundation fails to fulfil the qualifying criteria of owning and possessing 20 acres of land. Hence, the application may be recommended for disapproval.”*

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3(2)(2) of Establishment of Medical College Regulations, 1999 pertaining to the owing and possessing 20 acres of land, the Executive Committee of the Council decided to return the application for establishment of a new medical college at Saharsa, Bihar (Shree Narayan Medical College, Saharsa, Bihar) by Shree Narayan Foundation, Saharsa, Bihar to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

89. Establishment of New Medical College at Modinagar, District Ghaziabad, Uttar Pradesh (Divya Jyoti Institute of Medical Sciences & Research) by Jassar Dental Medical Education Health Foundation (JDMEHF) Modinagar, Ghaziabad u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

Read: the matter with regard to establishment of New Medical College at Modinagar, District Ghaziabad, Uttar Pradesh (Divya Jyoti Institute of Medical Sciences & Research) by Jassar Dental Medical Education Health Foundation (JDMEHF) Modinagar, Ghaziabad u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council noted that in the academic year 2014-15, the Principal/Dean of Jassar Dental Medical Education Health Foundation (JDMEHF) Modinagar, Ghaziabad vide letter dated 27.3.2014 had stated

“..... approved building plans will be produced for verification at the time of inspection”.

On the basis of the said letter, an assessment was conducted on 8 & 9th May, 2014 for issuance of LOP to the said Institute. The Dean has mentioned in SA-I Pg. 3 of assessment report that Building plan approval from the Competent Authority i.e. GDA, Ghaziabad is awaited. On 14.10.2014, a compliance verification assessment was carried out in compliance of the orders of the Hon'ble Supreme Court dated 25.9.2014. There was no mention in the report whether GDA approval had been obtained or not. Thereafter, another assessment of compliance verification was conducted on 9.4.2015 but again there was no mention of GDA approval.

The Committee further noted that on 27.8.2015, the Central Government, Ministry of Health & F.W., vide letter dated 11.9.2015 had forwarded a fresh application for establishment of New Medical College at Modinagar, District Ghaziabad, Uttar Pradesh (Divya Jyoti Institute of Medical Sciences & Research) by Jassar Dental Medical Education Health Foundation (JDMEHF) Modinagar, Ghaziabad for the academic year 2016-17. The certificate from Tahsildar dated 12.11.2014 enclosed alongwith the land documents states that permission from GDA is being obtained for building plan approval.

The Executive Committee of the Council further noted that the office vide its various communications had requested the clarifications/documents from the college authorities. The Committee further noted the response dated 13.11.2015, 07.12.2015 and 21.12.2015 (received on 28.12.2015) received from the Chairman, Jassar Dental Medical Education Health Foundation, Modinagar, Ghaziabad as well as the legal opinion on the matter which reads as under:-

“5. It is pertinent to note that the applicant has in its letter dated 07.12.15 had sought for two-week time to furnish the letter from Ghaziabad Development Authority. This letter was received in the Council office on 10.12.15. Thus the time limit sought by the applicant itself gets exhausted on 21.12.15. In case, any communication/correspondence by virtue of which the approval of GDA has been furnished by the applicant is received by that date as sought by the applicant, then it may be further processed.

6. Failing which, keeping in view the aforesaid proceedings, in Sri Muthukumaran Medical College in the Hon'ble High Court of Madras as

well as by the Executive Committee, in my considered opinion, the prudent course of action is to place the matter before the Executive Committee. It is open in my view for the Executive Committee to recommend the application for disapproval as the applicant had despite being granted sufficient opportunity failed to submit the requisite permission from the Ghaziabad Development Authority for its building plans.”

The Executive Committee of the Council further observed that applicant has not submitted any approval of GDA till date.

In view of above, the Executive Committee of the Council accepted the above legal opinion and decided to recommend to the Central Government to disapprove the scheme and return the application for establishment of New Medical College at Modinagar, District Ghaziabad, Uttar Pradesh (Divya Jyoti Institute of Medical Sciences & Research) by Jassar Dental Medical Education Health Foundation (JDMEHF) Modinagar, Ghaziabad u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

90. Establishment of new medical college at Palakkad, Kerala by Royal Medical Trust, Palakkad, Kerala with an annual intake of 150 MBBS students under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Palakkad, Kerala by Royal Medical Trust, Palakkad, Kerala with an annual intake of 150 MBBS students under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (16th & 17th December, 2015) and noted the following:

1. OPD: In Orthopaedics OPD, Plaster room & Plaster cutting room are common.
2. Both Audiometry & Speech therapy are in one room which is not permissible.
3. There was only 1 Normal delivery & NIL Caesarean Section on day of assessment.
4. Casualty: Some of the patients in Casualty were not of serious nature.
5. ICUs: There were only 2 patients each in ICCU, MICU, SICU & NICU/PICU.
6. Anatomy department: NIL cadavers are available.
7. Demonstration rooms in the hospital are small and many do not have teaching table; space between each row of chairs is less & congested. Some do not have Audiovisual aids.
8. Some of the patients admitted in General Medicine, Paediatrics, Psychiatry, Tb & Chest, General Surgery, Orthopaedics & Ophthalmology could have been managed on OPD basis.
9. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for establishment of new medical college at Palakkad, Kerala by Royal Medical Trust, Palakkad, Kerala under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

91. Consideration of Compliance Verification Assessment report with regard to continuance of recognition of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Jawahar Medical Foundation' Annasaheb Chudaman Patil Memorial Medical College, Dhule.

Read: the matter with regard to consideration of Compliance Verification Assessment report with regard to continuance of recognition of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Jawahar Medical Foundation' Annasaheb Chudaman Patil Memorial Medical College, Dhule.

The Executive Committee of the Council considered the compliance verification assessment report (17th December, 2015) along with previous assessment reports (14th July, 2015) and noted the following:-

1. Deficiency of faculty is 43 % as detailed in report.
2. Shortage of Residents is 82 % as detailed in report.
3. In Ophthalmology OPD, same room is shown as Dark Room & Keratometry room. In O.G. OPD there are only 2 Examination rooms against 4 required. Proper registers are not maintained. Deficiency remains as it is.
4. There were only 1 Major & 1 Minor operation for the whole hospital on day of assessment.
5. Register for Cytopathology is not maintained. Daily workload of Cytopathology is only 6-7. Deficiency remains as it is.
6. NIL quarters are available for non-teaching staff in the campus. Deficiency remains as it is.
7. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment upto 4 p.m.
8. Overall bed occupancy was 26 % on day of assessment. Bed occupancy in various departments was very low as under:

9. Radiological investigation workload is inadequate. Deficiency remains as it is.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision with regard to application of clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment),2010(Part II), dated 16th April, 2010 and to return the postgraduate applications of Jawahar Medical Foundation' Annasaheb Chudaman Patil Memorial Medical College, Dhule recommending disapproval of the scheme.

The Executive Committee of the Council further decided that since the gross deficiencies of teaching faculty, residents, & infrastructure are still

persisting inspite of repeated opportunities being given to the institute to rectify the same over a period of time, why the recognition for the award of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Jawahar Medical Foundation' Annasaheb Chudaman Patil Memorial Medical College, Dhule be not withdrawn u/s 19 of the IMC Act, 1956. It was further decided that the institute be directed not to make further admissions from the academic year 2016-17 onwards.

The Committee further decided to place the matter before the General Body of the Council.

92. Compliance Verification Assessment of the physical and the other teaching facilities available for 100 MBBS seats KMCT Medical College, Kozhikode, Kerala under Kerala University of Health Sciences, Thrissur.

The Executive Committee of the Council considered the compliance verification assessment report (16.12.2015) along with previous assessment reports (01.07.2015, 18th April, 2015 and 12th & 13th January, 2015) and noted the following:-

1. Deficiency of faculty is 11.6 % as detailed in report.
2. Shortage of Residents is 29.4 % as detailed in report.
3. Bed occupancy is 59.5 % on day of assessment.
4. There were only 4 Minor operations for the whole hospital on day of assessment.
5. Institute is maintaining double registers. Register in General Medicine OPD did not match with one of registers having inflated data.
6. OPD attendance was only 413 on day of assessment against 800 required.
7. Radiological investigation workload is inadequate.
8. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision with regard to application of clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment),2010(Part II), dated 16th April, 2010 and to return the postgraduate applications of KMCT Medical College, Kozhikode, Kerala recommending disapproval of the scheme.

The Executive Committee of the Council further decided that since the gross deficiencies of teaching faculty, residents, & infrastructure are still persisting inspite of repeated opportunities being given to the institute to rectify the same over a period of time, why the recognition for the award of MBBS degree granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at KMCT Medical College, Kozhikode, Kerala be not withdrawn u/s 19 of the IMC Act, 1956. It was further decided that the institute be directed not to make further admissions from the academic year 2016-17 onwards.

The Committee further decided to place the matter before the General Body of the Council.

93. To seek Guidance from the Executive Committee of the Council on the notification dated 07.03.2008 issued by the Govt. of India, Ministry of Health & F.W regarding recognition of Postgraduate Medical Qualifications awarded in USA, UK, Canada, Australia & New Zealand.

94. Pre-PG Assessment – Assessment of the physical and other teaching facilities available for starting of PG course at Raichur Institute of Medical Sciences, Raichur under Rajiv Gandhi University of Health Sciences, Bangalore.

Read: the matter with regard to Pre-PG Assessment – Assessment of the physical and other teaching facilities available for starting of PG course at Raichur Institute of Medical Sciences, Raichur under Rajiv Gandhi University of Health Sciences, Bangalore.

The Executive Committee of the Council considered compliance verification assessment report (16.12.2015) alongwith the previous assessment reports (15th & 16th Sept., 2014 & 9th March, 2015) and noted the following:-

1. Deficiency of faculty is 16.12 % as detailed in report.
2. Shortage of Residents is 36.23 % as detailed in report.
3. In Ophthalmology OPD, with regard to Dark room & Refraction room, only rooms with name boards are available; There is no equipment or facility provided.
4. Casualty: One room has only 7 beds against 20 required. Additional 4 beds in a small room with available & other 10 beds in SNCU are shown as Casualty.
5. Only 2 USG machines are available against requirement of 3.
6. Surgery & O.G. O.T.s have 2 tables which is not as per norms.
7. Speech Therapy is not available Deficiency remains as it is.
8. Audiometry room is available but there is no other instrument / facility provided. Deficiency remains as it is.
9. Common Rooms for Boys & Girls are yet to be furnished. Deficiency remains as it is.
10. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to grant 01 month time to the institute to submit the compliance on rectification of deficiencies to the Council for further consideration of the matter.

The Committee further decided to return the postgraduate applications in respect of Raichur Institute of Medical Sciences, Raichur .

95. Establishment of new medical college at Coimbatore, Tamilnadu by Govt. of Tamilnadu with an annual intake of 100 MBBS students under The Tamilnadu Dr. M.G.R Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Coimbatore, Tamilnadu by Govt. of Tamilnadu with an annual intake of 100 MBBS students under The Tamilnadu Dr. M.G.R Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (18th & 19th December, 2015) and noted the following:

1. Deficiency of faculty is 25.4 % as detailed in report.
2. Shortage of Residents is 13.3 % as detailed in the report.
3. Affiliated hospital is ESIC Hospital; however no proof/document is provided that it is owned by Govt. of Tamil Nadu who is the applicant for medical college. There is no MOU.
4. OPD: Separate Registration counters for males & females are not available. Separate Registration counters for OPD/IPD are not available. Registration counters are not computerized. Examination rooms & Teaching areas are inadequate. Enquiry desk is not available. In Ophthalmology OPD, Dark room & Dressing room are not available.
5. Casualty: Separate Casualty for O.G. is not available. Central O₂ & Central Suction are not available. Disaster Trolley, Crash Cart, Defibrillator, Ventilator are not available.
6. O.T.s: Only 2 O.T.s are available against 4 required. There are 2 tables in 1 O.T. which is not as per norms. Infusion Pumps are not available.
7. ICUs: ICCU & SICU are not available. There are only 2 beds in NICU/PICU.
8. Radiodiagnosis department: NIL mobile X-ray is available. There is only 1 static X-ray machine against 2 required. AERB approval is not available. Only 1 USG machine is available against requirement of 2.
9. Audiometry & Speech therapy are not available.
10. Workload of USG was NIL on day of assessment.
11. Histopathology & Cytopathology work is outsourced.
12. MRD: It is manual. ICD X classification of diseases is not followed for indexing.
13. CSSD is not available.
14. Intercom is not available.
15. Nursing staff: Only 130 Nurses are available against requirement of 174.
16. Paramedical & Non-teaching staff: 90 Paramedical & Non-teaching staff are available against requirement of 101.
17. College Council is not constituted.
18. Pharmaco Vigilance Committee is not constituted.
19. Central Library: Only space is available. It is not furnished. There are no books or journals.
20. Common Rooms for Boys & Girls are not available.
21. Central Photography Section is not available.
22. Students' & Nurses' Hostels are not furnished.
23. Gender Harassment Committee is not constituted.
24. Canteen is not available.
25. Anatomy department: Audiovisual aids are not available. Museum is non functional. Cadavers are not available. Band saw is not available. Lockers are not available.
26. Physiology department: Audiovisual aids are not available. Preparation rooms for laboratories are not available.
27. Biochemistry department: Audiovisual aids are not available.
28. Website is not available.
29. Other deficiencies as pointed out in the assessment report.

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3 (2) (5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds, the Executive Committee of the Council decided to return the application for establishment of a new medical college at Coimbatore, Tamilnadu by Govt. of Tamilnadu under The Tamilnadu Dr. M.G.R Medical University, Chennai to the Central Government recommending disapproval of the scheme u/s 10A of the IMC Act, 1956 for the academic year 2016-17 as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

The Executive Committee of the Council further noted that the application for establishment of a new medical college at Coimbatore, Tamilnadu by Govt. of Tamilnadu under The Tamilnadu Dr. M.G.R Medical University, Chennai had been processed by the office on the basis of opinion provided by the Law Officer of the Council even when a valid MoU was not available; therefore the Committee decided to seek explanation from the Law Officer as to under which provision the opinion had been provided when a valid MoU had not been submitted by the college authorities till date and whether in principal approval can be considered as deemed approval and secondly a 20% reservations had been sought for ESIC for admitting eligible wards of Insured Persons (IPs) in the DO Letter No. 34096/MC.2/2014-16, dated 5.5.2015.

96. Establishment of new medical college at Akathumuri, Varkala, Thiruvananthapuram, Kerala by S.R Educational & Charitable Trust, Kerala with an annual intake of 100 MBBS students under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Akathumuri, Varkala, Thiruvananthapuram, Kerala by S.R Educational & Charitable Trust, Kerala with an annual intake of 100 MBBS students under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (16th & 17th December, 2015) and noted the following:

1. Deficiency of faculty is 30.50 % as detailed in report.
2. Shortage of Residents is 86.66 % on day of assessment.
3. In respect of 09 Residents, hostel allotment order is predated than date of joining. In respect of 17 Residents, there is no hostel possession letter. Dr. Vipin Das, Senior Resident had no ID card of college & was unable to identify staff members.
4. OPD: There is no record in individual OPD to cross verify with central record.
5. Bed occupancy was < 35 % on day of assessment.
6. There is no Unitwise distribution of beds in General Medicine, General Surgery, O.G. & Paediatrics.
7. There was NIL Major & NIL Minor operation on day of assessment.
8. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment. There is no delivery since 07/12/2015 till date of assessment (i.e. 16/12/2015)
9. Radiological & Laboratory investigation workload is inadequate on day of assessment.
10. Workload of Histopathology & Cytopathology is NIL on day of assessment.
11. Casualty: In the morning, it was empty. Later on 3 patients were kept for observation without any serious indication or emergency treatment.
12. O.T. complex was totally closed.

13. ICUs: NICU/PICU are yet to open. There was NIL patient in MICU & SICU and only 1 patient in ICCU on day of assessment.
14. Blood Bank: There are only 2 bottles in stock. No bottles have been issued on day of assessment and also during the period from 01/12/2015 to 10/12/2015. It was closed at 04:30 p.m. on day of assessment.
15. MRD is partly computerized.
16. Central Library: Internet is not working.
17. Anatomy department: Only 70 specimens are available.
18. All the Demonstration rooms require updation.
19. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for establishment of new medical college at Akathumuri, Varkala, Thiruvananthapuram, Kerala by S.R Educational & Charitable Trust, Kerala under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Executive Committee of the Council further decided to refer the matter to the Ethics Committee of the Council.

97. Establishment of new medical college at Dewas, Madhya Pradesh by Amaltas Education Welfare Society, Indore, M.P with an annual intake of 150 MBBS students under Madhya Pradesh Medical Science University, Jabalpur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

Read: the matter with regard to establishment of new medical college at Dewas, Madhya Pradesh by Amaltas Education Welfare Society, Indore, M.P with an annual intake of 150 MBBS students under Madhya Pradesh Medical Science University, Jabalpur u/s 10A of the IMC Act, 1956 for the academic year 2016-2017.

The Executive Committee of the Council considered the Council Assessors report (18th & 19th December, 2015) and noted the following:

1. Deficiency of faculty is 69.23 % as detailed in report.
2. Shortage of Residents is 78.26 % as detailed in the report.
3. OPD attendance was 353 on day of assessment.
4. Bed occupancy was 40 % on day of assessment.
5. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment.
6. Radiological & Laboratory investigation workload was inadequate on day of assessment.
7. ICUs: There was only 1 patient in ICCU on day of assessment.
8. Blood Bank is not available.
9. Lecture Theaters: They are under construction.
10. Central Library: It is under construction.
11. Common Rooms for Boys & Girls are under construction.
12. Central Photography Section is not available.
13. Students', Residents' & Nurses' Hostels are under construction.
14. Residential Quarters are under construction.
15. Preclinical departments of Anatomy, Physiology & Biochemistry are under construction.
16. With regard to Paraclinical departments, space is not shown in the building under construction.
17. Website is not available.
18. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to issue Letter of Permission for establishment of new medical college at Dewas, Madhya Pradesh by Amaltas Education Welfare Society, Indore, M.P under Madhya Pradesh Medical Science University, Jabalpur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

98. Approval of the proceedings of the Ethics Committee meetings held on 15th & 16th October, 2015 and 04th & 05th November, 2015.

Read: the matter with regard to approval of the proceedings of the Ethics Committee meetings held on 15th & 16th October, 2015 and 04th & 05th November, 2015.

The Executive Committee of the Council perused the proceedings of the Ethics Committee meetings held on 15th & 16th October, 2015 and 04th & 05th November, 2015.

A: MEETING DT. 15 & 16/10/2015:

The Committee approved the proceedings of case nos. 2, 17 & 19 of 15th & 16th October, 2015 and rest of the proceedings, the Committee observed as under pointwise:-

1. CASE # 20. RC OF CBI ON 131 DOCTORS OF VINAYAKA MISSION MEDICAL COLLEGE, KARAIKAL

E.C. has already decided the matter at its meeting on 21/09/2015 wherein it was decided to disapprove decision of Ethics Committee. It is not comprehended how this matter has again been put before Ethics Committee for consideration. Further the wordings used in decision "*Ethics Committee reconsidered the matter and decided to accept the version of Executive Committee*" shows breach of protocol.

Ethics Committee is directed that in future it should reconsider only those items which are referred back by Executive Committee for reconsideration. Those matters on which Executive Committee has taken a decision of not approving the decision of Ethics Committee are beyond the scope and purview of Ethics Committee for reconsideration.

2. CASE # 21. CBI CASE AGAINST SHRI LAXMI NARAYAN INSTITUTE OF MEDICAL SCIENCES, PUDUCHERRY

E.C. has already decided the matter at its meeting on 21/09/2015 wherein it was decided to disapprove decision of Ethics Committee. It is not comprehended how this matter has again been put before Ethics Committee for consideration. Further the wordings used in decision "*Ethics Committee reconsidered the matter and decided to accept the version of Executive Committee*" shows breach of protocol.

Ethics Committee is directed that in future it should reconsider only those items which are referred back by Executive Committee for reconsideration. Those matters on which Executive Committee has taken a decision of not approving the decision of Ethics Committee are beyond the scope and purview of Ethics Committee for reconsideration.

3. CASE # 26. APPEAL FILED BY MR. MOHD. JEESHAN AGAINST U.P. MEDICAL COUNCIL

Not Approved. Executive Committee had clearly indicated in its decision that *"It would be desirable to obtain answers to queries asked by these two experts and obtain definitive expert opinion from them before any final decision is reached. Presently only definitive opinion states that "there does not seem to be any medical negligence in this case."*

This has not been done. Instead Ethics Committee has only reconsidered existing material and incomplete expert opinions of 2 experts. No answers to queries asked by 2 experts have been made available to have a definitive expert opinion of the two experts. Referred back with above observations.

B: MEETING DT. 04 & 05/11/2015:

The Executive Committee of the Council approved the proceedings of case nos. 1(17), 5,6,7,8 (with directions),10,11 and rest of the proceedings, the Committee observed as under pointwise:-

1. **CASE # 1(8) FAKE D.F. OF DR. D.R. PADMANABHA APPEARING AT MORE THAN 1 MEDICAL COLLEGE**

In the Minutes, Ethics Committee has recorded that Dr. D.R. Padmanabha did mention the fact that he appeared for assessment at Kannur Medical College while appearing for assessment for II college (i.e. Karwar Institute of Medical Sciences). However, Dr. S.B. Sharma has categorically denied this fact stating that *"he had not disclosed this fact that he had appeared for inspection at Kannur Medical College"*. Referred back to Ethics Committee with above observations to take appropriate decision after verification & consideration of all facts.

2. **CASE # 8. APPEAL FILED BY DR. R.K. JAIN AGAINST M.P. MEDICAL COUNCIL**

Approved. Office is directed that period of suspension of 1 year would come into effect from date of issue of order of suspension by M.P. Medical Council subsequent to decision in this appeal.

Office Note: Section to verify whether any stay order was issued for suspension & if not, whether Dr. R.K. Jain has practiced during the period from first decision of suspension by M.P. Medical Council till date.

99. **Approval of the proceedings of the Ethics Committee meeting dated 2nd & 3rd December, 2015.**

Read: the matter with regard to approval of the proceedings of the Ethics Committee meeting dated 2nd & 3rd December, 2015.

The Executive Committee of the Council perused the proceedings of the Ethics Committee meeting held on 2nd & 3rd December, 2015 and approved the proceedings of case nos. 22,23,25 & 31 and rest of the proceedings, the Committee observed as under pointwise:-

1. **CASE # 11. FALSE REPORT CAME IN PRESS AGAINST OFFICE BEARERS OF IMA KERALA STATE BRANCH**

Dr. K.V. Babu has not responded to notice issued by it. Even Law Officer has given a finding that sufficient opportunity was given to him. In the last meeting of Ethics Committee it was decided that ex-parte

decision will be taken if he does not appear. He has not appeared in this meeting or he has not submitted any document. Factual matrix of the case has also not been verified. However instead of taking ex-parte decision, it is decided by Ethics Committee to drop the case.

Referred back to Ethics Committee with above observations to take appropriate decision after considering all aspects & verifying factual matrix.

In view of clarification submitted by the Section, the Executive Committee of the Council noted that the complainant i.e. I.M.A. had withdrawn its complaint and therefore the matter be treated as closed.

2. CASE # 12. ISSUE OF TEACHING EXPERIENCE CERTIFICATES TO VARIOUS FACULTY PRIOR TO STARTING OF PG COURSES AT MAMTA MEDICAL COLLEGE, KHAMMAM

Decision of Ethics Committee is to close the case as the Dean who had worked during 1997-2004 has retired & crossed permissible age for employment; however it is not clarified what happens to decision taken at earlier meeting dt. 17 & 18/11/2014 to debar Dr. K. Koteswar Rao permanently from any administrative or teaching post, to issue warning to Dr. J. Sasi Kumar & Dr. Gurunadha Rao and to debar Dr. Anil Grover for 5 years from accepting any teaching post. Earlier decision of the Executive Committee that a decision be taken on uniform basis has also not been given effect to.

Referred back to Ethics Committee with above observations to take appropriate decision after considering all aspects.

3. CASE # 13. FAKE ' FORGED DOCUMENTS SUBMITTED BY DR. D. ARUNA, SENIOR RESIDENT AT MALLA REDDY INSTITUTE OF MEDICAL SCIENCES, HTDERABAD

Not approved. Ethics Committee has not taken into consideration the original finding of the Executive Committee that *"In view of the submission of MNR Medical College, Sangareddy, the Executive Committee of the Council noted that Dr. D. Aruna had not worked as Junior Resident in the department of General Medicine at any point of time at MNR Medical College and the experience certificate dated 31/07/2008 and subsequent letter dated 01/08/2008 are fabricated documents issued by Dr. Chandrakant Shirole."* This finding is consistent with the fact that no D.F. of Dr. D. Aruna from MNR Medical College is available with UG section. Further, although she claims to have worked for 3 years but states that she was present in only 2 inspections which itself throws doubt on her experience as no institute would not present a Resident for inspection if really working there. In respect of Dr. Chandrakant Shirole, he could not have issued a certificate dated 01/08/2008 admittedly at a later date.

Referred back to Ethics Committee to reexamine the matter afresh and take appropriate decision.

4. CASE # 14. COMPLIANCE VERIFICATION ASSESSMENT OF MAHARAHTRA INSTITUTE OF MEDICAL SCIENCES, TALEGAON, PUNE

Not approved. The issue is not whether it is compulsory for Tutors to stay in campus or not. The decision of E.C. was that "Dr. Mihir Chaudhary & Dr. Swapnil Thorat were found not to be staying in
