1. <u>Minutes of the Executive Committee Meeting held on 22nd December, 2016, 13th January, 2017 & 25th January, 2017.</u>

The Executive Committee of the Council confirmed the minutes of the Executive Committee Meetings held on 22nd December, 2016 & 13th January, 2017 and 25th January, 2017. While confirming the minutes of its meeting held on 25th January, 2017, the Executive Committee observed that under item no.15 i.e. "Minutes of meeting of the TEQ Sub-Committee held on 23.01.2017", the decision be read as under:-

"The Executive Committee of the Council perused the minutes of the TEQ Sub- Committee meeting held on 23.01.2017 and approved the decision of TEQ Sub- Committee with regard to Item # 3,4,5,8 & 12.

It was further decided not to approve the decision of TEQ Sub-Committee with regard to the following items due to reasons mentioned thereat:

6. Confirmation of eligibility for the post of Associate Professor/Assistant Professor in the department of Paediatric Oncology in respect of Dr. Nitin C. Joshi in a Medical College.

The Executive Committee of the Council referred back to TEQ Sub-Committee to resubmit the matter with full particulars of qualifications & teaching experience to be incorporated in the Minutes

7. Confirmation of eligibility for the post of Professor in the department of Nephrology in respect of Dr. Manjunath S. Shetty in a medical college.

The Executive Committee of the Council observed that the facts are not clear from minutes. It is recorded that the candidates Asst. Professorship for 2 years is inadequate as per TEQ Regulations. As TEQ Regulations prescribe 2 year experience as Asst. Prof. for promotion to Asso. Prof. of Nephrology, it is not clear as to how it has been considered inadequate. Referred back to TEQ Sub-committee to re-examine & resubmit. Meanwhile, communication be sent to Dr. Manjunath Shetty to submit his publications.

9. <u>Confirmation of eligibility for the post of Assistant Professor in department of Orthopaedics in respect of Dr. Vinay Vasu Bangera in a Medical College.</u>

The Executive Committee of the Council referred back to TEQ Sub-Committee to resubmit the matter with full particulars of qualifications & teaching experience to be incorporated in the Minutes.

10. <u>Confirmation of eligibility of Dr. Pratap Kumar Rath for the post of Medical Superintendent in a medical college in India.</u>

The Executive Committee of the Council observed that it is not clear from minutes whether as Professor of Surgery for 7 years he was Unit Head or not. This be re-examined. If not, that experience cannot be considered as administrative experience. Further it is also not clear whether two periods of 5 years & 7 years are separate or the period of 5 year as Unit Head is incorporated within larger period of 7 years as Professor. Matter to be resubmitted after re-examination as indicated.

11. Confirmation of eligibility of Dr. Manjit Singh Chahal for the post of Professor in General Medicine in a medical college in India.

The Executive Committee of the Council observed that the facts are not clear from the minutes. If the candidate was eligible as Asst. Prof. on 10/12/2011, he could not have become Professor on 09/12/2015. This be re-examined and experience be clearly recorded in the Minutes. Matter to be resubmitted after re-examination as indicated. Meanwhile communication be sent to him to submit details of publications.

13. <u>Proposed Amendments in the Medical Council of India Regulations namely Minimum Qualifications for Teachers in Medical Institution Regulations 1998 – approval of.</u>

The Executive Committee of the Council considered the matter regarding proposed amendments in the Medical Council of India Regulations namely Minimum Qualifications for Teachers in Medical Institution Regulations 1998 alongwith the letter received from Govt. of India, Ministry of Health & F.W. and directed the section to examine why special training for 3 years in Paediatric Neurology for M.D. (Paediatrics) degree holders is required as in all other subjects, special training requirement is of 2 years only.

The Executive Committee further requested the TEQ Subcommittee -

- (1) To place only those items on which a final decision has been taken for consideration by Executive Committee. If any details are required from the individual/institute, such items need not be placed before Executive Committee;
- (2) If any details of teaching experience, publications, etc. are required to be obtained, such a communication be sent to the concerned faculty/Institute without waiting for approval from the Executive Committee; &
- (3) While recording Minutes, full details of academic qualifications, teaching experience &research publications should be incorporated in the minutes."

The minutes of the above item were read out, approved and confirmed in the meeting itself.

The Executive Committee decided to place the matter before the Postgraduate Medical Education Committee.

15. Note from PG Section regarding Inclusion of DM (Paediatric Hematology Oncology) course in Postgraduate Medical Education Regulations, 2000

The Executive Committee decided to place the matter before the Postgraduate Medical Education Committee.

16. E-mail received from Dr. ShrishPatil dated 13.01.2017 regarding research articles published in Journal of own specialty / any medical subject.

The Executive Committee approved the recommendations subject to amendment that not more than one research publication in the field of Medical Education Technology in the Indexed / National Journals shall be considered towards eligibility for promotion.

17. Concerns expressed by Executive Committee meeting on 23 August, 2016 on starting new Superspecialty and broad specialty courses.

The Executive Committee noted the recommendations and directed the Academic Committee to bring forth suitable amendment in the regulations so that a, b & c are implemented.

18. Any other item with permission from Chair

a. E-mail received from Mr. Nischith Dsouza dated 21.01.2017 regarding publication guidelines

The Executive Committee approved the recommendations of the Academic Committee.

b. Report of the Committee on National Education Policy 2016.

The Executive Committee approved the recommendations of the Academic Committee and directed to include the following report:-

The present committee came to be constituted by the President, Medical Council of India for the purposes of crystallizing suggestions / views on the National Education Policy 2016 formulated by the Government of India, through its Department of Human Resource Development.

The committee noted that the Ministry of Health and Family Welfare, Government of India, had constituted a five member committee for evolution of the new education policy on 31st October, 2015 under the Chairmanship of Mr. T. S. R. Subramanian, Former Cabinet Secretary to the Government of India. The other four members of the committee were Smt. Shailaja Chandra, Former Chief Secretary, NCT of Delhi, Shri Sevaram Sharma, Former Home Secretary NCT of Delhi, Shri Sudhir Mankad, Former Chief Secretary, Gujarat and Prof. J. S. Rajput, Former Director NCERT with National University of Educational Planning and Administration (NUEPA) Serving as its secretariat. The committee submitted its report on 27th May, 2016 and has been put on the public domain.

Upon perusal of the report of the committee and recommendations from various consultations, which were held some inputs of the Draft National Education Policy 2016 have been formulated by the Ministry of Human Resource Development and have been forwarded to the concerned institutions and authorities for their opinion.

The Under Secretary to the Government of India, in the Ministry of Health and Family Welfare, vide a covering letter dated 21st July, 2016 forwarded it to the Secretary, Medical Council of India to forward inputs on the same including use, comments, suggestions of the Medical Council of India.

In view of the same, the President, Medical Council of India constituted the said committee for the needful.

The committee at its meeting held on 23rd January, 2017, looked into the National Education Policy Report and cumulative draft thereto formulated by the Ministry of Human Resource Development and is pleased to observed as under:

The said report at Para 7.11 has observed about Medical Education, which is as under:

- "7.11.1 Currently there are more than 400 functional medical colleges in the country out of which about half find the government sector (including the new six AllMS) and the remaining nine the private sector. The admission capacity of these medical colleges is around 57,000 at the undergraduate level and around 26,000 at the postgraduate level.
- 7.11.2 The majority of medical colleges are concentrated in the south and west of the country. The north-eastern region has comparatively still fewer facilities for medical education than anywhere else. The number of seats in the existing medical colleges falls short of the present demand for medical professionals. The growth postgraduate education has been very slow, which has an effect on the preparation of the next generation of medical teachers as well as the specialised doctors to undertake clinical practice and research.
- 7.11.3 The existing framework of medical education needs significant restructuring. Within the medical Council of India/dental Council of India/Indian medical Council (AYUSH) the work of setting standards, curriculum development, inspection and grant of permission for setting up new institutions, undertaking lies with the Councils subject to central government approval where defined. The Councils and in particular the Medical Council of India comprises of elected persons who have a strong vested interest in retaining their voting constituency over the larger interests of public health and medical education. Such entrenched interests of different kinds should be kept away from the functions of inspection, verification and standard-setting as well as approval for opening new institutions
- 7.11.4 A recent Parliamentary committee has given significant recommendations about how various matters related to the running of the Medical Council in particular have to receive attention. The government will no doubt take action as appropriate.
- 7.11.5 In keeping with recommendations which have already been made in respect of assessment and accreditation through professional and technical bodies working under the supervision of apex level nonelected bodies, it is necessary to replicate the same approach here. The responsibility for Manpower planning, design of curricula and standard-setting needs to be done by a body which is conversant with the demographics of India, the prevalence of communicable and non-communicable diseases, challenges connected with maternal and child health so that the production of doctors is planned keeping in mind the needs of specialised as

well as general duty doctors. Medical education needs an umbrella body as recommended for the higher education sector representation from citizens and consumers who could address the concerns of the public.

7.11.6 More public investment is needed for starting medical colleges and different regions. The private sector needs to be encouraged to set up medical colleges, with appropriate incentives. The present minimum requirement of land for setting up a medical college needs to be reviewed.

Recommendations

7.11.7 The number of seats in the existing medical colleges falls well short of the present demand for medical professionals. The growth postgraduate education has been very slow which has an effect on the preparation of the next generation of medical teachers as well as the specialised doctors to undertake clinical practice and research.

7.11.8 The existing framework of medical education needs significant restructuring. Entrenched interests of different kinds should be kept away from the functions of inspection, verification and standard-setting as well as approval for opening new institutions.

7.11.9 More public investment is needed for starting medical colleges. The private sector needs to be encouraged to set up medical colleges, with appropriate incentives".

On evaluation of the aforesaid inclusions pertaining to medical education in the National Education Policy 2016 document it is seen that they are generic in character. They need more elaborative discussion as has been invoked in the very report pertaining to 'Higher Education' with reference to Governance reforms in Higher Education and policy initiatives thereto, Regulation in Higher Education and relevant policy initiatives pertaining to the same followed by quality assurance in higher education and needed policy initiatives thereto.

The aspect of medical education in view of its significance and importance deserved to be discussed and formulated on the similar manner. As the same is wanting following suggestions are made for their appropriate incorporation in the report.

SUGGESTIONS:

- 1. In order to ensure timely implementation of academic policies towards generation of desired standards of medical education, the regulations on the said count need to be notified in a timely manner. The experience of the council over a period of time has been that they approval and notifying period taken by the Government of India, ranges from 1 year to 4 years, which comes as a big ordeal, with reference to timely implementation of the same. As such the regulations on academic matters should be exempted from the binding condition of their prior approval by the Government of India, by invoking an appropriate amendment to section 33 of the existing IMC Act
- In respect of other regulations (excluding academic) the time limit needs to be prescribed statutorily by an amendment for the approval and notification by the Govt. Such a time limit should be of six months duration from the date of submission of the draft regulation by the council to the Government of India.
- 3. The concept of recognition of medical colleges under the present scheme in the Act, against the prescribed Minimum Standard Requirements does not and cannot guarantee desired competitive and comparable standards. As such, it was recommended by the council that an accreditation mechanism autonomous in character needs to be created for medical education on the similar lines as University Grants Commission Act, 1956, provided for creation of an autonomous National Assessment and Accreditation Council for the Higher Education and All India Council for Technical Education Act, 1983, provided for creation of a National Accreditation Board for Engineering and Technological institutions in the country, so as to ensure outcome based evaluation of medical colleges in the country.
- 4. By a suitable amendment the Medical Council of India should be vested with the authority to prescribe pay scales and service conditions of the full time teachers in the medical education in the country as is accruable to University Grants Commission for higher education and All India Council for Technical Education for Technical Education.
- 5. By a suitable amendment medical education and medical colleges should be covered within the scope and meaning of section 12(b) of the University Act Commission Act, 1956 for entitlement to claim planned development grants as are accruable to higher education institutions.
- 6. In order to obviate the problem of density of medical colleges in geographical locations by a suitable amendment, the council should be empowered to propose a national perspective five year developmental plan to the Government of India for its approval with reference to need based location of medical schools on the considerations of socio-economic backwardness of the geographic location for the purposes of evoking equity and equitable geographic distribution of medical schools in the country. Such a plan for the concerned plan period should be binding for the geographic location of medical colleges in the country.
- 7. Appropriate mechanisms for faculty development in the form of Academic Staff Colleges for medical teachers in tune with those that have been created for teachers in higher education need to be evoked.

RECOMMENDATIONS:

1. Notwithstanding the above incorporations that have been suggested by the committee in the National Education Policy 2016, in the fitness of things it would be appropriate that the Ministry of Health and Family Welfare, Government of India, in consultation with Medical Council of India and other relevant stakeholders evolves a comprehensive National Policy on Medical Education in an independent exclusive document taking into consideration the concerns and challenges that confront it contemporarily and a long term basis so as to give a much desired fillip.

The Committee further directed to place the same before the General Body of the Council.

The minutes of the above item were read out, approved and confirmed in the meeting itself.

The Executive Committee of the Council perused the minutes of the Migration Sub-Committee meeting held on 14.2.2017 and observed as under:-

3. <u>Migration of Ms. Cheshtha Singla from Adesh Instt. Of Medical Sciences & Research, Bathinda to Govt. Medical College, Patiala.</u>

The Executive Committee approved the recommendations of the Migration Sub-Committee.

4. <u>Migration of Mr. Rutvij Prashant Patel from R.D. Gardi Medical College, Surasa, Ujjain to GCS Medical College, Hospital Research Centre, Ahmedabad.</u>

The Executive Committee of the Council did not approve the recommendations of the Migration Sub-Committee as Bronchial Asthma with Allergic Rhinitis with episodes of Status Asthmaticus is not a disease covered in the category of critical illness. Further as per the certificate, change of place is <u>preferable</u> which implies that it is not absolute must.

5. <u>Migration of Ms. Neelansha Pratap from Jorhat Medical College</u> & Hospital, Jorhat to S.N. Medical College, Agra.

The Executive Committee of the Council observed from the agenda note it is not clear whether Disturbed Area Notification was prevalent when admission was taken. It is also not clear under which category admission was taken at this Institute. If it was taken under AIEE category knowing that Disturbed Area Act was in force in Assam when the admission was taken then there is no valid ground for migration.

The Executive Committee referred back the matter to Migration Sub-Committee to ascertain the full facts & take appropriate decision in view of above observations.

The photograph on D.F. presented during assessment at Subbaiah be also compared with the original. It appears that the evidence presented by Dr. Darshan is circumstantial evidence which be weighed against evidence in the form of D.F. Appropriate decision be taken thereafter.

The Ethics Committee, based on available records confirmed that Dr. Paresh Ruparel was shown to be employed as a fulltime faculty in R.K.D.F. Medical College Hospital & Research Centre, Bhopal during January-2015 to February-2015. During that time period, proof has been submitted that he was also working on some days at Seth V.S. Hospital, Ellisbridge, Ahmedabad. Thus it is clear that Dr. Paresh Ruparel was not a full time faculty in R.K.D.F. Medical College Hospital & Research Centre, Bhopal during. He was only part time faculty. He has concealed this fact in his Declaration Form which was duly attested/signed by the then Dean, Dr. U. B. Shah.

In view of above, the Ethics Committee found violation of Regulation by the faculty and also the Dean as they have submitted false and forged information to the MCI and misguided the Council Office as well as the Assessors, who had carried out the inspection. Therefore, the Ethics Committee is of the view that the name of Dr. Paresh Ruparel and Dr. U. B. Shah, the then Dean of R.K.D.F. The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

- 8 (3) ...
- (2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in subclause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.

The Committee decided to place the matter before the General Body of the Council.

The minutes of the above item were read out, approved and confirmed in the meeting itself.

13. Recognition/Approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956.

Read: the matter with regard to recognition/approval of Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment reports (06th & 07th February, 2017 and 21st December, 2016) alongwith a letter dated 22.02.2017 received from the college authorities and noted the following:-

- 1. Casualty: Ventilator is not available. Portable Ventilator is not functional.
- 2. ICUs: There were only 2 patients in PICU on day of assessment.
- 3. 2 Static X-ray machines are available against requirement of 5.
- 4. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Government not to recognise/approve Hamdard Institute of Medical Sciences & Research, New Delhi for the award of MBBS degree (100 seats) granted by Jamia Hamdard University, New Delhi u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 15 days for further consideration of the matter.

The minutes of the above item were read out, approved and confirmed in the meeting itself.

14. Application of clause 8(3)(1)(d) from the academic year 2016-17 onwards on Career Institute of Medical Sciences & Hospital, Lucknow, U.P.

Read: the matter with regard to application of clause 8(3)(1)(d) from the academic year 2016-17 onwards on Career Institute of Medical Sciences & Hospital, Lucknow, U.P.

The Executive Committee of the Council observed that the compliance verification assessment report (2nd August, 2016) alongwith previous assessment report (22nd April, 2016) with regard to recognition/approval of Career Institute of Medical Sciences & Hospital, Lucknow, Uttar Pradesh for the award of MBBS degree (100 seats) granted by Dr. RML Avadh University, Faizabad, Uttar Pradesh u/s 11(2) of the IMC Act, 1956 was considered in its meeting held on 23.08.2016 and it was decided as under:-

"The Executive Committee of the Council considered the compliance verification assessment report (2nd August, 2016) along with previous assessment report(22nd April, 2016) and decided to recommend to the Central Government for recognition/approval of Career Instt. of Medical Sciences & Hospital, Lucknow for the award of MBBS degree(100 seats) granted by Dr. RML Avadh University, Faizabad, Uttar Pradesh u/s 11(2) of the IMC Act, 1956.

The Executive Committee further noted that clause 8(3)(1)(d) as recommended by the Ethics Committee at its meeting dated 3rd & 4th May, 2016 and approved by the Executive Committee on 15.06.2016 had been applied against the college.

In view of above, the Committee decided that the Institute be directed not to admit fresh batch of students for the academic year 2016-17 and 2017-18."

The Executive Committee further observed that the Council Office had received a letter dated 05/10/2016 from the Central Govt. addressed to the Secretary, OC and copy to this Council regarding comments/remarks of the Central Govt. on the minutes of the Executive Committee meeting dated 23.08.2016 in respect of Career Institute of Medical Sciences & Hospital, Lucknow u/s 11(2) of the IMC Act, 1956, which reads as under:-

"MCI vide letter dated 09.10.2015 recommended not to renew permission for admission of 5th batch at Career Institute of Medical Sciences & Hospital, Lucknow for 2015-2016 and also applied clause 8(3)(1)(d) of Establishment of Medical College Regulations that debar the college for 2016-17 also. However, the E.C. has now decided that the institution be directed not to admit fresh batches of students for the academic year 2016-2017 and 2017-2018. This needs to be re-considered. The E.C. has decided to recommend recognition of college u/s 11(2) of the IMC Act, 1956 but at the same time recommended to apply clause 8(3)(1) (d) of Regulation. The batches to be recognised needs to be indicated clearly.

Accordingly, the matter was considered by the Executive Committee at its meeting held on 04.11.2016 and it was decided as under:-

"The Executive Committee of the Council after due deliberations, decided that application of Section 8(3)(1)(d) regarding fake faculty of Establishment of Medical College Regulations, 1999 and recognition of a course u/s 11(2) of IMC Act, 1956 are two separate, distinct items and are independent of one another. Recognition u/s 11(2) of IMC Act envisages recognition of batches already admitted under LOP & Renewal of Permissions granted u/s 10A of IMC Act and thus applies retrospectively.

If an institute fulfills requirement of faculty, Residents, clinical material, infrastructure, etc., it is recommended for Recognition for award of degree. If during any assessment it is found that fake faculty is employed or if the documents submitted by faculty and countersigned by Dean are found to be fake/forged, then Section 8(3)(1)(d) is applied and the institute is debarred for admitting students for 2 Academic years. This is applicable with regard to any assessment and is applicable irrespective of recognition status of the institute.

The Committee observed that in the instant case, as the institute found to have fulfilled all deficiencies as verified by compliance verification assessment as shown above, it is recommended for Recognition for award of MBBS degree u/s 11(2) of IMC Act, 1956 which in fact applies retrospectively to previous batches admitted under LOP & Renewals of Permissions issued by Govt. of India. Simultaneously, as in one assessment, as it was found to have employed faculty with fake/forged documents, Section 8(3)(1)(d) of Establishment of Medical Colleges Regulations, 1999 is applied prohibiting institute for admitting

students for 2 Academic Years prospectively. Thus there is no inconsistency in this regard.

In view of above, the Executive Committee of the Council decided to convey the above to the Central Government and further decided to refer the matter to ASG for opinion."

The General Body of the Council at its meeting held on 22.11.2016 had also approved the recommendations of the Executive Committee with regard to recognition/approval of Career Instt. of Medical Sciences & Hospital, Lucknow for the award of MBBS degree(100 seats) granted by Dr. RML Avadh University, Faizabad, Uttar Pradesh u/s 11(2) of the IMC Act, 1956.

This decision of the General Body has not been formally communicated to the Central Government. Meanwhile, the Council Office has also received the opinion of Council Advocate as sought for by the Executive Committee in its meeting held on 04.11.2016.

The Executive Committee of the Council perused the opinion of Council Advocate in the matter, operative part of which reads as under:

"...In view of the above factual matrix, I am of the opinion that while considering the application for grant of permission to admit MBBS students for academic year 2015-16 the querist had invoked Regulation 8(3)(1)(d) of the Establishment of Medical College Regulations, 1999 and recommended to the Central Government to debar the applicant medical college from admitting students for academic year 2015-2016 and 2016-17. Since the applicant medical college was not granted permission by the Central Government to admit any students for two academic years i.e. 2015-16 & 2016-17, hence the applicant medical college has undergone the penalty as envisaged under Regulation 8(3)(1)(d) of the Establishment of Medical College Regulations, 1999 and has not admitted any students for said two academic years. In view thereof, the applicant medical college cannot be made to suffer again for the same action, thus the querist may reconsider their decision, whereby the applicant medical college has been again debarred from admitting student for academic years 2016-17 as also 2017-18 and thereafter consider the application submitted by the applicant medical college for renewal of permission to admit students in MBBS course for academic year 2017-18 in accordance with the provisions of the IMC Act, 1956 and the Regulations made thereunder...."

In view of above, the Executive Committee of the Council decided to communicate to the Central Govt. that Institute has already been debarred for 2 Academic Years – i.e. 2015-2016 & 2016-2017 & therefore the decision of Executive Committee meeting held on 23.08.2016 regarding debarment for Academic Year 2016-17 and 2017-18 is not applicable. Therefore, the Executive Committee decided to recommend to the Central Government for recognition/approval of Career Instt. of Medical Sciences & Hospital, Lucknow for the award of MBBS degree(100 seats) granted by Dr. RML Avadh University, Faizabad, Uttar Pradesh u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council further decided to place the matter before the General Body of the Council.

The minutes of the above item were read out, approved and confirmed in the meeting itself.

15. Recognition/approval of Padmashree Dr. D.Y. Patil Medical College, Hospital & Research Centre, Pimpri for the award of MBBS degree granted by Dr. D.Y. Patil Vidyapeeth (Deemed University) Pune against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956.

Read: the matter with regard to recognition/approval of Padmashree Dr. D.Y. Patil Medical College, Hospital & Research Centre, Pimpri for the award of MBBS degree granted by Dr. D.Y. Patil Vidyapeeth (Deemed University) Pune against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment reports (06th & 07th February, 2017 and 10th December, 2016) and decided to recommend to the Central Government for recognition/approval of Padmashree Dr. D.Y. Patil Medical College, Hospital & Research Centre, Pimpri for the award of MBBS degree granted by Dr. D.Y. Patil Vidyapeeth (Deemed University) Pune against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

- 8 (3) ...
- (2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

The Executive Committee of the Council considered the assessment reports (20th & 21st February, 2017 and 20th January, 2017) and decided to recommend to the Central Government for recognition/approval of Bharati Vidyapeeth Deemed University Medical College & Hospital, Sangli, Pune for the award of MBBS degree granted by Bharati Vidyapeeth Deemed University, Sangli, Pune against the increased intake i.e. from 100 to 150 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

- 8 (3) ...
- (2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

The Executive Committee of the Council considered the compliance verification assessment report (10.02.2017) along with previous assessment reports (19.07.2016, 27.04.2016, 10.03.2016 & 11.03.2016) and noted the following:-

- 1. Deficiency of faculty is 12.06 % as detailed in the report.
- Deficiency of inadequate teaching areas in OPD remains as such. It is not rectified.
- 3. Audiologist was not available on day of assessment.
- 4. ETO Sterilizer is not available. Deficiency remains as it is.
- 5. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Government not to recognise/approve NRS Medical College, Kolkata for the award of MBBS degree granted by The West Bengal University of Health Sciences, Kolkata against the increased intake i.e. from 150 to 250 u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 15 days for further consideration of the matter.

The minutes of the above item were read out, approved and confirmed in the meeting itself.

18. Recognition/approval of Rajendra Institute of Medical Sciences, Ranchi for the award of MBBS degree granted by Ranchi University, Ranchi against the increased intake i.e. from 90 to 150 seats u/s 11(2) of the IMC Act, 1956.

Read: the matter with regard to recognition/approval of Rajendra Institute of Medical Sciences, Ranchi for the award of MBBS degree granted by Ranchi University, Ranchi against the increased intake i.e. from 90 to 150 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment reports (09th February, 2017 and 2nd September, 2016) and decided to recommend to the Central Government for recognition/approval of Rajendra Institute of Medical Sciences, Ranchi for the award of MBBS degree granted by

Ranchi University, Ranchi against the increased intake i.e. from 90 to 150 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

- (2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

Read: the matter with regard to Live Streaming of both classroom teaching and the teaching hospital under Digital Mission Mode Project (DMMP) of MCI - Appointment of Expert Agency as Consultant for Project requirements and preparation of RFP etc.

The matter was placed in Executive Committee Meeting held on 13.01.2017 and 25.01.2017 and at both the occasions, the matter was deferred for next Executive Committee Meeting, hence the matter is re-submitted for consideration.

The Executive Committee noted that the Joint Secretary.(M.E.) vide his letter dt. 03/01/2017 has asked about the progress of 'Live Streaming of both classroom teaching and the teaching hospital under Digital Mission Mode Project (DMMP) of MCI', as desired by the MOH&FW vide their letters dated 30.09.2016 & 18.10.2016. It was informed to the J.S.(M.E.) that the proposal has been approved by the Executive Committee of the Council at its meeting held on 22.12.2016 and the further action is being taken. The J.S.(M.E.) emphasized to implement the said project at the earliest by directing all the medical colleges to install the CCTV's in at least one class room, Emergency Area and in OPD and the Council should have the live streaming of CCTV's at its website. In view of above, an expert agency may be appointed to understand the Project requirements in detail for preparing the Request for Proposal (RFP) document and further implementation plan.

In view of above, the Executive Committee of the Council constituted an expert panel for the project viz., 'Live Streaming of both classroom teaching and the teaching hospital under Digital Mission Mode Project (DMMP) of MCI' with the following names:-

- 1. Dr. Ajay Kumar, Chairman, Administration & Grievance Committee

The Executive Committee of the Council considered the assessment reports (9th January, 2017 and 28th Feb. & 1st March, 2017) and decided to recommend to the Central Government for recognition/approval of Ashwini Rural Medical College, Hospital & Research Centre, Solapur, Maharashrra for the award of MBBS degree (100 seats) granted by Maharashtra University of Health Sciences, Nashik u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

- 8 (3) ...

8(3)(1)(d):

(d) <u>Colleges which are found to have employed teachers with faked / forged documents:</u>

If it is observed that any institute is found to have employed a teacher with faked / forged documents and have submitted the Declaration Form of such a teacher, such an institute will not be considered for renewal of permission / recognition for award of M.B.B.S. degree / processing the applications for postgraduate courses for two Academic Years – i.e. that Academic Year and the next Academic Year also......."

In view of above, the Committee decided that the Institute be directed not to admit fresh batch of students for the academic year 2017-18 and 2018-19.

The minutes of the above item were read out, approved and confirmed in the meeting itself.

21. <u>Amendment in existing UG and Postgraduate Regulations of the Council to make a provision of Uniform Entrance Examination for Undergraduate and Postgraduate level.</u>

Read: the matter with regard to amendment in existing UG and Postgraduate Regulations of the Council to make a provision of Uniform Entrance Examination for Undergraduate and Postgraduate level.

The Executive Committee of the Council observed that Section 4 dealing with under-age students was challenged by some students before Hon'ble A.P. High Court. Although W.P. have been dismissed by Hon'ble High Court, it has made the following observations:

"4. But hard cases cannot make bad law. Therefore, in view of the decision in Master Alli Sai Deepak (supra), these writ petitions are discussed. But before parting, we would like to record our concern that Medical Council of India (MCI) should take a call on such cases, as cases of persons whose age falls short by a few days, cannot really be considered as under-aged. The concept of considering a person as under-aged, may apply to persons who could not have completed SSLC at a particular time or who could not have completed intermediate at a particular time and it cannot be applied to cases where the candidates have broadly entered into the required age but had not completed the same due to the shortage of a few days. The MCI may have to look at the concern of such candidates and address itself to the problems. The miscellaneous petitions, if any, pending in these writ petitions shall stand closed. No costs.

With regard to upper age limit & number of attempts, as per the letter dated 26 February 2017 of the Oversight Committee as well as letter dated 2nd March 2017 of the MOHFW, it has been decided by the Ministry to delete the upper age limit as well the number of attempts at NEET UG, since the country needs Doctors and the limitation would be restrictive in nature.

After due deliberations, the Executive Committee of the Council directed the office to place the amendments as approved by Central Govt. before the General Body. Regarding under-age issue also, it was decided to place the matter before General Body for detailed disscussion.

The minutes of the above item were read out, approved and confirmed in the meeting itself.

22. Approval of the minutes of the Finance Committee meeting held on 07th March, 2017.

The Executive Committee of the Council considered the assessment report (13th January, 2017) alongwith letter dated 20/02/2017 received from Dr. N. Ramkrishna Reddy (Co-ordinator), Bangalore and a letter dated 20.02.2017 of the Dean, Institute of Medical Sciences & Research, Satara. The Committee noted the following from the Assessors letter:-

"..we the assessors visit the above institution on 20th Feb., 2017. The college authorities have expressed their inability to undergo MCI assessment on the said dates for reasons mentioned in their letter. Please find enclosed the letter and photos of the institution for your kind perusal".

The Executive Committee further noted the contents of the letter dated 20.02.2017 of the Dean, Institute of Medical Sciences & Research, Satara, which reads as under:-

Due to aforementioned facts, we request you, not to conduct the inspection of our institute. This is a temporary problem of our institute, which will be solved within two months and the hospital as well as college will restart functioning

smoothly. Please note that the above mentioned situation is temporary and of curable nature.

Once again, we request not to conduct the inspection of our institute and kindly co-operate."

- 1. SAF Part I is not filled by the Dean.
- 2. Deficiency of faculty is 12.68 % on day of assessment.
- 3. Dr. R.V. Ramlal who is in charge of Medical Superintendent has not submitted his D.F.
- 4. Paramedical & Non-teaching staff: Only 65 Paramedical & Non-teaching staff are available against requirement of 179.
- 5. There were only 5 Major & 8 Minor Operations for the whole hospital on day of assessment.
- 6. OPD: Registration Counters are manual. Plaster Cutting Room is not available.
- 7. Casualty: 19 beds are available against requirement of 20.
- 8. O.T.: Septic O.T. is not available.
- 9. Wards: Pantry is not available in any ward.
- 10. 4 Static X-ray machines are available against requirement of 5.
- 11. CT Scan: It is 4 slice against requirement of minimum 16 slice.
- 12. ETO Sterilizer is not available.
- 13. There is no kitchen in the hospital. Provision for special diet is not available.
- 14. Colour coded bins are not available for disposal of Bio-medical waste. Needle Destroyer in ICU was not working at time of assessment.
- 15. Central Research Laboratory is not available.
- 16. MRD: It is not computerized. ICD X classification of Diseases is not followed.
- 17. Examination Hall: There are 2 Examination Halls with total capacity of 344 against requirement of 2 of 250 (i.e. total capacity 500).
- 18. Lecture Theaters: One Lecture Theater out of 4 is flat type & another is partial Gallery type. Audiovisual aids are not available in 3 Lecture Theaters. Rostrum for teachers are not available.
- 19. Central Library: It is partially air-conditioned. Total area is 900 sq.m. against requirement of 1,600 sq.m. Temporary library in the hospital is not functional. Capacity of Students' Reading room (Outside) is 60 against requirement of 100. There are NIL foreign journals.
- 20. Students' Hostels: There is no Visitors' room in Boys' Hostel. There is no Internet in Study room & it is not air-conditioned. In Girls' Hostel, students of Dental & Pharmacy colleges are also staying. Hygiene is poor.
- 21. Residents' Hostel: Visitors' Room, A.C. Study Room with Computer & Internet, Recreation Room are not available.
- 22. Nurses' room: 120 Nurses are accommodated in 20 rooms which is not permissible.
- 23. Physiology Department: Instruments are not adequate in Mammalian Laboratory.
- 24. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by Kerala

University of Health Sciences, Thrissur in respect of students being trained at T.D. Medical College, Alappuzha (Allepy), Kerala and further decided that the institute be asked to submit the compliance of rectification of the above deficiencies within 01 month.

41. <u>Continuance of recognition of MBBS degree granted by Rajasthan University of Health Sciences in respect of students being trained at S.M.S. Medical College, Jaipur.</u>

Read: the matter with regard to continuance of recognition of MBBS degree granted by Rajasthan University of Health Sciences in respect of students being trained at S.M.S. Medical College, Jaipur.

The Executive Committee of the Council considered the compliance verification assessment report (28th February, 2017) along with previous assessment report (6th & 7th June, 2016) and decided to recommend that recognition of MBBS degree granted by Rajasthan University of Health Sciences in respect of students being trained at S.M.S.
