3. Starting of M.D.(Anaesthesiology) course at Govt. Medical College, Bhavnagar affiliated to Bhavnagar University u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at Govt. Medical College, Bhavnagar for starting of M.D.(Anaesthesiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government to issue Letter of Permission for starting of M.D.(Anaesthesiology) course at Govt. Medical College, Bhavnagar affiliated to Bhavnagar University u/s 10A of the IMC Act, 1956 prospectively restricting the number of admissions to 2(two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provisions of Section 11(2) of the IMC Act, 1956.

The attention of the authorities be drawn towards the implementation of the observations made by the Council Inspector in the inspection report.

The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provisions of Section 11(2) of the IMC Act, 1956.

Medical College, Rajkot affiliated to Saurashtra University u/s 10A of the IMC Act, 1956 prospectively restricting the number of admissions to 2(two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provisions of Section 11(2) of the IMC Act, 1956.

6. **Starting of M.S.(Ophthalmology) & D.O. courses at Dr.D.Y.Patil Pratishtan's Medical College for Women, Pune affiliated to Pune University u/s 10A of the I.M.C. Act, 1956 – compliance regarding.**

7. **Starting of M.D.(Radio-Therapy) course at Nizam's Institute of Medical Sciences, Hyderabad affiliated to Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) u/s 10A of the IMC Act, 1956.**

Read : the Council Inspector's report (June, 2002) on the physical and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for starting of M.D.(Radio-Therapy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (June, 2002) and decided to recommend to Central Government to issue Letter of Permission for starting of M.D.(Radio-Therapy) course at Nizam's Institute of Medical Sciences, Hyderabad affiliated to Nizam's Institute of Medical Sciences, Hyderabad (Deemed University) u/s 10A of the IMC Act, 1956 prospectively restricting the number of admission to 1(one) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provisions of Section 11(2) of the IMC Act, 1956.

8. Starting of M.D.(Radio-Therapy) & D.M.R.T. courses at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram affiliated to The Tamilnadu Dr.M.G.R. Medical University, Chennai u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (June, 2002) on the physical and other teaching facilities available at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram for starting of M.D.(Radio-Therapy) & D.M.R.T. courses u/s 10A of the IMC Act, 1956..

The Postgraduate Committee considered the Council Inspector's report (June, 2002) and decided to recommend to Central Government not to issue Letter of Intent for starting of M.D.(Radio-Therapy) & D.M.R.T. courses at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram affiliated to The Tamilnadu Dr.M.G.R. Medical University, Chennai u/s 10A of the IMC Act, 1956 because – i) the composition of units in the department of Radio-therapy in terms of bed-strength & teaching faculty is not as per MCI norms i.e. each unit having a minimum of 3 faculty members and a bed strength between 30-50, ii) Professor & HOD has not been promoted as per MCI norms i.e. with a teaching experience of minimum of 5 years as Asstt. Professor and 4 years as Assoc. Professor to be eligible as Professor.

9. Starting of M.D.(Pharmacology) course at J.L.N.Medical College, Swangi, Wardha affiliated to Nagpur University u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (October, 2002) on the physical and other teaching facilities available at J.L.N. Medical College, Swangi, Wardha for starting of M.D.(Pharmacology) courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend to Central Government to issue Letter of Permission for starting of M.D.(Pharmacology) course at J.L.N. Medical College, Swangi, Wardha affiliated to Nagpur University u/s 10A of the IMC Act, 1956 prospectively restricting the number of admissions to 2(two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provisions of Section 11(2) of the IMC Act, 1956.

10. Starting of M.D.(Microbiology) course at Kempegowda Institute of Medical Sciences, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at Kempegowda Institute of Medical Sciences, Bangalore for starting of M.D.(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government to issue Letter of Permission for starting of M.D.(Microbiology) course at Kempegowda Institute of Medical Sciences, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 prospectively restricting the number of admissions to 2(two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provisions of Section 11(2) of the IMC Act, 1956.

11. Increase of seats in M.D.(Obst. & Gynae.) course at Kempegowda Institute of Medical Sciences, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 – compliance regarding.

Read : the compliance togetherwith Council Inspector's report (June, 2002) on the physical and other teaching facilities available at Kempegowda Institute of Medical Sciences, Bangalore for increase of seats in M.D.(Obst. & Gynae.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (June, 2002) together with compliance and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Obst. & Gynae.) course at Kempegowda Institute of Medical Sciences, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore from 2 (two) to 4(four) per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

The attention of the authorities be drawn towards the observations made by the Council Inspector in the inspection report.

12. Increase of seats in M.S.(General Surgery) course at Andhra Medical College, Visakhapatnam affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at Andhra Medical College, Visakhapatnam for increase of seats in M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.S.(General Surgery) course at Andhra Medical College, Visakhapatnam affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because – i) available clinical material in terms of OPD patient strength & operative work is not adequate to permit increase of seats, ii) infrastructural facilities, in term of OPD space etc. are inadequate, iii) library facilities are not adequate and iv) other deficiencies pointed out in the inspection report.

13. Increase of seats in M.S.(General Surgery) course at Osmania Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (August, 2002) on the physical and other teaching facilities available at Osmania Medical College, Hyderabad for increase of seats in M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (August, 2002) and noting that out of the 8 units in the department of Surgery; 7 are complete in term of teaching faculty, decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.S. (General Surgery) course at Osmania Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada from 8 (eight) to 14(fourteen) per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

14. Increase of seats in M.D.(Paediatrics) course at Osmania Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (August, 2002) on the physical and other teaching facilities available at Osmania Medical College, Hyderabad for increase of seats in M.D.(Paediatrics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (August, 2002) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Paediatrics) course at Osmania Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada from 5 (five) to 6(six) per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

The Committee further decided to obtain an undertaking from the institution authorities to the effect that they would no longer be admitting DNB candidates in the department.

15. Increase of seats in M.S.(Orthopaedics) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (October, 2002) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad for increase of seats in M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.S.(Orthopaedics) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because – i) infrastructure & space for OPD are inadequate & there is not teaching area in OPD, ii) half of the beds in the department of Orthopaedics are in corridors and lobbies without any basic facilities & there is no teaching area in wards and iii) other deficiencies pointed out in the inspection report.

16. Increase of seats in M.D.(Anatomy) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad for increase of seats in M.D.(Anatomy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.D.(Anatomy) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because – i) infrastructure facilities in term of space for histology lab is inadequate, ii) the facilities available in the department of Anatomy in terms of preservation of cadavers, sectioning and storage are

inadequate, iii) essential instruments like body cutter machine are not available and iv) other deficiencies pointed out in the inspection report.

17. Increase of seats in M.D.(Pharmacology) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad for increase of seats in M.D.(Pharmacology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.D.(Pharmacology) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because – i) equipments/instruments are inadequate, ii) available teaching staff and staff in library are inadequate and iii) other deficiencies pointed out in the inspection report.

18. Increase of seats in M.D.(Dermatology) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (October, 2002) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad for increase of seats in M.D.(Dermatology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend to Central Government to issue Letter of Permission for increase of seats in M.D. (Dermatology) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada from 1 (one) to 2(two) per year prospectively u/s. 10A of the IMC Act, 1956 till the first batch admitted against the increased number appears for the final examination of the said course.

19. Increase of seats in M.D.(Anatomy) courses at Kurnool Medical College, Kurnool affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at Kurnool Medical College, Kurnool for increase of seats in M.D.(Anatomy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.D.(Anatomy) course at Kurnool Medical College, Kurnool affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because – i) there are only 2 eligible P.G. teachers with recognised postgraduate qualification & requisite experience in the department of Anatomy & the institution is already having annual intake of 2 students in consonance with the available teaching faculty and ii) other observations made by the Council Inspector.

20. Increase of seats in M.D.(Biochemistry) courses at Kurnool Medical College, Kurnool affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at Kurnool Medical College, Kurnool for increase of seats in M.D.(Biochemistry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2002) and decided to recommend to Central Government not to issue Letter of Intent for increase of seats in M.D.(Biochemistry) course at Kurnool Medical College, Kurnool affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because – i) promotion of HOD has not been made as per MCI norms i.e. minimum of 5 years as Asstt. Professor and 4 years as Assoc. Professor before being promoted to the post of Professor, ii) inadequate teaching faculty which is not sufficient even for the permitted intake capacity of the institution for the undergraduate admissions and iii) other observations made by the Council Inspector.

21. Rajasthan University – Approval of R.N.T. Medical College, Udaipur for the award of M.D.(Paediatrics) qualification and also recognition of D.C.H qualification – compliance regarding.

Read : the compliance and Council Inspector's report (April, 2002) on the standard of examination and other teaching facilities available at R.N.T. Medical College, Udaipur for approval of the college for the award of M.D.(Paediatrics) qualification and also recognition of D.C.H. qualification granted by Rajasthan University.

The Postgraduate Committee considered the Council Inspector's report (April, 2002) togetherwith compliance and decided to verify the compliance by way of an inspection.

22. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of Dr. B.R. Ambedkar Medical College, Bangalore for the award of M.S.(E.N.T.) qualification .

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at Dr. B.R. Ambedkar Medical College, Bangalore for purpose of approval of the college for the award of M.S.(E.N.T.) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend that Dr.B.R.Ambedkar Medical College, Bangalore be approved for the award of M.S.(E.N.T.) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admission to 1(one) student per year.

The Committee further decided that attention of the authorities of institution be drawn towards the observations of Council Inspector in the report.

23. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of Dr. B.R. Ambedkar Medical College, Bangalore for the award of M.S.(Ophthalmology) qualification .

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at Dr. B.R. Ambedkar Medical College, Bangalore for purpose of approval of the college for the award of M.S.(Ophthalmology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend that Dr.B.R.Ambedkar Medical College, Bangalore be approved for the award of M.S.(Ophthalmology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admission to 1(one) student per year.

24. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of M.S. Ramaiah Medical College, Bangalore for the award of M.S.(Orthopaedics) qualification.

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at M.S. Ramaiah Medical College, Bangalore for purpose of approval of the college for the award of M.S.(Orthopaedics) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee noted that M.S.Ramaiah Medical College, Bangalore had been permitted to start M.S.(Ortho.) course by the Central Govt. vide letter dated 8.10.98 with an annual intake of 1(one) student and subsequently the institution had been permitted vide Govt.'s letter dated 14.9.2001 to increase the annual intake from 1(one) to 3(three) and further that as per the initial advise, the institution had applied for recognition of the qualification at the time of first available examination of the said batch of student as per the provision of Section 11(2) of the IMC Act, 1956.

The Postgraduate Committee upon consideration of the Council Inspector's report (October, 2002) and noting the facilities available therein, decided to recommend that M.S.Ramaiah Medical College, Bangalore be approved for the award of M.S.(Orthopaedics) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admission to 1(one) student per year.

40. i) **Kakatiya University – Recognition of M.D.(Biochemistry) qualification in respect of students being trained at Kakatiya Medical College, Warangal.**
- ii) **Osmania University, Andhra Pradesh University of Health Sciences, Vijayawada and N.T.R. University of Health Sciences, Vijayawada – Approval of Kakatiya Medical College, Warangal for the award of M.D.(Biochemistry) qualification.**

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at Kakatiya Medical College, Warangal for purpose of i) recognition of M.D.(Biochemistry.) qualification earlier granted by Kakatiya University and also ii) approval of the college for the award of M.D.(Biochemistry) qualification earlier granted by Osmania University, Andhra Pradesh University of Health Sciences, Vijayawada and now by N.T.R. University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the Council Inspector's report (October, 2002) and decided to recommend that :-

- i) MD (Biochemistry) qualification earlier granted by Kakatiya University in respect of students trained at Kakatiya Medical College, Warangal be recognised and included in the first schedule to the IMC Act,1956.
- ii) Kakatiya Medical College, Warangal be approved for the award of MD (Biochemistry) qualification earlier granted by Osmania University, Andhra Pradesh University of Health Sciences, Vijayawada and now by N.T.R. University of Health Sciences, Vijayawada restricting the number of admission to 1(one) student per year.

41. Calicut University – Recognition of D.M.(Nephrology) qualification in respect of students being trained at Calicut Medical College, Calicut - Compliance regarding.

Read : the compliance togetherwith Council Inspector's report (April, 2002) on the standard of examination and other teaching facilities available at Calicut Medical College, Calicut for purpose of recognition of D.M.(Nephrology) qualification granted by Calicut University.

The Postgraduate Committee considered the compliance togetherwith Council Inspector's report (April, 2002) and decided to recommend that DM (Nephrology) qualification granted by Calicut University in respect of students being trained at Calicut Medical College, Calicut be recognised and included in the first schedule to the I.M.C. Act, 1956 restricting the number of admission to 1(one) student per year.

42. Kerala University & Calicut University- Recognition of M.D.(Psychiatry) qualification in respect of students being trained at Calicut Medical College, Calicut.

Read : the Council Inspector's report (June, 2002) on the standard of examination and other teaching facilities available at Calicut Medical College, Calicut for purpose of recognition of M.D.(Psychiatry) qualification earlier granted by Kerala University & now by Calicut University.

The Postgraduate Committee considered the Council Inspector's report (June, 2002) and decided to recommend that MD (Psychiatry) qualification earlier granted by Kerala University & now by Calicut University in respect of students being trained at Calicut Medical College, Calicut be recognised and included in the first schedule to the I.M.C. Act, 1956 restricting the number of admission to 2(two) students per year.

The Committee further decided to obtain an undertaking from the institution to the effect that DNB candidates would not be admitted in future.

43. Parvara Medical Trust Vs.State of Maharashtra and Ors., WP No.376/2001 in the High Court of Bombay, Bench at Aurangabad – consideration of deferred item regarding.

Read : the recommendations of the Sub-Committee togetherwith Central Govt. letter dated 4.12.2001 and judgement of Hon'ble High Court of Judicature at Bombay regarding comments of MCI.

The Postgraduate Committee considered the matter and decided to advise the earlier constituted Sub-Committee to decide afresh in light of the recent eleven bench judgment delivered by the Hon'ble Supreme Court.

44. Matter of finalisation of Draft Syllabi for various postgraduate courses and the suggestion for deletion of M.D.(Medical Genetics) from the Schedule to Postgraduate Medical Education regulation – consideration of deferred items of last meeting.

Read : the deferred items No.199 (deletion of MD-Medical Genetics course) tagged with deferred item No.294 (finalisation of draft syllabi for various postgraduate courses) of the P.G. Committee meeting held in September, 2002.

The Postgraduate Committee considered the matter of finalisation of Draft Syllabi for various postgraduate courses and the suggestion for deletion of MD (Medical Genetics) from the Schedule to Postgraduate Medical Education Regulation and decided to constitute a Sub-Committee with the following members to work out all the modalities: -

- (1) Dr. Ved Prakash Mishra, Chairman
- (2) Dr. L.S. Chawla
- (3) Dr. Inderajit Ray

The Committee further decided to request the Sub-Committee to co-opt some experts if so required and complete the task within two months and submit the report to the Committee for further consideration of the matter.

45. Sher-I-Kashmir Institute of Medical Sciences,(Deemed University), Srinagar – Recognition of M.D.(Maternity & Child Health) degree at Sher-I-Kashmir Institute of Medical Sciences, Srinagar – Consideration of letter from Dean regarding.

Read : the letter dated 27.5.2002 from the Dean, Medical Faculty, Sher-I-Kashmir Institute of Medical Sciences, Srinagar with regard to recognition of M.D.(Maternity & Child Health) qualification at Sher-I-Kashmir Institute of Medical Sciences, Srinagar conducted in the institution from 1992 to 2000.

The Postgraduate Committee considered the letter dated 27.5.2002 from the Dean, Medical Faculty, Sher-I-Kashmir Institute of Medical Sciences, Srinagar and noted that the course of M.D.(Maternity & Child Health) had been started with the permission of Medical Council of India and further that no students are being admitted in the course since year 2000 and further that no student would ever be available for examination decided to recommend that M.D.(Maternity & Child Health) qualification granted by Sher-I-Kashmir Institute of Medical Sciences, Srinagar (Deemed University) between year 1992 to 2000 in the respect of students trained at Sher-I-Kashmir Institute of Medical Sciences, Srinagar be recognised and included in the 1st Schedule to the IMC Act, 1956.

The Committee further decided to direct the authorities of the institution not to restart the course which otherwise also is not prescribed in the Council regulation on Postgraduate Medical Education 2000.

46. Non-teaching Hospital – Continuance of recognition of Sundram Medical Foundation, Chennai for housemanship consideration of compliance regarding.

Read : the compliance togetherwith Council Inspector's report (November, 2001) on the physical facilities available at Sundram Medical Foundation, Chennai for purpose of continuance of recognition of the hospital for housemanship.

The Postgraduate Committee considered the Council Inspector's report (November, 2001) togetherwith compliance and decided that recognition of Sundram Medical Foundation, Chennai be continued for housemanship in the following subjects with the number of intake mentioned against each:-

Paediatrics	–	1(one)
Obst. & Gynae.	-	1(one)

47. Consideration of matter of recognition of D.G.O. qualification granted by University of Delhi in respect of students being trained at Maulana Azad Medical College, New Delhi- regarding.

Read : the matter with regard to recognition of D.G.O. qualification granted by University of Delhi in respect of students being trained at Maulana Azad Medical College, New Delhi in light of Court order dated 13.9.2002 passed in C.W.P.(C.No.4446/2001).

The Postgraduate Committee considered the matter with regard to recognition of D.G.O. qualification granted by University of Delhi in respect students being trained at Maulana Azad Medical College, New Delhi and noted that i) the Hon'ble High Court of Delhi vide order dated 13.9.2002 had directed the MCI to take the decision on the question of recognition of DGO qualification within 4 weeks, ii) some candidates are likely to be available to appear in DGO examination to be held in April/May, 2003 and further that the inspection for matter of recognition of any qualification can be arranged only during the time of practical examination.

The Committee, in view of the above, decided that Hon'ble Court be informed/apprised accordingly.

48. Inclusion of superspeciality course of D.M. in Reproductive Medicine in the regulations of the Council on Postgraduate Medical Education- letter regarding.

Read : the letter dated 27.9.2002 from the Principal, Christian Medical College, Vellore with regard to starting of new course related to the subject of reproduction in Obst. & Gynae. by nomenclature of D.M.(Reproductive Medicine).

The Postgraduate Committee considered the letter dated 27.9.2002 from the Principal, Christian Medical College, Vellore and decided to obtain from the authorities i) the related background documents/papers and also the rationale of starting such a course and ii) the facilities available for starting of such courses.

49. Survey for the evaluation of the state of Ophthalmic Education in the Country – regarding.

Read : the letter dated 5.8.2002 from Dr.Atul Kumar, All India Ophthalmological Society, Delhi with regard to survey for the evaluation of the state of Ophthalmic Education in the Country.

The Postgraduate Committee considered the letter dt. 5.8.2002 from Dr. Atul Kumar, Secretary, All India Ophthalmological Society, Delhi with regard to survey for the evaluation of the state of Ophthalmic Education in the Country and decided to tag this item with the item no.44 (finalisation of draft syllabus) for consideration by the Sub-Committee constituted therein. The Committee further decided that Dr. Raj Vardhan Azad, Prof & HOD, Deptt. of Ophthalmology, AIIMS, New Delhi, may be associated in this matter.

50. Ch. Charan Singh University – Review of intake capacity in M.D.(Paediatrics) course in respect of students being trained at L.L.R.M. Medical College, Meerut.

Read : the matter (in light of the decision of the General Body taken at its meeting held on 3rd & 4th June 2002 for recognition of D.C.H. course at L.L.R.M. Medical College, Meerut.) with regard to review of intake capacity in M.D.(Paediatrics) course in respect of students being trained at L.L.R.M. Medical College, Meerut.

The Committee considered the matter and decided to arrange for inspection of the department to fix the intake capacity in M.D.(Paediatrics) course.

51. Starting of M.D.(Anaesthesiology) & D.A. courses at J.L.N.Medical College, Swangi, Wardha affiliated to Nagpur University u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at J.L.N. Medical College, Swangi, Wardha for starting of M.D.(Aneesthesiology) & D.A. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September,2002) and decided to recommend to Central Govt. not to issue Letter of Intent for starting of M.D.(Anaesthesiology) & D.A. courses at JLN Medical College, Swangi, Wardha affiliated to Nagpur University u/s 10A of the IMC Act,1956 – i) because the Prof. & Head does not possess requisite recognised postgraduate qualification, ii) the promotion of the other Professor has not be effected as per MCI norms i.e. minimum of 5 years as Asstt. Professor & 4 years as Assoc. Professor to become eligible for the post of Professor and iii) other deficiencies as pointed out in the inspection report.

52. Starting of M.D.(Obst. & Gynae.) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 – further information regarding.

Read : the compliance togetherwith Council Inspector's report (June, 2002) (togetherwith further information) on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad for starting of M.D.(Obst. & Gynae.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (June, 2002) and decided to recommend to Central Govt. not to issue Letter of Intent for starting of M.D.(Obst. & Gynae.) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act,1956 because - i) the Dean of the institution is over the age of supernuation and hostel facilities are not available for the students in the institution and ii) other deficiencies as pointed out in the inspection report.

53. Increase of seats in M.S.(General Surgery) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (August, 2002) on the physical and other teaching facilities available at Gandhi Medical College, Hyderabad for increase of seats in M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (August,2002) and decided to recommend to Central Govt. to issue Letter of Permission for increase of seats in M.S. (General Surgery) course at Gandhi Medical College, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada from 5 (five) to 8 (eight) per year prospectively u/s 10A of the IMC Act,1956 till the first batch admitted against the increased number appears for the final examination of the said course.

The Committee further decided that an undertaking from the institution to the effect that they would no longer be admitting DNB candidates be obtained.

54. Increase of seats in M.S.(General Surgery) course at Father Muller's Medical College, Mangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 – compliance regarding.

Read : the compliance togetherwith Council Inspector's report (October, 2001) on the physical and other teaching facilities available at Father Muller's Medical College, Mangalore for increase of seats in M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October,2001) and decided to recommend to Central Govt. to issue Letter of Permission for increase of seats in M.S.(General Surgery) course at Father Muller's Medical College, Managalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore from 2 (two) to 4 (Four) per year prospectively u/s 10A of the IMC Act,1956 till the first batch admitted against the increased number appears for the final examination of the said course.

The attention of the authorities be drawn towards the implementation of the observations made by the Council Inspector in the inspection report.

55. Increase of seats in M.S.(Orthopaedics) course at Sri Devraj Urs Medical College, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (May, 2002) on the physical and other teaching facilities available at Sri Devraj Urs Medical College, Kolar for increase of seats in M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May,2002) and decided to recommend to Central Govt. to issue Letter of Permission for increase of seats in M.S.(Orthopaedics) course at Sri Devraj Urs Medical College, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore from 1 (one) to 3(three) per year prospectively u/s 10A of the IMC Act,1956 till the first batch admitted against the increased number appears for the final examination of the said course.

The attention of the authorities be drawn towards the implementation of the observations made by the Council Inspector in the inspection report.

56. Starting of M.S.(Ophthalmology) & D.O. courses at J.L.N.Medical College, Swangi, Wardha affiliated to Nagpur University u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (September, 2002) on the physical and other teaching facilities available at J.L.N. Medical College, Swangi, Wardha for starting of M.S.(Ophthalmology) & D.O. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September,2002) and decided to recommend to Central Govt. not to issue Letter of Intent for starting of M.S.(Ophthalmology) & D.O. courses at JLN Medical College, Swangi, Wardha affiliated to Nagpur University u/s 10A of the IMC Act, 1956 because – i) the Professor & HOD neither possesses requisite recognised postgraduate qualification nor his promotion to the post of Professor has been as per MCI norms, ii) infrastructure facilities in term of space in OPD are inadequate, iii) library facilities are inadequate and iv) other deficiencies as pointed out in the inspection report.

57. Rajasthan University – Recognition of M.D.(Radio-therapy) qualification in respect of students being trained at S.P. Medical College, Bikaner.

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at S.P. Medical College, Bikaner for purpose of recognition of M.D.(Radio-therapy) qualification granted by Rajasthan University.

The Postgraduate Committee considered the Council Inspector's report (October,2002) and decided to recommend that M.D.(Radio-therapy) qualification granted by Rajasthan University in respect of students being trained at S.P. Medical College, Bikaner be recognised and included in the 1st Schedule to the IMC Act,1956 restricting the number of admission to 1 (one) student per year.

58. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of Fr. Muller's Medical College, Mangalore for the award of D.P.M. qualification –compliance regarding.

Read : the compliance togetherwith Council Inspector's report (October, 2001) on the standard of examination and other teaching facilities available at Fr. Muller's Medical College, Mangalore for approval of the college for the award of D.P.M. qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (October,2001) togetherwith the compliance and decided to recommend that Fr. Muller's Medical College, Mangalore be approved for the award of DPM qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admissions to 2 (two) students per year.

59. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of J.S.S. Medical College, Mysore for the award of D.Ortho. qualification in respect of increased intake capacity.

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at J.S.S. Medical College, Mysore for purpose of approval of the college for the award of D.Ortho. qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of increased intake capacity.

The Postgraduate Committee considered the Council Inspector's report (October,2002) and noted that institution already stand approved for the award of D.Ortho. qualification with the annual intake of 6(six) students and the matter under consideration is for approval of institution for increased intake permitted by Govt. vide letter dated 28.2.2000 and decided to reiterate its earlier decision to approve J.S.S. Medical College, Mysore for the award of D.Ortho. qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore. However the authorities of the institution are directed that in consonance with the Council's regulation on Postgraduate Medical Education 2000, the annual intake capacity in D.Ortho. be restricted to 6(six) students per year for which the institution already stands approved.

60. Annamalai University – Recognition D.O. qualification in respect of students being trained at Rajah Muthiah Medical College, Annamalainagar.

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at Rajah Muthiah Medical College, Annamalainagar for purpose of recognition of D.O. qualification granted by Annamalai University.

The Postgraduate Committee considered the Council Inspector's report (October,2002) and decided to recommend that D.O. qualification granted by Annamalai University in respect of students being trained at Rajah Muthiah Medical College, Annamalainagar be recognised and included in the 1st Schedule to the IMC Act,1956. However the authorities of the institution are directed to prospectively restrict the annual intake in D.O. course to 1(one) student in consonance with Council's regulations on Postgraduate Medical Education 2000.

61. Annamalai University – Recognition D.C.H. qualification in respect of students being trained at Rajah Muthiah Medical College, Annamalainagar.

Read : the Council Inspector's report (September, 2002) on the standard of examination and other teaching facilities available at Rajah Muthiah Medical College, Annamalainagar for purpose of recognition of D.C.H. qualification granted by Annamalai University.

The Postgraduate Committee considered the Council Inspector's report (September,2002) and decided to recommend that D.C.H. qualification granted by Annamalai University in respect of students being trained at Rajah Muthiah Medical College, Annamalainagar be recognised and included in the 1st schedule to the IMC Act,1956. However the authorities of the institution are directed to prospectively restrict the annual intake in D.C.H. course to 3(three) students in consonance with Council's regulations on Postgraduate Medical Education 2000.

62. i) Bharathidasan University – Recognition of M.D.(Obst. & Gynae.) and D.G.O. qualifications in respect of students being trained at Thanjavur Medical College, Thanjavur.

ii) Madras University and The Tamilnadu Dr. M.G.R. Medical University, Chennai – Approval of Thanjavur Medical College, Thanjavur for the award of M.D.(Obst. & Gynae.) and D.G.O. qualifications.

Read : the Council Inspector's report (October, 2002) on the standard of examination and other teaching facilities available at Thanjavur Medical College, Thanjavur for purpose of i) recognition of M.D.(Obst. & Gynae.) & D.G.O. qualifications earlier granted by Bharathidasan University and also ii) approval of the college for the award of M.D.(Obst. & Gynae.) & D.G.O. qualifications earlier granted by Madras University and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (October,2002) and noted that composition of units in the department of Obst. & Gynae., in terms of bed strength, is not as per MCI norms i.e. a bed strength between 30-50 per unit and therefore decided to advise the institution authorities to re-organise the units as per MCI norms.

The Committee further decided to defer the consideration of the matter till the information is received.

63. i) Punjabi University -Recognition of M.D.(Pharmacology) qualification in respect of students being trained at Govt. Medical College, Patiala.

ii) Baba Farid University of Health Sciences, Faridkot- Approval of Govt. Medical College, Patiala for the award of M.D.(Pharmacology) qualification.

Read : the Council Inspector's report (September, 2002) on the standard of examination and other teaching facilities available at Govt. Medical College, Patiala for purpose of i) recognition of M.D.(Pharmacology) qualification granted by Punjabi University and ii) approval of Govt. Medical College, Patiala for the award of M.D.(Pharmacology) qualification granted by Baba Farid University of Health Sciences, Faridkot.

The Postgraduate Committee considered the Council Inspector's report (September,2002) and decided to recommend that –

- i) M.D.(Pharmacology) qualification earlier granted by Punjabi University in respect of students trained at Govt. Medical College, Patiala be recognised and included in the first schedule to the IMC Act,1956.
- ii) Govt. Medical College, Patiala be approved for the award of M.D. (Pharmacology) qualification granted by Baba Farid University of Health Sciences, Faridkot restricting the number of admissions to 4 (four) students per year.

64. University of Bombay/Mumbai – Approval of Tata Memorial Hospital, Mumbai for the award of M.S.(General Surgery) qualification.

Read : the matter togetherwith institution letter dated 1.11.2002 with regard to approval of Tata Memorial Hospital, Mumbai for the award of M.S.(General Surgery) course conducted in the institution from 1967 – 99.

The Postgraduate Committee considered the matter togetherwith institution letter dated 1.11.2002 and noted that the Tata Memorial Hospital, Mumbai had been conducting the course of M.S.(General Surgery) from 1967 and the same was discontinued in 1999. The matter of recognition of the qualification has never been taken for consideration and now as per the institution letter dated 1.11.2002 no candidate would ever be available to appear in examination during which time the inspection for consideration of recognition of qualification could have been arranged. In view of this and considering the eminent status of the institution, the Committee decided to recommend that Tata Memorial Hospital, Mumbai be approved for the award of M.S. (General Surgery) qualification granted by Bombay/Mumbai University when granted from 1969-2001.

The Committee further decided to direct the institution authorities not to restart the course of M.S.(General Surgery) in future.

65. Starting of M.D.(Psychiatry) course at Institute of Human Behaviour & Allied Sciences, Delhi under Delhi University u/s 10A of the Indian Medical Council Act, 1956 in compliance of the orders of the Hon'ble Supreme Court dated 12.5.2001 – consideration of compliance verification and legal opinion regarding.

Read : the compliance verification report (June, 2002) and legal opinion alongwith compliance and Council Inspector's report (June, 2001) on the physical and other teaching facilities available at Institute of Human Behaviour & Allied Sciences, Delhi for starting of M.D.(Psychiatry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (June,2002) togetherwith compliance and Council Inspector's report (June,2001) and noted the legal opinion from the Council's Advocate with regard to Govt.'s letter dated 13.2.2002 conveying therein guidelines for starting of P.G. courses for non-teaching institutions in Govt. sector; and the linkage of the institution with Maulana Azad Medical College, New Delhi and decided to recommend to Central Govt. to issue Letter of Permission for starting of M.D.(Psychiatry) course at Institute of Human Behaviour & Allied Sciences, Delhi affiliated to Delhi University u/s 10A of the IMC Act,1956 prospectively restricting the number of admissions to 2 (two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provisions of Section 11(2) of the IMC Act,1956.

66. Starting of M.D.(General Medicine) course at Govt. Medical College, Bhavnagar affiliated to Bhavnagar University u/s 10A of the IMC Act, 1956.

Read : the Council Inspector's report (July, 2002) on the physical and other teaching facilities available at Govt. Medical College, Bhavnagar for starting of M.D.(General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (July,2002) and decided to recommend to Central Govt. to issue Letter of Permission for starting of MD(General Medicine) course at Govt.
