1. Minutes of the last meeting of the Postgraduate Committee – confirmation of.

Minutes of the meeting of the Postgraduate Committee held on 22.5.2004 were confirmed.

2. Minutes of the last meeting of the Postgraduate Committee – action taken thereon.

The Postgraduate Committee noted & approved the action taken on the various items included in the minutes of the meeting of the Postgraduate Committee held on 22.5.2004 with the following changes:-

Item No.14 Starting of M.D.(Obst. & Gynae.) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 – compliance verification regarding.

The Postgraduate Committee considered the compliance verification report (March, 2004) togetherwith compliance and Council Inspector's report (June, 2002) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(Obst. & Gynae.) course at Deccan College of Medical Sciences, Hyderabad affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-06 restricting the number of admissions to 3 (three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11 (2) of the Act, 1956.

Item No.57 Starting of M.D.(Paediatrics) course at Govt. Medical College, Rajkot affiliated to Saurashtra University u/s 10A of the IMC Act, 1956 – Consideration of compliance verification regarding.

The Postgraduate Committee considered the compliance verification report (November, 2002) togetherwith compliance and Council Inspector's report (April, 2001) and decided to reiterate its earlier decision taken at its meeting held on 27.2.2003 recommending to the Central Govt. not to issue Letter of Intent for starting of M.D.(Paediatrics) course at

Govt. Medical College, Rajkot affiliated to Saurashtra University u/s 10A of the IMC Act, 1956 because the compliance is unsatisfactory.

Item No.92 Starting of M.D.(Physiology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Physiology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Promotion of HOD is not as per MCI norms.
- (ii) Second Professor is possessing unrecognised postgraduate qualification.
- (iii) Library facilities are inadequate.
- (iv) Staff is deficient by Two Lecturer and One Tutor.
- (v) Lab space is inadequate.
- (vi) Instrumentation is inadequate.
- (vii) Other deficiencies/observations as pointed out in the inspection report.

Read: the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Academy of Medical Sciences, Pariyaram for consideration of starting of M.D. (Paediatrics) & D.C.H. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Paediatrics) & DCH courses at Academy of Medical Sciences, Pariyaram affiliated to Kannur University u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Clinical material is inadequate.
- (ii) Library facilities are poor.
- (iii) Hostel facilities are inadequate.
- (iv) Unit III is incomplete in terms of beds and teaching faculty.
- (v) Promotion of HOD is not as per MCI norms.
- (vi) Other deficiencies/observations as pointed out in the inspection report.

5. Starting of M.D. (OBG) & DGO courses at Academy of Medical Sciences, Pariyaram affiliated to Kannur University u/s 10A of the IMC Act, 1956.

Read: the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Academy of Medical Sciences, Pariyaram for consideration of starting of M.D. (OBG) & DGO courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Obst. & Gynae.) & DGO courses at Academy of Medical Sciences, Pariyaram affiliated to Kannur University u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Clinical material is inadequate.
- (ii) Library facilities are inadequate.
- (iii) Teaching complement is incomplete in Unit I.
- (iv) DNB candidates are being registered in the speciality which is not permissible in the institution where MD/MS courses are being undertaken because this involves sharing the same infrastructural facilities.
- (v) Other deficiencies/observations as pointed out in the inspection report.

6. Starting of M.D. (Physiology) course at Rajiv Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Physiology) course at Rajiv Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act,1956 because of the following:-

- (ii) Staff is insufficient even for UG intake by one Asstt. Prof.
- (iii) Other than Prof. remaining staff is non-medical which is not as per MCI norms and no teacher has been recognised as PG teacher by the affiliating university.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

7. Starting of M.D.(Microbiology) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Patology) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956 because of the following:-

- (ii) Teaching staff is deficient even for UG intake by one Lecturer.
- (iii) Clinical material is inadequate.

- (iv) Investigative facilities are inadequate.

9. Starting of M.D.(Forensic Medicine) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD (Forensic Medicine) course at Rajiv Gandhi Medical College, Thane affiliated to University of Mumbai u/s 10A of the IMC Act, 1956 because of the following:-

- (i) There is no regular Dean.
- (ii) Prof. & HOD is holding additional charge of Dean.
- (iii) Prof. & HOD & Assoc. Prof. do not possess requisite recognised postgraduate qualification & the promotions of HOD & Assoc. Prof. are also not as per MCI norms.
- (iv) Staff is deficient even for UG intake by one lecturer.
- (v) Number of journals are inadequate.
- (vi) No teacher is recognised as PG teacher by the affiliating university.
- (vii) Other deficiencies /observations as pointed out in the inspection report.

10. Starting of M.D. (Paediatrics) course at Annasaheb Chaudaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956.

Read: the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Annasaheb Chaudaman Patil Memorial Medical College, Dhule for consideration of starting of M.D.(Paediatrics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Paediatrics) course at Annasaheb Chaudaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Teaching complement is incomplete in Unit I as there is no Assoc. Prof.
- (ii) Clinical Material is inadequate.
- (iii) NICU-PICU is not well equipped.
- (iv) Central library facilities are inadequate.
- (v) Blood Bank is in Dental College
- (vi) Other deficiencies/observations as pointed out in the inspection report.

11. Starting of M.S.(Orthopaedics) course at Annasaheb Chaudaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956.

Read: the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Annasaheb Chaudaman Patil Memorial Medical College, Dhule for consideration of starting of M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MS(Orthopaedics) course at Annasaheb Chaudaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Surgical workload is inadequate.
- (ii) Clinical material is grossly inadequate.
- (iii) No staff is recognised as PG teacher by the affiliating university.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

12. **Starting of M.Ch. (Cardio Thoracic & Vascular Surgery) at J.N. Medical College, Belgaum affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at J.N. Medical College, Belgaum for consideration of starting of M.Ch. (Cardio Thoracic & Vascular Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch. (Cardio-thoracic & Vascular Surgery) at J.N. Medical College, Belgaum affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 because of the following:-

- (i) There is 131 beds against Unit I which is not as per MCI norms.
- (ii) Prof. & HOD does not possess requisite recognised postgraduate qualification.
- (iii) Clinical material is inadequate.
- (iv) 2nd Prof. also does not possess requisite postgraduate qualification in the speciality.
- (v) Other deficiencies/observations as pointed out in the inspection report.

13. **Starting of M.Ch.(Surgical Gastroentology) course at Bangalore Medical College, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Bangalore Medical College, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore for consideration of starting of M.Ch.(Surgical Gastroentology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch.(Surgical Gastroentology) course at Bangalore Medical College, Bangalore affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Prof. & HOD does not possess super-speciality qualification.
- (ii) 2nd Prof. is Honorary and also does not possess requisite postgraduate qualification in the speciality.
- (iii) Teaching complement is incomplete.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

14. **Starting of M.D.(T.B & Respiratory Diseases) course at Sri Devraj Urs Medical College,Tamaka, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Sri Devraj Urs Medical College, Tamaka, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore for consideration of starting of M.D.(T.B. & Respiratory Diseases) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(TB & Respiratory Diseases) course at Sri Devraj Urs Medical College, Tamaka, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 because of the following :-

- (i) Prof. & HOD does not possess requisite recognised qualification.
- (ii) No Assoc. Prof. in the department.
- (iii) Teaching complement is incomplete.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

15. **Increase of seats in D.P.M. course at National Institute of Mental Health & Neuro Sciences, Bangalore affiliated to National Institute of Mental Health & Neuro Sciences (Deemed University), Bangalore u/s 10A of the IMC Act, 1956 – consideration of compliance regarding.**

Read: the compliance togetherwith the Council Inspector's report (March, 2004) on the physical and other teaching facilities available at National Institute of Mental Health & Neuro Sciences, Bangalore for consideration of increase of seats in D.P.M. course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance togetherwith the Council Inspector's report (March, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in DPM course at National Institute of Mental Health & Neuro Sciences, Bangalore (Deemed University) prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 6 (six) to 7(seven) per year as there is only 1 PG teacher in each of seven units till the first batch admitted against the increased number appears for the final examination of the said course.

16. **Starting of M.D.(Microbiology) course at Sri Venkateswara Institute of Medical Sciences, Tirupati affiliated to Sri Venkateswara Institute of Medical Sciences, Tirupati (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Sri Venkateswara Institute of Medical Sciences, Tirupati for consideration of starting of M.D.(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and noted that on the day of inspection only two teachers were identified and hence decided to carry out re-inspection especially with regard to faculty verification.

17. **Increase of seats in M.S.(General Surgery) course at Kurnool Medical College, Kurnool affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 – consideration of compliance verification regarding.**

Read: the compliance verification inspection report (May, 2004) together with compliance and Council Inspector's report (August, 2003) on the physical and other teaching facilities available at Kurnool Medical College, Kurnool for consideration of increase of seats in M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification inspection report (May, 2004) together with compliance and Council Inspector's report (August, 2003) and decided to reiterate its earlier decision taken at its meeting held on 9.10.2003 recommending to Central Govt. not to issue Letter of Intent for increase of seats in MS (Gen.Surgery) course at Kurnool Medical College, Kurnool affiliated to NTR University of Health Sciences, Vijayawada u/s10A of the IMC Act, 1956 as the compliance received is unsatisfactory.

18. **Starting of Diploma in Medical Radio Diagnosis (D.M.R.D.) course at M.G.M. Medical College, Navi Mumbai affiliated to University of Mumbai u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at M.G.M. Medical College, Navi Mumbai for consideration of starting of Diploma in Medical Radio Diagnosis (D.M.R.D.) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided to recommend to the Central Govt. to issue Letter of Intent for starting of Diploma in Medical Radio-Diagnosis (DMRD) course at M.G.M. Medical College, Navi Mumbai affiliated to University of Mumbai u/s 10A of the IMC Act, 1956 restricting the number of admission to 1 (one) student per year with attention to observation that there is no MRI machine available which need to be installed.

19. **Increase of seats in M.S.(Orthopaedics) course at Christian Medical College, Vellore affiliated to The Tamilnadu Dr.MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Christian Medical College, Vellore for consideration of increase of seats in M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to advise the institution authorities to re-organise the Unit IV in terms of bed strength as per MCI norms.

The Committee further decided to defer the consideration of the matter till the information is received.

20. **Starting of M.D. (Radio-Therapy) & D.M.R.T. courses at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram affiliated to The Tamilnadu Dr.MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 – consideration of compliance regarding.**

Read: the compliance togetherwith the Council Inspector's report (June, 2002) on the physical and other teaching facilities available at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram for starting of M.D.(Radio-Therapy) & D.M.R.T. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance togetherwith the Council Inspector's report (June, 2002) and decided to reiterate its earlier decision taken at its meeting held on 2.9.2003 recommending to Central Govt. not to issue Letter of Intent for starting of MD(Radio-Therapy) & DMRT courses at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram as the promotion of Prof. & HOD and 2nd Prof. are not as per MCI norms.

The Committee further decided to recommend that in view of the above; the Govt. may consider disapproving the proposal for starting of M.D.(Radio-Therapy) & DMRT courses. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulations on Postgraduate Medical Education,2000.

21. **Increase of seats in M.D.(Radiotherapy) course at Cancer Institute, Adyar, Chennai affiliated to The Tamilnadu Dr.MGR Medical University, Tamilnadu u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Cancer Institute, Adyar, Chennai for consideration of increase of seats in M.D.(Radiotherapy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) and decided to advise the authorities of the college to re-organise the units in terms of bed strength as per MCI norms.

The Committee further decided to defer the consideration of the matter till the information is received with regard to bed strength.

22. **Increase of seats in DM(Neurology) course at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow affiliated to Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2004) on the physical and other teaching facilities available at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow for consideration of increase of seats in DM(Neurology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided to recommend to the Central Government not to issue Letter of Intent for increase of seats in DM (Neurology) course at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow affiliated to Sanjay Gandhi Postgraduate Instt. of Medical Sciences, Lucknow (Deemed University) u/s 10A of the IMC Act, 1956 as the teaching complement is incomplete in Unit-II.

23. **Postgraduate Medical Education reforms – consideration of representations & minutes of sub-committee regarding.**

Read: the minutes of the Sub-Committee with regard to certain essential observations for consideration to the "Postgraduate Medical Education Committee."

The Postgraduate Committee approved the reports of the Sub-Committee and decided to place it before the General Body of the Council for its approval.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2003) and decided to recommend that the recognition of N.F. Railway Central Hospital, Maligaon, Guwahati be approved for housemanship in ENT with 2 (two) house posts.

The Postgraduate Committee considered the letter dated 28.5.2004 from the institution authorities for renewal of permission for starting of PG courses in MD(Gen. Medicine), MS (Ophthalmology) and MD (TB & Resp. Diseases) at Pt. Deen Dayal Upadhyay Medical College, Rajkot under section 10A of IMC Act, 1956 and noted that:-

- (i) The permission for starting of following postgraduate courses at Pt. Deen Dayal Upadhyay Medical College, Rajkot as recommended by the Postgraduate Committee were granted by the Govt. of India with intake capacity mentioned against each course till the first batch admitted appears in the final examination of the said course. The Postgraduate Committee considered the Council Inspector's report (April, 2004) and decided not to approve Lady Hardinge Medical College, New Delhi for the award of DMRD qualification granted by University of Delhi because the teaching faculty is insufficient even for undergraduate intake.

The Committee also decided to direct the institution authorities to stop the postgraduate admissions with immediate effect for M.D (Radio-diagnosis) course also.

The Postgraduate Committee considered the Council Inspector's report (June, 2004) and decided to recommend to the Central Govt. to issue letter of Permission for starting of MD (Psychiatry) & DPM courses at Padmashree Dr. D.Y. Patil Medical College, Pimpri, Pune affiliated to Dr.D.Y. Patil Vidyapeeth (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admission to 1(one) student per year till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examinations as per the provision of Section 11(2) of the Act, 1956.

An undertaking may be procured from the college authorities for stopping admission to DNB courses.

The Postgraduate Committee considered the Council Inspector's report (June,2004) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD(Biochemistry) course at Gandhi Medical College, Hyderabad affiliated to NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions to 2(two) to 4 (four) students per year till the first batch admitted against the increased number appears for the final examination of the said course.

47. **Calicut University – Recognition of MD(Radio-Diagnosis) qualification in respect of students being trained at Calicut Medical College, Calicut.**

Read: the Council Inspector's report (June,2004) on the standard of examination and other teaching facilities available at Calicut Medical College, Calicut for purposes of recognition of MD (Radio-Diagnosis) qualification granted by Calicut University.

The Postgraduate Committee considered the Council Inspector's report (June,2004) and decided not to recommend recognition of MD (Radio-Diagnosis) qualification granted by Calicut University in respect of students being trained at Calicut Medical College, Calicut because –

- i) Promotion of HOD & Assoc. Prof. is not as per MCI norms.
- ii) Asstt. Prof. does not possess requisite recognised postgraduate qualification.
- iii) Two lecturers also do not possess requisite recognised PG qualification.
- iv) Staff is insufficient even for existing UG intake.
- v) The institution is admitting DNB candidates.
- vi) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admissions in MD(Radio-Diagnosis) course from the ensuing academic session.

48. **Rajiv Gandhi University of Health Sciences, Bangalore – Approval of M.S. Ramaiah Medical College, Bangalore for the award of D.A. qualification.**

Read: the Council Inspector's report (May,2004) on the standard of examination and other teaching facilities available at M.S. Ramaiah Medical College, Bangalore for purpose of approval of the college for the award of D.A. qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (May,2004) and decided to recommend that M.S. Ramaiah Medical College, Bangalore be approved the award of D.A. qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Committee further decided to direct the institution authorities to prospectively restrict the number of admissions to 4(four) students per year.

49. **Madras University and The Tamilnadu Dr. M.G.R. Medical University, Chennai – Approval of Stanley Medical College, Chennai for the award of MD(Dermatology) & D.D. qualifications.**

Read: The Council Inspector's report (April,2004) on the standard of examination and other teaching facilities available at Stanley Medical College, Chennai for purpose of approval of

the college for the award of MD(Dermatology) & DD qualifications earlier granted by Madras university and now by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (April,2004) and decided to defer the consideration of the matter till a clarification from the college authorities is received with regard to unit wise details of teaching faculty and institution wise their break up of experience.

50. **Conduct of one time entrance examination for postgraduate courses for three sessions i.e. for the years 2004, 2005 & 2006 – Consideration of W.P. No.1248 of 2004 regarding.**

Read: the letter dated 21.6.2004 from the Under Secretary, Govt. of Chhattisgarh regarding conducting of one time entrance examination for postgraduate courses for three sessions i.e. for the years 2004, 2005 & 2006.

The Postgraduate Committee considered the letter dated 21.6.2004 from the Under Secretary, Govt. of Chhattisgarh regarding conducting of one time entrance examination for postgraduate courses for three sessions i.e. for the years 2004, 2005 & 2006 and decided to constitute a Sub-Committee on behalf of the PG Committee with the following members to go through the matter :-

1. Dr. Ved Prakash Mishra - Chairman, Sub-Committee.
2. Dr.S.B. Siwach
3. Dr.(Mrs.) Usha Sharma

The Committee further decided to grant a hearing to the officers of the Govt. of Chhattisgarh and directed the office to take appropriate action directly.

51. **To consider the Inspection report (12th & 13th Feb.,2004) of Guntur Medical College, Guntur (A.P) carried out to assess the undergraduate teaching and training facilities available at the college for continuance of MBBS degree granted by NTR University of Health Sciences, Vijayawada.**

Read: the Inspection report (12th & 13th Feb.,2004) of Guntur Medical College, Guntur (A.P) carried out to assess the undergraduate teaching and training facilities available at the college for continuance of MBBS degree granted by NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the Inspection report (12th & 13th Feb.,2004) of Guntur Medical College, Guntur (A.P) carried out to assess the undergraduate teaching and training facilities available at the college for continuance of MBBS degree granted by NTR University of Health Sciences, Vijayawada and decided that all the Postgraduate courses have to be stopped forthwith.

The Postgraduate Committee noted that the Executive Committee and members of the Adhoc Committee considered the Council Inspectors report (12th & 13th Feb.,2004) pertaining Guntur Medical College, Guntur (A.P) at its meeting held on 28th March, 2004 and observed the following gross deficiencies:-

1. The shortage of teaching faculty is 15.8 % (i.e.34 out of 215) as under:-
 - a) Professor : 1 (Dentistry)
 - b) Associate Professor : 11(Anatomy 2, Phsisiology - 2, Pharmacology - 2, TB & Chest-1, Ortho-1, RD-2, Dental -1)
 - c) Assistant Professor : 14 (Anatomy-4, Physiology-2, Microbiology-1,PSM-5,Anaesthesia-1, and RD -1)
 - d) Tutor :6 (Pharma-4, and FM-2)

2. Though the total number of beds are more than 750 the distribution of beds is not as per Council norms as Paediatrics has got only 75 beds against 90 required. Teaching facilities are inadequate. Treatment room is not available in any ward. Proper demarcation of units is not provided. Paediatrics ward is over crowded and space between beds is very narrow. Teaching areas are not available in Ophthalmology, ENT etc. Unit distribution in Paediatrics, TB & Chest, Psychiatry, Orthopaedics, Ophthalmology is not as per Council norms since the institution is running postgraduate courses also.
3. In the OPDs of major departments like Medicine, Surgery, Paediatrics, Obstetrics & Gynaecology and Orthopaedics, space for teaching area is inadequate. Facilities like blackboard, X-ray view box etc. are not provided. Class rooms and demonstration rooms are not available for clinical departments. Ward side labs are not available for Medicine department. Microscope is not available in STD OPD. In Surgery OPD cubicles are provided with temporary partition. Clinical Psychologist is not available. There is a common room for plaster application and plaster cutting where running water is not available.
4. In the casualty area, only 10 beds are provided. Central oxygen or suction is not available. Only one Pulse Oximeter and one nebuliser are available. No other resuscitation equipment is provided. Duty room for CMO is too small. No room for resident doctors is provided.
5. In the central laboratory, there is no common sample collection area.
6. Medical Record Department is not computerised.
7. Central Laundry : There is a mechanized laundry available with four hydro extractor and two washer. Drier is not functional.
8. Incinerator is not available.
9. Blood Bank : License for the blood bank expired in 1997. 10 to 20 units of blood is being collected and 15 to 20 units are being distributed daily, which is not commensurate with the workload desired. It is not under the control of Professor and Head of Pathology.
10. Available Paramedical staff is as under:
Laboratory Technicians : 36
Laboratory Assistant : 17
Laboratory Attendants : 20
There is a shortage of 8 technicians, 13 assistants, and 15 attendants.
11. Nursing staff :
Nursing Superintendent 01
Deputy Nursing Superintendent : 01
Nursing Tutors : 09
Asstt. Nursing Superintendent : -Nil-
Nursing Sisters : 46
Staff nurses : 183
Total : 240

There is a gross deficiency of Nursing staff for a hospital with a bed strength of 1177.
12. Auditorium is under construction.
13. Hostel accommodation for boys and girls is inadequate as accommodation is available for only 340 students against 750 required as under :

14. In the Central library, total number of journals subscribed is only 35 against 100 required. Internet and medlar facilities are not available
15. No residential accommodation is available for teaching and non-teaching staff.
16. At RHTC, no lecturers cum medical officers having MD (PSM) qualification is posted. Mess is not available.
17. No practical laboratory in Forensic Medicine.
18. Delivery services are not provided at UHC.
19. Blood bank has to be brought under Pathology department.
20. Sufficient number of lockers are not provided in the department of Anatomy.
21. In the department of Physiology, no couch is available.
22. DNB students – one each in Orthopaedics and Obstetrics & Gynaecology are admitted for 2003-2004.
23. Teachers in clinical departments are not provided with adequate space to sit.
24. Other deficiencies/remarks are in the report.

In view of above, the members of the Ad-hoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council decided to recommend to the Council to withdraw the recognition of MBBS degree granted by NTR University of Health Sciences, Vijayawada in respect of students being trained at Guntur Medical College, Guntur u/s 19 of the I.M.C. Act, 1956.

Accordingly, the Postgraduate Committee considered the said reports and taking note of the deficiencies including therein and the decision of the Executive Committee alongwith the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and decided that the college authorities be requested forthwith to stop the admissions to all the postgraduate degree/diploma courses that are currently being run by the said college under intimation to the Registrar of the NTR University of Health Sciences, Vijayawada and Secretary (Health) of the State of Andhra Pradesh.

52. **Teacher's Eligibility Qualification – Appointment of Dr. Vinay Krishna as postgraduate teacher – regarding.**

Read: Teacher's Eligibility Qualification regarding appointment of Dr. Vinay Krishna as postgraduate teacher.

The Postgraduate Committee deliberated upon the letter received from Dr. J.L. Sahni in view of the fact that Dr. Vinay Krishna possess total teaching experience of 18th years and eight months decided to recognise him as a postgraduate teacher in Cardio-Thoracic Surgery.

53. **OP No.18900/1995 – Dr. John Zachariah David Vs. Registrar, Medical Council of India & another before the Hon’ble Kerala High Court.**

Read: OP No.18900/1995 of Dr. John Zachariah David Vs. Registrar, Medical Council of India & another before the Hon’ble Kerala High Court.

The members of the Postgraduate Committee deliberated at length and decided as under:-

- (i) Whether any State Medical Council has the jurisdiction or authority to carry out any entry of possessing any additional qualification against the name of a doctor who gets registration u/s 15 of the Act? - NO (in view of the Section 26 (2) read with Sections 21,22,23,24 of the Act.)
- (ii) Whether any State Medical Council has any jurisdiction or authority to seek to cancel the entry of additional qualification made against the name of a doctor whose name also stands entered into the IMR? - NO

The Committee further decided that as the reply to 2(i) & 2(ii) above is in the negative, then the Council would be required to suitably advise all the State Medical Council to forward all the cases of entries for additional qualifications against the names of those doctors who get their name registered on the basis of primary medical qualification - to the Indian Medical Council, they would neither be empowered nor authorised either to make any such entry u/s 26 of the Act or to cancel any such entry which is made in the IMR.

54. **W.P. No.6798/2004 – Dr. C.V. Madhuri & Ors. Vs. Principal Secretary, Govt. of A.P. & Ors. filed before the Hon’ble Andhra Pradesh High Court at Hyderabad – Change of nomenclature of MD(Dermatology) & MD (Veneralogy) reg.**

Read: W.P. No.6798/2004 – Dr. C.V. Madhuri & Ors. Vs. Principal Secretary, Govt. of A.P. & Ors. filed before the Hon’ble Andhra Pradesh High Court at Hyderabad regarding change of nomenclature of MD(Dermatology) & MD (Veneralogy) courses.

The Postgraduate Committee deliberated at length upon the issues raised in W.P. No.6798/2004 – Dr. C.V. Madhuri & Ors. Vs. Principal Secretary, Govt. of A.P. & Ors. filed before the Hon’ble Andhra Pradesh High Court at Hyderabad regarding change of nomenclature of MD(Dermatology) & MD (Veneralogy) courses & noted that the changed nomenclature has already been notified on 7th October, 2000 vide regulations of the Council on Postgraduate Medical Education, 2000. The same may be given full effect and directed the office of the Council to place it on the Hon’ble High Court of Andhra Pradesh at Hyderabad.

55. **Starting of DM(Nephrology) course at T.N. Medical College, Mumbai affiliated to Mumbai University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector’s report (May,2004) on the physical and other teaching facilities available at T.N. Medical College, Mumbai affiliated to Mumbai University for consideration of starting of DM(Nephrology) course.

The Postgraduate Committee considered the Council Inspector’s report (May,2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of DM(Nephrology) course at T.N. Medical College, Mumbai u/s 10A of the IMC Act, 1956 because of the following –

- i) Prof. & Head does not possess requisite super-speciality qualification.
- ii) Promotion of Prof. & Head is not as per MCI norms.
- iii) Lecturer does not possess super-speciality qualification.
- iv) Teaching complement is incomplete.
- v) Library facilities are inadequate.
- vi) Other deficiencies/observations as pointed out in the inspection report.

56. **King George's Medical University, Lucknow (Deemed University) – Continuation of recognition of MD(Obst. & Gynae) & DGO qualifications– Compliance verification regarding.**

Read: the compliance verification report (May,2004) togetherwith compliance and Council Inspector's report (May,2003) on the standard of examination and other teaching facilities available at K.G. Medical College, Lucknow for purposes of continuance of recognition of MD(Obst. & Gynae.) & DGO qualifications granted by Lucknow University.

The Postgraduate Committee considered the compliance verification report (May,2004) togetherwith compliance and Council Inspector's report (May,2003) and decided to advise the institution authorities to re-organise the units in terms of bed strength as per MCI norms.

The Committee further decided to defer the consideration till the information is received from the institution authorities.

57. **Starting of MD(Biochemistry) course at Sri Venkateswara Instt. of Medical Sciences, Tirupati (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (June,2004) on the physical and other teaching facilities available at Sri Venkateswara Instt. of Medical Sciences, Tirupati (Deemed University) for consideration of starting of MD(Biochemistry) course.

The Postgraduate Committee considered the Council Inspector's Report (June,2004) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Biochemistry) course at Sri Venkateswara Instt. of Medical Sciences, Tirupati (Deemed University) u/s 10A of the IMC Act,1956 because of the following:-

- i) There is no Professor.
- ii) Promotion of Addl. Prof. & HOD is not as per MCI norms.
- iii) Asstt. Prof. does not possess requisite postgraduate qualification.
- iv) Teaching faculty is insufficient.
- v) Other deficiencies/observations as pointed out in the inspection report.
