4. **Starting of MD(Pharmacology) course at Kamineni Instt. of Medical Sciences, Narketpally, Nalgonda under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (July, 2005) on the physical and other teaching facilities available at Kamineni Instt. of Medical Sciences, Narketpally, Nalgonda under under NTR University of Health Sciences, Vijayawada for consideration of starting of MD(Pharmacology) course.

The Postgraduate Committee considered the Council Inspector's report (July,2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Pharmacology) course at Kamineni Instt. of Medical Sciences, Narketpally, Nalgonda under under NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. The Postgraduate Committee considered the Council Inspector's report (March, 2005) along with the minutes of the hearing and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD (Pathology) course at Sri Venkateshwara Instt. of Medical Sciences, Tirupati (Deemed University) u/s 10A of the I.M.C. Act, 1956 because of the following:-

1. Staff is insufficient even for U.G. annual intake.
2. Assoc. Professor's promotion is not as per MCI norms.
3. Other deficiencies as pointed out in the inspection report.

The Postgraduate Committee considered the Council Inspector's report (May, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(General Medicine) course at Sri Venkateshwara Instt. of Medical Sciences, Tirupati under the Institute (Deemed University) u/s 10A of the I.M.C. Act, 1956 because of the following:-

1. Promotion of Prof. & HOD and incharge of Unit II is not as per MCI norms.
2. Resultantly teaching complement is incomplete in both the units.
3. Other deficiencies as pointed out in the inspection report.

**7. Starting of D.A. course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2005) on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada for consideration of starting of D.A. course.

The Postgraduate Committee considered the Council Inspector's report (May, 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of D.A. course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admissions to 3(three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

**8. Starting of M.S.(ENT) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (March, 2005) along with the compliance on the physical and other teaching facilities available at Yenepoya Medical College, Mangalore under

Rajiv Gandhi University of Health Sciences, Mangalore for consideration of starting of M.S.(ENT) course.

The Postgraduate Committee considered the Council Inspector's report (March, 2005) along with the compliance and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(ENT) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Mangalore u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admissions to 2(two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

**9. Starting of M.S.(Ophthalmology) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 – Consideration of Central Govt. reg.**

The Postgraduate Committee considered the Council Inspector's report (March, 2005) alongwith Central Govt. letter dated 16.5.2004 and decided that the eye bank and donor Eye in the Deptt. of Ophthalmology is a desirable requirement, at the time of starting of the course. However, the same is mandatory at the time of recognition of the course.

The Postgraduate Committee further decided to inform the Govt.of India accordingly.

**10. Starting of M.D.(Anatomy) Course at Sri Devraj Urs Medical College, Kolar affiliated to Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: the compliance verification report together with compliance and Council Inspector's report (July, 2003) on the physical and other teaching facilities available at Sri Devraj Urs Medical College, Kolar for consideration of starting of M.D.(Anatomy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report together with compliance and Council Inspector's report (July, 2003) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Anatomy) course at Sri Devraj Urs Medical College, Kolar under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the I.M.C. Act, 1956 because of the following:-

1. Additional teaching staff for postgraduate course required as per MCI norms is not available.
2. Other deficiencies as pointed out in the inspection report.

**11. Starting of MD(Radio-Diag.) course at K.S.Hegde Medical Academy, Mangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2005) on the physical and other teaching facilities available at K.S.Hegde Medical Academy, Mangalore under Rajiv Gandhi University of Health Sciences, Bangalore for consideration of starting of MD(Radio-Diag.) course.

The Postgraduate Committee considered the Council Inspector's report (April, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD (Radio-Diag.) course at K.S.Hegde Medical Academy, Mangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 because –

1. Professor & HOD does not possess requisite recognized PG qualification.
2. DSA unit is not available.

3. Full time Physicist is not available.
4. Other deficiencies as pointed out in the inspection report

**12. Starting of M.S.(Ophthalmology) course at Sri Guru Ram Das Instt. of Medical Sciences, Sri Amritsar under Baba Farid University of Health Sciences, Faridkot u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (July, 2005) on the physical and other teaching facilities available at Sri Guru Ram Das Instt. of Medical Sciences, Sri Amritsar under Baba Farid University of Health Sciences, Faridkot for consideration of starting of M.S.(Ophthalmology).

The Postgraduate Committee considered the Council Inspector's report (July, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.S.(Ophthalmology) course at Sri Guru Ram Das Instt. of Medical Sciences, Sri Amritsar under Baba Farid University of Health Sciences, Faridkot u/s 10A of the IMC Act, 1956 because-

1. Promotion of Assoc. Prof. is not as per MCI norms.
2. Resultantly teaching complement is incomplete.
3. Number of Journals are inadequate.
4. Other deficiencies as pointed out in the inspection report.

**13. Starting of DM(Cardiology) courses at Dayanand Medical College, Ludhiana under Baba Farid University of Health Sciences, Faridkot u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (March, 2005) on the physical and other teaching facilities available at Dayanand Medical College, Ludhiana under Baba Farid University of Health Sciences, Faridkot along with the compliance for consideration of starting of DM(Cardiology) course.

The Postgraduate Committee considered the Council Inspector's report (March, 2005) along with the compliance and decided to recommend to the Central Govt. to issue Letter of Permission for starting of DM(Cardiology) course at Dayanand Medical College, Ludhiana under Baba Farid University of Health Sciences, Faridkot u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admission to 1(one) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

**14. Starting of MS(Ophthalmology) course at MIMS, Latur under Swami Ramanand Teerth Marathwada University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2005) on the physical and other teaching facilities available at MIMS, Latur under Swami Ramanand Teerth Marathwada University for consideration of starting of MS(Ophthalmology) course.

The Postgraduate Committee considered the Council Inspector's report (April, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MS (Ophthalmology) course at MIMS, Latur under Swami Ramanand Teerth Marathwada University u/s 10A of the IMC Act, 1956 because –

1. Professor & HOD does not possess requisite recognized PG qualification.
2. Promotion of Assoc. Professor is not as per MCI norms.
3. Resultantly teaching complement is incomplete in both the units.
4. Bed Strength is not as per MCI norms.
5. Other deficiencies as pointed out in the inspection report.

**15. Starting of MD(Immuno-Haematology & Blood Transfusion) course at S.M.S. Medical College, Jaipur under Rajasthan University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2005) on the physical and other teaching facilities available at SMS Medical College, Jaipur under Rajasthan University for consideration of starting of M.D.(Immuno- Haematology & Blood Transfusion) course.

The Postgraduate Committee considered the Council Inspector's report (May, 2005) and noted the following :-

1. The department of Immuno-Heamatology & Blood Transfusion is not having an independent academic entity.
2. As of now Immuno-Heamatology & Blood Transfusion department are under the Pathology Deptt.
3. There is no separate teaching faculty in the deptt. of Immuno-Haematology & Blood Transfusion.

The Committee further decided to advise the institution authorities for separation of the Immuno- Haematology & Blood Transfusion department from Pathology; supply the teaching faculty of both the departments of Immuno- Haematology & Blood Transfusion & Pathology and deferred the consideration of the matter.

**16. Starting of M.D.(Forensic Medicine) qualification at Surat Municipal Institute of Medical Education & Research, Surat under Veer Narmad South Gujrat University, Surat u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector report (Oct., 2005) on the physical and other teaching facilities available at Surat Municipal Institute of Medical Education & Research, Surat under Veer Narmad South Gujrat University, Surat for consideration of starting of M.D.(Forensic Medicine) course.

The Postgraduate Committee considered the Council Inspector report (Oct., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Forensic Medicine) course at Surat Municipal Institute of Medical Education & Research, Surat under Veer Narmad South Gujrat University, Surat u/s 10A of the IMC Act, 1956 because of the following:-

1. Additional teaching faculty required for PG courses is not available.
2. Other deficiencies as pointed out in the inspection report.

**17. Starting of D.M.(Clinical Haematology) course at Govt. Medical College, Kolkatta under West Bengal University of Health Sciences, West Bengal u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2005) on the physical and other teaching facilities available at Govt. Medical College, Kolkatta under West Bengal University of Health Sciences, West Bengal alongwith additional information received vide Principal's letter dated 21.11.2005 for consideration of starting of D.M. (Clinical Haematology) course.

The Postgraduate Committee considered the Council Inspector report (May, 2005) and decided to carry out an inspection for verification of additional information furnished by the college authorities.

**18. Increase of DM(Cardiology) course at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow under the Deemed University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2005) on the physical and other teaching facilities available at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow under the Deemed University for consideration of increase of seats in DM(Cardiology) course.

The Postgraduate Committee considered the Council Inspector's report (April, 2005) and decided to advise the institution authorities to re-organise the units in terms of teaching beds as per MCI norms recommend to the Central Govt. not to issue Letter of Intent for increase of seats in DM(Cardiology) course at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow under the Deemed University u/s 10 A of the IMC Act, 1956 because –

1. Units are not as per MCI norms in terms of teaching bed strength.
2. Advise to re-organise the units.

The Committee further decided to defer the consideration of the matter till the information is received from the institution authorities.

**19. Starting of M.S.(Orthopaedics) & D.Ortho courses at J.L.N. Medical College, Swangi, Wardha under Nagpur University u/s 10A of the IMC Act, 1956.**

Read: the compliance verification report (May, 2005) together with compliance and Council Inspector's report (August, 2004) on the physical and other teaching facilities available at J.L.N. Medical College, Swangi, Wardha under Nagpur University for consideration of starting of M.S.(Orthopaedics) & D.Ortho courses.

The Postgraduate Committee considered the compliance verification report (May, 2005) together with compliance and Council Inspector's report (August, 2004) and decided to seek comments of the college authorities pertaining to observations in the Inspection Report regarding :-

- i) Income shown in the declaration form of the HOD and Form 16 are not tallied.
- ii) Emoluments of Dr. V. W. Gadge, Associate Professor are almost 1/3 of the salary drawn by other in similar capacity in the same institute.

The Committee further decided to defer the consideration of the matter till the comments are received from the institution authorities.

**20. Starting of MD(Radio-Diagnosis) courses at Govt. Medical College, Kottayam under Mahatma Gandhi University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report(May, 2005) on the physical and other teaching facilities available at Govt. Medical College, Kottayam under Mahatma Gandhi University for consideration of starting of MD (Radio-Diagnosis) course.

The Postgraduate Committee considered the Council Inspector's report(May, 2005) and decided to advise the institution authorities to re-organise the faculty as per MCI norms and defer the consideration of the matter till the compliance is received from the institution authorities.

The Committee further decided to draw the attention of the college authorities to the observations made by the Council Inspector in the inspection report.

The Postgraduate Committee considered the letter dated 15.03.2005 received from Dr. V.K.Das, Indian College of Nuclear Medicine, Lucknow and decided to reiterate its earlier decision taken at its meeting held on 06.11.1996, which reads as under :-

*“The Postgraduate Committee reviewed the earlier Committee’s decision taken at its meeting held on 18.0.1995 pertaining Dr. B.K. Das to be a postgraduate teacher with ‘Arzt fur Nuclear Medicine’, Germany as a special case.*

*The Postgraduate Committee feels that a person having unrecognised qualification should not be considered as a recognised postgraduate teacher.*

*In view of the fact that Committee decided to review the earlier decision because of the fact that the degree possessed by Dr. B. K. Das cannot be equated with postgraduate degree of Indian Universities as there is no examination for the award of said degree”.*

51. **Increase of seats in MS(General Surgery) at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector’s report (September, 2005) on the physical and other teaching facilities available at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka for consideration of increase of seats in MS(General Surgery) course.

The Postgraduate Committee considered the Council Inspector’s report (September, 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MS(General Surgery) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the Indian Medical Council Act, 1956 prospectively i.e. from the academic session 2006-2007 from 2(two) to 4(four) students per year till the first batch admitted against the increased number appears for the final examination of the said course.

52. **Increase of seats in MS(Anaesthesia) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector’s report (October, 2005) on the physical and other teaching facilities available at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka for consideration of increase of seats in MD(Anaesthesia) course.

The Postgraduate Committee considered the Council Inspector's report (October, 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.D.(Anaesthesia) course at Yenepoya Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the Indian Medical Council Act, 1956 prospectively i.e. from the academic session 2006-2007 from 2(two) to 3(three) students per year till the first batch admitted against the increased number appears for the final examination of the said course.

**53. Increase of seats in M.S.(Orthopaedics) course at Rajah Muthiah Medical College, Annamalai Nagar affiliated to Annamalai University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (May, 2005) together with the compliance on the physical and other teaching facilities available at Rajah Muthiah Medical College, Annamalai Nagar under Annamalai University for consideration of increase of seats in MS(Orthopaedics) course u/s 10A of the IMC Act,1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2005) together with the compliance and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.S.(Orthopaedics) course at Rajah Muthiah Medical College, Annamalai Nagar under Annamalai University u/s 10A of the Indian Medical Council Act, 1956 prospectively i.e. from the academic session 2005-2006 restricting the number of admissions from 6(six) to 8(eight) students per year till the first batch admitted against the increased number appears for the final examination of the said course.

**54. Increase of seats in M.Ch.(Paediatrics Surgery) course at Maulana Azad Medical college, New Delhi under Delhi University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (March, 2005) together with the compliance on the physical and other teaching facilities available at Maulana Azad Medical College, New Delhi under Delhi University for consideration of increase of seats in M.Ch.(Paediatrics Surgery) course u/s 10A of the IMC Act,1956.

The Postgraduate Committee considered the Council Inspector's report (March, 2005) together with the compliance and decided to verify the compliance by way of an inspection.

**55. Increase of seats in M.S.(General Surgery) course at University College of Medical Sciences, Delhi under Delhi University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (March, 2005) on the physical and other teaching facilities available at University Medical Sciences, Delhi under Delhi University together with the compliance for consideration of increase of seats in M.S.(General Surgery) course u/s 10A of the IMC Act,1956.

The Postgraduate Committee considered the Council Inspector's report (March, 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.S.(General Surgery) course at University College of Medical Sciences, Delhi under Delhi University u/s 10A of the Indian Medical Council Act, 1956 prospectively i.e. from the academic session 2006-2007 from 4(four) to 6(six) students per year till the first batch admitted against the increased number appears for the final examination of the said course.

**56. Starting of D.Ortho. course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (March, 2005) together with the compliance on the physical and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada for consideration of starting of D.Ortho. course u/s 10A of the IMC Act,1956.

The Postgraduate Committee considered the Council Inspector's report (March, 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of D.Ortho. course at Deccan College of Medical Sciences, Hyderabad under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively restricting the number of admission to 1(one) student per year in each course till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

**57. Starting of M.D.(Immuno-Haematology & Blood Transfusion) at B.J. Medical College, Ahmedabad under Gujrat University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (August, 2005) on the physical and other teaching facilities available at B.J. Medical College, Ahmedabad under Gujrat University for consideration of starting of M.D.(Immuno-Haematology & Blood Transfusion) course.

The Postgraduate Committee considered the Council Inspector's report (August, 2005) and decided to seek clarification from the institution authorities regarding staff position of Pathology Deptt. as on date upon transfer of teaching faculty to Heamatology & Blood Transfusion Deptt.

The Committee further decided to defer the consideration of the matter till the information is received.

**58. Starting of M.D.(TB & Resp. Diseases) & D.T.C.D. courses at Pramukhswami Medical College, Karamsad, Gujarat affiliated to Sardar Patel University u/s 10A of the IMC Act, 1956-consideration of compliance regarding.**

Read: the compliance verification report together with compliance and Council Inspector's report (July, 2004) on the physical and other teaching facilities available at Pramukhswami Medical College, Karamsad, Gujarat affiliated to Sardar Patel University for consideration of starting of M.D.(TB & Resp. Diseases) & D.T.C.D. courses.

The Postgraduate Committee considered the compliance verification report together with compliance and Council Inspector's report (July, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(TB & Resp. Diseases) & D.T.C.D. courses at Pramukhswami Medical College, Karamsad, Gujarat affiliated to Sardar Patel University u/s 10A of the I.M.C.Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admission to 1(one) student per year in each course till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

**59. Starting of M.Ch. (Neurosurgery) course at Dr. D.Y. Patil Medical College, Pimpri, Pune under the Institute (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report(June, 2005) on the physical and other teaching facilities available at Dr. D.Y. Patil Medical College, Pimpri, Pune under the Institute (Deemed University) for consideration of starting of M.Ch.(Neurosurgery) course.

The Postgraduate Committee considered the Council Inspector's report (June, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch.(Neurosurgery) course at Dr. D.Y. Patil Medical College, Pimpri, Pune under the Institute (Deemed University) u/s 10A of the IMC Act, 1956 because –

1. Promotion of Assoc. Prof. is not as per MCI norms.
2. Resultantly teaching complement is incomplete.
3. Other deficiencies/observations as pointed out in the inspection report.

**60. Starting of MS(Orthopaedics) course at MIMS, Latur under Swami Ramanand Teerth Marathwada University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (April, 2005) on the physical and other teaching facilities available at MIMS, Latur under Swami Ramanand Teerth Marathwada University for consideration of starting of MS(Orthopaedics) course.

The Postgraduate Committee considered the Council Inspector's report (April, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M. S (Orthopaedics) course at MIMS, Latur under Swami Ramanand Teerth Marathwada University u/s 10A of the IMC Act, 1956 because :-

- i) Prof. & HOD does not possess requisite recognized postgraduate qualification
- ii) Resultantly teaching complement is incomplete.
- iii) Other deficiencies pointed out by the Council Inspector in the inspection report.

**61. Starting of MD(Radio-Diag.) course at MIMS, Latur under Swami Ramanand Teerth Marathwada University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report(April, 2005) on the physical and other teaching facilities available at MIMS, Latur under Swami Ramanand Teerth Marathwada University for consideration of starting of MD(Radio-Diag.) course.

The Postgraduate Committee considered the Council Inspector's report(April, 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D (Radio-Diag.) course at MIMS, Latur under Swami Ramanand Teerth Marathwada University u/s 10A of the IMC Act, 1956 because :-

1. All teaching faculty does not possess requisite recognized postgraduate qualification.
2. There is no research lab.
3. There is no MRI facility.
4. Books and Journals are inadequate.
5. Other deficiencies/observations as pointed out in the inspection report.

**62. Starting of M.S.(Orthopaedics) course at Annasaheb Chaudaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956 - consideration of compliance regarding.**

Read: the Council Inspector's report (May, 2004) together with compliance and compliance verification report (September, 2005) on the physical and other teaching facilities available at Annasaheb Chaudaman Patil Memorial Medical College, Dhule for consideration of starting of M.S.(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) together with compliance and compliance verification report (September, 2005) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M. S (Orthopaedics) course at Annasaheb Chaudaman Patil Memorial Medical College, Dhule u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007, restricting the number of admission to 1(one) student per year in each course till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

**63. Starting of M.D.(Microbiology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act,1956- consideration of compliance regarding.**

Read: the Council Inspector's report (May, 2004) on the physical and other teaching facilities available at Annasaheb Chavdaman Patil Memorial Medical College, Dhule together

with compliance and compliance verification report (Aug.,2005) for consideration of starting of M.D.(Microbiology) course.

The Postgraduate Committee considered the Council Inspector's report (May, 2004) together with compliance and compliance verification report (Aug.,2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D (Microbiology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule u/s 10A of the IMC Act, 1956 because –

1. Promotion of Assoc. Prof. is not as per MCI norms.
2. Teaching faculty is insufficient even for UG annual intake.
3. Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of M.D (Microbiology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulation on Postgraduation Medical Education, 2000.

**64. Starting of M.S.(Ophthalmology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956- consideration of compliance regarding.**

Read: the compliance verification report (Aug.,2005) together with the compliance & Council Inspector report (April, 2004) on the physical and other teaching facilities available at Annasaheb Chavdaman Patil Memorial Medical College, Dhule for consideration of starting of M.S.(Ophthalmology) course.

The Postgraduate Committee considered the compliance verification report (Aug.,2005) together with the compliance & Council Inspector report (April, 2004) and decided to reiterate its earlier decision taken at its meeting held on 07.06.2005 recommending to the Central Govt. not to issue Letter of Intent for starting of M.S (Ophthalmology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule u/s 10A of the IMC Act, 1956 because –

1. Prof. & Head does not possess requisite recognized postgraduation qualification.
2. Number of Journals are inadequate.
3. Compliance is unsatisfactory.
4. Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend that the Govt. may consider disapproving the proposal for starting of M.D (Microbiology) course. However, the institution is free to apply afresh after rectification of the deficiencies, in accordance with the Council's Regulation on Postgraduate Medical Education, 2000.

**65. Starting of various postgraduate courses at Command Hospital (WC), Chandimandir, Haryana affiliated to Kurukshetra University u/s 10A of the IMC Act, 1956- Consideration of compliance regarding.**

Read : the inspection reports on the physical and other teaching facilities available at Command Hospital (WC), Haryana along with recommendations of the General Body for counting of teaching experience of specialties graded doctors of AMC for starting of various courses at Command Hospital Chandimandir, u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's reports and decided to constitute a Sub-Committee of Dr. Indrajit Ray and Dr. Usha Sharma and refer this matter to the Sub-Committee to submit its observations to the Postgraduate Committee for further consideration.

**66. Inclusion of Head Injury training in M.Ch.(Neuro-Surgery) curriculum – Consideration regarding.**

Read : the letter dated 22/7/2005 received from Prof. A.K. Mahapatra, Honorary Secretary, New Delhi regarding inclusion of Head Injury training in M.Ch.(Neuro-Surgery) curriculum.

The Postgraduate Committee considered the letter dated 22.07.2005 received from Prof. A. K. Mahapatra, Honorary Secretary, New Delhi and decided that Dr. P. N. Tandon, Member of the Adhoc Committee appointed by the Honourable Supreme Court, be requested for his opinion through appropriate consultations that he may deem necessary for further consideration by the Postgraduate Committee.

**67. Variation in nomenclatures of Postgraduate Degree/Diploma qualification awarded by respective universities – consideration of recognition regarding.**

Read : the matter with regard to additional registration with Medical Council of India by the nomenclature of MD(Obst. & Gynae. & diseases of children) granted by Gujrat University at K.M. School of P.G. Medicine and Research, Ahmedabad as the qualification is recognised by the MCI and included in the Ist Schedule by the nomenclature of MD(Obst. & Gynae.) in respect of the said college.

The Postgraduate Committee considered the matter in view of the decision of the General Body taken at its meeting held on 26.03.2005 and decided that the qualification by nomenclature of MD (f. & Gynae. and diseases of Children) be treated as deemed recognised qualification at par with MD (Obst. & Gynae) in respect of K. M. School of P.G. Medicine and Research is already recognised and included in the 1<sup>st</sup> Schedule to the IMC Act, 1956.

The Postgraduate Committee also decided that all similarly placed cases may be decided on merit in the light of the decision of the General Body taken at its meeting held on 26.03.2005.

**68. Exemption to in-service candidates of the State of Kerala for appearing for PG Common Entrance Examination.**

Read : the letter dated Nil of President, Medical College Teachers Association, Kerala regarding exemption to in-service candidates of the State of Kerala for PG Common Entrance Examination.

The Postgraduate Committee considered the letter dated Nil of President, Medical College Teachers Association, Kerala regarding exemption to in-service candidates of the State of Kerala for PG Common Entrance Examination and decided to approve that :

- (a) *The minimum eligibility for inservice candidates is not compromised. However, weightage is given on the basis of their seniority or the rural service in a quantified manner including due cognizance to difficult rural service, which could be added to their eligibility score for the purpose of computation of inter-se merit amongst themselves as they are to compete for a quota of seats earmarked for them.*
- (b) *The Medical Council of India has recommended amendment in the Postgraduate Medical Education Regulations, 2000, wherein it is proposed that 50% of the Diploma seats should be exclusively earmarked for admission to the health personnel in the rural health services.*

*As a matter of fact, Council is of the considered opinion that entry of the rural health manpower into Diploma course would update them in terms of "knowledge/informational inputs as well as hands on training". The non-entitlement of admission to postgraduate Degree courses per se could be a well founded initiative which would facilitate retaining the said manpower to serve the rural areas as against, procurement of the degree qualifications would be naturally tempting them to opt for pursuits off the rural situations, which would be self defeating.*

- (c) *The criterion for admission to the inservice candidates be fixed in terms of scheme incorporated at seriatim III under the Postgraduate Regulations, 2000 which reads "on the basis of the individual cumulative performance at the first, second and third MBBS examinations, if such examinations have been passed from the same university.*

*This would satisfy the limit of the requirement of securing minimum 50% marks in as much as the passing percentage prescribed by the Council for passing all these examinations has been fixed as 50% irrespective of the stream where from the candidate is admitted.*

*However, the legal embargo that has been brought out by the various pronouncements by the Hon'ble Supreme Court interpreting clause 9 of the Postgraduate Regulations, 200, in as much as, that there should not be two different yardsticks for admission to the postgraduate courses by the same admitting authority, meaning thereby that in service candidates cannot be admitted to the postgraduate courses by the admitting authority resorting to any different yardstick as against the one applied to the remainder of the students and further the weightage so contemplated cannot be added so as to compensate for the deficiency of the minimum eligibility score i.e. 50%.*

*As such, justifying the cause for update of the rural health manpower, so as to make the rural health care delivery system effective, it would be appropriate to provide for any one of the three modalities as an amendment to the clause 9 of the Postgraduate Regulations along with the other proposed amendments that are already underway and are pending/awaiting notification by the Govt. of India.*

69. **University of Delhi - Approval of Army Hospital Delhi Cantt., Delhi for the award of M.D. (Radio-Diagnosis) qualification.**

Read : the Council Inspector's report (October, 2003) together with the compliance on the standard of examination and other teaching facilities available at Army Hospital Delhi Cantt., Delhi for purpose of approval of the college for the award of M.D.(Radio-Diagnosis) qualification granted by University of Delhi

The Postgraduate Committee considered the Council Inspector's report (October 2003) and decided to constitute a Sub-Committee of Dr. Indrajit Ray and Dr. Usha Sharma and refer this matter to the Sub-Committee to submit its observations to the Postgraduate Committee for further consideration.

70. **University of Delhi - Approval of Army Hospital Delhi Cantt., Delhi for the award of M.D. (Paediatrics) & D.C.H. qualifications – consideration of compliance regarding.**

Read : the Council Inspector's report (Oct., 2003) together with the compliance on the standard of examination and other teaching facilities available at Army Hospital Delhi Cantt., Delhi for purpose of approval of the college for the award of M.D.(Paediatrics) & D.C.H. qualifications granted by University of Delhi.

The Postgraduate Committee considered the Council Inspector's report (October 2003) and decided to constitute a Sub-Committee of Dr. Indrajit Ray and Dr. Usha Sharma and refer this matter to the Sub-Committee to submit its observations to the Postgraduate Committee for further consideration.

71. **A.P. Singh University, Rewa – Recognition of D.O./D.O.M.S. qualification in respect of students being trained at S.S. Medical College, Rewa.**

Read : the Council Inspector's report (July, 2005) on the standard of examination and other teaching facilities available at S.S. Medical College, Rewa for purpose of recognition of D.O./D.O.M.S. qualification granted by A.P. Singh University Rewa.

The Postgraduate Committee considered the Council Inspector's Report (July 2005) and noted that the bed strength in Units is not as per MCI Norms and decided to advise the Institution authorities to reorganize the Units in terms of bed strength in consonance with the Regulations of the Council on Postgraduate Medical Education, 2000.

The Committee further decided to defer the consideration till the compliance is received from the Institution authorities.



**72. The Tamilnadu Dr. M.G.R. Medical University, Chennai- Approval of Stanley Medical College, Chennai for the award of D.C.P. qualification.**

Read : the Council Inspector's report (August, 2005) on the standard of examination and other teaching facilities available at Stanley Medical College, Chennai for purpose of approval of the college for the award of D.C.P. qualification granted by The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's Report (August 2005) and decided not to approve Stanley Medical College, Chennai for the award of D. C. P. qualification because of the following deficiencies pointed out in the Inspection Report :-

1. There is a separate department of Transfusion Medicine with separate sanction of posts for Reader & Tutor. The HOD of Transfusion Medicine is Dr.Rajkumar as mentioned on the display board in Dean's office. However, on this post Dr. Ravibabu was show as Reader and Head of Blood Bank (considering blood bank as part of the Pathology) and Dr.Rajkumar was not listed anywhere in Transfusion Medicine department thought he was available in the deptt. on second day of inspection ??
2. Dr.Ravibabu (Assoc.Prof.) – his transfer order from Changelpattu Medical College issued by Health & Family Welfare (A1) Department is dated 28.2.2005. However, his joining report at Stanley Medical College indicate dt.12.2.2003. His pay drawn particulars are for the year 2003-2004 and that also not from Dean's office (It is from office of I.O.G. Govt. Hospital EGMORE – Madras).
3. The Dean of the college has certified in writing?? That Blood Bank (Deptt. of Transfusion Medicine) is part of Pathology inspite of a display board in his office clearly mentions it as a separate department with a separate Head of the department.
4. Two of the tutors I) Dr.Vanaja and ii) Dr.Thenmozhi are tutorls in the department of Blood Transfusion medicine but they are shown as tutors in Pathology.
5. Two of the tutor mentioned in department of Pathology Dr.Mohandas Joe Chandra, Dr.Syed Rafi Ahmed are actually tutors in Anatomy as per the information provided in their T.D.S. for 2004-2005.
6. Following reliving orders of faculty members coming from other college were signed by Dean-Stanley Medical College, (Reliving & Joining orders signed by same dean)
  - i) Dr.S.Balamurngen – Asst. Prof. of Pathology.
  - ii) Dr.Thenmozhi – Tutor in Transfusion Medicine
  - iii) Dr.S.Jaykumar – Tutor in Pathology
  - iv) Dr.G.Tulsikumar – Tutor in Pathology
7. The college and hospital both were in very unhygienic condition with lots of garbage lying everywhere.
8. Cold stograge facility in Post Mortum room were out of order since long, so dead bodies were decomposing in open and nearly unworkable situation.
9. The Transfusion Medicine Department was run 24 hrs by one reader Dr.Rajkumar and two tutors i) Dr.Vanaja and ii) Dr.Thenmozhi plus one technician and one technical asst. and two NACO provided technician and six nurses. No other Medical or Paramedical staff was there not even residents of Pathology. Night emergencies were done only by non-technical staff like nurses. This is quite against the norm laid down by F.D. Depart.

**73. Recognition of MS(Orthopaedics), MD (obst. & gynae.), MD(Anaes.), MS (Ophth.), MD(Paed.), MD(Radio-Diag.) and MD (Dermatology STD & Leprosy) qualifications granted by University of Mumbai in respect of Institute of Naval Medicine, Asvini, Mumbai.**

The Postgraduate Committee considered the Council Inspector's report (June,2004) together with compliance & minutes of the hearing and decided to recommend to the Central Govt. not to issue letter of Intent for starting of MD(Biochemistry) course at Sri Venkateswara Instt. of Medical Sciences, Tirupati (Deemed University) u/s 10A of the I.M.C. Act,1956 because of the following deficiencies:-

1. Department is not headed by a Professor with Medical qualifications.
2. The promotion of 2<sup>nd</sup> Additional Professor is not as per MCI norms.
3. Resultantly teaching complement is incomplete.
4. Other deficiencies/observations as pointed out in the inspection report.

**130. Starting of MD(General Medicine) course at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act, 1956.**

Read : the Council Inspector's report (Oct., 2005) on the physical and other teaching facilities available at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada along with additional information for consideration of starting of MD (General Medicine) course.

The Postgraduate Committee considered the Council Inspector's report (Oct., 2005) along with additional information received from the college authorities vide their letter dated 30.10.2005 and decided to carry out fresh inspection.

**131. Starting of MD(Obst. & Gynae.) & D.G.O. course at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act, 1956.**

Read : the Council Inspectors report (Nov., 2005) on the physical and other teaching facilities available at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada for consideration of starting of MD(Obst. & Gynae.) & D.G.O. course.

The Postgraduate Committee considered the Council Inspector's report (Nov.,2005) and decided to recommend to the Central Govt. to issue Letter of Intent for starting of MD(Obst. & Gynae.) & D.G.O. courses at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act,1956 prospectively i.e. from the academic session 2006-07 restricting the number of admissions to 2 (two) students per year in each course.

The Committee further decided to draw the attention to the observations made by the Council Inspector in the inspection report.

**132. Starting of M.S. (Orthopaedics) and D.(Otho.) courses at Academy of Medical Sciences, Parivaram affiliated to Kannur University u/s 10A of the IMC Act, 1956-consideration of compliance regarding.**

Read : the compliance verification report (Oct., 2005) together with the compliance and Council Inspectors report (April, 2004) on the physical and other teaching facilities available at Academy of Medical Sciences, Pariyaram for consideration of starting of M.S.(Orthopaedics) and D.(Ortho.) courses.

The Postgraduate Committee considered the compliance verification report (Oct., 2005) together with the compliance and Council Inspectors report (April, 2004) and noted that teaching complement is incomplete in Unit-I for want of Associate Professor and teaching complement is insufficient even for undergraduate course; decided to reiterate its earlier decision taken at its meeting held on 23.12.2004 recommending to the Central Govt. not to issue Letter of Intent for starting of M.S. (Orthopaedics) and D.(Ortho.) courses at Academy of Medical Sciences, Pariyaram affiliated to Kannur University u/s 10A of the IMC Act, 1956 as the earlier deficiencies are still persisting.

The Postgraduate Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of M.S. (Orthopaedics) and D.(Ortho.) courses at Academy of Medical Sciences, Pariyaram affiliated to Kannur University. However, the institution is free to apply afresh after rectification of the deficiencies in accordance with the Council's Regulations on Postgraduate Medical Education,2000.

**133. Starting of DM(Neurology) course at Bangalore Medical College, Bangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read : the compliance verification report (Oct., 2005) together with the compliance and Council Inspector report (February, 2005) on the physical and other teaching facilities available at Bangalore Medical College, Bangalore under Rajiv Gandhi University of Health Sciences, Bangalore for consideration of starting of DM(Neurology) course.

The Postgraduate Committee considered the compliance verification inspection report (Oct.,2005) together with the compliance and Council Inspector's report (February,2005) and noted that the compliance is unsatisfactory; decided to reiterate its earlier decision taken at its meeting held on 26.3.2005 recommending to the Central Govt. not to issue Letter of Intent for starting of DM(Neurology) course at Bangalore Medical College, Bangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 as the earlier deficiencies are still persisting.

The Postgraduate Committee further decided to recommend that in view of the above, the Govt. may consider disapproving the proposal for starting of D.M.(Neurology) course at Bangalore Medical College, Bangalore under Rajiv Gandhi University of Health Sciences, Bangalore. However, the institution is free to apply afresh after rectification of the deficiencies in accordance with the Council's Regulations on Postgraduate Medical Education,2000.

**134. Increase of seats in M.D.(General Medicine) course at Christian Medical College, Vellore affiliated to The Tamilnadu Dr.MGR Medical College, Tamilnadu u/s 10A of the IMC Act, 1956.**

Read : the Council Inspectors report (Oct., 2005) on the physical and other teaching facilities available at Christian Medical College, Vellore under The Tamilnadu Dr. MGR Medical University, Tamilnadu for consideration of increase of seats in MD(General Medicine) course.

The Postgraduate Committee considered the Council Inspector's report (Oct.,2005) and noted that promotion of one Professor, three Associate Professors, one Reader and Incharge of Unit-IV are not as per MCI norms, and decided to advise the institution authorities to re-organise the units in terms of teaching faculty as per MCI norms.

The Committee further decided to defer the consideration of the matter till the compliance is received.

**135. Starting of DM(Neonatology) course at Seth G.S. Medical College, Mumbai under University of Mumbai u/s 10A of the IMC Act, 1956.**

Read : the Council Inspectors report (Oct., 2005) on the physical and other teaching facilities available at Seth G.S. Medical College, Mumbai under Mumbai University for consideration of starting of DM(Neonatology) course.

The Postgraduate Committee considered the Council Inspector's report (Oct.,2005) and noted that D.M.(Neonatology) course was started at Seth G.S. Medical College, Mumbai under Mumbai University in the year 1994 without the prior permission of the Council. It further noted that there are some other similar cases, therefore, decided to authorize the Chairman to make a Sub-Committee for making recommendations for further consideration of PG Committee.

**136. Starting of M.D.(PSM) qualification at C.U. Shah Medical College, Surendranagar under Saurashtra University u/s 10A of the IMC Act, 1956.**

Read : the Council Inspectors report (Oct., 2005) on the physical and other teaching facilities available at C.U. Shah Medical College, Surendranagar under Saurashtra University for consideration of starting of M.D.(PSM) course.

The Postgraduate Committee considered the Council Inspector's report (Oct.,2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(PSM) course at C.U. Shah Medical College, Surendranagar under Saurashtra University u/s 10A of the IMC Act, 1956 because of the following deficiencies:-

1. Professor & HOD does not possess recognized postgraduate qualification.
2. RHC & UHC are not under the administrative control of the Dean of the college.
3. There is no Epidemiologist.
4. Other deficiencies/observations as pointed out in the inspection report.

**137. Conducting of DNB courses in Postgraduate Medicine in Govt. Medical Colleges by utilising the surplus capacity available vis-à-vis MCI norms – reg.**

Read : the Central Govt. letter dated 19/9/2005 together with report of the Sub-Committee with regard to Conducting of DNB courses in Postgraduate Medicine in Govt. Medical Colleges by utilising the surplus capacity available vis-à-vis MCI norms.

The Postgraduate Committee considered the Central Govt. letter dated 19.09.2005 together with report of the Sub-Committee constituted in the matter and decided to approve the following report of the Sub-Committee:-

“The present Committee has been constituted by the President (Acting), Medical Council of India in terms of the authorization made by the Executive Committee of the Council along with members of the Adhoc Committee appointed by the Hon'ble Supreme Court in the meeting of the Committee held on 30.12.2004 wherein letter dated 17.8.2004 received from the Director, Govt. of India, Ministry of Health & F.W. was considered.

The Executive Committee decided that the said letter should be placed before the next meeting of the General Body of the Council. The Executive Committee further decided that regarding starting of DNB courses already approved by the National Board of Examination in the teaching institutions, a Sub-Committee be constituted to go through in detail about the academic fall-outs of the said decision.

The meeting of the Committee was held on 6<sup>th</sup> June,2005 at 11.00 a.m. in the office of the Council. Upon careful scrutiny and perusal of the relevant documents that have been brought out before the Committee, the Committee thought it appropriate to take stock of chronological details of the events that have taken place in the past. They are catalogued here-in-below for ready reference:-

- The General Body of the Council at its meeting held on 17.10.1993 on the basis of approved recommendation of the Postgraduate

Committee decided as under:-

*“It is recommended that for teaching appointments in the broad specialities the holders of Diplomate NBE should have at least 1(one) year teaching experience as a Tutor/Registrar/Demonstrator or equivalent post in a recognized medical college imparting undergraduate teaching and training for appointment as Lecturer. Regarding the candidates holding Diplomate NBE in superspeciality subjects, the training shall be for 2 (two) years in a recognized medical college having recognized postgraduate medical degree in the concerned speciality for appointment as a Lecturer.”*

- The matter of eligibility of DNB qualification holder for admission to DM/M.Ch. courses was deliberated in the PG Committee meeting held on 28.11.1994 wherein the Committee extended provision of “two years teaching experience in a recognized medical college having recognized postgraduate medical degree in the concerned speciality applicable to DNB holder for being eligible for appointment as Lecturer’, as referred to in the decision of the General Body of the Council at its meeting dated 17.10.1993.
- Further, the Postgraduate Committee of the Council at its meeting held on 10.9.1998 considered the issue of equivalence of DNB qualifications with that of MCI recognized MD/MS or DM/M.Ch. qualifications and decided that for teaching appointments in the broad specialities, DNB qualification holder with one year teaching experience as a Tutor/Registrar/Demonstrator or equivalent post in a recognized medical college imparting undergraduate teaching and training can be appointed. Further, with regard to holders of DNB qualification in superspeciality subjects, the required training shall be of 2(two) years in a recognized medical college having recognized postgraduate course in the concerned speciality can be appointed as Lecturer. The aforesaid decision of the PG Committee dated 10.9.1998 was approved by the General Body of the Council at its meeting held on 29.10.1998.
- Further, the Postgraduate Committee upon consideration of a letter dated 07.02.2002 from the Ministry of Health & F.W. forwarding therewith a copy of letter dated 28.12.2002 from President, National Board of Examination in regard to consideration of DNB qualifications granted by National Board of Examination as equivalent to postgraduate MD/MS or DM/M.Ch. degrees, in its meeting dated 16.9.2002 constituted a Sub-Committee of 3 members namely Dr. B.Ray Chaudhuri, Chairman with Dr. Subhash Penkar and Dr. G. Sham Sunder as members to consider the matter in all its aspects.
- Due to sad demise of Dr. B. Ray Chaudhuri, Chairman of the Sub-Committee, Dr. L.S. Chawla was appointed as Chairman in his place. The Committee submitted its report on 12.5.2003 which was considered by the General Body of the Council in its meeting held on 20.10.2003 wherein the recommendations of the Sub-Committee were approved by the Council. The reasons included in the said report facilitated in drafting of the conclusion approved by the General Body are catalogued as under:-
  - (a) The reasons for not equating DNB degrees with MD/MS/DM/M.Ch. are as follows:-
    - (1) Admissions to DNB course is only by qualifying examination whereas admission to postgraduate course is by competent examination in all States and for all colleges.
    - (2) A definite teaching faculty along with other infrastructural facilities as prescribed in the regulations governing the postgraduate education by the Council has to be made whereas for DNB training the faculty possessing required teaching experience is not a pre-requisite. Moreover, the said courses by and large are conducted in non-teaching hospitals and are under the supervision of consultants who are by and large not eligible to be qualified teacher in terms of MCI regulations.

- (3) The facilities of basic sciences training which is essential and vital for postgraduate teaching and training is non-existent in such non-teaching hospitals. Some facilities of para-clinical departments like Pathology, Microbiology, Biochemistry may be available but the facilities of pre-clinical and other para-clinical departments namely that of Anatomy, Physiology, Community Medicine, Forensic Medicine are non-existent. The said facilities even in case where they are available are 'service oriented' and not 'teaching oriented'.
  - (4) The candidates possessing postgraduate courses i.e. MD/MS/DM/M.Ch. in recognized teaching institutions are trained in hospitals attached to such institutions where the clinical material is available in terms of variety and quantity sufficient enough for imparting of the hands on training to the postgraduate students. On the other hand the DNB candidates are training on paying beds which mainly cater to private patients and insufficient hands on training is imparted resulting in defeat the very purpose of practical training for the postgraduate students.
  - (5) The regular teaching institutions have a multi-disciplinary approach for orientation of the postgraduate trainees whereby they have a wider interaction with different aspects of medicine whereas the training of DNB students for want of required facilities as are available in a medical college are denied of this multi-disciplinary approach of teaching and training.
  - (6) The postgraduate teachers as contemplated by the Medical Council of India are to be whole-time in nature whereas the teaching and training conducted for DNB courses is by and large by consultants who are either part-time or are honorary in nature.
  - (7) The students training for MD/MS is for 3 years duration and as of now is residential in character. Such a situation is not applicable in regard to the trainees for DNB courses.
- The regulations on Postgraduate Medical Education, 2000 mandates 3 years teaching experience with recognized postgraduate qualification as minimum eligibility for admission of a person as Lecturer/Assistant Professor in a medical college. One year teaching experience after broad speciality and 2 years experience after superspeciality for DNB candidates does not equate them with such a prescribed eligibility for want of 3 years experience gained by a regular postgraduate student in a teaching institution during the period of his postgraduate training. This limitation cannot be overcome in any mode and manner at any given point of time until and unless the concerned degree holders are required to work as a resident for 3 years all over again on residential basis in a teaching institution.
  - The concept in regard to utilization of the unutilized facilities in medical college was also deemed to be incorrect as the intake capacity in the postgraduate courses is fixed commensurate with the available teaching faculty, clinical material and infrastructural facilities available which are necessary for maintaining desired standards of training and hence there is nothing which can be said to be an unutilized/surplus component.
  - The said matter has been dealt adequately by the General Body of the Council at its meeting held on 26.03.2005 wherein it was unanimously decided that the position adopted by the Council in this case be reiterated.
  - Coming to the question of approval/renewal of the DNB courses in teaching institutions, the idea which has been canvassed is maintenance of 1:1 postgraduate teaching student ratio.

- The Committee is aware that there could be situations where the number of postgraduate seats may not be commensurate with the number of available postgraduate teachers. As a matter of fact, the Postgraduate Regulations, 2000 prescribes a ceiling on the number of students permissible in a teaching unit. As per the governing regulations against a teaching unit which ought to have a complement of 3 teachers that the first unit being headed by a person not below the rank of Professor along with a Associate Professor and Assistant Professor and the subsequent unit, if any, to be headed by the person not below the rank of Associate Professor along with 2 Assistant Professors/Lecturers being a minimum must.
- Constituting a possibility that in unit 1 all the 3 professors constitutes the teaching complement are recognized postgraduate teachers yet the number of students that can be registered with degree against the said unit shall be 2 per year and in case of diploma it would be one diploma per unit in addition to the 2 degree students. Thus in any case the total number of registration of degree and diploma taken together in one unit in one year shall not exceed 3 (2+1) provided 3 postgraduate teachers are available. In subjects which do not have diploma against the available 3 teachers still the number of registered students shall be restricted to 2 per year.
- At the cost of repetition, the Committee would like to emphatically said that teacher taught ratio is not the only parameter which is viewed in isolation for the purposes of according permission of starting of postgraduate courses or augmenting of its annual intake, the other parameters like infrastructural facilities, clinical material, teaching and training facilities are also given equal emphasis in a holistic manner.
- Prescribing of the upper limit of the permissibility of the annual intake is not only intake of teacher student ratio of 1:1 but also is aimed at having a ratio with number of teaching unit.
- In this context, it may be noted that a minimum bed strength is prescribed for a postgraduate teaching unit which is of minimum 30 beds in case of broad speciality and 20 beds in case of super speciality. Meaning thereby that in a unit with postgraduate teachers wherein only degree course is permitted with an annual intake of 2 seats and the duration of the course being 3 years, the number of postgraduate students shall be 6 at a given point of time with ratio of bed strength or student ratio is 1:5. Therefore, the governing ratio automatically the teachers are to taught is also tagged with bed strength: the student.
- The Committee is conscious of the fact that the bed strength does not contemplate number of beds but the patients of desired variety facilitating the appropriate orientation in regard to hands on training. An emphasis is also prescribed in regard to the daily overall clinical material and the prescribed bed strength viewed in the form of occupancy rate. By and large the governing practice adopted by the Council is that a minimum of 80% occupancy is a must for granting of permission for postgraduate course.
- All these parameters have been prescribed by the Council upon due application of mind with required emphasis on the standards of teaching and training at the postgraduate level whereby the postgraduate students is upto the desired level in terms of being able to discharge the prescribed competence catalogued in the regulations. The stringent parameters that have been prescribed are solely made to ensure on maintenance and adherence of the academic standards governing teaching and training for the postgraduate students.
- Taking note of these considerations, the General Body of the Council had emphasized that all efforts need to be taken to ensure that no duplication takes place in regard to the streams including modalities of admissions, teaching and training methods and also availing of the available infrastructure in an institution.
- The academic fall-outs therefore out of a liberal approach would be causing a definite prejudice to the standards and legitimate expectations out of a well structured postgraduate teaching programme. As such, the Committee taking stock of it is of the

considered opinion that the position adopted by the General Body of the Council in regard to non-grant of permission for running of DNB courses in recognized teaching institutions needs to be maintained in the larger academic interest and standards of postgraduate medical education in the country.

**138. Inclusion of DM/PDCC courses in Cardiac Anaesthesia for commencement the course in LPS Instt. of Cardiology, GSVM Medical College, Kanpur.**

Read : the letter dated 5/9/2005 received from Dr. J.L. Sahni, Professor Director, LPS Instt. of Cardiology, GSVM Medical College, Kanpur for inclusion of DM/PDCC programme in Cardiac Anaesthesia at LPS Instt.

The Postgraduate Committee considered the letter dated 05.09.2005 received from Dr. J.L. Sahni, Professor Director, LPS Instt. of Cardiology, GSVM Medical College, Kanpur for inclusion of DM/PDCC programme in Cardiac Anaesthesia at LPS Instt. and decided that Dr. V. Kanagaraj in consultation with experts in this regard should furnish detailed observations for further consideration of the Postgraduate Committee.

**139. Increase of seats in M.Ch.(Surgical Oncology) course K.G. Medical College, Lucknow affiliated to King George's Medical University, Lucknow u/s 10A of the IMC Act, 1956.**

Read : the letter dated 31/8/2005 received from the Registrar, King George's Medical University, Lucknow to permit one extra seat in M.Ch.(Surgical Oncology) at K.G. Medical University, Lucknow for the session 2006 in view of the urgent necessity of the University.

The Postgraduate Committee considered the letter dated 31.08.2005 received from the Registrar, King George's Medical University, Lucknow and decided to advise the institute to apply through the Central Govt. u/s 10A of the I.M.C. Act,1956 for increase of seats in M.Ch.(Surgical Oncology) course.

**140. Recognition of M.D.(General Medicine) qualification in respect of B.P. Koirala Institute of Health Sciences, Dharan, Nepal.**

Read : the Council Inspector's report (September, 2005) on the standard of examination and other teaching facilities available at B.P. Koirala Institute of Health Sciences, Dharan, Nepal for recognition of MD(General Medicine) qualification.

The Postgraduate Committee while considering the matters regarding recognition of various postgraduate courses in respect of B.P. Koirala Institute of Health Sciences, Dharan, Nepal noted as under:-

1. That the college is admitting the students in MBBS course in the current year over and above the sanctioned intake of 50 students as pointed out in the inspection reports carried out by the Council Inspectors.
2. The applications are considered u/s 12(2) of the I.M.C. Act which governs reciprocity.

In view of above, the Committee decided that the factual position in regard to point No. 1 be ascertained from the college authorities with copy to Nepal Medical Council.

200. **Starting of MD(Derm., Vene., & Leprosy) & DDVL courses at Academy of Medical Sciences, Pariyaram affiliated to Kannur University u/s 10A of the IMC Act, 1956-consideration of compliance regarding.**

Read: the compliance verification report (Oct., 2005) together with the compliance and Council Inspectors report (April, 2004) on the physical and other teaching facilities available at Academy of Medical Sciences, Pariyaram for consideration of starting of MD(Derm., Vene., & Leprosy) & DDVL courses.

The Postgraduate Committee considered the Council Inspectors report (Nov., 2005) together with the compliance and Council Inspectors report (April, 2004) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Derm., Vene., & Leprosy) & DDVL courses at Academy of Medical Sciences, Pariyaram affiliated to Kannur University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2006-2007 restricting the number of admission to 1(one) student per year in each course till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examination as per the provision of Section 11(2) of the Act, 1956.

201. **Starting of MS(ENT) & DLO courses at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act, 1956.**

Read: the Council Inspectors report (Nov., 2005) on the physical and other teaching facilities available at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada for consideration of starting of MS(ENT) & DLO courses.

The Postgraduate Committee considered the Council Inspectors report (Nov., 2005) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MS(ENT)

& DLO courses at Narayna Medical College, Nellore under NTR University of Health Sciences, Vijaywada u/s 10A of the IMC Act, 1956 because –

2. Promotion of Prof. & HOD is not as per MCI norms, resultantly teaching complement is incomplete.
3. Other deficiencies/observations as pointed out in the inspection report.

**202. SLP © No.219/2003 – Birender Singh Thind Vs. UOI & Ors.**

Read: SLP © No.219/2003 – BirenderSingh Thind Vs. UOI & Ors

The Postgraduate Committee noted that Shri Maninder Singh, Council Advocate vide his letter dated 25/10/2005 has stated that the case [SLP ( C ) No.219/2003 – Birender Singh Thind Vs. UOI & Anr.] was listed for final hearing before a bench comprising of Hon'ble Mr. Justice Y.K. Sabharwal, Hon'ble Mr. Justice B.N. Srikrishna and Hon'ble Mr. Justice R.V. Raveendran of the Hon'ble Supreme court on 19/10/2005.

It was submitted before the Hon'ble Supreme Court that as per the desire of the Hon'ble High Court the matter of the petitioner has been considered but the Council could not accede to his request for accepting his application u/s 26 of the Act with regard to his Ph.D. degree. Thereafter the Hon'ble Delhi High Court had dismissed the review petition which had filed by the petitioner.

After considering the matter and having regard to the contention raised on behalf of the petitioner, that he may be the only person seeking this benefit of acceptance of his Ph.D qualification received by him from the medical education in the erstwhile States of USSR, the Hon'ble Court has been pleased to direct Postgraduate Committee of the Council in the following terms:-

“.....We, however, feel that if the petitioner is the only case and there are not many doctors similarly placed as the petitioner, the Medical Council of India, having regard to the equities of the case, may sympathetically consider the question of recognizing the Ph.D. degree of the petitioner, in view of the fact that he has spend five years in Ph.D. course in Russia and it is a solitary case.

The learned counsel for the Medical Council of India submitted that the matter will have to be placed before the Post-graduate Committee and is likely to take some time.

Accordingly the PG Committee considered the matter in light of the observations by the Hon'ble Suprme Court and decided that it is not possible to accede to the request of the applicant seeking privileges u/s 26 of the IMC Act, 1956 on the strength of having done five years integrated Ph.D. course in Russia, in view of the stipulation in the notification issued by the Council dated 27<sup>th</sup> July, 1999 which provides that the said Ph.D. qualification shall be recognized in respect of students admitted for undergoing Ph.D. course upto the year 1989.

The above decision may be brought to the notice of the legal Counsel of the Medical Council of India for further necessary action in terms of the observations of the Hon'ble Supreme Court.
