The Postgraduate Committee noted the action taken on the various items included in the minutes of the meeting of the Postgraduate Committee held on 20/11/2006.

**3. Work output report of the requests received u/s 10A for the year 2006.**

The Postgraduate Committee noted the work output report of the requests received u/s 10A of the IMC Act, 1956 for the year 2006.

**4. Starting of M.D.(Community Medicine) course at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education(Deemed University) Manipal u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report(November 2006) on the physical and other teaching facilities available at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education(Deemed University) Manipal for consideration of starting of M.D.(Community Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the inspection report of inspection carried out by the Council Inspector's dated 20<sup>th</sup> & 21<sup>st</sup> November,2006 for continuance of recognition of MBBS course at Kasturba Medical College, Mangalore granted by Manipal Academy of Higher Education(Deemed University) and the decision of the Adhoc Committee and Executive Committee dated 02.12.2006 along with the inspection report (October,2006) carried out by the Council Inspector for starting of M.D.(Community Medicine) course and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Community Medicine) course at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education(Deemed University) Manipal u/s 10A of the IMC Act, 1956 because of the following:-

1. There is shortage of 1 Asstt. Prof. & 2 MSW as required for Additional teaching component for PG.
2. There is no Lecturer cum Medical Officer posted at RHTC/UHC having M.D.(PSM) qualification.
3. RHTC Moodabidri is under the financial & administrative control of Govt. of Karnataka. The college is allowed to utilize its facilities which is not as per MCI norms.
4. Promotion of second Prof. Dr. S. Jayarama is not as per MCI norms.
5. Resultantly, there is deficiency of one Professor & Epidemiologist.
6. Other deficiencies as pointed out in the inspection report.

**5. Starting of M.D.(Psychiatry) course at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (October 2006) on the physical and other teaching facilities available at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education (Deemed University) for consideration of starting of M.D.(Psychiatry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the inspection report of inspection carried out by the Council Inspector's dated 20<sup>th</sup> & 21<sup>st</sup> November, 2006 for continuance of recognition of MBBS course at Kasturba Medical College, Mangalore granted by Manipal Academy of Higher Education (Deemed University) and the decision of the Adhoc Committee and Executive Committee dated 02.12.2006 along with the inspection report (October, 2006) carried out by the Council Inspector for starting of M.D.(Psychiatry) course and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Psychiatry) course at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education (Deemed University) Manipal u/s 10A of the IMC Act, 1956 because of the following:-

1. 35 beds are split in 2 hospitals – i.e. 25 at Attawar & 10 at Wenlock Hospital which is not as per MCI norms. Required 30 beds in one unit are not available at either hospital.
2. Departmental Research Laboratory & Wardside Laboratory are not available.
3. OPD space is inadequate.
4. There is no space for workup of PG students.
5. Office space for faculty is inadequate.
6. There is no separate office room for HOD & other faculty.
7. Space available for ward is inadequate.
8. There are no facilities available for rehabilitation of improved patients.
9. Other deficiencies as pointed out in the inspection report.

**6. Starting of M.Ch.(Plastic Surgery) course at Kasturba Medical College, Manipal under Manipal Academy of Higher Education (Deemed University) Manipal u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (October 2006) on the physical and other teaching facilities available at Kasturba Medical College, Manipal under Manipal Academy of Higher Education (Deemed University) Manipal for consideration of starting of M.Ch.(Plastic Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the inspection report of inspection carried out by the Council Inspector's dated 17<sup>th</sup> & 18<sup>th</sup> November, 2006 for continuance of recognition of MBBS course at Kasturba Medical College, Manipal granted by Manipal Academy of Higher Education (Deemed University) and the decision of the Adhoc Committee and Executive Committee dated 02.12.2006 along with the inspection report (October, 2006) carried out by the Council Inspector for starting of M.Ch.(Plastic

Surgery) course and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch.(Plastic Surgery) course at Kasturba Medical College, Manipal under Manipal Academy of Higher Education(Deemed University) Manipal u/s 10A of the IMC Act, 1956 because of the following:-

1. The operative, outpatient & inpatient turnover & major operations show reduction in number of patients over the period of time.
2. OPD attendance is grossly inadequate (5/day). Resultantly, clinical material is inadequate.
3. Books in the departmental library are inadequate (10 books).
4. Other deficiencies as pointed out in the inspection report.

**7. Starting of M.D.(Radio Diagnosis) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.D.(Radio Diagnosis) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Radio Diagnosis) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Instrumentation is inadequate in terms of non-availability of MRI.
2. DSA Angiography is not available.
3. Two Assistant Professors namely Dr. Sumathy and Dr. Sundari do not possess recognized postgraduate qualification.
4. Resultantly, teaching complement is incomplete.
5. Other deficiencies as pointed out in the inspection report.

**8. Starting of M.D.(Dermatology Venereology & Leprosy) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.D.(Dermatology Venereology & Leprosy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.( Dermatology Venereology & Leprosy) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Promotion of Dr. Kumar, Professor & Head of the department is not as per MCI norms as he possesses experience of only 6 months as Associate Professor.
2. Resultantly, teaching complement is incomplete.
3. Foreign journals in the departmental library are not available.
4. Laboratory technician is not available.
5. Other deficiencies as pointed out in the inspection report.

**9. Starting of M.D.(Pharmacology) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.D.(Pharmacology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Pharmacology) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Additional teaching complement for postgraduate studies is not available in terms of 1 Associate Professor & 1 Assistant Professor.
2. Other deficiencies as pointed out in the inspection report.

**10. Starting of M.Ch.(Paediatrics Surgery) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.Ch.(Paediatrics Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch.(Paediatrics Surgery) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. There is no provision for Central O<sub>2</sub> and Suction.
2. There are no incubators.
3. Space for surgical NICU is inadequate.
4. Books and journals in the central library pertaining to speciality are inadequate. There are no books pertaining to the subject in the central library.
5. There are 29 books in the departmental library most of which are old editions. There are no journals except JIAPS.
6. Other deficiencies as pointed out in the inspection report.

**11. Starting of M.D.(Physiology) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.D.(Physiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Physiology) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Teaching component is inadequate for undergraduate in terms of 1 Assistant Professor.
2. Two Professors i.e. Dr. B.V. Rao & Dr. M. Tamilkodi, Three Associate Professors i.e. Dr. Vijayalakshmi, Dr. Pushpam & Dr. Thangam and 1 Asstt. Professor i.e. Dr. Balnaganandhini do not possess recognized postgraduate qualifications.
3. Additional teaching complement for postgraduate is not available.
4. Other deficiencies as pointed out in the inspection report.

**12. Starting of M.D.(Biochemistry) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November, 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.D.(Biochemistry) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Biochemistry) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Staff is insufficient even for undergraduate studies by 1 Associate Professor & 1 Assistant Professor.
2. Additional teaching complement for postgraduate is not available.
3. Other deficiencies as pointed out in the inspection report.

**13. Starting of MD(Paediatrics) course at Tirunelveli. Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of MD(Paediatrics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD(Paediatrics) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2007-2008 restricting the number of admission to 3 (Three) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act,1956.

**14. Starting of MS(Orthopaedics) course at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November 2006) on the physical and other teaching facilities available at Tirunelveli Medical College, Tirunelveli under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of MS(Orthopaedics) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to refer the matter of recognition of qualification of Dr. Ramguru, Professor & HOD and Dr. Ramkrishnan, Professor to the Teachers Eligibility Qualifications Sub-Committee of the Council as they possess postgraduate qualification –

M.S.(Ortho.) 1988 – from M.K. University which is not recognized but recognized under Dr. M.G.R. University

The Committee further decided to defer the consideration of the matter till then.

It was further decided that the office of the Council be directed to place all such cases wherein the teachers have acquired postgraduate qualifications during the period of interregnum between the parent university and the successor university wherein the qualifications from both the universities are recognized by the Council before the Teachers Eligibility Qualifications Sub-Committee of the Council and to place the items before the Postgraduate Committee along with the decision of the TEQ Sub-Committee.

**15. Starting of M.Ch.(Neuro-Surgery) course at Thanjavur Medical College, Thanjavur under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November, 2006) on the physical and other teaching facilities available at Thanjavur Medical College, Thanjavur under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.Ch.(Neuro-Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch.(Neuro-Surgery) course at Thanjavur Medical College, Thanjavur under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. 2<sup>nd</sup> Professor of Unit-I Dr. Sundar does not possess recognized postgraduate qualification.
2. Promotion of 2<sup>nd</sup> Professor Dr. Sundar & other Associate Professor in Unit-II Dr. R. Elangovan is not as per MCI norms.
3. Resultantly teaching complement is incomplete.
4. Other deficiencies as pointed out in the inspection report.

**16. Increase of seat in MD(Dermatology, Venereology & Leprosy) course at J.N. Medical College, Belgaum under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (October 2006) on the physical and other teaching facilities available at J.N. Medical College, Belgaum for increase of seats in MD(Dermatology, Venereology & Leprosy) course under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (October,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats in M.D.(Dermatology, Venereology & Leprosy) course at J.N. Medical College, Belgaum under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the I.M.C. Act, 1956 as the available clinical material is commensurate with the present intake of 1(one) student per year for the degree course.

The Committee further decided to direct the authorities of the institute to prospectively restrict the number of admissions in D.V.D./DDVL course with 1(One) student per year in conformity with the Regulations of the Council on Postgraduate Medical Education,2000 as there is only one unit in the department.

**17. Starting of M.Ch.(Surgical Gastroenterology) course at Thanjavur Medical College, Thanjavur under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November, 2006) on the physical and other teaching facilities available at Thanjavur Medical College, Thanjavur under The

Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.Ch.(Surgical Gastroenterology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch.( Surgical Gastroenterology) course at Thanjavur Medical College, Thanjavur under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Dr. Manoharan, designated as Professor & HOD was not physically present and hence could not be verified.
2. There is no Associate Professor.
3. Resultantly, teaching complement is incomplete.
4. Surgical workload is inadequate for in depth training.
5. Library facilities are inadequate.
6. Other deficiencies as pointed out in the inspection report.

**18. Starting of MS(Ophthalmology) course at Chengalpattu Medical College, Chengalpattu granted by The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November, 2006) on the physical and other teaching facilities available at Chengalpattu Medical College, Chengalpattu for consideration of starting of MS(Ophthalmology) course granted by The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MS(Ophthalmology) course at Chengalpattu Medical College, Chengalpattu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Equipments/instrumentation is inadequate as instruments like Fluorescein angiography equipment, Lasers, B. Scan, Applanation tonometer, Synaptophore, Prism etc. are not available.
2. Bed occupancy is inadequate (only 27.5%).
3. Facilities for retinal repair, keratoplasty and Eye bank are not available.
4. Other deficiencies as pointed out in the inspection report.

**19. Increase of seats in MS(General Surgery) course at Chengalpattu Medical College, Chengalpattu granted by The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November, 2006) on the physical and other teaching facilities available at Chengalpattu Medical College, Chengalpattu for consideration of increase of seats in MS(General Surgery) course granted by The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.S.(General Surgery) course at Chengalpattu Medical College, Chengalpattu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the I.M.C. Act,1956 prospectively i.e. from the academic session 2007-2008 from 1 (One) to 3 (Three) students per year till the first batch admitted against the increased number appears in the final examination of the said course.

**20. Starting of MD(Pharmacology) course at Coimbatore Medical College, Coimbatore under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (November, 2006) on the physical and other teaching facilities available at Coimbatore Medical College, Coimbatore under The

Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of MD(Pharmacology) course.

The Postgraduate Committee considered the Council Inspector's report (November, 2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Pharmacology) course at Coimbatore Medical College, Coimbatore under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

1. Some instruments like U.V. spectrophotometer, Physiograph vertex mixture, Magnetic Stirrer, Electrodes for nerve muscle stimulation which are required for postgraduate studies are not available.
2. For Animal House CPCSEA permission is under process.
3. Dr. S. Mohamed Mustafa, Associate Professor, does not possess recognized postgraduate medical qualification.
4. Other deficiencies as pointed out in the inspection report.

**21. Starting of MS(Orthopaedics) course at Coimbatore Medical College, Coimbatore under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report(November, 2006) on the physical and other teaching facilities available at Coimbatore Medical College, Coimbatore under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.S.(Orthopaedics) course.

The Postgraduate Committee considered the Council Inspector's report (November,2006) and decided to refer the matter of postgraduate qualifications of Dr. P.S. Shanmugam, Professor & HOD and Dr. N. Sekar, Associate Professor to the Teachers Eligibility Qualifications Sub-Committee of the Council.

The Committee further decided to defer the consideration of the matter till then.

It was further decided that the office of the Council be directed to place all such cases wherein the teachers have acquired postgraduate qualifications during the period of interregnum between the parent affiliating university and the successor affiliating university wherein the qualifications from both the universities are recognized by the Council before the Teachers Eligibility Qualifications Sub-Committee of the Council and to place the items before the Postgraduate Committee along with the decision of the TEQ Sub-Committee.

**22. Starting of MD(Radio Diagnosis) & DMRD courses at Era Lucknow Medical College, Lucknow under Dr. Ram Manohar Lohia University, Faizabad u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (October, 2006) on the physical and other teaching facilities available at Era Lucknow Medical College, Lucknow under Dr. Ram Manohar Lohia University, Faizabad for consideration of starting of MD(Radio Diagnosis) & DMRD courses.

The Postgraduate Committee considered the Council Inspector's report (October, 2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Radio Diagnosis) & DMRD courses at Era Lucknow Medical College, Lucknow under Dr. Ram Manohar Lohia University, Faizabad u/s 10A of the IMC Act, 1956 because of the following:-

1. Dr. B. Tiwary, Professor & Head of the department does not possess recognized postgraduate medical qualification.
2. Resultantly, teaching complement is incomplete.
3. Instrumentation is incomplete in terms of MRI, DSA Angiography, and Mammography.

1. General Surgery department has only one surgical table and one O.T.
2. There is no CT Scan.
3. Casualty needs to be strengthened.
4. There is no emergency trauma unit available exclusively for the department.
5. There is no Assoc. Prof. In Unit-I.
6. Unit-III & IV have only 2 teachers.
7. Resultantly, teaching complement is incomplete in Units-I, III & IV.
8. Other deficiencies as pointed out in the inspection report.

**28. Starting of M.D.(Dermatology, Venereology & Leprosy) course at D.Y. Patil Education Society (Deemed University) Medical College, Kolhapur u/s 10A of the IMC Act, 1956.**

4. Other deficiencies as pointed out in the inspection report.

3. Library facilities for the subject are inadequate.
4. Departmental museum is not available.
5. Audiovisual equipment is inadequate.
6. Other deficiencies as pointed out in the inspection report.

**33. Starting of MD(Microbiology) course at Alluri Sitharama Raju Academy of Medical Sciences, Eluru under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

The Postgraduate Committee considered the Council Inspector's report (September,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD(Microbiology) course at Alluri Sitharama Raju Academy of Medical Sciences, Eluru under NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act,1956 because of the following:-

1. Biosafety cabinets in the sections of Bacteriology, Virology & Mycology are not available.
2. Fluorescent microscopy is not available.
3. Washing room, media and sterilization facilities need to be improved.
4. Other deficiencies as pointed out in the inspection report.

**34. Starting of MD(TB & Resp. Diseases) course at Alluri Sitharama Raju Academy of Medical Sciences, Eluru under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (September, 2006) on the physical and other teaching facilities available at Alluri Sitharama Raju Academy of Medical Sciences, Eluru under NTR University of Health Sciences, Vijayawada for consideration of starting of MD(TB & Resp. Diseases) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (September, 2006) and decided to recommend to the Central Govt. to issue Letter of Intent for starting of MD(TB & Resp. **36. Madurai University, Madurai Kamraj University & The Tamilnadu Dr. M.G.R. Medical University, Chennai – Recognition of M.D.(Psychiatry) qualification in respect of students being trained at Madurai Medical College, Madurai.**

Read: The Council Inspector report (October, 2006) on the standard of examination and other teaching facilities available at Madurai Medical College, Madurai for purpose of recognition of M.D.(Psychiatry) qualification earlier granted by the Madurai University, Madurai Kamraj University & now by Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (October,2006) and decided to advise the institution authorities to re-organize the teaching units in terms of bed strength.

The Committee further decided to defer the consideration of the matter till then.

**37. Tamilnadu Dr. M.G.R. Medical University, Chennai – Recognition of M.Ch.(Genito-Urinary-Surgery/Urology) qualification in respect of students being trained at Stanley Medical College, Chennai.**

Read: The Council Inspector report (August, 2006) on the standard of examination and other teaching facilities available at Stanley Medical College, Chennai for purpose of recognition of M.Ch.(Genito-Urinary-Surgery/Urology) qualification granted by the Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (August,2006) and decided to recommend not to recognize M.Ch.(Genito-Urinary-Surgery/Urology) qualification granted by the Tamilnadu Dr. M.G.R. Medical University, Chennai in respect of students being trained at Stanley Medical College, Chennai because of the following:-

1. There is no Associate Professor in the Unit.
2. Resultantly, teaching complement is incomplete.
3. Other deficiencies as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.Ch.(Genito-Urinary-Surgery/Urology) course from the ensuing academic session 2007-2008.

**38. Gulbarga University & Rajiv Gandhi University of Health Sciences, Bangalore – Recognition of MD(Obst. & Gynae.) & DGO qualifications in respect of student being trained at Vijayanagar Institute of Medical Sciences, Bellary.**

Read: The Council Inspector's report (November, 2006) on the standard of examination and other teaching facilities available at Vijayanagar Institute of Medical Sciences, Bellary for purpose of recognition of M.D. (Obst. & Gynae.) & DGO

qualifications earlier granted by Gulbarga University & now by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (November, 2006) and decided to recommend not to recognize M.D. (Obst. & Gynae.) & DGO qualifications earlier granted by Gulbarga University & now by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Vijayanagar Institute of Medical Sciences, Bellary because of the following:-

1. There are 3 Units in 2 hospitals – 2 units in HQ hospital & 1 unit in college hospital. Teaching facilities are not adequate in HQ hospital. Ultrasound machine with vaginal probe is not available in HQ hospital.
2. Labour room is not equipped with central suction or central O<sub>2</sub>.
3. Equipment in critical area is inadequate.
4. Special clinics like Gynaecology Endocrine clinic, Semen bank etc. are not available.
5. Other deficiencies as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (Obst. & Gynae.) & DGO courses from the ensuing academic session 2007-2008.

**39. Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad – Approval of Nizam's Institute of Medical Sciences, Hyderabad for the award of D.M. (Neurology) qualification in respect of increased intake.**

Read: The Council Inspector's report (October, 2006) on the standard of examination and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for purpose of approval of the college for the award of D.M. (Neurology) qualification granted by Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad for the increased intake.

The Postgraduate Committee considered the Council Inspector's report (October, 2006) and decided to recommend that Nizam's Institute of Medical Sciences, Hyderabad be approved for the award of D.M.(Neurology) qualification granted by Nizam's Institute of Medical Sciences (Deemed University), Hyderabad restricting the number of admission to 4(four) students per year as there are 2 units and 5 postgraduate teachers.

**40. Rajiv Gandhi University of Health Sciences, Bangalore – Recognition of MD(Forensic Medicine) qualification in respect of student being trained at Al-Ameen Medical College, Bijapur.**

Read: The Council Inspector's report (November, 2006) on the standard of examination and other teaching facilities available at Al-Ameen Medical College, Bijapur for purpose of recognition of M.D. (Forensic Medicine) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (November, 2006) and decided to recommend not to recognize M.D.(Forensic Medicine) qualification granted by granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Al-Ameen Medical College, Bijapur because of the following:-

1. The teaching faculty is deficient even for undergraduate course by 1 Associate Prof.
2. Additional teaching component for postgraduate course is not available.
3. Standard of the candidate appearing for examination is very poor, casting doubt on the quality of postgraduate teaching being imparted.
4. Mortuary needs improvement in infrastructure.
5. Other deficiencies as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (Forensic Medicine) course from the ensuing academic session 2007-2008.

**41. Utkal University – Recognition of M.Ch.(Neuro-Surgery) qualification in respect of student being trained at S.C.B.Medical College, Cuttack.**

Read: The Council Inspector report (October, 2006) on the standard of examination and other teaching facilities available at S.C.B. Medical College, Cuttack for purpose of recognition of M.Ch.(Neuro-Surgery) qualification granted by Utkal University.

The Postgraduate Committee considered the Council Inspector report (October, 2006) and decided not to recommend recognition of M.Ch.(Neuro-Surgery) qualification in respect of students being trained at S.C.B. Medical College, Cuttack because of the following:-

1. There is no Assoc. Prof. in the Unit-I.
2. Resultantly, teaching complement is incomplete.
3. Operative workload is inadequate (major 1/day; minor Nil/day).
4. OPD runs only once a week where attendance is low (20/week).
5. Resultantly, Clinical Material is inadequate.
6. Other deficiencies as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.Ch.(Neuro-Surgery) course from the ensuing academic session 2007-2008.

**42. Patna University – Continuation of recognition of M.Ch.(Plastic-Surgery) qualification in respect of student being trained at Patna Medical College, Patna.**

Read: The Council Inspector report (November, 2006) on the standard of examination and other teaching facilities available at Patna Medical College, Patna for purpose of continuance of recognition of M.Ch.(Plastic-Surgery) qualification granted by Patna University.

The Postgraduate Committee considered the Council Inspector report (November, 2006) and decided to advise the institution to reorganize the unit in terms of bed strength as per MCI norms in the department of M.Ch.(Plastic-Surgery).

The Committee further decided to defer the consideration till the information is received.

**43. Calicut University – Recognition of D.M.(Neurology) qualification in respect of students being trained at Calicut Medical College, Calicut.**

Read: The Council Inspector report (April, 2004) togetherwith compliance verification report (November,2006) on the standard of examination and other teaching facilities available at Calicut Medical College, Calicut for purpose of recognition of D.M.(Neurology) qualification granted by Calicut University.

The Postgraduate Committee considered the Council Inspector report (April, 2004) togetherwith compliance verification report (November,2006) and decided to recommend that D.M.(Neurology) qualification granted by Calicut University in respect of students being trained at Calicut Medical College, Calicut be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admission to 1 (one) student per year.

**44. Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad – Approval of Nizam's Institute of Medical Sciences, Hyderabad for the award of M.D.(Anaesthesia) qualification in respect of increased intake.**

Read: The Council Inspector report (October, 2006) on the standard of examination and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for purpose of approval of the college for the award of M.D.(Anaesthesia) qualification granted by Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad for the increased intake.

The Postgraduate Committee considered the Council Inspector report (October, 2006) and decided not to approve Nizam's Institute of Medical Sciences, Hyderabad for the award of M. D.(Anaesthesia) qualification granted by Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad against the increased intake because –

1. Department does not have pre-anesthesia and pain clinics.
2. Dr. R. Chaturvedi was appointed external examiner for 4 consecutive years contrary to MCI Regulations. The same set of external examiners examined thesis contrary to MCI Regulations.
3. Current infrastructure of the department is heavily titled for conducting training programmes in super specialities.
4. Other deficiencies as pointed out in the inspection report.

The Committee further decided to seek an explanation regarding observations by the Inspector “apathetic attitude of the department of anesthesia and administration of the NIMS to this MCI inspection caused considerable difficulties in getting requisite information” from the institute authorities.

**45. Starting of M.D.(Radio-Diagnosis) course at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector report (November 2006) on the physical and other teaching facilities available at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education (Deemed University) for consideration of starting of M.D.(Radio-Diagnosis) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the inspection report of inspection carried out by the Council Inspectors dated 20<sup>th</sup> & 21<sup>st</sup> November, 2006 for continuance of recognition of MBBS course at Kasturba Medical College, Mangalore granted by Manipal Academy of Higher Education (Deemed University) and the decision of the Adhoc Committee and Executive Committee dated 02.12.2006 alongwith the inspection report (October, 2006) carried out by the Council Inspectors for starting of M.D. (Radio-Diagnosis) course at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education (Deemed University) Manipal u/s 10A of the IMC Act, 1956 and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D. (Radio-Diagnosis) course at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education (Deemed University) Manipal u/s 10A of the IMC Act, 1956 because of the following:-

1. Teaching faculty for UG is deficient by 1 Assoc. Prof.
2. Additional component for PG is not available.
3. Number of specimens & charts in the departmental museum are grossly inadequate. (8 specimens & 3 charts/Diagrams). Space for the museum is inadequate (10x10 sq.ft.)
4. Number of books in the departmental library are inadequate (70 books against the requirement of 80).
5. Other deficiencies as pointed out in the inspection report.



**46. Starting of M.D.(Psychiatry) course at Thanjavur Medical College, Thanjavur under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector report (November 2006) on the physical and other teaching facilities available at Thanjavur Medical College, Thanjavur under The Tamilnadu Dr. MGR Medical University, Chennai for consideration of starting of M.D.(Psychiatry) course u/s 10A of the IMC Act, 1956.

2. Faculty is not adequately qualified and experienced to teach the subject of PMR. None of the teachers have qualifications or any special experience in the subject of PMR.
3. Clinical material is inadequate. Daily OPD attendance is 10-12/day & operative load is 0.33-0.50/day (Major) & 0.3/day (Minor). The variety of clinical material is disproportionate as primarily the patients with only amputations and related problems are available. For other types of patient material required to teach PMR, it would be dependent upon other hospitals. The department at present does not cater to other patients required to provide clinical material.
4. Other deficiencies pointed out in the inspection report.

**73. Starting of Postgraduate courses in Anatomy, Physiology, Forensic Medicine & Community Medicine at Kameneni Instt. of medical sciences – request received from the college for Deferment of inspection for the year 2007-08.**

Read: The request received from the Principal, Kameneni Instt. of Medical Sciences to defer the inspection for starting of Postgraduate courses in Anatomy, Physiology, Forensic Medicine & Community Medicine to the next academic year i.e 2007-08.

The Postgraduate Committee considered the request received from the Principal, Kameneni Instt. of Medical Sciences for postponement of the inspection for starting of Postgraduate courses in Anatomy, Physiology, Forensic Medicine & Community Medicine MD (Forensic medicine) & DFM for the year 2007-08 and decided to return the applications to Govt. of India for their necessary action at their end.

**74. Increase of seats in MD(General Medicine) course at Govt. Mohan Kumaramangalam Medical College, Salem granted by The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956..**

Read: The inspection report (December, 2006) for Increase of seats in MD(General Medicine) course at Govt. Mohan Kumaramangalam Medical College, Salem granted by The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the inspection report (December, 2006) and decided to advise the institution to reorganize the unit in terms of a teaching faculty promotion of Prof. & HOD is not as per MCI norms in the department of MD (General Medicine).

The Committee further decided to defer the consideration till the information is received.

**75. Bombay University and Mumbai University – Recognition of D.G.O. qualification in respect of students being trained at Grant Medical College, Mumbai.**

Read: The inspection report November, 2006 for recognition of D.G.O. qualification granted by Bombay University / Mumbai University in respect of students being trained at Grant Medical College, Mumbai.

The Postgraduate Committee considered the inspection report (November,2006) and noted that the teaching complement is incomplete in the following units as under:-

1. Unit II at J.J. Hospital (KMA) is incomplete as there are only 2 teachers in the Unit.
2. Unit 1 at S.G. Hospital (MSP) is headed by Honorary teacher.
3. Unit II at S.G. Hospital (SSK) is incomplete as there is only 1 teacher in the unit.
4. Unit 1 at C.A. Hospital (SMT) is incomplete as there are only 2 teachers in the unit and they have not been given teaching designations.
5. Unit IV at C.A. Hospital (SPT) is incomplete as it is headed by Honorary teacher and there are only 2 teachers (including Honorary) in Unit.
6. Resultantly, there are only 4 complete units with 2 Professors, 6 Assoc. Prof. & 4 Asstt. Prof. against intake of 10 degree & 6 diploma students.

In view of above, the Committee decided to recommend that D.G.O. qualification granted by Bombay University / Mumbai University in respect of students being trained at Grant Medical College, Mumbai be recognized and included in the 1<sup>st</sup> Schedule to the IMC Act, 1956 restricting the number of admissions to 4 (four) students per year prospectively in commensurate with the number of available Postgraduate teachers in four units where teaching complement is complete.

The Committee further decided to direct the institution authorities to prospectively restrict the number of admissions in MD (Obst. & Gynae.) to 4(four) seats per year in commensurate with the number of available Postgraduate teachers in the units with complements of the teaching units from ensuing academic session 2007-2008.

The Postgraduate Committee taking note of the above decision of the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council and of the inspection report of the Council Inspectors dated 24<sup>th</sup> and 25<sup>th</sup> November, 2006 decided that an immediate fresh inspection be caused in respect of all on-going postgraduate courses at the said medical college for further consideration in the matter.

**95. Continuance of recognition of MBBS course at M.G.M. Medical College, Indore granted by Devi Ahilya Vishwavidyalaya, Indore.**



Read: The decision of the members of the Adhoc Committee appointed by the Hon'ble of the Supreme Court and of the Executive Committee of the Council on the subject mentioned above alongwith the inspection report of the Council Inspectors dated 27<sup>th</sup> and 26<sup>th</sup> November, 2006.

The Postgraduate Committee considered the matter at length and noted that the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and Executive Committee of the Council at its meeting held on 2.12.2006 observed that the deficiencies in terms of teaching faculty and infrastructure have worsened and the quantum of the deficiencies is much higher than that observed in 2003 inspection and decided to reiterate its decision taken at its meeting held on 28<sup>th</sup> July,2003 to recommend to the Central Government to withdraw the recognition of MBBS degree in respect of M.G.M. Medical College, Indore granted by Devi Ahilya Vishwavidyalaya, Indore as approved by the General Body of the Council at its meeting held on 20.10.2003 and recommended to the Govt. of India, Ministry of Health & F.W., New Delhi vide letter dt. 12.1.2004 for further necessary action u/s 19 of the IMC Act,1956 and requested the Central Government to direct the institute not to make any further admissions in the MBBS course w.e.f. academic year 2007-08.

The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council further directed the office to place the decision before the Postgraduate Committee for its consideration and necessary action.

The Postgraduate Committee taking note of the above decision of the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council and of the inspection report of the Council Inspectors dated 27<sup>th</sup> and 26<sup>th</sup> November, 2006 decided that an immediate fresh inspection be caused in respect of all on-going postgraduate courses at the said medical college for further consideration in the matter.

**96. Continuance of recognition of MBBS course at Kasturba Medical College, Manipal granted by Manipal Academy of Higher Education(Deemed University).**

Read: The decision of the members of the Adhoc Committee appointed by the Hon'ble of the Supreme Court and of the Executive Committee of the Council on the subject mentioned above alongwith the inspection report of the Council Inspectors dated 17<sup>th</sup> and 18<sup>th</sup> November, 2006.

The Postgraduate Committee considered the matter at length and noted that the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and Executive Committee of the Council at its meeting held on 2.12.2006 observed that the deficiencies of teaching faculty, teaching beds, distribution of units, availability of paramedical staff and other infrastructure are still persisting decided to reiterate its decision taken at its meeting held on 22.5.2002 and as approved by the General Body of the Council presided over by the Administrator at its meeting held on 27.8.2002 to recommend to the Central Government to initiate action u/s 19 of the Indian Medical Council Act,1956 for withdrawal of recognition of MBBS degree granted by Manipal Academy of Higher Education in respect of students being trained at Kasturba Medical College, Manipal and requested the Central Government to direct the institute not to make any further admissions in the MBBS course w.e.f. academic year 2007-08. It was further decided to request the Central Government to direct the institute not to teach and train the students of Malekka Manipal Medical College, Malaysia unless proof of creating additional facilities for training such students is submitted to the Central Government and prior permission of the Central Government is obtained for such an agreement.

The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council further directed the office to place the decision before the Postgraduate Committee for its consideration and necessary action.

The Postgraduate Committee taking note of the above decision of the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council and of the inspection report of the Council Inspectors dated 17<sup>th</sup> and 18<sup>th</sup> November, 2006 decided that an immediate fresh inspection be caused in respect of all on-going postgraduate courses at the said medical college for further consideration in the matter.

**97. Continuance of recognition of MBBS course at Kasturba Medical College, Mangalore granted by Manipal Academy of Higher Education(Deemed University).**

Read: The decision of the members of the Adhoc Committee appointed by the Hon'ble of the Supreme Court and of the Executive Committee of the Council on the subject mentioned above alongwith the inspection report of the Council Inspectors dated 20<sup>th</sup> and 21<sup>st</sup> November, 2006.

The Postgraduate Committee considered the matter at length and noted that the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and Executive Committee of the Council at its meeting held on 2.12.2006 observed that the deficiencies of teaching faculty, teaching beds, distribution of units, availability of paramedical staff and other infrastructure are still persisting decided to reiterate its decision taken at its meeting held on 22.5.2002 and as approved by the General Body of the Council presided over by the Administrator at its meeting held on 27.8.2002 to recommend to the Central Government to initiate action u/s 19 of the Indian Medical Council Act,1956 for withdrawal of recognition of MBBS degree granted by Manipal Academy of Higher Education in respect of students being trained at Kasturba Medical College, Mangalore and requested the Central Government to direct the institute not to make any further admissions in the MBBS course w.e.f. academic year 2007-08.

The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council further directed the office to place the decision before the Postgraduate Committee for its consideration and necessary action.

The Postgraduate Committee taking note of the above decision of the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council and of the inspection report of the Council Inspectors dated 20<sup>th</sup> and 21<sup>st</sup> November, 2006 decided that an immediate fresh inspection be caused in respect of all on-going postgraduate courses at the said medical college for further consideration in the matter.

**98. Starting of MD (Radio-Therapy) course at Madurai Medical College, Madurai under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.**

Read: The inspection report (December, 2006) for recognition/increase of seats in M.D. (Radio-Therapy) course at Madurai Medical College, Madurai under the Tamilnadu Dr. MGR Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (December,2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.( Radio-Therapy) course at Madurai Medical College, Madurai u/s 10A of the IMC Act, 1956 because of the following:-

1. Promotion of Prof. & Head Dr. Vasanthamalai is not as per norms as she possesses experience of only 1 year as Assoc.Prof.
2. Brachytherapy machine is not available. Individual shielding blocks and tissue compensation are not available. Resultantly, instrumentation is inadequate.
3. Diagnostic/therapeutic Radioactive isotope work is not available.
4. Other deficiencies as pointed out in the inspection report.

**99. Quantification of clinical material required for the different clinical subjects in the summary report.**

Read: The matter with regard to quantification of clinical material required for the different clinical subjects in the summary report.

The Postgraduate Committee considered the matter and decided to constitute a Sub-Committee of experts to go into the details with regard to quantification of clinical material required for the different clinical subjects and authorized the Chairman to constitute the Sub-Committee for different disciplines.

**100. N.T.R. University of Health Sciences, Vijayawada – Recognition/increase of seats in M.D.(TB & RD/Chest Diseases) course at Mamta Medical College, Khammam.**

Read: The Council Inspector's report (December, 2006) on the physical and other teaching facilities available at Mamta Medical college, Khammam alongwith the standard of examination held under NTR University of Health sciences, Vijayawada for its recognition for the award of M.D.(TB & RD/Chest Diseases) course and also increase of seats u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2006) and decided to recommend that M.D.( TB & RD/Chest Diseases) qualification granted by NTR University of Health Sciences in respect of students being trained at Mamta Medical College,Khammam be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admission to 1(one) student per year.

The Committee further decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats in M.D.( TB & RD/Chest Diseases) course at Mamta Medical College,Khammam under NTR University of Health Sciences u/s 10A of the I.M.C. Act,1956 as there are only 2 postgraduate teachers with recognized qualification and the institute is approved for annual intake of 1 degree and 1 diploma.

**101. N.T.R. University of Health Sciences, Vijayawada – Recognition/increase of seats in M.D.(Anaesthesia) course at Mamta Medical College, Khammam.**

Read: The Council Inspector's report (December, 2006) on the physical and other teaching facilities available at Mamta Medical college, Khammam alongwith the standard of examination held under NTR University of Health sciences, Vijayawada for its recognition for the award of MD (Anaesthesia) course and also increase of seats u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2006) and decided to recommend that M.D.(Anaesthesia) qualification granted by NTR University of Health Sciences in respect of students being trained at Mamta Medical College,Khammam be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 2(two) students per year.

The Committee further decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.D. (Anaesthesia) course at Mamta Medical College, Khammam under NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act,1956 prospectively i.e. from the academic session 2007-2008 from 2 (two) to 3 (three) students per year till the first batch admitted against the increased number appears in the final examination of the said course.

**102. N.T.R. University of Health Sciences, Vijayawada – Recognition/increase of seats in M.D.(Radio-Diag.) course at Mamta Medical College, Khammam.**

Read: The Council Inspector's report (December, 2006) on the physical and other teaching facilities available at Mamta Medical college, Khammam alongwith the standard of examination held under NTR University of Health sciences, Vijayawada for its

recognition for the award of M.D.(Radio-Diag.) course and also increase of seats u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2006) and decided to recommend that M.D.(Radio-Diag.) qualification granted by NTR University of Health Sciences in respect of students being trained at Mamta Medical College, Khammam be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 2(two) students per year.

The Committee further decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats in M.D.(Radio-Diag) course at Mamta Medical College, Khammam under NTR University of Health Sciences u/s 10A of the I.M.C. Act,1956 as the teaching faculty is sufficient only for present intake.

**103. N.T.R. University of Health Sciences, Vijayawada – Recognition/increase of seats in M.D.(Obst. & Gynae.) course at Mamta Medical College, Khammam.**

Read: The Council Inspector's report (December, 2006) on the physical and other teaching facilities available at Mamta Medical college, Khammam alongwith the standard of examination held under NTR University of Health sciences, Vijayawada for its recognition for the award of M.D.(Obst. & Gynae.) course and also increase of seats u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (December, 2006) and decided to recommend that M.D.(Obst. & Gynae.) qualification granted by NTR University of Health Sciences in respect of students being trained at Mamta Medical College, Khammam be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 3(three) students per year.

The Committee further decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in M.D. (Obst. & Gynae.) course at Mamta Medical College, Khammam under NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act,1956 prospectively i.e. from the academic session 2007-2008 from 3(three) to 4 (four) students per year till the first batch admitted against the increased number appears in the final examination of the said course as there are six postgraduate teachers with recognized qualifications and the institute has been granted recognition for DGO with intake of 2(two) seats.

**104. N.T.R. University of Health Sciences, Vijayawada – Recognition of MD(Pharmacology) course at Mamta Medical College, Khammam.**

Read: The Council Inspector's report (Dec., 2006) on the physical and other teaching facilities available at Mamta Medical college, Khammam alongwith the standard of examination held under NTR University of Health sciences, Vijayawada for its recognition for the award of M.D.(Pharmacology) course.

The Postgraduate Committee considered the Council Inspector's report (December,2006) and decided not to recognize M.D. (Pharmacology) qualification granted by NTR University of Health sciences, Vijayawada in respect of students being trained at Mamta Medical college, Khammam because the following deficiencies:-

1. Clinical Pharmacology Laboratory is not available.
2. Departmental animal house is not available.
3. The capacity of demonstration room is only 50 which is inadequate.
4. Departmental library needs to be upgraded as only 12 new books have been purchased in last three years.
5. Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (Pharmacology) course from the ensuing academic session.

**105. Starting of MS(Ortho.) & D.Ortho. course at Alluri Sitarama Raju Academy of Medical Sciences, Eluru under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

Read: The compliance together with the Council Inspector's report (September, 2006) on the physical and other teaching facilities available at Alluri Sitarama Raju Academy of Medical Sciences, Eluru under NTR University of Health Sciences, Vijayawada for consideration of starting of M.S.(Ortho.) & D.Ortho. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (September, 2006) and decided to verify the compliance by way of an inspection.

**106. Starting of MS(Ophthalmology) & D.O. courses at N.K.P. Salve Instt. of Medical Sciences & Research Centre, Nagpur under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956.**

Read: The compliance together with the Council Inspector's report (September, 2006) on the physical and other teaching facilities available at N.K.P. Salve Instt. of Medical Sciences & Research Centre, Nagpur under Maharashtra University of Health Sciences, Nashik for starting of M.S.(Ophthalmology) & D.O. courses u/s 10A of the I.M.C. Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (September, 2006) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(Ophthalmology) & DO courses at N.K.P. Salve Instt. of Medical Sciences & Research Centre, Nagpur under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2007-2008 restricting the number of admission to 1 (one) student in each course per year till the first batch admitted appears in the final examinations of the said courses. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**107. Starting of Postgraduate Courses at Vinayaka Mission's Kirupananda Variyar Medical College & Hospital, Salem under Vinayaka Mission's Research Foundation Deemed University – inspection date regarding.**

Read: The matter with regard to starting of various Postgraduate courses at Vinayaka Mission's Kirupananda Variyar Medical College & Hospital, Salem under Vinayaka Mission's Research Foundation Deemed University.

The Postgraduate Committee taking note on the letter dated 19.12.2006 received from the Dean of the college and decided to return the application recommending disapproval of the scheme to Govt. of India for necessary action at their end.

**108. Tribhuvan University – recognition of M.S. (General Surgery) qualification in respect of Institute of Medicine, Maharjunj, Kathmandu, Nepal.**

Read: The matter with regard to recognition of M.S. (General Surgery) qualification in respect of Institute of Medicine, Kathmandu along with letter dated 1/12/2006 received from the Dean, Tribhuvan University, Institute of Medicine, Harajgunj Kathmandu, Nepal.

The Postgraduate Committee considered the matter along with letter dated 1/12/2006 received from the Dean, Tribhuvan University, Institute of Medicine, Harajgunj Kathmandu, Nepal and decided not to recommend recognition of M.S. (General Surgery) qualification in respect of Institute of Medicine, Kathmandu because of the following:-

1. 2<sup>nd</sup> Prof. Dr. Mahesh Pd. Khakurel in Unit-I does not possess requisite postgraduate qualification as he has FRCS of March, 1981. Similarly, Dr. Pradeep Vaidya in Unit-I does not possess postgraduate qualification and has doctoral degree of 1996. Resultantly, teaching complement is incomplete in Unit-I.
2. Assoc.Prof. Dr. Mitra Lal Shrestha in Unit-II has passed his MS (General Surgery) examination in 2006 and hence he cannot be counted as an Assoc.Prof.
3. Promotion of Dr. Ishwar Lohani, Incharge of Unit-III is not as per MCI norms as he has been Asstt.Prof. for a period of 3 years and 6 months only. The 2<sup>nd</sup> Prof Dr. Yogendra Prasad Singh does not possess the requisite postgraduate degree in the speciality as he has a Ph.D. degree of 1998. Resultantly, teaching complement is incomplete in Unit-III.
4. Other deficiencies/remarks in the report.

**109. Himachal Pradesh University – Recognition of D.Ortho. qualification in respect of students being trained at Indira Gandhi Medical College, Shimla.**

Read: The compliance together with the previous inspection report (July, 2004 & Oct., 2006) with regard to recognition of D. Ortho qualification granted by Himachal Pradesh University in respect of students being trained at Indira Gandhi Medical college, Shimla.

The Postgraduate Committee considered the compliance together with the previous inspection report (July, 2004 & Oct., 2006) and decided to recommend that D. Ortho. qualification granted by Himachal Pradesh University in respect of students being trained at Indira Gandhi Medical College, Shimla be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 prospectively restricting the number of admission to 1(one) student per year as per Postgraduate Medical Education Regulations, 2000 as teaching complement is complete only in one unit as the promotion of Dr. Mukand Lal, Prof. and I/c Unit II, is not as per norms as he possesses experience of only 2 years as Assoc. Prof. and hence teaching complement in Unit II is incomplete.

**110. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of Fr. Muller Medical College, Mangalore for the award of M.D. (Radio-diagnosis) & D.M.R.D. qualification.**

Read: The compliance verification inspection report (Sept., 2006) along with the compliance and previous inspection report (May, 2005) for approval of Fr. Muller Medical College, Mangalore for the award of M.D.(Radio-diagnosis) and D.M.R.D. qualifications granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the compliance verification inspection report (Sept., 2006) along with the compliance and previous inspection report (May, 2005) and decided to recommend that Fr. Muller Medical College, Mangalore be approved for the award of M.D.(Radio-diagnosis) and D.M.R.D. qualifications granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admission to 1 (one) student each per year.

**111. Recognition of MS(Ortho.), MD(Obst. & Gynae.), MD(Anaesthesia), MS(Ophthalmology), MD(Paediatrics), MD(Radio-diagnosis) and MD(Dermatology, Venerology and Leprosy) qualifications granted by University of Mumbai in respect of Naval Medicine, Asvini, Mumbai – consideration of report of the Sub-Committee.**

Read: The report of the Sub-Committee dated 19/12/2006 for recognition of MS(Ortho.), MD(Obst. & Gynae.), MD(Anaesthesia), MS(Ophthalmology), MD(Paediatrics), MD(Radio-diagnosis) and MD(Dermatology, Venerology and Leprosy) qualifications granted by University of Mumbai in respect of Naval Medicine, Asvini, Mumbai.

The Postgraduate Committee approved the report of the Sub-Committee dated 19/12/2006 for recognition of MS(Ortho.), MD(Obst. & Gynae.), MD(Anaesthesia), MS(Ophthalmology), MD(Paediatrics), MD(Radio-diagnosis) and MD(Dermatology, Venerology and Leprosy) qualifications granted by University of Mumbai in respect of Naval Medicine, Asvini, Mumbai and decided as under:-

#### **MS (Ortho.)**

The Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 15.12.2003 in view of no communication received from the Institute of Naval Medicine in respect of MS (Ortho.) qualification in response to Council letter dated 1.1.2004 pointing out various deficiencies.

#### **MD (Obst. & Gynae.)**

The Postgraduate Committee decided to recommend that a fresh inspection be carried out for verification of the compliance in respect of INHS, Asvini, Mumbai.

#### **MD (Anaesthesia)**

The Postgraduate Committee decided to recommend that a fresh inspection be carried out for verification of the compliance in respect of INHS, Asvini, Mumbai.

#### **MS (Ophthalmology)**

The Postgraduate Committee decided to recommend that a fresh inspection be carried out for verification of the compliance in respect of INHS, Asvini, Mumbai.

#### **MD (Paediatrics)**

The Postgraduate Committee decided to recommend that M.D.(Paediatrics) qualification granted by University of Mumbai in respect of students being trained at Institute of Naval Medicine be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2(two) students per year.

#### **MD (Radio-Diagnosis)**

The Postgraduate Committee decided to recommend that M.D.(Radio-Diagnosis) qualification granted by University of Mumbai in respect of students being trained at Institute of Naval Medicine be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admission to 1(one) student per year.

#### **MD (Der.Ven. Lap.)**

The Postgraduate Committee noted that no communication has been received from the institute in response to Council letter dated 15.3.2006 and decided that the Institute may be requested again to inform the Council about the next date of practical examination of MD (Der.Ven. Lap.) qualification so that inspection of the said examination for the purposes of approval of MD (Der.Ven. Lap.) be arranged by this Council.

#### **112. Increase of seat in MS(Orthopaedics) course at J.N. Medical College, Belgaum under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (December, 2006) on the physical and other teaching facilities available at J.N. Medical College, Belgaum under Rajiv Gandhi University of Health Sciences, Bangalore for consideration of increase of seat in M.S.(Orthopaedics) course.

The Postgraduate Committee considered the Council Inspector's report (December, 2006) and decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats in MS (Orthopaedics) course at JN Medical College, Belgaum under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 because there are only 6 postgraduate teachers in the department with recognized qualifications and the institute is already recognized for annual intake of 3 degree and 3 diploma seats.

In view of above, the institution be directed to restrict the number of admissions prospectively to 3(three) students per year for diploma course in conformity with the Council Regulations on Postgraduate Medical Education Regulations, 2000.

**113. Increase of seats in MS(Orthopaedics) course at Kamineni Instt. Of Medical Sciences, Nalgonda granted by NTR University of Health Sciences u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (December, 2006) on the physical and other teaching facilities available at Kamineni Instt. Of Medical Sciences, Nalgonda for consideration of increase of seats in MS(Orthopaedics) course granted by NTR University of Health Sciences.

The Postgraduate Committee considered the Council Inspector's report (December, 2006) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MS(Orthopaedics) course at Kamineni Instt. of Medical Sciences, Nalgonda under NTR University of Health Sciences u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2007-2008 from 2(two) to 3 (three) students per year till the first batch admitted against the increased number appears in the final examination of the said course.

**114. Starting of DCH course at Santosh Medical College, Ghaziabad under Choudhary Charan Singh University, Meerut u/s 10A of the IMC Act, 1956.**

Read: The Council Inspector's report (December, 2006) on the physical and other teaching facilities available at Santosh Medical College, Ghaziabad under Choudhary Charan Singh University, Meerut for consideration of starting of D.C.H. course.

The Postgraduate Committee considered the Council Inspector's report (December, 2006) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of DCH course at Santosh Medical College, Ghaziabad under Choudhary Charan Singh University, Meerut u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2007-2008 restricting the number of admission to 2 (two) students per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act,1956.

**115. Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad – Approval of Nizam's Institute of Medical Sciences, Hyderabad for the award of M.S. (Orthopaedics) qualification in respect of increased intake.**

Read: The Council Inspector's report (December, 2006) on the standard of examination and other teaching facilities available at Nizam's Institute of Medical Sciences, Hyderabad for purpose of approval of the college for the award of M.S.(Orthopaedics) qualification granted by Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad for the increased intake.

(Orthopaedics) qualification granted by Nizam's Institute of Medical Sciences, (Deemed University) Hyderabad against the increased intake because –



1. There is no departmental museum.
  2. Departmental library facilities are inadequate.
  3. Office space for the faculty is inadequate.
  4. Other deficiencies/remarks in the inspection report.
