1. Minutes of the last meeting of the Postgraduate Committee – confirmation of.

The minutes of the Postgraduate Committee meetings held on 25.5.2006 were confirmed.

2. Madras University/The Tamilnadu Dr. MGR Medical University, Chennai – Approval of Chennai Medical College, Chennai for the award of M.D(Physiology) qualification.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities available for approval of Chennai Medical College, Chennai for the award of MD (Physiology) qualification granted by Madras University/The Tamilnadu Dr. MGR Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector report (March, 2007) and decided not to approve Chennai Medical College, Chennai for the award of MD (Physiology) qualification granted by Madras University/The Tamilnadu Dr. MGR Medical University, Chennai because of the following:-

1. Professor & Head does not possess requisite recognized postgraduate qualification.
2. Additional teaching component for PG is not available.
3. Other deficiencies as pointed out in the inspection report.

3. The Tamilnadu Dr. M.G.R. Medical Univerisity, Chennai- Recognition of MD (Dermatology, Venerology & Leprosy) & DDVL qualification in respect of students being trained at Madurai Medical College, Madurai.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities available for recognition of MD (Dermatology, Venerology & Leprosy) qualification granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Madurai Medical college, Madurai.

The Committee further decided to direct the institution authorities to stop admission in D.Ortho. course with immediate effect prospectively for want of the postgraduate teacher.

The Postgraduate Committee considered the Council Inspector report (March, 2007) and decided to recommend that Christian Medical College, Christian be approved for the award of MS (Anatomy) qualification granted by Madras University/The Tamilnadu Dr. MGR Medical University, Chennai restricting the number of admission to 1 (one) student per year.

6 The Tamilnadu Dr. M.G.R. Medical University, Chennai – Approval of Coimbatore Medical College, Coimbatore for the award of M.D(OBG) qualification.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities available for approval of Coimbatore Medical College, Coimbatore for the award of MD (OBG) qualification granted by The Tamilnadu Dr. MGR Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector report (March, 2007) and decided to recommend that Coimbatore Medical College, Coimbatore be approved for the award of MD (OBG) qualification granted by The Tamilnadu Dr. MGR Medical University, Chennai.

The Committee further decided to direct the institution authorities to restrict the number of admissions to 2 (two) students for degree & 3 (Three) students for diploma course per year prospectively against 3 Units.

7 Bhartihar University, Madras University and The Tamilnadu Dr. M.G.R. Medical University, Chennai – Approval of Coimbatore Medical College, Coimbatore for the award of DA qualification.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities available for approval of Coimbatore Medical College, Coimbatore for the award of DA qualification granted by Bhartihaar University, Madras University and The Tamilnadu Dr. M.G.R. Medical University, Chennai.

The Postgraduate Committee considered the Council Inspector report (March, 2007) and decided to recommend that Coimbatore Medical College, Coimbatore be approved for the award of DA qualification granted by Bhartihaar University, Madras University and The Tamilnadu Dr.

M.G.R. Medical University, Chennai restricting the number of admissions to 3 (three) students per year.

8 Madras University, Chennai – Approval of Dr. ALM Postgraduate Instt. of Medical Sciences, Taramani, Chennai for the award of MD (Pathology) & DCP qualification.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities available for approval of Dr. ALM Postgraduate Instt. of Medical Sciences, Taramani, Chennai for the award of MD (Pathology) & DCP qualification granted by Madras University, Chennai.

The Postgraduate Committee considered the Council Inspector's report (March, 2007) and decided to recommend that Dr. ALM Postgraduate Instt. of Medical Sciences, Taramani, Chennai be approved for the award of MD (Pathology) & DCP qualification granted by Madras University, Chennai restricting the number of admission to 1 (one) student per year in each course prospectively.

9 Mahatma Gandhi University–Recognition of D.M.(Nephrology) qualification in respect of students being trained at Medical College, Kottayam.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities for recognition of DM (Nephrology) qualification granted by Mahatma Gandhi University in respect of students being trained at Medical College, Kottayam.

The Postgraduate Committee considered the Council Inspector report (March, 2007) and decided to advise the institution authorities to reorganize the unit in terms of beds strength & teaching faculty as per MCI norms.

The Committee further decided to defer the consideration of the matter till the information is received.

10. Madurai, University, Madurai Kamraj University and The Tamilnadu Dr. MGR Medical University, Chennai – Recognition of MD (Microbiology) qualification in respect of students being trained at Madurai Medical College, Madurai.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities for recognition of MD (Microbiology) qualification granted by Madurai University, Madurai Kamraj University and The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Madurai Medical College, Madurai.

The Postgraduate Committee considered the Council Inspector report (March, 2007) and decided to recommend that MD (Microbiology) qualification granted by Madurai University, Madurai Kamraj University and The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Madurai Medical College, Madurai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2 (two) students per year.

11. Lucknow University, Chhatrapati Shahuji Maharaj Medical University, Lucknow and King George Medical University, Lucknow – Recognition of DMRD qualification and also continuance of recognition MD (Radio-diagnosis) qualification in respect of students being trained at KG Medical College, Lucknow.

Read: The Council Inspector report (April & May, 2007) on the standard examination and other teaching facilities for recognition of DMRD qualification and also continuance of recognition MD (Radio-diagnosis) qualification granted by Lucknow University, Chhatrapati Shahuji Maharaj Medical University, Lucknow and King George Medical University, Lucknow in respect of students being trained at KG Medical College, Lucknow.

The Postgraduate Committee considered the Council Inspector report (April & May, 2007) and decided not to recommend recognition of MD (Radio-diagnosis) qualification in respect of students being trained at KG Medical College, Lucknow because of the following:-

1. Teaching staff is insufficient even for undergraduate studies.
2. Instrumentation is inadequate in terms of Digital subtraction angiography & Intensifier Unit.
3. Other deficiencies as pointed out in the inspection report.

The Postgraduate Committee further decided to direct the college authorities to stop admissions with immediate effect for MD (Radio-diagnosis) course.

12. Lucknow University, Chhatrapati Shahuji Maharaj Medical University, Lucknow and King George Medical University, Lucknow – Recognition of MD (Microbiology) qualification in respect of students being trained at KG Medical College, Lucknow.

Read: The Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of MD (Microbiology) qualification granted by Lucknow University, Chhatrapati Shahuji Maharaj Medical University, Lucknow and King George Medical University, Lucknow in respect of students being trained at KG Medical College, Lucknow.

The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided not to recommend recognition of MD (Microbiology) qualification in respect of students being trained at KG Medical College, Lucknow because of the following:-

1. Dean is also Head of the Department.
2. Animal house facilities are inadequate.
3. Stock culture of Fungi is inadequate for PG training.
4. Conduct of examination is unsatisfactory.
5. Other deficiencies as pointed out in the inspection report.

13. Sher-I-Kashmir Instt. of Medical Sciences (Deemed University) Srinagar – Recognition of MD (Pathology) qualification in respect of students being trained at Sher-I-Kashmir Instt. of Medical Sciences, Srinagar.

Read: The Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of MD (Pathology) qualification granted by Sher-I-Kashmir Instt. of Medical Sciences (Deemed University) Srinagar in respect of students being trained at Sher-I-Kashmir Instt. of Medical Sciences, Srinagar.

The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided to recommend that MD (Pathology) qualification granted by Sher-I-Kashmir Instt. of Medical Sciences (Deemed University) Srinagar in respect of students being trained at Sher-I-Kashmir Instt. of Medical Sciences, Srinagar be recognised and included in the 1st Schedule to the Indian Medical Council Act, 1956 restricting the number of admission to 1 (one) student per year.

14. Sardar Patel University – Recognition of DVD/DDVL qualification in respect of students being trained at Pramukhswami Medical College, Karamsad.

Read: the Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of DVD/DDVL qualification granted by Sardar Patel University in respect of students being trained at Pramukhswami Medical College, Karamsad.

The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided to recommend that DVD/DDVL qualification granted by Sardar Patel University in respect of students being trained at Pramukhswami Medical College, Karamsad be recognised and included in the 1st Schedule to the Indian Medical Council Act, 1956 restricting the number of admission to 1 (one) student per year.

15. Sardar Patel University – Recognition of DCP qualification in respect of students being trained at Pramukhswami Medical College, Karamsad.

Read: The Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of DCP qualification granted by Sardar Patel University in respect of students being trained at Pramukhswami Medical College, Karamsad.

The Postgraduate Committee considered the Council Inspector report (April,2007) and decided to recommend that DCP qualification granted by Sardar Patel University in respect of students being trained at Pramukhswami Medical College, Karamsad be recognised and included in the 1st Schedule to the Indian Medical Council Act,1956 restricting the number of admissions to 2 (two) students per year.

16. Nizam’s Institute of Medical Sciences, (Deemed University) Hyderabad – Approval of Nizam’s Institute of Medical Sciences, Hyderabad for the award of M.S. (Orthopaedics) qualification in respect of increased intake.

Read: The compliance verification inspection report (April, 2007) alongwith the compliance and inspection report (November, 2006) for approval of Nizam’s Institute of Medical Sciences, (Deemed University) Medical College, Hyderabad for the award of M.S. (Orthopaedics) qualification granted by Deemed University.

The Postgraduate Committee considered the compliance verification inspection report (April, 2007) and decided to recommend that Nizam’s Institute of Medical Sciences, (Deemed University) Medical College, Hyderabad be approved for the award of M.S. (Orthopaedics) qualification granted by Deemed University restricting the number of admissions to 4 (four) students per year.

17. University of Bombay/Mumbai – Approval of Institute of Naval Medicine, INHS, Asvini, Mumbai for the award of M.S.(Ophthalmology) qualification –

Read: The Council inspector report (March, 2007) for approval of Institute of Naval Medicine, INHS, Asvini, Mumbai for the award of M.S. (Ophthalmology) qualification granted by University of Bombay/Mumbai.

The Postgraduate Committee considered the Council inspector report (March, 2007) and decided to recommend that Institute of Naval Medicine, INHS, Asvini, Mumbai be approved for the award of M.S. (Ophthalmology) qualification granted by University of Bombay/Mumbai restricting the number of admissions to 2 (two) students per year.

18. Banaras Hindu University – recognition of DM(Nephrology) qualification in respect student being trained at Institute of Medical Sciences, Varanasi.

Read: The compliance verification inspection report (March, 2007) alongwith the compliance and inspection report (July, 1999) for recognition of DM (Nephrology) qualification granted by Banaras Hindu University in respect of students being trained at Instt. of Medical Sciences, Varanasi.

The Postgraduate Committee considered the Council inspector report (March, 2007) and decided to recommend that DM (Nephrology) qualification granted by Banaras Hindu University in respect of students being trained at Instt. of Medical Sciences, Varanasi be recognised and included in the 1st Schedule to the Indian Medical Council Act,1956 restricting the number of admissions to 2 (two) students per year.

However, the attention of the authorities concerned be drawn towards the implementation of observations made by the Council Inspector in his inspection report.

19. Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University – Recognition of M.D. (Anaesthesia) & DA qualifications in respect students being trained at B.R.D. Medical College, Gorakhpur.

Read: The compliance verification inspection report (February, 2007) alongwith the compliance and inspection report (May, 2006) for recognition of MD (Anaesthesia) & DA qualification granted by Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur.

The Postgraduate Committee considered the compliance verification inspection report (February, 2007) and decided to recommend that MD (Anaesthesia) & DA qualification granted by Deen Dayal Upadhyaya Gorakhpur University/Gorakhpur University be recognised and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 3 (three) students for degree and 1 (one) student for diploma course per year prospectively.

20. Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University Recognition of M.D. (General Medicine) qualification in respect students being trained at B.R.D. Medical College, Gorakhpur.

Read: The compliance report alongwith the inspection report (May, 2006) for recognition of MD (General Medicine) qualification granted by Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur.

The Postgraduate Committee considered the compliance report (May, 2006) and noted that the compliance is unsatisfactory; decided to reiterate its earlier decision taken at its meeting held on 16.6.2006 recommending not to recognize MD (General Medicine) qualification granted by Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur as the following deficiencies are still persisting:-

1. There is no Assoc. Prof. in Unit I, as the present Assoc. Prof. is working in the Deptt. of Cardiology.
2. Unit II is also headed by Assoc. Prof. of Neurology.
3. As such, teaching complement continues to be incomplete in all the units.
4. Other deficiencies/observations as pointed out in the inspection report.

21. West Bengal University of Health Sciences, Kolkata – Recognition of M.D(SPM/Community Medicine) qualification in respect of students being trained at North Bengal Medical College, Darjeeling.

The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided to recommend that M.S/MD (Anaesthesia) qualification granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Burdwan Medical College, Burdwan be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admissions to 3 (three) students per year.

32. West Bengal University of Health Sciences, Kolkata – Recognition of MD (Forensic Medicine) qualification in respect of students being trained at NRS Medical College, Calcutta.

Read: The Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of MD (Forensic Medicine) qualification granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at NRS Medical College, Calcutta.

The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided not to recommend recognition of M.D (Forensic Medicine) qualification granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at NRS Medical College, Calcutta because of the following:-

1. Additional teaching component for postgraduate study is deficient.
2. Other deficiencies as pointed out in the inspection report.

33. West Bengal University of Health Sciences, Kolkata – Recognition of MD (Radio-therapy) qualification in respect of students being trained at Medical College, Calcutta.

Read: The Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of MD (Radio-therapy) qualification granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Medical College, Calcutta.

The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided to advise the institution authorities to reorganize the units in terms of bed strength as per MCI norms.

The Committee further decided to defer the consideration till the information is received.

34. The Tamilnadu Dr. MGR Medical University, Chennai – Approval of Stanley Medical College, Chennai for the award of M.D(Biochemistry) qualification.

Read: The Council Inspector report (March, 2007) on the standard examination and other teaching facilities for approval of Stanley Medical College, Chennai for the award of M.D(Biochemistry) granted by West Bengal University of Health Sciences, Kolkata for the increased intake.

The Postgraduate Committee considered the Council Inspector report (March, 2007) and decided to recommend that Stanley Medical College, Chennai be approved for the award of M.D(Biochemistry) qualification granted by West Bengal University of Health Sciences, Kolkata restricting the number of admissions to 2 (two) students per year.

35. RTM Nagpur University – Recognition of DPM qualification in respect of students being trained at Mahatma Gandhi Instt. of Medical Sciences, Sewagram, Wardha.

Read: The Council Inspector report (May, 2007) on the standard examination and other teaching facilities for recognition of DPM qualification granted by RTM Nagpur University in respect of students being trained at Mahatma Gandhi Instt. of Medical Sciences, Sewagram, Wardha.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend that DPM qualification granted by RTM Nagpur University in respect of students being trained at Mahatma Gandhi Instt. of Medical Sciences, Sewagram, Wardha be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admission to 1 (one) student per year.

36. RTM Nagpur University – Recognition of MS/MD (Anatomy) qualification in respect of students being trained at NKP Salve Instt. of Medical Sciences, Nagpur.

Read: The Council Inspector report (May, 2007) on the standard examination and other teaching facilities for recognition of MS/MD (Anatomy) qualification granted by RTM Nagpur University in respect of students being trained at NKP Salve Instt. of Medical Sciences, Nagpur.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend that M.S/MD (Anatomy) qualification granted by RTM Nagpur University in respect of students being trained at NKP Salve Instt. of Medical Sciences, Nagpur be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admission to 1 (one) student per year.

37. RTM Nagpur University – Recognition of MD (Physiology) qualification in respect of students being trained at NKP Salve Instt. of Medical Sciences, Nagpur.

Read: The Council Inspector report (May, 2007) on the standard examination and other teaching facilities for recognition of MD (Physiology) qualification granted by RTM Nagpur University in respect of students being trained at NKP Salve Instt. of Medical Sciences, Nagpur.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend that MD (Physiology) qualification granted by RTM Nagpur University in respect of students being trained at NKP Salve Instt. of Medical Sciences, Nagpur be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admissions to 2 (two) students per year.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend that M.S/MD (Anatomy) qualification granted by Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University in respect of students being trained at JLN Medical College, Swangi, Wardha be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admissions to 2 (two) students per year.

39. Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University – Recognition of MS(ENT) & DLO qualification in respect of students being trained at JLN Medical College, Swangi, Wardha.

Read: The Council Inspector report (May, 2007) on the standard examination and other teaching facilities for recognition of MS/MD (Anatomy) qualification granted by Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University in respect of students being trained at JLN Medical College, Swangi, Wardha.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend that M.S/MD (Anatomy) qualification granted by Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University in respect of students being trained at JLN Medical College, Swangi, Wardha be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admission to 1 (one) student per year in each course.

Dr. Ved Prakash Mishra rejoined the proceedings.

40. Sri Venkateswara Instt. of Medical Sciences (Deemed University), Tirupati – Recognition of MD (Anaesthesia) qualification in respect of students being trained at Sri Venkateswara Instt. of Medical Sciences, Tirupati.

Read: The Council Inspector report (May, 2007) on the standard examination and other teaching facilities for recognition of MD (Anaesthesia) qualification granted by Sri Venkateswara Instt. of Medical Sciences (Deemed University), Tirupati in respect of students being trained at Sri Venkateswara Instt. of Medical Sciences, Tirupati..

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend that MD (Anaesthesia) qualification granted by Sri Venkateswara Instt. of Medical Sciences (Deemed University), Tirupati in respect of students being trained at Sri Venkateswara Instt. of Medical Sciences, Tirupati be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admissions to 2 (two) students per year.

41. Nizam’s Institute of Medical Sciences, (Deemed University)– Approval of Nizam’s Institute of Medical Sciences, Hyderabad for the award of M.Ch. (Neuro-Surgery) qualification in respect of increased intake.

Read: The compliance verification inspection report (May, 2007) alongwith the compliance and earlier inspection report (December, 2006) for approval of Nizam’s Institute of Medical Sciences, Hyderabad for the award of M.Ch. (Neuro-Surgery) granted by Nizam’s Institute of Medical Sciences, (Deemed University)for the increased intake.

The Postgraduate Committee considered the compliance verification inspection report (May, 2007) alongwith the compliance and earlier inspection report (December, 2006) and decided to reorganize the units in terms of bed strength as per MCI norms.

The Committee further decided to defer the consideration till the information is received.

42. Delhi University – Recognition of MD (Psychiatry) qualification in respect of students being trained at Instt. of Human Behaviour and allied sciences, Delhi.

Read: The Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of MD (Psychiatry) qualification granted by Delhi University in respect of students being trained at Instt. of Human Behaviour and allied sciences, Delhi.

The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided to recommend that MD (Psychiatry) qualification granted by Delhi University in respect of students being trained at Instt. of Human Behaviour and allied sciences, Delhi be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admissions to 2 (two) students per year.

43. Rajiv Gandhi University of Health Sciences, Bangalore – Recognition of MD (Radio-diagnosis) qualification in respect of students being trained at Command Hospital, Air Force, Bangalore.

Read: The Council Inspector report (May, 2007) on the standard examination and other teaching facilities for recognition of MD (Radio-diagnosis) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Command Hospital, Air Force, Bangalore.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided not to recommend recognition of MD (Radio-diagnosis) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Command Hospital, Air Force, Bangalore because of the following:-

1. Promotion of HOD is not as per MCI norms.
2. Other deficiencies as pointed out in the inspection report.

44. Pt. Ravishankar Shukla University – Recognition of M.S.(ENT) & D.L.O. qualifications in respect of students being trained at Pt. J.N.M. Medical College, Raipur.

Read: The compliance verification inspection report (May, 2007) alongwith the compliance and earlier inspection report (May, 2006) for recognition of M.S.(ENT) & D.L.O qualification granted by Pt. Ravishankar Shukla University in respect of students being trained at Pt. J.N.M. Medical College, Raipur.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend that M.S.(ENT) qualification granted by Pt. Ravishankar Shukla University in respect of students being trained at Pt. J.N.M. Medical College, Raipur be recognized and included in the 1st schedule to the I.M.C.Act,1956 restricting the number of admission to 1 (one) student per year prospectively as there are only 2 PG teachers with recognized PG qualification and the institute is also running D.L.O. course which is yet to be recognized.

The Committee further decided that as no examination for DLO was held, the institute be advised to intimate to the Council the next date of DLO examination for further necessary action.

45. Nagpur University – Recognition of MS (Orthopaedics) and D. Ortho. Qualification in respect of students being trained at Mahatma Gandhi Instt. of Medical Sciences, Sevagram, Wardha.

Read: The matter with regard to recognition of MS (Orthopaedics) and D. Ortho. Qualification granted by Nagpur university in respect of students being trained at Mahatma Gandhi Instt. of Medical Sciences, Sevagram, Wardha alongwith recommendation of TEQ Sub-Committee.

The Postgraduate Committee approved the recommendations of the TEQ Sub-Committee regarding recognition of MS (Orthopaedics) and D. Ortho. Qualification granted by Nagpur University in respect of students being trained at Mahatma Gandhi Instt. of Medical Sciences, Sevagram, Wardha which is as under:-

“The TEQ Sub-Committee considered the report of the Sub-Committee dated 30.8.2006 constituted by the Postgraduate Committee of the Council at its meeting held on 16.6.2006 and noted that Dr.K.A. Paton does not possess recognized postgraduate qualification. The Sub-Committee decided that Dr. K.A. Paton is not eligible as he is having unrecognized qualification.”

In view of above, the Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 2.2.2000 and on 23.11.2005 as Dr. K.N. Patond, Prof. & Head of the department does not possess recognized postgraduate qualification prescribed as per Regulations.

46. SLP NO. 23605/2003 - Medical Council of India Vs. Vitthal & others in the Hon'ble Supreme Court of India.

Read: The letter dt. 26.03.07 received from the Govt. of India, Ministry of Health & Family Welfare, Nirman Bhavan, New Delhi in the above matter.

The Postgraduate Committee considered the letter dated 26.03.07 received from the Govt. of India, Ministry of Health & Family Welfare, Nirman Bhavan, New Delhi and decided to authorize the Chairman to constitute a Sub-Committee in the above matter.

47. K.J. Somaiya Medical college, Mumbai – To consider the inspection report (March, 2007) carried out for renewal of permission for increase of MBBS seats.

Read: The Council Inspector's report (March, 2007) carried out for renewal of permission for increase of MBBS seats at K.J. Somaiya Medical College, Mumbai.

The Postgraduate Committee considered the Council Inspector's report (March, 2007) and noted the decision of the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council at its meeting held on 2.4.2007 which is recorded hereunder: -

“The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council considered the Council Inspectors report (16th & 17th March, 2007) and noted the following:-

1.(a) *The shortage of teaching staff is 14.7% is as under:-*

- (i) Professors-3 (Biochemistry-1, PSM-1, Orthopaedics-1)
- (ii) Assoc.Profs.-3 (Physiology-1, Forensic Medicine-1, Orthopaedics-1)
- (iii) Asstt.Profs.-12 (Anatomy-2, Pathology-1, Forensic Medicine-1, PSM-2, General Medicine-3, Paediatrics-1, General Surgery-1, Radio-Diagnosis-1)
- (iv) Tutors-2 (Anaesthesia-2)

(b) *The shortage of Residents is less than 5% as under:-*

2. *Clinical material is grossly inadequate even for existing intake of 50 students as under:-*

3. *OPD: There is no registration counter separate for male & female patients. There are no separate teaching areas. There is no plaster cutting room.*
4. *Wards: There is no separate pantry, examination/procedure room, teaching area and the side laboratory. There is no seminar hall in the major departments. Teaching facilities are not as per Council norms.*
5. *Medical Education Unit is located in a small room. It is an empty room with one computer.*
6. *There is no separate OPD block. OPDs are conducted on different floors of the hospital building. Space is not adequate for all teaching activities in all the departments and also for central facilities.*
7. *Auditorium is available as a plain hall with a capacity of 350 seats which is not adequate and not as per Regulations.*
8. *There is no separate examination hall. Examinations are conducted in Lecture Theatres which is not as per Regulations.*
9. *In the animal house, air-conditioner is provided but was not found to be in use. The hygiene of the room in which the animals are kept is very poor and is stinking. Animals not available in the animal house are Rats & Large animals. Facilities for experimental work are not available.*
10. *The casualty has only 12 beds which is inadequate as per Regulations. There were no patients in the casualty on the day of inspection.*
11. *Health Centre: Bhayandar, RHTC is under the control of the State Govt. and the college is allowed to use its facilities for teaching purposes which is not as per norms. The PSM department organizes only teaching programmes and no field visits. Other clinical departments like Medicine, Pediatrics and Obst. & Gynae. Do not participate in the outreach teaching programmes. No lecturer cum Medical Officer having MD (PSM) is available. No hostel and messing facilities are available. Lecture hall cum seminar room is not available. Audiovisual aids have not been provided. Other basic investigations like HB, urine, x-ray & ECG are not available. Family welfare activities are not carried out. Field visits are carried out under the supervision of the Medical Officer off and on.
UHC: The PSM department does not organize teaching programmes and field visits. No lecturer cum medical officer having MD (PSM) is posted. Students visit only twice during their PSM posting and interns are posted in batches.*
12. *Two of the lecture theatres in the college have a capacity of only 80 each which is inadequate as per Regulations. Lecture theatres in the hospital is of level type with capacity of 60 which is not as per Regulations.*
13. *Hostel accommodation for boys & girls are grossly inadequate as under:-*

- *Accommodation is available only for 81 students against the requirement of 500 students at this stage. Hostels for students are located outside the campus at a distance of 4 kms. which is not as per Regulations.*

14. *Nurses accommodation is grossly inadequate as under:-*

- *On the 4th floor of the college building, 37 wooden partitioned rooms are provided for the interns and residents with a capacity of 111. Only cots have been provided. There is no other furniture.*
- *There is a combined hostel for interns & residents with a capacity of 1,1,1 which is grossly inadequate.*

15. *In the department of Radio-Diagnosis, CT scan is not available. There are only two mobile units against the requirement of six as per Regulations.*

16. *In the CSSD, glove inspection machine and instrument washing machine are not available. The receiving and distribution are not separate. Mixtures are not available. Adequate CSSD facilities are not available.*
17. *There is no separate ICCU, Medical & Surgical ICCU, and Burns ICU. There is a combined ICU with 8 beds which is not as per Regulations.*
18. *Total 6 quarters are available within the campus and two are available outside the campus at a distance of two kms. for the teaching faculty which are inadequate.*
19. *There are 7+1 (minor) operation theatres having total 9 tables which is inadequate for the present stage. There is no separate earmarked post operative ward; each OT has its own 2 -3 post operative beds.*
20. *In the department of Anatomy, the demonstration rooms do not have adequate seating arrangements. MRI, CT & X-rays are not displayed. The research laboratory is not equipped.*
21. *In the department of Physiology, there is no artificial light source in the Hematology laboratory. The clinical physiology laboratory is located in two different rooms and lacks required equipments. The research laboratory is not equipped.*
22. *In the department of Biochemistry, gas cylinders need to be kept away in a separate enclosure outside the laboratory with proper copper tubing. The research laboratory is not equipped.*
23. *In the department of Pharmacology, museum is located in a small room (150 sq.ft.). There is over-crowding of samples and display of samples needs to be reorganized. The department entrance is through the department of Microbiology.*
24. *In the department of Pathology, there is no seminar room.*
25. *In the department of Microbiology, the space for the museum is very small. There is no research laboratory.*
26. *In the department of Community Medicine, there is no preparation room for the laboratory. The research laboratory is not equipped. The museum needs to be upgraded and reorganized with new models, charts and catalogues. The capacity of the demonstration room is only 25 which is inadequate as per Regulations.*
27. *In the department of Forensic Medicine, there is no Research Laboratory. The mortuary is not as per Council norms. It is located in one room only.*
28. *Books in the departmental libraries of Skin & VD, Ophthalmology & ENT are not adequate.*
29. *Other deficiencies pointed out in the inspection report.*

In view of above, the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 9th batch of MBBS students against the increased intake i.e. from 50 to 100 for the academic session 2007-08 at K.J. Somaiya Medical College, Mumbai.

The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council further decided to disapprove the scheme and return the application to the Central Government as the institution has failed to provide adequate facilities required as per Regulations inspite of numerous attempts over a period of 8(eight) years and the same deficiencies have been observed consecutively for a period of more than 4 years.

The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council further decided to issue a show cause notice to the institute why the recognition for the award of MBBS degree should not be withdrawn u/s 19 of the IMC Act, 1956 and further decided to place the inspection report before the Postgraduate Committee."

The Postgraduate Committee taking note of the above decision of the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council and of the inspection report of the Council Inspectors dated 16th and 17th March, 2007 decided that an immediate fresh inspection be caused in respect of all on-going postgraduate courses at the said medical college for further consideration in the matter.

**48. Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati
- To consider the inspection report (January, 2007) carried out for continuance of
recognition of MBBS degree.**

Read: The Council Inspector's report (January, 2007) carried out for continuance of recognition of MBBS degree in respect of students being trained at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati.

The Postgraduate Committee considered the Council Inspector's report (January, 2007) and noted the decision of the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council at its meeting held on 5.2.2007 which are as under:-

"The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council considered the compliance verification inspection report (5th & 6th January, 2007) and noted the following:-

1. *The shortage of teaching faculty is as under:-*

(a) Shortage of teaching faculty is 9.91%.

i) Professor-02 (Biochemistry-1, Comm.Med.-1)

ii) Associate Professor-04 (Anatomy-2, For. Med.-1, Anaesthesia-1)

iii) Asstt. Professor-05 (Anatomy-1, Physiology-1, Pharma.Chemist-1, Lecturer in Epidimiology-1, Comm.Med.-1,)

iv) Tutor - 01 (Radiology-1)

(b) The shortage of Residents is more than 5% is as under:-

(i) Sr. Resident -06 (Peadiatric-2, TB & Chest-1, Surgery-2, Orthopaedics-1).

2. *Hostel accommodation is inadequate as it is available only for 336 students against the requirement of 500.*

3. *Interns hostel is not available.*

4. *Accommodation for only 66 residents is available against the requirement of 114 residents; thus it is inadequate.*

5. *Accommodation for nurses is grossly inadequate as only 10 double-seated rooms for accommodating 20 nurses are available.*

6. *Only 12 quarters are available within the campus for the teaching faculty, which are inadequate as per norms.*

7. *The following deficiencies are observed in the infrastructure of pre-clinical departments:-*

(i) Anatomy Department – Cooling cabinet is not functioning.

Dissection hall needs proper light.

Catalogues in the museum are not available.

MRI & CT Scan specimens are not available.

8. *The following deficiencies are observed in the infrastructure of para-clinical departments:-*

(i) Pathology Deptt.-Haematology practical laboratory is not provided artificial light for use of microscope.

9. *At RHTC, Labour room is not functional. Investigations facilities for basic laboratory Investigation, X-ray, ECG are not available. Transport is not provided to the students and staff by the institution for visiting these centers. Audio-visual aids are not provided.*

10. *At UHC, Lecturer cum Medical Officer having M.D(PSM) qualification is not posted. Pharmacist is not available. Duty rosters & record of various activities and*

investigations are not maintained properly. Transport is not provided to staff and students.

11. *Animal House is non-functional. No animals are available. Facilities for experimental work are not available. No staff is available for animal house. Facilities for carrying out minor surgical procedures are also not available.*
12. *The area available for library is only 630 sq.mt. which is inadequate against the requirement of 800 sq.mt.. Total number of journals subscribed are 13 Indian and 46 Foreign, which is inadequate against the requirement of 100 journals – 30 Indian and 70 foreign.*
13. *Common room for boys and girls are not available.*
14. *Only two lecture theatres are available in the college with capacity of 100 students each against the requirement of 3 lecture theatres of 120 capacity and one lecture theatre of 250 capacity.*
15. *The guidelines of Pollution Control Board for collection and segregation of hospital biomedical waste are not followed.*
16. *Kitchen is not available for patient, staff and students.*
17. *Central Sterilization department has only one room provided on the 2nd floor of the operation block. It has only one cylindrical autoclave. It runs from 8.00 a.m. to 12.00 noon and 2.00 p.m. to 6.00 p.m. in two shifts. No other equipments are available. There is no water connection/taps in the room. Daily an average of only 25 drums and 20 trays are prepared. The receiving and distribution points are not separate. Only one technician is available. CSSD needs improvement.*
18. *Only two static units of 500 M.A. and two mobile units are available which is inadequate in the Radiological department as per norms. CT scan is not available.*
19. *In the OPD space provided for examination of patients and accommodation for doctors are inadequate. Audiologist is not qualified. There is no minor OT and dressing room for surgical OPD.*
20. *There is overcrowding of beds in wards. Patients of tuberculosis, Skin & VD and Psychiatry are kept in the Medicine Ward which is not acceptable.*
21. *The registration counter for OPD and indoor admission registration counter are not computerized. The Medical Record Officer is not qualified. ICD X classification of diseases is not followed for indexing. Follow up service is not available.*
22. *There is no Central Oxygen and central suction facilities in casualty.*
23. *There are only 9 operation theatres against the requirement of 10 operation theatres.*
24. *Blood Bank has license for whole blood and blood components. It is under pathology department. License is valid upto 31.12.2000. Institution has applied for renewal of the license on 31.12.2002. The competent authority has inspected the blood bank on 21.4.2006. Reply from the authority is awaited.*
25. *Capacity of examination hall is only 110, which is inadequate against the requirement of 250 seats.*
26. *Books in the departmental libraries of Biochemistry, Microbiology, Forensic Medicine, TB & Chest, Skin & VD, Psychiatry, ENT, Anaesthesia and Dentistry are inadequate as per norms.*
27. *Other deficiencies/remarks in the report.*

In view of above, the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council decided to reiterate its earlier decision taken at its meeting held on 12th November, 2005 and as approved by the General Body of the Council at its meeting held on 18th Feb., 2006 to recommend to the Central Govt. to initiate action u/s 19 of the Indian Medical Council Act, 1956 for withdrawal of recognition of MBBS degree granted by Amravati University in respect of students being trained at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati and request the Central Government to direct the institute not to make any further admission in MBBS course w.e.f. academic year 2007-2008 .

The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council further decided that this report be placed before the Postgraduate Committee of the Council in respect of applications received from the institute for various postgraduate courses."

In view of above, the Postgraduate Committee decided to return the application to the Central Govt. recommending disapproval of the scheme for starting of P.G. courses at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati.

55. Manipur University – Recognition of MD (Dermatology, Venerology & Leprosy) qualification in respect of students being trained at Regional Instt. of Medical Sciences, Imphal.

Read: The Council Inspector report (April, 2007) on the standard of examination and other teaching facilities available at Regional Instt. of Medical Sciences, Imphal for purpose of recognition of MD (Dermatology, Venerology & Leprosy) qualification granted by Manipur University.

The Postgraduate Committee considered the Council Inspector's report (April, 2007) and decided to recommend that MD (Dermatology, Venerology & Leprosy) qualification granted by Manipur University in respect of students being trained at Regional Instt. of Medical Sciences, Imphal be recognized and included in the 1st Schedule to the I.M.C. Act,1956 restricting the number of admission to 1(one) student per year.

56. Rajiv Gandhi University of Health Sciences, Bangalore. - Approval of Sri Devraj Urs Medical College, Kolar for the award of M.D (Microbiology).

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at Sri Devraj Urs Medical College, Kolar for purpose of approval of the college for the award of M.D (Microbiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (May,2007) and decided to recommend that Sri Devraj Urs Medical College, Kolar be approved for the award of M.D.(Microbiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admission to 1(one) student per year.

57. Goa University – Recognition of MS (ENT) qualification in respect of students being trained at Goa Medical College, Panaji.

Read: The Council inspector report (April, 2007) on the standard of examination and other teaching facilities available at Goa Medical College, Panaji for purpose of recognition of MS (ENT) qualification granted by Goa University.

The Postgraduate Committee considered the Council Inspector's report (April, 2007) and decided to recommend not to recognize M.S. (ENT) qualification granted by the Goa University in respect of students being trained at Goa Medical College, Panaji because of the following:-

1. Dr. Sandesh Chodankar, Asstt.Prof. & Dr. Carnegie De Sa, Lecturer do not possess requisite postgraduate qualification.
2. Resultantly, teaching complement is incomplete in Unit-I.
3. Other deficiencies as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.S. (ENT) course from the ensuing academic session 2008-2009.

58. Rajiv Gandhi University of Health Sciences, Bangalore – Recognition of MS(Orthopaedics) qualification in respect of students being trained at Al-Ameen Medical College, Bijapur.

Read: The compliance verification report (April, 2007) togetherwith Council inspector report (June, 2006) on the standard of examination and other teaching facilities available at Al-Ameen Medical College, Bijapur for purpose of recognition of MS(Orthopaedics) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (April, 2007) togetherwith Council inspector report (June, 2006) and decided to recommend that MS (Orthopaedics) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Al-Ameen Medical College, Bijapur be recognized and included in the 1st Schedule to the I.M.C. Act,1956 restricting the number of admission to 1(one) student per year.

59. Starting of M.Ch.(Neuro-Surgery) course at Goa Medical College, Goa affiliated to Goa University u/s 10A of the IMC Act, 1956.

Read: The Council Inspector report (May, 2007) on the physical and other teaching facilities available at Goa Medical College, Goa for consideration of starting of M.Ch.(Neuro-Surgery) u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector report (May, 2007) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.Ch.(Neuro-Surgery) course at Goa Medical College, Goa under Goa University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2008-2009 restricting the number of admission to 1 (one) student per year till the first batch admitted appears in the final examination

of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

60. To consider the recommendations emerging from the National Review Meeting on Health held on 6th March, 2007 – letter received from Mrs. Aruna Sharma, Joint Secretary, National Human Rights Commission.

Read: The recommendations emerging from the National Review Meeting on Health held on 6th March, 2007 – letter received from Mrs. Aruna Sharma, Joint Secretary, National Human Rights Commission.

The Postgraduate Committee considered the letter received from Mrs. Aruna Sharma, Joint Secretary, National Human Rights Commission and noted the following recommendations emerging from the National Review Meeting on Health held on 6th March, 2007 pertaining to postgraduate medical education :-

- (1) It is necessary for Medical Council of India to have an inbuilt compulsory rural attachment and it may reduce number of years for postgraduate training.
- (2) It was also recommended that there is a need to develop 'Emergency Medicines' as a speciality to improve the emergency medical services in the country. The snakebites, dog bites and bleeding be included in emergency services and their respective treatment to be provided to all free of cost. In addition, approval should be given to use of Intradermal rabies vaccination in all facilities at the earliest to enable its universal free availability.

In view of above recommendations of National Human Rights Commission, the Postgraduate Committee decided to authorize the Chairman of the Committee to constitute a Sub-Committee for recommendation at serial number (1) and for recommendation at serial number (2) the Committee decided to refer the matter to Standing Sub-Committee of the Postgraduate Committee comprising Dr.(Mrs.) Sneh Bhargava and Dr. Indrajit Ray to go through in detail and place the report in the next meeting.

61. Jammu University – Recognition of MD (SPM/Community Medicine) qualification in respect of students being trained at Govt. Medical College, Jammu.

Read: The Council Inspector's report (May, 2007) on the standard of examination and other teaching facilities available at Govt. Medical College, Jammu for purpose of recognition of MD (SPM/Community Medicine) qualification granted by Jammu University.

The Postgraduate Committee considered the Council Inspector's report (May, 2007) and decided to recommend that MD (SPM/Community Medicine) qualification granted by Jammu University in respect of students being trained at Govt. Medical College, Jammu be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 4(four) students per year.

62. Devi Ahilya Vishwavidyalaya – Permitting intake in M.D. (SPM) course at MGM Medical College, Indore.

Read: The inspection report (March, 2007) on the physical and other teaching facilities available at MGM Medical College, Indore for purpose of fixing intake in MD (SPM) course.

The Postgraduate Committee considered the inspection report (March, 2007) for purpose of continuance of recognition u/s 19 of the IMC Act of M.D. (SPM) course at M.G.M. Medical College, Indore and noted the following:-

1. Additional teaching component is not available for PG.
2. There is no qualified Medical Record Officer in Medical Record department.
3. ICD IX classification is used for coding the deaths inspite of availability of ICD X classification since 1993.
4. There is deficiency of seating arrangement for UG & PG students in the laboratory.
5. Neither central library nor departmental library subscribe WHO periodicals/books.

6. UHC, Sanyogitaganj is overcrowded and is under the control of State Health department which is not as per Regulations.
7. There is no separate hostel facilities for boys and girls at RHTC.
8. There is no mess neither at RHTC nor UHC.
9. There is no transport facility
10. Other deficiencies/remarks are in the main report.

The Postgraduate Committee also noted that the following deficiencies were observed during the inspection carried out on 27th and 28th Nov. 2006 for continuance of recognition of MBBS degree:-

1. (a) The shortage of teaching faculty is 27.85% as under:
 - (i) Professor -02 (Pharmacology-1, Forensic Medicine-1)
 - (ii) Assoc.Prof. - 16 (Anatomy-2, Pathology-4, Microbiology-1, Pharmacology-3, Psychiatry-1, Surgery-4, PSM-1)
 - (iii) Asstt.Prof.-25 (Anatomy-3, Physiology-1, Lecturer in Biophysics-1, Biochemistry-1, Pathology-1, Microbiology-1, Pharmacology-1, Pharmaceutical Chemist-1, Forensic Medicine-2, PSM-1, Lecturer in Epidemiology-1, Medicine-3, Surgery-3, Obst. & Gynae.-1, ANMO-1, MWO-1, Radiology-2)
 - (iv) Tutor -18 (Anatomy-2, Pathology-2, Pharmacology-2, Radiology-5, Anaesthesia-7)
- (b) The shortage of Residents is 29.56% as under:-
 - i) Sr. Resident – 25 (Medicine-6, TB & Chest-1, Dermatology-1, Psychiatry-1, Paediatric-3, Surgery-6, Orthopaedic-3, ENT-1, Obst. & Gynae.-3)
 - ii) Jr. Resident-09 (Dermatology-3, Psychiatry-3, Ophthalmology-3)
2. Clinical material in terms of OPD attendance, bed occupancy and Radiological investigations is inadequate on the day of inspection as under:

3. Dr. D.K. Jain shown as Medical Superintendent is not qualified to hold the post of Medical Superintendent as he has 3 years of administrative experience against the requirement of 10 years.
4. Dr. V.K. Saini, Dean of the medical college is also holding the additional charge of Director of Medical Education which is not as per norms.
5. Distribution of teaching beds in different specialities is not as per Council recommendation. In the department of Psychiatry there are 164 beds (9 beds in MYH and 155 beds in Mental Hospital). All these beds are managed by the Psychiatry Department. The beds of TB & Chest and Dermatology are combined with those of medicine and these two are not separate specialities.
6. The composition of units in Medicine, Paediatrics, Surgery, Ophthalmology and Obst. & Gynae. is not as per norms of the Council as under:-

Medicine Department:

- Medicine Unit I is having 31 beds (Unit should not have more than 30 beds)
- Medicine Unit III is having one professor and one assistant professor (Unit should have 3 senior faculty members).
- Medicine Unit V is having one associate professor and one assistant professor (Unit should have 3 senior faculty members).
- Medicine Unit VI is having one associate professor and one assistant professor (Unit should have 3 senior faculty members).
- TB & chest and Dermatology departments are not separated from Medicine Department.
- Head of the Department of Medicine is Professor of TB & Chest department.

Pediatric Department:

- Unit I, II & III are having 34 beds each.
In addition to this 52 beds are common for all the three units.
Hence the total beds available in Pediatric department are 154 beds.

Surgery Department:

- Unit I is having 35 beds and two assistant professors (it is headed by Assistant Professors).
- Unit II is having 35 beds.
- Unit III is having 35 beds.
- Unit IV is having 32 beds and two assistant professors (it is headed by Assistant Professor)
- Unit V is having two assistant professors (it is headed by Assistant Professor)
- Unit VI is having two assistant professors (it is headed by Assistant Professor)

Ophthalmology Department:

- Unit I is having 31 beds, one professor and one assistant professor.
- Unit II is having one associate professor and one assistant professor.
- Unit III is having one associate professor.

Obstetrics & Gynecology Department:

- Unit I is having 52 beds.
- Unit II is having 37 beds and one assistant professor. (Unit is headed by Assistant Professor)
- Unit III is having 37 beds and one associate professor and one assistant professor.
- Unit IV is having 37 beds, one associate professor and one assistant professor.
- Unit V is having 37 beds, one associate professor and one assistant professor.

7. In the O.P.D. Teaching facilities like patient couch, stools, x-ray view box, examination tray, etc. are not available in all the rooms. There is no separate injection room for male and female patients. Injection room was without any emergency drugs. There is no minor O.T. There is a physiotherapy section. OPD is overcrowded and the space provided to different specialties for examination of patients, sitting of doctors & teaching is inadequate.
8. Most of the wards are not provided with duty doctor room, nurse duty room, pantry, examination/procedure room, teaching area and side laboratory. Nursing station is available in most of the wards but it is outside in most of the wards. In the ward bed-side teaching is carried out as there is no designated teaching area in any ward. There is overcrowding of the beds in most of the wards. Beds are numbered but in most of the wards unit distribution of the beds is not clearly mentioned. All the beds are not provided with side lockers. In one of the Medicine male ward patients of medicine, psychiatry & dermatology and TB & Chest are kept. The same situation is seen in one female medicine ward.
9. Some of the operation theatres are not air-conditioned which is not as per norms. Central oxygen & Nitrous oxide supply and central suction are not functional in any OT and they are under repairs.

10. The ICCU is not air conditioned. Central oxygen and central suction is not available in Medical ICU. There is no central oxygen or central suction. Equipments are grossly inadequate. Burns ICU is not available. There is no central suction and oxygen in Neonatal ICU at CNBC. Hospital.
11. CT Scan is not available. There is no 800 MA x-ray machine available.
12. In CSSD, ETO sterilization is not available.
13. Services of Dietician are not available. There is no provision for supply of diet as recommended by physician.
14. The para-medical staff is grossly inadequate as under:-

Laboratory Assistants: 05
Laboratory Attendants: 02
15. Nursing staff is inadequate as under:-
Nursing Superintendent: Nil
Deputy Nursing Superintendent: Nil
Matron 04
Asstt. Nursing Superintendent Nil
Nursing Sisters 32
Staff nurses 198
16. The auditorium has a capacity of only 425 seats against the requirement of 750.
17. The common room for girls does not have adequate furniture.
18. The accommodation for students in Hostels is available only for 337 students which is inadequate against the requirement of 700.
19. There is no hostel for working nurses.
20. In the central library, the number of journals subscribed are only 65 against the requirement of 100.
21. In the infrastructure of pre-clinical departments, the following deficiencies are observed:-

Anatomy Department:
2 demonstration rooms each having 75-100 seats are required.
Histopathology practical laboratory should have 90 workplaces.

Physiology Department:
Each demonstration rooms should have 75 seats.
All practical laboratories should have 90 workplaces each.

Biochemistry Department:
Two demonstration rooms of 75 seats each is required.
The practical laboratory should have 90 workplaces.
22. The following deficiencies are observed in the infrastructure of para-clinical departments:-
Pathology Department:
Histopathology laboratory should have 90 workplaces.
Clinical pathology lab should have 40 workplaces.
Microbiology Department:
Two demonstration rooms of 75 seats each are required.
Practical laboratory should have 90 workplaces.
Forensic Medicine Department:

Two demonstration rooms of 75 seats each are required.

Community Medicine Department:

Two demonstration rooms of 75 seats each are required.

The practical laboratory should have 90 workplaces.

23. In animal house, large animals are not available. Veterinary officer is part-time which is not as per norms.
24. At RHTC Harsola, messing facilities are not available. Audio-visual aids have not been provided.
25. At UHC, Lecturer-cum-Medical Officer having MD(PSM) qualification is not available.
26. In the medical record department, no qualified medical record officer available. ICD IX classification of diseases is followed for indexing which should be replaced by ICD X classification.
27. Central oxygen supply and central suction are not available in the casualty emergency area. It is not equipped with adequate equipments. Disaster trolley and crash cots are not available. There is no minor O.T. Space provided for casualty is grossly inadequate and there is over-crowding of beds.
28. Collection and segregation of hospital waste is not carried out as per pollution control board guidelines.
29. Other deficiencies/remarks are in the main report.

In view of above, the Postgraduate Committee decided to recommend to the Council for withdrawal of recognition of M.D. (SPM) course at M.G.M. Medical College, Indore granted by Devi Ahilya Vishwavidyalaya u/s 19 of the Indian Medical Council Act, 1956.

The Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (SPM) course from the academic session 2008-09.

63. Barkatullah University – Permitting intake in M.D. (SPM) course at Gandhi Medical College, Bhopal.

Read: The inspection report (Feb., 07) on the physical and other teaching facilities available at Gandhi Medical College, Bhopal for purpose of fixing intake in M.D. (SPM) course.

The Postgraduate Committee considered the inspection report (February, 2007) for purpose of continuance of recognition u/s 19 of the IMC Act of M.D. (SPM) course at Gandhi Medical College, Bhopal and noted the following:-

1. Staff is inadequate even for U.G studies.
2. As far as RHTC is concerned, administrative control is with the Dean while financial control is with D.H.O., Raisen. This dual control is not as per norms. There is no staff nurses at RHTC.
4. There is no vehicle.
5. Hostels are not available.
6. Other deficiencies/remarks are in the main report.

The Postgraduate Committee also noted that the following deficiencies were observed during the inspection carried out on 24th and 25th Nov. 2006 for continuance of recognition of MBBS degree:-

1. The shortage of teaching faculty is as under:-
 - (a) Faculty 40%
 - (i) Professor : 02 (TB & Chest-1, Microbiology-1)
 - (ii) Associate Professor: 22 (Anatomy -3, Physiology -3, Biochemistry- 1, Pathology -3, Microbiology -2, Forensic medicine-1, Medicine -1, TB & Chest-1, Pediatrics -1, Surgery -3, Radiology-1, Anaesthesia -1, Dentistry-1)
 - (iii) Assistant Professor: 32 (Anatomy -4, Physiology-2 Lecturer in Biophysics- 1, Biochemistry-2, Pathology-2, Microbiology-1,

Pharmacology- 3, Pharmachemist-1, Forensic Medicine – 1, PSM- 2, lecturer in epidimiology –1, Medicine-1, Psychiatry – 1, Peadiatric-2, Surgery-2, Orthopedics-2, ANMO-1, MWO –1, Radiology-1, Anaesthesia –1)

(iv) Tutor: 32 (Anatomy-3,Physiology-5, Biochemistry-1, Pathology-3, Pharmacology-1, Forensic Medicine-2, PSM-3, Radiology –5, Anaesthesia-8, Dentistry-1)

(b) Resident 25.8%

(i) Sr. Resident: 26(Medicine-6, TB & Chest –1,Dermatology-1, Psychiatry-1, Peadiatric-3, surgery-6, Orthopaedic-3, ENT-1, Ophthalmology-1, Obst. & Gynae.-3)

(ii) Jr. Resident: 08 (TB & Chest -2, Dermatology – 3, Psychiatry-3)

2. Bed occupancy is only 70% on the day of inspection, which is inadequate.
3. In the department of Obst. & Gynae. there are 235 teaching beds distributed in 3 units, which is not as per norms.
4. The unit composition in the departments of Pediatrics, Medicine, Skin & VD, Psychiatry & TB & Chest is inadequate as under:-
 - (a) Skin & VD : At present dermatology is under medicine department. There are no senior resident or junior resident. Dermatology department should be separated at from medicine.
 - (b) Psychiatry – Psychiatry Department is having only 1 Professor. No other teaching staff and no senior or junior resident.
 - (c)TB & Chest department is having only 1 assistant professor. No other teaching staff and no senior or junior resident.
5. There is no central registration counter in the OPD. Each speciality is having its own registration counter which is not as per norms.
6. Some of the rooms in OPD are very small in size. There is no privacy for the patients in most of the areas. Facilities like patient couch, stools, x-ray view box, examination tray etc. are not provided in most of the rooms. Paramedical staff and nurses are very few. Most of the specialities are not provided teaching areas.
7. Air conditioning of the Audiometry room is not working. There is no proper sound proofing. Audiometry technician is not available.
8. Most of the wards are not having teaching areas. Side laboratories are not available in most of the wards. Most of the wards are over crowded. Space between the two cots is not adequate The unit distribution of beds is not clearly marked. Bed side lockers are not provided to many beds. Patients of Psychiatry, TB & Chest & Skin diseases are kept in the same ward. Male and female patients are also kept together which is not as per norms. Most of the wards are not having duty doctor room and duty nurse room. There is no provision of safe drinking water in OPD and Wards.
9. Obst. & Gynae operation theatres do not have any specialized equipment like bed side monitors, pulse oximeters, infusion pump, ventilators, defibrillator etc.
10. The infrastructural facilities in the ICCU are grossly inadequate. There are no medical, surgical, burns in ICU. Ventilator in the ICCU is not available. For entry of dialysis room patients and staff has to cross through the entire ICCU. There is no central oxygen supply and central suction in ICCU. Air condition is not functional in the ICCU.
11. There are no departmental libraries of TB & Chest, Skin & VD and Psychiatry. Number of books in the departmental library of Pediatrics, ENT, Radiodiagnosis and Anaesthesia are inadequate.
12. At present both the labour room are closed for major repair. Except for delivery tables, no other special equipments are available in makeshift labour room.
13. Canteen is not available.
14. There is no provision to supply special diet as recommended by Physician.
15. Para medical staff is grossly inadequate as under:-

17. Residential quarters for teaching and non-teaching staff within the campus are inadequate.
18. In the central library only 36 journals are available against the requirement of 100
19. No training courses for faculty were conducted during this year by medical education unit.
20. Common room for boys is not available. Common room for girls is empty room without any furniture.
21. In the animal house large animals. Guinea pig are not available. Para medical staff is not available in the animal house.
22. In RHTC, Lecturer cum medical officer having MD (PSM) qualification is not available. At present students / interns are not staying in the hostel.
23. In UHC, Lecturer cum medical officer having MD (PSM) qualification is not available.
24. Separate hostels for interns is not available.
25. Dr. V.K. Pandya is incharge medical superintendent of the main teaching hospital which is not as per norms. Full time Medical Superintendent of the main hospital is not available. Dr. Neeraj Bedi who is Associate Professor has been posted as full time medical superintendent of Sultania Hospital. He is not qualified to hold the post as he has no administrative experience.
26. Medical Record department is not computerized. The staff in MRD is not qualified.
27. There is no collection and segregation of hospital waste as per the guidelines of Pollution Control Board.
28. The following deficiencies have been observed in the Pre-clinical department:-
- a. Anatomy:
 - The capacity of demonstration room is not as per Council norms.
 - There is no cooling cabinet.
 - b. Biochemistry
 - The department does not participates in hospital work.
29. Following deficiencies have been observed in the infrastructure of Para-clinical department:-
- c. Microbiology - it has not its own laboratory and using practical laboratory of Pathology for students.
30. Other deficiencies / remarks are in the main report.

In view of above, the Postgraduate Committee decided to recommend to the Council for withdrawal of recognition of M.D. (SPM) course at Gandhi Medical College, Bhopal granted by Barkatullah University u/s 19 of the Indian Medical Council Act, 1956.

The Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (SPM) course from the academic session 2008-09.

64. Rajiv Gandhi University of Health Sciences, Bangalore - Approval of MR Medical College, Gulbarga for the award of MD (Microbiology) qualification.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at MR Medical College, Gulbarga for purpose of approval of the college for the award of MD (Microbiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council Inspector's report (May,2007) and decided to recommend that MR Medical College, Gulbarga be approved for the award of M.D.(Microbiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore restricting the number of admissions to 2(two) students per year.

65. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of JSS Medical College, Mysore for the award of M.S.(General Surgery) qualification in respect of increased intake.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at JSS Medical College, Mysore for purpose of approval of the college for the award of M.S.(General Surgery) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of increase intake.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at Govt. Medical College, Nagpur for purpose of recognition of MS (Orthopaedics) qualification granted by Nagpur University/RTM Nagpur University.

The Postgraduate Committee considered the Council inspector report (May, 2007) and decided to seek a clarification from the authorities concerned in regards to the Dean, Dr. Varsha Sagdeo as to whether she is regular Dean or otherwise?

The Postgraduate Committee decided to defer the consideration of the matter till the clarification is received from the authorities concerned.

76. Mumbai University – Approval of LTM Medical College, Mumbai for the award of DO qualification.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at LTM Medical College, Mumbai for purpose of approval of the college for the award of DO qualification granted by Mumbai University.

The Postgraduate Committee considered the Council inspector report (May, 2007) and decided not to approve LTM Medical College, Mumbai for the award of D.O. qualification granted by Mumbai University because of the following:-

1. Department is not headed by a Professor.
2. YAG laser is not working.
3. B. Scan is not available. Resultantly, instrumentation is inadequate.
4. Other deficiencies/remarks as pointed out in the inspection report.

77. Sher-I-Kashmir Instt. of Medical Sciences (Deemed University) Srinagar – Recognition of MD (Paediatrics) qualification in respect of students being trained at Sher-I-Kashmir Instt. of Medical Sciences, Srinagar.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at Sher-I-Kashmir Instt. of Medical Sciences, Srinagar for purpose of recognition of MD (Paediatrics) qualification granted by Sher-I-Kashmir Instt. of Medical Sciences (Deemed University).

The Postgraduate Committee considered the Council inspector report (May, 2007) and decided not to recommend recognition of M.D. (Paediatrics) qualification granted by Sher-I-Kashmir Instt. of Medical Sciences (Deemed University) in respect of students being trained at Sher-I-Kashmir Instt. of Medical Sciences, Srinagar because of the following:-

1. Department is not headed by Professor.
2. Additional Prof. Dr. Wajid Ali does not possess recognized postgraduate qualification.
3. Professor emeritus Dr. Masood-ul-Hassan is honorary, hence he cannot be counted.
4. Teaching complement is incomplete in Unit-I.
5. There is no recognized PG teacher in Unit-I.
6. Other deficiencies/remarks as pointed out in the inspection report.

78. Jammu University – Approval of Acharya Shri Chander College of Medical Sciences, Jammu for the award of MD (Anaesthesia) qualification.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at Acharya Shri chander college of Medical Sciences, Jammu for purpose of approval of the college for the award of MD (Anaesthesia) qualification granted by Jammu University.

The Postgraduate Committee considered the Council Inspector's report (May,2007) and decided to recommend that Acharya Shri chander college of Medical Sciences, Jammu be approved for the award of MD (Anaesthesia) qualification granted by Jammu University restricting the number of admissions to 4(four) students per year.

79. HNB Garhwal University – Approval of Himalayan Instt. of Medical Sciences, Dehradun for the award of DMRD qualification in respect of increased intake.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at Himalayan Instt. of Medical Sciences, Dehradun for purpose of approval of the college for the award of DMRD qualification granted by HNB Garhwal University in respect of increased intake.

The Postgraduate Committee considered the Council Inspector's report (May,2007) and noted that the promotion of Dr. Alka Ahuja is not as per MCI norms; decided to recommend that Himalayan Instt. of Medical Sciences, Dehradun be approved for the award of DMRD qualification granted by HNB Garhwal University in respect of increased intake restricting the number of admissions to 3(three) students per year.

80. Shivaji University – Approval of V.M. Medical College, Solapur for the award of MD (Paediatrics) & DCH qualification.

Maharashtra University of Health Sciences, Nashik – Approval of V.M. Medical College, Solapur for the award of DCH qualification.

Read: The Council inspector report (May, 2007) on the physical and other teaching facilities available at the college togetherwith the Council Inspector's report (Dec., 2004) on the standard of examination and other teaching facilities available at V.M. Medical Solapur for purpose of i) approval of the college for the award of M.D.(Paediatrics) & DCH qualification granted by Shivaji University and ii) approval of V.M. Medical College, Solapur for the award of DCH qualification granted by Maharashtra University of Health sciences, Nashik alongwith the order of Hon'ble Mumbai High Court in W.P. The Postgraduate Committee perused the order of the Hon'ble High Court of Mumbai in W.P. No. 1459/2007, dated 23.4.2007 and considered the Council inspector report (May, 2007) togetherwith the Council Inspector's report (Dec., 2004) and decided to reiterate its earlier decision taken at its meetings held on 11.2.2005 & 7.6.2006 recommending not to approve V.M. Medical College, Solapur for the award of MD (Paediatrics) & DCH qualifications granted by Shivaji University / Maharashtra University of Health sciences, Nashik because:-

- (i) The Deptt. is being headed by Emeritus Prof. who is more than 65 years of age.
- (ii) There is no Associate Professor in Unit I. Dr. N.S. Bohari, Assoc.Prof. cannot be considered as he possesses the experience as Hon. Asstt.Prof. which cannot be considered.
- (iii) Unit-II has only one full time faculty member.
- (iv) Resultantly, teaching complement is incomplete in both the units.
- (v) Other deficiencies/remarks in the report.

The Committee further decided to reiterate its earlier decision of directing the institution authorities to henceforth stop admissions prospectively in MD (Paediatrics) & DCH qualifications.

81. Shivaji University – Approval of Dr. V.M. Medical College, Solapur for the award of MD(SPM) qualification & recognition of DPH qualification.

Maharashtra University of Health Sciences, Nashik – Approval of V.M. Medical College, Solapur for the award of DPH qualification.

Read: The Council inspector report (May, 2007) on the physical and other teaching facilities available at the college togetherwith the Council Inspectors report (Jan., 2005) on the standard of examination and other teaching facilities available at Dr. V.M. Medical College, Solapur for purpose of i) recognition of DPH qualification and approval of the college for the award of MD (SPM) qualification granted by Shivaji University and (ii) approval of the college for the award of DPH qualification under Maharashtra University of Health Sciences, Nashik alongwith the order of Hon'ble Mumbai High Court in W.P. No. 3441/2007, dated 23.4.2007.

The Postgraduate Committee perused the order of Hon'ble Mumbai High Court in W.P. No. 3441/2007, dated 23.4.2007 and considered the Council Inspector report (May, 2007) togetherwith the Council Inspectors report (Jan., 2005) and decided to reiterate its earlier decision taken at its meetings held on 11.2.2005 & 7.6.2005 recommending not to approve V.M. Medical College, Solapur for the award of MD (SPM) & recognition of DPH qualifications granted by Shivaji University / Maharashtra University of Health sciences, Nashik because:-

- (i) Professor & HOD does not possess requisite recognised postgraduate qualification.
- (ii) Other deficiencies/remarks in the report.

The Committee further decided to reiterate its earlier decision directing the institution authorities to henceforth stop admissions prospectively in MD (SPM) & DPH qualifications.

82. AP Singh University – Permitting intake in M.D. (Pharmacology) course at SS Medical College, Rewa.

Read: The Council inspector report (May, 2007) on the physical and other teaching facilities available at SS Medical College, Rewa for purpose of fixing intake in M.D. (Pharmacology) course.

The Postgraduate Committee considered the Inspection report (May, 2007) for purpose of continuance of recognition u/s 19 of the I.M.C. Act, 1956 of M.D. (Pharmacology) qualification at S.S. Medical College, Rewa and noted the following:-

1. There is no Professor in the department.
2. Staff is inadequate even for UG.
3. There is no central animal house in the department.
4. Instruments are not in working order.
5. Other deficiencies as pointed out in the inspection report.

The Postgraduate Committee also noted that the following deficiencies were observed during the inspection carried out on 27th & 28th November, 2006 for continuance of recognition at MBBS degree:-

1. The shortage of teaching staff required at present stage is as under:-

3. The institution does not have separate departments of Psychiatry and skin & V.D. These specialities are sections/divisions of department of medicine. These specialities do not have their separate departmental libraries. The head of department of Medicine is also the head of these specialities which is not as per MCI norms.
4. Hostel accommodation for students is inadequate as it is available for 216 students only against the requirement of 300.
5. Non-teaching staff in the library is inadequate.
6. Number of available journals are only 45 against the requirement of 100.
7. Central Animal house with required facilities are not available. No animal is regularly maintained in the animal house.
8. No Lecturer cum medical officer having MD(PSM) is available at RHTC. Infrastructural facilities are inadequate at RHTC. No audio-visual aids are provided.
9. At UHC – No Lecturer-cum-Medical Officer for MD(PSM) qualification is posted. Record for investigations are not maintained properly.
10. Registration counter for OPD is not computerized.
11. The indoor registration counter is not computerized and not cross linked with the outdoor registration.
12. The Medical Record department is not computerized. ISD classification of record is not being followed.
13. Only one mobile x-ray unit is available which is inadequate as per MCI norms.
14. Canteen for patients, staff and students is not available.
15. In Pathology department, the up-keeping of the museum is not satisfactory.
16. Service laboratory for Serology, virology, parasitology, mycology and tuberculosis are not available in the Department of Microbiology.

17. Catalogues are not available in the museum of Deptt. of Forensic Medicine.
18. Number of books in the departmental library in TB & Chest, Psychiatry, ENT, Padiatrics is inadequate as per MCI norms.
19. Other deficiencies/remarks are in the main report.

In view of above, the Postgraduate Committee decided to recommend to the Council for withdrawal of recognition of M.D. (Pharmacology) qualification at S.S. Medical College, Rewa granted by A.P. University u/s 19 of the IMC Act, 1956.

The Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (Pharmacology) qualification from the academic session 2008-2009.

At this point, Dr. Ved Prakash Mishra, disassociated from the consideration of next item i.e. No.83.

83. Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University – Recognition of DVD/DDVL qualification in respect of students being trained at JLN Medical College, Swangi, Wardha.

Dr. Ved Prakash Mishra rejoined the proceedings.

84. Jammu University – Recognition of MD (Deramatology, Venerology & Leprosy) qualification in respect of students being trained at Govt. Medical College, Jammu.

Read: The Council inspector report (May, 2007) on the standard of examination and other teaching facilities available at Govt. Medical College, Jammu for purpose of recognition of MD (Dermatology, Venerology & Leprosy) qualification granted by Jammu University.

The Postgraduate Committee considered the Council Inspector's report (May, 2007) and decided to recommend that MD (Dermatology, Venerology & Leprosy) qualification granted by Jammu University in respect of students being trained at Govt. Medical College, Jammu be recognized and included in the 1st Schedule to the I.M.C. Act,1956 restricting the number of admissions to 2(two) students per year.

85. Patna University – Recognition of MD (Microbiology) & Diploma in Microbiology qualification in respect of students being trained at Patna Medical College, Patna.

Read: The Council inspector report (June, 2007) on the standard of examination and other teaching facilities available at Patna Medical College, Patna for purpose of recognition of MD (Microbiology) & Diploma in Microbiology qualification granted by Patna University.

The Postgraduate Committee considered the Council Inspector's report (June, 2007) and noted that there are 5 postgraduate teachers in the department; decided to recommend that MD (Microbiology) qualification granted by Patna University in respect of students being trained at Patna Medical College, Patna be recognized and included in the 1st Schedule to the I.M.C. Act,1956 restricting the number of admissions to 4(four) students per year.

The Committee further decided to direct the institution authorities to restrict the number of admission to 1(one) student per year prospectively for Diploma in Microbiology.

86. Comments of MCI on the complaint of Prof. A. Rajasekaran, Member, PG committee regarding serious irregularities.

Read: The complaint of Prof. A. Rajasekaran, Member, PG committee received from Govt. of India, Ministry of Health & Family Welfare, Nirman Bhavan, New Delhi for comments of the Council.

The Postgraduate Committee took a serious note with concern of the complaint of Prof. A. Rajasekaran, Member, PG Committee received from Govt. of India, Ministry of Health & Family Welfare and observed that the remarks made therein are uncharitable, uncalled, unwarranted and devoid of any substance.

The Postgraduate Committee authorized the Chairman to draft a suitable reply for sending to Prof. A. Rajasekaran under intimation to the Central Government, Ministry of Health & F.W. New Delhi and place before the Postgraduate Committee at its next meeting.

87. Rani Durgawati Vishwavidyalaya – Permitting intake in M.D. (Pharmacology) course at NSCB Medical College, Jabalpur.

Read: The Council Inspector report (February, 2007) on the physical and other teaching facilities available at NSCB Medical College, Jabalpur for purpose of fixing intake in MD. (Pharmacology) course.

The Postgraduate Committee considered the Inspection report (Feb., 2007) for purpose of continuance of recognition u/s 19 of the I.M.C. Act, 1956 of MD. (Pharmacology) qualification at NSCB Medical College, Jabalpur and noted the following:-

4. Other deficiencies as pointed out in the inspection report.

The Postgraduate Committee also noted that the following deficiencies were observed during the inspection carried out on 27th & 28th November, 2006 for continuance of recognition of MBBS degree:-

1. The gas cylinders are kept in the practical lab.
2. There is seepage in the practical Lab.
3. The administration of the department is done by HOD Physiology as there is no Professor/Associate Professor in the Department of Biochemistry.
4. There is no department library cum seminar room.
5. There is no demonstration room.

4. The following deficiencies are observed in the infrastructure of para-clinical departments:-

Pathology:

1. One Demonstration room is located inside the museum.
2. There is a no research laboratory.
3. Catalogues are not available.

Microbiology:

1. There is no research laboratory.
2. There is no museum
3. There is no provision for artificial light in the practical lab.
4. Practical lab is shared with Forensic Medicine Department.

For. Medicine :

1. There is only 01 faculty in the department who is the HOD.
2. There are no catalogue are kept in the museum.
3. There is no research laboratory.
4. The demonstration room is located inside the museum.
5. There is no practical lab in the department. It is being shared with the Microbiology Department.
6. There is no department library cum seminar room.

Com. Medicine:

1. One demonstration room is located in the museum.
2. There is no research laboratory

5. The number of beds in the Deptt. of Pead. is 80 in three units against the requirement of 90 beds in three units.
6. The Audiometry room is not sound proof and not airconditioned.
7. There are only five operation theatres having 10 tables against the requirement of 10 operation theatres. The arrangement for more than one table in OT is also not as per the MCI norms.
8. Septic labour room and eclampsia room are not available.
9. There is no separate surgical & medical ICU. There is no Gynae. ICU and Neonatal ICU.
10. CT Scan is not available.

11. Number of para-medical staff is grossly inadequate is as under:-
 Laboratory Technicians: 7 (5 posts vacant)
 Laboratory Assistants: 01
 Laboratory Attendants: 04 (1 post vacant)

12. The Nursing Staff is inadequate as under :

Nursing Superintendent:	nil (1 post vacant)
Deputy Nursing Superintendent:	nil
Matron	01
Asstt. Nursing Superintendent	nil
Nursing Sisters	32 (2 posts vacant)
Staff nurses	144 (36 posts vacant)

There is a deficiency of paramedical and nursing staff and is not as per MCI norms.

13. There are only four lecture theatres having capacity of 150 each which is not as per MCI norms.
14. Hostel accommodation is available only for 516 students against the requirement of 700.
15. Separate hostel for interns is not available.
16. In the central library – no current journals are available for the year 2005. Only few current journals for the year 2006 are available upto the month of July. Total number of journals subscribed are 86 which is inadequate.
17. No training courses were held for teachers by the Medical Education Unit during the year.
18. Guinea pig, mice and large animals are not available in the animal house. The veterinary officer visits are as per MCI norms.
19. RHTC-Natwara is under the control of the State Health Govt. Department and not under the control of Dean.
20. No Lecturer-cum-Medical Officer with MD(PSM) is available. Audio-visual aids have not been provided.
21. The college does not have any Urban Health Centre at present.
22. There is no Medical Record Department and there is no staff appointed for the same. ICD X classification of diseases is not followed for indexing.
23. Instrumentation is grossly inadequate. Only one Ambu Bag and BP instrument is available. There is no minor operation theatre and there is no emergency operation theatre.
24. Doctors for pre-clinical are posted on rotation in the casualty which is not as per MCI norms. There is no emergency treatment in the casualty.
25. The CSSD Hall is not as per MCI norms. Distribution and receiving points are not separate.
26. The following deficiencies have been observed in the infrastructure of three MBBS departments:-
 Anatomy: 1. The cooling cabinet is not functioning; 2. MRI, CT and X-ray are not displayed in the museum; 3. Catalogue in the museum are not displayed; 4. Departmental library cum seminar room is located in the research lab.

Physiology: 1. One demonstration room is located in the practical lab

Biochemistry: 1. The administration of the department is done by HOD Physiology as there is no Professor/Associate Professor in the Deptt. of Biochemistry

2. There is no departmental library cum seminar room; 3. There are no demonstration room in the department and it is shared with the Physiology department. 4. The Gas cylinders need to be kept away in a separate enclosure.

27. There are no departmental library for TB & Chest, Dermatology and Psychiatry department.
28. Number of books in Radio-diagnosis and Anatomy department are inadequate.
29. The following deficiencies are observed in the para-clinical departments of Pharmacology, Microbiology and Forensic Medicine:-
 Pharmacology – photographs and medicinal plants are not available in the museum.
 Pathology – 1. One demonstration room is located inside the museum; 2. There is no research laboratory; 3. Catalogues are not available in the museum.
 Microbiology – 1. There is no research laboratory; 2. There is no museum; 3. There is no provision for artificial light in the practical lab.; 4. Practical lab. Is shared with the Forensic Medicine department.
 Forensic Med. Deptt 1. There are no catalogue are kept in the museum. 2. There is no research laboratory. 3. The demonstration room is located inside the museum. 4. There is no practical lab. in the department. It is being shared with the Microbiology Lab. 5. There is no departmental library cum seminar room.
 Comm. Med.deptt. – One demonstration room is located in the museum. There is no Research lab.
30. Other deficiencies/remarks are in the main report.

In view of above, the Postgraduate Committee decided to recommend to the Council for withdrawal of recognition of MD (Pharmacology) qualification at NSCB Medical College, Jabalpur granted by Rani Durgawati Vishwavidyalaya u/s 19 of the I.M.C.Act, 1956.

The Committee further decided to direct the institution authorities to henceforth stop admission in MD (Pharmacology) qualification from the academic session 2008-2009.

At this point, Dr. Ved Prakash Mishra, disassociated from the consideration of next item i.e. No.88.

88. Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University – Recognition of MD (Physiology) qualification in respect of students being trained at JLN Medical College, Swangi, Wardha.

Read: The Council Inspector report (May, 2007) on the standard of examination and other teaching facilities available at JLN Medical College, Swangi, Wardha for purpose of recognition of MD (Physiology) qualification granted by Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University.

The Postgraduate Committee considered the Council Inspector's report (May, 2007) and decided to recommend not to recognize MD (Physiology) qualification granted by Datta Meghe instt. of Medical Sciences (Deemed University)/RTM Nagpur University in respect of students being trained at JLN Medical College, Swangi, Wardha because of the following:-

1. There is no separate seating room for tutors.
2. Dr. D.A. Biswas, Professor & Dr. Chhaya Saraf, Asstt.Prof. do not possess requisite postgraduate qualification.

3. Laboratory Technicians are two in number (deficiency of two as per MCI as there are no technical assistant).
4. Some important equipments at undergraduate level are deficient i.e. perimeter, spirometer ordinary, physiograph-single channel, stethograph, bicycle ergometer, mossos ergograph etc., Polygraph 3 channel non existing.
5. Other deficiencies as pointed out in the inspection report.

Dr. Ved Prakash Mishra rejoined the proceedings.

89. Rajiv Gandhi University of Health Sciences, Bangalore – Approval of JSS Medical College, Mysore for the award of M.S.(Ophthalmology) qualification.

Read: The Council Inspector report (May, 2007) on the standard of examination and other teaching facilities available at JSS Medical College, Mysore for purpose of approval of the college for the award of M.S.(Ophthalmology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the Council inspector report (May, 2007) and decided not to approve JSS Medical College, Mysore for the award of M.S.(Ophthalmology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore because of the following:-

1. Dr. R. Rajendra & Dr. S.K. Prabhakar do not possess prescribed academic qualification.
2. Resultantly, teaching complement is incomplete in Unit-I.
3. Operative workload is inadequate.
4. Flourescein angiography equipment is not available.
5. Average daily operative workload is inadequate (major 2 to 3 and minor 1 to 2)
6. Other deficiencies/remarks as pointed out in the inspection report.

90. West Bengal University of Health Sciences, Kolkata – Recognition of M.D (Pharmacology) qualification in respect of students being trained at Burdwan Medical College, Burdwan.

Read: The Council Inspector report (February, 2007) on the standard of examination and other teaching facilities available at Burdwan Medical College, Burdwan for purpose of recognition of MD(Pharmacology) qualification granted by West Bengal University of Health Sciences, Kolkata.

The Postgraduate Committee considered the Council Inspector's report (February, 2007) and decided to recommend that MD(Pharmacology) qualification granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Burdwan Medical College, Burdwan be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2(two) students per year.

91. Veer Narmad South Gujarat University- Recognition of M.D. (Physiology) qualification in respect of students being trained at Govt. Medical College, Surat,

Read: The Council Inspector report (May, 2007) on the standard of examination and other teaching facilities available at Govt. Medical College, Surat for purpose of recognition of M.D. (Physiology) qualification granted by Veer Narmad South Gujarat University.

The Postgraduate Committee considered the Council Inspector's report (May, 2007) and decided to recommend not to recognize MD (Physiology) qualification granted by Veer Narmad South Gujarat University in respect of students being trained at Govt. Medical College, Surat because of the following:-

1. Demonstration room is inadequate.
2. Log Book of PG is not maintained.

3. At undergraduate teaching level some equipments are highly deficient viz., Mosso's Ergograph, Perimeter, Stethograph, Single channel Physiograph etc. Some very important equipment non existing eg., Dynamometer, Bicycle ergometer.
4. One demonstration room is small having capacity of only 35-45 students. There are non desks & chairs in both demonstration rooms, only stools are available which are not comfortable for one hour duration class.
5. Laboratory technicians are three (deficiency of one as there are no technical assistant).
6. Other deficiencies as pointed out in the inspection report.

92. Jammu University – Approval of Acharya Shri Chander College of Medical Sciences, Jammu for the award of MD (Radio-diagnosis) qualification.

Read: The Council Inspector report (May, 2007) on the standard of examination and other teaching facilities available at Acharya Shri chander college of Medical Sciences, Jammu for purpose of approval of the college for the award of MD (Radio-diagnosis) qualification granted by Jammu University.

The Postgraduate Committee considered the Council Inspector's report (May,2007) and observed that as per the inspection report D.S.A. is to be installed shortly and decided to defer the consideration till the clarification is received from the institute regarding installation of D.S.A.

93. Padmashree D.Y. Patil Medical College (Deemed University), Pune – Recognition of DPM qualification in respect of students being trained at Padmashree D.Y. Patil Medical College, Pune.

Read: The Council Inspector report (February, 2007) on the standard of examination and other teaching facilities available at Padmashree D.Y. Patil Medical College, Pune for purpose of recognition of DPM qualification granted by Padmashree D.Y. Patil Medical College (Deemed University), Pune.

The Postgraduate Committee considered the Council Inspector's report (February, 2007) and decided to recommend that DPM qualification granted by Padmashree D.Y. Patil Medical College (Deemed University), Pune in respect of students being trained at Padmashree D.Y. Patil Medical College, Pune be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admission to 1(one) student per year.

94. Rajiv Gandhi University of Health Sciences, Bangalore-Recognition of MD (Forensic Medicine) qualification in respect of students being trained at Al-Ameen Medical College, Bijapur.

Read: The compliance of the institution alongwith the Council Inspector report (November, 2006) on the standard of examination and other teaching facilities available at Al-Ameen Medical College, Bijapur for purpose of recognition of MD (Forensic Medicine) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Committee considered the compliance of the institution alongwith Council Inspector's report (November, 2006) and noted that the compliance is unsatisfactory; decided to reiterate its earlier decision taken at its meeting held on 27.12.2006 recommending not to recognize M.D.(Forensic Medicine) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Al-Ameen Medical College, Bijapur because of the following:-

1. The teaching faculty is deficient even for undergraduate course by 1 Associate Prof.
2. Additional teaching component for postgraduate course is not available.
3. Standard of the candidate appearing for examination is very poor, casting doubt on the quality of postgraduate teaching being imparted.
4. Mortuary needs improvement in infrastructure.
5. Other deficiencies as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (Forensic Medicine) course from the ensuing academic session 2007-2008.
