5. Increase of seats in MD (Radio-Diag.) course at Bharati Vidyapeeth University Medical College, Pune under Bharati Vidyapeeth University (Deemed University) u/s 10A of the IMC Act, 1956.

Read: the Council Inspector's report (Nov., 2008) on the physical and other teaching facilities available at Bharati Vidyapeeth University Medical College, Pune for increase of seats in MD (Radio-Diag.) course under Bharati Vidyapeeth University (Deemed University) u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats in MD (Radio-Diag.) course at Bharati Vidyapeeth University Medical College, Pune under Bharati Vidyapeeth University (Deemed University) u/s 10A of the I.M.C. Act, 1956 as the Essentiality Certificate issued by the State Govt. is for increase of 2 to 4 seats in degree course which has already been permitted in 2007 and also the available postgraduate teachers are commensurate with the present intake of 4(four) students per year for the degree course and 2(Two) students per year for the diploma course.

1. Promotion of Dr. P.Anusuya, Professor in Unit I is not as per MCI norms as she has been promoted as Assoc. Prof. with only 4 years & 10 months experience as Asstt. Prof.
2. Other deficiencies/observations as pointed out in the inspection report.

7. Starting of MS (General Surgery) courses at Vinayaka Mission's Kirupananda Variyar Medical College, Salem under Vinayaka Missions University (Deemed University) u/s 10A of the IMC Act, 1956.

Read: the Council Inspector's report (Nov., 2008) on the physical and other teaching facilities available at Vinayaka Mission's Kirupananda Variyar Medical College, Salem for starting of MS (General Surgery) course under Vinayaka Mission's University (Deemed University) u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MS (General Surgery) course at Vinayaka Mission's Kirupananda Variyar Medical College, Salem under Vinayaka Mission's University (Deemed University) u/s 10A of the IMC Act, 1956 because of the following:-

1. Clinical material is showing declining trend over a period of last 3 years.
2. Average daily bed occupancy 60-70%.
3. Resultantly, clinical material is inadequate.
4. Other deficiencies/observations as pointed out in the inspection report.

8. Starting of MD (Psychiatry) course at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.

Read: the Council Inspector's report (Nov., 2008) on the physical and other teaching facilities available at M.M. Instt. Of Medical Sciences & Research, Mullana, Ambala for starting of MD (Psychiatry) course under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD (Psychiatry) course at M.M. Instt. Of Medical Sciences & Research, Mullana, Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956 because of the following:-

1. All the admissions in the indoor beds were made two days prior to inspection & most of these cases had medical/neurological disorders. There was no case of Schizophrenia, bipolar, affective disorders and other major psychiatric disorder.
2. In the OPD, no records are maintained and the diagnosis & history is written on the cards and new card is made after every 7 day.
3. Psychological tests are not provided by the department.
4. Important books on Psychiatry are not available in the library.
5. Social worker & clinical Psychologist who were appointed four months back are not involved in patient care.
6. Psychological tests need to be purchased.
7. Other deficiencies/observations as pointed out in the inspection report.

9. Starting of MD (Paediatrics) & DCH courses at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.

3. Other deficiencies/observations as pointed out in the inspection report.

The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

12. Starting of MD (General Medicine) course at M.M. Instt. of Medical Sciences & Research, Mullana Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2008) and noted that promotion of Dr. D.S. Ramchandra, Professor, is not as per MCI norms as he has been promoted as Professor with only 7 years 2 months experience as Asstt. Professor.

However, the teaching faculty complement other than the teacher mentioned above is adequate and complete and hence decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Anaesthesia) & D.A. courses at Navodaya Medical College, Raichur under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 4(four) students in MD(Anaesthesia) & 3(three) students in D.A. per year, till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

14. Starting of MD (TB & Respiratory Diseases) course at Navodaya Medical College, Raichur under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956.

1. Dr. A.Hamumaiah, Prof. & HOD, does not possess recognized postgraduate qualification.
2. Promotion of Dr. Vilas G. Kulkarni, Professor & Incharge of Unit-C and Dr. Ajit Kumar B.K., Professor & Incharge of Unit D is not as per MCI norms.
3. Resultantly, teaching component is incomplete.
4. Other deficiencies/observations as pointed out in the inspection report.

The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

Remarks: In Biochemistry Department Professor & Head is non-medical. Non -Medical Teachers are more than 50%.

2. Daily OPD attendance is : 842 and Bed Occupancy is 84%. These high OPD and bed occupancy do not commensurate with other clinical data like CT Scan, Microbiological investigations and histopathology (major surgeries -15). Data reported by Medical Superintendent.
3. Bed occupancy was 81.30% at 5.00 pm as reported by the Medical Superintendent. The Inspectors Team took the round of all the wards at 7.00 pm and observed that the overall bed occupancy in all wards was 57%.
4. Casualty attendance, major surgeries, minor surgeries, microbiology investigations and parasitology investigations do not commensurate with OPD attendance and bed occupancy.
5. Total number of Journals subscribed are 17 Indian and 13 Foreign as against the requirements 70 Indian and 30 Foreign. Meddler facility is not available.
6. Auditorium is not available.
7. Examination hall is not available.
8. Common room for 50 boys in basement of the college building without toilets and for 50 girls it is on ground floor without toilet.
9. Hostel accommodation available for undergraduate boys is 200 and girls 250. Total accommodation available is 450 as against the requirement of 500.
10. The hostel for Interns Residents & Nurses are not available.
11. There are 4 lecture theaters in the college, 2 are gallery type and, 2 are level type, which is not as per norms.
12. All OPD registrations are done manually with the help of 6 clerks. Waiting area is inadequate. Teaching facilities like x-ray view box, examination tray are not provided in all rooms. There are only two teaching areas each having capacity for 25-30. These teaching areas are shared by various departments.
13. In many wards side laboratories not functional. Wards are congested, the space between the beds is not sufficient. Beds are numbered but unit wise distribution of the bed is not

- seen. Patients of dermatology and psychiatry are kept in the medicine ward which is not allowed.
14. There is a medical record section located in a old heritage hut. There is no medical record officer. A MBBS doctor is performing the show. There is a computer but the record is not computerized. ICD X WHO classification is not followed.
 15. Total 15 beds are available in two rooms of casualty area, one room is having 7 beds with central oxygen supply. Both the rooms are without central suction, another room is not having central oxygen supply.
 16. Separate ICCU, Surgical ICU, Burns ICU, Pediatric ICU, Respiratory ICU are not available.
 17. Two static units of 300 mA are available as the against the requirement of 1-800 mA, 1-500 mA and 1-300 mA in the department of Radio-diagnosis.
 18. Service of the dietician is not available. There is no provision to supply therapeutic diet.
 19. Para Medical Staff: The specific technical paramedical staff is not provided.
 20. Residential Quarters - Total 12 quarters are available for teaching faculty, which is inadequate against the requirement of 60 at this stage.
 21. Anatomy Department : Toilet for staff members is inadequate. 36 students lockers are available, which is inadequate against the requirement for 100. Research Laboratory is not available. Deficiencies remain as it is.
 22. Pharmacology Department: Toilet for staff members is inadequate. Research Laboratory is not available. Deficiencies remain as it is.
 23. Physiology Department: toilet for staff members is inadequate. Research Laboratory is not available. Deficiencies remain as it is.
 24. Pathology Department: Research Laboratory is not available. Space and toilet for staff members is inadequate. Deficiencies remain as it is.
 25. Microbiology Department: Space and toilet for staff members is inadequate. Deficiencies remain as it is.
 26. Forensic Medicine Department: Space and toilet for staff members is inadequate. Deficiencies remain as it is.
 27. Community Medicine Department: Research Laboratory is not available. Toilet for staff members is inadequate. Deficiencies remain as it is.
 28. Other deficiencies pointed out in the inspection report.

In view of above, the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council decided to give 2 months time to the authorities of Maharashtra Institute of Medical Education & Research, Talegaon to rectify the above deficiencies and submit the compliance within the stipulated period. Copy of the letter be also marked to DME of the concerned State Govt., Registrar of the University to which the college is affiliated and also to the member of MCI representing the State where the college is located.

However, the teaching faculty complement other than the teacher mentioned above is adequate and complete and hence decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Community Medicine) course at Mahatma Gandhi Institute of Medical Sciences, Wardha under Maharashtra University of Health Sciences, Nashik u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 3(Three) to 5(five) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

However, the teaching faculty complement other than the teacher mentioned above is adequate and complete and hence decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Anaesthesia) course at Mahatma Gandhi Medical College & Hospital, Jaipur under University of Rajasthan u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 5(Five) students per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

Hence the Committee decided to reiterate its earlier decision taken at its meeting held on 2.9.2008 not to recognize MD(Forensic Medicine) qualification granted by Guru Nanak Dev University in respect of students being trained at Govt. Medical College, Amritsar because the deficiencies are still persisting.

102 Rani Durgawati Vishwavidhalaya - Recognition of MD (Radio-Therapy) qualification in respect of NSCB Medical College, Jabalpur.

4. *The demonstration room is located inside the museum.*
5. *There is no practical lab in the department. It is being shared with the Microbiology Department.*
6. *There is no department library cum seminar room.*

Com. Medicine:

1. *One demonstration room is located in the museum.*
2. *There is no research laboratory*

5. *The number of beds in the Deptt. of Peadt. is 80 in three units against the requirement of 90 beds in three units.*

6. *The Audiometry room is not sound proof and not airconditioned.*

7. *There are only five operation theatres having 10 tables against the requirement of 10 operation theatres. The arrangement for more than one table in OT is also not as per the MCI norms.*

8. *Septic labour room and eclamsia room are not available.*

9. *There is no separate surgical & medical ICU. There is no Gynae. ICU and Neonatal ICU.*

10. *CT Scan is not available.*

11. *Number of para-medical staff is grossly inadequate is as under:-*

There is a deficiency of paramedical and nursing staff and is not as per MCI norms.

13. *There are only four lecture theatres having capacity of 150 each which is not as per MCI norms.*

14. *Hostel accommodation is available only for 516 students against the requirement of 700.*

15. *Separate hostel for interns is not available.*

16. *In the central library – no current journals are available for the year 2005. Only few current journals for the year 2006 are available upto the month of July. Total number of journals subscribed are 86 which is inadequate.*

17. *No training courses were held for teachers by the Medical Education Unit during the year.*

18. *Guinea pig, mice and large animals are not available in the animal house. The veterinary officer visits are as per MCI norms.*

19. *RHTC-Natwara is under the control of the State Health Govt. Department and not under the control of Dean.*

20. *No Lecturer-cum-Medical Officer with MD(PSM) is available. Audio-visual aids have not been provided.*

21. *The college does not have any Urban Health Centre at present.*
22. *There is no Medical Record Department and there is no staff appointed for the same. ICD X classification of diseases is not followed for indexing.*
23. *Instrumentation is grossly inadequate. Only one Ambu Bag and BP instrument is available. There is no minor operation theatre and there is no emergency operation theatre.*
24. *Doctors for pre-clinical are posted on rotation in the casualty which is not as per MCI norms. There is no emergency treatment in the casualty.*
25. *The CSSD Hall is not as per MCI norms. Distribution and receiving points are not separate.*
26. *The following deficiencies have been observed in the infrastructure of three MBBS departments:-*
Anatomy: 1.The cooling cabinet is not functioning; 2. MRI, CT and X-ray are not displayed in the museum; 3. Catalogue in the museum are not displayed; 4. Departmental library cum seminar room is located in the research lab.
Physiology: 1. One demonstration room is located in the practical lab
Biochemistry: 1.The administration of the department is done by HOD Physiology as there is no Professor/Associate Professor in the Deptt. of Biochemistry
2. There is no departmental library cum seminar room; 3. There are no demonstration room in the department and it is shared with the Physiology department. 4. The Gas cylinders need to be kept away in a separate enclosure.
27. *There are no departmental library for TB & Chest, Dermatology and Psychiatry department.*
28. *Number of books in Radio-diagnosis and Anatomy department are inadequate.*
29. *The following deficiencies are observed in the para-clinical departments of Pharmacology, Microbiology and Forensic Medicine:-*
Pharmacology – photographs and medicinal plants are not available in the museum.
Pathology – 1. One demonstration room is located inside the museum; 2. There is no research laboratory; 3. Catalogues are not available in the museum.
Microbiology – 1. There is no research laboratory; 2. There is no museum; 3. There is no provision for artificial light in the practical lab.; 4. Practical lab. Is shared with the Forensic Medicine department.
Forensic Med. Deptt 1. There are no catalogue are kept in the museum. 2. There is no research laboratory. 3. The demonstration room is located inside the museum. 4. There is no practical lab. in the department. It is being shared with the Microbiology Lab. 5. There is no departmental library cum seminar room.
Comm. Med.deptt. – One demonstration room is located in the museum. There is no Research lab.
30. *Other deficiencies/remarks are in the main report.*

The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council also observed that the deficiencies in terms of teaching faculty and infrastructure have worsened and the quantum of the deficiencies is much higher than that observed in 2003 inspection.

In view of above, the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council decided to reiterate its decision taken at its meeting held on 28th July, 2003 to recommend to the Central Govt. to withdraw the recognition of MBBS Degree in respect of Netaji Subhash Chandra Bose Medical College, Jabalpur granted by Rani Durgawati Vishwavidyalaya, Jabalpur as approved by the General Body of the Council at its meeting held on 20/10/2003 and recommended to the Govt. of India, Ministry of Health & Family Welfare, (Department of Health), Nirman Bhavan, New Delhi vide letter dated 12.01.2004 for further necessary action u/s 19 of the IMC Act, 1956 and request the Central Government to direct the institute not to make any further admissions in the MBBS course w.e.f. academic year 2007-08".

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in MD(Radio-Therapy) course from the academic session 2009-2010.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (October, 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MS (E.N.T.) & D.L.O. courses at Adichunchanagiri Instt. of Medical Sciences, Karnataka under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 1(one) student in MS(ENT) & 1(One) student in D.L.O. course per year till the first batch admitted appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

104. **Increase of seats in MD(Paediatrics) course at Govt. Medical College, Kottayam under Mahatma Gandhi University u/s 10A of the IMC Act, 1956.**

Read: the compliance together with the Council Inspector's report (October, 2008) on the physical and other teaching facilities available at Govt. Medical College, Kottayam for increase of seats in MD(Paediatrics) course under Mahatma Gandhi University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (October, 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD(Paediatrics) course at Govt. Medical College, Kottayam under Mahatma Gandhi University u/s 10A of the IMC Act, 1956, prospectively i.e. from the academic session 2009-2010 from 3(three) to 5 (five) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

The Committee further decided that the intake of diploma students be reduced from 6 (six) to 3 (three) students per year commensurate with the availability of the postgraduate teachers in the department (total 8 in number).

105. **Starting of MD (TB & Chest Diseases) course at A.J. Instt. of Medical Sciences, Mangalore under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956.**

The Postgraduate Committee considered the compliance together with the Council Inspector's report (October, 2008) and decided to reiterate its earlier decision taken at its meeting held on 28.11.2008 to recommend not to issue Letter of Intent for starting of MD (TB & Chest Diseases) course at AJ Institute of Medical Sciences, Mangalore under Rajiv Gandhi University of Health Sciences because of the following:-

1. Dr.Vishnu Sharma, Professor & Head and Dr.K. Praveen Kumar, Asstt. Professor do not possess recognized postgraduate qualification as the degree acquired by them – i.e.

MD(TB & Chest Diseases) at JIPMER under Pondicherry University is not recognized by the Medical Council of India till date.

2. Other deficiencies/observations as pointed out in the inspection report.

Office Note: The members of the Postgraduate Committee also decided that a clarification may be obtained from Karnataka Medical Council to ascertain as to how the certificate of registration of Addl. Qualification has been issued by them in respect of MD(TB & Chest Diseases) qualification at JIPMER under Pondicherry University when the same is not recognized by the Medical Council of India.

It was further observed that no compliance has been submitted by the Institute with regard to the unrecognized postgraduate qualification of Dr. Anil Golhar Prof. & Incharge of Unit-2, Dr. Sunil Mankar, Prof. of Unit-2 and Dr. Rajendra Patil, Asstt. Prof. of Unit-2 and the deficiencies remains still persisting.

In view of above, the Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 10.11.2008 decided to recommend to the Central Government not to issue Letter of Intent for starting of MS (Ortho.) & D.Ortho. courses course at NKP Salve Institute of Medical Sciences, Nagpur under Maharashtra University of Health Sciences, Nashik.
