**01. Minutes of the last meeting of the Postgraduate Committee - confirmation of.**

The Postgraduate Committee confirmed the minutes of the last meetings of the Postgraduate Committee held on 02.09.2008 with the following modifications:-

The minutes may be read corrected as under:-

**Item No. 85. Bharati Vidyapeeth University – Recognition of MD (Paediatrics) qualification in respect of students being trained at Bharati Vidyapeeth Medical college, Pune.**

“The Postgraduate Committee considered the compliance verification report (April, 2008) and the Council Inspector’s report (June, 2007) and decided to recommend that MD (Paediatrics) qualification granted by Bharati Vidyapeeth University in respect of students being trained at Bharati Vidyapeeth Medical College, Pune be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 3 (three) students per year”.

**Note:** The institute is having 5 postgraduate teachers with recognized qualifications and necessary experience. While considering the item in the meeting held on 02.09.2008 it was observed that the institute is recognized for the award of DCH qualification with the intake of 3 students, which was placed by the office inadvertently. Hence, while recognizing the number of admissions were restricted 2 students prospectively commensurate with the number of postgraduate teachers. However, consequently on verification of the office records, it was found that the institute is recognized for the award of DHC qualification for 1 (One) student (not 3 (Three) Students) considered earlier by the General Body of the Council at its meeting held on 10.03.2007. Hence, recognition for the award of MD (Paediatrics) qualification can be awarded with the existing permitted 3 students per year commensurate with number of postgraduate teachers available.

**05. Starting of M.S.(General Surgery) course at Siddhartha Medical College, Vijayawada affiliated to N.T.R. University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

Read: the compliance verification report (Feb., 2008) for starting of MS(General Surgery) course at Siddhartha Medical College, Vijayawada on the physical and other teaching facilities available at Siddhartha Medical College, Vijayawada under NTR University of Health Sciences, Vijayawada for starting of M.S.(General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council inspector report (Feb., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(General Surgery) course at Siddhartha Medical College, Vijayawada under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 4 (Four) students per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**06. Starting of M.D. (Radio-Therapy) & D.M.R.T. courses at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram affiliated to The Tamilnadu Dr.MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 - consideration of compliance verification report.**

Read: the compliance verification report (Sept, 2006) together with the Council Inspector's report (June, 2002) on the physical and other teaching facilities available at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram under The Tamilnadu Dr. MGR Medical University, Chennai for starting of M.D.(Radio-Therapy) & D.M.R.T. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (Sept, 2006) together with the Council Inspector's report (June, 2002) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Radio-Therapy) & D.M.R.T. courses at Govt. Arignar Anna Memorial Cancer Research Institute & Hospital, Karapettai, Kancheepuram under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 because of the following:-

- (i) The promotion of Dr. S. Shanmugakumar - Prof. & HOD, Dr. P. Balasubramaniam - Professor & Dr. V.R. Venkatagiri - Reader is not as per MCI norms.
- (ii) There is no other teacher in the rank of Assistant Professor and above in the department.
- (iii) Resultantly, both the units are incomplete.
- (iv) Library needs more number of books.
- (v) Teaching programme for Postgraduate students has not been charted out.
- (vi) Other deficiencies/observations as pointed out in the inspection report.

**07. Starting of MD(Anaesthesia) course at Command Hospital (WC), Chandimandir, Haryana affiliated to Kurukshetra University u/s 10A of the IMC Act,1956.**

Read: the compliance verification report (August, 2008) on the physical and other teaching facilities available at Command Hospital (WC), Chandimandir, Haryana under Kurukshetra University for consideration of starting of MD(Anaesthesia) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (August, 2008) togetherwith Council Inspector's report (Nov.,2007) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.D.(Anaesthesia) course at Command Hospital (WC), Chandimandir, Haryana under Kurukshetra University u/s 10A of the IMC Act, 1956 because of the following:-

- (i) The promotion of Dr. (Col.) A.R. Gupta - Professor & HOD is not as per MCI norms.
- (ii) There is shortage of one Associate Professor & 2 Assistant Professors in the department for conducting PG course in the speciality of Anaesthesia
- (iii) Other deficiencies/observations as pointed out in the inspection report.

**08. Starting of M.D.(Psychiatry) & D.P.M. courses at Pt. J.N.M. Medical College, Raipur under Pt. Ravishankar Shukla University u/s 10A of the IMC Act, 1956.**

Read: the compliance together with the Council Inspector's report (February, 2008) on the physical and other teaching facilities available at Pt. J.N.M. Medical College, Raipur under Pt. Ravishankar Shukla University for starting of M.D.(Psychiatry) & D.P.M. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (February, 2008) and observed that the compliance report is unsatisfactory and decided to reiterate its earlier decision taken at its meeting held on 27.2.2008 recommending to the Central Govt. not to issue Letter of Intent for starting of M.D.(Psychiatry) & D.P.M. courses at Pt. J.N.M. Medical College, Raipur under Pt. Ravishankar Shukla University as the following deficiencies are still persisting:-

1. Dr. M.D. Sikdar, Asstt. Prof. does not possess prescribed academic qualification. Resultantly, teaching faculty is inadequate.
2. Geriatric Psychiatric Care is not available.
3. Other deficiencies/observations as pointed out in the inspection report.

**09. Starting of MD(Radio-Diagnosis) & DMRD courses at M.G.M. Medical College, Navi Mumbai under Mumbai University u/s 10A of the IMC Act, 1956 - compliance verification regarding.**

Read: the compliance verification report (April, 2008) on the physical and other teaching facilities available at M.G.M. Medical College, Navi Mumbai under Mumbai University for starting of M.D.(Radio-Diagnosis) & DMRD course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (April, 2008) and decided to recommend to the Central Govt. not to issue Letter of Intend for starting of M.D.(Radio-Diagnosis) & DMRD courses at M.G.M. Medical College, Navi Mumbai under Mumbai University u/s 10A of the IMC Act, 1956 because of the following:-

- (i) Special investigations pertaining to Vascular work (Peripheral arteriography, Aorthography, Four Vessels Angiography etc.) interventional procedures are not being carried out.
- (ii) More imaging journals are required to be subscribed for Central library.
- (iii) Departmental teaching files appear to be very less in number. It should be strengthened by more no. of conventional Diagnostics X-ray films, USG films. CT & MRI films. Number of fully worked up cases are to be increased alongwith the cases of various imaging modalities.
- (iv) Number of Doppler investigations are required to be increased.
- (v) DSA Angiography is not available in the department.
- (vi) Dr. Vasan Kuldeep Singh, Associate Professor, Dr. Vinit Gawand, Lecturer & Dr. Lamikant Magar, Lecturer are not having prescribed academic qualifications.
- (vii) Dr. Ashutosh Chitnis, Lecturer is not having recognized Postgraduate qualification.
- (viii) Resultantly, teaching complement is incomplete.
- (ix) Other deficiencies/observations as pointed out in the inspection report.

**10. Starting of MD(Microbiology) course at Govt. Medical College, Thrissur under Calicut University u/s 10A of the IMC Act, 1956.**

Read: the compliance verification report (August, 2008) on the physical and other teaching facilities available at Govt. Medical College, Thrissur under Calicut University for consideration of starting of M.D.(Microbiology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (August, 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D.(Microbiology) at Govt. Medical College, Thrissur under Calicut University u/s 10A of the IMC Act, 1956 u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 4 (Four) students per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**11. Starting of MD(Pulmonary Medicine) course at Lala Ram Sarup Instt. of TB & Respiratory Diseases, New Delhi under Guru Gobind Singh Indraprastha University u/s 10A of the IMC Act, 1956.**

Read: the compliance together with the Council Inspector's report (Feb, 2008) on the physical and other teaching facilities available at LRS Institute of TB & Respiratory Diseases, New Delhi under Guru Gobind Singh Indraprastha University for starting of M.D.(Pulmonary Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (Feb, 2008) and observed that the compliance report is unsatisfactory and decided to reiterate its earlier decision taken at its meeting held on 27.02.2008, recommending to the Central Govt. not to issue Letter of Intent for starting of MD (Pulmonary Medicine) course at LRS Institute of TB & Respiratory Diseases, New Delhi under Guru Gobind Singh Indraprastha University u/s 10A of the IMC Act, 1956 as the following deficiencies are still persisting:-

1. Although there are 5 Units, only Unit-IV has been designated as teaching Unit. The head of Unit, Dr. D. Behera, does not possess prescribed academic qualification. There is no Assoc. Prof. in this Unit. Dr. R. Gupta and Dr. J. Saini, Chest Specialist Grade II, do not possess prescribed teaching experience. Hence, none of the specialists shown as teachers possess teaching experience required as per Regulations for the respective posts.
2. Resultantly, teaching complement is incomplete.
3. The institute also admitting D.N.B. students which is not as per Council norms.
4. Other deficiencies/observations as pointed out in the inspection report.

**12. Starting of DM(Neonatology) course at Seth G.S. Medical College, Mumbai under University of Mumbai u/s 10A of the IMC Act, 1956.**

Read: the compliance together with the inspection report (March, 2008) on the physical and other teaching facilities available at Seth G.S. Medical College, Mumbai for starting of DM(Neonatology) course under Mumbai University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the inspection report (March, 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of DM(Neonatology) at Seth G.S. Medical College, Mumbai under Mumbai University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 1(One) student per year till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**13. Lucknow University, Chhatrapati Shahuji Maharaj Medical University, Lucknow and King George Medical University, Lucknow - Recognition of MD (Microbiology) qualification in respect of students being trained at KG Medical College, Lucknow.**

Read: the compliance report togetherwith the Council Inspector report (April, 2007) on the standard examination and other teaching facilities for recognition of MD (Microbiology) qualification earlier granted by Lucknow University, Chhatrapati Shahuji Maharaj Medical University, Lucknow and now by King George Medical University, Lucknow in respect of students being trained at KG Medical College, Lucknow.

The Postgraduate Committee considered the compliance report togetherwith the Council Inspector report (April, 2007) and decided to recommend that MD (Microbiology) qualification granted by Lucknow University, Chhatrapati Shahuji Maharaj Medical University, Lucknow and now by King George Medical University, Lucknow in respect of students being trained at KG Medical College, Lucknow be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 3 (Three) student per year.

**14. Ranchi University - Recognition of MD (Forensic Medicine) qualification in respect of students being trained at Rajendra Institute of Medical Sciences, Ranchi.**

Read: the compliance report togetherwith the Council inspector report (May, 2008) on the standard of examination and other teaching facilities available at Rajendra Institute of Medical Sciences, Ranchi for purpose of recognition of MD (Forensic Medicine) qualification granted by Ranchi University.

The Postgraduate Committee considered the compliance report togetherwith the Council inspector report (May, 2008) and decided not to recognize MD (Forensic Medicine) qualification granted by Ranchi University in respect of students being trained at Rajendra Institute of Medical Sciences, Ranchi because of the following:-

- (i) Dr. C.S. Prasad cannot be considered as Associate Professor as he has joined as Assistant Professor on 21.01.2007 and he will be eligible for the post of Associate Professor after completion of 5 years as per TEQ regulations, 1998.
- (ii) Resultantly, there is shortage of one Assoc.Prof. in the department.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Postgraduate Committee reiterated its earlier decision taken at its meeting held on 02.07.2008 to direct the institution authorities to henceforth stop admission in MD (Forensic Medicine) course from the academic session 2009-2010.

**15. University of Delhi - Approval of Maulana Azad Medical College, New Delhi for the award of MD (Obst. & Gynae) qualification in respect of increased intake.**

Read: the compliance report togetherwith the Council Inspector's report (April, 2008) on the standard of examination and other teaching facilities available at Maulana Azad Medical College, New Delhi for purpose of approval of the college for the award of MD (Obst. & Gynae) qualification granted by University of Delhi in respect of increase intake.

The Postgraduate Committee considered the compliance report togetherwith the Council Inspector's report (April, 2008) and observed that the compliance report is unsatisfactory and decided to reiterate its earlier decision taken at its meeting held on

12.06.2008 not to recommend approval of Maulana Azad Medical College, New Delhi for the award of MD (Obst. & Gynae.) against increase of seats granted by Delhi University u/s 10A of the IMC Act, 1956 as the following deficiencies are still persisting:-

1. Promotion of Prof.Y.M. Male of Unit-I, Prof. G.Gandhi & Prof.Deepti Goswami of Unit-II, Prof. Asmita Rathore of Unit-III & Dr.Ashok Kumar of Unit-IV is not as per MCI norms.
2. Resultantly, teaching complement of Units-I,II,III,IV are incomplete.
3. Other deficiencies/observations as pointed out in the inspection report.

In view of the above, the Committee further decided to direct the institution authorities to henceforth stop admission in MD (Obst. & Gynae.) course from the ensuing academic session 2009-2010.

**16. RTM Nagpur University - Recognition of MD (Pharmacology) qualification in respect of students being trained at NKP Salve Institute of Medical Sciences & Research Centre, Nagpur.**

Read: the compliance report togetherwith the Council Inspector's report (April, 2008) on the standard of examination and other teaching facilities available at NKP Salve Institute of Medical Sciences & Research Centre, Nagpur for purpose of recognition of MD (Pharmacology) qualification granted by RTM Nagpur University.

The Postgraduate Committee considered the compliance report togetherwith the Council Inspector's report (April, 2008) and decided to recommend that MD (Pharmacology) qualification granted by RTM Nagpur University in respect of students being trained at NKP Salve Institute of Medical Sciences & Research Centre, Nagpur be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2 (Two) students per year.

**17. The Tamilnadu Dr. MGR Medical University, Chennai - Recognition of DM (Cardiology) qualification in respect of students being trained at Madurai Medical College, Madurai.**

Read: the Council inspector report (August, 2008) on the standard of examination and other teaching facilities available at Madurai Medical College, Madurai for purpose of recognition of DM (Cardiology) qualification granted by the Tamilnadu Dr. MGR Medical University, Chennai.

The Postgraduate Committee considered the Council inspector report (August, 2008) and decided to recommend that DM (Cardiology) qualification granted by the Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Madurai Medical College, Madurai be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2 (Two) students per year.

**18. Dr. NTR University of Health Sciences, Vijayawada - Approval of Andhra Medical College, Vishakapatnam for the award of MD (Biochemistry) qualification in respect of increased intake.**

Read: the Council inspector report (July, 2008) on the standard of examination and other teaching facilities available at Andhra Medical College, Vishakapatnam for purpose of approval of the college for the award of MD (Biochemistry) qualification granted by Dr. NTR University of Health Sciences, Vijayawada in respect of increased intake.

The Postgraduate Committee considered the Council inspector report (July, 2008) and decided to recommend that Andhra Medical College, Vishakapatnam be approved for the award of MD (Biochemistry) qualification granted by Dr. NTR University of Health Sciences, Vijayawada in respect of increased intake restricting the number of admissions to 2 (Two) to 4 (Four) students per year.

**19. Chhatrapati Sahuji Maharaj Medical University, Lucknow - Recognition of M.Ch. (Surgical Oncology) qualification in respect of students being trained at Chhatrapati Sahuji Maharaj Medical University, Lucknow.**

Read: the Council inspector report (October, 2007) on the standard of examination and other teaching facilities available at Chhatrapati Sahuji Maharaj Medical University, Lucknow for purpose of recognition of M.Ch. (Surgical Oncology) qualification granted by the Chhatrapati Sahuji Maharaj Medical University, Lucknow.

The Postgraduate Committee considered the Council inspector report (October, 2007) and decided not to recommend that M.Ch. (Surgical Oncology) qualification granted by the Chhatrapati Sahuji Maharaj Medical University, Lucknow in respect of students being trained at Chhatrapati Sahuji Maharaj Medical University, Lucknow because of the following reasons:-

- (i) Unit-wise bed strength is not as per MCI norms.
- (ii) Promotion of Dr. Sanjiv Mishra - Unit -III is not as per MCI norms.
- (iii) Operative workload is inadequate (major operations 10 per week & minor operations 15 per week).
- (iv) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.Ch. (Surgical Oncology) course from the academic session 2009-2010.

**20. Andhra University, Andhra Pradesh University of Health Sciences, Vijayawada & NTR University of Health Sciences, Vijayawada - Recognition of M.D.(Radiology/Radio-Diagnosis) qualification in respect of students being trained at Andhra Medical College, Visakhapatnam.**

Read: the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report (May, 2001) on the standard of examination and other teaching facilities available at Andhra Medical College, Visakhapatnam for purpose of recogniton of M.D.(Radiology/Radio-Diagnosis) qualification granted by Andhra University, Andhra Pradesh University of Health Sciences, Vijayawada & NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report (May, 2001) and decided not to recommend that M.D.(Radiology/Radio-Diagnosis) qualification granted by Andhra University, Andhra Pradesh University of Health Sciences, Vijayawada & NTR University of Health Sciences, Vijayawada in respect of students being trained at Andhra Medical College, Visakhapatnam because of the following reasons:-

- (i) Mammography and DSA angiography are not available.
- (ii) Resultantly, instrumentation is inadequate.
- (iii) Dr. G.V. Prasad - Assoc. Prof., Dr. P. Bujji Babu - Assoc. Prof. & Dr. B. Surendra - Asst. Prof. are not having the recognized postgraduate qualifications.
- (iv) Other deficiencies/observations as pointed out in the inspection report.



In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.D.(Radiology/Radio-Diagnosis) course from the academic session 2009-2010.

**21. Nagpur University - Recognition of MS(Orthopaedics) and D.Ortho. qualifications in respect of students being trained at Mahatma Gandhi Instt, of Medical Sciences, Sevagram, Wardha.**

Read: the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report [November, 99] on the standard of examination and other teaching facilities available at Mahatma Gandhi Institute of Medical Sciences, Sevagram, Wardha for recognition of MS(Ortho.) & D.Ortho. qualifications granted by Nagpur University.

The Postgraduate Committee considered the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report [November, 99] and decided to advise the institution authorities to re-organize the units in respect of teaching faculty as per MCI norms.

The Postgraduate Committee further decided to defer the consideration of the matter till the information is received.

**22. MGM University of Health Sciences (Deemed University) - Recognition of MD (Anaesthesia) qualification in respect of students being trained at MGM Medical College, Navi Mumbai.**

Read: the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report (May, 2007) on the standard of examination and other teaching facilities available at MGM Medical College, Navi Mumbai for purpose of recognition of MD (Anaesthesia) qualification granted by MGM University of Health Sciences (Deemed University).

The Postgraduate Committee considered the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report (May, 2007) and noted that Dr. Sunil Pal, Asst. Prof., does not possess the requisite prescribed academic qualifications. However, even without him the teaching complement is complete; and decided to recommend that MD (Anaesthesia) qualification granted by MGM University of Health Sciences (Deemed University) in respect of students being trained at MGM Medical College, Navi Mumbai be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. - i) Dr. T.S. Chandra Gupta, Prof. and Head, does not possess recognized postgraduate qualification.
- ii) There is no Associate Professor in the unit.
- iii) Resultantly, teaching complement is incomplete.
- iv) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admission in MD (Venereology) course from the ensuing academic session 2009-10.

**24. Osmania University, Andhra Pradesh University of Health Sciences, Vijayawada & NTR University of Health Sciences, Vijayawada - Recognition of M.D.(Psychiatry) & D.P.M. qualifications in respect of students being trained at Osmania Medical College, Hyderabad.**

Read: the compliance verification report (July, 2008) togetherwith the compliance and the Council Inspector's report (May, 2001) on the standard of examination and other teaching facilities available at Osmania Medical College, Hyderabad for purpose of recognition of M.D.(Psychiatry) & D.P.M. qualifications earlier granted by Osmania University, Andhra Pradesh University of Health Sciences, Vijayawada & now by NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the compliance verification report (July, 2008) togetherwith the compliance and the Council Inspector's report (May, 2001) and decided to advise the institution authorities to re-organize the units in terms of teaching faculty as per MCI norms.

The Postgraduate Committee further decided to defer the consideration of the matter till the information is received.

**25. MGM University of Health Sciences (Deemed University) - Recognition of MD (General Medicine) qualification in respect of students being trained at MGM Medical College, Navi Mumbai.**

Read: the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report (May, 2007) on the standard of examination and other teaching facilities available at MGM Medical College, Navi Mumbai for purpose of recognition of MD (General Medicine) qualification granted by MGM University of Health Sciences (Deemed University).

The Postgraduate Committee considered the compliance verification report (August, 2008) togetherwith the compliance and the Council Inspector's report (May, 2007) and noted that Dr. Sandeep Ari, Assoc. Prof., Unit -II, Dr. Mitesh Thakkar, Asst. Prof., Unit-III and Dr. Rajesh Benny, Asst. Prof. Unit-IV, do not possess requisite prescribed academic qualifications. However, even without them the teaching complement is complete and decided to recommend that MD (General Medicine) qualification granted by MGM University of Health Sciences (Deemed University) in respect of students being trained at MGM Medical College, Navi Mumbai be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 4 (Four) students per year.

**26. Recognition of MD (Dermatology and STD) qualification in respect of B.P. Koirala Institute of Health Sciences, Dharan, Nepal**

Read: the compliance verification report (August, 2008) togetherwith the Council inspector report (Sept, 2005) on the standard of examination and other teaching facilities available at B.P. Koirala Institute of Health Sciences, Dharan, Nepal for recognition of MD (Dermatology & STD) qualification granted by B.P. Koirala Instt. of Health Sciences, Dharan, Nepal (Autonomous University).

The Postgraduate Committee considered the compliance verification report (August, 2008) togetherwith the Council inspector report (Sept, 2005) and decided not to recognise MD (Dermatology & STD) qualification granted by B.P. Koirala Instt. of Health Sciences, Dharan, Nepal (Autonomous University) in respect of students being trained at B.P. Koirala Institute of Health Sciences, Dharan, Nepal because of the following:-

1. Promotions of Dr. S Agarwal, Prof. & HOD, Dr. Tapan Kumar Dhali, Assoc.Prof. & Dr. Arpana Rijal, Assoc. Prof. are not as per MCI norms.
2. Resultantly, teaching complement is incomplete.
3. Bed occupancy is 30%.
4. Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admission in MD (Dermatology & STD) course from the ensuing academic session 2009-2010.

**27. Kerala University - Recognition of DM (Nephrology) qualification in respect of students being trained at Medical College, Thiruvananthapuram.**

Read: the compliance verification report (August, 2008) togetherwith the compliance and the inspection report (May 2004) carried out to assess the standard of examination and other teaching facilities available at Medical College, Thiruvanthapuram for purpose of recognition of D.M.(Nephrology) qualification granted by Kerala University.

The Postgraduate Committee considered the compliance verification report (August, 2008) togetherwith the compliance and the inspection report (May 2004) and decided to recommend that D.M.(Nephrology) qualification granted by Kerala University in respect of students being trained at Medical College, Thiruvanthapuram be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 1 (One) student per year.

**28. The Tamilnadu Dr. MGR Medical University, Chennai - Approval of Christian Medical College, Vellore for the award of DM (Neurology) qualification in respect of increased intake.**

Read: the Council inspector report (August, 2008) on the standard of examination and other teaching facilities available at Christian Medical College, Vellore for purpose of approval of the college for the award of DM (Neurology) qualification granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of increased intake.

**29. University of Mumbai - Recognition of M.Ch. (Urology/Genito-Urinary Surgery) qualification in respect of students being trained at Bombay Hospital Institute of Medical Sciences, Mumbai.**

Read: the Council inspector report (August, 2008) on the standard of examination and other teaching facilities available at Bombay Hospital Institute of Medical Sciences, Mumbai for purpose of recognition of M.Ch. (Urology/Genito-Urinary Surgery) qualification granted by University of Mumbai.

The Postgraduate Committee considered the Council inspector report (August, 2008) and decided not to recognise M.Ch. (Urology/Genito-Urinary Surgery) qualification granted by University of Mumbai in respect of students being trained at Bombay Hospital Institute of Medical Sciences, Mumbai because of the following:-

1. Dr. B.K. Goyal, Dean is more than 70 years of age.
2. Dr. A.K. Phadle, Prof. & Head & Dr. D.D. Gaur, Assoc. Prof., both are more than 72 years of age.
3. Dr. S.W. Thatte, Assoc. Prof., does not have the required prescribed academic qualification.
4. Dr. J.N. Kulkani, Assoc. Prof. not having recognized Postgraduate qualification.
5. Resultantly, teaching complement is incomplete.
6. Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admission in M.Ch. (Urology/Genito-Urinary Surgery) course from the ensuing academic session 2009-2010.

**30. Regarding documentation of Post Graduate course in Pathology as a para-clinical subject.**

Read: the letter dated nil from the Residents of Pramukhswami Medical College, Karmsad seeking a document stating that postgraduate course in pathology as a para clinical subject and some confusion regarding the fees structure for the academic year 2008-2009.

The Postgraduate Committee considered the letter dated nil from the Residents of Pramukhswami Medical College, Karmsad and noted that there is no clear cut definition about the para clinical in the Postgraduate Medical Education Regulations, 2000. However, in the Graduate Medical Education Regulations, 1997 of Medical Council of India in page -13 categorically stated that "*The Para-clinical subjects shall consist of Pathology, Pharmacology, Microbiology, Forensic Medicine including Toxicology and part of Community Medicine*" and in Page 95 of the said regulations at Appendix-C under the heading "prescribed teaching hours and suggested model time tables" has been shown as a para clinical subject.

In view of above, the Postgraduate Committee decided to refer the matter to the Executive Committee for its consideration and appropriate decision in this regard.

**31. Starting of M.S.(Ophthalmology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule affiliated to North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956- consideration of compliance regarding.**

Read: the compliance verification inspection report (June, 2008) on the physical and other teaching facilities available at Annasaheb Chavdaman Patil Memorial Medical College, Dhule under North Maharashtra University, Jalgaon for starting of M.S.(Ophthalmology) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification inspection report (June, 2008) and noted that (i) Dr. Sanjeevani S Deore, Lecturer and Dr. Maneesh M Bapaye, Lecturer are not having prescribed academic qualifications and (ii) Dr. Sanjay V Vaghamre, Lecturer is not having the recognized postgraduate qualification. Even without them the teaching complement is complete; and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(Ophthalmology) course at Annasaheb Chavdaman Patil Memorial Medical College, Dhule under North Maharashtra University, Jalgaon u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 1 (One) student per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**32. Non- teaching hospital - Continuation of recognition of Central Railway Hospital, Bhusawal for housemanship - consideration of inspection report reg.**

Medical College, Tirupati for purpose of approval of the college for the award of DGO qualification granted by Dr. NTR University of Health Sciences, Vijayawada in respect of increased intake.

The Postgraduate Committee considered the Council inspector report (July, 2008) and decided to recommend that S.V. Medical College, Tirupati be approved for the award of DGO qualification granted by Dr. NTR University of Health Sciences, Vijayawada in respect of increased intake restricting the number of admissions to 4 (Four) students per year prospectively i.e. from the academic year 2009-10.

**38. Dr. D.Y. Patil University, Navi Mumbai - Recognition of MS (Orthopaedics) qualification in respect of students being trained at Dr. DY Patil Medical College Hospital & Research Centre, Navi Mumbai.**

Read: the compliance verification report (Sept, 2008) togetherwith the compliance and the Council inspector report (June, 2008) on the standard of examination and other teaching facilities available at Dr. D.Y. Patil Medical College Hospital & Research Centre, Navi Mumbai for purpose of recognition of M.S. (Orthopaedics) qualification granted by Dr. D.Y. Patil University, Navi Mumbai.

Patil Medical College Hospital & Research Centre, Navi Mumbai because of the following reasons:-

- (i) Dr. Sanjay Dhar who has recently joined as Associate Professor could not be considered as he did not have relieving order from the previous institute.
- (ii) There is no separate dressing room for outdoor patients. There is only one room which is used for applying plaster, splints & dressing etc. and ethically two separate rooms for wound dressing, stitch removal, minor procedure and plaster are needed.
- (iii) There is no publication of the department.
- (iv) The clinical material; bed occupancy was 70% but 20% patients were of non clinical significance. There were about 95 patients in OPD, one patient in Casualty and there are only 2-3 operations of Orthopaedics for a day. In light of this, the clinical material is deficient.
- (v) The teaching schedule is also not followed properly. There are one seminar for a month, two grand round per month, case presentation once in 10 days. There is no journal club etc. Hence, the teaching is also not upto the mark.
- (vi) There is no research lab. in the department.
- (vii) Other deficiencies/observations as pointed out in the inspection report.

The Postgraduate Committee also reiterate its earlier decision taken in its meeting held on 02.07.2008 to direct the institution authorities to henceforth stop admissions in M.S. (Orthopaedics) course from the academic session 2009-2010.

- (ii) Dr. B.Raghavendra Rao, Associate Professor, Dr. Ch.Madhubabu, Assistant Professor and Dr. Mohan Rao, Assistant Professor of Unit -I and Dr. M.A. Gaffar, Professor & Incharge of Unit -II, Dr. G.S.N. Reddy - Assistant Professor & Dr. Rajeev Singh, Assistant Professor of Unit II are not having recognized Postgraduate qualifications.
- (iii) Incharge of Unit -III, Dr. G. Manmohan is only in the rank of Assistant Professor.
- (iv) Resultantly, teaching complement is incomplete.
- (v) Other deficiencies/observations as pointed out in the inspection report.

Act,1956 restricting the number of admission to 1 (One) student per year.

**42. The Tamilnadu Dr. MGR Medical University, Chennai - Approval of Christian Medical College, Vellore for the award of M.Ch. (Urology) qualification in respect of increased intake.**

Read: the Council inspector report (August, 2008) on the standard of examination and other teaching facilities available at Christian Medical College, Vellore for purpose of approval of the college for the award of M.Ch. **43. The Tamilnadu Dr. MGR Medical University, Chennai - Approval of Christian Medical College, Vellore for the award of DM (Gastroenterology) qualification in respect of increased intake.**

Read: the Council inspector report (August, 2008) on the standard of examination and other teaching facilities available at Christian Medical College, Vellore for purpose of approval of the college for the award of DM (Gastroenterology) qualification granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of increased intake.

The Postgraduate Committee considered the Council inspector report (August, 2008) and noted that Dr. C.E. Eapen, Professor & Dr. R Jeyamani, Professor of Unit -II, the promotion of these 2 teachers are not as per MCI norms. However, even without them the unit -II is complete and decided to recommend that Christian Medical College, Vellore be approved for the award of DM (Gastroenterology) qualification granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of increased intake restricting the number of admissions to 2(Two) to 4 (Four) students per year.

**44. Dr. NTR University of Health Sciences, Vijayawada - Recognition of DO qualification in respect of students being trained at S.V.S. Medical College, Mahabubnagar.**

Read: the Council inspector report (July, 2008) on the standard of examination and other teaching facilities available at S.V. Medical College, Tirupati for purpose of recognition of M.S. (Orthopaedics) qualification earlier granted by Sri Venkateshwara University, Tirupati, Andhra Pradesh University of Health Sciences, Vijayawada and now by NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the Council inspector report (July, 2008) and decided to ask the institution to provide unit-wise distribution of beds vis-à-vis teaching faculty as per MCI norms.

The Committee further decided to defer the consideration of the matter till the information is received.

**47. University of Delhi - Recognition of MD (Psychiatry) qualification in respect of Institute of Human Behaviour and Allied Sciences, Delhi - regarding amendment in the notification of Government of India.**

Read: the letter dated 01.09.2008 from the Director, Institute of Human Behaviour and Allied Sciences, Delhi regarding amendment in the earlier notification of Government of India in respect of MD (Psychiatry).

The Postgraduate Committee considered the letter dated 01.09.2008 from the Director, Institute of Human Behaviour and Allied Sciences, Delhi regarding amendment in the earlier notification of Government of India in respect of MD (Psychiatry) and observed that the General Body of the council at its meeting held on 16.11.2007 has approved the following recommendations of the Postgraduate Committee:-

*"The Postgraduate Committee considered the Council Inspector report (April, 2007) and decided to recommend that MD (Psychiatry) qualification granted by Delhi University in respect of students being trained at Instt. of Human Behaviour and Allied Sciences, Delhi be recognized and included in the 1<sup>st</sup> schedule to the I.M.C.Act,1956 restricting the number of admissions to 2 (two) students per year."*

Thereafter, the Central Govt. vide its letter dated 10.07.2008 has notified that MD (Psychiatry) qualification of Instt. of Human Behaviour and Allied Sciences, Delhi with following proviso:-

*"This qualification shall be a recognized medial qualification when granted on or after April, 2007."*

The Postgraduate Committee further observed vide letter dated 01.09.2008 of the Director of the institute has informed that MD (Psychiatry) has started in 2003 and first batch of examination and passed 2006, examination was held in the year 2006, further requesting the Council to rectify the error apparent in the record.

In view of above, the Postgraduate Committee decided that the MD(Psychiatry) course run by the institute under the Delhi University be recognized w.e.f. 2006.

**48. Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University - Recognition of M.S. (Ophthalmology) qualification in respect students being trained at B.R.D. Medical College, Gorakhpur.**

Read: the compliance togetherwith the inspection report (May, 2006) carried out to assess the standard of examination and other teaching facilities available at B.R.D. Medical College, Gorakhpur for purpose of recognition of M.S. (Ophthalmology) qualification granted by Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University.

The Postgraduate Committee considered the compliance togetherwith the inspection report (May, 2006) and decided to recommend that M.S. (Ophthalmology) qualification granted by Deen Dayal Upadhyaya Gorakhpur University/ Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 2 (Two) students per year prospectively i.e. from the academic year 2009-10.

**49. Dr. NTR University of Health Sciences, Vijayawada - Approval of Andhra Medical College, Vishakapatnam for the award of MS (Orthopaedics) qualification in respect of increased intake.**

Read: the Council inspector report (July, 2008) on the standard of examination and other teaching facilities available at Andhra Medical College, Vishakapatnam for purpose of approval of the college for the award of MS (Orthopaedics) qualification granted by Dr. NTR University of Health Sciences, Vijayawada in respect of increased intake.

The Postgraduate Committee considered the Council inspector report (July, 2008) and decided to recommend not to approve Andhra Medical College, Vishakapatnam for the award of M.S. (Orthopaedics) qualification granted by Dr. NTR University of Health Sciences, Vijayawada because of the following reasons:-

- (i) Clinical material is inadequate.
- (ii) Dr. N.V.S. Kiran Kumar, Asst. Prof., Unit-I not having prescribed academic qualifications. He has stated in his Declaration form that he possess 5 years

experience in the Department of Anatomy as Tutor, which is not the subject concerned. Hence, not considered.

(iii) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.S. (Orthopaedics) course from the academic session 2009-2010.

**50. Saurashtra University–Recognition of MD(Radio-Diag.) & DMRD qualifications in respect of students being trained at M.P. Shah Medical College, Jamnagar.**

Read: the compliance togetherwith the Council Inspector report (May, 1998) on the standard examination and other teaching facilities available at M.P. Shah Medical College, Jamnagar for purpose of recognition of MD (Radio-Diag.) & DMRD qualifications granted by Saurashtra University.

The Postgraduate Committee considered the compliance togetherwith the Council Inspector report (May, 1998) and decided to recommend that MD (Radio-Diag.) & DMRD qualifications granted by Saurashtra University in respect of students being trained at M.P. Shah Medical College, Jamnagar be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 5 (Five) students per year in MD (Radio-Diag.) course and 2(Two) students per year in DMRD course commensurate with the number of available PG teachers in the department.

**51. Dr. NTR University of Health Sciences, Vijayawada - Recognition of MS (Ortho.) & D.Ortho. qualification in respect of students being trained at Kamineni Institute of Medical Sciences, Narkatpally.**

Read: the compliance dated 16.09.2008 from the Principal, Kamineni Institute of Medical Sciences, Narkatpally togetherwith the Council inspector report (July, 2008) on the standard of examination and other teaching facilities available at Kamineni Institute of Medical Sciences, Narkatpally for purpose of recognition of MS (Ortho) & D.Ortho. qualifications granted by Dr. NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the compliance dated 16.09.2008 from the Principal, Kamineni Institute of Medical Sciences, Narkatpally togetherwith the Council Inspector report (July, 2008) and decided to recommend that MS (Ortho.) & D. Ortho. qualifications granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narkatpally be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 3 (three) students in M.S. (Ortho.) & 2 (two) students in D.Ortho. per year.

**52. Sanjay Gandhi Postgraduate Institute of Medical Sciences (Deemed University), Lucknow - Recognition of M.Ch. (CTVS) qualification in respect of Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow - regarding amendment in the notification of Government of India.**

Read: the letter dated 03.09.2008 from the Director, Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow regarding amendment in the earlier notification of Government of India in respect of M.Ch. (CTVS).

The Postgraduate Committee considered the letter dated 03.09.2008 from the Director, Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow regarding amendment in the earlier notification of Government of India in respect of M.Ch. (CTVS) and directed to the office to obtain the clarification from the institute that, though the permission was given to start the course in 1992, under what circumstances the course was started in the year 1990 and the students admitted therein.

**53. University of Mumbai- Recognition of DM (Nephrology) qualification in respect of students being trained at Bombay Hospital Institute of Medical Sciences, Mumbai.**

Read: the Council inspector report (August, 2008) on the standard of examination and other teaching facilities available at Bombay Hospital Institute of Medical Sciences, Mumbai for purpose of recognition of DM (Nephrology) qualification granted by University of Mumbai.

The Postgraduate Committee considered the Council inspector report (August, 2008) and decided not to recommend that DM (Nephrology) qualification granted by University of Mumbai in respect of students being trained at Bombay Hospital Institute of Medical Sciences, Mumbai because of the following:-

- (i) Dr. B.K. Goel, Dean, is more than 70 years of age.
- (ii) Dr. A.K. Kirplani, Prof. & Head, Dr. Shrirang Bichu, Assoc. Prof. & Dr. Vikram Agarwal, Lecturer are not having prescribed academic qualifications.
- (iii) Resultantly, teaching complement is incomplete.
- (iv) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in DM (Nephrology) course from the academic session 2009-2010.

**54. Osmania University & NTR University of Health Sciences, Vijayawada - Recognition of DM (Cardiology) qualification in respect of students being trained at Osmania Medical College, Hyderabad.**

Read: the compliance verification report (Sept, 2008) togetherwith compliance and the Council inspector's report (June, 2001/1.4.2008) on the standard of examination and other teaching facilities available at Osmania Medical College, Hyderabad for purpose of recognition of DM (Cardiology) qualification earlier granted by Osmania University and now by NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the compliance verification report (Sept, 2008) togetherwith compliance and the Council inspector's report (June, 2001/1.4.2008) and decided to recommend that DM (Cardiology) qualification earlier granted by Osmania University and now by NTR University of Health Sciences, Vijayawada in respect of students being trained at Osmania Medical College, Hyderabad be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 1 (one) student per year.

**55. Dr. NTR University of Health Sciences, Vijayawada - Recognition of MD (Pathology) qualification in respect of students being trained at Kamineni Institute of Medical Sciences, Narkatpally.**

Read: the Council inspector report (July, 2008) on the standard of examination and other teaching facilities available at Kamineni Institute of Medical Sciences, Narkatpally for purpose of recognition of MD (Pathology) qualification granted by Dr. NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the Council inspector report (July, 2008) and decided to recommend that MD (Pathology) qualification granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narkatpally be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2 (Two) students per year.

**56. Admission made in various postgraduate medical courses after the last date for the academic session 2008-09 as prescribed by Supreme Court in its order no. IA 17/2008 in Writ Petition (Civil) No. 157 of 2005 - Amit Gupta Vs Union of India & anr Dated. 2<sup>nd</sup> May, 2008.**

Read: the matter with regard to admission made in various postgraduate medical courses after the last date for the academic session 2008-09 as prescribed by Supreme Court in its order no. IA 17/2008 in Writ Petition (Civil) No. 157 of 2005 - Amit Gupta Vs Union of India & anr Dated. 2<sup>nd</sup> May, 2008.

The Postgraduate Committee considered the matter with regard to admissions made in various Postgraduate medical courses after the last date i.e. 10<sup>th</sup> June, 2008 (By the order of the Hon'ble Court) for the academic session 2008-09 and noted that the following medical colleges admitted the students after the permitted last date by the Hon'ble Court i.e.10<sup>th</sup> June, 2008; thus violating the prescribed regulatory schedule of admissions by the Council: -

**59. Starting of MD (Sports Medicine) Course at Guru Nanak Dev University, Amritsar.**

Read: the letter dated 28.08.2008 received from the Registrar, Guru Nanak Dev University, Amritsar regarding starting of MD (Sports Medicine) course at Guru Nanak Dev University, Amritsar.

The Postgraduate Committee considered the letter dated 28.08.2008 received from the Registrar, Guru Nanak Dev University, Amritsar regarding starting of MD (Sports Medicine) course at Guru Nanak Dev University, Amritsar wherein they have mentioned the relevant portion of the Punjab Act No.21 of 1969 is reproduced as under:-

*"4. The University shall exercise the following powers and perform the following duties, namely:*

- (1) *to make provision for imparting education and for promoting research in the humanities learned professions, sciences especially of applied nature, technology and such other branches of learning and courses of study as it may think fit."*

In view of above, the Postgraduate Committee is of the opinion that there is no necessity of a separate Essentiality Certificate from the Govt. of Punjab and the office is directed to taken action according to rules/procedure.

**60. NTR University of Health Sciences, Vijayawada - Recognition of DM (Clinical Pharmacology) qualification in respect of students being trained at Osmania Medical College, Hyderabad.**

Read: the Council inspector report (July, 2008) on the standard of examination and other teaching facilities available at Osmania Medical College, Hyderabad for purpose of recognition of DM (Clinical Pharmacology) qualification granted by NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the Council Inspector's Report (July, 2008) and decided not to recognize DM (Clinical Pharmacology) qualification in respect of students being trained at Osmania Medical College, Hyderabad because of the following:-

- 1) In the library the journals have not been properly displayed. The subscription for all the journals i.e. both national and foreign is available only up to December, 2006 and no journal is available after 2006.
- 2) The validity of license of the blood bank was up to November, 2006 only. Though the renewal has been applied for but it is not available as on now.
- 3) The Department does not seem to be fully functional and is presently providing some drug information service and therapeutic monitoring service to the hospital.
- 4) The total space provided for the department is inadequate. The infrastructure provided is very old and requires massive renovation work.
- 5) The space provided for the various laboratories is not adequate.

- 6) There is no space available for the office of the Professor and Head of the Department. There is no space provided for the residents of the department.
- 7) There is no space available for the office of the department.
- 8) No demonstration room is available in the department.
- 9) Dr. Shobha Jagdish Chandra who is presently the Professor & Head of the Department of Clinical Pharmacology is not a regular faculty member at the Osmania Medical College and Hospital. She has been working as an Additional Professor in Clinical Pharmacology at Nizam's Institute of Medical Sciences, Hyderabad and has been given a temporary appointment at Osmania Hospital as Professor and HOD since 16<sup>th</sup> July, 2008 barely one week before the inspection. Her orders clearly state that she is being deputed at Osmania Hospital till further orders. She is also not having prescribed academic qualification.
- 10) No regular steno-typist/clerk available.
- 11) The laboratory staff is inadequate. There is only one laboratory technician for all the laboratories.
- 12) No laboratory attendants are available in any of the laboratories.
- 13) There is only one sweeper for whole of the department.
- 14) In the kinetics and chemical laboratory though the HPLC is available but it has been kept in such a small area that functioning is not practically possible. The necessary accessories with the HPLC are not available.
- 15) No auto analyzer for the routine biochemical investigations is available.
- 16) The other necessary equipments like a spectrofluorometer, flame photometer, distillation apparatus, deionizer, cold centrifuge etc. are not available.
- 17) The clinical pharmacology (Pharmacodynamics Lab.) is hardly equipped. Except an ECG machine there is no other equipment available in the laboratory and hardly any pharmacodynamic studies can be under taken in the laboratory.
- 18) In the clinical pharmacology laboratory (for carrying out bioequivalence studies) only some beds have been provided without any other equipment at all. No other furniture and equipment has been provided in the dining hall for the volunteers and the sampling room. No emergency kit, emergency drugs have been provided.
- 19) Resultantly, instrumentation is grossly inadequate.
- 20) No departmental library available. The number of books available in the departmental library is grossly inadequate (hardly 25 books available). Even the books are not really meant for the training of the DM students.
- 21) The teaching rosters to undertake the training were neither displayed nor provided during the course of inspection.
- 22) The DM residents are not participating in the UG teaching for the training purposes.

In view of the above, the Committee further decided to direct the institution authorities to henceforth stop admissions in DM (Clinical Pharmacology) course from the academic session 2009-2010.

**61. Marathwada University/Dr.Baba Saheb Ambedkar Marathwada University, Aurangabad and Maharashtra University of Health Sciences, Nashik - Recognition of DLO Qualification in respect of students being trained at Govt. Medical College, Aurangabad**

Read: the compliance verification report (Sept, 2008) togetherwith the inspection report (Feb., 2005) on the standard of examination and other teaching facilities available at Govt. Medical College, Aurangabad for purpose of recognition of DLO qualification earlier granted by Marathwada University and now by Dr. Baba Saheb Ambedkar Marathwada University, Aurangabad.

The Postgraduate Committee considered the compliance verification report (Sept, 2008) togetherwith the inspection report (Feb., 2005) and decided to recommend

DLO qualification earlier granted by Marathwada University and now by Dr. Baba Saheb Ambedkar Marathwada University, Aurangabad in respect of student being trained at Govt. Medical College, Aurangabad be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 1 (One) student per year prospectively i.e. from the academic year 2009-10.

**62. Dr. D.Y. Patil University, Navi Mumbai - Recognition of MD (Pharmacology) qualification in respect of students being trained at Dr. DY Patil Medical College Hospital & Research Centre, Navi Mumbai.**

Read: the compliance verification report (Sept. 2008) togetherwith compliance and the Council Inspector's Report (May, 2008) on the standard of examination and other teaching facilities available at Dr. D.Y. Patil Medical College Hospital & Research Centre, Navi Mumbai for purpose of recognition of MD (Pharmacology) qualification granted by Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Committee considered the compliance verification report (Sept, 2008) togetherwith compliance and the Council Inspector's Report (May, 2008) and decided to recommend that MD (Pharmacology) qualification granted by Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Dr. D.Y. Patil Medical College Hospital & Research Centre, Navi Mumbai be recognized and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 restricting the number of admissions to 2 (Two) students per year.

**63. Starting of M.Ch. (Urology) course at Dr. D.Y. Patil Medical College, Pimpri, Pune under the Institute (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: the compliance verification report (Sept, 2008) on the physical and other teaching facilities available at Dr. D.Y. Patil Medical College, Pimpri, Pune under the Institute (Deemed University) for consideration of starting of M.Ch.(Urology).

The Postgraduate Committee considered the compliance verification report (Sept, 2008) and noted Dr. Vikram P. Satav, Asst./Lecturer, is not having prescribed academic qualifications. However, the teaching component is complete without him and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.Ch.(Urology) course at Dr. D.Y. Patil Medical College, Pimpri, Pune under the Institute (Deemed University) u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 1 (One) student per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**64. Dr. NTR University of Health Sciences, Vijayawada - Recognition of MD (Paediatrics) qualification in respect of students being trained at Siddhartha Medical College, Vijayawada.**

The Postgraduate Committee considered the compliance dated 18.09.2008 from the Principal, Siddhartha Medical College, Vijayawada togetherwith the Council inspector's report (July, 2008) and decided not to recognize MD (Paediatrics)

qualification granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Siddhartha Medical College, Vijayawada because of the following reasons:-

- (i) Unit -II is having only 2 teachers.
- (ii) Resultantly, teaching complement is incomplete.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (Paediatrics) course from the academic session 2009-2010.

65. (i) **A.P./NTR University of Health Sciences, Vijayawada - Recognition of MD(Radio-Diagnosis) qualification in respect of students being trained at Deccan College of Medical Sciences, Hyderabad.**
- (ii) **Starting of DMRD course at Deccan College of Medical Sciences, Hyderabad affiliated to NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act,1956.**

Read: the compliance verification report (Sept, 2008) togetherwith the compliance and inspection report (July 2006) carried out to assess the standard of examination and other teaching facilities available at Deccan College of Medical Sciences, Hyderabad for purpose of recognition of MD(Radio-Diagnosis) qualification granted by A.P./NTR University of Health Sciences, Vijayawada.

The Postgraduate Committee considered the compliance verification report (Sept, 2008) togetherwith the compliance and inspection report (July 2006) and decided not to recommend recognition of MD(Radio-Diagnosis) qualification granted by A.P./NTR University of Health Sciences, Vijayawada in respect of students being trained at Deccan College of Medical Sciences, Hyderabad because of the following reasons:-

- (i) Dr. M. A. Mateen, Assoc. Prof. does not have the requisite prescribed academic qualifications.
- (ii) Resultantly, teaching complement is incomplete.
- (iii) Other deficiencies/observations as pointed out in the inspection report.

The Committee further decided to recommend to the Central Govt. not to issue Letter of Intent for starting of D.M.R.D. course at Deccan College of Medical Sciences, Hyderabad affiliated to NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act,1956 due to the deficiencies quoted above.

In view of above, the Committee further decided to direct the institution authorities to henceforth stop admissions in M.D. (Radio Diagnosis) course from the academic session 2009-2010.
