**3. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MS(Ophthalmology) qualification against increased intake from 01 to 02 seats in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore - Karnataka.**

Read: the Assessment Report (June, 2014) on the standard of examination and other teaching facilities for Recognition of MS(Ophthalmology) qualification against increased intake from 01 to 02 seats at A. J. Institute of Medical Sciences, Mangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council assessor's report (June, 2014) and decided to recommend not to recognize MD(General Medicine) qualification against increased intake from 04 to 08 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore because of the following facts:-

1. Most of indoor beds are vacant on day of assessment. There are less number of academic cases.
2. Seminars conducted are less.
3. Academic teaching is of poor quality.
4. Academic publications are very few. Published journals are not reputed ones.
5. Other deficiencies as pointed out in the Assessment Report.

J. Institute of Medical Sciences, Mangalore because of the following facts:-

1. Dr. Kavitha Ashok Kumar, Professor was absent on the day of assessment.
2. Promotion of Dr. Sheetal Dharangut, Assoc. Professor is not as per regulation. She has been Asst. Professor for 4 years 5 months without 2 publications in indexed Journal.
3. Daily Major Surgeries are less and on day of assessment (i.e. 05/06/2014), no cases were posted for operation.
4. Other deficiencies as pointed out in the Assessment Report.

**9. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Biochemistry) qualification for 1 (One) seat in respect of students being trained at Basaveswara Medical College and Hospital, Chitradurga - Karnataka.**

**11. Himachal Pradesh University - Recognition of MD(Pharmacology) qualification for 1 (One) seat in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P - Himachal Pradesh.**

2. Back volumes of journals are not available.
3. Deficiency of faculty: (a) Asst. Prof.: 1.
4. Other deficiencies as pointed out in the Assessment Report.

**12. Himachal Pradesh University - Recognition of MS(General Surgery) qualification for 2 (Two) seats in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P - Himachal Pradesh.**

Read: the Assessment Report (June, 2014) on the standard of examination and other teaching facilities for Recognition of MS(General Surgery) qualification for 2 (Two) seats at Dr. Rajendar Prasad Government Medical College, Tanda, H.P granted by Himachal Pradesh University.

The Postgraduate Medical Education Committee considered the Assessment Report (June, 2014) and decided to recommend that MS(General Surgery) qualification granted by Himachal Pradesh University in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P be recognized for 2 (Two) seats and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee considered the Council assessor's report (June, 2014) and decided to recommend not to recognize MD(Biochemistry) qualification for 1 (One) seat granted by Himachal Pradesh University in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P because of the following facts:-

1. Dr. K.K. Sharma, Professor, has acquired qualifications of M.Sc. & Ph.D. from Science faculty of Punjab University and not from Medical faculty as per Regulations; hence he cannot be considered as faculty.
2. Dr. Vinay Malik, Asso. Prof. has acquired qualifications of M.Sc. from Science faculty of Punjab University and not from Medical faculty as per Regulations; hence he cannot be considered as faculty.
3. Dr. S.B. Sharma, Asso. Prof. has acquired qualifications of M.Sc. from Science faculty of Dr. R.M.L. University and not from Medical faculty as per Regulations; hence he cannot be considered as faculty.
4. Except 1 all other faculty members are non-medical, which is beyond the permissible limits.
5. No new books have been added in departmental library in last 3 years.
6. Other deficiencies as pointed out in the Assessment Report.

**14. Himachal Pradesh University - Recognition of MD/MS(Ophthalmology) qualification for 2 (Two) seats in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P - Himachal Pradesh.**

Read: the Assessment Report (June, 2014) on the standard of examination and other teaching facilities for Recognition of MD/MS(Ophthalmology) qualification for 2 (Two) seats at Dr. Rajendar Prasad Government Medical College, Tanda, H.P granted by Himachal Pradesh University.

The Postgraduate Medical Education Committee considered the Council assessor's report (June, 2014) and decided to recommend not to recognize MD/MS(Ophthalmology) qualification for 2 (Two) seats granted by Himachal Pradesh University in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P because of the following facts:-

1. Special clinics like Cornea Clinic are not available.
2. Bed occupancy is only 40 %.
3. No. of major surgeries has decreased from 767 in 2011 when the first batch of PG students was admitted to 665 in 2013. Daily average of major operations is only 2-3.
4. No journals on Ophthalmology since 2011 are available in the library.
5. Other deficiencies as pointed out in the Assessment Report.

**15. Himachal Pradesh University - Recognition of MS(ENT) qualification for 2 (Two) seats in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P - Himachal Pradesh.**

The Postgraduate Medical Education Committee considered the Council assessor's report (June, 2014) and decided to recommend not to recognize MD(Radio Diagnosis) qualification for 2 (Two) seats granted by Himachal Pradesh University in respect of students being trained at Dr. Rajendar Prasad Government Medical College, Tanda, H.P because of the following facts:-

1. Deficiency of faculty for PG: (a) Asso. Prof.: 1.
2. Shortage of Senior Residents: 6.
3. No new books have been added in departmental library in last 3 years.
4. Only 4 static X-ray machines are available against requirement of 5 as per Regulations.
5. Only 3 mobile X-ray machines are available against requirement of 6 as per Regulations.
6. DSA is not available.
7. Other deficiencies as pointed out in the Assessment Report.

**17. Baba Farid University of Health Sciences, Faridkot - Recognition of MD(Pathology) qualification for 1 (One) seat in respect of students being trained at Guru Govind Singh Medical College, Faridkot - Punjab.**

Read: the Assessment Report (June, 2014) on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification for 1 (One) seat at Guru Govind Singh Medical College, Faridkot granted by Baba Farid University of Health Sciences, Faridkot.

1. Equipment for PG teaching like IF microscope, Cryostat, Tissue embedding center, Coagulometer, etc. are not available.
2. Pathological post-mortems are not performed.
3. Central Research laboratory is not available.
4. Deficiency of faculty for PG: (a) Asso. Prof.: 1.
5. Frozen section is not available.
6. Daily Histopathology 9-11 of the entire hospital is very less.
7. Other deficiencies as pointed out in the Assessment Report.

**18. Baba Farid University of Health Sciences, Faridkot - Recognition of MS(General Surgery) qualification against increased intake from 03 to 04 seats in respect of students being trained at Guru Govind Singh Medical College, Faridkot - Punjab.**

4. The data of major & minor surgeries appear unrealistic.
5. There was no faculty present in Radiology department except one Dr. Siddesh. On asking him, he said that all were on leave for some reason or other.
6. Other deficiencies as pointed out in the Assessment Report.

3. Shortage of Senior Residents: 4.
4. Central Research Laboratory is under the control of ICMR.
5. Units II, III, IV & V have only 2 faculty each; hence they cannot be considered as PG Units.
6. Resultantly deficiency of faculty for PG: (a) Asst. Prof.: 4.
7. Injection room is not available in OPD.
8. Many important equipment as detailed in the report are not available.
9. Investigative facilities like nerve Conduction, EMG are not available.
10. CPC are held only occasionally. Death review meetings are not held.
11. Other deficiencies as pointed out in the Assessment Report.

3. Both the above deficiencies indicate inadequate clinical material

It appeared as if the examiners were in a hurry to go as the first day's examination was over before 4:15 p.m. without involving the assessor.

3. Many of the things could not be assessed as HOD was not in the hospital and even the Asso. Prof. who was accompanying the assessor left before it was over. The juniormost Asst. Prof. did not have about many things which the assessor asked and had no documentary evidence with him.
4. Bed occupancy was 50 % on day of assessment. Average daily bed occupancy is 40 %.
5. Extracts from OPD, wards, Radiology, Pathology, Microbiology, Laboratory registers were not produced in spite of several reminders.
6. There are no Senior Residents.
7. Speciality clinics & services are not provided by the department.
8. Departmental library had only 40 books which are old & outdated. There are no recent purchases in last 3 years.
9. Departmental museum is not available.
10. Working ward side labs are not available.
11. Office accommodation was not shown to the assessor. There is only 1 room of all Asso. Prof. & 1 room for all Asst. Prof. which is inadequate.
12. Fracture clinic was not shown to the assessor.
13. Physiotherapy section was not shown to the assessor.
14. Investigative facilities like Nerve Conduction, EMG, etc. are not shown to the assessor.
15. No information about CPC is available.
16. There is no information about periodic appraisal of candidates before they appear for M.S. examination.
17. Other deficiencies as pointed out in the Assessment Report.

It was a pre-fixed assessment on the date suggested by the Institution/ University. Despite this the Institution had made no attempt to prepare the information/ documents needed for assessment. Not only this, the Dean and HoD showed complete non-co-operation with the Assessor in the assessment of College/ Department. The Postgraduate Medical Education Committee decided to summon the Dean and HoD in person to clarify their view point. A copy of Assessor's remark be sent along to them. The Committee decided that the Institute should approach for recognition of 2 to 3 seats when 3 students are appearing in the examination.

Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. The Postgraduate Medical Education Committee considered the Council assessor's report (June, 2014) and decided to recommend not to recognize MD (Social & Preventive Medicine/Community Medicine) qualification for 4 (Four) seats and DPH qualification for 2 (Two) seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka because of the following facts:-

1. Department library facilities are inadequate. Books are inadequate and journals are not available.
2. Offices for faculty & clerical staff are inadequate. Three faculty members are sitting in one small room.
3. There are no Epidemiology Unit, paramedical sections including Medico-Social Work, Family care study, Health Education, & Biostatistics section.
4. UHC is in private building. It has inadequate clinical material. Clinics like ANC/PNC, Immunization, DOTS, etc. are not run due to which PGs & Interns are deprived of learning National Health programmes in urban setting.
5. RHTC is in private building. It has very less clinical material. Deliveries are very few. Only OPD services are provided. Clinics like ANC/PNC, Immunization, DOTS, etc. are not run due to which PGs & Interns are deprived of learning National Health programmes in rural setting.
6. Other deficiencies as pointed out in the Assessment Report.

**197. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MS(ENT) qualification for 2 (Two) seats in respect of students being trained at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka - Karnataka.**

Read: the Assessment Report (June, 2014) on the standard of examination and other teaching facilities for Recognition of MS(ENT) qualification for 2 (Two) seats at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council assessor's report (June, 2014) and decided to recommend not to recognize MS(ENT) qualification for 2 (Two) seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka because of the following facts:-

1. Daily average of Minor operations is only 2 which is inadequate.
2. Daily total average of major operations is 3 and daily average Histopathological load from the department is also 3 which is not feasible. There is data mismatch.
3. There is no separate Temporal Bone Dissection laboratory. It is a part of PG Center Common research laboratory.
4. Other deficiencies as pointed out in the Assessment Report.

**198. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of M.Ch(Urology) qualification for 1 (One) seat in respect of students being trained at St. Johns Medical College, Bangalore - Karnataka.**
