The Chairman welcomed the members of the Postgraduate Medical Education Committee.

Leave of absence was received from Prof. (Dr. Dhruba Jyoti Borah, Member and Dr. Rani Bhaskaran, Member.

1. <u>Minutes of the last meeting of the Postgraduate Medical Education Committee</u> – confirmation of.

The minutes of the Postgraduate Medical Education Committee meeting held on 15/09/2015 were confirmed in the meeting itself.

2. <u>Minutes of the last meeting of the Postgraduate Medical Education Committee</u> – action taken thereon.

The Postgraduate Medical Education Committee noted & approved the action taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

3. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD/MS(Ophthalmology) qualification against increased intake from 02 to 03 seats in respect of students being trained at Adichunchanagiri Institute of Medical Sciences, Balagangadharanath Nagar.

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD/MS(Ophthalmology) qualification against increased intake from 02 to 03 seats at Adichunchanagiri Institute of Medical Sciences, Balagangadharanath Nagar granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD/MS(Ophthalmology) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Adichunchanagiri Institute of Medical Sciences, Balagangadharanath Nagar because of the following facts:-

- 1. There were NIL surgeries on day of assessment.
- 2. The institute is paying stipend of Rs. 7, 000; Rs. 8, 000 & Rs. 9, 000 p.m. to I/II/III year Residents which is much less than that paid by Govt. of Karnataka to I/II/III year Residents & is contrary to PG Medical Education Regulations.
- 3. Promotion of Dr. R. Jayram, Professor as Asso. Prof. is not as per Regulations as he has been promoted as Asso. Prof. with experience of only 4 years as Asst. Prof. against requirement of 5 years as per Regulations. Consequently, there is a deficiency of Asst. Professor: 1.
- 4. Facilities for Retinal Surgery are not available.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 3 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

4. Rajiv Gandhi University of Health Sciences, Bangalore - Renewal of recognition of MS(General Surgery) qualification for 02 seats in respect of students being trained at Al-Ameen Medical College, Bijapur.

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MS(General Surgery)

qualification for 02 seats at Al-Ameen Medical College, Bijapur granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to renew the recognition of MS(General Surgery) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Al-Ameen Medical College, Bijapur because of the following facts:-

- 1. Specialty clinic like Cardiovascular & Thoracic Surgery clinic is not run.
- 2. Out of 12 Multipara Monitors, 2 are nonfunctional. Out of 5 Electric Cautery, 2 are nonfunctional.
- 3. Promotion of Dr. Vikas G. Bhosale as Asso. Prof. is not as per Regulations as he has been promoted as Asso. Prof. with experience of only 3 years 1 month as Asst. Prof. against requirement of 5 years as per Regulations. Further the same period has been shown twice in the faculty table. His experience as Asst. Prof. is shown as (i) 09/10/2001 to 10/11/2004 & (ii) 12/12/2003 to 11/12/2004; however period from 12/12/2003 to 10/11/2004 of the period shown in (ii) is already covered under period at (i) & hence cannot be counted twice.
- 4. Resultantly, Unit F is not headed by Asso. Prof. It has only 2 faculty & cannot be considered as PG Unit.
- 5. Senior Resident in Unit-I is not eligible. He has no 3 years experience at the time of appointment.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

5. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(Anaesthesiology) qualification against increased intake from 04 to 06 seats and renewal of recognition of MD(Anaesthesiology) qualification for 02 seats and DA qualification for 03 seats in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru.

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesiology) qualification against increased intake from 04 to 06 seats and renewal of recognition of

MD(Anaesthesiology) qualification for 02 seats and DA qualification for 03 seats at Alluri Sitarama Raju Academy of Medical Sciences, Eluru granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Anaesthesiology) qualification against increased intake from 04 to 06 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee also decided to recommend to the Central Government that recognition of MD(Anaesthesiology) qualification for 02 seats and DA qualification for 03 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

6. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Paediatrics) qualification for 01 seat in respect of students being trained at Basaveswara Medical College and Hospital, Chitradurga.

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification for 01 seat at Basaveswara Medical College and Hospital, Chitradurga granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Paediatrics) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Basaveswara Medical College and Hospital, Chitradurga be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

7. <u>Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(Radio Diagnosis) qualification for 01 seat in respect of students being trained at Bhaskar Medical College, Yenkapally.</u>

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Radio Diagnosis) qualification for 01 seat at Bhaskar Medical College, Yenkapally granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Radio

Diagnosis) qualification for 01 seat granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Bhaskar Medical College, Yenkapally because of the following facts:-

- 1. Workload of CT guided procedures like FNAC was NIL on day of assessment. It was only 51 in 2014 which is inadequate.
- 2. Workload of DSA on day of assessment is not provided. It is NIL in last 3 years.
- 3. Dr. N. Sandeep, Dr. K.C. Kranthi, Dr. S. Sunitha, Dr. Kasture A.A., Senior Residents, do not have 3 years experience as a Resident in the department in a medical college; hence they cannot be considered as Senior Residents.
- 4. Resultantly, there is shortage of Senior Residents: 4.
- 5. Academic parameters like Clinical Seminars (12/year), Journal Clubs (11/year), Group Discussions (12/year) are inadequate.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 01 seat after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(DVL) qualification against increased intake from 01 to 02 seats at Chalmeda Anandrao Institute of Medical Sciences, Karimnagar granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(DVL) qualification against increased intake from 01 to 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Chalmeda Anandrao Institute of Medical Sciences, Karimnagar because of the following facts:-

- 1. LASER is not available in the department.
- 2. Specialty clinics like Contact Dermatitis clinic, Acne clinic are not run.
- 3. Workload of LASER procedures is NIL in last 3 years.

- 4. Academic parameters like Theory Classes (12/year) is inadequate.
- 5. Publications during last 3 years only 1. All others are Case Reports, which cannot be considered.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 2 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. 9. Baba Farid University of Health Sciences, Faridkot - Recognition of MD(Radiotherapy) qualification against increased intake from 01 to 02 seats in respect of students being trained at Christian Medical College, Ludhiana.

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Radiotherapy) qualification against increased intake from 01 to 02 seats at Christian Medical College, Ludhiana granted by Baba Farid University of Health Sciences, Faridkot.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Radiotherapy) qualification against increased intake from 01 to 02 seats granted by Baba Farid University of Health Sciences, Faridkot in respect of students being trained at Christian Medical College, Ludhiana because of the following facts:-

- 1. Total number of patients in OPD has decreased from 3, 790 in 2012 to 3, 549 in 2014.
- 2. Total number of patients in IPD has decreased by 71% from 436 in 2012 to 125 in 2014.
- 3. Even though IPD patients have decreased as shown above, weekly clinical load is shown to have increased from 7 in 2012 to 7-10 in 2014 which is not feasible. There is data mismatch.
- 4. Average bed occupancy is 70%.
- 5. There is no Senior Resident.
- 6. HDR Brachytherapy is not available.
- 7. OPD for department of Radiotherapy on the day of assessment is shown as 425 which is not feasible. It also does not tally with total OPD of 930 for the hospital. There is data mismatch.
- 8. Facilities for Radioactive Isotope work are not available.
- 9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 2 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. 10. Pt. B D Sharma Postgraduate Institute of Medical Sciences, Rohtak (Haryana) - Recognition of MD(Anaesthesiology) qualification for 02 seats in respect of students being trained at Command Hospital, Chandimandir.

Read: the Council Assessor's Report (June, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesiology) qualification for 02 seats at Command Hospital, Chandimandir granted by Pt. B D Sharma Postgraduate Institute of Medical Sciences, Rohtak (Haryana).

The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2015) and decided to recommend not to recognize MD(Anaesthesiology) qualification for 02 seats granted by Pt. B D Sharma Postgraduate Institute of Medical Sciences, Rohtak (Haryana) in respect of students being trained at Command Hospital, Chandimandir because of the following facts:-

- 1. 2 Seats were permitted in the year 2009 and recognition assessment was due in 2012, which the Institution never got done. However, they have been admitting students after 2012 as well, which is not as per Regulations.
- 2. Total number of Major operations are only 16 on the day of assessment for the hospital. Average of randomly selected days is 12-15 which is inadequate.
- 3. Deficiency of faculty: (a) Asso. Prof.: 2.
- 4. Shortage of Senior Residents: 2.
- 5. Central Research Laboratory is not available.
- 6. Brig. N.S. Lamba was never Graded Specialist and he was Classified Specialist only for 2 years. Hence, his appointment as Assoc. Professor is not as per Regulations.
- 7. Lt. Col. N.S. Ajay Chandra has been shown as Asst. Professor as well as Assoc. Professor both, which is not feasible. He is not eligible to be Assoc. Professor.
- 8. Dr. B.S. Parihar & Dr. Rohit Malhotra have been shown as Asst. Prof. continuing till date from their date of appointment in the faculty table; however they are shown as Senior Residents during assessment which is not permissible.
- 9. Departmental Library has only 30 books which is grossly inadequate.

- 10. Academic parameters like Clinical Seminars (08 in no.), Journal Clubs (07 in no.), Group Discussions (14) per year are inadequate.
- 11. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. 11. <u>Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(Radio Diagnosis) qualification against increased intake from 01 to 04 seats in respect of students being trained at Deccan College of Medical Sciences, Hyderabad.</u>

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Radio Diagnosis) qualification against increased intake from 01 to 04 seats at Deccan College of Medical Sciences, Hyderabad granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Radio Diagnosis) qualification against increased intake from 01 to 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Deccan College of Medical Sciences, Hyderabad because of the following facts:-

- 1. Workload of Mammography, CT guided procedures like FNAC, DSA was NIL on day of assessment. There is no Mammography in OHRC.
- 2. Dr. M. Sarvan Kumar, Asst. Professor with DNB qualification is not eligible. He has no post DNB Teaching Experience. However, Faculty is complete without him.
- 3. Workload of CT guided FNAC, etc. was only 08 during the year 2014 which is grossly inadequate.
- 4. Total workload of DSA + Mammography is only 140 during the year 2014 which is inadequate.
- 5. None of the PG students are getting any stipend as of now.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of

Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MS(ENT) qualification against increased intake from 01 to 02 seats at Dr BR Ambedkar Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MS(ENT) qualification against increased intake from 01 to 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Dr BR Ambedkar Medical College, Bangalore because of the following facts:-

- 1. Total number of Major operations has decreased from 365 in 2012 to 355 in 2014. This implies daily average of major operations as 1.18 which is inadequate.

- 1. Shortage of Senior Residents: 2.
- 2. 3 Major O.T.s & 1 Minor O.T. were under renovation; hence non-functional.
- 3. Dr. V. Ramlingam possess experience of only 2 years as Resident; hence not eligible as Senior Resident & cannot be considered as Senior Resident.
- 4. With regard to eligibility of publications for promotion of Dr. S. Ravindran, Professor. 2 out of 4 publications appear to be case reports and hence not acceptable. Resultantly, his promotion is not as per Regulations as he has been promoted as Professor with experience of only 3 years 2 months as Asso. Prof. against requirement of 4 years as per Regulations.
- 5. Resultantly, Unit 4 has only 2 faculty and is headed by Asst. Prof. and cannot be considered as a teaching Unit.
- 6. Other deficiencies as pointed out in the Assessment Report.

- 1. No details of experience as Resident / Junior Resident has been given in respect of Dr. S.S. Siva, Senior Resident. Hence he cannot be considered as Senior Resident.
- 2. Dr. V.G. Siva, Senior Resident possesses experience of only 2 years 6 months as Resident; hence she cannot be considered as Senior Resident.
- 3. Dr. S. Lokesh, Asso. Prof. has been promoted as Asso. Prof. on the basis of publications; however one of the publication appears to be a case report and cannot be accepted as publication; hence his promotion is not as per Regulations.
- 4. As per faculty table (signed by the Dean and Assessor), Dr. P. Govindraj, Asso. Prof. in Unit 7 is shown as working in this institute from 21/12/2009 to 04/11/2012 as Asst. Prof. He has also been shown as working as Asso. Prof. at SSSMC & RI, Chennai from 06/10/2010 to 04/01/2013. Thus between 06/10/2010 and 04/11/2012 he has been working simultaneously at this institute & SSSMC & RI, Chennai, which is not permissible and contrary to Regulations.
- 5. Resultantly, there are only 2 faculty in Unit 7 & it cannot be considered as PG Unit.
- 6. Dr. Kumili Nageswar Rao, Senior Resident does not possess requisite experience of 3 years in the department a medical college; he cannot be considered as Senior Resident.
- 7. Resultantly, there is deficiency of faculty: (a) Asst. Professor: 3; Senior Residents: 3.
- 8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 3 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 7. Treatment for MDR Tuberculosis is not available.

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MS(ENT) qualification for 03 seats at Shadan Institute of Medical Sciences, Research Centre and Teaching Hospital, Peerancheru, Hyderabada granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MS(ENT) qualification for 03 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Shadan Institute of

Medical Sciences, Research Centre and Teaching Hospital, Peerancheru, Hyderabada because of the following facts:-

- 1. OPD on day of assessment is only 52.
- 2. Total number of patients in OPD has decreased from 14, 913 in 2012 to 14, 535 in 2014.
- 3. Total number of Major operations has decreased from 718 in 2012 to 526 in 2014.
- 4. Total number of Minor operations has decreased from 982 in 2012 to 770 in 2014.
- 5. Workload of procedures like MLS, Laryngectomy, Bronchoscopy, Foreign Body Removal, Laryngo/Tracheoplasty, Maxillectomy. Angiofibroma is NIL during last 3 years.
- 6. Average Major Operations (from yearly data) less than 2 per day.
- 7. Equipment like Flexible Fiber optic Nasopharyngolaryngoscope/ Bronchoscope, Nerve Stimulator/ Monitor are not available.
- 8. The department does not participate in National Programme for Prevention & Control of Deafness.
- 9. Academic parameter like Journal Club (12/year) is inadequate.
- 10. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 3 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2015) and decided to recommend to the Central Government that MD(TB & Respiratory Medicine) qualification against increased intake from 01 to 03 seats granted by Devi Ahilya Vishwa Vidyalaya, Indore in respect of students being trained at Sri Aurobindo Medical College and Post Graduate Institute, Indore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2015) and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 02 to 06 seats granted by Devi Ahilya Vishwa Vidyalaya, Indore in respect of students being trained at Sri Aurobindo Medical College and Post Graduate Institute, Indore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MS(General Surgery) qualification against increased intake from 04 to 06 seats granted by Baba Farid University of Health Sciences, Faridkot in respect of students being trained at Sri Guru Ram Das Institute of Medical Sciences and Research, Sri Amritsar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

46. <u>Baba Farid University of Health Sciences, Faridkot - Recognition of MD(Paediatrics) qualification against increased intake from 02 to 03 seats in respect of students being trained at Sri Guru Ram Das Institute of Medical Sciences and Research, Sri Amritsar.</u>

Read: the Council Assessor's Report (June, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification against increased intake from 02 to 03 seats at Sri Guru Ram Das Institute of Medical Sciences

and Research, Sri Amritsar granted by Baba Farid University of Health Sciences, Faridkot.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2015) and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 02 to 03 seats granted by Baba Farid University of Health Sciences, Faridkot in respect of students being trained at Sri Guru Ram Das Institute of Medical Sciences and Research, Sri Amritsar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

47. Bharath University, Chennai - Recognition of MD(Community Medicine) qualification for 02 seats in respect of students being trained at Sri Lakshmi Narayana Institute of Medical Sciences, Pondicherry.

Read: the Council Assessor's Report (April, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Community Medicine) qualification for 02 seats at Sri Lakshmi Narayana Institute of Medical Sciences, Pondicherry granted by Bharath University, Chennai.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MD(Community Medicine) qualification for 02 seats granted by Bharath University, Chennai in respect of students being trained at Sri Lakshmi Narayana Institute of Medical Sciences, Pondicherry because of the following facts:-

- 1. The following faculty cannot be considered due to reasons given in detail in the assessment report:
 - a) Dr. H.M. Sridhara, Professor;
 - b) Dr. Shailendra S. Zamakade, Professor;
 - c) Dr. S. Rajjini, Asso. Prof.;
 - d) Dr. P. Rajaram; Professor;
 - e) Dr. P.R. Mohapatra; Asst. Prof.
 - f) Dr. Priyadarshini, Medical Officer;
 - g) Dr. Haripranav, Medical Officer;
 - h) Dr. S. Rajendran, Medical Officer;
 - i) Dr. Rakesh, Medical Officer.
- 2. Dr. P.R. Moharana, working in NGO "CARE", in Bihar was presented as Asst. Prof. mentioned in his D.F. as having joined institution on 05/06/2014 vide Dean's letter No. SLIMS/DEAN/Appt. Order/2014. But he himself told and HOD has written that he was not working here and not an employee of this institution. However, he again appeared on 17/04/2015 at 2:30 p.m. with another appointment order & joining letter from the Dean dated 16/04/2015. He did not produce any relieving order from the previous institute.
- 3. Dr. Priyadarshini, Dr. Haripranav, Dr. S. Rajendran, Dr. Rakesh, all Medical Officers, have written in their D.F. that they have not filled their D.F. as there were many discrepancies in relation to date of birth, Aadhar card, etc. in their D.F. Some of them don't have Aadhar Card but the number was written.
- 4. All Tutors & Medical Officers presented only on days of assessment, though mentioned in their D.F. with certificates issued by Dean of joining

- last year or 6-8 months back. They mentioned signing daily in attendance register but no such register was produced & in fact was not even existing.
- 5. HOD was unable to tell the names of many staff members working in the department for many months.
- 6. None of the staff produced as Medical Officers/Lady Medical Officers, claiming to be working in the department for many months was present at RHTC/UHC. Rather, medical officers presented at RHTC/UHC were not part of the department.
- 7. Salary certificates produced by all Medical officers & Tutors were without any number or date of issue. It was told that salary is paid to them in cash so no bank pass book can be shown. This is not permissible.
- 8. Departmental Library has only 2 volumes of old journal.
- 9. No information is provided regarding activities of various paramedical sections.
- 10. PG Research laboratory is ill equipped. Equipment like Kata Thermometer, Horrock's Apparatus, Dry & Wet Thermometer are not available. Information provided does not match.
- 11. No information is provided regarding purchase of books in last 3 years by Central or Departmental Library.
- 12. No UG teaching schedule was shown to verify teaching activities of faculty.
- 13. Professors have been shown as Medical Social Workers, Health Educators, Statisticians for RHTC & UHC in signed paper by HOD & Dean. No paramedical worker exists either in the department or at RHTC/UHC.
- 14. Central Research Laboratory is in charge of Dr. Sridhar, Tutor in Anatomy who was not knowing anything about laboratory equipment or its activities.
- 15. All data related to radiology, Microbiology, Pathology & Biochemistry presented by Dean in SAF is false. Actual figures are as those mentioned in SAF by assessor.
- 16. Dr. Dilip Suryavanshi of Pathology department in charge of Central Laboratory was unable to produce actual register. He was showing various registers filled with one handwriting & in 1 ink of entries of last 1 year. Actual register kept in 1 laboratory had only 78 mixed entries of Blood Chemistry, Haematology 16/04/2015 against shown as 2412 & 2506 respectively in the register.
- 17. On 17/04/2015, one female staff making entries of fake names & other particulars in USG register from a printed list provided to her which was showing 138 USG done on 16/04/2015. However, actual register present mentioned only 19 & 10 USGs on 16/04/2015 & 17/04/2015 respectively.
- 18. OPD statistics presented & actual printout taken were absolutely different. In front of assessor, some official instructed the clerk to cook entries in final OPD data of a day before to be presented to the assessor.
- 19. Registration Counter was deserted for most of time.
- 20. Overall Bed Occupancy of hospital was only 20%. In Gynaecology ward, there were only 4 patients; rest all beds were deserted.
- 21. For PG examination for Clinico-Social examination, patients were brought by the department from villages.
- 22. RHTC Kumarapallayam: Dr. Kalyansundaram presented himself as Senior Resident without any proof of identity, claimed to be working there from 21/01/2008. According to him Dr. Aarthi was L.M.O. who was absent. However, he was not shown in SAF as working here. None of the staff information matched with that provided by the Dean. During 40 minute stay, not a single patient turned up, though register shows 25 patients/day. There is no class room, no vaccination, no IFA tables. There was no activity under National Health Programmes. Boys' hostel was in an abandoned house, with no proof of residential activities.

- 23. RHTC Katterekuppam: Dr. Akhilan presented himself as Medical officer without any proof of identity, claimed to be working there from last month. However, he was not shown in SAF as working here. None of the staff information matched with that provided by the Dean. Register shows 20 patients/day. There is no class room, no vaccination, no IFA tables. There was no activity under National Health Programmes. Residential accommodation was not shown. Biomedical safety norms are not followed.
- 24. UHC: It is a multispecialty Polyclinic & not a UHC. It is under Medicine department & not under Community Medicine department. Dr. V. Anabaracy, working as M.O. from Medicine department is a PG in Physiology. She knows nothing about any Community Medicine faculty or Resident. Two notices of Resident roster from Community Medicine department were posted only an evening before. None of the information matches with that provided in SAF. Biomedical safety norms are not followed.
- 25. PG Training: Though information was provided on paper, of so called posting schedule, about teaching & training activities of PGs, in various clinical departments & submitted certificates also by various HODs, of completion of training but actually all was on paper only as nothing was entered in PG log books. PGs were unable to tell about the activities performed by them in 3 years. It appears that they have not even been posted at RHTC/UHC as they were unable to explain anything about activities performed at these centers.
- 26. Information provided for all Academic parameters was not supported by any valid proof of conducting such activities.
- 27. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. - 3. Overall Bed Occupancy of hospital was only 20%. E.g. in Gynaecology ward, there were only 4 patients; rest all were deserted.

48. Pondicherry University, Puducherry - Recognition of MD(Biochemistry) qualification for 03 seats in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry.

Read: the Council Assessor's Report (April, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Biochemistry) qualification for 03 seats at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry granted by Pondicherry University, Puducherry.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend to the Central Government that MD(Biochemistry) qualification for 03 seats granted by Pondicherry University, Puducherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

49. Pondicherry University, Puducherry - Recognition of MD(General Medicine) qualification for 04 seats in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry.

Read: the Council Assessor's Report (April, 2015) on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification for 04 seats at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry granted by Pondicherry University, Puducherry.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MD(General Medicine) qualification for 04 seats granted by Pondicherry University, Puducherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry because of the following facts:-

- 1. Unit-wise distribution of Faculty is not provided. A list of 17 faculty members have been given against the requirement of 18 for 6 Units. Consequently, there is a deficiency of Asst. Professor: 1.
- 2. Dr. K. Aswani, Senior resident does not possess 3 years experience in the department in a medical college; hence he cannot be considered as Senior Resident.
- 3. Resultantly, there is shortage of Senior Residents: 2.
- 4. Details of beds occupied in ICU & ICCU are not given.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 4 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per

provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MD(Forensic Medicine) qualification for 04 seats granted by Pondicherry University, Puducherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry because of the following facts:-

- 1. There is no permission to conduct medico-legal post-mortems at this institute. As per the Assessor, till now police authorities has not referred post mortem cases, hence no medico legal autopsy has been conducted in the mortuary.
- 2. If there is no permission, from where the post-mortem data has been provided. It cannot be accepted.
- Workload of examination of sexual assault victims is NIL. That of examination of sexual assault accused is only 014/day which is inadequate.
- 4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 04 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

54. <u>Pondicherry University, Puducherry - Recognition of MS(Orthopaedics)</u> <u>qualification for 02 seats in respect of students being trained at Sri Manakula</u> <u>Vinayagar Medical College & Hospital, Pondicherry.</u>

Read: the Council Assessor's Report (April, 2015) on the standard of examination and other teaching facilities for Recognition of MS(Orthopaedics) qualification for 02 seats at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry granted by Pondicherry University, Puducherry.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MS(Orthopaedics) qualification for 02 seats granted by Pondicherry University, Puducherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry because of the following facts:-

- 1. Out of 7 publications, only 2 are research publications while the rest 5 are case reports.
- 2. OPD space is not adequate. It is too small with 4 tiny cubicles & about a dozen sitting chairs crumpled into a waiting space of about 100 sq.ft. Full day Fracture Clinic & concomitant specialty clinic are also running from the same space.
- 3. Statistics of Female Dressing Room (NIL) & similar scarce statistics of work in plaster room on day of assessment did not corroborate with claimed OPD attendance of 250 patients/day. Actual quantum of work appeared to be 1/3rd of projected figures.
- 4. About 20% of admitted patients had ailments neither appropriate for teaching nor for their treatment.
- 5. Patients' details of the last duty done by Senior Residents did not corroborate with details documented in emergency register, thus raising doubt about their genuineness.
- 6. Projected issuance of 2 blood units/day to the department did not corroborate with projected Surgical work. Random checking revealed that in most of the cases it was for Anaemia rather than any Orthopaedic Surgical exercise.
- 7. Most of operating work shown as Minor operations comprised of Local Steroid Injections or Suture Removal, etc. performed in the operation room. Data of Minor operations appear to be inflated.
- 8. Declaration Forms of 7 faculty & Residents did not have any authenticated proof of residence. Joining report of Dr. Jiju Jacob w.e.f. 10/03/2015 is found to have been dated 17/12/2014 i.e. almost 3 months in advance.

- 9. Office space for faculty appeared to have been created only for assessment purpose since brand new furniture did not show even a single sheet of paper or pen or books, clinical records, etc.
- 10. Dr. V.S.V. Kumar & Dr. S. Velumurugan, Senior Residents have 3 years experience at Southern Railways hospital & not in a department in a medical college; hence not considered.
- 11. Dr. Sathyanarayan, Senior Residents has 2 years experience as Junior resident against requirement of 3 years as per Regulations; hence not considered.
- 12. Resultantly, there is shortage of Senior Residents: 3.
- 13. Details of beds occupied in ICU & ICCU on day of assessment are not given.
- 14. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. - 1. Out of 6 Units, Units V & VI have only 15 beds each; hence cannot be considered as teaching Units at all. There are 6 Units but only 150 beds.
- 2. Shortage of residents: (a) Senior Resident: 1; (b) Junior Resident: 1.
- 3. Academic parameter like Group Discussion (12/year) is inadequate.
- 4. There were only 6 deaths out of 9748 admissions in a year in the department of Surgery, which simply indicate that no serious surgical

- emergencies were admitted, without which, the training of PG Students will be inadequate.
- 5. The column of Stipend being paid to PG Students has been deleted from the SAF. Consequently, there is no information about the stipend.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 5 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. 59. The Tamil Nadu Dr. M.G.R. Medical College University, Chennai - Recognition of MD (Radio Diagnosis) qualification for 1 seat in respect of students being trained at Coimbatore Medical College, Coimbatore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MD (Radio Diagnosis) qualification for 1 seat granted by The Tamil Nadu Dr. M.G.R. Medical College University, Chennai in respect of students being trained at Coimbatore Medical College, Coimbatore because of the following facts:-

1. Total number of contrast Radiology has decreased from 1, 145 in 2012 to 376 in 2014.

- 2. Workload of US guided FNAC/Biopsy & CT guided FNAC/Biopsy is only 53/year & 46/year respectively which is inadequate.
- 3. Workload of Mammography is 328 in 2014 implying daily average of < 1 which is inadequate.
- 4. Experience as Resident/Junior Resident has not been shown in respect of any Senior Resident in the faculty table.
- 5. Only publication in indexed journals appears to be a case report. Hence there are NIL publications from the department in indexed journals in last 3 years.
- 6. There are only 4 static machines available against requirement of 5 as per Regulations.
- 7. DSA is not available (page 27 of SAF).
- 8. Academic parameters like Theory Classes (24/year), Clinical Seminars (10 in no.). Journal Clubs (12/year), Group Discussions (12/year) are inadequate.
- 9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 01 seat after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MS(OBG) qualification against increased intake from 3 to 5 seats granted by D.Y. Patil Education Society Deemed University, Kolhapur in respect of students being trained at Dr. D. Y. Patil Medical College, Kolhapur because of the following facts:-

- 1. OPD on day of assessment is only 72.
- 2. Data of Caesarean Sections & Operative Vaginal Deliveries in last 3 years are not provided. Apparently it seems that number of Caesarean Sections has decreased during the period from 2012 2014.
- 3. Publications quoted 4. No reference/ reprint of any of them provided.

- 4. Dr. S.R. Rawal, Senior Resident has experience of only 1 year 4 months in the department in medical college; hence he cannot be considered as Senior Resident.
- 5. PG degree of Dr. R.G. Ranade, Professor is not recognized.
- 6. Dr. Asma Khan, Dr. Pallavi Mirashi, Dr. K. Anamika & Dr. K. Madhulika, Senior Residents are having experience as Tutor for 3 years & not as Resident/Junior Resident, which cannot be accepted because Tutor is designation in basic departments.
- 7. Details of beds occupied in HDU/ICU on day of assessment are not given.
- 8. Specialty clinics like High Risk Pregnancy Clinic, Cancer Clinic, Gynaec Endocrine Clinic, Family Planning Clinic are not run. Details of patients attending Specialty clinics like Post-natal clinic, Infertility clinic, Menopausal clinic are not given.
- 9. Services like Prenatal Diagnosis, Oncology are not provided.
- 10. Academic parameter like Journal Clubs (10 in no.) is inadequate.
- 11. Other deficiencies as pointed out in the Assessment Report.

1. Number of Major Surgeries on day of assessment was only 14 which is inadequate. Daily average is 14-15 which is inadequate.

- 2. Total number of Caesarean Sections has decreased from 674 to 634 during 3 year period.
- 3. There is only 1 publication from the department in indexed journals in last 3 years.
- 4. Regular Pain Clinic is not yet established.
- 5. Dr. Sherina Bright, Dr. Vidyadhar Metri & Dr. J. Nagendran, Senior Residents have no experience as Resident/Junior Resident in the department in a medical college; hence they cannot be considered as Senior Resident.
- 6. Dr. Rajiv Gandhi, Senior Resident has experience of only 1 year as Resident/Junior Resident in the department in a medical college against requirement of 3 years as per Regulations; hence he cannot be considered as Senior Resident.
- 7. Dr. S. Anil Kumar, Senior Resident has experience of only 6 months as Resident/Junior Resident in the department in a medical college against requirement of 3 years as per Regulations; hence he cannot be considered as Senior Resident.
- 8. Resultantly there is shortage of Senior Residents: 4.
- 9. Details of bed occupancy in ICU, ICCU, SICU on day of assessment are not provided.
- 10. Academic parameter like Clinical Seminar (14/year) is inadequate.
- 11. The College got LoP on 13/11/2002. Dr. Davis Arun Kumar has been given teaching experience from 11/12/2001. Consequently, he has been Asst. Professor for less than 5 years. Hence, his promotion is not as per Regulations.
- 12. Deficiency of Faculty: (a) Assoc. Professor: 1; (b) Asst. Professor: 1
- 13. Other deficiencies as pointed out in the Assessment Report.

- 1. Workload of CT guided procedures is only 42/year which is inadequate.
- 2. Workload of DSA is only 55/year which is inadequate. However, there is no DSA available in the Institution as per equipment list on page 28 of the SAF.
- 3. Dr. D. Shereen, Senior Resident has no experience as Resident/Junior Resident in the department in a medical college; hence he cannot be considered as Senior Resident.
- 4. Total number of MRI has decreased from 2, 560 in 2012-13 to 2, 273 in 2014-15. MRI 7 per day, which is inadequate.
- 5. Only 3 static X-ray machines are available against requirement of 5 as per Regulations.
- 6. Academic parameter like Theory Classes (24/year) is inadequate.
- 7. Other deficiencies as pointed out in the Assessment Report.

- 7. Death data is left unfilled in the appropriate column.

- 3. Other deficiencies as pointed out in the Assessment Report.

- 2. Resultantly, Unit-I is left with 2 faculty, which cannot be considered as PG Unit.
- 3. Yearly data of Major & Minor Operations not given separately. It is a combined data, which cannot reflect the adequate number of Major Operations.
- 4. Total MRI on the day of Assessment, 6 in entire hospital, which indicate inadequate clinical material.
- 5. Other deficiencies as pointed out in the Assessment Report.

- 3. Annual specimens processed for Cytology are 3, 076 implying daily average of 10 which is inadequate.
- 4. Workload of Bone Marrow Biopsy is only 09/year which is inadequate.
- 5. Academic parameters like Journal Clubs (17/year), Case Presentations (11/year), Group Discussions (12/year) are inadequate.
- 6. Promotion of Dr. R.K. Thukral, Professor is not as per Regulations. He has been Lecturer for 4 years 4 months and Assoc. Professor for 3 years 3 months without any publications. There is only 1 publication, which is a case report and cannot be accepted.
- 7. Promotion of Dr. Anupam Varshney, Professor is not as per Regulations. He has been Lecturer for 4 years against the requirement of 5 years. All the publications quoted are in non-indexed journal, which cannot be considered.
- 8. Consequently, there is a deficiency of Assoc. Professor: 2.
- 9. Other deficiencies as pointed out in the Assessment Report.
