2. Minutes of the last meeting of the Postgraduate Medical Education Committee – action taken thereon.

The Postgraduate Medical Education Committee noted & approved the action taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

3. Starting of M.Ch. (Urology) course at NRI Medical College, Guntur under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (10/04/2015) on the physical and other teaching facilities available at NRI Medical College, Guntur under Dr. NTR University of Health Sciences, Vijayawada for Starting of M.Ch. (Urology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10/04/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of M.Ch. (Urology) course at NRI Medical College, Guntur under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. Average daily OPD is 23.
2. Average daily operations are Major only 2 & Minor only 1.
3. No details of Renal transplant operations are provided.
4. OPD/ IPD almost static in the last 3 years.
5. There is no departmental Research Lab.
6. Other deficiencies as pointed out in the Assessment Report.

4. Starting of DM (Critical Care) course at NRI Medical College, Guntur under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (07/04/2015) on the physical and other teaching facilities available at NRI Medical College, Guntur under Dr. NTR University of Health Sciences, Vijayawada for Starting of DM (Critical Care) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (07/04/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of DM (Critical Care) course at NRI Medical College, Guntur under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. All 3 Staff were considered as P.G. Teachers in Anaesthesia department from which this department is not yet separated
2. There cannot be a combined department of Anaesthesia and Critical Care All 3 Staff members are part of Anaesthesia department, if these 3 staff members are taken out from Anaesthesia department then there is a shortage of 3 Asst. Professors in Anaesthesia department for 150 UG seats.
3. No Faculty members have DM or 2 years special training in Critical Care.
4. Dr. Varalaxmi, Asst. Professor with DNB qualification from non-teaching Hospital is not eligible, since, she has no 3 years teaching experience and one year Post DNB experience at the time of appointment.
5. Other deficiencies as pointed out in the Assessment Report.

5. Starting of DM (Neonatology) course at Maulana Azad Medical College, New Delhi under University of Delhi u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (09/04/2015) on the physical and other teaching facilities available at Maulana Azad Medical College, New Delhi under

University of Delhi for Starting of DM (Neonatology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (09/04/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of DM (Neonatology) course at Maulana Azad Medical College, New Delhi under University of Delhi u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. All 3 Faculty Members have MD (Pediatrics) qualification and were deputed from the department of Pediatrics to Neonatology (when this Department was started in 2002) in the same rank, which they were holding in the department of Pediatrics. At the time of deputation to Neonatology department, they had no DM qualification in Neonatology or 2 years special training in Neonatology. Hence, they were not eligible to hold the post they are occupying in the department of Neonatology.
2. Other deficiencies as pointed out in the Assessment Report.

6. **Increase of seats in DM (Hepatology) course at Institute of Liver & Biliary Sciences, New Delhi under Institute of Liver & Biliary Sciences (Deemed to be University), New Delhi u/s 10A of the IMC Act, 1956 for the academic year 2015-16.**

Read: the Council Assessor's Report (30/03/2015) on the physical and other teaching facilities available at Institute of Liver & Biliary Sciences, New Delhi under Institute of Liver & Biliary Sciences (Deemed to be University), New Delhi for Increase of seats in DM (Hepatology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (30/03/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in DM (Hepatology) course at Institute of Liver & Biliary Sciences, New Delhi under Institute of Liver & Biliary Sciences (Deemed to be University), New Delhi u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. Total beds are shown as 160 in 2 Units which is not as per Regulations. In summary, it is shown that there 40 beds in each of 2 Units while on P. 17 & 20, it is shown that both the Units have 80 beds.
2. PG degree of Dr. K.D. Jamwal, Asst. Prof. is not recognized.
3. Promotion of Dr. Vikram Bhatia, Asso. Prof. in Unit II is not as per Regulations as he has been promoted with experience of only 1 y 11 m as Asst. Prof. against requirement of 2 y as per Regulations.
4. Resultantly, there are only 2 faculty in Unit II & it cannot be considered as PG Unit.
5. Other deficiencies as pointed out in the Assessment Report.

7. **Increase of seats in DM (Paediatric Hepatology) course at Institute of Liver & Biliary Sciences, New Delhi under Institute of Liver & Biliary Sciences (Deemed to be University), New Delhi u/s 10A of the IMC Act, 1956 for the academic year 2015-16.**

Read: the Council Assessor's Report (31/03/2015) on the physical and other teaching facilities available at Institute of Liver & Biliary Sciences, New Delhi under Institute of Liver & Biliary Sciences (Deemed to be University), New Delhi for Increase

of seats in DM (Paediatric Hepatology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (31/03/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in DM (Paediatric Hepatology) course at Institute of Liver & Biliary Sciences, New Delhi under Institute of Liver & Biliary Sciences (Deemed to be University), New Delhi u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. There is no Asso. Prof. in the only Unit.
2. One Asst. Prof. Dr. R. Khanna is on study leave.
3. Resultantly, faculty complement is incomplete.
4. Average daily OPD is 25.
5. Average daily bed occupancy is 65 %.
6. There are only 16 beds in the only Unit. Rest 4 beds are in PICU which cannot be considered as teaching beds.
7. Dr. Dinesh Rawal, Asst. Prof. does not possess 3 years experience in the department in teaching institutes in India. His experience in U.K. hospitals cannot be considered as they are not recognized by Medical Council of India as teaching hospitals.
8. None of the Faculty Members have special Training in Paediatric Hepatology department.
9. Other deficiencies as pointed out in the Assessment Report.

8. Starting of DM(Cardiology) course at Bharati Vidyapeeth Deemed University Medical College & Hospital, Sangali under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (10th April 2015) on the physical and other teaching facilities available at Bharati Vidyapeeth Deemed University Medical College & Hospital, Sangali under Bharati Vidyapeeth Deemed University, Pune for Starting of DM(Cardiology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10th April 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of DM(Cardiology) course at Bharati Vidyapeeth Deemed University Medical College & Hospital, Sangali under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. There is no Professor in the department.
2. Data of current Clinical material in the department is not provided.
3. No information has been provided about the Clinical material during the last 3 years.
4. Other deficiencies as pointed out in the Assessment Report.

9. Starting of M.Ch. (Paediatric Surgery) course at Bharati Vidyapeeth Deemed University Medical College, Pune under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (09th April 2015) on the physical and other teaching facilities available at Bharati Vidyapeeth Deemed University Medical College, Pune under Bharati Vidyapeeth Deemed University, Pune for Starting of M.Ch. (Paediatric Surgery) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (09th April 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of M.Ch. (Paediatric Surgery) course at Bharati Vidyapeeth Deemed University Medical College, Pune under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. Average daily OPD is 20-22.
2. Average daily operative load is 2-3 which is inadequate.
3. Other deficiencies as pointed out in the Assessment Report.

10. Starting of DM(Neonatology) course at Bharati Vidyapeeth Deemed University Medical College, Pune under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (08th April 2015) on the physical and other teaching facilities available at Bharati Vidyapeeth Deemed University Medical College, Pune under Bharati Vidyapeeth Deemed University, Pune for Starting of DM(Neonatology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (08th April 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of DM(Neonatology) course at Bharati Vidyapeeth Deemed University Medical College, Pune under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. No faculty member possesses D.M. qualification.
2. Dr. Sumit Arora, Asst. Professor; Dr. Anil Kumar Khankar and Dr. Suprita Pattnaik have no 2 years special training in Neonatology.
3. Dr. Nandini Malshe with DNB qualification has no special training of 2 years in Neonatology. Hence, she cannot be considered.
There is no Certificate of Fellowship in Neonatology attached.
4. Consequently, there is only 1 Faculty in the department and teaching complement is incomplete.
5. Other deficiencies as pointed out in the Assessment Report.

11. Increase of seats in DM(Cardiology) course at Chettinad Hospital & Research Institute under Chettinad Academy of Research and Education (Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (24th March 2015) on the physical and other teaching facilities available at Chettinad Hospital & Research Institute under Chettinad Academy of Research and Education (Deemed University) for Increase of seats in DM(Cardiology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (24th March 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in DM(Cardiology) course at Chettinad Hospital & Research Institute, Chennai under Chettinad Academy of Research and Education (Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. Bed occupancy in ICCU is 40-50 % & in general ward is 50-60 %.
2. There is no Senior Resident.

3. Professor & HoD will be 70 years in July, 2015 (before the start of session)
4. Professor Pradeep G. Nair, DNB from non-teaching Hospital have no 3 years teaching experience at the time of appointment as Asst. Professor. Hence, not eligible.
5. Dr. Chokilingam M., Asst. Professor with DNB qualification from Non-teaching Hospital has no 3 years teaching experience at the time of appointment as Asst. Professor. Hence, he cannot be considered.
6. Consequently, there is only 1 Faculty in the department. Teaching complement is incomplete.
7. Other deficiencies as pointed out in the Assessment Report.

12. Starting of DM(Critical Care Medicine) course at Christian Medical College, Vellore under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (25th March 2015) on the physical and other teaching facilities available at Christian Medical College, Vellore under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of DM(Critical Care Medicine) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (25th March 2015) and decided that the College authorities be requested to provide Certificate of Special Training/ experience of exclusively working in Critical Care Medicine for 2 years at the time of their appointment/ transfer in the department of Critical Care Medicine within 48 hours.

13. Starting of M.Ch.(Surgical Oncology) course at Dr. Ram Manohar Lohia Institute of Medical Sciences, Lucknow under Chhatrapati Shahu ji Maharaj Medical University, Lucknow u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (20th March 2015) on the physical and other teaching facilities available at Dr. Ram Manohar Lohia Institute of Medical Sciences, Lucknow under Chhatrapati Shahu ji Maharaj Medical University, Lucknow for Starting of M.Ch.(Surgical Oncology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (20th March 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of M.Ch.(Surgical Oncology) course at Dr. Ram Manohar Lohia Institute of Medical Sciences, Lucknow under Chhatrapati Shahu ji Maharaj Medical University, Lucknow u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. Dr. Arun Chaturvedi, Professor & HoD has no M.Ch. qualification or 2 years special training in Surgical Oncology. He has not worked for 2 years as Asst. Professor and 4 years as Assoc. Professor in Surgical Oncology before he was appointed Professor in Surgical Oncology. Thus, he is not eligible to hold the present post.
2. Other deficiencies as pointed out in the Assessment Report.

14. Starting of M.Ch.(Paediatric Surgery) course at Era's Lucknow Medical College & Hospital, Lucknow, Uttar Pradesh under Dr. Ram Manohar Lohia Avadh University, Faizabad u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (07th April 2015) on the physical and other teaching facilities available at Era's Lucknow Medical College & Hospital, Lucknow, Uttar Pradesh under Dr. Ram Manohar Lohia Avadh University, Faizabad for Starting of M.Ch.(Paediatric Surgery) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (07th April 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of M.Ch.(Paediatric Surgery) course at Era's Lucknow Medical College & Hospital, Lucknow, Uttar Pradesh under Dr. Ram Manohar Lohia Avadh University, Faizabad u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. Equipments & other facilities are shared with General Surgery.
2. Patient turnover in OPD, Operation details & inpatient records are incongruous at many places as per the documents supplied by the institute & inspected.
3. Recent editions of books & journals are lacking
4. Dr. Raj Kumar Tandon, Professor & HoD was appointed as Lecturer in the department of Surgery and promoted to Assoc. Professor and Professor in the same department as is evident from letter dated 23/02/1995 of Registrar, Lucknow University. Hence, he is not eligible for appointment to the post of Professor in Pediatric Surgery.
5. As per appointment order, Dr. Akhilesh Kumar Roy was Consultant, Pediatric Surgery, which is not a teaching post, from 03/03/2005 to 13/03/2009 and not Asst. Professor. Hence, his promotion to Assoc. Professor and Professor is not as per Regulations.
6. Other deficiencies as pointed out in the Assessment Report.

15. Starting of M.Ch.(Cardio Thoracic & Vascular Surgery) course at Jawaharlal Nehru Medical College, Aligarh under Aligarh Muslim University u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (08th April 2015) on the physical and other teaching facilities available at Jawaharlal Nehru Medical College, Aligarh under Aligarh Muslim University for Starting of M.Ch.(Cardio Thoracic & Vascular Surgery) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (08th April 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of M.Ch.(Cardio Thoracic & Vascular Surgery) course at Jawaharlal Nehru Medical College, Aligarh under Aligarh Muslim University u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. There is no Asso. Prof. in the only Unit.
2. Resultantly, faculty complement is incomplete.
3. Daily average operative workload is only 1 major or Minor which is inadequate. No open heart surgery is performed.
4. Equipment like Heart Lung Machine is not functioning.
5. Departmental library has only 17 books.
6. There are no Senior or Junior Residents.

7. There is no Cathlab in Cardiology department, which is the feeding department for CTVS.
8. No experience details of the HoD has been provided.
9. Other deficiencies as pointed out in the Assessment Report.

16. Increase of seats in DM(Nephrology) course at Kilpauk Medical College, Chennai under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (25th March 2015) on the physical and other teaching facilities available at Kilpauk Medical College, Chennai under The Tamilnadu Dr. MGR Medical University, Chennai for Increase of seats in DM(Nephrology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (25th March 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in DM(Nephrology) course at Kilpauk Medical College, Chennai under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. There are no research publications from the department, which indicate the department is not doing any significant research work.
2. No Side Lab/ Renal Lab in the department.
3. Other deficiencies as pointed out in the Assessment Report.

17. Starting of M.Ch.(Urology) course at Krishna Institute of Medical Sciences, Karad under Krishna Institute of Medical Sciences University(Deemed), Karad u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (27th March 2015) on the physical and other teaching facilities available at Krishna Institute of Medical Sciences, Karad under Krishna Institute of Medical Sciences University(Deemed), Karad for Starting of M.Ch.(Urology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (27th March 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of M.Ch.(Urology) course at Krishna Institute of Medical Sciences, Karad under Krishna Institute of Medical Sciences University(Deemed), Karad u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. The appointment of Dr. Anil Dinkarrao Huddedar, Professor & HoD as Assoc. professor on 01/09/1997 is not as per Regulations. He had no 2 years teaching experience as Asst. Professor in Nephrology prior to that. Hence, his promotion is not as per Regulations.
2. Other deficiencies as pointed out in the Assessment Report.

18. Starting of DM(Nephrology) course at Bharati Vidyapeeth Deemed University Medical College & Hospital, Sangali under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

Read: the Council Assessor's Report (08th April 2015) on the physical and other teaching facilities available at Bharati Vidyapeeth Deemed University Medical College

& Hospital, Sangali under Bharati Vidyapeeth Deemed University, Pune for Starting of DM(Nephrology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (08th April 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of DM(Nephrology) course at Bharati Vidyapeeth Deemed University Medical College & Hospital, Sangali under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. There is no Professor.
2. Resultantly, faculty complement is incomplete.
3. There is no Senior Resident.
4. OPD attendance is 25/week which is inadequate.
5. Kidney biopsy is done in the department; however, tissues are sent to Bangalore for Immunoflorescence & electron microscopy examination.
6. Kidney transplant facility is not available.
7. There is no PG teacher as the only Asso. Prof. does not possess 5 years' post D.M. teaching experience.
8. Blood Bank Stock is grossly inadequate.
9. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (17th April 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of DM(Cardiology) course at Bharati Vidyapeeth Deemed University Medical College, Pune under Bharati Vidyapeeth Deemed University, Pune u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

 - i. He has worked at two places during the period 14/05/2014 to 20/05/2014 & drawn salary from both the places
 - ii. National Institute of Medical Sciences, Jaipur allowed him to join without relieving orders from previous employer
 - iii. Neither National Institute of Medical Sciences, Jaipur nor Dr. Anil Grover replied to the clarification sought by MCI. The Committee further decided to handover the case to the Ethics Committee for appropriate action against National Institute of Medical Sciences, Jaipur and Dr. Anil Grover. Consequently, there is no Assoc. Professor in the Department.

In fact as per information provided in the SAF, only non-invasive procedures (Holter, Echo, TMT and ECG) are done. No other procedure are done. Without invasive procedures, the Cardiology department is not adequate.

1. The declaration Form of HoD is not signed by the Dean.
2. Publications nil (page 18 of SAF).

2. MS and M.Ch. degrees of Dr. Satyanarayan Mishra are not registered. His total experience as Asst. Professor and Assoc. Professor is in General Surgery. Hence, his promotion as Professor is not as per Regulations. Consequently, there is only 1 Faculty in the department.

Read: the Council Assessor's Report (27/04/2015) on the physical and other teaching facilities available at Mahatma Gandhi Medical College and Research Institute, Puducherry under Sri Balaji Vidyapeeth University, Puducherry for Increase of seats in DM (Cardiology) course u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (27/04/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in DM (Cardiology) course at Mahatma Gandhi Medical College and Research Institute, Puducherry under Sri Balaji Vidyapeeth University, Puducherry u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. On verification of the Post Permanent pacemaker implantation register, it is found that some patients are repeatedly shown attending the clinic, sometimes as frequently as 1 week.
2. The average cardiology OPD attendance is about 20-25 patients as per the OPD Register.
3. The Echoes are being done by Echo Technicians.
4. The defibrillator in the treadmill room was not functioning.
5. The department library does not have some essential books like Perloff's Clinical recognition of heart disease and Grossman's cardiac catheterization.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (13/02/2015) and Compliances dated 29/04/2015 submitted by the College Authorities and decided to recommend to the Central Govt. to disapprove the scheme for Starting of DM (Neurology) course at Pramukhswami Medical College, Karamsad (Gujarat) under Sardar Patel University, Gujarat u/s 10A of the IMC Act, 1956 for the academic year 2015-16, because of the following facts:-

1. Retrospective change in designation from Assoc. professor to Asst. Professor is not allowed. Even if it is accepted after designating Dr. Anand Vaibhav as Asst. Professor, there is no Assoc. Professor in the department. Consequently, faculty complement is incomplete.
2. Other deficiencies as pointed out in the Assessment Report.
