**1. Minutes of the last meeting of the Postgraduate Medical Education Committee – confirmation of.**

The Postgraduate Medical Education Committee confirmed the minutes of Postgraduate Medical Education Committee meeting held on 26<sup>th</sup> April, 2016.

**2. Minutes of the last meeting of the Postgraduate Medical Education Committee – action taken thereon.**

The Postgraduate Medical Education Committee noted & approved the action taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

**3. Kerala University of Health Sciences - Recognition of MD(Physical Medicine & Rehabilitation) qualification against increased intake from 01 to 03 seats in respect of students being trained at Govt. Medical College, Kozhikode,Calicut,Kerala.**

Read: the Compliance Verification Assessment Report (28/03/2016) along with the Council Assessor's Report (June, 2014 & 12.03.2015) and compliance dated 27/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Physical Medicine & Rehabilitation) qualification against increased intake from 01 to 03 seats at Govt. Medical College, Kozhikode,Calicut,Kerala granted by Kerala University of Health Sciences.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (28/03/2016) along with the Council Assessor's Report (June, 2014 & 12.03.2015) and compliance dated 27/09/2015 submitted by the college authorities and decided to recommend not to recognize MD(Physical Medicine & Rehabilitation) qualification against increased intake from 01 to 03 seats granted by Kerala University of Health Sciences in respect of students being trained at Govt. Medical College, Kozhikode,Calicut,Kerala because of the following facts:-

1. The only Unit has 60 beds which is not as per Regulations.
2. As per Faculty Table in report dated 20/06/2014, Dr. Sreejith K. was Senior Resident from 07/10/2006 to 23/12/2009, which has now been converted into Asst. Professor in the compliance. He was shown Asst. Professor from 24/12/2009 till date, which has now been converted into Assoc. Professor. This is not permissible. The Postgraduate Medical Education Committee decided that the Dean may be asked to provide a copy of Government Orders (Appointment, promotion in different ranks) and clarification from Dean and Dr. Sreejith K. obtained that how these dates and designations have been changed.
3. Qualification and experience of Senior Residents is not provided in the Faculty Table without which, their eligibility cannot be decided.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 01 to 03 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

4. **Amrita Vishwa Vidyapeetham University - Recognition of DPMR Qualification for 01 seat in respect of students being trained at Amrita School of Medicine, AIMS, Kochi.**

Read: the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (May, 2014) and compliance dated 09/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of DPMR Qualification for 01 seat at Amrita School of Medicine, AIMS, Kochi granted by Amrita Vishwa Vidyapeetham University.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (May, 2014) and compliance dated 09/11/2015 submitted by the college authorities and decided to recommend to the Central Government that DPMR Qualification for 01 seat granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

5. **Kerala University of Health Sciences - Recognition of MD(Paediatrics) qualification for 01 seat in respect of students being trained at Sri Gokulam Medical College Trust & Research Foundation, Trivandrum, Kerala.**

Read: the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (June, 2014 & 08.06.2015) and compliance dated 15/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification for 01 seat at Sri Gokulam Medical College Trust & Research Foundation, Trivandrum, Kerala granted by Kerala University of Health Sciences.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (June, 2014 & 08.06.2015) and compliance dated 15/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Paediatrics) qualification for 01 seat granted by Kerala University of Health Sciences in respect of students being trained at Sri Gokulam Medical College Trust & Research Foundation, Trivandrum, Kerala be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

6. **Vinayaka Mission's University, salem - Recognition of MD(Radio Diagnosis) qualification for 04 seats in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem.**

Read: the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (April,2012 June, 2013, Feb.,2015 and 17.07.2015) and

compliance dated 03/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radio Diagnosis) qualification for 04 seats at Vinayaka Mission's Kirupananda Variyar Medical College, Salem granted by Vinayaka Mission's University, salem.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (April,2012 June, 2013, Feb.,2015 and 17.07.2015) and compliance dated 03/11/2015 submitted by the college authorities and decided to recommend not to recognize MD(Radio Diagnosis) qualification for 04 seats granted by Vinayaka Mission's University, salem in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem because of the following facts:-

1. Senior Resident, Dr. R. Vidhya is MD (Radio-Therapy). Hence, not eligible to be appointed as Senior Resident.
2. Senior Resident, Dr. K.S. Babu has no 3 years experience as Junior Resident in the department of Radio-Diagnosis. Hence, not eligible.
3. Resultantly, there is a deficiency of Senior Resident: 2.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 04 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**7. Kerala University of Health Sciences, Thrissur - Recognition of MD(Pulmonary/Respiratory Medicine) qualification for 2 seats in respect of students being trained at Academy of Medical Sciences,Pariyaram, Kannur.**

Read: the Compliance Verification Assessment Report (31/03/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 15/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pulmonary/Respiratory Medicine) qualification for 2 seats at Academy of Medical Sciences,Pariyaram, Kannur granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (31/03/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 15/09/2015 submitted by the college authorities and decided to recommend not to recognize MD(Pulmonary/Respiratory Medicine) qualification for 2 seats granted by Kerala University of Health Sciences, Thrissur in

respect of students being trained at Academy of Medical Sciences, Pariyaram, Kannur because of the following facts:-

1. Deficiency of inadequate experience for promotion in respect of Dr. Manoj has been sought to be rectified by issuing a modified order with retrospective effect which is not permissible.
2. No publications, 4 publications submitted not yet published.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**8. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 02 seats in respect of students being trained at MNR Medical College, Sangareddy.**

Read: the Compliance Verification Assessment Report (05/04/2016) along with the Council Assessor's Report (November, 2014 & 26.06.2015) and compliance dated 19/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 02 seats at MNR Medical College, Sangareddy granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/04/2016) along with the Council Assessor's Report (November, 2014 & 26.06.2015) and compliance dated 19/10/2015 submitted by the college authorities and decided to recommend not to recognize MD(Social & Preventive Medicine / Community Medicine) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at MNR Medical College, Sangareddy because of the following facts:-

1. RHTC & UHC function in leased buildings with lease of only 5 years. Deficiency remains as it is.
2. Dr. P. Samuel Raj Kumar has been promoted as Asso. Prof. after cutoff date; however details of his publications are not provided in the faculty table; hence it cannot be verified whether his promotion is as per Regulations or not.

3. Promotion of Dr. T.K. Pandey, Assoc. Professor is not as per Regulations. He is promoted on 01/11/2014 after the cut-off date without any publications.
4. Resultantly, there is a deficiency of Assoc. Professor: 1
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**9. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Forensic Medicine) Qualification for 01 seat in respect of students being trained at Dr BR Ambedkar Medical College, Bangalore.**

Read: the Compliance Verification Assessment Report (31/03/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 24/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Forensic Medicine) Qualification for 01 seat at Dr BR Ambedkar Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (31/03/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 24/09/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Forensic Medicine) Qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Dr BR Ambedkar Medical College, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**10. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(General Medicine)qualification against increased intake from 03 to 10 seats in respect of students being trained at Kempegowda Institute of Medical Sciences, Bangalore.**

Read: the Compliance Verification Assessment Report (30/03/2016) along with the Council Assessor's Report (May, 2014 & March, 2015) and compliance dated 23/12/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine)qualification against increased intake from 03 to 10 seats at Kempegowda Institute of Medical Sciences, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/03/2016) along with the Council Assessor's Report (May, 2014 & March, 2015) and compliance dated 23/12/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(General Medicine)qualification against increased intake from 03 to 10 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Kempegowda Institute of Medical Sciences, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**11. Sri Siddhartha University, Tumkur - Recognition of MS(OBG) qualification against increased intake from 01 to 03 seats & DGO qualification against increased intake from 01 to 02 seats in respect of students being trained at Sri Siddhartha Medical College, Tumkur.**

Read: the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (may, 2014) and compliance dated 15/02/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification against increased intake from 01 to 03 seats & DGO qualification against increased intake from 01 to 02 seats at Sri Siddhartha Medical College, Tumkur granted by Sri Siddhartha University, Tumkur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (may, 2014) and compliance dated 15/02/2016 submitted by the college authorities and decided to recommend not to recognize MS(OBG) qualification against increased intake from 01 to 03 seats & DGO qualification against increased intake from 01 to 02 seats granted by Sri Siddhartha University, Tumkur in respect of students being trained at Sri Siddhartha Medical College, Tumkur because of the following facts:-

1. Promotion of Dr. Dhananjaya, Professor & HoD is not as per Regulations. He has been Assoc. Professor for 3 years. Out of 6 publications cited, no Author names have been given, 2 of them are in State Journals, year of publication not given in two of them. No reprint of Journals provided.
2. Promotion of Dr. Omkara Murthy, Assoc. Professor is not as per Regulations. He has been Asst. Professor for 4 years 6 months against the requirement of 5 years. No photocopy, no Author names or year of publication given for both the publications.
3. In respect of Dr. K. Pavana, experience at BLDE College as Resident is mentioned from 01/05/2004 to 30/04/2006 which is period of 2 y;

however it shown as 3 years in the column of duration which is incorrect; Resultantly experience as Resident is only 2 years 6 months and hence not eligible to hold the post.

4. There is no Senior Resident in Unit II.
5. Dr. B.I. Girish, Unit III is shown as "Asso. Prof." in the column of Designation; however, in the column of Experience, it is shown as Asst. Prof. from 24/09/2011 till date. This dichotomy needs to be clarified.
6. Number of Major operations on day of assessment was only 2 on day of assessment.
7. It is not clearly shown in faculty table who are working as Antenatal Medical officer & as Maternal & Child Welfare Officer.
8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 3 degree seats and increased intake from 1 to 2 diploma seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**12. Maharashtra University of Health Sciences, Nashik - Recognition of M.Ch.(Urology/Genito-Urinary Surgery) qualification against increased intake from 02 to 04 seats in respect of students being trained at Seth G.S.Medical College & King Edward VII Memorial Hospital, Parel Mumbai..**

Read: the Compliance Verification Assessment Report (28/03/2016) along with the Council Assessor's Report (Aug., 2014) and compliance dated 01/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch.(Urology/Genito-Urinary Surgery) qualification against increased intake from 02 to 04 seats at Seth G.S.Medical College & King Edward VII Memorial Hospital, Parel Mumbai granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (28/03/2016) along with the Council Assessor's Report (Aug., 2014) and compliance dated 01/09/2015 submitted by the college authorities and decided to recommend not to recognize M.Ch.(Urology/Genito-Urinary Surgery) qualification against increased intake from 02 to 04 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S.Medical College & King Edward VII Memorial Hospital, Parel Mumbai. because of the following facts:-

1. There is no Senior Resident as shown in the faculty table in the only Unit.



2. The Compliance is not in a prescribed SAF. The Assessor has only signed summary page of report, which gives no faculty details.
3. Faculty Table not signed by the Assessor.
4. Dr. Nilesh Rangnekar has been promoted Assoc. Professor on 22/04/2015 without any publication, which is not permissible.
5. Deficiency of Assoc. Professor remains as it is.
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**13. The Tamilnadu Dr. MGR Medical University, Chennai - Recognition of MD(General Medicine) qualification against increased intake from 02 to 06 seats in respect of students being trained at PSG Institute of Medical Sciences & Research, Coimbatore.**

Read: the Compliance Verification Assessment Report (05/04/2016) along with the Council Assessor's Report (17.04.2014 and 30.06.2015) and compliance dated 28/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 02 to 06 seats at PSG Institute of Medical Sciences & Research, Coimbatore granted by The Tamilnadu Dr. MGR Medical University, Chennai.

2. Dr. A. Murali has been promoted Professor on 01/09/2013 without any publications, which is not permissible. Resultantly, Unit-V left with 2 faculty.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. Read: the Compliance Verification Assessment Report (31/03/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 09/02/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 04 to 06 seats at Dr BR Ambedkar Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (31/03/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 09/02/2016 submitted by the college authorities and decided to recommend not to recognize MD(General Medicine) qualification against increased intake from 04 to 06 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Dr BR Ambedkar Medical College, Bangalore because of the following facts:-

1. Dr. R. Hareesh has been promoted as Asso. Prof. after cutoff date; however no details of his promotion are given; hence it cannot be verified whether his promotion is as per Regulations or not.
2. Faculty table only signed by nine persons. It means, others were absent. Unit-III - only one person signed. Unit-IV - only 2 persons signed.
3. Dr. Srinivasa, Assoc. Professor, Unit-IV has been promoted on 17/12/2013 without any publications, which is not permissible. Resultantly, Unit left with 2 Asst. Professors.
4. Only 2 faculty are shown in Unit III in faculty table; hence it cannot be considered as PG Unit.
5. There is no Senior Resident in Unit II.
6. Specialty clinics like Endocrine clinic, Gastroenterology clinic are still not run.
7. Data of clinical material on day of assessment are not provided.
8. Only 3 out of 6 candidates appearing in the examination presented poster/paper against requirement of each candidate doing so.
9. Clinical material of the Assessment day not given.
10. MRI: 8 to 10 per day, still less.
11. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (June, 2014) and compliance dated 14/08/2015 submitted by the college authorities and decided to recommend not to recognize MD(Pathalogy)qualification for 04 seats granted by Baba Farid University of Health Sciences, Faridkot in respect of students

being trained at Adesh Institute of Medical Sciences & Research, Bhatinda because of the following facts:-

1. Dr. Krishna Jindal, shown as Professor & HOD in compliance was absent on day of assessment at 10: 15 a.m. She reached only at 2 p.m. Her address is shown in Patiala while the institute is located in Bhatinda. Hence her full time working is doubtful.
2. In the last assessment an objection was raised with regard to promotion of Dr. Vijay Suri not being as per Regulations. In the compliance it was stated that he has been reverted as Asso. Prof. However, during this assessment he is once again shown as Professor & HOD. Hence the deficiency remains as it is. His experience at Veer Chander Singh Garhwali Govt. Medical College is not shown in old report. He is shown as Professor there after 2 years 10 months experience as Assoc. Professor, which is not as per Regulations. Hence, he is not eligible to be Professor in 2009. Required experience was 4 years as Assoc. Professor.
3. No proper leave was granted to 3 faculty members who were absent on day of assessment.
4. No TRACE certificate was shown for TDS deducted by any of the faculty. Depositing TDS against PAN of faculty could not be traced.
5. Resultantly deficiency of faculty is: (a) Professor: 1; (b) Asso. Prof.: 3; (b) Asst. Prof.: 2.
6. Dr. G.N. Verma, Asso. Prof. was absent at 10:15 a.m. He reported at 2 p.m. hence cannot be considered.
7. Payment of stipend is done irregularly & in few months.
8. Dr. Kuldeep Singh, Assoc. Professor is not eligible. He was Asst. Professor for 4 years 4 months against the requirement of 5 years. In 2011, there was no provision for publications benefit.
9. Dr. Anshul Gupta, Asst. Professor is DNB from non-teaching. She is not eligible, she has no 3 years experience in a medical college.
10. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 04 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

1. Promotion of Dr. Rajesh Verma, Professor & HoD is not as per Regulations. He was Asst. Professor for 4 years 8 months against the requirement of 5 years and Assoc. Professor for 3 years 9 months against the requirement of 4 years without any publications.
2. Unit I does not have Asso. Prof.; resultantly faculty complement is incomplete.
3. Both Senior Residents who were found to be non-eligible in earlier assessment have been made eligible by amending orders to show experience of 3 years as Resident retrospectively which is not permissible.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. (June, 2015) and compliance dated 10/09/2015 submitted by the college authorities and decided to recommend not to recognize MD(Emergency Medicine) qualification for 02 seats granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi because of the following facts:-

1. Bed occupancy was 31.75 % on day of assessment.
2. Dr. G. Ganapathi Rao, Professor has no special training in Emergency Medicine.
3. There are only 2 faculty shown in the faculty table; resultantly faculty complement is incomplete & it cannot be considered as PG Unit.
4. Dr. Girish Kumar K.P., Professor has experience in the department of General Medicine as Asst. Professor from 11/11/2003 to 10/11/2008 at Amrita School of Medicine, Kochi and Dr. G. Ganapathi Rao, Professor has experience in the department of General Medicine as Lecturer/ Assistant Professor from 13/01/1984 to 27/04/1998 at Medical College, Calicut and Medical College, Thrissur; Assoc. Professor from 27/04/1998 to 31/01/2002 at Medical College, Trivandrum and Medical College, Calicut; Assoc. Professor from 01/02/2002 to 31/04/2002 at Amrita School of Medicine, Kochi and Professor from 01/05/2002 to 31/12/2013 at Amrita School of Medicine, Kochi.
5. Dr. Naveen Mohan is shown as "Senior Resident" in the column of Designation but in the column of experience, it is shown as "Junior Resident" w.e.f 02/05/2012 till date. This dichotomy needs to be clarified.
6. Teaching experience of both Residents is not proper. Deficiency remains as it is.
7. Certificate of special training is not provided in respect of faculty.
8. Beds in Casualty are also counted for Emergency Medicine which is not permissible.
9. Certain wards are not as per MSR Regulations.
10. Dean has not signed the assessment report.
11. Other deficiencies as pointed out in the Assessment Report.

4. Other deficiencies as pointed out in the Assessment Report.

3. Promotion of Brig. P.C. Awasthi is not as per Regulations. He was promoted on 28/10/2015 without any publications.
4. Promotion of Col. Alok Kulshreshtha, Assoc. Professor is not as per Regulations. He was promoted on 09/08/2015 after the cut-off date without any publication.
5. Lt. Col. Sameer Mehrotra was not available on Assessment day.
6. Other deficiencies as pointed out in the Assessment Report.

**24. The Tamil Nadu Dr. M.G.R. Medical College University, Chennai - Recognition of MS(General Surgery) qualification against increased intake from 03 to 04 seats in respect of students being trained at Chengalpattu Medical College, Chengalpattu.**

Read: the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 14/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(General Surgery) qualification against increased intake from 03 to 04 seats at Chengalpattu Medical College, Chengalpattu granted by The Tamil Nadu Dr. M.G.R. Medical College University, Chennai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 14/09/2015 submitted by the college authorities and decided to recommend not to recognize MS(General Surgery) qualification against increased intake from 03 to 04 seats granted by The Tamil Nadu Dr. M.G.R. Medical College University, Chennai in respect of students being trained at Chengalpattu Medical College, Chengalpattu because of the following facts:-

1. Specialty clinics like Cardiovascular & Thoracic Surgery clinic, Surgical Gastroenterology clinic, Surgical Oncology clinic are still not available. Deficiency remains as it is.
2. No original research article is published in indexed journal as yet.
3. There is no Senior Resident in Unit 4.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 03 to 04 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/04/2016) along with the Council Assessor's Report (17.04.2014, Jan.,2015 & 07.07.2015) and compliance dated 30/09/2015 submitted by the college authorities and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 05 to 06 seats granted by Bharath University, Chennai in respect of students being trained at Sree Balaji Medical College & Hospital, Chennai because of the following facts:-

1. In NICU or PICU, none of the babies admitted was on ventilator. In PICU, only 1 out of 4 patients was in critical condition.
2. Wards: Only about 25 % of admitted patients were having important health issues. Only 50-55 % of admitted patients were found to be suffering from ailments fit enough to teach PG students.
3. Professor, Unit-III, Dr. Annamalai Vijayaraghavan shown as Professor in column of Designation and Assoc. Professor is column of Experience. If last column is Professor w.e.f. 03/02/2016, he is not eligible. He has no publications. Resultantly, Unit-III left with 2 faculty.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 5 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 30/01/2016 submitted by the college authorities and decided to recommend to the Central Government that the recognition of MD(Forensic Medicine/ Forensic Medicine & Toxicology) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Al-Ameen Medical College, Bijapur be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

Read: the Compliance Verification Assessment Report (05/04/2016) along with the Council Assessor's Report (November, 2014 & 26.06.2015) and compliance dated 21/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Community Medicine) qualification for 02 seats at Medicity Institute of Medical Sciences, Ghanpur granted by Dr. N.T.R. University of Health Sciences, Vijaywada. A.P.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/04/2016) along with the Council Assessor's Report (November, 2014 & 26.06.2015) and compliance dated 21/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Community Medicine) qualification for 02 seats granted by Dr. N.T.R. University of Health Sciences, Vijaywada. A.P in respect of students being trained at Medicity Institute of Medical Sciences, Ghanpur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**28. Pondicherry University, Puducherry - Recognition of MD(Anaesthesiology) qualification for 03 seats in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry.**

Read: the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 04/02/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesiology) qualification for 03 seats at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry granted by Pondicherry University, Puducherry.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 04/02/2016 submitted by the college authorities and decided to recommend not to recognize MD(Anaesthesiology) qualification for 03 seats granted by Pondicherry University, Puducherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry because of the following facts:-

1. Dr. Dinesh Babu has been promoted as Asso. Prof. after cutoff date; however out of 3 publications cited in the list, 2 are case reports; hence there is only 1 original article against requirement of 2; resultantly his promotion is not as per Regulations & he cannot be considered as faculty.
2. Dr. Dinesh Kumar S. & Dr. K. Srikanth, both Asst. Prof., have acquired DNB from non-teaching institutes and do not possess requisite experience to hold the post.
3. Resultantly deficiency of faculty is: (a) Asso. Prof.: 2
4. Shortage of Senior Residents: 2.
5. In earlier report, it was remarked there were only 2 research publications from the department. It is stated that since then 6 more articles have been sent for publication; however their acceptance is awaited. Hence presently deficiency remains as such.
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 03 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (31/03/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 12/02/2016 submitted by the college authorities

and decided to recommend not to recognize MS(ENT) qualification against increased intake from 2 to 4 seats granted by Delhi University, Delhi in respect of students being trained at Army Hospital Research & Referral, New Delhi because of the following facts:-

1. Deficiency 4: It was for the Institute to take the Assessor to Centre of Exam. Without inspection of Exam, recognition under section 11(2) cannot be granted.
2. Professor, Col. Poonam Raj: Advisor in October, 2014. So, she can be given equated teaching designation of Professor from October, 2014. However, this is after cut-off date and she has no publications. Hence, her promotion is not as per Regulations.
3. Deficiency 2: During year 3, there were 774 patients admitted and Major Operations stated are 1080, which ENT Major Surgeries can be done on Day Care basis. This number excludes Minor Surgeries, which can be performed on Day Care basis. The objection is not irrelevant. Percentage of ENT patients having multiple surgeries in same sitting or ENT surgeon operating on patients admitted in other wards cannot be 40%. To call the objection irrelevant may not be very appropriate.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 10/02/2016 submitted by the college authorities and decided to recommend not to recognize MS(Orthopaedics) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Govt. Medical College, Latur because of the following facts:-

1. Students cannot be allowed to complete their training period of 3 years after the exam. 3 years period including exam period not beyond that.
2. Dr. Shashikant, Lecturer is DNB from non-teaching Institute. Hence, he is not eligible to hold the post on which he is working.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/04/2016) along with the Council Assessor's Report (July, 2013) and compliance dated 28/07/2015 submitted by the college authorities and decided to recommend to the Central Government that M.Ch.(Neuro surgery) qualification against increased intake from 01(One) to 03(Three) seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Andhra Medical College, Visakhapatnam be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**32. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MS(General Surgery) qualification against increased intake from 04 to 06 seats in respect of students being trained at MNR Medical College, Sangareddy.**

Read: the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 06/02/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(General Surgery) qualification against increased intake from 04 to 06 seats at MNR Medical College, Sangareddy granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 06/02/2016 submitted by the college authorities and decided to recommend not to recognize MS(General Surgery) qualification against increased intake from 04 to 06 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at MNR Medical College, Sangareddy because of the following facts:-

1. Dr. C.V. Mohan, Senior resident in Unit I does not have 3 years experience as Resident in a medical college; hence not eligible to hold the post; resultantly there is no Senior Resident in Unit I.
2. Senior Resident in Unit-I is not eligible. He is DNB from non-teaching without 3 years experience as Junior Resident in a Medical College. NO other Senior Resident.
3. Dr. B. Srinivas, Unit IV has been promoted as Asso. Prof. after cutoff date; however details of research publications are not provided; hence he cannot be considered as faculty; resultantly there are only 2 faculty in Unit IV & it cannot be considered as PG Unit.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 18/09/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Social & Preventive Medicine / Community Medicine) qualification for 04 seats granted by Yenepoya University in respect of students being trained at Yenepoya Medical College, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**34. Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MD(Tuberculosis & Respiratory Diseases / Pulmonary Medicine) qualification for 02 seats in respect of students being trained at Katuri Medical College, Guntur.**

Read: the Compliance Verification Assessment Report (06/04/2016) along with the Council Assessor's Report (May, 2013 & 30.12.2015) and compliance dated 30/12/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Tuberculosis & Respiratory Diseases / Pulmonary Medicine) qualification for 02 seats at Katuri Medical College, Guntur granted by Dr. NTR University of Health Sciences, Vijayawada, A.P..

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/04/2016) along with the Council Assessor's Report (May, 2013 & 30.12.2015) and compliance dated 30/12/2015 submitted by the college authorities and decided to recommend not to recognize MD(Tuberculosis & Respiratory Diseases / Pulmonary Medicine) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at Katuri Medical College, Guntur because of the following facts:-

1. Dr. P.V.K. Kumar has been promoted as Asso. Prof. with experience of only 4 years 3 months as Asst. Prof.; however 1 out of 2 publications cited in the list is a case report which cannot be considered; hence his promotion is not as per Regulations & he cannot be considered as faculty.
2. Resultantly, there is no Asso. Prof. in Unit I & there are only 2 faculty in the Unit; hence it cannot be considered as PG Unit.
3. Except Asthma clinic & Allergy clinic, no other Special clinic is run. Deficiency remains as it is.
4. Details of stipend paid are provided by way of payment register only. It is not shown whether it is paid through bank or not. Bank passbook entries are not shown.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek

timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

1. One remark was regarding payment of stipend to Residents in cash. No compliance is shown regarding it. No evidence of bank transfer or passbook entries has been shown.
2. UHC: It is still run in a Rotary Club building. The fact that it is a non-profitable organization is of no relevance. Cold chain equipment is not available. No compliance is given regarding inadequate infrastructure.
3. RHTC: No compliance is submitted regarding even Normal Deliveries are not being conducted.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 06 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 1. Dr. Lalit Gothecha, Asst. Prof. has only 2 years experience as Resident against requirement of 3 years required as per Regulations; hence not qualified to hold the post.
2. Dr. Reena Gupta, Senior Resident was shown as Senior Resident w.e.f. 01/11/2013 in the reports dated 12/06/2014 and 18/11/2015 and also in her Declaration Form enclosed with those reports. However, this has been changed to Resident w.e.f. 01/01/2013 and Senior Resident from 01/11/2014, which is not permissible. The Committee decided that matter be referred to the Ethics Committee.
3. Patient entry register is still not maintained independently by the department. Only printouts of computerized data are kept in the department which is not same as independent entry register.
4. Other deficiencies as pointed out in the Assessment Report.

1. Dr. Md. Javed Akhtar, Unit VI has been promoted as Professor after cutoff date; however, details of his research publications are not provided; hence it cannot be verified whether his promotion is as per Regulations or not.
2. No Certificate of Dr. P.K. Hota as Graded Specialist, Classified Specialist and Advisor attached. It is for the college to designate him. College has designated him Asst. Professor from 3 years 2 months. Unit-III left with 2 faculty. There are no 2 Asst. Professor in Unit-III, only one Asst. Professor.
3. Promotion of Dr. M.D. Jawed Akhtar, Professor, Unit-VI is not as per Regulations. He was Asst. Professor for 4 years and Assoc. Professor for 3 years 3 months without any publications. Resultantly, Unit-VI left with 2 Asst. Professor.
4. Dr. Vamshi Krishna has not signed faculty table, which means she is absent.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 6 to 8 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. 1. Dr. Aneesh, Asso. Prof. has been promoted after cutoff date; however, both of his publications cited in the list are case reports & cannot be accepted; hence he cannot be considered as faculty.
2. Dr. Nagaraj, Asso. Prof. in Unit IV has been promoted after cutoff date; however, details of his research publications are not provided; hence it cannot be verified whether his promotion is as per Regulations or not.
3. Promotion of Dr. Aneesh, Assoc. Professor is not as per Regulations. He was promoted on 01/08/2015. Both publications are Case Reports.
4. Promotion of Dr. Ali Hasan Karnam, Assoc. Professor, Unit-III is not as per Regulations. He was promoted on 01/06/2015 without any publications.

5. Dr. George Abraham is not eligible. He was Asst. Professor for 3 years and never been Assoc. Professor. He was absent on the Assessment day.
6. Promotion of Dr. Nagrajan, Assoc. Professor is not as per Regulations. He was promoted on 16/10/2014 without any publications. Resultantly, Unit-IV left with only 2 Asst. Professor.
7. Stipend increased since when not given.
8. One External Examiner is from the same state.
9. Other deficiencies as pointed out in the Assessment Report.

1. Dr. M. Praveen Kumar has been promoted as Asso. Prof. after cutoff date. He has no publications. Hence, not eligible.
2. Workload of DSA is only 4-5/month.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 3 degree and 1 diploma seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 3. Dr. Shabina Parveen, Asst. Professor was absent on the day of Assessment. She had not signed the Faculty Table.
4. 8 Staff members were absent on the day of Assessment.
5. Dr. Ayesha Parveen, Senior Resident in Unit I; Dr. R. Anjum, Senior Resident in Unit III does not have experience of 3 years as Resident before being appointed as Senior Resident; hence not qualified to hold the post; resultantly there is no Senior Resident.
6. Dr. Salma Aqueel has been shown as Senior Resident in the column of Designation; however in the column of teaching experience, it is shown as Junior Resident w.e.f. 01/01/2012 till date. This dichotomy needs to be clarified.
7. Both Senior Resident in Unit are shown as Junior Resident in column of experience. One of them was absent.
8. On day of assessment there was NIL Major Obstetric operation; out of 6 Major operations, 3 were Hysterectomies which are Gynaecological operations & 3 were LSCS which are to be considered separately; resultantly there is NIL Major Obstetric operation. Deficiency remains as it is.
9. Other deficiencies as pointed out in the Assessment Report.

2. Out of 3 Senior Residents, 2 are Honorary & cannot be considered.
3. OPD attendance on day of assessment was 43 which is inadequate.
4. Bed occupancy was only 26.67 % on day of assessment.
5. Last ECT was given on 08/08/2015. There is no Pre ECT, Post ECT Resuscitation facility.
6. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 28/09/2015 submitted by the college authorities and decided to recommend to the Central Government that MS(ENT) qualification for 2 seats granted by Kerala University of Health Sciences, Thrissur/ Kerala University in respect of students being trained at Jubilee Mission Medical College & Research Institute, Kerala be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

Read: the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 19/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MD(Anaesthesiology) qualification for 2 seats & recognition against increased intake from 2 to 3 seats at Institute of Naval Medicine, INHS, Aswini granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 19/10/2015 submitted by the college authorities and decided to recommend not to renew the recognition of MD(Anaesthesiology) qualification for 2 seats and not to recognize against increased intake from 2 to 3 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Institute of Naval Medicine, INHS, Aswini because of the following facts:-

1. Promotion of Lt. Col. Kiran S., Assoc. Professor is not as per Regulations. He has been promoted on 08/12/2014 without any publications.
2. Promotion of Dr. V. Bhatnagar is not as per Regulations. He was promoted Assoc. Professor in September, 2014 without any publications.
3. Deficiency of Assoc. Professor: 2
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/04/2016) along with the Council Assessor's Report (May, 2013 and 03.08.2015) and compliance dated 30/12/2015 submitted by the college authorities and decided to recommend not to recognize MS (General Surgery) qualification for 04 (Four) seats granted by Dr. NTR University of Health Sciences,

Vijayawada, A.P. in respect of students being trained at Katuri Medical College, Guntur because of the following facts:-

1. Dr. S.V. Subbarao, Dr. K. Sudhakar Rao & Dr. A. Saidatta, all Asso. Prof. have been promoted after cutoff date; however no details of publications are provided; hence it cannot be verified whether their promotion is as per Regulations or not. As there are only 3 publications from the department in last 5 years, it is not feasible that both of them would have 2 research papers to their credit.
2. Promotion of Dr. S.V.S. Rao, Asso. Prof. is not as per Regulations as he has been promoted as Asso. Prof. with experience of only 3 years 1 month as Asst. Prof. against requirement of 5 y; hence he cannot be considered; resultantly there are only 2 faculty in Unit V and it would come to be headed by Asst. Prof. and it cannot be considered as PG Unit.
3. Dr. Koteswar Rao, Assoc. Professor, Unit-I was absent on the day of Assessment. He had not signed the Faculty Table.
4. Dr. V. Kotaiah, Asst. Professor, Unit-IV was absent on the day of Assessment.
5. Departmental museum has only a few specimens on two shelves and that too is placed in the departmental library.
6. There is inadequate space in departmental library. Only 2 Surgical Interventional Journals available.
7. Departmental Museum almost non-existent.
8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 04 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

Read: the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 06/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification against increased intake from 3 to 5 seats at Dr. D. Y. Patil Medical College, Kolhapur granted by D.Y. Patil Education Society Deemed University, Kolhapur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 06/11/2015 submitted by the college authorities and decided to recommend not to recognize MS(OBG) qualification against increased intake from 3 to 5 seats granted by D.Y. Patil Education Society Deemed University, Kolhapur in respect of students being trained at Dr. D. Y. Patil Medical College, Kolhapur because of the following facts:-

1. In 2015, total number of Major, Minor & Daycare operations is 3,391 but total number of specimens sent for Histopathology from the department is 4,123 which is not feasible. There is data mismatch.
2. Research Publications by teachers are less. Most of the articles cited in the list are review articles. Deficiency remains as it is.
3. Bed occupancy of HDU has not improved. Infrastructure of HDU needs improvement.
4. Specialty clinics like Cancer Detection clinic are insufficient.
5. Prenatal diagnosis services are not provided.
6. Official website is still under construction.
7. Elective O.T. list not signed by HOU or HOD.
8. In Blood Bank, blood is not issued to patient in spite of being available. (Pt. # B 14101, dt. 03/04/2016).
9. General Surgery & O.G. departments have common set of Endoscopes, Cables, Cautery & other instruments which is not permissible.
10. MRD: It was extremely difficult to retrieve data or inpatient records even by MRD staff itself.
11. MRI workload of the whole hospital is 7-8 on day of assessment.
12. Total number of patients have remained almost stagnant over 3 year period from 2013 to 2015.
13. Dr. S.R. Rawal, Senior Resident has experience of only 1 year 4 months as Resident in Medical College affiliated hospitals; hence not qualified to hold the post; resultantly there is no Senior Resident in Unit III.
14. In earlier report, one remark was that "The experience of Dr. Pallavi Mirashi, Dr. K. Anamika & Dr. K. Madhulika, all Senior Residents, was that as Tutor & not as Junior Resident which cannot be accepted as Tutor is a designation in basic departments." In the present assessment, their experience has been changed from Tutor to Junior Resident with retrospective effect which is not permissible.
15. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 3 to 5 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (01/04/2016) along with the Council Assessor's Report (June, 2014 & 03.07.2015) and compliance dated 19/11/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 05 to 06 seats granted by Rajasthan University of Health Sciences, Jaipur in respect of students being trained at Jawaharlal Nehru Medical College, Ajmer be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**52. Manipal University, Manipal - Recognition of MD(Radiotherapy) qualification against increased intake from 02 to 03 seats in respect of students being trained at Kasturba Medical College, Manipal.**

Read: the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 06/08/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radiotherapy) qualification against increased intake from 02 to 03 seats at Kasturba Medical College, Manipal granted by Manipal University, Manipal.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 06/08/2015 submitted by the college authorities and decided to recommend not to recognize MD(Radiotherapy) qualification against increased intake from 02 to 03 seats granted by Manipal University, Manipal in respect of students being trained at Kasturba Medical College, Manipal because of the following facts:-

1. OPD attendance on day of assessment is only 35.
2. Bed occupancy is only 16.67 % on day of assessment.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 3 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

The Postgraduate Medical Education Committee considered the letter dated 09/02/2016 received from the Ministry of Health & Family Welfare, New Delhi forwarding therewith a copy of letter dated 16/11/2015 received from the Secretary, Health & Family Welfare Department, Govt. of Tamil Nadu with regard to Recognition of MS(OBG) qualification at Tirunelveli Medical College, Tirunelveli, Tamil Nadu for the batches admitted during the year from 1996 to 1998 and noted that the batch was admitted after the introduction of Regulation 10A in the IMC Act, 1956 under which, no course could be started without the permission of MCI. Under the circumstances, it is not possible to give retrospective recognition to the batches admitted in 1996, 1997 and 1998.

**54. Starting of DM (Infectious Disease) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17- consideration of compliance.**

Read: the Council Assessor's Report (24th February 2016) and compliance dated 19th April 2016 submitted by the college authorities on the physical and other teaching facilities available at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of DM (Infectious Disease) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (24th February 2016) and compliance dated 19th April 2016 submitted by the college authorities and noted the following:

1. The deficiency of Senior Resident stays as such. There is no eligible Senior Resident in the department of Infectious Disease.
2. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Starting of DM (Infectious Disease) course at Christian Medical College,



Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

**55. Starting of M.Ch. (Gynaecological oncology) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17- consideration of compliance.**

Read: the Council Assessor's Report (24th February 2016) and compliance dated 19th April 2016 submitted by the college authorities on the physical and other teaching facilities available at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of M.Ch. (Gynaecological oncology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (24th February 2016) and compliance dated 19th April 2016 submitted by the college authorities and noted the following:

1. Still there is no independent department of Gynaecological Oncology. It is a unit under the department of OBGY.
2. As per compliance submitted by the college authorities, they have said that first two years of service in the institute may be treated as training which is not permissible.
3. If Dr. Rachel Chandy and Amit Thomas are to be demoted, it is to be done by the institute and not by MCI.
4. If Dr. Ajit Sebastian is to be made Senior Resident, the college authorities have to do it and not by MCI. MCI cannot remove any person from the list and cannot demote any person.
5. All special training/fellowship of HOD Dr. Abraham Peedicayil is after he completed his Assistant Professorship. He has no 02 year special training at the time of joining as Asstt. Prof. in the department.
6. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Starting of M.Ch. (Gynaecological oncology) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

**56. Increase of seats in DM (Endocrinology) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17- consideration of compliance.**

Read: the Council Assessor's Report (03rd March 2016) and compliance dated 20th April 2016 submitted by the college authorities on the physical and other teaching facilities available at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Increase of seats in DM (Endocrinology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (03rd March 2016) and compliance dated 20th April 2016 submitted by the college authorities and noted the following:

Compliance is not satisfactory.

1. The compliance is not satisfactory.

2. There is no Senior Resident who has 03 years experience as Resident in the department and the deficiency stays as such. Reply given by the college authorities that deficiency of Senior Resident is being addressed cannot be taken as satisfactory.
3. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Increase of seats in DM (Endocrinology) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

**57. Increase of seats in DM (Neurology) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17- consideration of compliance.**

Read: the Council Assessor's Report (24th February 2016) and compliance dated 23rd April 2016 submitted by the college authorities on the physical and other teaching facilities available at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Increase of seats in DM (Neurology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (24th February 2016) and compliance dated 23rd April 2016 submitted by the college authorities and noted the following:

Compliance is not satisfactory.

1. There is no Senior Resident who has 3 years experience as Resident in the department. Deficiency remains as it is.
2. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Increase of seats in DM (Neurology) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

**58. Increase of seats in DM (Hepatology) course at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17- consideration of compliance.**

Read: the Council Assessor's Report (29th February 2016) and compliance dated 20th April 2016 submitted by the college authorities on the physical and other teaching facilities available at Christian Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Increase of seats in DM (Hepatology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (29th February 2016) and compliance dated 20th April 2016 submitted by the college authorities and noted the following:

Compliance is not satisfactory.

1. There is no Senior Resident who has 3 years experience as Resident in the department. Deficiency remains as it is.

2. Deficiency 1 remains as such. Details of training in Haepatology in respect of Dr. Zachariah, Dr. C.Eapen, Dr. K.G. Sajith, Dr. Ashish Goyal and Dr. Bharat Kumar have not been provided.
3. Other deficiencies as pointed out in the Assessment Report.

3. Letter dated 28.3.2016 has been wrongly interpreted by the college authorities and the university. The letter specifically stated that only those doctors who were working in the hospital where with affiliation with any university postgraduate teaching is being imparted should be considered eligible for grant of equated teaching designations; hence department of Plastic Surgery in LNJP Hospital was not entitled to the benefit given any Notification dated 15.03.2005, as stated above.
4. Other deficiencies as pointed out in the Assessment Report.

- (ii) Super-speciality faculty is not counted by MCI while doing inspection for UG (MBBS). However, if their appointment is in main department concerned in UG curriculum, they will be counted irrespective of their degree.
- (iii) If the appointment is in General Medicine, he can be considered but if the basic appointment is in Cardiology, he cannot be considered in General Medicine.

3. Dr. Anupama Hegde passed DNB from non-teaching hospital. She has no 3 years experience as Junior Resident in a teaching institution. Hence, not eligible to be appointed as Senior Resident or Asst. Professor.
4. DM Students are shown as Senior Residents without showing 3 years experience as Resident in the department; hence none of them is qualified to hold the post; resultantly, there is NIL Senior Resident. Deficiency remains as such.
5. Bed occupancy has been computed taking into consideration patients in CCU also which is not permissible as beds in CCU are non-teaching beds.
6. OPD attendance was only 52 which is inadequate for increase in intake.
7. Department of Cardiology runs in association with Narayana Hrudayalaya. Institute has stated that it is for the purpose of co-branding only. Assessor has reported that all the clinical work & procedures are being done in the premises of M.S. Ramaiah Medical College. This implies that the true nature of association is not revealed. It is not clear who is carrying out the clinical work & procedures and what is the extent of training of PGs in such association.

1. Facilities for Renal Transplant yet not available.
2. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Starting of DM (Nephrology) course at Kamineni Institute of Medical Sciences, Narketpally under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

1. There is no significant increase in OPD (86 per day), which does not justify any increase in seats.
