1. Minutes of the last meeting of the Postgraduate Medical Education Committee - confirmation of.

The Postgraduate Medical Education Committee confirmed the minutes of Postgraduate Medical Education Committee meeting held on 12th May, 2016.

2. Minutes of the last meeting of the Postgraduate Medical Education Committee - action taken thereon.

The Postgraduate Medical Education Committee noted & approved the action taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

3. **Maharashtra University of Health Sciences, Nashik - Recognition of MS(OBG) qualification for 02 seats in respect of students being trained at KJ Somaiyya Medical College & Research Centre, Mumbai.**

Read: the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2014, December, 2014 & 28.10.2015) and compliance dated 28/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification for 02 seats at KJ Somaiyya Medical College & Research Centre, Mumbai granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2014, December, 2014 & 28.10.2015) and compliance dated 28/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MS(OBG) qualification for 02 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at KJ Somaiyya Medical College & Research Centre, Mumbai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

4. **Dr. NTR. University of Health Sciences, Vijayawada - Recognition of MD(Hospital Administration) qualification for 02 seats in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally.**

Read: the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 14/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Hospital Administration) qualification for 02 seats at Kamineni Institute of Medical Sciences, Narketpally granted by Dr. NTR. University of Health Sciences, Vijayawada.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 14/09/2015 submitted by the college authorities and decided to recommend not to recognize MD(Hospital Administration) qualification for 02 seats granted by Dr. NTR. University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally because of the following facts:-

1. Both Dr. Bhanuprakash & Dr. Nalini Kanth have been designated as "Residents" & not as "Senior Residents" as required.
2. Administrative control room should be large & the scope/functions expanded.
3. Professor & HoD, Dr. M. Vasudeva Rao promoted on 16/12/2014 after the cut-off date and with 3 years experience as Assoc. Professor without any publications, which is not as per Regulations. Hence, he cannot be accepted as Professor and Head.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in

accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

5. **Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MS(Obstetrics & Gynaecology) qualification against increased intake from 04(Four) to 09(Nine) seats in respect of students being trained at S V Medical College, Tirupati.**

Read: the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2013 for 4 to 6 seats and May, 2015 for 6 to 9 seats, 23.07.2015 for 4 to 6 seats) and compliance dated 13/01/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(Obstetrics & Gynaecology) qualification against increased intake from 04(Four) to 09(Nine) seats at S V Medical College, Tirupati granted by Dr. NTR University of Health Sciences, Vijayawada, A.P..

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2013 for 4 to 6 seats and May, 2015 for 6 to 9 seats, 23.07.2015 for 4 to 6 seats) and compliance dated 13/01/2016 submitted by the college authorities and decided to recommend not to recognize MS(Obstetrics & Gynaecology) qualification against increased intake from 04(Four) to 09(Nine) seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at S V Medical College, Tirupati because of the following facts:-

1. Only 2 faculty from Units II & IV were present on day of assessment; resultantly faculty complement is incomplete & they cannot be considered a PG Units.
2. There was NIL Major operation & NIL Daycare operations on day of assessment. Contention of the institute that "Major operations have not increased much due to audit" is not tenable.
3. Gynaecological OPD was 70 on day of assessment, which is inadequate.
4. Specialty clinic like Gynaec Endocrine clinic is still not run. Deficiency remains as it is.
5. Prenatal diagnostic services except USG are not available. Even USG is carried out by Radiologist & not by O.G. department.
6. The following faculties were absent on inspection day:
 - (i) Dr. V. Bhavani, Professor, Unit-I
 - (ii) Dr. S. Geetha Lakshmi, Asst. Professor, Unit-I
 - (iii) Dr. B. Yamini, Asst. Professor, Unit-I
 - (iv) Dr. Kannapurna, Assoc. Professor, Unit-II.

- (v) Dr. S. Venkata Raman, Asst. Professor, Unit-II
- (vi) Dr. K. Sunitha, Asst. Professor, Unit-II
- (vii) Dr. K. Sreelatha, Unit-III
- (viii) Dr. Manjulatha, Assoc. Professor, Unit-IV
- (ix) Dr. Vijay Kumar, Asst. Professor, Unit-IV
- (x) Dr. Himabindu, Senior Resident

Resultantly, Unit-II & III are left with only 2 Faculty.

How can 8 faculty be absent on the day of Assessment in a Government College? The Dean may be asked to clarify.

7. Cherishma Chand Yadav K, SR DGO is not eligible. She has no 3 years experience at the time of appointment.
8. No Senior Resident in Unit-III
9. Dr. V. Revathi, Professor, Unit-II promoted on 07/09/2015 after the cut-off date. Details of publications (full reference) not given. Hence, her promotion is not as per Regulations.
10. Dr. P. Himabindu promoted Professor on 07/09/2015 after the cut-off date. No full reference of publications is given. Hence, his promotion is not as per Regulations.
11. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 9 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. Read: the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 11/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification against increased intake from 05 to 08 seats at Kasturba Medical College, Mangalore granted by Manipal University, Manipal.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 11/11/2015 submitted by the college authorities

and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 05 to 08 seats granted by Manipal University, Manipal in respect of students being trained at Kasturba Medical College, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

7. **Pondicherry University, Puducherry - Recognition of MD(Physiology) qualification against increased intake from 2 to 4 seats in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry.**

Read: the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 15/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification against increased intake from 2 to 4 seats at Pondicherry Institute of Medical Sciences, Pondicherry granted by Pondicherry University, Puducherry.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 15/10/2015 submitted by the college authorities and decided to recommend not to recognize MD(Physiology) qualification against increased intake from 2 to 4 seats granted by Pondicherry University, Puducherry in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry because of the following facts:-

1. For payment of stipend at Government rates, only an order from the Principal, which has no number or date has been produced, which cannot be accepted. Stipend before June, 2015 remains at old rates. The College authorities be asked to provide proof of payment of stipend at Government rates to all students (Ist, IInd and IIIrd year) in the form of Bank Transfer and entry in their passbooks.
2. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (June, 2013, Feb.,2015, & 30.06.2015) and compliance dated 30/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Anaesthesiology) qualification against increased intake from 04 to 06 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Government Medical College, Mysore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

9. **Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(General Medicine) qualification for 8 seats in respect of students being trained at GSL Medical College & GSL General Hospital, Lakshmipuram, Rajahmundry.**

Read: the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2014 for 6 seats and May, 2015 for 6 to 8 seats and 14/05/2015 for 6 seats) and compliance dated 01/01/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification for 8 seats at GSL Medical College & GSL General Hospital, Lakshmipuram, Rajahmundry granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May, 2014 for 6 seats and May, 2015 for 6 to 8 seats and 14/05/2015 for 6 seats) and compliance dated 01/01/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(General Medicine) qualification for 8 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at GSL Medical College & GSL General Hospital, Lakshmipuram, Rajahmundry be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

10. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Paediatrics) qualification against increased intake from 02 to 03 seats in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore.

J. Institute of Medical Sciences, Mangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (May. 2015) and compliance dated 31/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

11. MGM Institute of Health Sciences, Navi Mumbai - Recognition of MD (General Medicine) qualification against increased intake from 4 to 8 seats in respect of students being trained at MGM Mission's Medical College, Navi Mumbai.

Read: the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (December, 2014 & 30.06.2015) and compliance dated 09/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD (General Medicine) qualification against increased intake from 4 to 8 seats at MGM Mission's Medical College, Navi Mumbai granted by MGM Institute of Health Sciences, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/04/2016) along with the Council Assessor's Report (December, 2014 & 30.06.2015) and compliance dated 09/11/2015 submitted by the college authorities and decided to recommend not to recognize MD (General Medicine) qualification against increased intake from 4 to 8 seats granted by MGM Institute of Health Sciences, Navi Mumbai in respect of students being trained at MGM Mission's Medical College, Navi Mumbai because of the following facts:-

1. Dr. Krishnadas Kotwade is shown as having acquired DNB from Care Hospital Hyderabad in 2015. However, he is also shown as having worked as Resident at this institute from 2012 to 2015 which is not feasible.
2. Resultantly, there is no Senior Resident in Unit IV.
3. Dr. Datta Raj More, Senior Resident, Unit-II is DNB from non-teaching institution. He has no 3 years experience at the time of appointment. Hence, not eligible.
4. 2nd Senior Resident, Dr. Tushar Sontake has not signed the faculty table, which means he was absent on the day of Assessment.

5. Resultantly, there is no Senior Resident in Unit-II.
6. Dr. Umakant Deshpandey, Asst. Professor, Unit-III, Dr. Rajesh Benny, Assoc. Professor, Unit-III and Dr. Ingale Atul Vinayak, Unit-V have not signed the faculty table, which means they were not present on the day of Assessment.
7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 8 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 14. Kerala University of Health Sciences, Thrissur/ Kerala University - Recognition of MD(Radiodiagnosis) qualification against increased intake from 02 to 05 seats in respect of students being trained at Govt. Medical College, Kozhikode, Calicut, Kerala.

Read: the Compliance Verification Assessment Report (18/04/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 23/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radiodiagnosis) qualification against increased intake from 02 to 05 seats at Govt. 7. Dr. B. Shankar, Assoc. Professor, Unit-IV promoted on 01/08/2014 after the cut-off date without any publications. Hence, not eligible. Unit is left with 2 Faculty. Hence, it cannot be considered a PG Unit.
8. Dr. A. Srinivas, Assoc. Professor, Unit-VI promoted on 01/10/2014 after the cut-off date without any publications. Hence, not eligible. Resultantly, Unit-IV does not have full faculty complement. Hence, it cannot be considered a PG Unit.

9. All dates in different ranks of Dr. C. Raja Krishna Prasad have been changed from previous report, which is not permissible. His experience as per previous report is as below:

1. Dr. Vidyasagar Narsingrao, Assoc. Professor, Unit-II promoted on 01/03/2016 after the cut-off date without any publications, which is not as per Regulations. Hence, he cannot be considered as Assoc. Professor.
2. Resultantly, Unit-II is left with 2 faculty.

1. In earlier assessment remark was that "Facilities for Retinal Surgery are not available." Institute in its compliance has stated that purchase order for OCT has been placed on 27/09/2015. Assessor in his report of April 2016 does not mention availability of OCT; rather it is reiterated that order has been placed on 27/09/2015. It is surprising that OCT machine has not been made functional even after 7 months. In this view, deficiency of facility for Retinal Surgery remains as it is.

2. Promotion of Dr. Srinivas R. Kalligudi, Assoc. Professor, Unit-I is not as per Regulations. He was Asst. Professor for 4 years 1 month. Both publications quoted are outside his period of Asst. Professorship.
3. Dr. Neelkanth, Assoc. Professor, Unit-II was absent on the day of Assessment.
4. Promotion of Dr. Arun K.N., Professor, Unit-C is not as per Regulations. He was Asst. Professor for 4 years 9 months. All publications are outside his period of Asst. Professorship.
5. Dr. Sri Harsha Patil, Senior Resident is DNB from non-teaching hospital and no 3 years experience as Junior Resident in a medical College. Hence, not eligible.
6. Other deficiencies as pointed out in the Assessment Report.

1. Dr. B. Vengamma, Professor & HOD was not available on day of assessment as he has gone abroad for training.
2. Resultantly, there are only 2 faculty in Unit I & it cannot be considered a PG Unit.
3. There is no Senior Resident in the Department.
4. Dr. T. Naveen, Assoc. Professor promoted on 23/05/2015 after the cut-off date. He is not first or second author in any of the publications cited, which is not as per Regulations. Hence, he cannot be considered Assoc. Professor.
5. Other deficiencies as pointed out in the Assessment Report.

1. With regard to payment of stipend, bank statement has been produced for only 1 Resident; for others the institute has submitted its own certificate without any corroborative evidence. Deficiency regarding payment of stipend to Residents @ Govt. rates remains as such.
2. Bed occupancy was 50% on day of assessment.
3. There was only 1 Major & 1 Minor operation on day of assessment, which is inadequate.
4. There was only 1 patient in OICU on day of assessment (Occupancy 50%).
5. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment.
6. Occupancy in NICU was only 1 on day of assessment (Occupancy 17%).
7. There are only 2 research publications from the department in indexed journals in last 3 years. Deficiency remains as it is.

Abdul Rafeek has no 3 years experience as Junior Resident. Resultantly, there is a deficiency of Senior Residents: 2. The P.G. Committee decided to obtain clarification from the Dean and concerned faculty members for thie discrepancies, which amounts to supplying false information.

1. Dr. N. Sandeep, Senior Resident has been shown as Junior Resident from 01/09/2012 to 31/08/2013 in the present report. However in earlier report, he was shown as Senior Resident from 01/09/2012 till date. Thus his experience has been changed retrospectively which is not permissible. It is also an attempt to mislead the Council.
2. Dr. K.C. Kranthi, Senior Resident has been shown as Junior Resident from 15/11/2012 to 14/11/2015 in the present report. However in earlier report, he was shown as Senior Resident from 15/11/2012 till date. Thus his experience has been changed retrospectively which is not permissible. It is also an attempt to mislead the Council. The P.G. Committee decided to seek clarification from the Dean and concerned Senior Resident for supplying false and misleading information.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 01 seat after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per

provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

51. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MS(OBG) qualification for 01 seat in respect of students being trained at Konaseema Institute of Medical Sciences & Research Foundation, Amalapuram.

Read: the Compliance Verification Assessment Report (29/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 23/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification for 01 seat at Konaseema Institute of Medical Sciences & Research Foundation, Amalapuram granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (29/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 23/10/2015 submitted by the college authorities and decided to recommend not to recognize MS(OBG) qualification for 01 seat granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Konaseema Institute of Medical Sciences & Research Foundation, Amalapuram because of the following facts:-

1. The college authorities have stated that they are dealing with all critically ill patients, however, there is only one death in the department during the entire year, which speaks contrary to the above contention. The Assessor could not find that any patients were shifted to other ICU as claimed by the college authorities. The deficiency remains as such.
2. On the day of Assessment Deliveries were Nil.
3. Dr. K. Suba Rao, Professor, Unit-III promoted on 01/03/2015 after the cut-off date without any publications, which is not as per Regulations. Resultantly, Unit-III left with two Asst. Professors only.
4. Five Senior Faculties were absent on the day of Assessment, which raises serious doubt about the full time, regular nature of appointment of faculty.
5. Three Senior Residents have MD qualification (not MS), which means they have no PG qualification in OBG.
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 01 seat after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek

timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

52. Baba Farid University of Health Sciences, Faridkot - Recognition of MD(Radiotherapy) qualification against increased intake from 01 to 02 seats in respect of students being trained at Christian Medical College, Ludhiana.

Read: the Compliance Verification Assessment Report (29/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 12/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radiotherapy) qualification against increased intake from 01 to 02 seats at Christian Medical College, Ludhiana granted by Baba Farid University of Health Sciences, Faridkot.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (29/04/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 12/11/2015 submitted by the college authorities and decided to recommend not to recognize MD(Radiotherapy) qualification against increased intake from 01 to 02 seats granted by Baba Farid University of Health Sciences, Faridkot in respect of students being trained at Christian Medical College, Ludhiana because of the following facts:-

1. HDR Brachytherapy is not yet available.
2. Total OPD on day of assessment is 37, which is inadequate.
3. No Radioisotope work is done in the department.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 2 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

Read: the Compliance Verification Assessment Report (26/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 06/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(General Surgery) qualification for 02 seats at ESI-PGIMSR,ESI Hospital, K.K Nagar, Chennai granted by The Tamilnadu Dr. MGR Medical University, Chennai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (26/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 06/11/2015 submitted by the college authorities and decided to recommend to the Central Government that MS(General Surgery) qualification for 02 seats granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at ESI-PGIMSR,ESI Hospital, K.K Nagar, Chennai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

54. Vinayaka Mission's University, salem - Recognition of MD(Paediatrics) qualification against increased intake from 02 to 04 seats in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem.

Read: the Compliance Verification Assessment Report (25/04/2016) along with the Council Assessor's Report (25.04.2014) and compliance dated 09/01/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification against increased intake from 02 to 04 seats at Vinayaka Mission's Kirupananda Variyar Medical College, Salem granted by Vinayaka Mission's University, salem.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (25/04/2016) along with the Council Assessor's Report (25.04.2014) and compliance dated 09/01/2016 submitted by the college authorities and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 02 to 04 seats granted by Vinayaka Mission's University, salem in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem because of the following facts:-

1. Bed occupancy is 50% on day of assessment.
2. Labour room does not have properly demarcated area for newborn resuscitation. Even sheets for wiping babies could not be produced.
3. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment; resultantly there was NIL Newborn to take care on day of assessment.
4. Three patients were found with IV cannula stuck on their skin & sticking plaster applied to it to give appearance of IV fluid being given which was

not true. There was not a single patient on IV fluids although case sheets mentioned 10-12 patients.

5. Pantry in Unit I is an empty room; Unit II has no pantry.
6. There was no Nebulizer in Unit I although Doctors & Nurses mentioned about patients getting nebulization every 2 hours.
7. Drugs mentioned on case sheets are not found in the ward. (E.g. patient named Namratha)
8. X-rays of patients claimed to have been done 2 days ago could not be produced.
9. CT & MRI are done at VIMS hospital, another hospital owned by the same trust not under control of Dean.
10. 22 children in OPD had no relative with them. They appeared to have been brought by 2-3 attendants only for inspection & were given milk with bread by hospital authorities.
11. Senior Residents do not stay in the campus.
12. Case sheets of some patients shown in Specialty OPD register could not be found. (E.g. Patient Babu on 18/03/2016).
13. Blood bank is in VIMS hospital which is ½ km. away & bears no record of being a part of medical college or hospital.
14. Biochemistry had 33 samples from Paediatrics on day of assessment but only 59 total samples were there from whole hospital. Data are inflated.
15. Birth records submitted to Authority show 10 deliveries in April & 12 in March which are grossly inadequate; however labour room record higher number of deliveries. Data are inflated.
16. Patients in VIMS hospital are managed by Asst. Prof. of medical college during working hours.
17. Histopathology had no sample on day of assessment. There were only 4 samples of last full working day (22/04/2016).
18. Some examination going students do not have a single publication.
19. Biomedical disposal for sharp objects was not available in Paediatric wards.
20. Dr. M.G. Venkatesan, Senior Resident, does not have experience of 3 years as Resident in medical college; hence not qualified to hold the post; Resultantly there is no Senior Resident in Unit I & Shortage of Senior Resident: 1.
21. Other deficiencies as pointed out in the Assessment Report.

The Committee further decided to seek explanation from the Dean and HoD for deficiency at Sl. No. 4, which amounts to supplying false and misleading information.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

Read: the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 13/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification against increased intake from 03 to 05 seats at Andhra Medical College, Visakhapatnam granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 13/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Social & Preventive Medicine / Community Medicine) qualification against increased intake from 03 to 05 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Andhra Medical College, Visakhapatnam be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

56. C.G. Ayush & Health Science University, Raipur - Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 01 seat in respect of students being trained at Chhattisgarh Institute of Medical Sciences, Bilaspur.

Read: the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (Sep, 2014) and compliance dated 11/03/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 01 seat at Chhattisgarh Institute of Medical Sciences, Bilaspur granted by C.G. Ayush & Health Science University, Raipur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (Sep, 2014) and compliance dated 11/03/2016 submitted by the college authorities and decided to recommend not to recognize MD(Social & Preventive Medicine / Community Medicine) qualification for 01 seat granted by C.G. Ayush & Health Science University, Raipur in respect of students being trained at Chhattisgarh Institute of Medical Sciences, Bilaspur because of the following facts:-

1. Dr. Shankuntala Jitpure, Assoc. Professor promoted on 29/09/2014 after the cut-off date without any publications, which is not as per Regulations.
2. There is no Statistician in the department.
3. There is no Epidemiologist in the department.

4. Deficiency of Faculty: (a) Assoc. Professor: 1; (b) Statistician: 1 and (c) Epidemiologist: 1.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 01 seat after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/05/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 23/01/2016 submitted by the college authorities and decided to recommend not to recognize MD(Tuberculosis & Respiratory Diseases / Pulmonary Medicine) qualification against increased intake from 03 to 04 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Armed Forces Medical College, Pune because of the following facts:-

1. Professor was not present on day of assessment.
2. Faculty is inadequate for 4 seats.
3. Other deficiencies as pointed out in the Assessment Report.

Note: In the compliance institute has requested for recognition of 3 seats. As 3 seats are already recognized & 4th was permitted in 2010, and as only 3 students have been admitted during period 2011 - 2015, institute be asked to clarify whether any student has ever been admitted against increased intake form 3 to 4. If not, the matter be treated as closed in view of request of college and no further action is required in the matter.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 26/02/2016 submitted by the college authorities and decided to recommend not to recognize M.S.(Ophthalmology) qualification against increased intake from 02 to 04 seats granted by Delhi University, Delhi in respect of students being trained at Army Hospital Research & Referral, New Delhi because of the following facts:-

1. Bed occupancy is 65.70% on day of assessment.
2. There is only 1 Unit with 40 beds; hence maximum 4 seats can be recognized. Institute already has 4 recognized seats - 2 Degree & 2 Diploma. Creation of 2nd full-fledged Unit is required for recognition of any further seat in Permitted category (i.e. 2 seats permitted in 2010).
3. There are no multiple major ophthalmic surgeries possible on the same patient during one admission and if multiple admissions are done then the patient gets a new IPD number each time. To call the observation irrelevant may not be justified. As per ICD X classification, Major Operations are not classified on OPD basis.
4. OPD on the day of Assessment: Nil. OPD runs thrice a week.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the

concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (June, 2014) and compliance dated 17/02/2016 submitted by the college authorities and decided to recommend to the Central Government that MS(General Surgery) qualification for 02 seats granted by Kerala University of Health Sciences in respect of students being trained at Sri Gokulam Medical College Trust & Research Foundation, Trivandrum, Kerala be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

60. Sri Balaji Vidyapeeth University, Puducherry - Renewal of recognition of MS(Orthopaedics) and D Ortho qualifications for 01 seat each in respect of students being trained at Mahatama Gandhi Medical College & Research Institute, Pondicherry.

Read: the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 22/02/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(Orthopaedics) and D Ortho qualifications for 01 seat each at Mahatama Gandhi Medical College & Research Institute, Pondicherry granted by Sri Balaji Vidyapeeth University, Puducherry.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/05/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 22/02/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MS(Orthopaedics) and D

Ortho qualifications for 01 seat each granted by Sri Balaji Vidyapeeth University, Puducherry in respect of students being trained at Mahatama Gandhi Medical College & Research Institute, Pondicherry because of the following facts:-

1. In the compliance, it was stated by institute that Dr. S. Ravichandran was demoted as Asso. Prof. & was head of Unit 2 and even his Declaration Form as Asso. Prof. (after demotion to Asso. Prof.) was enclosed; however, in the faculty table, he is shown as Professor & as HOU of Unit 5. His experience is shown as Professor w.e.f. 27/08/2014 till date. This implies he was never demoted to Asso. Prof. and institute has submitted wrong information in compliance.
2. In previous assessment, Dr. Ramlingam was shown as Senior Resident 05/11/2012 to 04/11/2013. As he was not fulfilling experience criteria required for Senior Resident, he was not considered as Senior Resident. Presently he is shown as Junior Resident for the same period of 05/11/2012 to 04/11/2013 which is not permissible and also an attempt to mislead the Council.
3. Dr. M.K. Sachidhandham & Dr. Anchit Uppal, both Senior Residents, do not have 3 years experience as Resident in medical college; hence not qualified to hold the post; Resultantly there is no Senior Resident in Unit 2 & 4.
4. Dr. Vineet T. Abraham has been promoted as Asso. Prof. with experience of only 4 years 10 months as Asst. 5. Dr. Ashish Kumar Jose, Assoc. Professor, Unit-I was Asst. Professor for 4 years and promoted on 01/10/2015. None of the publications cited give full reference (Author names). Hence, his eligibility to the post of Assoc. Professor cannot be decided.
6. Professor, R. Surender Kumar was Assoc. Professor for 3 years. Promoted Professor on 29/10/2015. None of the publications cited give full reference (Author names). Hence, his eligibility to the post of Professor cannot be decided.
7. Other deficiencies as pointed out in the Assessment Report.

The Committee further decided to seek explanation from the Dean and concerned doctors for deficiency at Sl. No. 2.

Admissions done (if any) against these seats i.e. 01 seat each for degree and diploma till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 2. Dr. Raveesha H.S., Senior Resident is not eligible. She was Junior Resident for 2 years. Tutor is not a designation in Anaesthesia. Hence, no 3 years experience in Anaesthesia as Junior Resident at the time of Appointment as Senior Resident.
3. Dr. Shivakumar P.S., Senior Resident is not eligible. He has no 3 years experience as Junior Resident in Anaesthesia at the time of appointment as Senior Resident.
4. Dr. Meena Kumar M.R., Senior Resident is not eligible. She has no 3 years experience as Junior Resident in Anaesthesia at the time of appointment as Senior Resident.
5. Resultantly, deficiency of Senior Residents: 4
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated

21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

73. Kerala University of Health Sciences, Thrissur - Recognition of MS(OBG) qualification against increased intake from 01 to 03 seats in respect of students being trained at T.D. Medical College, Alappuzha.

Read: the Compliance Verification Assessment Report (09/05/2016) along with the Council Assessor's Report (June, 2014 & 16.03.2015) and compliance dated 24/02/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification against increased intake from 01 to 03 seats at T.D. Medical College, Alappuzha granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (09/05/2016) along with the Council Assessor's Report (June, 2014 & 16.03.2015) and compliance dated 24/02/2016 submitted by the college authorities and decided to recommend not to recognize MS(OBG) qualification against increased intake from 01 to 03 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at T.D. Medical College, Alappuzha because of the following facts:-

1. Unit I has 55 beds which is as per Regulations.
2. Experience as Resident for 3 years in the department is not shown in the faculty table in respect of Dr. Padmapriya, Senior Resident. It appears that she has been appointed as Senior Resident after DGO qualification without 1 year's additional experience as Resident.
3. There is no Senior Resident in Unit II.
4. Artificial Insemination is not carried out.
5. Deficiency of NIL publications from the department remains as it is.
6. Dr. Bindu P. shown Assoc. Professor in the column of Designation and Asst. Professor in the column of Experience, which is not feasible.
7. Dr. Pio James and Baby Lekha are DNB without mentioning the Institute from which they passed (whether teaching or non-teaching). Their eligibility cannot be decided without this information.
8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 3 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek

timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

“This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject.”

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

74. Kerala University of Health Sciences, Thrissur - Recognition of MD(Community Medicine) qualification for 3 seats in respect of students being trained at Government Medical College, Thrissur.

Read: the Compliance Verification Assessment Report (09/05/2016) along with the Council Assessor’s Report (June, 2015) and compliance dated 13/11/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Community Medicine) qualification for 3 seats at Government Medical College, Thrissur granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (09/05/2016) along with the Council Assessor’s Report (June, 2015) and compliance dated 13/11/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Community Medicine) qualification for 3 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Government Medical College, Thrissur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

75. Sri Siddhartha University, Tumkur - Recognition of MS(ENT) qualification against increased intake from 01 to 02 seats in respect of students being trained at Sri Siddhartha Medical College, Tumkur.

Read: the Compliance Verification Assessment Report (10/05/2016) along with the Council Assessor’s Report (May, 2014) and compliance dated 04/03/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(ENT) qualification against increased intake from 01 to 02 seats at Sri Siddhartha Medical College, Tumkur granted by Sri Siddhartha University, Tumkur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (10/05/2016) along with the Council Assessor’s Report (May, 2014) and compliance dated 04/03/2016 submitted by the college authorities and decided to recommend to the Central Government that MS(ENT) qualification against increased intake from 01 to 02 seats granted by Sri Siddhartha University, Tumkur in respect of students being trained at Sri Siddhartha Medical College, Tumkur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

76. Padamshree Dr. D.Y. Patil University, Navi Mumbai - Renewal of recognition of MS(Orthopaedics) qualification for 02 seats and recognition against increased intake from 05 to 08 seats in respect of students being trained at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai.

Read: the Compliance Verification Assessment Report (11/05/2016) along with the Council Assessor's Report (June, 2014 for 5 seats (renewal) & 5 to 6 seats and May, 2015 for 6 to 8 seats & 05/06/2015 for 5 seats (renewal) & 5 to 6 seats) and compliance dated 28/03/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(Orthopaedics) qualification for 02 seats and recognition against increased intake from 05 to 08 seats at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai granted by Padamshree Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/05/2016) along with the Council Assessor's Report (June, 2014 for 5 seats (renewal) & 5 to 6 seats and May, 2015 for 6 to 8 seats & 05/06/2015 for 5 seats (renewal) & 5 to 6 seats) and compliance dated 28/03/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MS(Orthopaedics) qualification for 02 seats and not to recognize against increased intake from 05 to 08 seats granted by Padamshree Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

1. Dr. Athal Moralwar, Senior Resident in Unit III has been appointed without any experience as Resident; he has been appointed as Senior Resident at the institute from 01/02/2010 to 28/01/2013 without any experience as Junior Resident & again as Senior Resident from 28/04/2015 till date; hence not qualified to hold the post; resultantly there is no Senior Resident in Unit III.
2. Dr. Sonal Bansal, having D.O. qualification has been appointed as Senior Resident without any additional 3rd year's experience as Resident in medical college; hence not qualified to hold the post; resultantly there is no Senior Resident in Unit IV.
3. Dr. Rajender Prasad Botla is shown as Assoc. Professor in the column of Designation and Asst. Professor in the column of Experience, which is not feasible.
4. The college authorities are not clearly conveying that how much exact amount of stipend they are paying presently to PG students of different years. They are only making indirect assertions that they are not paying less than Maharashtra Government rates.
5. Contention of institute that Residents have requested to consider arrears against future payment of fess cannot be accepted.

The P.G. Committee decided that specific clarification from the institute with regard to quantum of stipend paid (exact amount) presently to PG students of different years along with evidence of bank transfer and bank passbooks of Residents as proof of payment of stipend to residents be provided.

6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course"

Admissions done (if any) against these increased number of seats i.e. 5 to 8 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

77. Bharati Vidyapeeth Deemed University, Pune - Recognition of MS(Orthopaedics) qualification for 1 seat in respect of students being trained at Bharati Vidyapeeth Medical College & Hospital, Sangli.

Read: the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (June, 2014 & June, 2015) and compliance dated 07/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(Orthopaedics) qualification for 1 seat at Bharati Vidyapeeth Medical College & Hospital, Sangli granted by Bharati Vidyapeeth Deemed University, Pune.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (June, 2014 & June, 2015) and compliance dated 07/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MS(Orthopaedics) qualification for 1 seat granted by Bharati Vidyapeeth Deemed University, Pune in respect of students being trained at Bharati Vidyapeeth Medical College & Hospital, Sangli be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of

Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

78. The Tamil Nadu Dr. M.G.R. Medical College University, Chennai - Recognition of M.Ch.(Surgical Oncology) qualification against increased intake from 02 to 04 seats in respect of students being trained at Kilpauk Medical College, Chennai.

Read: the Compliance Verification Assessment Report (05/10/2015) along with the Council Assessor's Report (Aug., 2014 & March, 2015) and compliance dated 20/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch.(Surgical Oncology) qualification against increased intake from 02 to 04 seats at Kilpauk Medical College, Chennai granted by The Tamil Nadu Dr. M.G.R. Medical College University, Chennai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/10/2015) along with the Council Assessor's Report (Aug., 2014 & March, 2015) and compliance dated 20/05/2015 submitted by the college authorities and Members of PG Committee observed that proper compliance verification assessment report is not available. Repeated reminders to assessor have failed to evoke any response.

In view of above, it was decided to reverify the compliance by fresh assessment. It was also decided to debar the Assessor from the panel of Assessors.

79. Maharashtra University of Health Sciences, Nashik - Renewal of recognition of MD(Pharmacology) qualification for 2 seats in respect of students being trained at Govt. Medical College, Miraj.

Read: the Compliance Verification Assessment Report (12/05/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 29/03/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MD(Pharmacology) qualification for 2 seats at Govt. Medical College, Miraj granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (12/05/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 29/03/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MD(Pharmacology) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Govt. Medical College, Miraj because of the following facts:-

1. Blood Component Separation facility is not yet functional.
2. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

80. Ranchi University - Recognition of MD(Pathology) qualification against increased intake from 07 to 11 seats in respect of students being trained at Rajendra Institute of Medical Sciences, Ranchi.

Read: the Compliance Verification Assessment Report (10/05/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 15/03/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification against increased intake from 07 to 11 seats at Rajendra Institute of Medical Sciences, Ranchi granted by Ranchi University.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (10/05/2016) along with the Council Assessor's Report (June, 2015) and compliance dated 15/03/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(Pathology) qualification against increased intake from 07 to 11 seats granted by Ranchi University in respect of students being trained at Rajendra Institute of Medical Sciences, Ranchi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

81. Kerala University of Health Sciences, Thrissur/ Kerala University - Recognition of MD(Immuno Haematology and Transfusion) qualification for 2 seats in respect of students being trained at Jubilee Mission Medical College & Research Institute, Kerala.

Read: the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 16/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Immuno Haematology and Transfusion) qualification for 2 seats at Jubilee Mission Medical College & Research Institute, Kerala granted by Kerala University of Health Sciences, Thrissur/ Kerala University.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (29/03/2016) along with the Council Assessor's Report (July, 2015) and compliance dated 16/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Immuno Haematology and Transfusion) qualification for 2 seats granted by Kerala University of Health Sciences, Thrissur/ Kerala University in respect of students being trained at Jubilee Mission Medical College & Research Institute, Kerala be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

82. SRM University, Chennai - Recognition of MD (General Medicine) qualification for 6 seats in respect of students being trained at SRM Medical College Hospital & Research Centre, Kancheepuram.

Read: the Compliance Verification Assessment Report (11/03/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 16/10/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD (General Medicine) qualification for 6 seats at SRM Medical College Hospital & Research Centre, Kancheepuram granted by SRM University, Chennai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/03/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 16/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MD (General Medicine) qualification for 6 seats granted by SRM University, Chennai in respect of students being trained at SRM Medical College Hospital & Research Centre, Kancheepuram be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The minutes are subject to approval of the Hon'ble Oversight Committee.
