The Postgraduate Medical Education Committee considered the Council Assessor's Report (08/08/2016) and noted the following:-

1. Promotion of Dr. S.S.G. Mohapatra is not as per Regulations. He was Assoc.Prof. for 03 years and promoted as Professor on 11.7.2015. Publications at Sl.No. 1,2 & 3 are case reports. In Publications at Sl.No. 4 & 5, he is 3rd author; hence his promotion is not as per Regulations. Resultantly, there is deficiency of 01 Asstt.Prof.
2. Workload of DSA was NIL on day of assessment as well as on randomly selected days.
3. Workload of Contrast Radiology is only 739 in 2015 implying daily average of 2.
4. Workload of the following procedures in 2015 is not provided:
 - (a) USG guided FNAC;
 - (b) CT guided FNAC;
 - (c) DSA.
5. Only 4 Static X-ray machines are available against requirement of 5.
6. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to issue letter of permission for increase of seats in MD (Radio-Diagnosis) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

151. Increase of seats in MD (Paediatrics) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (08/08/2016) on the physical and other teaching facilities available at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar for Increase of seats in MD (Paediatrics) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (08/08/2016) and noted the following:-

1. Dr. Mrityunjay Dash has been promoted as Asso. Prof. after cut-off date; however out of 9 publications cited in the list, in 5 he is 3rd, 4th or 5th author & therefore cannot be considered. Out of remaining 4, 2 are Case Reports & 1 appears to be a review article; hence there is only 1 research publication to his credit against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered. All his publications are related to Dermatology.

2. Dr. P.K. Dash has been promoted as Asso. Prof. with experience of only 4 y against requirement of 5 y; however the column of "Benefit of publications" in the faculty table has been left blank implying there are NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
3. Dr. Anusandana Mohapatra has been promoted as Asso. Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying there are NIL publications against requirement of 2; hence her promotion is not as per Regulations & he cannot be considered.
4. Workload of MRI from Paediatrics was NIL on inspection day.
5. Total number of patients in OPD has decreased from 52,884 in 2013 to 47,317 in 2015.
6. Total number of patients in IPD has decreased from 3,817 in 2013 to 3,137 in 2015.
7. PICU has only 4 beds against requirement of 5.
8. Paediatric Bronchoscope is not available.
9. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Govt. not to issue letter of permission for increase of seats in MD(Paediatrics) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

152. Starting of MS (OBG) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (08/08/2016) on the physical and other teaching facilities available at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar for Starting of MS (OBG) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (08/08/2016) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.S.(OBG)course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2017-2018 restricting the number of admissions to 3(Three) students per year, till the first batch admitted appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

153. Increase of seats in MS (General Surgery) course at Kempegowda Institute of Medical Sciences, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (11/08/2016) on the physical and other teaching facilities available at Kempegowda Institute of Medical Sciences, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka for Increase of seats in MS (General Surgery) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (11/08/2016) and noted the following:-

1. Dr. Vinayaka Das, Senior Resident in Unit 4, has been appointed as Senior Resident without any experience as Resident against requirement of 3 y;

hence not eligible to hold the post. There is no other Senior Resident in the Unit.

2. There are 7 O.T.s with 11 Tables implying there are some theaters with 2 tables or more which is not as per norms.
3. The first LOP date when the MBBS course was started has been given in SAF is 23.06.2012 which cannot be correct.
4. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Govt. not to issue letter of permission for increase of seats in MS(General Surgery) course at Kempegowda Institute of Medical Sciences, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (11/08/2016) on the physical and other teaching facilities available at Kempegowda Institute of Medical Sciences, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka for Increase of seats in MD (Skin & VD) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the opinion of the Law Officer of the Council in similar matter with regard to nomenclature as detailed below:-

"Thus, as on date, there is no course in the Postgraduate Medical Education Regulations, 2000 by the name MD (Pulmonary Medicine). Thus, the Consent of Affiliation that has been submitted is for a course that does not survive since 21st July, 2009 i.e. for nearly 7 years now in the Schedule to the Postgraduate Medical Education Regulations, 2000. Accordingly, the Consent of Affiliation that has been submitted is for a course that does not exist in Regulations. Thus the necessary requirement of submitting valid Consent of Affiliation by the affiliating University with the application is not fulfilled. In this regard, the Hon'ble Supreme Court in its judgment dated 20.08.15 in Royal Medical Trust & Anr. Vs. Union of India & Anr. Reported in (2015) 10 SCC 19 has in paragraph 27 of the judgment laid down the mode and manner in which the application for establishment of new medical college, renewal of permission of existing and increase in intake capacity has to be processed, at all stages. It reads as under:-

27...

The Schedule giving various stages and time limits must accommodate very possible eventuality and at the same time must comply with the requirements of observance of natural justice at various levels. In our view the Schedule must ideally take care of:

"(A) Initial assessment of the application at the first level should comprise of checking necessary requirements such as essentiality certificate, consent of affiliation and physical features like land and hospital requirement. If an applicant fails to fulfill these requirements, the application on the face of it, would be incomplete and be rejected. Those who fulfill the basic requirements would be considered at the next stage"

Therefore, it would be appropriate to recommend to the Central Government to disapprove the application for starting/increase of seats in Pulmonary Medicine course as there is no such course existing in the regulations as on date"

In view of the above, the Postgraduate Medical Education Committee decided to approve the opinion of the Law Officer and to return the application to the Central Government recommending disapproval of the scheme for increase of seats in MD (Skin & VD) course at Kempegowda Institute of Medical Sciences, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2017-18 as the nomenclature is not in conformity with the Regulations of the Council on Postgraduate Medical Education, 2000.

Read: the Council Assessor's Report (12/08/2016) on the physical and other teaching facilities available at Mysore Medical College and Research Institute, Mysore under Rajiv Gandhi University of Health Sciences, Karnataka for Starting of MD (Psychiatry) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (12/08/2016) and noted the following:-

1. There is no Professor.
2. Chronic Psychiatry care facility is not available.
3. Dr. Narender Kumar, Asstt.Prof. is possessing DNB from non-teaching institution. He is not having 3 yrs. experience as JR in a medical college at the time of appointment as SR and then Asstt. Prof. Hence, his appointment *abinitio* is not as per Regulations.
4. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Govt. not to issue letter of permission for starting of MD (Psychiatry) course at Mysore Medical College and Research Institute, Mysore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

156. Increase of seats in MD (Dermatology) course at Raja Rajeswari Medical College & Hospital, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (10/08/2016) on the physical and other teaching facilities available at RajaRajeswari Medical College & Hospital, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka for Increase of seats in MD (Dermatology) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the opinion of the Law Officer of the Council in similar matter with regard to nomenclature as detailed below:-

"Thus, as on date, there is no course in the Postgraduate Medical Education Regulations, 2000 by the name MD (Pulmonary Medicine). Thus, the Consent of Affiliation that has been submitted is for a course that does not survive since 21st July, 2009 i.e. for nearly 7 years now in the Schedule to the Postgraduate Medical Education Regulations, 2000. Accordingly, the Consent of Affiliation that has been submitted is for a course that does not exist in Regulations. The Postgraduate Medical Education Committee considered the Council Assessor's Report (10/08/2016) and noted the following:-

1. Dr. S.M. Hashim has been promoted as Asso. Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying there are NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
2. Dr. K.M. Gopinath has been promoted as Professor after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying there are NIL publications against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
3. Dr. H. Manjunath has been promoted as Asso. Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table has been left blank implying there are NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
4. Dr. Syeeduddin Q., Senior Resident has experience of only 1 y as Resident in medical college hospital before appointment as Senior Resident; hence not eligible to hold the post.
5. Only 1 new book has been purchased in last 3 years in the Departmental Library.

6. The college got first LOP to start MBBS course on 25.05.2005. Dr. Roshankumar BN, Professor and HOD has been given teaching experience from 11.09.2000 when the college was not in existence and this is not permissible. Resultantly, his promotion is not as per Regulations.
7. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Govt. not to issue letter of permission for increase of seats in MS(Orthopaedics) course at Raja Rajeswari Medical College & Hospital, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

8. The college got first LOP to start MBBS course on 27.05.2005. Dr. Sailakshmi M.P.A., Professor has been given teaching experience from 02.09.2004 when the college was not in existence and this is not permissible.
9. Dr. Arpitha, Senior Resident is possessing DNB from non-teaching institution. She is not having 3 yrs. experience as JR in a medical college. Hence, not eligible.
10. There is no Senior Resident in Unit-I.
11. Dr. Rekha BR, Senior Resident is possessing DNB from non-teaching institution. She is not having 3 yrs. experience as JR in a medical college when appointed SR and then Asstt. Prof. Hence, her promotion is not as per Regulations.
12. Dr. Indumathi, SR has been shown as not working in the column of experience and there is no other SR in the Unit. Resultantly, Unit-II left with one Asstt. Prof. only.
13. Other deficiencies as pointed out in the assessment report.

2. There were only 2 Minor & 1 Daycare Operation on day of assessment.
3. Total workload for 3 year period from 2013 – 2015 of the following operations is very less:
 - (a) Stapedectomy: 07;
 - (b) Laryngectomy: 03;
 - (c) Laryngo/Tracheoplasty: 03;
 - (d) Rhinoplasty: 03;
 - (e) Maxillectomy: 01;
 - (f) Angiofibroma: 01.
4. There is no participation in National programme for Prevention & Control of Deafness.
5. Other deficiencies as pointed out in the assessment report.

5. Workload of Plain X-rays was 105 & of MRI 11 which is barely adequate for starting PG course.
6. The information provided about the stipend paid in Govt. Colleges (6700+allowances) in Maharashtra is incorrect and college is not paying stipend to 2nd and 3rd year PGs at par with Govt. Medical Colleges in the State.
7. As per report of the Pathology department, inspection for which was held on the same day, there was no CT guided or Ultrasound guided FNAC. As per this report, there were 03 CT guided and 04 ultrasound guided FNAC. This is a data mismatch and contrary to each report.
8. Promotion of Dr. Mangal Mahajan, Assoc. Prof. is not as per Regulations. He was promoted Assoc.Prof. on 1.1.2016 after the cut of date without any publication.
9. Dr. Kshitija Kadam passed DMRE from Karad in 2015. How can she be Junior Resident at Bharati Vidyapeeth Deemed University Medical College, Pune from 2014 to 2016?
10. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to issue letter of permission for increase of seats in MD (Radio-Diagnosis) course at Bharati Vidyapeeth Deemed University Medical College & Hospital, Pune under Bharati Vidyapeeth University (Deemed), Pune u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

180. Starting of MD (Community Medicine) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (10th August 2016) on the physical and other teaching facilities available at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata for Starting of MD (Community Medicine) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10th August 2016) and noted the following:-

1. There is no Professor.
2. Deficiency of faculty: (a) Asst. prof.: 1; (b) Epidemiologist cum Asst. Prof.: 1; (c) Statistician cum Lecturer: 1.
3. Both UHC & RHTC are not under full financial & administrative control of Dean. All available Paramedical staff at UHC & RHTC are not under the control of Principal of the college.
4. UHC is actually a General Hospital.
5. Seminar room is not available at RHTC.
6. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to issue letter of permission for starting of MD (Community Medicine) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Note: The Dean has stated that there is a Professor and six Asstt.Prof. in the Department. However, faculty table does not reflect any of them in the department. The Dean may be requested to clarify his stand with documentary proof.

181. Starting of MD (Dermatology, Venereology & Leprosy) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (10th August 2016) on the physical and other teaching facilities available at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata for Starting of MD (Dermatology, Venereology & Leprosy) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the opinion of the Law Officer of the Council in similar matter with regard to nomenclature as detailed below:-

.....

“Thus, as on date, there is no course in the Postgraduate Medical Education Regulations, 2000 by the name MD (Pulmonary Medicine). Thus, the Consent of Affiliation that has been submitted is for a course that does not survive since 21st July, 2009 i.e. for nearly 7 years now in the Schedule to the Postgraduate Medical Education Regulations, 2000. Accordingly, the Consent of Affiliation that has been submitted is for a course that does not exist in Regulations. Thus the necessary requirement of submitting valid Consent of Affiliation by the affiliating University with the application is not fulfilled. In this regard, the Hon’ble Supreme Court in its judgment dated 20.08.15 in Royal Medical Trust & Anr. Vs. Union of India & Anr. Reported in (2015) 10 SCC 19 has in paragraph 27 of the judgment laid down the mode and manner in which the application for establishment of new medical college, renewal of permission of existing and increase in intake capacity has to be processed, at all stages. It reads as under:-

27...

The Schedule giving various stages and time limits must accommodate very possible eventuality and at the same time must comply with the requirements of observance of natural justice at various levels. In our view the Schedule must ideally take care of:

“(A) Initial assessment of the application at the first level should comprise of checking necessary requirements such as essentiality certificate, consent of affiliation and physical features like land and hospital requirement. If an applicant fails to fulfill these requirements, the application on the face of it, would be incomplete and be rejected. Those who fulfill the basic requirements would be considered at the next stage”

Therefore, it would be appropriate to recommend to the Central Government to disapprove the application for starting/increase of seats in Pulmonary Medicine course as there is no such course existing in the regulations as on date”

In view of the above, the Postgraduate Medical Education Committee decided to approve the opinion of the Law Officer and to return the application to the Central Government recommending disapproval of the scheme for starting of MD (Dermatology) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18 as the nomenclature is not in conformity with the Regulations of the Council on Postgraduate Medical Education, 2000.

182. Increase of seats in MD (Anaesthesia) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor’s Report (10th August 2016) on the physical and other teaching facilities available at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata for Increase of seats in MD (Anaesthesia) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor’s Report (10th August 2016) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Anaesthesia) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2017-2018 from 6(Six) to 8(Eight) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

183. Increase of seats in MS (Obstetrics & Gynaecology) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (10th August 2016) on the physical and other teaching facilities available at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata for Increase of seats in MS (Obstetrics & Gynaecology) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10th August 2016) and noted the following:-

1. Promotion of Dr. Pranav Kumar Biswas, Prof. is not as per Regulations. He was Assoc.Prof. for 3 years 10 months and promoted Professor without any publication. Resultantly, Unit left with only 02 faculty.
2. OPD attendance for the whole hospital is 1,624 against 2,000 required as per Regulations.
3. There were only 2 Minor and 2 Daycare Operations on day of assessment.
4. There was Nil Major and Nil Minor Obstetrics Operation on day of assessment as well as on randomly selected days.
5. Prenatal Diagnosis services are not available.
6. Equipment like Cryo Cautery/LEEP are not available.
7. ART services are not available.
8. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to issue letter of permission for increase of seats in MS (Obstetrics & Gynaecology) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

184. Increase of seats in MD (Pathology) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (10th August 2016) on the physical and other teaching facilities available at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata for Increase of seats in MD (Pathology) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10th August 2016) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Pathology) course at Calcutta National Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2017-2018 from 2(Two) to 4(Four) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

185. Starting of MD (Bio-Chemistry) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (11th August 2016) on the physical and other teaching facilities available at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of MD (Bio-Chemistry) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (11th August 2016) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of M.D. (Biochemistry) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2017-2018 restricting the number of admission to 3(Three) students per year, till the first batch admitted appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

186. Starting of MD (Pharmacology) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (11th August 2016) on the physical and other teaching facilities available at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of MD (Pharmacology) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (11th August 2016) and noted the following:-

1. Promotion of Dr. R. Many is not as per Regulations. He was Asstt.Prof. for 4 years and promoted Assoc.Prof. without any publication. Resultantly, there is deficiency of Assoc.Prof.-1
2. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to issue letter of permission for starting of MD (Pharmacology) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

187. Starting of MD (Forensic Medicine) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (11th August 2016) on the physical and other teaching facilities available at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of MD (Forensic Medicine) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (11th August 2016) and noted the following:-

1. Experience of Dr. A. Edwin Joe are not provided in the faculty table without which his eligibility cannot be decided.

2. Promotion of Prof. T. Jeyasingh, is not as per Regulations. He was Assoc.Prof. for 3 years 5 months and promoted Professor on 15.3.2016 after the cut of date.
3. There are no publications mentioned in the faculty table.
4. Workload of other medico-legal work is inadequate as under:
 - (a) Examination of Accused of Sexual Offences: 2/week
 - (b) Age Estimation of Victims of Sexual Offences: 2/week
 - (c) Age Estimation of Accused: 2/week
5. There was Nil postmortem on day of assessment.
6. Open mortuary with fly proofing arrangement is not available.
7. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to issue letter of permission for starting of MD (Forensic Medicine) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

188. Starting of MD (Anaesthesia) course at Government Vellore Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the Council Assessor's Report (12th August 2016) on the physical and other teaching facilities available at Government Vellore Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of MD (Anaesthesia) course u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (12th August 2016) and noted the following:-

1. Promotion of Dr. R. Sudhakar, Assoc.Prof. is not as per Regulations. He was promoted on 16.12.2015 after the cut of date without any publication. Resultantly, there is deficiency of Assoc.Prof.-1.
2. Other deficiencies as pointed out in the assessment report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to issue letter of permission for starting of MD (Anaesthesia) course at Government Vellore Medical College, Vellore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

189. Starting of MD (Infectious Diseases) course at Bharati Vidyapeeth Deemed University Medical College & Hospital, Pune u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Read: the matter with regard to starting of MD (Infectious Diseases) course at Bharati Vidyapeeth Deemed University Medical College & Hospital, Pune u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

The Postgraduate Medical Education Committee discussed the matter and it was resolved that MD & DM should not continue with same nomenclature and it was decided to recommend that MD (Infectious Diseases) be abolished and removed from the Schedule. The Committee further decided to refer the matter to the General Body of the Council. The application may be returned to the Central Government with these remarks.

190. Recognition of MS (OBG) in respect of students being trained at ESI-PGIMER, ESI Hospital, Joka, Kolkata in pursuance of the court order dt. 26.7.2016 passed by the Hon'ble Kolkata High Court in W.P. No. 7055(W) of Year 2016 (titled as Dr. Shikha Agarwal & Ors. Vs. Medical Council of India & Ors)

Read: the matter with regard to recognition of MS (OBG) in respect of students being trained at ESI-PGIMER, ESI Hospital, Joka, Kolkata in pursuance of the court order dt. 26.7.2016 passed by the Hon'ble Kolkata High Court in W.P. No. 7055(W) of Year 2016 (titled as Dr. Shikha Agarwal & Ors. Vs. Medical Council of India & Ors)

The Postgraduate Medical Education Committee perused the court order dated 26.7.2016 passed by the Hon'ble Kolkata High Court in W.P. No. 7055(W) of Year 2016 and noted the college was permitted PG/Diploma seats and recognition inspection under section 11(2) of the IMC Act, 1956 was to be got done in the year.....

The Committee further noted that the college was permitted MS (OBG) seats in 2011 and recognition inspection under section 11(2) of the IMC Act, 1956 was to be got done in the year 2014. The Institution applied for recognition inspection in the year 2014 and many deficiencies were found, which are reproduced below:

1. There is only 1 functional Unit with 30 teaching & 30 non-teaching beds.
2. There were few USG examinations done for Gynaecology patients.
3. There is no adequate waiting area for patients in OPD.
4. There is no dedicated counseling center for Antenatal women in OPD.
5. There is no separate O.T. for the department. There is general O.T. where only 2 days / week are allotted for Gynaecology operations.
6. Promotion of Dr. Nalini Arora, Professor as Asso. Prof. is not as per Regulations as she has been promoted as Asso. Prof. with experience of only 4 y 2 m as Asst. Prof. against requirement of 5 y as per Regulations.
7. There is no computer in the department office.
8. There is no separate Obstetric ICU.
9. IVF services are through tie up with private IVF center.
10. Other deficiencies pointed out in the assessment report.

At present deficiency of CT/ MR being not available in the institute still persists and this deficiency (when removed) will have to be verified by way of inspection (cannot be accepted on undertaking only).

In view of above, the Postgraduate Medical Education Committee decided to recommend that an appeal may be filed against the Order of the Hon'ble Kolkata High Court in W.P. No. 7055(W) of Year 2016.
