3. Increase of seats in MS (Orthopaedics) course at A.J. Institute of Medical Sciences & Research Centre, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

Read: the Council Assessor's Report (20/06/2017) for Increase of seats in MS (Orthopaedics) course at A.J. Institute of Medical Sciences & Research Centre, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (20/06/2017) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MS (Orthopaedics) course at A.J. Institute of Medical Sciences & Research Centre, Mangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2018-19 from 4(Four) to 8(Eight) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (22/06/2017) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MD (Pathology) course at B J Medical College, Ahmedabad under Gujarat University, Ahmedabad u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2018-19 from 20(Twenty) to 26(Twenty Six) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

5. Increase of seats in MS (General Surgery) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (16/06/2017) and noted the following:

1. Dr. Samir R. Patnaik had only 1 original research publication on the day of his promotion to the post of Professor against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
2. Dr. K.L. Narsimha had nil original research publication on the day of his promotion to the post of Professor against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
3. Dr. Rajesh Jasi, Asst.Prof. was absent on the day of assessment.
4. Dr. Ravi Nekkanti, Ast.Prof. was absent on the day of assessment.
5. Dr. V.Venkateswara Rao, Sr. Resident, was absent on the assessment day.
6. Out of 14 Major Operations shown by the Institute, Phimosis, Debridement & Haemorrhoidectomy are shown as Major Operations which is not as per norms.
7. Occupancy in SICU was only 2 on day of assessment.
8. The number of patients admitted (IPD) in 2016 was 8306. Major + Minor Operations (excluding day care operations) were 12217. This is not feasible. The number of operations were more than the total admitted patients, which means the data is non-genuine.
9. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MS (General Surgery) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

6. Increase of seats in MD(Community Medicine) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

Read: the Council Assessor's Report (16/06/2017) for Increase of seats in MD (Community Medicine) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (16/06/2017) and noted the following:

1. Promotion of Dr. K.Raja Gopala Rao, Professor is not as per regulations. He was Assoc.Prof. for 3 years against the requirement of 4 years and he has no publication.
2. Promotion of Dr. Sarat Kumar Patnaik, Professor, is not as per regulations. He was promoted on 15.10.2016 after the cut off date without any publications.
3. Postgraduate degree of Dr. Sipra Komal Jena, Professor, is not recognized.
4. Dr. Sulekha Renu Vasanth, is shown Assoc.Prof. in the column of Designation and Asst.Prof. in the column of experience, which is not feasible.
5. Two of the faculty, One Professor Dr. K Rajgopal Rao and One Assoc.prof. Dr. GSS Ganesh Babu were not available on the day of assessment as they were told to be deputed on government assignment on the invitation of the district health authorities. However, there was no document produced in support of this.

6. RHTC: Average Delivery rate is < 1/month. Bed Occupancy on day of assessment is not given.
7. There is no Medical Officer in UHTC and RHTC.
8. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (Community Medicine) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

7. Increase of seats in MD (DVL) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

Read: the Council Assessor's Report (16/06/2017) for Increase of seats in MD (DVL) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (16/06/2017) and noted the following:

1. Workload of the following procedures is very low in 2016:
 - (a) Nail Surgeries: 17;
 - (b) LASER for Scar Revision: 32;
 - (c) Cryo Surgical Procedures: 34;
 - (d) Skin Grafting procedures: 36;
 - (e) LASER for Hair Reduction: 39;
 - (f) LASER for Pigment Removal: 40.

With such low workload, there is no justification for increase in PG seats.

2. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (DVL) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

8. Increase of seats in MS (OBG) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

Read: the Council Assessor's Report (19/06/2017) for Increase of seats in MS (OBG) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (19/06/2017) and noted the following:

1. Dr. Vaddadi Sarojini, Prof. & HoD, is already 70 years on 01.07.2017.

2. Total number of patients admitted in IPD(2016) was 7358. Total Number of major + minor operation + deliveries + caesareans section (excluding day care operation) were 9254. This is not feasible. Data is non-genuine.
3. There was nil Minor Obstetric Operation on day of assessment.
4. Occupancy in ICU/HDU was only 1 on day of assessment.
5. Attendance at Specialty clinic like Gynaec Endocrine clinic is low – 2-3 cases/week.
6. Equipment like LEEP is not functional.
7. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MS (OBG) course at GSL Medical College & General Hospital, Rajahmundry, Andhra Pradesh under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

9. Increase of seats in MS (Otorhinolaryngology) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University, Bhubaneswar U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

Read: the Council Assessor's Report (21/06/2017) for Increase of seats in MS (Otorhinolaryngology) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University, Bhubaneswar U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (21/06/2017) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MS (Otorhinolaryngology) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University, Bhubaneswar u/s 10A of the I.M.C. 1. All the faculty have qualification of M.D. (Pathology). There is no evidence of having received 2 years special training in IHBT before appointment in IHBT.
2. Dr. B. Vijaya, Professor & HOD is appointed as Professor of IHBT straightaway from the post of Professor of Pathology without any experience in IHBT as such.
3. There is no Senior Resident or Tutor.
4. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of MD (Immuno Haematology & Blood Transfusion) course at JSS Medical College, Mysore under JSS University, Mysore u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

Read: the Council Assessor's Report (22/06/2017) for Starting of MD (Anaesthesiology) course at Mandya Institute of Medical Sciences, Mandya, Karnataka under Rajiv Gandhi University of Health Sciences, Karnataka U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

4. Other deficiencies as pointed out in the Assessment Report.

Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table is left blank implying NIL publications against requirement of 2; hence her promotion is not as per Regulations & she cannot be considered. She was absent on the day of assessment.
3. Promotion of Dr. R.Nageswara Rao, Prof. & Head, is not as per regulations. He was Assoc.Prof. for 3 years 11 months. He has only 2 publications against required 4.
4. Workload of TT investigation is NIL.
5. Equipment like Cryostat, Microwave, HPLC, Cytospin are not yet available.
6. Both the columns of "Stipend paid by State Govt. to Residents" & "Stipend paid by the Institute to Residents" are left blank implying there is no commitment on part of the Institute to pay stipend to Residents which is contrary to PG Regulations.
7. Other deficiencies as pointed out in the Assessment Report.

- dichotomy. Further, out of 4 publications cited in the list of publications, 1 is a review article which cannot be considered; resultantly there are only 3 research publications to her credit against requirement of 4.
2. Molecular Microbiology is not available.
 3. In the column of “Stipend paid by the Institute to Residents”, it is stated “NA” implying there is no commitment on part of the Institute to pay stipend to Residents which is contrary to PG Regulations.
 4. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Starting of MD (Microbiology) course at NRI Institute of Medical Sciences, Visakhapatnam under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

3. Workload at Specialty clinics like Hansen's disease clinic, STD clinic is low – 10/month.
4. There is only 1 publication from the department during the last 3 years that also a Histopathology study.
5. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to recommend to the Central Government not to grant letter of permission for Increase of seats in MD (DVL) course at Sri Venkateshwaraa Medical College Hospital & Research Centre, Puducherry under Pondicherry University, Puducherry u/s 10A of the IMC Act, 1956 for the academic year 2018-19.

71. Request made by Ministry of Defence for considering exemption from NEET requirement for friendly foreign candidates nominated by Ministry of External Affairs against UG/PG course in the medical colleges/ institution of AFMS – reg.

Read: the letter dated 21/06/2017 received from the Under Secretary to the Government of India, Ministry of Health & Family Welfare, New Delhi with regard to Request made by Ministry of Defence for considering exemption from NEET requirement for friendly foreign candidates nominated by Ministry of External Affairs against UG/PG course in the medical colleges/ institution of AFMS.

The Postgraduate Medical Education Committee considered the letter dated 21/06/2017 received from the Under Secretary to the Government of India, Ministry of Health & Family Welfare, New Delhi with regard to Request made by Ministry of Defence for considering exemption from NEET requirement for foreign candidates from friendly countries nominated by Ministry of External Affairs in UG/PG course in the medical colleges/ institution of AFMS and decided to inform AFMS that the matter of exemption from NEET was beyond the purview of MCI as it has been made mandatory by the Hon'ble Supreme Court for all undergraduate and postgraduate admissions in medical colleges of the country (including NRI candidates). However, the Ministry of Defence may approach the Hon'ble Supreme Court for this exemption (if they so desire).

72. Eligibility qualification for non-medical teachers in the subject of Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology who have been appointed before the publication of Minimum Qualification for Teachers in Medical Institutions Regulations, 1998.

The Postgraduate Medical Education Committee considered the matter with regard to Eligibility qualification for non-medical teachers in the subject of Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology who have been appointed before the publication of Minimum Qualification for Teachers in Medical Institutions Regulations, 1998 along with the letter dated 23/05/2017 received from the Central Government, Ministry of Health & Family Welfare, New Delhi and decided that the condition of 2 research publications for promotion from Assistant Professor to Associate Professor (as in case of medical teacher) will be applicable to non-medical teacher also. Similarly the condition of 4 research publication for promotion from Associate Professor to Professor will be applicable for non-medical teacher as well. However, no research paper/published work etc can be considered as a substitute for Ph.D degree. They should have Ph.D. degree before promotion from Assistant Professor onwards.

73. Allow the Private Institutes owning a hospital and fulfilling the bed requirement to start PG courses without UG courses.

Read: the matter with regard to allowing the Private Institutes owning a hospital and fulfilling the bed requirement to start PG courses without UG courses along with the D.O. letter dated 30/05/2017 received from Shri Arun Singhal, Joint Secretary, Ministry of Health & Family Welfare, New Delhi and letter dated 12/07/2017 received from the Section Officer, Ministry of Health & Family Welfare, New Delhi forwarding therewith the ID Note dated 07/07/2017 received from PMO.

The Postgraduate Medical Education Committee considered the matter with regard to allowing the Private Institutes owning a hospital and fulfilling the bed requirement to start PG courses without UG courses along with the D.O. letter dated 30/05/2017 received from Shri Arun Singhal, Joint Secretary, Ministry of Health & Family Welfare, New Delhi and letter dated 12/07/2017 received from the Section Officer, Ministry of Health & Family Welfare, New Delhi forwarding therewith the ID Note dated 07/07/2017 received from PMO and noted the following:

- The following sub-clause 11.1(d) has been included in the Postgraduate Medical Education Regulations, 2000 in terms of Notification published in the Gazette of India on 16th March, 2005:

“(d) Consultants of specialists who have the experience of working for a period of not less than 18 years and 10 years in the teaching and other general departments in the institution or hospitals, not attached to any medical college, where with the affiliation from any university, postgraduate teaching is being imparted as contemplated under sub-regulation (1A) of regulation 8, shall respectively be eligible to be equated as Professor and Associate Professor in the department concerned. The requisite experience for equating a Consultant or Specialist working in the super-speciality department of the said institution or hospitals as Professor and Associate Professor shall respectively be 16 years and 8 years. Consultants or specialists having postgraduate degree qualification, working in such an institution or hospital, who do not have the said period of experience, shall be eligible to be equated as Assistant Professor in the department concerned.”

The following proviso has been further included to clause 11.1(d) in terms of Notification published in the Gazette of India on 17th November, 2009.

“Provided that such conferment of the nomenclature of the designation/status of postgraduate medical teachers shall be awarded only to those many number of consultants in the concerned hospital/institution so as to fulfil the minimum requirement for imparting Postgraduate Medical Education to the sanctioned annual intake of the respective Govt. Hospital/Institute”.

The Postgraduate Medical Education Committee further observed that:

- Most of the staff working in these Private Corporate Hospital do not have any teaching experience; hence they cannot be given teaching designation which is essential for any teaching hospital.
- Consultants of Corporate Hospitals may not be full time Consultant and may be attached to two or more hospitals whereas a Professor of medical college will be available full time in the college during college hours and will thus be always available for teaching and training of the students. Most of the staff working in Private Corporate Hospitals have their Private Nursing Homes/Clinics. They go to these Corporate Hospitals only for a few hours. They are allotted OPD space and O.T as and when required. Hence, they are not full time faculty and will not be available to the PG students for teaching purposes.
- The following basic departments are mandatorily required as per the Postgraduate Medical Education Regulations, 2000, Appendix-II in the private/corporate Institutions wishing to start Postgraduate courses without UG courses:

“Criteria to be fulfilled by institutions eligible to start postgraduate course(s) under sub-regulation (1A) of regulation 8, which are required to create their own facilities for setting up departments in basic medical sciences:

A. The basic subjects identified for the purpose of creation of facilities shall be:

- i) Anatomy
- ii) Physiology
- iii) Pharmacology
- iv) Community Medicine with Forensic Medicine being optional.

B. Staff requirements:

(1) The minimum staff required in each of the departments of Anatomy, Physiology, Pharmacology and Community Medicine shall be:

Provided that the department of Community Medicine shall also have:

- a) *Epidemiologist-cum-Lecturer*
- b) *Statistician-cum-Lecturer*

Provided further that the person in charge of a Unit shall not be below the rank of Associate Professor.

(2) The required strength of the teaching personnel shall be in proportion to the number of postgraduate courses started by the institution in a manner that the ultimate upper limit of the requirement shall be on a par with the requirement indicated in the Regulation of the Council titled 'Minimum Requirements for Establishment of Medical College for Annual Intake Capacity of 50'.

C. Infrastructural requirements:

- 1) *The infrastructural requirements in terms of lecture theatres and demonstration rooms could be common.*
- 2) *The research laboratories shall be well-equipped so that the teachers in the departments concerned shall be able to work on solicited research projects.*
- 3) *Department of Anatomy: Apart from the common facilities, there shall be placed for dissection with adequate accommodation, along with an embalming room, cold room and also a museum:*

Provided that Histology and Research laboratory may be clubbed together.

- 4) *Department of Physiology: There shall be clinical, experimental and animal physiology laboratories along with a museum.*
- 5) *Department of Pharmacology: The facilities could be common except for research laboratory, which shall be separate.*
- 6) *Department of Community Medicine: There shall be a museum alongwith a well-equipped Rural/Urban Health Centre with necessary staff."*

- The rationale behind the above provision is that a person doing his MD/MS in any clinical subjects will have to have full knowledge of the postgraduate level of these basic subjects for being adequately trained.
- Allowing such private/ corporate Hospitals to start postgraduate courses without UG course will result in snatching away of all basic department faculties of the already existing Govt. colleges since these Private/Corporate set-ups would offer higher salaries. This will affect existing Govt. colleges and would result in promoting Corporate hospitals at their cost.
- On analyzing the data of vacant seats in the country in pre and para-clinical subjects for the academic year 2016-17 & 2017-18, it has been observed that most of the MBBS doctors do not opt for these subjects and a large number of seats in these subjects are remaining vacant. In another five years the situation will further worsen and no faculty will be available in these subjects.
- Further DNB training taking place in these corporate hospitals is totally different from MD/MS training. There is no hands on training in DNB because in all corporate hospitals, all patients are paid patients and under one particular doctor. These paid patients will never let a student treat/touch them.
- Even in existing medical colleges, MCI does not count private ward beds towards the required number of beds in each department because private ward patients usually do not permit them to be examined by PG students. A DNB student of Surgery, for example will not have operated upon a single patient but ultimately get a degree of Surgery.

In view of above, the Committee decided that in case the private/ corporate hospitals are allowed to start postgraduate courses without UG course, it would affect the standard of medical education and severely compromise the quality of specialists being produced.

The Minutes of this item read and confirmed in the meeting itself.

81. Amendments in Postgraduate Medical Education Regulations, 2000 with regard to lowering the minimum percentile for admissions in Postgraduate Courses and consideration for deletion of clause for institutional reservation of 50%– reg.

Read: the minutes of the Monthly Review meeting held on 26/05/2017 with regard to Amendments in Postgraduate Medical Education Regulations, 2000 with regard to lowering the minimum percentile for admissions in Postgraduate Courses.

The Postgraduate Medical Education Committee considered the minutes of the monthly review meeting held on 26.05.2017 under the Chairmanship of JS(ME), Ministry of Health & Family Welfare, Govt. of India regarding retention of clause in Postgraduate Medical Education Regulations 2000, for lowering the minimum percentage/percentile marks if sufficient number of candidates fail to secure the minimum prescribed percentage of marks and seats remain vacant and noted that the Central Government has already taken decision on this which has been notified vide Gazette Notification No.18(1)/2010/Med./62052, dated 15.02.2012. Hence no further action is required.

The matter with regard to agenda item 81(b) regarding deletion of clause for institutional reservation/preference of 50% from Postgraduate Medical Education Regulation, the Council had taken the opinion of Additional Solicitor General of India, the operative part of which reproduced below:-

- 1 The querist has sought my opinion with regard to the permissibility of having institutional preference during the common counselling for admission in Post Graduate medical Courses for the academic year 2017- 18. The issue which required to be considered is as to:-

“Whether the benefit of institutional preference can be granted to the students for admission in Post Graduate Courses at the time of common counselling by the State Government?”

4 It is in this background that the primary query to be answered by the present opinion is with regard to permissibility to any University/College/Educational Institution of granting institutional preference, while adhering to the basic principle of merit.

- i. The issue of institutional reservation for the first time came up for consideration before the Hon’ble Supreme Court in the case of Pradeep Jain Vs. Union of India (1984)3 SCC 654. The Hon’ble Supreme Court in the above-Mentioned case held that it is constitutionally permissible for the States to have reservation of seats on the basis of institutional preference in the Post Graduate Medicine Course for students who have passed MBBS course from the same university /College. However, Such institutional reservation should not exceed the outer limit of 50% and the percentage of reservation of seats may be revised from time to time depending upon the prevailing situation.

- ii Thereafter the Hon'ble Supreme Court in the case of AIIMS Students Union Vs AIIMS-(2002) 8 SCC 481 was pleased to hold that a reasonable percentage of seats may be reserved for students in post graduate medicine courses on the basis of institutional preference. However, the reservation of seats on the basis of institutional preference should not violate the principle of merit as well equality of opportunity in matters of education.
- iii In the case of Magan Mahrotra & Ors. Vs. Union of India & Ors. (2003) 11 SCC 186 the Hon'ble Supreme Court, while reiterating the principles laid down in the case of Pradeep Jain (supra), held that it is permissible to have reservation of seats at post graduate level on the basis institutional preference for students who have completed their MBBS Course from the same College/University. The Hon'ble Court further held that there cannot be any reservation in post graduate medicine courses on the basis of domicile / place of residence.
- iv It is submitted that in the case of Saurabh Chaudhri and Or. Vs. Union of India and Ors. – (2003) 11 SCC 146 the Constitution Bench of the Hon'ble Supreme Court examined in great detail the constitutional validity of institutional reservation. The Hon'ble Supreme Court, while upholding the validity of institutional reservations, was pleased to observe that institutional reservations do not violate the principles of equality enshrined under article 14 of the constitution.
- 6 The Hon'ble Supreme Court in the cases of Nikhil Himthani Vs. State of Uttarakhand & Ors. (2013) 10 SCC 237 and Vikas Goyal Vs State of Karnataka (2014) 11 SCC 456, while relying on the earlier decisions in the case of Pradeep Jain (supra) and Saurabh Chaudhri, held that institutional reservations is matter of State policy and are permissible under the Constitution. However, the institutional reservation should not be disguised as domicile reservation and should also conform to the principle of equality provided under Article 14 of the Constitution.
- 7 In all the above-mentioned judgments by the Hon'ble Apex Court, it comes out clearly that there exists complete justification for any University/ college / Educational Institution to follow the principle of grant of institutional preference. The Hon'ble Apex Court has accepted the existence of objective, reasons and factors including institutional continuity in a particular branch / stream of education leading to admission in higher courses. In fact, the overall scheme of the medical education is completely dependent upon institutional continuity for any medical student, not only during the MBBS course itself but also for higher medical PG courses leading to such medical students securing Speciality and Super-speciality medical degrees / qualifications.
- 8 In view of the above factual matrix and having considered the judgments passed by the Hon'ble Supreme Court on the issue of institutional reservations in post graduate medicine courses, I am of the opinion that institutional reservations are permissible under the scheme of constitution. However, the institutional reservations should not be violative of the principles of merit as well as equality under Article 14 of the constitution. Accordingly, the Council may issue appropriate directions to all the stake- holders for granting institutional reservations to the candidates at the time of common counselling for admission in Post Graduate Medicine Courses.
- 9 Since any ambiguity in this regard may not only result in causing confusion at different levels / places in carrying out the critical duty of granting PG Medical admissions properly and appropriately, I am also of the opinion that it would be expected of the MCI to consider and issue an appropriate clarification by any Circular to the effect that any University / College / Educational Institution {while strictly adhering to the principle of merit by taking students from the merit list of NEET} would not get prohibited to adopt and follow the principle of institutional preference in granting admissions for PG medical courses.

The Postgraduate Committee considered the above opinion of Additional Solicitor General of India and agreed with the same and decided to approve the above opinion. The Central Government be intimated accordingly.

7. Bed occupancy was 50% on the day of assessment.
8. Out of total number of 2592 patients admitted in 2016 as many as 2064 is shown to have died (death rate 79%). (page-6, table 18), which is too much.
9. There was Nil Major & nil Minor Operation on day of assessment.
10. Specialty clinics like Spine clinic, Arthroplasty clinic, Hand clinic, Arthroscopy clinic are not run.
11. Services like Joint Replacement (Hip/Knee), Arthroplasty, Arthroscopy, Spine Surgery are not available.
12. Equipment like Hip Arthroplasty set, knee Arthroplasty set, Spine Surgery set are not available.
13. Investigative facilities like Nerve Conduction, EMG are not available.
14. Nil new books have been purchased for Departmental Library during last 3 years.
15. Space for faculty & office is inadequate as detailed in the report.
16. CPC, Death Review meetings are not held.
17. MRI is not available.
18. Other deficiencies as pointed out in the Assessment Report.

Regulation 9(A) of PGMER 2000 provides for admission through common counseling by the State/UT Govt. admission through any other mode or mechanism is not permissible. Accordingly, the above mentioned candidates may be discharged. However, the Committee was also informed that the matter relating to admission made in Postgraduate Courses in Puducherry was subject matter of a PIL (Public Interest Litigation) in the Hon'ble High Court of Madras - W.P. No. 14232 of 2017 - VBR Menon Vs. the Government of Puducherry & Ors. The Hon'ble High Court has on 16/06/2016 passed in order by which it has been inter-alia directed as under:-

"We, therefore, deem it appropriate to pass an interim order directing the deemed universities to admit the students provisionally selected and successful in the admission tests/counseling to the vacant seats in order of their merit, subject to the condition that the students shall each deposit Rs. 10.00 lakhs at the time of admission towards the annual fee for the first year with CENTAC (third respondent) and subject to the further condition that in the event the fees determined by the Fee Committee that may be constituted by the University Grant Commission (sevenths respondent) and Ministry of Human Resource Development (sixth respondent) to study the fee structure of the deemed Universities is higher, they shall pay the differential amount. Needless to mention that those students who have already taken admission by depositing that full fees will, if necessary, be entitled to refund/adjustment of the difference between the fees that might be determined by the Committee and the amount paid by them. Such admission shall be effected within 5 P.M. pm 19th June 2017 and the students will be allowed to provisionally attend their classes from 20th June 2017. Needless to mention that the admission of students pursuant to this interim order shall abide by the result of the writ petition."

Approved. Issue Discharge Notice. Institute be directed to comply within 2 weeks. Copy of the Discharge Notice be also sent to Secretary (ME), DME, Affiliating University, State Medical Council & representative of the State on MCI.

The Monitoring Sub-Committee noted the letter dated 11.05.2017 of the Principal, Index Medical College, informing there with the percentage of the candidate namely Dr. Himanshu Suman wrongly typed as 27.09% instead of 47.09% as a SC candidate. The amount of stipend for the PG students has been fixed to Rs. 45,000/- (Rs. Forty-five thousand) per month in the first year and we are completely complying with the rules framed. The Monitoring Sub-Committee accepted the explanation submitted by the college authorities. Hence, no further action is required.

20. **Admission of PG students (Broad-specialty) at The Gandhigram Institute of Rural Health & Family Welfare Trust, Ambathurai for the Academic Year 2016-17 – Regarding.**

The Monitoring Sub-Committee observed that the letter dated 18.06.2016 has informed that the Gandhigram Institute of Rural Health and Family Welfare Trust (GIRH&FWT) is conducting one year Postgraduate Diploma in Health Promotion and Education. The course is affiliated with the Tamil Nadu Dr. M.G.R. Medical University, Chennai and it is an Allied Health Science course of the University. It may further be stated that the Council has received another letter 18.06.2016 of the college authority has informed that the Gandhigram Institute of Rural Health and Family Welfare Trust (GIRH&FWT) is conducting one year Postgraduate Diploma in Health Promotion and Education. The course is affiliated with the Tamil Nadu Dr. M.G.R. Medical University, Chennai and it is an Allied Health Sciences course of the University. In view of the above explanation, the Diploma in Health Promotion & Educaiton is not included in the schedule to PGMER 2000. Thus, there is no requirement of monitoring of such courses by MCI and it may be also be removed from MCI website.

Approved.

21. **Admission of PG students (Broad-speciality) at Chalmeda Anand Rao Institute of Medical Sciences, Karimnagar for the Academic Year 2016-17 – Regarding.**

The Monitoring Sub-Committee noted the opinion of the Council Advocate, Gaurav Sharma regarding the management quota is as under:-

"... That at present the second provision to Regulation 9 (2) of the Post Graduate Medical Educajtion Regulation, 2000 cannot be applied on private medical colelges directing them to surrender 50% of seats in postgraduate course to the State Government. The afore-said opinion is subject to the outcome of Civil Appeal Nos. 670 of 2007 – Medical Council of India Vs. St. John's Medical College & Ors. and other connected matters, pending before the Hon'ble Apex Court."

The above opinion was approved by the Postgraduate Committee at its meeting held on 23.06.2017 and General Body.

Thus, there is no requirement of monitoring of seat sharing between State Government and College authorities.

22. **Admission of PG students Broad-speciality) at Mahatma Gandhi National Institute of Medical Sciences, Jaipur for the Academic Year 2016-17– Regarding.**

The Monitoring Sub-Committee noted the opinion of the Council Advocate, Gaurav Sharma regarding the management quota is as under:-

"... That at present the second provision to Regulation 9 (2) of the Post Graduate Medical Educajtion Regulation, 2000 cannot be applied on private medical colelges directing them to surrender 50% of seats in postgraduate course to the State Government. The afore-said opinion is subject to the outcome of Civil Appeal Nos. 670 of 2007 – Medical Council of India Vs. St. John's Medical College & Ors. and other connected matters, pending before the Hon'ble Apex Court. The above opinion was approved by the Postgraduate Committee at its meeting held on 23.06.2017 and General Body.

The Monitoring Sub-Committee also noted vide letters dated 07.03.2017 & 17.04.2017 the college authorities has informed that 11 students have been admitted by the college under NRI quota as per the eligibility criteria given by MCI/orders of Hon'ble Supreme Court. The explanation may be accepted as NRI candidate could have been admitted for the academic year 2016-17 without entrance examination.

23. Admission of PG students (Super-Speciality) at Medical College, Thiruvananthapuram, for the Academic Year 2016-17- Regarding.

The Monitoring Sub- Committee observed that the letter dated 21.12.2016 & 09.05.2017 has informed that the college authorities the department of Plastic & Reconstructive Surgery was started in 1970 and MCH course was started in 1980 with annual intake of 2 candidates after getting LOP from Government. The 1st batch of MCH students passed out in 1982. MCI inspection was done in 1988 during M.Ch. final exam by Dr. Sharma. M.N from Baroda and the course was recognized retrospectively from 1980 onwards. As per reference given above the HOD-Plastic Surgery replied to the letter from MCI on 21/1/2014 and again in 14/3/2016 and 08/12/2016. As per the MCI reference, M.Ch course in Medical College, Trivandrum is recognized and is included in 1st schedule of IMC Act 1956 without mentioning the number of seats. But there is some confusion regarding the number of M.Ch Plastic & Reconstructive Surgery seats in Medical College, Trivandrum. In the MCI site, for course recognition, it is shown as the course is recognized but the number of seats not mentioned. Usually one PG course can be started in Medical College after getting letter of permission from the Government for a particular number of seats. The course will be recognized after MCI inspection for the allotted number of seats. Once the course will be recognized by MCI all candidates who passed out from the institution will get recognized degree. Since there are no records available in the department regarding LOP recognition they could not produce certificates as requested by MCI.

The Monitoring Sub-Committee noted that the college authorities has informed that all candidates including service quota shall have to qualify the eligibility marked by Commissioner for Entrance Examination Kerala by securing minimum of 50% marks for either Paper I or II (40% marks for Paper I or II for ST/SC candidates). The following students have secured above 50% marks for either Paper I or II in the Entrance Examinations conducted by CEE Kerala. The details is attached herewith for further action.

With regard to 6 students who have secured < 50 %/40 % marks, they cannot be admitted according to PG Regulations which requires computation of eligibility on total % of marks in the Entrance Examination & to that extent, the Rule of admitting Authority permitting student to be admitted if he has secured > 50 % in either Paper I or Paper II even if he has secured < 50 % /40 % in total is contrary to PG Regulations & cannot be permitted.

Issue Discharge Notice. Institute be directed to comply within 2 weeks. Copy of the Discharge Notice be also sent to Secretary (ME), DME, Affiliating University, State Medical Council & representative of the State on MCI.

24. Admission of PG students (Super-speciality) at Calcutta National Medical College, Kolkata for the Academic Year 2015-16- Regarding.

The Monitoring Sub-Committee noted that the inspite of reminders reply has not come in such circumstances the PG committee at its meeting dated 30.06.2017 directed to issue discharge notice. The above is similar case and discharge notice may be issued.

Approved. Issue Discharge Notice. Institute be directed to comply within 2 weeks. Copy of the Discharge Notice be also sent to Secretary (ME), DME, Affiliating University, State Medical Council & representative of the State on MCI.

25. Admission of Postgraduate Super-specialities students at Burdwan Medical College, Burdwan for the Academic Year 2015-16 – Regarding.

32. **Admission of PG students at Adichuncnanagiri Institute of Medical Sciences, Bellur for the Academic Year 2015-16 – Regarding.**

Matter pertains to admission of NRI students upto 25 %. The matter along with clarification with regard to admission of PG students at Adichuncnanagiri Institute of Medical Sciences, Bellur for the Academic Year 2015-16 was considered by the Monitoring Sub-Committee at its meeting held on 08/02/2016 and the Committee decided as under:-

The minutes of the Monitoring Sub-Committee held on 07/09/2015 were placed before the Postgraduate Medical Education Committee at its meeting held on 06/11/2015 and the decision of the Committee is under:-

“The Postgraduate Medical Education Committee also perused the minutes of the Monitoring Sub-Committee meetings held on 07/09/2015 and noted that what information has been supplied by the College authorities, which has been accepted by the Monitoring Committee is not provided in any of the items. Hence, the minutes are referred back for clarification. It is requested that the minutes may be drafted in 3 columns information providing the deficiencies noted, reply given by the College and decision of the Monitoring Committee”.

The Dean / Principal, **Adichuncnanagiri Institute of Medical Sciences, Bellur** vide Council letter dated 31/07/2015, was directed to send the clarification on the above point.

In this regard reply has been received from the college authority vide letter dated 03.08.2015 received on Council office dated 07.08.2015 stating as under:-

The Institute admits the PG students under 3 categories.

- a). Through Govt. PGET – 33%
- b). Through Comed-K - 42%
- c). Through NRI/IP- 25%

As per the order of Government of Karnataka the NRI students need not appear for the entrance examination. Hence the question of percentage of marks in entrance examination for NRI students does not arise. However the institute has considered all the eligibility criteria for admitting NRI students. (Copy enclosed). The matter along with clarification at **Adichuncnanagiri Institute of Medical Sciences, Bellur** was considered by the Monitoring Sub-Committee at its meeting held on 07th September 2015 and the Committee decided as under:-

“The Sub-Committee considered the matter along with clarification with regard to Admission of PG students at Adichuncnanagiri Institute of Medical Sciences, Bellur for the Academic Year 2015-16 and noted the following explanation of the institute submitted by letter dated: 03/08/2015.

As per the clarification submitted by the Principal vide their letter dated 03.08.2015 the Monitoring Committee observed that Institute admits PG students in 3 categories i.e. (a) through Govt. PGET – 33% (b) through COMED K- 42% and (C) through NRI/I.P – 25%. The Monitoring Sub-Committee noted that the clarification regarding (C) may be obtained from college authorities that as to why the NRI/I.P is above 15% as laid down by the Hon’ble Supreme Court. The matter alongwith the above recommendations of the Monitoring Sub-Committee was placed before the Postgraduate Medical Education Committee at its meeting held on 30/03/2016 and the Committee approved the above minutes of the Monitoring Sub-Committee.

The college authorities vide Council letter dated 22/04/2016 was requested to submit the clarification regarding © that as to why the NRI/I.P is above 15% as laid down by the Hon'ble Supreme Court. The Principal, Adichunchanagiri Institute of Medical Sciences, Karnataka, vide his letter dated 28/04/2016 furnished the following clarification for admission of PG students for the academic year 2015-16. In Karnataka, the Karnataka Professional Colleges Foundation (KPCF) and the State Government have made Consensual Agreement between them with respect to Post Graduate admissions in private medical colleges. As per this consensual agreement 42% of the students are admitted through Comed-K, 33% of the students are admitted through Government PGET and 25% of the seats admitted through NRI/IP (NRI-15% and Institutional Preferences (IP)-10%). A copy of consensual agreement between Government of Karnataka and the Karnataka Professional College's Foundation in the matter of regulating admissions and fee structure to the post graduate courses in private professional colleges of Medicine and Dental Sciences for the academic year 2015-16 is submitted by the college authorities. They have admitted the students in the year 2015-16 as per the consensual agreement and declare that they have not exceeded the limit (number of seats) in any of the category.

Total Number of seats allotted under NRI/IP	– 25% = 19 seats
Total Number of seats allotted under NRI	– 15% = 11 seats
Total Number of seats allotted under IP	– 10% = 08 seats

The matter with regard to Admission of PG students at Adichunchanagiri Institute of Medical Sciences, Bellur for the Academic Year 2015-16 was placed before the Monitoring Sub-Committee at its meeting held on 13/06/2016 and Committee decided as under:-

"The explanation given by the Principal where he has explained that he has filled the seat as per the consensual agreement between the college and the Central Govt. and the Monitoring Committee observed that the explanation may be accepted. The minutes of the Monitoring Sub-Committee dated 13/06/2016 was placed before the Postgraduate Committee for consideration and approval at its meeting held on 03/11/2016 and the committee decided as under:-

"Legal opinion may be obtained, whether institutional preference of 10% is permissible or not. The matter be re-considered after that"

In this regard, opinion of Shri Tushar Mehta, Ld. Additional Solicitor General of India has been obtained on the issue which is as under:

"In all the above-mentioned judgments by the Hon'ble Apex Court, it comes out clearly that there exists complete justification for any University/College/Educational Institution to follow the principle of grant of institutional preference. The Hon'ble Apex Court has accepted the existence of objective, reasons and factors including institutional continuity in a particular branch/stream of education leading to admissions in higher courses. In fact, the overall scheme of the medical education is completely dependent upon institutional continuity for any medical student, not only during the MBBS course itself but also for higher medical PG courses leading to such medical students securing 'Specialty' and 'Super-Specialty' medical degrees/qualifications." The Ld. ASG has therefore opined that "institutional reservations are permissible under the scheme of the Constitution". The opinion of Ld. ASG is kept on the file. In view of the aforesaid, the answer to the query posed by the PG Committee is in affirmative and it is permissible to admit students in

postgraduate courses on the basis of the principle of institutional preference and that the extent of such institutional preference should not exceed the outer limit of 50%. The Monitoring Sub-Committee noted that the query was posed by P.G Committee and the opinion that has been received may be placed before PG Committee.

Approved.

33. Admission of PG students (Broad-speciality) at Armed Forces Medical College, Pune for the Academic Year 2016-17 – Regarding.

The Monitoring Sub-Committee accepted the explanation submitted by the college authorities. Hence no further action is required in the matter.
