The Chairman welcomed the members of the Postgraduate Medical Education Committee.

Leave of absence was received from Dr. Bhanu Prakash Dubey, Dr. Datteswar Hota, Dr. Deelip Govindrao Mhaisekar, Dr. Dhruba Jyoti Borah, Dr. K S Sharma, Member(s), Postgraduate Medical Education Committee.

The Postgraduate Committee considered letter no. 4/2011/25/2016-ME-I (PT. 2) dated 11<sup>th</sup> May, 2017 received from Sh. Amit Biswas, Under Secretary to the Govt. of India, Ministry of Health and Family Welfare addressed to the Secretary, Medical Council of India, which is reproduced below:

"I am directed to say that oversight committee vide its email letter dated 27.04.2017 has sought status of implementation of their decision to adopt the same practice for increase of seats in PG (Super specialty) courses that was followed in case of one-time increase of seats in PG (Broad specialty) courses in all government funded medical colleges in the academic year 2017-18. A copy of their mail letter is enclosed.

MCI is requested to send recommendations for one-time increase of seats in PG (Super specialty) courses under revised teacher student ratio for the year 2017-18 after obtaining information from colleges/state governments."

As desired by Central Govt. & oversight committee in the letter reproduced above the Postgraduate Committee decided to seek information from Government. Medical Colleges which are already running superspeciality courses about the faculty (Professor, Assoc. Prof., Asstt. Prof., Sr. Resident, clinical material & infrastructure

available in their colleges (in clinical departments only) for consideration of grant of additional PG seats to them in superspeciality departments as desired by central govt. The information sought should be received within 5 days (on account of time schedule limitation) and delivered by hand in MCI office by 23<sup>rd</sup> May 2017 during working hours. No requests received after 23<sup>rd</sup> May 2017 5 pm will be entertained. The information should be provided in the prescribed Proforma (to be sent along) giving all details about the number of units, beds, equipment, faculty available and superspeciality seats already running.

The information must be accompanied by the declaration forms (duly filled and signed by concerned faculty & dean) giving all experience details of working in superspeciality department (in different ranks), their appointment/promotion orders and joining reports, reprints of their research publications (in which they are 1st or 2nd author only) published in indexed journals of their superspeciality, and a list of available specialized equipment in the department. It should also be certified that these faculty members have not appeared in any MCI inspection for any Broad specialty.

However, the postgraduate medical education committee decided that no seats will be given to those colleges:

- 1. Whom MCI has already denied superspeciality seats in that subject during academic year 2017-18.
- 2. Promotion of Professor/Associate professor is not as per MCI regulations fulfilling the required superspeciality qualification, time period in each rank and necessary research publications (if promoted after cut off date)
- 3. The department is not fulfilling the prescribed criteria of required number of units/beds/infrastructure/equipment as per regulations.

The above decision of PG committee has already been approved by the central govt. and oversight committee in the case of PG Broad specialties (the present decision to grant extra seats in superspecialities being an offshoot of broad specialties decision only).

# 125. Maharishi Markandeshwar University, Mullana-Ambala, Haryana - Renewal of recognition of MD(Microbiology) qualification for 03 seats in respect of students being trained at M.M. Institute of Medical Sciences & Research, Ambala.

Read: the Council Assessor's Report (17.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of MD(Microbiology) qualification for 03 seats at M.M. Institute of Medical Sciences & Research, Ambala granted by Maharishi Markandeshwar University, Mullana-Ambala, Haryana.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (17.04.2017) and decided to recommend to the Central Government that the recognition of MD(Microbiology) qualification for 03 seats granted by Maharishi Markandeshwar University, Mullana-Ambala, Haryana in respect of students being trained at M.M. Institute of Medical Sciences & Research, Ambala be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

# 126. Maharishi Markandeshwar University, Mullana-Ambala, Haryana - Renewal of recognition of MD(Physiology) qualification for 05 seats in respect of students being trained at M.M. Institute of Medical Sciences & Research, Ambala.

Read: the Council Assessor's Report (18.04.2017) on the standard of examination and other teaching facilities available for Renewal of recognition of MD(Physiology) qualification for 05 seats at M.M. Institute of Medical Sciences & Research, Ambala granted by Maharishi Markandeshwar University, Mullana-Ambala, Haryana.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (18.04.2017) and decided to recommend to the Central Government that the recognition of MD(Physiology) qualification for 05 seats granted by Maharishi Markandeshwar University, Mullana-Ambala, Haryana in respect of students being trained at M.M. Institute of Medical Sciences & Research, Ambala be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

## 127. <u>Manipal University, Manipal - Renewal of recognition of MS(ENT) qualification for 04 seats and DLO qualification for 02 seats in respect of students being trained at Kasturba Medical College, Manipal.</u>

Read: the Council Assessor's Report (10.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of MS(ENT) qualfication for 04 seats and DLO qualification for 02 seats at Kasturba Medical College, Manipal granted by Manipal University, Manipal.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10.04.2017) and decided to recommend to the Central Government that the recognition of MS(ENT) qualfication for 04 seats and DLO qualification for 02 seats granted by Manipal University, Manipal in respect of students being trained at Kasturba Medical College, Manipal be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 128. Manipal University, Manipal - Renewal of recognition of MS(General Surgery) qualfication for 08 seats in respect of students being trained at Kasturba Medical College, Manipal.

Read: the Council Assessor's Report (10.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of MS(General Surgery) qualfication for 08 seats at Kasturba Medical College, Manipal granted by Manipal University, Manipal.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10.04.2017) and decided to recommend not to renew the recognition of MS(General Surgery) qualfication for 08 seats granted by Manipal University, Manipal in respect of students being trained at Kasturba Medical College, Manipal because of the following facts:-

- 1. Dr. L. Ramchandra is shown as "Professor" in the column of "Designation" in the faculty table; however in the column of "Designation", it is shown as "Addl. Prof./Prof." w.e.f. 10/10/2001. Thus it is not clear whether he is Addl. Prof. or Professor. No explanation is given for this dichotomy. Unit left with only 2 faculty.
- 2. Dr. Annappa Kudva is shown as "Professor" in the column of "Designation" in the faculty table; however in the column of "Designation", it is shown as "Addl. Prof./Prof." w.e.f. 10/10/2001. Thus it is not clear whether he is Addl. Prof. or Professor. No explanation is given for this dichotomy.
- 3. Dr. Pratik J. Raval is shown as "Assistant Professor" in the column of "Designation" in the faculty table; however, in the column of "Experience" it is shown as "Senior Resident" w.e.f. 14/07/2014 till date. No explanation is provided for this dichotomy. Unit left with only 2 faculty.
- 4. Dr. Ramesh Singareddi, Senior Resident in Unit VII does not possess 3 y experience as Resident in a teaching hospital before appointment as Senior Resident; hence not qualified to hold the post. There is no other Senior Resident in the Unit. There is no other Sr. Resident in the Unit.
- 5. Day care operations during the last 3 years were nil.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 08 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate

Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

#### 129. <u>Manipal University, Manipal - Renewal of recognition of MD(General Medicine) qualfication for 20 seats in respect of students being trained at Kasturba Medical College, Manipal.</u>

Read: the Council Assessor's Report (17.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of MD(General Medicine) qualfication for 20 seats at Kasturba Medical College, Manipal granted by Manipal University, Manipal.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (17.04.2017) and decided to recommend not to renew the recognition of MD(General Medicine) qualfication for 20 seats granted by Manipal University, Manipal in respect of students being trained at Kasturba Medical College, Manipal because of the following facts:-

- 1. Joining report for faculty during the course of their promotions are not available. When pointed out by assessor, current joining report dated to-day (i.e. day of assessment) for promotion of faculty were provided.
- 2. Dr. Joseph Thomas signed in the morning but was not prsent for verification & did not submit Declaration Form either.
- 3. Dr. H. Manjunath Hande is shown as "Professor" in the column of "Designation" in the faculty table; however in the column of "Designation", it is shown as "Addl. Prof./Prof." w.e.f. 05/03/2003, which is not feasible.
- 4. Dr. Shubha Shesadri is shown as "Professor" in the column of "Designation" in the faculty table; however in the column of "Designation", it is shown as "Addl. Prof./Prof." w.e.f. 20/06/1995, which is not feasible. Resultantly Unit is left with 2 faculty.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 20 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. #### 130. <u>Manipal University, Manipal - Renewal of recognition of MD(Psychiatry)</u> qualfication for 03 seats and DPM qualification for 06 seats in respect of students being trained at Kasturba Medical College, Manipal.

Read: the Council Assessor's Report (17.04.2017) on the standard of examination and other teaching facilities available for Renewal of recognition of MD(Psychiatry) qualification for 03 seats and DPM qualification for 06 seats at Kasturba Medical College, Manipal granted by Manipal University, Manipal.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (17.04.2017) and decided to recommend not to renew the recognition of MD(Psychiatry) qualfication for 03 seats and DPM qualification for 06 seats granted by Manipal University, Manipal in respect of students being trained at Kasturba Medical College, Manipal because of the following facts:-

- 1. Equipment like Lithium Analyzer, EEG, Thin Layer Chromatography are not available.
- 2. Projective tests, intelligent tests and personality tests are not available.
- 3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 3 degree and 6 diploma seats till renewal of their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

#### 131. <u>Sumandeep Vidyapeeth, Vadodara - Renewal of recognition of DDVL qualification for 01 seat in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara.</u>

Read: the Council Assessor's Report (11.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of DDVL qualification for 01 seat at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara granted by Sumandeep Vidyapeeth, Vadodara.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (11.04.2017) and decided to recommend to the Central Government that the recognition of DDVL qualification for 01 seat granted by Sumandeep Vidyapeeth, Vadodara in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 132. Sumandeep Vidyapeeth, Vadodara - Renewal of recognition of DGO qualification for 04 seats in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara.

Read: the Council Assessor's Report (10.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of DGO qualification for 04 seats at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara granted by Sumandeep Vidyapeeth, Vadodara.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10.04.2017) and decided to recommend not to renew the recognition of DGO qualification for 04 seats seat granted by Sumandeep Vidyapeeth, Vadodara in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara because of the following facts:-

- 1. Obstetric ward is common. There is no separate Antenatal & Postnatal wards.
- 2. IUI & ART facilities are not available.
- 3. Equipment like LEEP is not available.
- 4. There is no ICU/HDU in OBGY department.
- 5. 10 patients admitted in Obstetric ward were admitted for more than 5 days after Normal Delivery, which means non-deserving patients are admitted and kept in ward.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 04 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

Read: the Council Assessor's Report (10.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of D. Ortho qualification for 02 seats at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara granted by Sumandeep Vidyapeeth, Vadodara.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10.04.2017) and decided to recommend to the Central Government that the recognition of D. Ortho qualification for 02 seats granted by Sumandeep Vidyapeeth, Vadodara in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 134. Sumandeep Vidyapeeth, Vadodara - Renewal of recognition of DA qualification for 03 seats in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara.

Read: the Council Assessor's Report (12.04.2017) on the standard of examination and other teaching facilities available for renewal of recognition of DA qualification for 03 seats at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara granted by Sumandeep Vidyapeeth, Vadodara.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (12.04.2017) and decided to recommend to the Central Government that the recognition of DA qualification for 03 seats granted by Sumandeep Vidyapeeth, Vadodara in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

#### 135. <u>Sumandeep Vidyapeeth, Vadodara - Renewal of recognition of DCH qualification for 02 seats in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara.</u>

Read: the Council Assessor's Report (10.04.2017) on the standard of examination and other teaching facilities available for Renewal of recognition of DCH qualification for 02 seats at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara granted by Sumandeep Vidyapeeth, Vadodara.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10.04.2017) and decided to recommend not to renew the recognition of DCH qualification for 02 seats granted by Sumandeep Vidyapeeth, Vadodara in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara because of the following facts:-

- 1. Dr. Kushagra Gupta & Dr. Priyanka, Senior Residents in Unit I do not possess 3 y experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. There is no other eligible Senior Resident in the Unit.
- 2. Dr. Honey Aswani & Dr. Rohit Bharadwaj, Senior Residents in Unit II do not possess 3 y experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. There is no other eligible Senior Resident in the Unit.
- 3. Promotion of Dr. Varsha Shah is not as per Regulations. She was promoted Professor after the cut-off date. However, only 3 publications are quoted against the required four. Hence, she cannot be considered.
- 4. Dr. Deepak Kumar, Senior Resident in Unit III does not possess 3 y experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. There is no other eligible Senior Resident in the Unit.
- 5. Dr. Nishant Sharma, Senior Resident in Unit IV does not possess 3 y experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. There is no other eligible Senior Resident in the Unit.
- 6. Equipment like Transport Incubator is not available.
- 7. Promotion of Dr. Prasad Muley, Professor is not as per regulations. He was Asst.Professor for 4 years and Assoc.Prof. for 3 years & 2 months and promoted Professor on 21.09.2013 after the cut-off date. Out of 4 publications quoted 3 are review articles which cannot be accepted. Resultantly, Unit have no other Assoc.Prof.
- 8. Dr. Bhairavi Shah, Professor, is already 70 years of age.
- 9. Promotion of Dr. Manish Rasania, Professor, is not as per regulations. He was Assoc.Prof. for 3 years and 10 months against the required 4 years. He has no publication. Resultantly, Unit-III left with only 2 faculty.
- 10. Dr. R.Shivkumar, Professor was Tutor/Lecturer for 1 year 6 months. There is no designation like Tutor/Lecturer. Resultantly, he was Asst.Prof. for 3 years 7 months against the required 4 years. Hence his promotion is not as per regulation. He cannot be considered.
- 11. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. - 2. Resultantly, Unit II would come to be headed by Asst. Prof. which is not permissible & it cannot be considered as a teaching Unit.
- 3. Dr. Raju Iyengar is promoted as Professor after cut-off date on 26/07/2016; however in the column "Benefit of publications" in the faculty table, it is stated "No" implying NIL publications against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
- 4. Dr. Srikanth Reddy Konda, Senior Resident in Unit I does not possess 3 y experience as Resident in a teaching hospital before appointment as Senior Resident; hence not eligible to hold the post.
- 5. Dr. S. Guru Prasad, Senior Resident in Unit II does not possess 3 y experience as Resident in a teaching hospital before appointment as Senior Resident; hence not eligible to hold the post.
- 6. Specialty clinic like Hand clinic is not run by the department.

- 3. Three Asso. Prof. are receiving salary ranging from Rs. 15,000 to Rs. 23,000 p.m. which is too less.
- 4. One Asst. prof. is receiving salary of Rs. 15,000 p.m. which is too less.
- 5. OPD attendance on day of assessment till 2 p.m. was 750 against 800 required.
- 6. Ancillary facilities are inadequate in some wards.
- 7. On the day of assessment MRI in the entire hospital only 8 and CT Scan only 6, which is grossly inadequate.

- 3. Total Bacteriology investigations have decreased from 1,94,203 in 2015 to 1,23,345 in 2016.
- 4. Total Mycology investigations have decreased from 7,803 in 2014 to 6,023 in 2016.
- 5. Total Virology investigations have decreased from 34,456 in 2014 to 32,678 in 2016
- 6. Other deficiencies as pointed out in the Assessment Report.

- 4. Faculty table is not signed by any faculty members.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 3 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 3. There was NIL Major Obstetric & NIL Minor Obstetric Operation on day of assessment.
- 4. Specialty clinic registers are not maintained as per requirement.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 9 degree and 12 diploma seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 3. Dr. Jayanti Ray, Asst.Prof. is DNB, it is not giving from where she passed whether it is teaching or non-teaching hospital without which her eligibility cannot be decided.
- 4. Unit 7 & 8 have only 2 faculty each; hence they cannot be considered as PG Units.
- 5. Only 2 faculty each from Units 2 & 3 were present during assessment; hence faculty complement is incomplete & they cannot be considered as PG Units.
- 6. Shortage of Senior Residents: 3.
- 7. There is no Senior Resident in Units 5, 7 & 8.

  - (iii) Dr. Sunil Takair, Asst.Prof.

- 8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 2(Two) seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. Medical College and Hospital, Guntur because of the following facts:-

- 1. The college got Letter of Permission to start DM course in 2012, however, Dr. R.John Satish has been shown Assoc.Prof. from 2005, which is not acceptable.
- 2. Faculty table not signed by any faculty members.
- 3. Clinical material of inspection day has not been provided.
- 4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 1(One) after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. In respect of Dr. Fiyaz M. Khalid, Senior Resident, remark in earlier assessment was that he has experience of only 2 y as Resident before appointment as Senior Resident; hence not eligible. In the present assessment, his experience from 12/01/2015 to 12/01/2016 is redesignated as Junior Resident. Such retrospective changes to make him eligible are not permissible & he cannot be considered.

- 1. In respect of Dr. Sabyasachi Roy, Asso. Prof., all his publications do not belong to O.G. and cannot be considered; resultantly his promotion is not as per Regulations. Deficiency remains as it is.
- 2. In respect of Dr. Ranjan Dasgupta, Asso. Prof., he does not have any publication in indexed/National journals cannot be considered; resultantly his promotion is not as per Regulations. He cannot be considered Assoc.Prof. Deficiency remains as it is.
- 3. Dr. A. Sultana, Senior Resident in Unit I was absent on day of assessment.
- 4. Average workload of randomly selected days of Gynaec Major Operations is 1/day.
- 5. There were only 02 Minor Operations on day of assessment.
- 6. Gynaecological Operative workload is inadequate as total 573 Major & Minor Operations combined were performed in 2016.
- 7. Specialty clinics like Infertility clinic, Cancer clinic, High Risk Pregnancy clinic, etc. are allotted in a single room which is undergoing renovation.
- 8. Prenatal diagnosis services are not available.
- 9. Equipment like Cryocautery, LEEP are not available.
- 10. Equipment like Laparoscope, Hysteroscope, Colposcope are non-functional on day of assessment.
- 11. IUI, ART services are not available.
- 12. Ultrasound machine in the department is not working.
- 13. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 3(Three) seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. Promotion of Dr. Chandrasenan, Assoc.Prof., is not as per regulations. He was promoted on 11.08.2016 after the cut-off date without any publications. Resultantly, Unit left with only 2 faculty.
- 2. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 01(One) to 03(Three) seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. (Deemed Univ.), Belgaum in respect of students being trained at Jawaharlal Nehru Medical College, Belgaum because of the following facts:-

- 1. On the day of assessment OPD only 50, which is bare minimum to start the course.
- 2. There are no demotion order and fresh joining report of Dr. S.I.Neeli, Professor from Prof. to Assoc. Professor without which she cannot be considered as Assoc.Prof. and her promotion as Professor is not as per regulations.
- 3. There are no demotion order of Dr. Vikram Prabha, Assoc.Prof. from Assoc.prof. to Asst.Prof., without which she cannot be considered as Asst.Prof., her promotion as Assoc.Prof. is not as per regulations.
- 4. Other deficiencies as pointed out in the Assessment Report.

1. Deficiency of faculty: (a) Asst. Prof.: 1.

- 2. Unit 2 has only 2 faculty; hence it cannot be considered as PG Unit.
- 3. There is no Senior Resident in Unit I.
- 4. Average OPD on randomly selected days was 100, which is bare minimum to start the course.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 1(One) after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 2. MRI is outsourced.
- 3. Dr. Neelima Singh, Asst.Prof. was not available on the day of assessment. Resultantly, Unit-II left with only 2 faculty, hence, it cannot be considered a PG unit.
- 4. Other deficiencies as pointed out in the Assessment Report.

- 10. If Dr. H.K. Narang, Professor, and HoD is present in this institute since 1987 without any break (as shown in the faculty table) then why he was not shown in the last assessment report.
- 11. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 2(Two) after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (June, 2014 & 30.06.2016) and compliance dated 29/12/2016 submitted by the college authorities and decided to recommend not to recognize MS(General Surgery) qualification against increased intake from 07 to 09 seats granted by Pt. Ravishankar Shukla University (upto 2008) & Ayush and Health University (from 2009), Raipur in respect of students being trained at Pt. J N M Medical College, Raipur because of the following facts:-

1. On the day of assessment OPD/IPD/Operations are given in the entire hospital, not of Surgery Department as required.

- 2. There is NIL Senior Resident in the department. Deficiencies of Senior Resident 5.
- 3. Faculty table is not signed by any faculty/Resident.
- 4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 07 to 09 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 24/10/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MD(Pathology) qualification for 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Dr BR Ambedkar Medical College, Bangalore because of the following facts:-

- 1. On the day of assessment bed occupancy is 55% only which is inadequate.
- 2. Workload of TT investigations is 1/month.
- 3. Frozen Section workload is nil.
- 4. Reference books are inadequate in Departmental Library. WHO Classification of Tumors is not available.
- 5. At 11.45 only 4 operation were done/going on. Many Cataract Surgery patients were brought. Proper case papers were not available Consent was also not taken. Professor Ophthalmology told that six cases were operated. When asked to substantiate No OT register was shown. When asked to show the operated cases, she didn't come. Ophthalmology ward was visited to see if such cases are available along with Superintendent. No cases were seen. Evidence sheet signed by Dean and Superintendent is attached. Evidence sheet of bed occupancy is also attached. Wards and wards facilities are not as per MSR. This simply indicates that data of clinical material is fictitious.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 3(Three) seats till renewal of their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (03/04/2017) along with the Council Assessor's Report (July, 2015 & 24.10.2016) and compliance dated 14/02/2017 submitted by the college authorities and decided to recommend to the Central Government that MS(General Surgery) qualification for 2 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Dr. Somervel Memorial CSI Hospital & Medical College, Karakonam, Thiruvananthapuram be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

Admissions done (if any) against these seats i.e. increased intake from 04 to 08 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. Dr. Sanjiv B. Birajdar is promoted as Assoc. Prof. after cut-off date; however the column of "Benefit of publications" in the faculty table is left blank implying NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 2. Dr. Manjari Deshpande has resigned and then re-joined 3 times in preceding 3 years as under:
  - (a) From 15/03/2013 to 19/09/2014;
  - (b) From 01/03/2016 to 15/04/2016;
  - (c) From 22/02/2017 till date.

It seems as if she is being shown only for the purpose of assessment and is not a regular faculty.

3. Other deficiencies as pointed out in the Assessment Report.

- 1. Dr. Swapnil A Patil, Sr. Resident, Unit-I was absent on the day of assessment. How she signed the faculty table, may be asked from the Dean & Faculty.
- 2. There is no Senior Resident in Unit II and Unit I.
- 3. Bed Occupancy is 70 % on day of assessment. 40 % of these patients are simple back pain & knee pain.
- 4. There were only 2 Major Operations on day of assessment.
- 5. Data of clinical material provided by Institute appears to be inflated.
- 6. Only 2 Examination rooms are available in OPD against requirement of 4.
- 7. MRI is under repair.
- 8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 1(One) seat till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations

(notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 4. Promotion of Dr. Somendra Pal Singh, Professor, is not as per regulations. He was promoted on 04.07.2016 after the cut-off date. He has only 3 publications against the required 4.

- 2. Dr. Shilpa P.H., Sr. Resident, arrived late. Hence not counted.
- 3. Dr. Vasantha Kumar K.R., Prof., Dr. Shridhar Kathvate, Asst.Prof. & Dr. Sanjay B G, Sr.Resident were absent on the day of assessment.
- 4. Only 4 MRI on the day of assessment in the entire hospital, which is grossly inadequate.
- 5. Bed occupancy on inspection day in SICI, MICU and Paediatrics ICU was 60%, which is inadequate.
- 6. On the day of assessment bed occupancy in the entire hospital was 29%.
- 7. On assessment day there were only 11 major operations and nil minor and day care operation which means the operative workload is inadequate.
- 8. Faculty table not signed by any faculty members.
- 9. OPD attendance is 1,000 on day of assessment against requirement of 1,200.
- 10. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 04 to 05 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be

recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (April, 2015 & 29.03.2016 & 05.10.2016) and compliance dated 18/02/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(General Medicine) qualification for 04 seats granted by Pondicherry University, Puducherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (28/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 18/01/2017 submitted by the college authorities and decided to recommend not to recognize MD(Anaesthesiology) qualification for 2 seats granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Midnapore Medical College, Midnapore because of the following facts:-

- 1. Faculty deficiency: (a) Assoc.Prof. -1 (b) Asst.Prof.-1
- 2. Dr. Anurup Pakhira is promoted as Assoc. Prof. after cut-off date without any publications; hence his promotion is not as per Regulations & he cannot be considered.
- 3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 2(Two) after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.

Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (03/04/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 30/01/2017 submitted by the college authorities and decided to recommend to the Central Government that the recognition of MD(General Medicine) qualification for 3 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Academy of Medical Sciences, Pariyaram, Kannur be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

Read: the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 15/01/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Respiratory Medicine) qualification against increased intake from 1 to 3 seats at Lokmanya Tilak Municipal Medical College, Sion, Mumbai granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 15/01/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Respiratory Medicine) qualification against increased intake from 1 to 3 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Lokmanya Tilak Municipal Medical College, Sion, Mumbai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

### 35. Padamshree Dr. D.Y. Patil University, Navi Mumbai - Renewal of recognition of MS(OBG) and DGO qualifications for 3 seats each in respect of students being trained at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai.

Read: the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (May, 2015 & 26.05.2016) and compliance dated Council received date 16/01/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(OBG) and DGO qualifications for 3 seats each at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai granted by Padamshree Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (May, 2015 & 26.05.2016) and compliance dated Council received date 16/01/2017 submitted by the college authorities and decided to recommend not to renew the recognition of MS(OBG) and DGO qualifications for 3 seats each granted by Padamshree Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

- 1. In the compliance it is stated that Dr. Alka Dani is reverted to the post of Asst. Prof. because of inadequate publications; however in the faculty table, in the column of "Designation" it is shown as "Asso. Prof." and in the column of "Experience" it is shown as "Asso. Prof." w.e.f. 13/08/2015 till date. This indicates that her so called demotion is only a sham and an attempt to mislead the Council.
- 2. Dr. Priyanka Suhag, Senior Resident in Unit I, does not have 3 y experience as Resident in a teaching hospital before appointment as Senior Resident; hence not qualified to hold the post. She is DNB from non-teaching hospital. There is no other Senior Resident in Unit-I.
- 3. Dr. Aditi Trivedi, Senior Resident in Unit II does not have any experience as Resident in a teaching hospital before appointment as Senior Resident; hence not qualified to hold the post. Further in the column of "Designation" in the faculty table it is shown as "Sr. Resident" but in the column of "Experience" it is shown as "Jr. Resident" w.e.f. 27/02/2017 till date. Further her qualification is shown as "M.D." but Institution is shown as "Dr. L.H. Hiranandani Hospital" which is not possible. No explanation is given for this dichotomy.
- 4. Dr.Priyanka Suhaag, Sr.Resident, is DNB from non teaching hospital. She has no 3 year experience from a medical college as Jr. Resident. Hence, she is not eligible for Sr. Resident.
- 5. There is no other Sr. Resident in Unit-I.
- 6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 3 seats each in MS(OBG) and DGO till renewal of their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (27/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 18/01/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Anaesthesiology) qualification against increased intake from 2 to 4 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Mahatma Gandhi Institute of Medical Sciences, Sevagram, Wardha be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

## 37. <u>Maharashtra University of Health Sciences, Nashik - Recognition of MS(General Surgery) qualification for 2 seats in respect of students being trained at ESI-PGIMSR,ESI-Hospital,Andheri(E), Mumbai.</u>

Read: the Compliance Verification Assessment Report (29/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 10/01/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(General Surgery) qualification for 2 seats at ESI-PGIMSR,ESI-Hospital,Andheri(E), Mumbai granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (29/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 10/01/2017 submitted by the college authorities and decided to recommend not to recognize MS(General Surgery) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of

students being trained at ESI-PGIMSR, ESI-Hospital, Andheri (E), Mumbai because of the following facts:-

- 1. Institute is running only PG courses for which Units, faculty & Residents as per 50 MBBS intake, which is 3 Units & total 9 faculty; however there are total 6 faculty only available. Resultantly, there is deficiency of faculty: (a) Asst. Prof.: 3. Contention of the Institute that it is exempted by Ministry is of no relevance as these requirements are as per Statutory Regulations which being mandatory in character are binding on all. In fact, perusal of the Exemption reveals that the exemption is u/s 8(1)(A) for conducting recognized MBBS course only and it clearly states that the "... Institute will submit formal proposals in accordance with IMC Act, 1956 and Regulations made thereunder for starting PG courses...." Further, reliance on MOU with LTMC, Sion also is of no relevance as such MOU can only be for facilities in basic sciences and not for broad specialities for which PG courses are conducted. Deficiency remains as it is.
- 2. In view of above, there is deficiency of 1 Unit & 30 beds. Deficiency remains as it is.
- 3. Dr. Anuja A. Belose is designated as "Specialist" which is not a teaching post and hence she cannot be considered as faculty.
- 4. There is no certificate from DGAFMS regarding period and places of posting as Graded/Classified specialist and Advisor without which eligibility of Dr. Surath Chandra Patra, Professor, cannot be decided.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 2(Two) seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (31/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 23/01/2017 submitted by the college authorities and decided to recommend to the Central Government that M.Ch(Surgical Oncology) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at St. Johns Medical College, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (10/04/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 09/02/2017 submitted by the college authorities and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 2 to 4 seats granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at North Bengal Medical College, Darjeeling because of the following facts:-

- 1. Deficiency of faculty: (a) Asst. Prof.: 1.
- 2. Unit III has only 2 faculty; hence it cannot be considered as PG Unit.
- 3. Dr. S.K. Das is promoted as Professor after cut-off date; however, out of 5 publications cited in the list, in 2 he is 4<sup>th</sup> author & in another he is 3<sup>rd</sup> author which cannot be considered; resultantly there are only 2 research publication to his credit against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
- 4. Dr. Balai Chandra Karmakar is promoted as Asso. Prof. after cut-off date; however, out of 3 publications cited in the list, in 1 he is 4<sup>th</sup> author which cannot be considered and the rest 2 are case reports which cannot be considered; resultantly there is NIL research publication to his credit against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 5. Promotion of Dr. Abhijit Dutta, Assoc.Prof. is not as per regulations. He was Asst.Prof. for 4 years 5 months against the requirement of 5 years. He has no publications.
- 6. Dr. Toshiba Nanda Bag, Assoc.Prof. was absent on the day of assessment. She was promoted on 04.02.2016 after the cut-off date and she has no publications in which she is 1<sup>st</sup> & 2<sup>nd</sup> Author. Resultantly, her promotion is not as per Regulations.
- 7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/03/2017) along with the Council Assessor's Report (June,2011, Feb.,2014 & November, 2014 & 28.07.2015 31.03.2016, 12.08.2016(for 02 to 03 seats) & 05.10.2016) and compliance dated 23/01/2017 submitted by the college authorities and decided to recommend not to recognize MD(Anaesthesia) qualification for 3 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at A.C.P.M.Medical College, Dhule because of the following facts:-

- 1. Deficiency of faculty: (a) Asst. Prof.: 3.
- 2. Promotion of Dr. Sanjay P Gadre, Prof. & HoD is not as per regulations. He was promoted on 01.03.2017 after the cut-off date. He has only one publication against the required 4.
- 3. Dr. Sunita B, Wadekar, Assoc.Prof. was absent on the day of assessment.
- 4. Dr. Shruti N Loya Asst.Prof. was absent on the day of assessment.
- 5. On the day of assessment MRI in the entire hospital were only 3, which is grossly inadequate.
- 6. Other deficiencies as pointed out in the Assessment Report.

- 2. Dr. Madan M. Ballal is promoted as Assoc. Prof. after cut-off date; however the column "Benefit of publications" in the faculty table is left blank implying NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 3. Dr. Sagar, Senior Resident does not have any experience as Resident in a teaching hospital before appointment as Senior Resident; hence not eligible to hold the post.
- 4. MRI and CT Scan are not available.
- 5. Dr. Dharni Chithra D.M,; Dr. Sachin Katti, Dr. Raheel Irfan, Dr. Urmani H, all are Sr. Resident have been shown to have worked as Jr. Resident for 3 years in this institute in the present report. However, in the earlier assessment report no such experience was shown to their credit. Such retrospective addition to make the faculty eligible is not allowed.
- 5. Dr. Ramesh C.G., Sr.Resident, is not eligible. He has no 3 years experience as Jr. Resident when appointed as Sr. Resident.
- 6. The institute got Letter of permission to start MS(Orthopaedics) on 31.03.2012. Prior to that it was a non-teaching hospital. However, all faculty members have

been given teaching experience prior to 2012 (starting from 1996), which is not permissible. Deficiency stays as such.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (27/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 31/12/2016 submitted by the college authorities and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at ESI-PGIMSR,ESI-Hospital, Rajajinnagar, Banglore because of the following facts:-

- 1. Dr. S. Udaykumar is promoted as Professor after cut-off date; however, in the column of "Benefit of publications" in the faculty table, it is stated "No" implying NIL publications against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered. Dr. Udaykumar is shown Professor in the column of designation and Assoc.Prof. in the column of experience, which is not feasible. Resultantly, Unit left 2 faculty.
- 2. Deficiency of 2 faculty.
- 3. Dr. S. Kaviraj & Dr. U. Mallesh, both Senior Residents in Unit 2, do not have 3 y experience as Resident in a medical college affiliated teaching hospital before appointment as Senior Resident; hence not qualified to hold the post. Resultantly, there is no Senior Resident in Unit-II.
- 4. Other deficiencies as pointed out in the Assessment Report.

Medical College, Yavatmal. because of the following facts:-

- 1. Only 1 Assoc.Prof. present/available in the department on the day of assessment. All others were absent.
- 2. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 1(One) seat till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. Promotion of Dr. Sudhakar Dwivedi, Prof.&HoD, is not as per regulations. He was promoted after the cut off date without 4 required publications.
- 2. Deficiency of faculty: (a) Assoc. Prof.: 1, (b) Sr. Resident -4.
- 3. Dr. Avtar Singh Yadav is promoted as Assoc. Prof. after cut-off date; however in the column of "Benefit of publications" in the faculty table, it is stated "No" implying NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 4. Dr. Y.M. Ansari, Senior Resident does not have 3 y experience as Resident before appointment as Senior Resident; hence not eligible to hold the post.

- 6. Dr. M.M. Singh, Sr. Resident, is MS(Orthopaedics), it is not expected that he will be working as Jr. Resident in Anaesthesia. Resultantly, none of the Sr. Resident is having 3 years experience as Jr. Resident when appointed Sr. Resident. Hence they are not eligible.
- 7. Dr. Ravi S. Sharma, Sr. Resident was absent on the day of assessment.
- 8. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (07/04/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 10/01/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 04 to 06 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Karnataka Institute of Medical Sciences, Hubli be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

increased intake from 02 to 03 seats at Institute of Liver and Biliary Sciences, New Delhi granted by Statutory Autonomous`.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (17/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 23/12/2016 submitted by the college authorities and decided to recommend not to recognize M.Ch(Hepato Pancreato Biliary Surgery) qualification against increased intake from 02 to 03 seats granted by Statutory Autonomous` in respect of students being trained at Institute of Liver and Biliary Sciences, New Delhi because of the following facts:-

- 1. Dr. Viniyendra Pamecha, Professor & HOD is shown as Professor (Liver Transplant Surgery) in the column of "Experience" in the faculty table. It is not clear whether he is Professor of Hepato Pancreato Biliary Surgery or of liver transplant Surgery. He has been appointed as Assoc. Prof. of Haepato Pancreato Biliary Surgery without any experience as Asst. Prof. in the subject.
- 2. Dr. Nikhil is promoted as Asso. Prof. after cut-off date; however, the column of "Benefit of publications" in the faculty table is left blank implying NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 3. Dr. Asit Arora is promoted as Asso. Prof. after cut-off date; however, the column of "Benefit of publications" in the faculty table is left blank implying NIL publications against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
- 4. NIL Indian journals are available.
- 5. Prescribed SAF for compliance verification has not been used.
- 6. No reply has been given to deficiencies pointed out as Sr. No.3,4,5 in the earlier assessment report conveyed vide letter dated 30.11.2016.
- 7. Clinical material on the day of assessment has not been provided.
- 8. Faculty table not signed by any faculty members.
- 9. Dr. S.K. Sarin is shown as Director/Head of Institution in the column of designation and Sr. Professor & Head & Director ILBS in the column of experience. It is not specified that he is Head of which department (Dr. Viniyendra Pamecha, Prof., has been shown Head of Hepato Pancreato Biliary Surgery and that is the subject under consideration here). Even otherwise as per the regulations Head of Institution cannot be Head of Department, simalteneously.
- 10. Dr. Senthil Kumar, Addl. Prof. was shown Registrar Surgery (in UK from October, 2002 to April 2013) in report dated 24.07.2016 signed by Assoc. Dean and Assessor. However, in the present report this has been changed as follow:-
  - (i) Specialist Registrar (GI/Vascular/Endocrine) from April 2006 to September, 2009
  - (ii) Specialist Registrar (HPB/Liver Transplantation) October, 2009 to October 2012.
  - (iii) Clinical fellow, Liver transplant November 2012 to April, 2013.

However, only 2 certificates available which show that he was Registrar in General Surgery in U.K. Such retrospective changes to make the faculty eligible are not allowed.

He is shown Assoc.prof. at ILBS from April, 2013 to August, 2016 without having worked as Asst.Prof. at any time. Resultantly, his promotion is not as per regulations.

11. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

seats at Government Medical College, Kota, Rajasthan granted by Rajasthan University of Health Sciences, Jaipur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (21/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 03/02/2017 submitted by the college authorities and decided to recommend not to recognize MS(ENT) qualification against increased intake from 1 to 2 seats granted by Rajasthan University of Health Sciences, Jaipur in respect of students being trained at Government Medical College, Kota, Rajasthan because of the following facts:-

- 1. Dr. Shiv Kumar is promoted as Professor after cut-off date; however in the list of publications only 2 publications are listed against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
- 2. Dr. Varun Malu is DNB from non-teaching hospital. He has only 2 year experience as Resident in a teaching hospital against requirement of 3 y; hence not eligible to hold the post.
- 3. Dr. Vijay Kr Meena, Assoc.Prof., was not available on the day of assessment.
- 4. Dr. Payal Mittal, Asst.Prof., was not available on the day of assessment.
- 5. Impedance Audiometry not available. Deficiency remains as it is.
- 6. Equipment like Microdebrider, 90° Endoscope, OAE, nerve Monitor are not available. Deficiency remains as it is.
- 7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 2 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

#### 75. Ch. Charan Singh University - Recognition of MD(Community Medicine) qualification for 2 seats in respect of students being trained at Saraswati Institute of Medical Sciences, Hapur.

Read: the Compliance Verification Assessment Report (17/03/2017) along with the Council Assessor's Report (June, 2016) and compliance dated 26/10/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Community Medicine) qualification for 2 seats at Saraswati Institute of Medical Sciences, Hapur granted by Ch. Charan Singh University.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (17/03/2017) along with the Council Assessor's Report (June, 2016) and compliance dated 26/10/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(Community Medicine) qualification for 2 seats granted by Ch. Charan Singh University in respect of students being trained at Saraswati Institute of Medical Sciences, Hapur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

### 76. Rajasthan University of Health Sciences, Jaipur - Recognition of MS(Orthopaedics) qualification against increased intake from 15 to 16 seats in respect of students being trained at SMS Medical College, Jaipur.

Read: the Compliance Verification Assessment Report (20/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 28/12/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(Orthopaedics) qualification against increased intake from 15 to 16 seats at SMS Medical College, Jaipur granted by Rajasthan University of Health Sciences, Jaipur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (20/03/2017) along with the Council Assessor's Report (August, 2016) and compliance dated 28/12/2016 submitted by the college authorities and decided to recommend not to recognize MS(Orthopaedics) qualification against increased intake from 15 to 16 seats granted by Rajasthan University of Health Sciences, Jaipur in respect of students being trained at SMS Medical College, Jaipur because of the following facts:-

- (i) Promotion of Dr. Sudhir Kumar, Professor, is not as per regulations. He was promoted on 08.07.2016 after the cut of date without required 4 publications.
- (ii) Dr. Lakhpat Yadav, Sr. Resident, is DNB from non-teaching hospital. He has no 3 years experience in a teaching hospital. Hence not eligible.
- (iii) Dr. Jitesh Kumar Jain, Sr. Resident, no date of joining given in the faculty table.
- (iv) Unit-VI, has only 2 faculty.
- (v) Record of speciality clinic is Bizarre. No patient data is maintained.
- (vi) There is no record of teaching schedule maintained.
- (vii) On assessment day it was a holiday and clinical material could not be verified.
- (viii) Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 15 to 16 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

## 77. Rajiv Gandhi University of Health Sciences, Bangalore - Renewal of recognition of MS(Orthopaedics) & D.Ortho qualifications for 01 seat each in respect of students being trained at Dr BR Ambedkar Medical College, Bangalore.

Read: the Compliance Verification Assessment Report (22/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 30/12/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(Orthopaedics) & D.Ortho qualifications for 01 seat each at Dr BR Ambedkar Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (22/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 30/12/2016 submitted by the college authorities and decided to recommend to the Central Government that the recognition of MS(Orthopaedics) & D.Ortho qualifications for 01 seat each granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Dr BR Ambedkar Medical College, Bangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

## 78. Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MS(Obstetrtics & Gynaecology) qualification against increased intake from 04(Four) to 09(Nine) seats in respect of students being trained at S V Medical College, Tirupati.

Read: the Compliance Verification Assessment Report (16/03/2017) along with the Council Assessor's Report (May, 2013 for 4 to 6 seats and May, 2015 for 6 to 9 seats, 23.07.2015 for 4 to 6 seats and 11.04.2016) and compliance dated 28/10/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(Obstetrtics & Gynaecology) qualification against increased intake from 04(Four) to 09(Nine) seats at S V Medical College, Tirupati granted by Dr. NTR University of Health Sciences, Vijayawada, A.P..

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (16/03/2017) along with the Council Assessor's Report (May, 2013 for 4 to 6 seats and May, 2015 for 6 to 9 seats, 23.07.2015 for 4 to 6 seats and

11.04.2016) and compliance dated 28/10/2016 submitted by the college authorities and decided to recommend not to recognize MS(Obstetrtics & Gynaecology) qualification against increased intake from 04(Four) to 09(Nine) seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at S V Medical College, Tirupati because of the following facts:-

- 1. Dr. V. Revathi, Profssor & Dr. S. Venkata Ramana, Asst.Prof. were absent on the day of assessment.
- 2. Dr. J. Sowjanya Kumari is shown as "Professor" in the column of "Designation" in the faculty table; however in the column of "Experience" it is shown as "Associate Professor" w.e.f. 29/09/2013 till date. No explanation is given for this dichotomy. No details of publications are given in the faculty table.
- 3. Dr. V. Raghava Rao is promoted as Professor after cut-off date; however no details of publications are given in the faculty table implying NIL publications against requirement of 4; hence his promotion is not as per Regulations &he cannot be considered.
- 4. Dr. P. Hima Bindu is promoted as Professor after cut-off date; however no details of publications are given in the faculty table implying NIL publications against requirement of 4; hence her promotion is not as per Regulations & she cannot be considered.
- 5. Dr. V. Sravani, Senior Resident in Unit IV, is DNB, no date of joining is given in the faculty table, hence cannot be considered.
- 6. Dr. Karuna, Senior Resident in Unit I, is DNB from non-teaching hospital she has no 3 years experience in a medical college, hence, not eligible.
- 7. There is no SR in the Unit-V.
- 8. Faculty table not signed by any faculty members.
- 9. Prenatal Diagnosis services are not available. Deficiency remains as it is.
- 10. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 04(Four) to 09(Nine) seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

79. King George's Medical University, U.P. Lucknow (Deemed University) - Renewal of recognition of MD(Paediatrics) qualification for 9 seats in respect of students being trained at King George's Medical University, U.P. Lucknow.

Read: the Compliance Verification Assessment Report (16/03/2017) along with the Council Assessor's Report (June, 2016) and compliance dated 28/10/2016 submitted

by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MD(Paediatrics) qualification for 9 seats at King George's Medical University, U.P. Lucknow granted by King George's Medical University, U.P. Lucknow (Deemed University).

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (16/03/2017) along with the Council Assessor's Report (June, 2016) and compliance dated 28/10/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MD(Paediatrics) qualification for 9 seats granted by King George's Medical University, U.P. Lucknow (Deemed University) in respect of students being trained at King George's Medical University, U.P. Lucknow because of the following facts:-

- 1. Dr. Chandrakanta, Professor, was not available on the day of assessment. No certificate about permissible leave attached. Her promotion is not as per regulations. She was promoted in March, 2015 after the cut off date without any publications. Resultantly, there is no other Assoc.Prof. in Unit-I.
- 2. Promotion of Dr. Shakal Narayan Singh, Professor, is not as per regulations.. He was Asst.Prof. for 4 years against the requirement of 5 years. He has no publications to his credit, hence his promotion is not as per regulations.
- 3. There are total 21 PG seats 9 Degree & 12 Diploma; however only 6 PG teachers are available who can take maximum1 2 students/year. Maximum permissible seat 12 and the college already admitting 21 students.
- 4. Equipment like Paediatric Endoscope, Paediatric Dialysis machine are not available. Deficiency remains as it is.
- 5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 9(Nine) seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

Note: The college be directed that in future the admission should be restricted to maximum permissible 12 seats. (The institute is having 9 degree and 12 diploma (21 Total) seats in Paediatrics Department)

80. Kerala University of Health Sciences, Thrissur - Recognition of MD(General Medicine) qualification against increased intake from 03 to 04 seats in respect of students being trained at Academy of Medical Sciences, Pariyaram, Kannur.

Read: the Compliance Verification Assessment Report (22/03/2017) along with the Council Assessor's Report (July, 2015 & 06.06.2016) and compliance dated 27/12/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 03 to 04 seats at Academy of Medical Sciences, Pariyaram, Kannur granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (22/03/2017) along with the Council Assessor's Report (July, 2015 & 06.06.2016) and compliance dated 27/12/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(General Medicine) qualification against increased intake from 03 to 04 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Academy of Medical Sciences, Pariyaram, Kannur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.
