1. Minutes of the last meeting of the Postgraduate Medical Education Committee - confirmation of.

The Postgraduate Medical Education Committee confirmed the minutes of the Postgraduate Medical Education Committee meeting held on 24/04/2018.

2. Minutes of the last meeting of the Postgraduate Medical Education Committee - action taken thereon.

The Postgraduate Medical Education Committee noted the approval from the Oversight Committee received vide their email dated 04.05.2018 and action will be taken by the office accordingly.

3. **Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar - Renewal of recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 03 seats in respect of students being trained at Government Medical College, Bhavnagar.**

Read: the Council Assessor's Report (27.03.2018) on the standard of examination and other teaching facilities for renewal of recognition of MD(Social & Preventive Medicine/Community Medicine) qualification for 03 seats at Govt. Medical College, Bhavnagar granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (27.03.2018) and decided to recommend not to renew the recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 03 seats granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar because of the following facts:-

1. There is no Professor.
2. Deficiency of faculty: (a) Professor: 1; (b) Asst. Prof.: 1; (c) Epidemiologist cum Asst. Prof.: 1; (d) Tutor: 2.
3. Equipment like Spirometry, Ophthalmoscope, Infantometer are not available.
4. RHTC: Dean's control is partial. Details of OPD, Bed Occupancy, deliveries on day of assessment are not provided.
5. Examiners: Details of only 2 Examiners are provided. It is not clear whether the examination was conducted by 2 or 4 Examiners. One of External Examiners is from the same State.
6. Faculty table was not signed by any faculty members.
7. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 3(Three) till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. 1. There is no Professor.
2. Deficiency of faculty: (a) Professor: 1; (b) Assoc. Prof.: 2; (c) Asst. Prof.: 3.
3. Dr. Shilpa Doshi, Assoc. Prof. & Dr. Ravikumar Parmar, Asst. Prof. have appeared for UG assessment at GMERS Medical College, Junagadh during December 2017; hence cannot be considered.
4. I/c HOD is Dr. Lopa Trivedi who is Assoc. Prof.
5. Details of Major Operations on day of assessment are not provided.
6. Details of ICU Beds Occupied on day of assessment are not provided.
7. NIL book has been purchased for Departmental Library during last 3 years.
8. CPC is not held.
9. On the day of assessment MRI in the entire hospital were only 2 and CT Scan only 8, which indicates inadequate clinical material.
10. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2(Two) till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

1. Deficiency of faculty: (a) Assoc. Prof.: 1; (b) Asst. Prof.: 4.
2. Unit 2 has only 1 faculty; hence it cannot be considered as a teaching Unit.
3. Unit 3 has Nil faculty; hence it cannot be considered as a Unit.
4. OPD attendance upto 2 p.m. on day of assessment is only 94.
5. Details of Radiological & Laboratory investigations on day of assessment are not provided.
6. PICU has 4 beds against requirement of 5.
7. Equipment like Echo, Colour Doppler is not available in the department.
8. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 04 seats in MD(Paediatrics) & 1(One) seat in DCH till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Council Assessor's Report (28.03.2018) and decided to recommend not to renew the recognition of DLO qualification for 01 seat granted by Maharaja Krishnakumarsinghi Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar because of the following facts:-

1. The only Professor, Dr. Vikas Sinha is also holding the charge of Medical Superintendent. There is no another Professor.

2. There is NIL Assoc. Prof. in the only Unit; resultantly faculty complement is incomplete & it cannot be considered as PG Unit.
3. Incharge HOD is Dr. Bhagirath D. Parmar who is only Asst. Prof. which is not permissible.
4. NIL book has been purchased for Departmental Library during last 3 years.
5. Equipment like Microdebrider for Sinus Surgeries, High Definition Digital Camera with Recording System, OAE, BERA, Nerve stimulator are not functional.
6. On the day of assessment MRI in the entire hospital were only 2 and CT Scan only 8, which indicate inadequate clinical material.
7. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 1(One) till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Council Assessor's Report (06.04.2018) and decided to recommend not to renew the recognition of DCP qualification for 02 seats granted by Maharaja Krishnakumarsinghi Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar because of the following facts:-

1. There is no Professor.
2. Dr. Shaila N. Shah, Professor has appeared for UG assessment at Vadnagar during the same Academic year; hence cannot be considered. Further, although she is promoted as Professor after cut-off date; in the column of "Benefit of publications", it is stated "No" implying NIL publication. Hence not eligible.
3. Dr. Alpesh Goswami, Asso. Prof. has appeared for UG assessment at Vadnagar during the same academic year; hence cannot be considered.

4. As per faculty table signed by Dean, both the above mentioned faculty members (Sr. No.2 & 3) have been shown to be continuously working in this college. It is not understood that how they appeared in MCI assessment in December, 2017 at GMERS Medical College, Vadanagar. If they were posted for a short period, it means they were only sent for MCI Assessment, which amounts to misleading the Council.
5. Deficiency of faculty: (a) Professor: 1; (b) Assoc. Prof.: 2.
6. Equipment like HPLC is not functional.
7. Workload of CT guided FNAC is only 09 during 2017.
8. Workload of TT investigation in 2017 is NIL.
9. One of Internal Examiners is Dr. Ravindra Jadeja who is Professor of Microbiology which is not permissible.
10. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2(Two) till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Council Assessor's Report (26.03.2018 (for degree) and 27.03.2018 (for diploma) and decided to recommend not to renew the recognition of MS(OBG) qualification for 02 seats and DGO qualification for 01 seat granted by Maharaja Krishnakumarsinghi Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar because of the following facts:-

1. Deficiency of faculty: (a) Asst. Prof.: 2.

2. Promotion of Dr. G.K. Kadikar, Professor, is not as per regulations. He was promoted on 08.03.2017 after the cut off date without any 4 required research publications in indexed journals.
3. Dr. Medha Kanani, Asst. Prof. in Unit A is designated as Asst. Prof. & ANMO. She is 3rd faculty member in the Unit. As there is no other Asst. Prof. in the Unit, it implies that ANMO is not available.
4. Dr. Aditi Vithal, Asst. Prof. in Unit B is designated as Asst. Prof. & MCHO. She is 2nd faculty member in the Unit. As there is no other Asst. Prof. in the Unit, it implies that MCHO is not available.
5. Units B, C have only 2 faculty each; hence they cannot be considered as PG Units.
6. Details of beds occupied in HDU on day of assessment are not provided.
7. ART service is not available.
8. NIL new book has been purchased for Departmental library during last 3 years.
9. On the day of assessment MRI in the entire hospital were only 4, which indicates inadequate clinical material.
10. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. MS(OBG) for 02 seats and DGO for 01 seat till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Council Assessor's Report (16.04.2018) and decided to recommend to the Central Government that MD(General Medicine) qualification for 02 seats granted by Siksha O Anusandhan University, Bhubaneswar in respect of students being trained at Institute of Medical Sciences & SUM Hospital, Bhubaneswar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

11. Saurashtra University, University Road, Rajkot - Renewal of recognition of MS(ENT) qualification for 03 seats in respect of students being trained at M. P. Shah Medical College, Jamnagar, Gujarat.

3. Medico Legal cases in casualty are dealt by CMOs. Department of Forensic Medicine is not conducting medico-legal examination on regular basis.

5. Faculty table is not signed by any faculty members.
6. MRD: ICD X classification for indexing of diseases is not followed.

2. In the column "Stipend paid by Institution", it is stated "---" which implies that it is not clear whether stipend to Residents is being paid by the Institute which needs to be clarified.
3. Other deficiencies as pointed out in the assessment report.

4. Examiners are appointed from such colleges where M.D. course has not yet been started; hence details of their PG teaching experience are not available.
5. RHTC: Average Daily Bed Occupancy is NIL. Average Deliveries are only 05-1/month. Bed Occupancy on day of assessment was ZERO.
6. Dr. Naresh R Makwana, Professor, appeared in MCI Assessment at Junagarh in December, 2017. (same academic year). Hence he cannot be considered.

2. Dr. N. Vamsi Krishna is shown as Senior Resident in the table of available teachers at Item § 4 of Summary; however details of his qualification & experience are not provided in the faculty table without which his eligibility cannot be decided.
3. Details of Investigative workload on day of assessment are not provided.
4. Workload of the following investigations has decreased from 2015 to 2017 as under:

4. Nursing staff is inadequate in general wards.
5. MRD is in very poor condition in unhygienic environment.

1. Promotion of Dr. Vinayak Vishnu Raje, Professor, is not as per regulations. He was promoted on 02.12.2017 after the cut off date without 4 required research publications in indexed journals.
2. Dr. Sunil R. Yadav is promoted as Professor after cut-off date; however the column "Benefit of publications" in the faculty table is left blank implying NIL publication against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered. Further, date of Appointment Order

is immaterial as he has joined as Professor w.e.f. 01/08/2013 - i.e. after cut-off date & he was in continuous service at this Institute w.e.f. 01/04/1995& as Assoc. Prof. upto 31/07/2013. 1. Promotion of Dr. K. Boopathi, Professor, is not as per regulations. He was promoted on 23.12.2017 after the cut off date. He has no publications against the required 4 in indexed journals. In earlier report his promotion was from 17.02.2015 and there are no revised promotion orders and fresh joining report.
2. On assessment day OPD was 49 only.
3. Skin Bank is still not available.
4. On assessment day MRI in the entire hospital was only 8, which indicates inadequate clinical material.
5. Other deficiencies as pointed out in the assessment report.

4. With regard to inadequate workload of several operations as shown in earlier assessment report, no compliance is submitted as such as to how the workload has increased or how the deficiency is rectified.
5. Other deficiencies as pointed out in the assessment report.

4. OPD attendance upto 2 p.m. on day of assessment was 94.
5. No other Specialty clinic except CTEV clinic is conducted.
6. Facility for Knee Replacement Surgery is not available.
7. Arthroscopy is not available.
8. There are 2 Tables in the O.T. which is not as per norms.
9. IPD has decreased from 3640 in 2016 to 3126 in 2017.
10. Casualty beds are only 16 against the required 25.
11. Other deficiencies as pointed out in the assessment report.

2. Dr. Bharathi E, Asst.Prof. is not eligible. She is DNB from non-teaching hospital and she has no 3 years experience as Jr. Resident in a teaching hospital when appointed Assistant Professor.
3. Dr. Suchithra J, Sr. Resident, is not eligible, she is DNB from non teaching hospital and she has no 3 years experience as Jr. Resident in a teaching hospital when appointed Sr.Resident.
4. Other deficiencies as pointed out in the assessment report.

Read: the Compliance Verification Assessment Report (07.03.2018) and Council Assessor's Report (June, 2017) on the standard of examination and other teaching facilities for Renewal of recognition of MD(Microbiology) qualification for 05 seats at SCB Medical College, Cuttack granted by Utkal University, Orissa.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (07.03.2018) and Council Assessor's Report (June, 2017) and decided to recommend to the Central Government that the recognition of MD(Microbiology) qualification for 05 seats granted by Utkal University, Orissa in respect of students being trained at SCB Medical College, Cuttack be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

35. Ch. Charan Singh University - Recognition of MD(Pathology) qualification for 4 seats in respect of students being trained at Saraswati Institute of Medical Sciences, Hapur.

Read: the Compliance Verification Assessment Report (03.04.2018) and Council Assessor's Report (September, 2017) on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification for 4 seats at Saraswati Institute of Medical Sciences, Hapur granted by Ch. Charan Singh University.

The Postgraduate Medical Education Committee considered the compliance Verification Assessment Report (03.04.2018) and Council Assessor's Report (September, 2017) and decided to recommend not to recognize MD(Pathology) qualification for 4

seats granted by Ch. Charan Singh University in respect of students being trained at Saraswati Institute of Medical Sciences, Hapur because of the following facts:-

1. Dr. Jayant K. Jha, was demoted as Assoc.Prof. on 10.11.2017 which he accepted with protest against it, it means he has not accepted the demotion. After this he has been promoted on 16.02.2016 after the cut off date without required 4 research publications. He cannot be considered.
2. Equipment like HPLC is not available in the department. Deficiency remains as it is.
3. Pathological post-mortems are not performed. Deficiency remains as it is.
4. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 4(Four) after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

36. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Renewal of recognition of DM(Neurology) qualification for 02 seats in respect of students being trained at Narayana Medical College, Nellore.

Read: the Compliance Verification Assessment Report (28.03.2018) and Council Assessor's Report (July, 2017) on the standard of examination and other teaching facilities for Renewal of recognition of DM(Neurology) qualification for 02 seats at Narayana Medical College, Nellore granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (28.03.2018) and Council Assessor's Report (July, 2017) and decided to recommend to the Central Government that the recognition of DM(Neurology) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Narayana Medical College, Nellore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

37. NIMS University (Deemed University), Jaipur - Recognition of M.Ch (Urology) qualification for 1 seat in respect of students being trained at National Institute of Medical Science & Research, Jaipur.

Read: the Compliance Verification Assessment Report (05.04.2018) and Council Assessor's Report (October, 2017) on the standard of examination and other teaching facilities for Recognition of M.Ch (Urology) qualification for 1 seat at National Institute of Medical Science & Research, Jaipur granted by NIMS University (Deemed University), Jaipur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05.04.2018) and Council Assessor's Report (October, 2017) and decided to recommend to the Central Government that M.Ch.(Urology) qualification for 1 seat granted by NIMS University (Deemed University), Jaipur in respect of students being trained at National Institute of Medical Science & Research, Jaipur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

38. Dr. Ram Manohar Lohia Avadh University, Faizabad - Recognition of Recognition of MD(Paediatrics) qualification against increased intake from 2 to 4 Seats and Renewal of recognition of DCH qualification for 2 seats in respect of students being trained at Era's Lucknow Medical College, Lucknow.

Read: the Compliance Verification Assessment Report (04.04.2018) and Council Assessor's Report (August, 2015 & 13.02.2017) on the standard of examination and other teaching facilities for Recognition of Recognition of MD(Paediatrics) qualification against increased intake from 2 to 4 Seats and Renewal of recognition of DCH qualification for 2 seats at Era's Lucknow Medical College, Lucknow granted by Dr. Ram Manohar Lohia Avadh University, Faizabad.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (04.04.2018) and Council Assessor's Report (August, 2015 & 13.02.2017) and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 2 to 4 Seats and not to renew the recognition of DCH qualification for 2 seats granted by Dr. Ram Manohar Lohia Avadh University, Faizabad in respect of students being trained at Era's Lucknow Medical College, Lucknow because of the following facts:-

1. Dr. Uma Shankar Prasad, Professor, was not available on the day of assessment.
2. Promotion of Dr. Mohd. Islam, Professor, is not as per regulations. He was promoted on 02.09.2014 after the cut off ate without 4 required research publications in indexed journals. His Declaration Form is not attached.
3. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2(Two) of DCH till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate

Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

Admissions done (if any) against these increased number of seats i.e. increased intake from 2 to 4 seats of MD(Paediatrics) after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

39. Vinayaka Mission's University, salem - Recognition of MD(Paediatrics) qualification against increased intake from 02 to 04 seats in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem.

Read: the Compliance Verification Assessment Report (12.04.2018) and Council Assessor's Report (April 2014, April, 2016 & 10.02.2017 & 12.09.2017) on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification against increased intake from 02 to 04 seats at Vinayaka Mission's Kirupananda Variyar Medical College, Salem granted by Vinayaka Mission's University, salem.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (12.04.2018) and Council Assessor's Report (April 2014, April, 2016 & 10.02.2017 & 12.09.2017) and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 02 to 04 seats granted by Vinayaka Mission's University, salem in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

40. Teerthanker Mahaveer University, Moradabad - Recognition of MD(General Medicine) qualification for 4 seats in respect of students being trained at Teerthanker Mahaveer Medical College and Research Centre, Moradabad.

Read: the Compliance dated 06.01.2018, 04.12.2017 and Council Assessor's Report (July, 2017) on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification for 4 seats at Teerthanker Mahaveer Medical College and Research Centre, Moradabad granted by Teerthanker Mahaveer University, Moradabad.

The Postgraduate Medical Education Committee considered the Compliance dated 06.01.2018, 04.12.2017 and Council Assessor's Report (July, 2017) and decided to recommend to the Central Government that MD(General Medicine) qualification for 4 seats granted by Teerthanker Mahaveer University, Moradabad in respect of students being trained at Teerthanker Mahaveer Medical College and Research Centre, Moradabad be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

41. Ranchi Instt. Of Neuro-Psychiatry and Allied Sciences,Kanke (Deemed University), Jharkhand - Recognition of MD(Psychiatry) & DPM qualification for 01 seat in each course in respect of students being trained at Ranchi Instt. Of Neuro-Psychiatry and Allied Sciences,Kanke,Ranchi.

Read: the Compliance dated 08.01.2018, 13.11.2017 and 08.08.2017 and Council Assessor's Report (November, 2013) on the standard of examination and other teaching facilities for Recognition of MD(Psychiatry) & DPM qualification for 01 seat in each course at Ranchi Instt. Of Neuro-Psychiatry and Allied Sciences,Kanke,Ranchi granted by Ranchi Instt. Of Neuro-Psychiatry and Allied Sciences, Kanke (Deemed University), Jharkhand.

The Postgraduate Medical Education Committee considered the Compliance dated 08.01.2018, 13.11.2017 and 08.08.2017 and Council Assessor's Report (November, 2013). In light of recent Gazetted Notification dated 05.04.2018 PG Committee decided to recommend to the Central Government that MD(Psychiatry) & DPM qualifications for 01 seat in each granted by Ranchi Instt. of Neuro-Psychiatry and Allied Sciences, Kanke (Deemed University), Jharkhand in respect of students being trained at Ranchi Instt. Of Neuro-Psychiatry and Allied Sciences, Kanke, Ranchi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 for the admissions made till the academic year 2018-19.

The Committee further decided that as per existing amendment dated 05.04.2018 in Postgraduate Medical Education Regulations, 2000, the college is directed to stop admissions in the aforesaid courses from the academic year i.e. 2019-20.

42. Banaras Hindu University - Recognition of MD(Radiotherapy) qualification against increased intake from 1 to 3 seats in respect of students being trained at Institute of Medical Sciences, BHU, Varansi.

Read: the Compliance dated 12.01.2018, 04.10.2017 and Council Assessor's Report (July, 2017) on the standard of examination and other teaching facilities for Recognition of MD(Radiotherapy) qualification against increased intake from 1 to 3 seats at Institute of Medical Sciences, BHU, Varansi granted by Banaras Hindu University.

The Postgraduate Medical Education Committee considered the compliance dated 12.01.2018, 04.10.2017 and Council Assessor's Report (July, 2017) and decided to verify the compliance by way of an assessment.

The Committee further decided that all deficiencies pointed out in its meeting held on 03.07.2017 be listed in the letter to be sent to the Assessor.

43. MGM Institute of Health Sciences, Navi Mumbai - Recognition of MD(Immuno Haematology & Blood Transfusion) qualification for 1 seat in respect of students being trained at MGM Mission's Medical College, Navi Mumbai.

Read: the compliance dated 20.12.2017, Compliance Verification Assessment Report (15.09.2017) and Council Assessor's Report (May, 2017) on the standard of examination and other teaching facilities for Recognition of MD(Immuno Haematology & Blood Transfusion) qualification for 1 seat at MGM Mission's Medical College, Navi Mumbai granted by MGM Institute of Health Sciences, Navi Mumbai.

The Postgraduate Medical Education Committee considered the compliance dated 20.12.2017, Compliance Verification Assessment Report (15.09.2017) and Council Assessor's Report (May, 2017) and decided to recommend to the Central Government that MD(Immuno Haematology & Blood Transfusion) qualification for 1 seat granted by MGM Institute of Health Sciences, Navi Mumbai in respect of students being trained at MGM Mission's Medical College, Navi Mumbai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

44. Maharashtra University of Health Sciences, Nashik - Renewal of recognition of MD(Community Medicine) qualification for 2 seats in respect of students being trained at N.K.P.Salve Institute of Medical Sciences & Research Centre & Lata Mangeshkar Hospital, Nagpur.

Read: the compliance dated 18.01.2018, Council Assessor's Report (July, 2017) on the standard of examination and other teaching facilities for Renewal of recognition of MD(Community Medicine) qualification for 2 seats at N.K.P.Salve Institute of Medical Sciences & Research Centre & Lata Mangeshkar Hospital, Nagpur granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the compliance dated 18.01.2018, Council Assessor's Report (July, 2017) and decided to recommend to the Central Government that the recognition of MD(Community Medicine) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at N.K.P.Salve Institute of Medical Sciences & Research Centre & Lata Mangeshkar Hospital, Nagpur be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

45. Rajasthan University of Health Sciences, Jaipur - Renewal of recognition of MD(Microbiology) qualification for 2 seats in respect of students being trained at SP Medical College,Bikaner.

Read: the compliance dated 25.02.2018, 06.12.2017 and Council Assessor's Report (July, 2017) on the standard of examination and other teaching facilities for Renewal of recognition of MD(Microbiology) qualification for 2 seats at SP Medical College,Bikaner granted by Rajasthan University of Health Sciences, Jaipur.

The Postgraduate Medical Education Committee considered the compliance dated 25.02.2018, 06.12.2017 and Council Assessor's Report (July, 2017) and decided to recommend to the Central Government that the recognition of MD(Microbiology) qualification for 2 seats granted by Rajasthan University of Health Sciences, Jaipur in respect of students being trained at SP Medical College,Bikaner be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

46. Statutory Autonomous Delhi, Institute of Liver and Biliary Sciences, New Delhi - Recognition of DM(Organ Transplant Anaesthesia & Critical Care) qualification for 01 seat in respect of students being trained at Institute of Liver and Biliary Sciences, New Delhi.

Read: the compliance dated 05.03.2018, Compliance Verification Assessment Report (11.12.2017) and Council Assessor's Report (July, 2016) on the standard of examination and other teaching facilities for recognition of DM(Organ Transplant Anaesthesia & Critical Care) qualification for 01 seat at Institute of Liver and Biliary Sciences, New Delhi granted by Statutory Autonomous Delhi, Institute of Liver and Biliary Sciences, New Delhi.

The Postgraduate Medical Education Committee considered the compliance dated 05.03.2018, Compliance Verification Assessment Report (11.12.2017) and Council Assessor's Report (July, 2016) and decided to recommend to the Central Government that DM(Organ Transplant Anaesthesia & Critical Care) qualification for 01 seat granted by Statutory Autonomous Delhi, Institute of Liver and Biliary Sciences, New Delhi in respect of students being trained at Institute of Liver and Biliary Sciences, New Delhi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

47. Aryabhatta Knowledge University, Patna - Renewal of recognition of DA qualification for 8 seats in respect of students being trained at Patna Medical College, Patna.

Read: the compliance dated 28.02.2018 and Council Assessor's Report (June, 2017) on the standard of examination and other teaching facilities for renewal of

recognition of DA qualification for 8 seats at Patna Medical College, Patna granted by Aryabhata Knowledge University, Patna.

The Postgraduate Medical Education Committee considered the compliance dated 28.02.2018 and Council Assessor's Report (June, 2017) and decided to recommend to the Central Government that the recognition of DA qualification for 8 seats granted by Aryabhata Knowledge University, Patna in respect of students being trained at Patna Medical College, Patna be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

48. D.D.U. Gorakhpur University, Gorakhpur, Uttar Pradesh - Recognition of MD(Pathology) qualification against increased intake from 2 to 3 seats in respect of students being trained at BRD Medical College, Gorakhpur.

Read: the compliance dated 07.03.2018 and Council Assessor's Report (July, 2017) on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification against increased intake from 2 to 3 seats at BRD Medical College, Gorakhpur granted by D.D.U. Gorakhpur University, Gorakhpur, U.P.

The Postgraduate Medical Education Committee considered the compliance dated 07.03.2018 and Council Assessor's Report (July, 2017) and decided to recommend to the Central Government that MD(Pathology) qualification against increased intake from 2 to 3 seats granted by D.D.U. Gorakhpur University, Gorakhpur, U.P. in respect of students being trained at BRD Medical College, Gorakhpur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

49. C.S.J.M. University, Kanpur- GSVM Medical College, Kanpur with regard to recognition of Diploma in Cardiology in respect of students being trained at GSVM Medical College, Kanpur- representation received through Central Govt. Ministry of Health & Family Welfare - comments regarding.

Read: the representation dated 01.11.2017 alongwith legal opinion 16.04.2018 with regard to sending comments to Ministry in respect of students being trained at GSVM, Medical College, Uttar Pradesh.

The Postgraduate Medical Education Committee considered the representation dated 01.11.2017 alongwith legal opinion 16.04.2018 with regard to recognition of Diploma in Cardiology in respect of students being trained at GSVM Medical College, Kanpur and noted the opinion of the Law Officer, which reproduced as under:-

".....9. Moving on further, comments as sought by the Ministry on the representation of Dr. Rajesh Kumar Srivastava and Dr. Rakesh Singh is required to be furnished in the light of statutory provisions and the case-law referred in the representation. The request of Dr. Rajesh Kumar Srivastava and Dr. Rakesh Singh for inclusion of the Diploma in

Cardiology qualification in the First Schedule of the Indian Medical Council Act, 1956 cannot be considered for the following reasons:-

Firstly, section 11 of the Indian Medical Council Act, 1956 mandates that the University of medical institution in India which grants a medical qualification not included in the First Schedule to make apply to the Central Government for inclusion in the First Schedule and the Central Government after consulting the Council by notification in the Official Gazette has to include such qualification. Till date, there is no such application of GSVM Medical College through Kanpur University. The Principal of the GSVM Medical College has stated in his letter dated 20.01.18 to the Registrar, CSJM Kanpur University that the forwarding of the representation does not seem to be against Rules, and the Registrar of the University has only forwarded the representation. Thus the procedure as contemplated under section 11 of the IMC Act, 1956 while the course was offered during 1974 to 1993 has not been observed by the authorities of GSVM Medical College and Kanpur University.

Secondly, it was incumbent upon the Kanpur University and GSVM Medical College, Kanpur to run the course in accordance with the Recommendations of the Postgraduate Medical Education Committee of the Council. Council's recommendations dating back to 1965 are to the effect that Cardiology is a higher specialty course for which only MD pass-outs were eligible. The same position is reaffirmed in the recommendations of PGMEC in 1971, that governed the field until the formulation of Postgraduate Medical Education Regulations, 2000.

Thirdly, the nomenclature of the courses was required to be in accordance with that set by the Council. This has been done by the PGMEC in exercise of its responsibility under section 20 of the IMC Act to secure uniform standards of medical education for postgraduate medical education throughout India. DM (Cardiology) is the prescribed nomenclature for higher/super specialty of Cardiology not "Diploma in Cardiology" and the recommendations of the PGMEC governing the field during the period under reference, i.e., 1974 to 1993 did not provide for any Diploma course by the name Diploma in Cardiology.

Fourthly, the order of the Hon'ble Uttar Pradesh Public Service Tribunal in Dr. Chiranjee Lal vs. State of U.P. & Ors. is based upon the understanding of UP Govt. GO of 1964 that provided for recognition of degree and diploma awarded by the University established by law in India. The order of the UP PST categorically records that the "postgraduate diploma possessed by the petitioner as well as O.P. no. 6 have been awarded by the Universities established under an Act of the State. Therefore, the diploma awarded by Kanpur as well as Meerut Universities shall be deemed to have been automatically recognized, **even if they are not recognized by the Medical Council of India**". Further, the order relates only about the fairness of the recommendation made by the Departmental Promotion Committee. The appeal before the Hon'ble High Court and Hon'ble Supreme Court was in relation to the aspect of promotion in the State Medical Cadre of Specialist and does not come to the aid of applicants for inclusion of the qualification of Diploma in Cardiology in the First Schedule of IMC Act, 1956.

10. The aforesaid may be if deemed appropriate with the approval of PGMEC be communicated to the Central Govt. as comments and observations of the Council."

The Committee decided to approve legal opinion of Law Officer & inform Central Government accordingly.

50. **King Georges Medical University, Lucknow - Recognition of M.Ch.(Surgery Gastroenterology) qualification for 2 seats in respect of students being trained at Command Hospital, Lucknow.**

Read: the representation dated 16.01.2018 alongwith legal opinion 11.03.2018 with regard to sending comments to Ministry in respect of students being trained at Command Hospital, Lucknow.

The Postgraduate Medical Education Committee considered the representation dated 16.01.2018 alongwith legal opinion 11.03.2018 with regard to recognition of M.Ch.(Surgical Gastroenterology) qualifications in respect of students being trained at Command Hospital, Lucknow and perused the legal opinion of the Law officer, which is reproduced as under:-

“The file of Command Hospital, Lucknow for recognition of M.Ch Surgical Gastroentology has been referred for my opinion. The issue identified in the pre-page note is that the Institute was granted Letter of Permission for starting the course in 2012. Thereafter, at the time of final examination inspection was conducted and the College was directed to submit compliance. The Institute had decided to close the course. The PG Committee has decided to seek my opinion “about recognition of one batch which was admitted in 2012.”

2. *It may be noted that on 05.04.2018 amendments have been made in Postgraduate Medical Education Regulations, 2000 vide Postgraduate Medical Education (Amendment) Regulation, 2000 notified on 05.04.2018. It is submitted that Regulation 6 (2) of the above-mentioned amended Regulation provides that the degrees of the students admitted in the first four batches of the Post Graduate Degree Course and first three batches of Post Graduate Diploma Courses shall be recognized in the event the college fails to rectify the deficiencies. The relevant portion of the amended Regulations is as under:*

“(2) The Institution shall apply for recognition of the Post Graduate Medical qualification to the Central Government through the affiliating University, when the first admitted batch shall be due to appear for the examination to be conducted by the affiliating University.

In the event of deficiencies being found in the assessment, the Institution shall be granted an opportunity to submit compliance within 30 days from the date of communication of deficiencies by the Council. Such an opportunity to comply with the deficiencies shall be availed by the Institute only twice. The Postgraduate Medical Education Committee on finding the compliance satisfactory shall convey the recommendation to recognize the course. In all others cases, the prior permission of the Central Government granted under sub-clause (1) shall be deemed to have lapsed after four and three years for Postgraduate Degree/Postgraduate Diploma courses respectively. Further, in such cases; recommendation shall be made to the Central Government to include the qualifications in the First Schedule of the Indian Medical Council Act, 1956 only in respect of first four batches of Postgraduate Degree Courses and three batches of Postgraduate Diploma courses....”

3. *The Postgraduate Committee in view of the aforesaid provisions should consider recommending to the Central Govt. for recognition of aforesaid course in respect of only the first batch of students admitted in the course.*
4. *The Postgraduate Committee may also take into consideration the above provision in respect of pending recognition matters, so that the students who have passed out should not suffer.”*

In view of the legal opinion of the Law Officer, the Committee decided to recommend to the Central Government that M.Ch.(Surgery Gastroenterology) qualification for 2 seats granted by King Georges Medical University, Lucknow in respect of students being trained at Command Hospital, Lucknow be recognized and included in the 1st Schedule to the I.M.C. Act, 1956. The said course has already been stopped by the institute from the academic year 2013-14.

51. Request of Dr. Sarthak Kamath K. as PH candidate to choose subjects of MD(Radio-Diagnosis, MD(Psychiatry) and MD(Dermatology).

Read: the request of Dr. Sarthak Kamath K. as PH candidate to choose subjects of MD(Radio-Diagnosis, MD(Psychiatry) and MD(Dermatology) alongwith legal opinion.

The Postgraduate Medical Education Committee considered the request Dr. Sarthak Kamath K. as PH candidate to choose subjects of MD(Radio-Diagnosis, MD(Psychiatry) and MD(Dermatology alongwith legal opinion and noted that the matter pertains to request of Dr.Sarthak Kamath K. who is Physically Handicapped candidate for joining M.D. (Courses). Legal opinion of Law Officer is as under:

"It may be noted that on 05.04.2018 amendments have been made in Postgraduate Medical Education Regulations, 2000 vide Postgraduate Medical Education (Amendment) Regulations 2000 notified on 05.04.2018. The recent amendments provide that candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 are entitled for admission in Postgraduate courses in modern medicine. Therefore, in case the disability of Dr. Sarthak falls in the specified disabilities under the 2016 Act he is entitled to pursue postgraduate courses in any discipline of modern medicine."

The PG Committee decided to approve the legal opinion of Law Officer.

The Committee further decided that it is for the admitting authority to decide whether disability of Dr. Sarthak Kamath K falls in the specified disabilities under the 2016 Act or not.

52. (i) **Extension of last date for receipt of applications for starting/increasing the intake capacity of PG seats and**
(ii) **Consideration for the relaxation of experience in Sports Medicine required for appointment to the position of teacher in the Department of Sports Medicine.**

Read: to consider the email dated 19.04.2018 received from the ME(P) Section, Ministry of Health & Family Welfare, New Delhi, letter dated 02.05.2017 from Sh. Amit Biswas, Under Secretary, MoH&FW,GoI & E-mail dated 04/04/2018 from Mr. Devesh Deval, Deputy Secretary, Ministry of Health & Family Welfare, New Delhi with regard to Extension of last date for receipt of applications for starting/increasing the intake capacity of PG seats and (ii) E-mail dated 02/05/2018 from Prof. Dr. G.L. Khanna, Project Director, IISSR, Ministry of Youth Affairs and Sports, New Delhi, letter dated 04.05.2018 from Sh. DVK Rao, Under Secretary, Ministry of Health, Govt. of India as well as DO letter dated 20.04.2018 of Sh. Rahul Bhatnagar, IAS, Secretary, Department of sports Shashtri Bhawan regarding consideration for the relaxation of experience in Sports Medicine required for appointment to the position of teacher in the Department of Sports Medicine.

The Postgraduate Medical Education Committee considered the email dated 19.04.2018 received from the ME(P) Section, Ministry of Health & Family Welfare, New Delhi, letter dated 02.05.2017 from Sh. Amit Biswas, Under Secretary, MoH&FW,GoI & E-mail dated 04/04/2018 from Mr. Devesh Deval, Deputy Secretary, Ministry of Health & Family Welfare, New Delhi with regard to Extension of last date for receipt of applications for starting/increasing the intake capacity of PG seats and noted that the PG Committee at its meeting held on 24.04.2018 had decided to accept the legal opinion, the operative part of which is as under:-

".....it is not permissible for the Council to agree to the request of Central Government for extending the last date for receipt of the applications upto one month. In case the Central Government desires any change in time schedule it may file an appropriate application before the Hon'ble Supreme Court".

The Postgraduate Committee further noted that the Oversight Committee vide e-mail letter dated 04.04.2018 has approved the decision of the Postgraduate Committee

taken at its meeting held on 24.04.2018. Hence, the Committee decided to reiterate its earlier decision and inform the Ministry accordingly.

The Committee further considered the E-mail dated 02/05/2018 from Prof. Dr. G.L. Khanna, Project Director, IISSR, Ministry of Youth Affairs and Sports, New Delhi, letter dated 04.05.2018 from Sh. DVK Rao, Under Secretary, Ministry of Health, Govt. of India as well as DO letter dated 20.04.2018 of Sh. Rahul Bhatnagar, IAS, Secretary, Department of Sports, Shashtri Bhawan regarding consideration for the relaxation of experience in Sports Medicine required for appointment to the position of teachers in the Department of Sports Medicine and noted that there are only 2 or 3 institutes running this course and it is difficult to get faculty with 2 years special training and required experience for teaching posts of Prof. & Assoc.Prof. in Sports Medicine. Keeping in view the importance of Sports Medicine and recent achievements of the Country in International Games, it was resolved that persons with Postgraduate Qualifications and experience in the subjects of Sports Medicine, Orthopaedics, Physical Medicine & Rehabilitation and Physiology be considered eligible for appointment in the department of Sports Medicine.

The minutes of this agenda item were read and confirmed in the meeting itself so as to obtain the approval the Oversight Committee.

The matter be placed before the General Body for information and ratification.

Meeting ended with a vote of thanks to the Chair.
