3. **Saurashtra University, University Road, Rajkot- Recognition of MS(General Surgery) qualification against increased intake from 04 to 06 seats in respect of students being trained at C.U. Shah Medical College & Hospital, Surendra Nagar.**

Read: the Assessment Report (16.04.2018) on the standard of examination and other teaching facilities available at C.U. Shah Medical College & Hospital, Surendra Nagar for purpose of Recognition of MS(General Surgery) qualification against increased intake from 04 to 06 seats granted by Saurashtra University, Rajkot.

The Postgraduate Medical Education Committee considered the Assessment Report (18.04.2018) and decided to recommend not to renew the recognition of MD(Radio Diagnosis/Radiology) qualification for 03 seats granted by Saurashtra University, Rajkot in respect of students being trained at C.U. Shah Medical College & Hospital, Surendra Nagar because of the following facts:-

1. Dr. Gunavant R. Virugama, Senior Resident possesses experience of only 2 y as Resident; further his designation shown in the column of experience is "Tutor" while in the column of "Designation", it is shown as "Senior Resident".
2. Dr. Pratik J. Lakhtaria, Senior Resident possesses experience of only 2 y as Resident; further his designation shown in the column of experience is "Tutor" while in the column of "Designation", it is shown as "Senior Resident".

3. Resultantly, deficiency of Sr. Resident -1.
4. Workload of CT guided FNAC/Biopsy is only 13 in 2017.
5. Workload of Ultra Sound guided FNAC/Biopsy is only 49 in 2017.
6. Workload of DSA in the department during the period of previous 3 y is not provided.
7. One of the external examiners is from same the State.
8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 03 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

Shah Medical College & Hospital, Surendra Nagar be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

10. **Maharaja Krishnakumarsinghi Bhavnagar University, Bhavnagar- Renewal of recognition of MD(Biochemistry) qualification for 03 seats in respect of students being trained at Government Medical College, Bhavnagar.**

Read: the Assessment Report (02.04.2018) on the standard of examination and other teaching facilities available at Government Medical College, Bhavnagar for purpose of Renewal of recognition of MD(Biochemistry) qualification for 03 seats granted by Maharaja Krishnakumarsinghi Bhavnagar University, Bhavnagar.

The Postgraduate Medical Education Committee considered the Assessment Report (02.04.2018) and decided to recommend not to renew the recognition of MD(Biochemistry) qualification for 03 seats granted by Maharaja Krishnakumarsinghi Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar because of the following facts:-

1. Deficiency of faculty: (a) Asso. Prof.: 1; (b) Asst. Prof.: 2; (c) Tutors: 2.
2. Professor & HOD is M.Sc. Ph.D.; there is no other PG teacher holding Medical degree; resultantly there is no faculty who can qualify as PG teacher.
3. Dr. Hina Bariya was appeared in MCI assessment at M.P. Shah Medical College, Jamnagar in December, 2017. Hence, she cannot be counted.
4. Workload of the following investigations has decreased over a period of preceding 3 years:

5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 03 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated

As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Assessment Report (11.04.2018) and decided to recommend not to renew the recognition of MS(General Surgery) qualification for 04 seats granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar because of the following facts:-

1. Deficiency of faculty: (a) Assoc. Prof.: 2; (b) Asst. Prof.: 5 & (c) Sr.Resident-4.
2. Dr. Maitrey Joshi, Sr. Resident, is not eligible. She was appointed on 18.07.2017 and he is not MS.
3. Dr. Swarnim Thakur, Sr.Resident, is not eligible. She was appointed on 05.07.2017 and she is not MS.
4. No details of external examiners and examination have been given.
5. Unit 3 has only 2 faculty; hence it cannot be considered as PG Unit.
6. Details of faculty in Units 4 & 5 are not provided in the faculty table. There is no faculty in these 2 Units; hence they cannot be considered as Teaching Units.
7. Total number of IPD patients has decreased from 11,860 in 2015 to 11,144 in 2017.
8. Total number of Major Operations has decreased from 2,356 in 2015 to 1,888 in 2017.
9. Total number of Minor Operations has decreased from 2,541 in 2015 to 2,171 in 2017.
10. No other Specialty clinic except Neurosurgery clinic is run.
11. Details of books purchased for Departmental Library in last 3 years are not provided.
12. Equipment like Portable USG machine is not functional.
13. On the day of assessment MRI in the entire hospital were only 4, which indicate inadequate clinical material.
14. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 04 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Assessment Report (05.04.2018) and decided to recommend not to renew the recognition of Diploma in Community Medicine qualification for 02 seats granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar because of the following facts:-

1. Details of Head of Department are not provided at Item § 2 of Summary implying there is no HOD which is not permissible.
2. There is no Professor.
3. Deficiency of faculty: (a) Professor: 1; (b) Asst. Prof.: 2; (c) Tutor: 2.
4. RHTC: Control of Dean is partial. Details of Paramedical staff are not provided. There was NIL Delivery on day of assessment. LMO is not available.
5. No details of internal examiners have been given.
6. There is no Statistician only Statistical Assistant is available.
7. There is no Epidemiologist.
8. Postgraduate teaching programme register is not maintained.
9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. The Postgraduate Medical Education Committee considered the Assessment Report (27.04.2018) and decided to recommend to the Central Government that MD(Anaesthesiology) qualification against increased intake from 04 to 06 seats granted by Siksha O Anusandhan University, Bhubaneswar in respect of students being trained at Institute of Medical Sciences & SUM Hospital, Bhubaneswar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

14. Siksha O Anusandhan University, Bhubaneswar- Recognition of MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 02 seats in respect of students being trained at Institute of Medical Sciences & SUM Hospital, Bhubaneswar.

Read: the Assessment Report (27.04.2018) on the standard of examination and other teaching facilities available at Institute of Medical Sciences & SUM Hospital, Bhubaneswar for purpose of Recognition of MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 02 seats granted by Siksha O Anusandhan University, Bhubaneswar.

The Postgraduate Medical Education Committee considered the Assessment Report (27.04.2018) and decided to recommend not to recognize MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 02 seats granted by Siksha O Anusandhan University, Bhubaneswar in respect of students being trained at Institute of Medical Sciences & SUM Hospital, Bhubaneswar because of the following facts:-

1. Permission for conducting Medico-Legal post-Mortems is not available.
2. Mortuary & Sexual offences Examination Laboratory are not available.
3. There is NIL workload pertaining to Medico-Legal post-mortems & other Medico-Legal work.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

4. Units 6, 7 have only 1 faculty each; hence they cannot be considered as Teaching Units.
5. As many as 10 faculty have also appeared during MCI assessment at several medical colleges in Gujarat during the current Academic Year as detailed in the report.
6. Dr. Tarun Rochlani is appointed as Senior Resident on 10/07/2017; however he possesses only MBBS qualification; hence not qualified to hold the post. There is no other Senior Resident in the Unit.

6. Total number of Operative Deliveries has decreased from 128 to 47 during the preceding 3 year period.

6. Column 7 pg.37 about faculty which appeared in MCI assessment in other medical colleges during the last 2 years have been left blank.
7. Workload related with Biopsies from patients within the hospital has decreased from 3,182 in 2015 to 2,967 in 2017.

Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. The Postgraduate Medical Education Committee considered the Compliance verification Report (20.04.2018) and Council Assessor's Report(s) (August, 2016, 23.03.2017 & 29.08.2017) and decided to recommend not to recognize MD(Radiodiagnosis) qualification against increased intake from 1 to 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Bombay Hospital Institute of Medical Sciences, Mumbai Bombay Hospital because of the following facts:-

1. There is deficiency of Sr. Resident -2. Two of the Three Sr. Resident who are DNB are not eligible. They have passed DNB from non-teaching hospital and they have no 3 years experience as Jr. Resident in a teaching hospital when appointed Sr. Resident.
2. Deficiency with regard to inadequate workload of US guided FNAC & of CT guided FNAC remains as it is.
3. Deficiency with regard to inadequate workload of MRI & USG remains as it is.
4. Clinical workload is inadequate.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 2 seats after the first batch appeared in Examination till their recognition will be irregular/

illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

31. Vinayaka Mission's University, Salem - Renewal of Recognition of MD(DVL) qualification for 01 seat in respect of students being trained at Aarupadai Veedu Medical College & Hospital, Puducherry.

1. The only Unit has only 2 faculty; resultantly faculty complement is incomplete & it cannot be considered as PG Unit.
2. Deficiency of faculty: (a) Asst. Prof.: 1.
3. A few IP admissions were unwarranted.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 01 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. Medical College, Bangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

33. Vinayaka Missions University (Deemed), Salem - Renewal of Recognition of D.Ortho qualification for 2 seats in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem.

Read: the Compliance verification Report (24.04.2018) and Council Assessor's Report(s) (June, 2017) on the standard of examination and other teaching facilities available for Renewal of recognition of D.Ortho qualification for 2 seats at Vinayaka Mission's Kirupananda Variyar Medical College, Salem granted by Vinayaka Mission's University, Salem.

The Postgraduate Medical Education Committee considered the Compliance verification Report (24.04.2018) and Council Assessor's Report(s) (June, 2017) and decided to recommend not to renew the recognition of D.Ortho qualification for 2 seats granted by Vinayaka Mission's University, Salem in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem because of the following facts:-

1. It is stated that Orthopaedics department also manages another Superspecialty hospital in the premises. It is not clear whether it is managed by separate staff or by the same faculty of the department.
2. On day of assessment, only 1 Minor Operation was performed in the main hospital.
3. On an average, operative workload is 1-2 which is inadequate.
4. There was NIL freshly fractured patient admitted as IPD.
5. OPD attendance upto 1 p.m. was only 83.
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. The Postgraduate Medical Education Committee considered the Compliance verification Report (25.04.2018) and Council Assessor's Report(s) (May, 2014, 05.10.2015, 26.09.2016, 30.03.2017 & 05.10.2017) and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 01 to 02 seats granted by Sri Siddhartha University, Tumkur in respect of students being trained at Sri Siddhartha Medical College, Tumkur because of the following facts:-

1. Promotion of Dr. K.B. Rangaswamy, Prof. & Head, is not as per regulations. He was promoted on 22.03.2014 after the cut off date without any required publications.
2. Bed Occupancy at 10 a.m. on day of assessment was 5.55 % (Total 5 patients on 90 beds) on day of assessment.
3. Computer Register showed registration of 110 patients; however physically only 3 patients had attended Paediatric OPD till 11 a.m. There is Data mismatch.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 01 to 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 1. Dr. K.B. Yadavendra Reddy, Professor & HOD Designate was absent on day of present assessment. He was absent during previous assessment as well.
2. Dr. Sasi Bhushan Reddy, Asst. Prof. was absent on day of present assessment. He was absent during previous assessment as well.
3. Dr. Sureshwara Reddy, Assoc.Prof. was not available on assessment day. Resultantly, Unit-IV left only 2 faculty.
4. Unit I has only 2 faculty; hence it cannot be considered as PG Unit.
5. Unit II is headed by Asst. Prof. which is not permissible; hence it cannot be considered as a Teaching Unit.
6. Only 2 faculty were present in Unit IV; hence it cannot be considered as PG Unit.
7. MRI is not available.
8. On Assessment day OPD and IPD data of the department is not provided.
9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 03 after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 1. Dr. Aleksha Thakur, Asst.Prof., is not eligible. He is DNB from non-teaching hospital. He has no 3 years experience as resident from a teaching hospital when appointed first as Sr. Resident and later Asst.Prof.

2. Dr. Reeta Agrawal, Sr. Resident, is not eligible. She is DNB from non-teaching hospital. She has no 3 years experience as Jr. Resident from a teaching hospital when appointed as Sr. Resident.
3. Dr. Lakshmi Sailaja P, Sr. Resident, is not eligible. She has no 3 years experience as Jr. Resident from a teaching hospital when appointed as Sr. Resident. There is no other Sr. Resident in Unit-III.
4. Average daily delivery was 2 and Caesarian Section was 2, which is inadequate.
5. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee considered the Compliance verification Report (03.05.2018) and Council Assessor's Report(s) (July, 2017) and decided to recommend not to renew the recognition of MS(OBG) qualification for 1 seat and not to recognize MS(OBG) qualification against increased intake from 04 to 06 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at N.K.P.Salve Institute of Medical Sciences & Research Centre & Lata Mangeshkar Hospital, Nagpur because of the following facts:-

1. Bed Occupancy at 10 a.m. on day of assessment is 70%.
2. Obstetric OPD is only 64.
3. There were only 2 Major Operations on day of assessment.
4. Only IUI is available. Rest of ART services are not available. Even the frequency of IUI is very low: 1 in 15 days.
5. Other deficiencies as pointed out in the Assessment Report.

Medical College & King Edward VII Memorial Hospital, Parel Mumbai because of the following facts:-

1. Dr. Jyotsna Dwivedi, Assistant Professor has not signed the faculty table which means she was not available.
2. There are 6 units of 40 beds each. Maximum permissible seats 24. However, the Institute/department is admitting 36 PG students. It is far in excess to maximum permissible.
3. Bed Occupancy on day of assessment is 67.12 %.
4. Unit 1 has Bed Strength of 41 which is not as per Regulations.
5. Unit 1 which is the Unit of HOD does not have Assoc. Prof.; resultantly faculty complement is incomplete & it cannot be considered as PG Unit.
6. Unit PKB has only 1 faculty & is headed by Asst. Prof.; hence it cannot be considered as PG Unit.
7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 12 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. 5. Equipment like Flow Cytometer is not functional.
6. No books has been purchased for the departmental library during the last 3 years.
7. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee considered the Compliance verification Report (03.05.2018) and Council Assessor's Report(s) (July, 2017) and decided to recommend to the Central Government that MS(Orthopaedics) qualification

against increased intake from 3 to 6 seats granted by Mahatma Gandhi University of Medical Sciences and Technology, Jaipur in respect of students being trained at Mahatma Gandhi Medical College and Hospital, Jaipur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

56. Kerala University, Thiruvananthapuram - Recognition of MS(OBG) qualification against increased intake from 01 to 03 seats in respect of students being trained at T.D. Medical College, Alappuzha.

Read: the Compliance verification Report (04.05.2018) and Council Assessor's Report(s) (June, 2013 & 16.03.2015,09.05.2016) on the standard of examination and other teaching facilities available for Recognition of MS(OBG) qualification against increased intake from 01 to 03 seats at T.D. Medical College, Alappuzha granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Compliance verification Report (04.05.2018) and Council Assessor's Report(s) (June, 2013 & 16.03.2015,09.05.2016) and decided to recommend not to recognize MS(OBG) qualification against increased intake from 01 to 03 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at T.D. Medical College, Alappuzha because of the following facts:-

1. The following faculty were absent on assessment day:-

 - (2) Dr. M.I. Geetha, Assoc. Prof.
 - (3) Dr. Sapna S, Prof.

 - (6) Dr. Nisha V, Lecturer
 - (7) Dr. Suman Paul, Asst.Prof.
2. Dr. Swathi Ambadas Khande, Sr. Resident, is not eligible. She was appointed on 03.04.2018 and she is not MD. There is no other Sr. Resident in Unit-II.
3. All 3 Units have 50 beds which is not as per Regulations.
4. Dr. R. Sreekumari is shown as "Professor" in the column of "Designation" in the faculty table; however in the column of "Experience", it is shown as "Asso. Prof." from 2017 till date. No explanation is provided for this discrepancy.
5. Dr. P.S. Anasooya is shown as "Assoc. Prof." in the column of "Designation" in the faculty table; however in the column of "Experience", it is shown as "Asst. Prof." from 2004 till date. No explanation is provided for this discrepancy.
6. Dr. Bessy Binu Sam is shown as "Assoc. Prof." in the column of "Designation" in the faculty table; however in the column of "Experience", it is shown as "Asst. Prof." from 2017 till date. No explanation is provided for this discrepancy.
7. Obstetric OPD is only 66 on day of assessment.
8. There were only 2 Major Operations on day of assessment.
9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 01 to 03 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of

Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

57. Sher-I-Kashmir Instt. Of Medical Sciences (Deemed University), Sour Srinagar - Recognition of M.Ch(Urology) qualification for 01 seat in respect of students being trained at Sher-I-Kashmir Institute of Medical Sciences, Soura, Srinagar.

Read: the Compliance verification Report (27.04.2018) and Council Assessor's Report(s) (July, 2017) on the standard of examination and other teaching facilities available for Recognition of M.Ch(Urology) qualification for 01 seat at Sher-I-Kashmir Institute of Medical Sciences, Soura, Srinagar granted by SherEKashmir Institute of Medical Sciences, Srinagar (Deemed University).

The Postgraduate Medical Education Committee considered the Compliance verification Report (27.04.2018) and Council Assessor's Report(s) (July, 2017) and decided to recommend to the Central Government that M.Ch(Urology) qualification for 01 seat granted by Sher-E-Kashmir Institute of Medical Sciences, Srinagar (Deemed University) in respect of students being trained at Sher-I-Kashmir Institute of Medical Sciences, Soura, Srinagar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

58. Vinayaka Mission's University, Salem - Renewal of Recognition of MS(Orthopaedics) and D. Ortho. qualification for 01 seat each in respect of students being trained at Aarupadai Veedu Medical College & Hospital, Puducherry..

Read: the Compliance verification Report (03.05.2018) and Council Assessor's Report(s) ((28.06.2017 (for degree) and 29.06.2017 (for diploma)) on the standard of examination and other teaching facilities available for Renewal of recognition of MS(Orthopaedics) and D. Ortho. qualification for 01 seat each at Aarupadai Veedu Medical College & Hospital, Puducherry granted by Vinayaka Mission's University, salem.

The Postgraduate Medical Education Committee considered the Compliance verification Report (03.05.2018) and Council Assessor's Report(s) ((28.06.2017 (for degree) and 29.06.2017 (for diploma)) and decided to recommend not to renew the recognition of MS(Orthopaedics) and D. Ortho. qualification for 01 seat each granted by Vinayaka Mission's University, Salem in respect of students being trained at Aarupadai Veedu Medical College & Hospital, Puducherry because of the following facts:-

1. Deficiency of faculty: (a) Assoc. Prof.: 1; (b) Asst. Prof.: 1.
2. Unit II has only 1 faculty & is headed by Asst. Prof.; hence it cannot be considered as a teaching Unit.
3. Dr. K. Sarvana Kumar, Senior Resident does not have 3 y experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. Action by the Institute to demote him retrospectively is impermissible & cannot be considered. Deficiency remains as it is.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 1 each till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

59. Maharashtra University of Health Sciences, Nashik - Renewal of Recognition of MD(DVL) qualification for 1 seat in respect of students being trained at Dr. Vasantaro Pawar Medical College & Research Centre, Nasik..

Read: the Compliance verification Report (04.05.2018) and Council Assessor's Report(s) (July, 2017) on the standard of examination and other teaching facilities available for Renewal of recognition of MD(DVL) qualification for 1 seat at Dr. Vasantaro Pawar Medical College & Research Centre, Nasik granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Compliance verification Report (04.05.2018) and Council Assessor's Report(s) (July, 2017) and decided to recommend to the Central Government that the recognition of MD(DVL) qualification for 1 seat granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Dr. Vasantaro Pawar Medical College & Research Centre, Nasik be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

60. Nizams Institute of Medical Sciences, (Deemed University), Hyderabad - Renewal of recognition of MD(Anaesthesiology) qualification for 07 seats in respect of students being trained at Nizams Institute of Medical Sciences, Hyderabad.

Read: the Assessment Report (11.04.2018) on the standard of examination and other teaching facilities available at Nizams Institute of Medical Sciences, Hyderabad for purpose of Renewal of recognition of MD(Anaesthesiology) qualification for 07 seats granted by Nizams Institute of Medical Sciences, (Deemed University), Hyderabad.

The Postgraduate Medical Education Committee considered the Assessment Report (11.04.2018) and decided to recommend to the Central Government that the recognition of MD(Anaesthesiology) qualification for 07 seats granted by Nizams Institute of Medical Sciences, (Deemed University), Hyderabad in respect of students being trained at Nizams Institute of Medical Sciences, Hyderabad be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

61. Consideration of prior requirement/qualification (entry level) for inclusion of DM (Paediatric Neurology) in Postgraduate Medical Education Regulations, 2000 - Reg.

Read: the matter with regard to prior requirement/qualification (entry level) for inclusion of DM (Paediatric Neurology) in Postgraduate Medical Education Regulations, 2000.

The Postgraduate Medical Education Committee considered the matter with regard to prior requirement/qualification (entry level) for inclusion of DM (Paediatric Neurology) in Postgraduate Medical Education Regulations, 2000 and after detailed deliberation decided that prior qualification (entry level) for admission to DM(Paediatric Neurology) should be MD(Paediatrics) & MD(General Medicine).

62. Starting of M.Ch (Surgical Gastroenterology) course at Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19- re-consideration of Compliance Verification Assessment Report.

Read: the Central Govt. Letter dated: 14/05/2018 along with Compliance Verification Assessment (04/04/2018), the Council Assessor's Report (3rd November 2017) and compliance dated 30/01/2018 submitted by the college authorities for Starting of M.Ch (Surgical Gastroenterology) course at Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical

Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee re-considered the matter alongwith Central Govt. Letter dated: 14/05/2018 as well as verbal explanation of the authority of the institute during personal hearing together with Compliance Verification Assessment (04/04/2018), the Council Assessor's Report (3rd November 2017) and compliance dated 30/01/2018 submitted by the college authorities and after due deliberations observed as under:-

1. Dr Manish Mandal Prof & HOD

He is MS General Surgery and He has no two years special training in surgical Gastroenterology: Experience of senior resident cannot be counted as special training.

2. There is No Assoc Prof in the Deptt.
3. None of the SR is eligible. None is M.ch Surgical G.E or have 3 yrs experience as JR in this Deptt when appointed SR.

In view of above, the Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 24-04-2018 recommending to the Central Govt. **not** to grant Letter of Permission for starting of M.Ch (Surgical Gastroenterology) course at Indira Gandhi Institute of Medical Sciences,Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

63 Starting of DM (Nephrology) course at Indira Gandhi Institute of Medical Sciences,Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19- re-consideration of Compliance Verification Assessment Report.

Read: the Central Govt. Letter dated: 14/05/2018 along with Compliance Verification Assessment (9th April 2018), the Council Assessor's Report (7th November 2017) and compliance dated 30th January 2018 submitted by the college authorities for Starting of DM (Nephrology) course at Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee re-considered the matter alongwith Central Govt. Letter dated: 14/05/2018 as well as verbal explanation of the authority of the institute during personal hearing together with Compliance Verification Assessment (9th April 2018), the Council Assessor's Report (7th November 2017) and compliance dated 30th January 2018 submitted by the college authorities and after due deliberations observed as under:-

Dr Amresh Krishna:

1. He was appointed Assoc prof on 03-03-2016 by the order of BOG. A Joining report dated 14-03-18 has been attached in his DF submitted in compliance verification inspection dated 09-04-2018 which states that joining of Dr Amresh Krishna to the Post of Assoc Prof of Nephrology is hereby accepted w.e.f. 28-03-2017, which is one year and 25 Days after the issue of his appointment letter. The appointment letter dated 03-03-16 also states that he must convey his acceptance within 7 days. However a line has been added in his appointment letter that "Your joining report will be accepted W.e.f 28-03-2017,

which has been actually accepted on 14-03-2018. It cannot be understood that if Dr Amrish Krishna was working as Asstt Prof in this very deptt from 10-08-12 then why he will join after 1 year of receipt of appointment orders as Associate professor. If he was not eligible on 06-10-2015 (date of interview) then how the selection committee selected him. However the same appointment letter dated 03-03-2016 attached in his DF submitted on the day of first inspection on 07-11-2017 does not stipulate any such condition that his joining will be accepted w.e.f. 28-03-2017. According to this letter he was given joining time upto 31-03-16 only and he actually joined W.e.f 04-03-16 itself. His joining report was accepted w.e.f. 04-03-16 by the administrative officer. This can also be confirmed by the fact that in the faculty table (signed by dean & Assessor) in report dated 07-11-2017 he is shown Assoc. prof. w.e.f. 03-03-16 which means he joined on the same day on which his appointment orders as Assoc prof were issued. The line in his appointment letter dated 03-03-2016 submitted on 09-04-2018 (compliance verification inspection) that his joining report will be accepted from 28-03-17 have been added retrospectively and later on even without changing the date of issue of that letter.

The Honable Director could neither produce any order of BOG (or any other competent authority) authorizing him to change his joining report from 04-03-16 to 28-03-17 nor proof of recovery of arrears of salary paid to him as Assoc. Prof. from 04-03-2016 to 28-03-2017 (about one year). Obviously orders of Directors accepting Dr Amresh Krishna's joining report from 28-03-17 and introducing this condition in his appointment letter dated 03-03-16 are not only without authorization by BOG and beyond his competence but also not supported by proof of recovery of arrears of salary paid to him as Assoc. Prof. from 04-03-2016 to 28-03-2017. Obviously these orders issued by the Director to make the faculty eligible retrospectively cannot be accepted. Two out of his three publications quoted are after his promotion. His one publication for which acceptance letter dated 03-01-2017 has been attached is still not published although 16 months have passed. This is also after his promotion. Hence his appointment is not as per regulations. There is no other Assoc Prof in the Deptt.

2. No eligible SR in the Deptt. Dr Govind Prasad is neither Mch nor he has 3 years experience as JR in the Deptt when appointed SR.

In view of above, the Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 24-04-2018 recommending to the Central Govt. **not** to grant Letter of Permission for starting of DM (Nephrology) course at Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Committee further decided that this matter be referred to ethics committee.

64. **Starting of M.Ch (Paediatric Surgery) course at Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19- re-consideration of Compliance Verification Assessment Report.**

Read: the Central Govt. Letter dated: 14/05/2018 along with Compliance Verification Assessment (12th April 2018), the Council Assessor's Report (31st October 2017) and compliance dated 30th January 2018 submitted by the college authorities for Starting of M.Ch.(Paediatric Surgery) course at Indira Gandhi Institute of Medical

Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee re-considered the matter alongwith Central Govt. Letter dated: 14/05/2018 as well as verbal explanation of the authority of the institute during personal hearing together along with Compliance Verification Assessment (12th April 2018), the Council Assessor's Report (31st October 2017) and compliance dated 30th January 2018 submitted by the college authorities and after due deliberations observed as under:-

Dr Vijayendra Kumar:

In DF Dated 31-10-2017: Submitted during first inspection he is shown professor w.e.f. 08-10-2014 till date. Details of experience as below:

Asstt Prof : Sept 2004 to Feb 2014
Assoc Prof : Feb 2014 to Oct 2014 (8 Months)
Prof : 08-10-2014 till date.

In DF dated 12-04-2018. Submitted during compliance verification he is shown Professor W.e.f. 08-02-2017. Details of experience as below:

Asstt Prof : Sept 2004 to Feb 2014
Assoc Prof : Feb 2014 to Oct 2014 (8 Months) and Oct. 2014 to 07-02-17
Prof : 08-02-2017 till date.

Confirmed as Prof after completion of 2 years of probation on 10-03-2017.

The Director vide his order dated 08-03-2018 has said that he may be considered Assoc. Prof till 07-02-2017 and Professor from 08-02-2017. However in his order dated 10-03-2017, he is confirmed as Prof after completion of 2 years probation period.

The Director is not competent/authorised to demote a confirmed professor (appointed by BOG) to Assoc Prof.

The Honourable Director could neither produce any order of BOG authorizing him to change the promotion date of professors, nor proof of recovery of arrears from Dr Vijayendra Kumar for the period 08-10-2014 to 08-02-17. Obviously the promotion orders issued by Director dated 08-03-18 promoting Dr Vijayendra Kumar Professor W.e.f. 08-02-2017 are not only without Authorization by the BOG and beyond his competence but also not supported by proof of recovery of arrears for the salary paid to him as professor from 08-10-2014 to 08-02-2017. Obviously these orders issued by the Director to make the faculty eligible retrospectively cannot be accepted. Even in the present compliance verification report dated 31-10-2017 (faculty table) he is shown Assoc Professor only for 8 months when promoted professor against the requirement of 3/4 years. Hence his promotion is not as per regulations. There is no other professor in the department.

In view of above, the Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 24-04-2018 recommending to the Central Govt. **not** to grant Letter of Permission for starting of M.Ch.(Paediatric Surgery) course at Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Committee further decided that this matter be referred to ethics committee.

65. Starting of DM (Cardiology) course at Indira Gandhi Institute of Medical Sciences,Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19- re-consideration of Compliance Verification Assessment Report.

Read: the Central Govt. Letter dated: 14/05/2018 along with Compliance Verification Assessment (11th April 2018), the Council Assessor's Report (8th November 2017) and compliance dated 30th January 2018 submitted by the college authorities for Starting of DM (Cardiology) course at Indira Gandhi Institute of Medical Sciences,Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee re-considered the matter alongwith Central Govt. Letter dated: 14/05/2018 as well as verbal explanation of the authority of the institute during personal hearing together along with Compliance Verification Assessment (11th April 2018), the Council Assessor's Report (8th November 2017) and compliance dated 30th January 2018 submitted by the college authorities and after due deliberations observed as under:-

1. Dr B.P. Singh Prof. : His DM Degree has been recognized only on 23-04-2018 by the Central Govt. with retrospective effect which is after compliance verification inspection on 11-04-2018. However, this is not taken as a deficiency since it has been recognized now.
2. Dr Nishant Tripathy Assoc Prof : He was promoted on 07-03-2016 after the cut off date.
Out of the publications quoted:
Two are in 2011 (Before he was appointed Asstt Prof on 12-08-2012).
One is in Sept. 2012 in which he is 5th author.
One is a case report in 2016 in which he is 4th Author.
One is a letter to editor in which he is 3rd Author.
Resultantly he has no publications against the required two.
Hence his promotion is not as per regulations.
3. Dr Ravi Vishnu Parsad Assoc Prof: He was promoted on 01-07-2016. Out of 3 Publications quoted one is in their own institutional journal in 2017 which is after his promotion and one in 2016 in which he is 6th Author. Resultantly he has only one publication against the required two. Hence his promotion is not as per regulations.
4. Nirav Kumar Assoc Prof : He was promoted on 01-07-2016 (as per faculty table in both the reports) and on 01-09-2017 as per his DF. Both the dates are after the cut off date.
He is DNB, passed in 2010. It is not given that he passed from teaching or non-teaching intuition without which has eligibility cannot be decided.
He has only one publication in their own institutional journal in 2017 which is after his promotion. Resultantly he has no publications against the required two. Hence his promotion is not as per regulations.
There is no other associate professor in the deptt.
5. There is no eligible SR in the deptt.

In view of above, the Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 24-04-2018 recommending to the Central Govt. **not** to grant Letter of Permission for starting of DM (Cardiology) course at Indira Gandhi

Institute of Medical Sciences, Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

66. Starting of M.Ch (Neuro Surgery) course at Indira Gandhi Institute of Medical Sciences,Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19- consideration of Compliance Verification Assessment Report.

Read: the Central Govt. Letter dated: 14/05/2018 along with Compliance Verification Assessment (20th April 2018), the Council Assessor's Report (02/11/2017) and compliance dated 30/01/2018 submitted by the college authorities for Starting of M.Ch(Neuro Surgery) course at Indira Gandhi Institute of Medical Sciences,Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Medical Education Committee re-considered the matter alongwith Central Govt. Letter dated: 14/05/2018 as well as verbal explanation of the authority of the institute during personal hearing together along with Compliance Verification Assessment (20th April 2018), the Council Assessor's Report (02/11/2017) and compliance dated 30/01/2018 submitted by the college authorities and after due deliberations observed as under:-

Dr Keshav Mohan Jha

As per faculty table signed by dean & Assessor in report dated 02-11-17 and his own declaration from, he was shown professor w.e.f 12-09-2014 (appointed vide order dated 11-09-14) which has been changed to 20-09-2011 in the report dated 20-04-2018. (Compliance verification inspection)

It has been observed that Dr Keshav Mohan Jha was appointed/promoted professor w.e.f 12-09-2014 by the Board of governors of the institute vide order dated 11-09-14. However the Director vide his order dated 14-03-18 promoted him professor w.e.f. 20-09-2011 and withdrew retrospectively his promotion to the post of Professor which had been granted by the Board of governors w.e.f. 12-09-2014.

The Hon'ble Director could neither produce any order of BOG authorizing him to change the promotion date of professors nor any fresh joining report of Dr Keshav Mohan Jha (as professor) W.e.f. 20-09-2011, Nor proof of payment of arrears as salary of professor for the period 20-09-2011 to 12-09-2014. Obviously the promotion orders issued by Director dated 14-03-18 promoting. Dr Keshav Mohan Jha Professor W.e.f. 20-09-2011 to 12-09-2014 are not only without Authorization by the BOG and beyond his competence but also neither supported by proof of payment of salary as professor from 20-09-2011 to 12-09-2014 nor Dr Keshav Mohan Jha's fresh joining report as professor w.e.f. 20-09-2011. Such orders issued by the Director to make the faculty eligible retrospectively cannot be accepted. There are 13 publications attached to his DF but none of them is a research article published in an indexed journal in which he is first or 2nd Author. Hence his promotion is not as per regulations. The P.G. committee decided to reiterate its earlier decision dated 24-04-18 and further decided to refer this matter to ethics committee.

Dr Sudhir Kumar

As per faculty table signed by dean & Assessor in report dated 02-11-17 and his own declaration from, he was shown professor w.e.f 01-07-2017 which has been changed to 01-07-13 by the order of Director dated 14-03-2018. Interestingly he has shown himself Assoc Prof from 01-07-2009 till date in his DF submitted in compliance verification assessment on 20-04-2018 and also in faculty table of report dated 20-04-2018.

It has been observed that Dr Sudhir Kumar was appointed/promoted professor w.e.f. 08-07-2017 by the Board of governors of the institute. However the Director vide his order dated 14-03-18 promoted him professor w.e.f. 01-07-2013 and withdrew retrospectively his promotion to the post of Addl. Professor which had been granted by the Board of governors w.e.f. 01-07-2014 (Subsequently changed to 01-07-2013).

The Honable Director could neither produce any order of BOG authorizing him to change the promotion date of professors nor any fresh joining report of Dr Sudhir Kumar (as professor) W.e.f. 01-07-2013, Nor proof of payment of arrears for the period 01-07-2013 to 01-07-2017. Obviously the promotion orders issued by Director dated 14-03-18 promoting. Dr Sudhir Kumar Professor W.e.f. 01-07-2013 are not only without Authorization by the BOG and beyond his competence but also neither supported by proof of payment of salary as professor from 01-07-2013 nor Dr Sudhir Kumar's fresh joining report as professor w.e.f. 01-07-13. Obviously these are issued by the Director to make the faculty eligible retrospectively cannot be accepted. He has no publications. Hence his promotion is not as per regulations. The PG committee decided to reiterate its earlier decision dated 24-04-18 and further decided to refer this matter to Ethics committee.

Dr Somender Kumar Singh

As per faculty table signed by dean & Assessor in report dated 02-11-17 and his own declaration from, he was shown Assoc professor w.e.f 18-03-16 till date which has been changed to Asstt Prof W.e.f. 17-03-2017 till date in the compliance verification report dated 20-04-2018. His period from 18-03-2016 to 17-03-2017 is changed as senior resident instead of Assoc Professor.

It has been observed that Dr Somender Kumar Singh was appointed Assoc professor w.e.f 18-03-16 by the Board of governors of the institute. However the Director vide his order dated 20-04-18 (on the day of inspection) changed it to Asstt Prof W.e.f 17-03-2017 (As per Assessor W.e.f. 17-06-2017) till date.

The Honable Director could neither produce any order of BOG (or any other competent authority) authorizing him to demote any faculty nor any fresh joining report of Dr Somender Kumar Singh as Asstt Prof w.e.f. 17-03-2017, Nor recovery of excess salary paid to him as Assoc Prof from 18-03-2016 to 20-04-2018. Obviously the promotion orders issued by Director dated 20-04-2018 designating. Dr Somender Kumar Singh as Asstt Professor W.e.f. 17-03-2017 and SR from 18-03-2016 to 17-03-2017 are not only without Authorization by the BOG and beyond his competence but also neither supported by proof of recovery of arrears for the period when he was demoted from Associate Professor to Asstt professor nor Dr Somender Kumar Singh's fresh joining report as Asstt professor w.e.f. 17-03-2017. Obviously these orders issued by the Director to make the faculty eligible retrospectively cannot be accepted. The PG committee decided to reiterate its earlier decision dated 20-04-2018 and further decided to refer this matter to Ethics committee.

2. None of the senior residents is eligible. They are neither M.Ch. nor have 3 years experience as Jr.Resident in neurosurgery when appointed Sr.Resident.

In view of above, the Postgraduate Committee decided to reiterate its earlier decision taken at its meeting held on 24-04-2018 recommending to the Central Govt. **not** to grant Letter of Permission for starting of M.Ch.(Neuro Surgery) course at Indira Gandhi Institute of Medical Sciences,Sheikhpura, Patna, Bihar under Indira Gandhi Instt of Medical Sciences (Deemed University), Patna U/s 10(A) of the IMC Act, 1956 for the academic year 2018-19.

The Postgraduate Committee further decided that this matter be referred to ethics committee.

67. Increase in seats in various Postgraduate (Broad Specialty) course(s) at Government Medical College Srinagar - Permission of Central Government - Regarding.

Read: the representation dated: 11/04/2018 from the from the Dean/Principal Govt Medical College Srinagar & dated 04.05.2018 from Joint Registrar, GGSIP University, Delhi with regard to Inclusion of Increased seats for the counselling for the academic year 2018-19.

The Postgraduate Medical Education Committee considered the representation dated: 11/04/2018 from the from the Dean/Principal Govt Medical College Srinagar & dated 04.05.2018 from Joint Registrar, GGSIP University, Delhi with regard to Inclusion of Increased seats for the counselling for the academic year 2018-19 and after due deliberations the Committee decided that the Central Govt. had issued Letter of Permission on 12.03.2018 for the academic year 2018-19. The admission on these subjects should be allowed during this session.

3. Dr. Reshma Korat, Sr.Resident, is not eligible. She is DNB from non-teaching hospital. She has no 3 years experience as Jr. Resident from a teaching hospital when appointed as Sr. Resident.
4. There were only 13 Major Operations on day of assessment.
5. MRI workload on day of assessment is only 6.
6. CT Scan workload on day of assessment is only 5.

7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 05 to 09 after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. 4. Dr. Nilesh Doctor, Asso. Prof. is shown working as Assoc. Prof. at this Institute w.e.f. 04/05/2009 to 08/03/2017. There is no record of his service at this Institute thereafter in the faculty table. Hence he cannot be considered as faculty.

3. Endoscopy, Dialysis services are not available.
4. Specialty clinics like Paediatric Cardiology clinic, Paediatric Nephrology clinic, Paediatric Endocrine clinic are not run.
5. Equipment like Upper GI Endoscope, Dialysis, ECG, Echo Colour Doppler, Computerized PFT Equipment, Bronchoscope, USG are not available. (P. 31)
6. MRI is not available.
7. Specialized services provided by the department are not adequate as detailed at Item § 11 of Summary.
8. Details of Examiners are not provided.
9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 06 to 09 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. 2. Unit 3 has only 12 beds; hence it cannot be considered as PG Unit.
3. Total available 74 beds against requirement of 120 beds are scattered in 3 hospitals: 52 in Lady Hardinge Medical College Hospital, 10 beds in Kalavati Saran Children Hospital & 12 in RML Hospital, which is not permissible.
4. Although RML Hospital is now a separate autonomous Institute conducting M.S. (Orthopaedics) course of its own, its infrastructure continues to be used for this Institute which is not permissible.
5. Unit I does not have Assoc. Prof. & has only 2 faculty; resultantly faculty complement is incomplete & it cannot be considered as PG Unit.
6. Dr. Vivek Jangira is promoted as Assoc. Prof. after cut-off date; however the column "Benefit of publications" in the faculty table is left blank implying NIL publication against requirement of 2; hence his promotion is not as per Regulations & he cannot be considered.
7. Details of beds occupied in ICU on day of assessment are not provided.
8. Specialty clinics like Spine clinic, Arthroplasty clinic, Hand clinic, Arthroscopy clinic are not conducted.
9. Equipment like Knee Arthroplasty set are not available.

10. CPC, Death Review Meetings are not held.
11. Central Research Laboratory is not available.
12. MRI is not available.
13. Total number of Daycare Operations has decreased from 871 in 2015 to 840 in 2017.
14. 2 External Examiners are from the same State.
15. Other deficiencies as pointed out in the Assessment Report.

3. Promotion of Dr. Vijender Singh, Assoc.Prof. is not as per regulations. He was Asst.Prof. for 3 years 11 months when promoted Assoc.Prof. and he has no publications.
4. Both Units have 50 beds which is not as per Regulations.
5. Total number of beds in the department is shown at 255 out of which 100 beds are shown as Teaching beds. It is not clear who is managing the remaining Non-teaching beds.
6. Total number of admitted patients in IPD has decreased from 2,334 to 2,257 during the preceding 3 year period.
7. Specialty clinics like Clinic for Senile Disorder, Memory clinic are not run by the department.
8. Departmental Library has only 50 books.
9. Other deficiencies as pointed out in the Assessment Report.

The Monitoring Sub-Committee recommends that in respect of the 5 candidates who have not joined, the discharge notice may be treated as null & void.

Concerning the remaining 10 students the Committee noted on perusal of reply of college authorities that W.P No. 3259/2018 - Sri Manakula Vinayagar Medical College & Hospital, v/s the Union of India and ors is pending before the Hon'ble High Court of Madras at Chennai. The Council Advocate may be requested to expedite the hearing of the matter.

It be ascertained by Legal Section whether any stay order is granted by Hon'ble High Court. If not, decision to discharge be reiterated & Institute be directed to submit compliance within 1 week.

University of Health Sciences, Warangal includes the name of Dr. Dharmana Chandana. Therefore the discharge notice dated 01.02.2018 may be withdrawn.

Clarification be sought from DME & K.N. University of Health Sciences as to why the name of Dr. Dharmana Chandana was not included in the first list submitted earlier.

36. Nomination of Foreign students to various PG course at the Institute of Medical Sciences, BHU, Varanasi for the academic year 2018-19.

The Monitoring Sub-Committee observed that section 10D of the Indian Medical Council Act included in the Act in 2016 provides for uniform entrance examination for admissions to courses in modern medicine. NEET is the only mode of admission in UG/PG courses. There is no exemption from the requirement of NEET for foreign Nationals. This position may be placed before PG Committee. The decision in this matter may be conveyed to Central Govt. & BHU with the approval of Executive Committee as it is a policy matter.

Opinion of Council Advocate be taken & matter be resubmitted.
