Sub:- News Report of ragging of first year MBBS students in your Institute.


Sir,

The Council office has taken note of the reports that have appeared in Print and Electronic Medical regarding the ragging of First Year Medical Students in your college. It has been noted that the first year MBBS students were made to shave their heads and salute their seniors. The news reports also bring out the complete failure of College Authorities in addressing the menace of ragging. This has been viewed very seriously by the Council authorities. Accordingly, as regulator of medical education and in exercise of powers conferred by the Medical Council of India (Prevention and Prohibition of Ragging in Medical Colleges/Institutions) Regulations, 2009, it has been decided to show cause and seek an explanation from your Institute as to why:-

- All the senior batches admitted in MBBS course in the Institute be not suspended from attending classes for a minimum period of one month;
- The Institute be not declared as an erring medical College and be declared as ineligible for preferring any application under Section 10(A) of the Indian Medical Council Act, 1956 for a minimum period of one year, extendable by such quantum by the Council as would be commensurate with the wrong.
- Exemplary fine of 1 lakh for each incident of ragging that is of 150 X 1 lakh that is equal to Rupees 150 lakhs be not imposed upon the Institute.

2. Your explanation should reach within 24 hours failing which it shall be presumed that you have nothing to say in the matter and punishment as indicated above shall be imposed upon your Institution.


